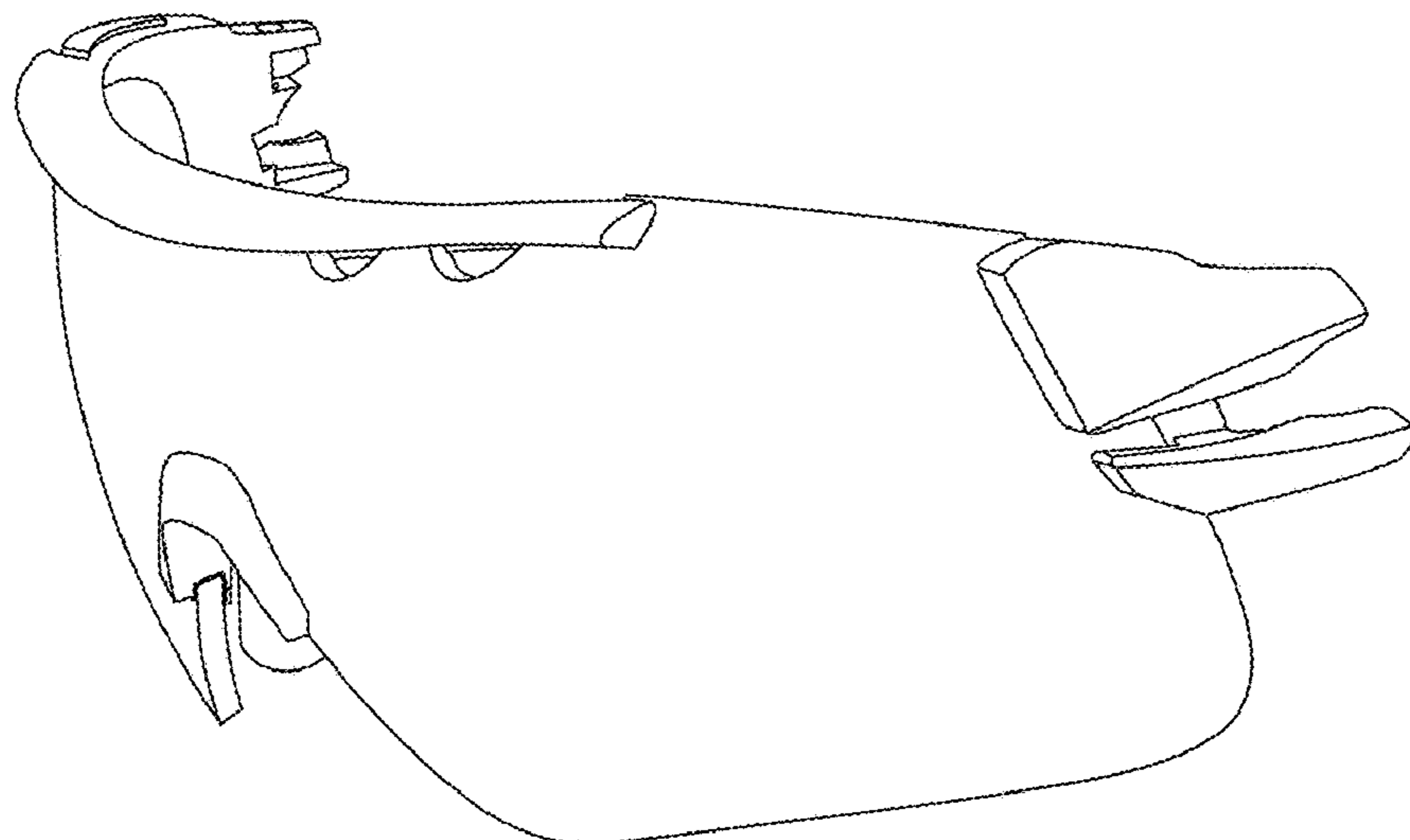
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the sport glasses; FIG. 2 is a front-elevation view of the sport glasses; FIG. 3 is a rear-elevation view of the sport glasses; FIG. 4 is a top-plan view of the sport glasses; FIG. 5 is a bottom-plan view of the sport glasses; and, FIG. 6 is a first side-elevation view of the sport glasses, the opposite side-elevation view being a mirror image thereof.

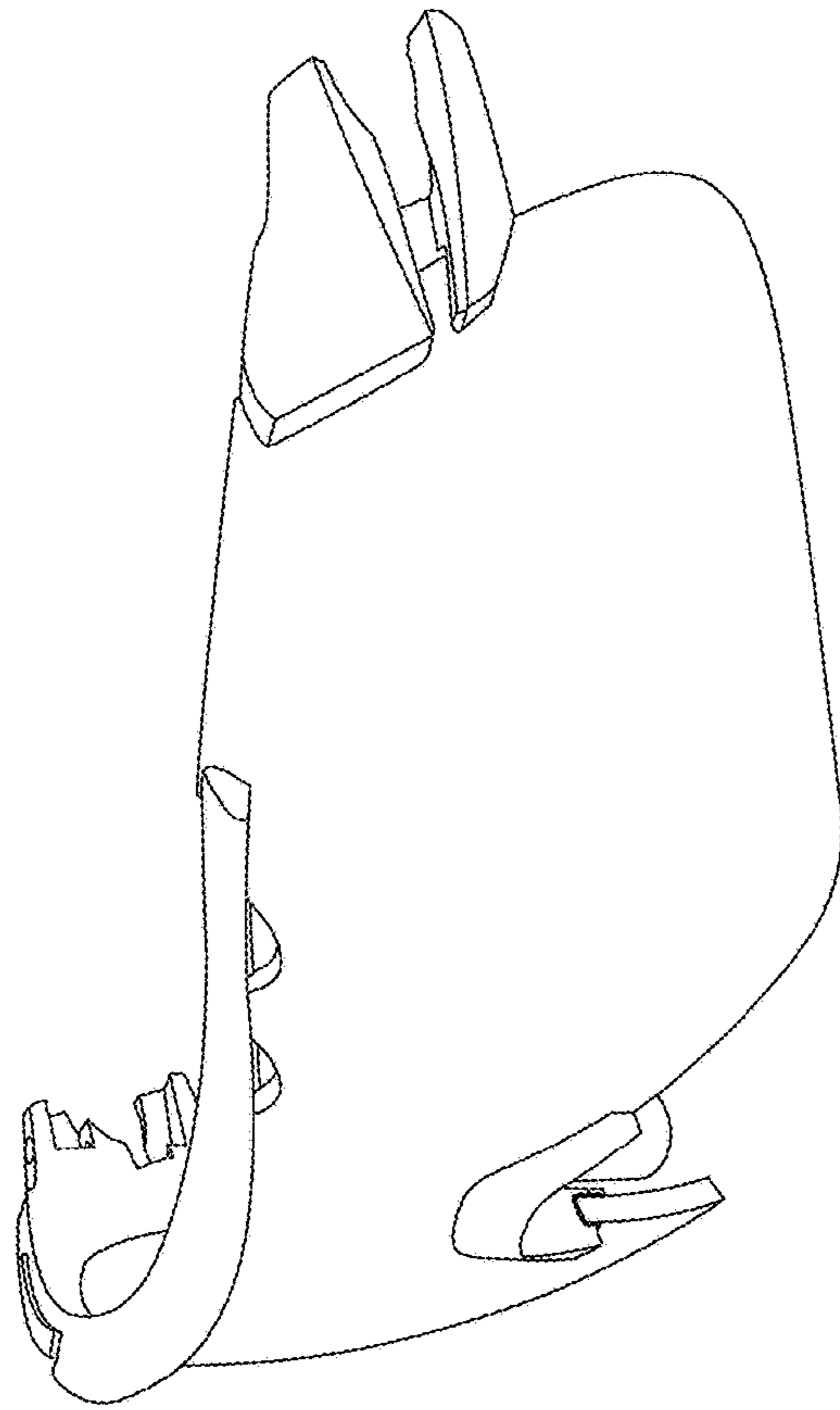

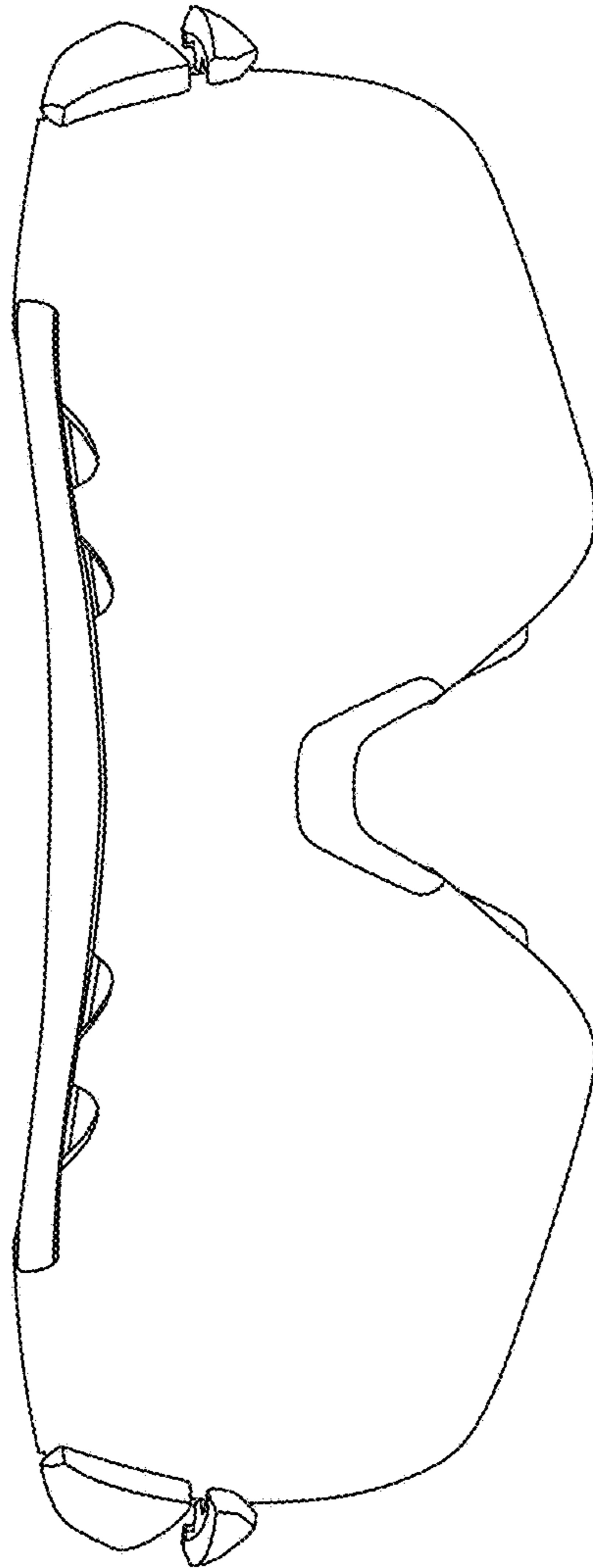

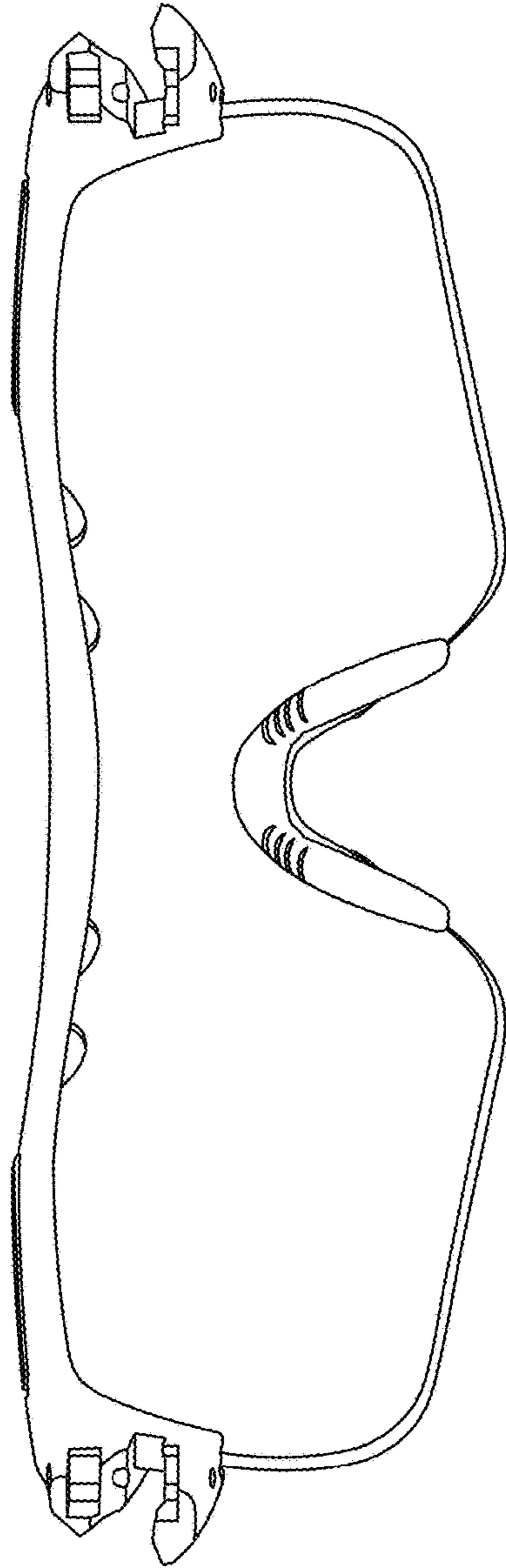

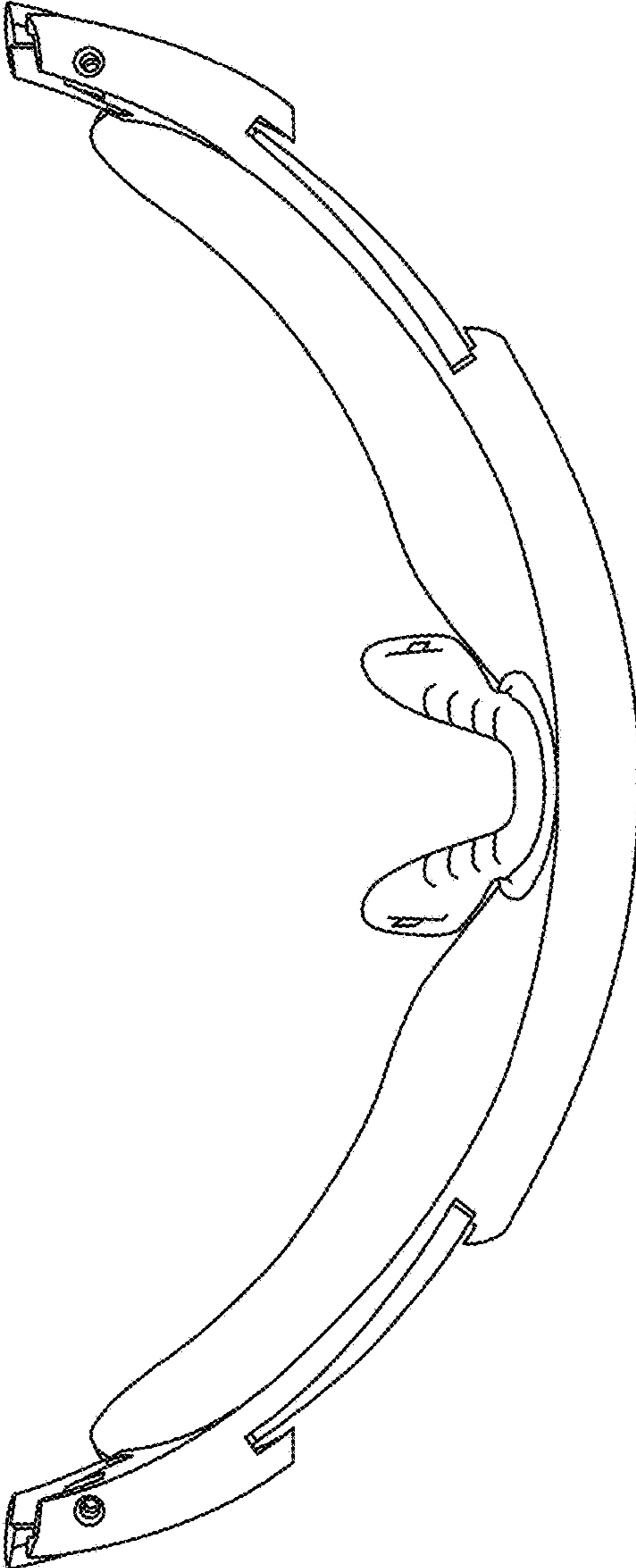

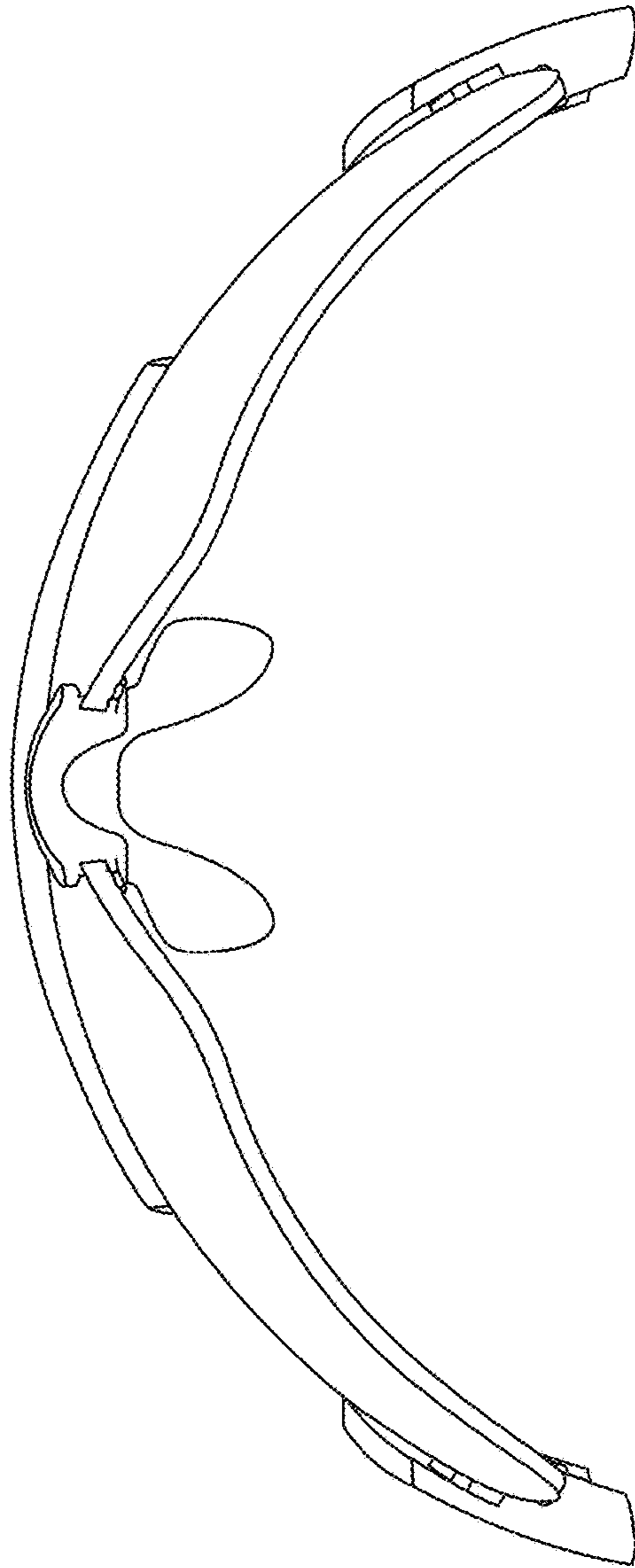
