(57) **CLAIM**

We claim the ornamental design for a monofin with flexible boot structures, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a monofin with flexible boot structures, showing our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom view thereof;

FIG. 4 is a left side view thereof;

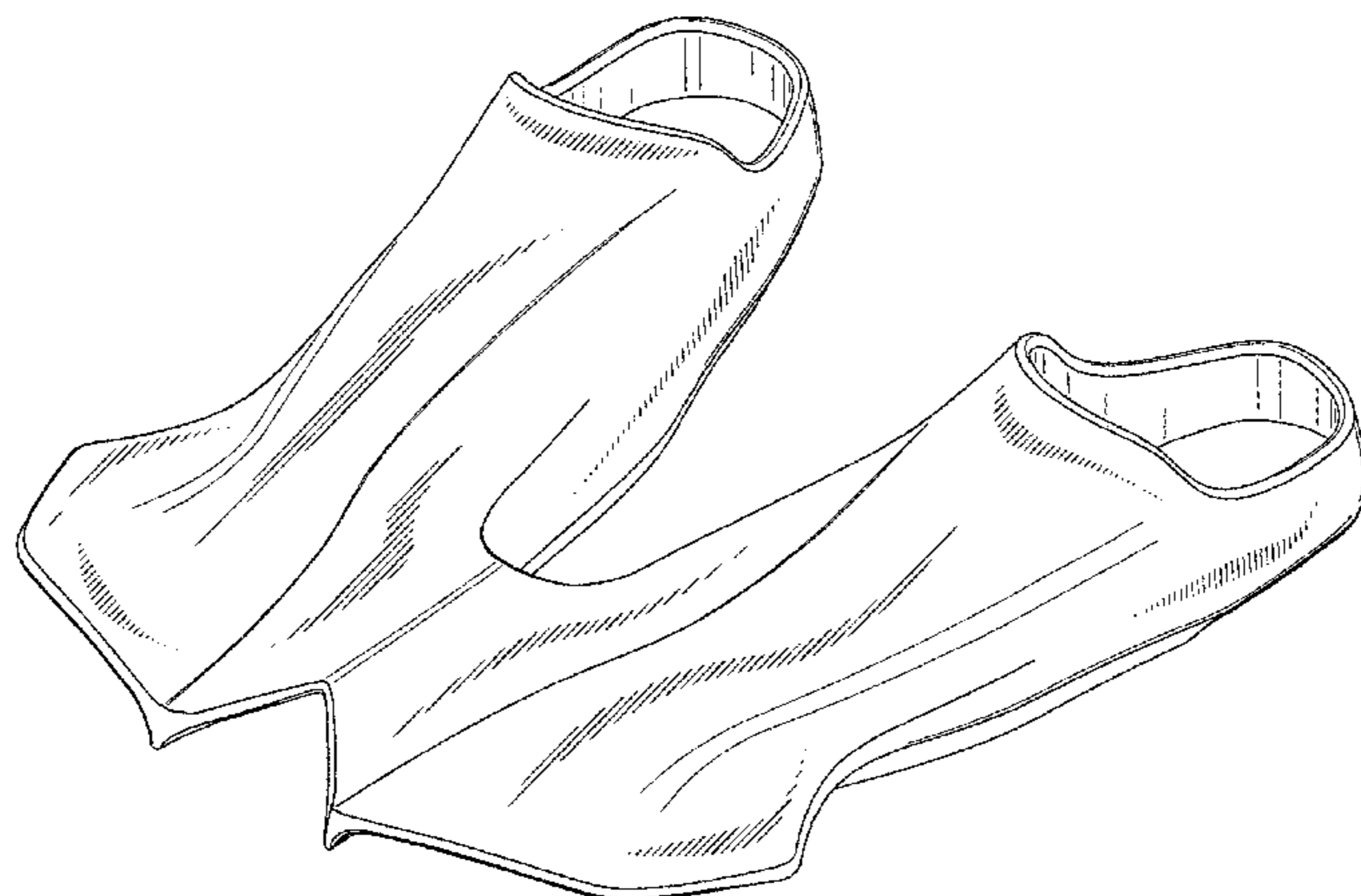
FIG. 5 is a right side view thereof;

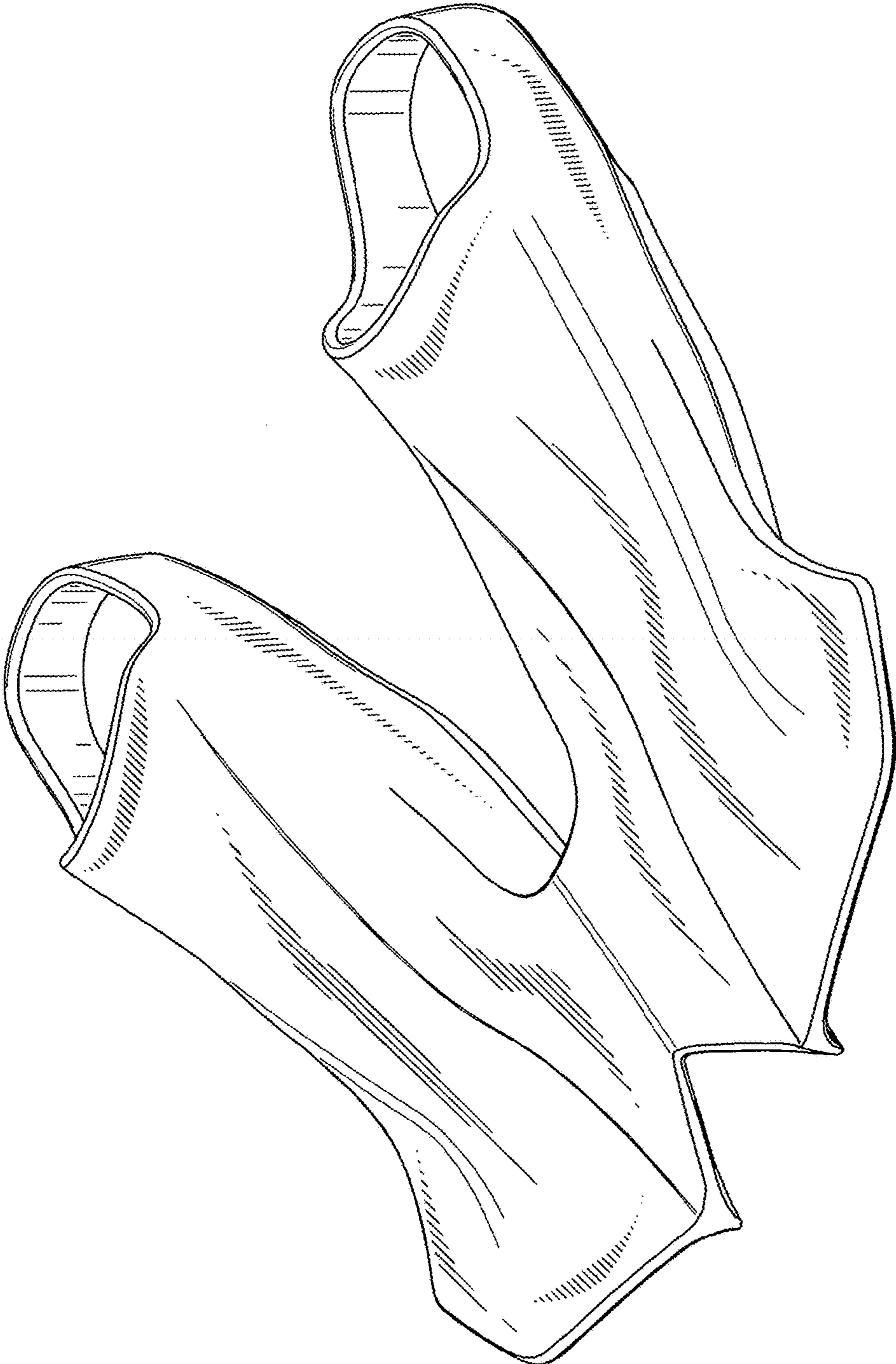

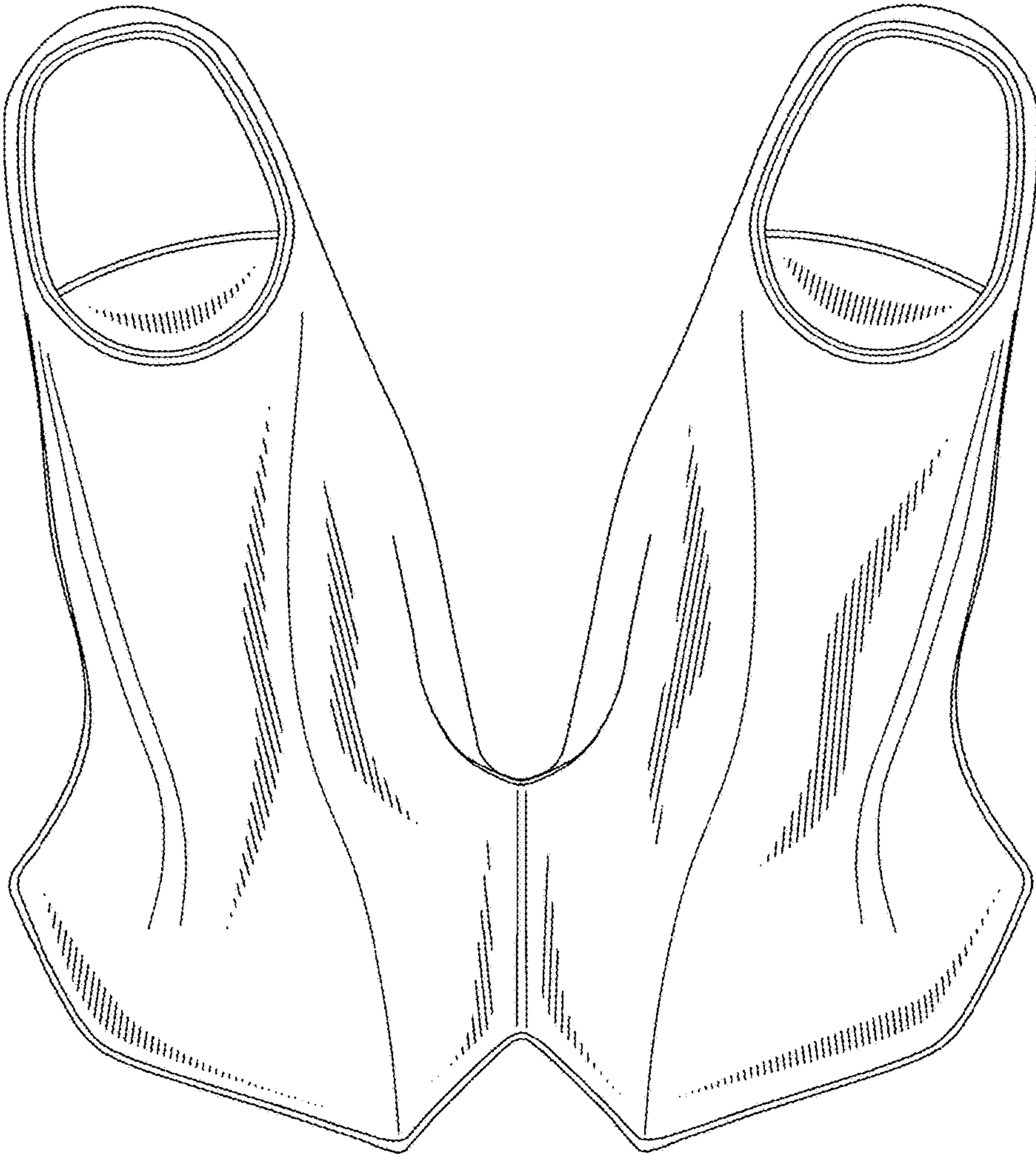

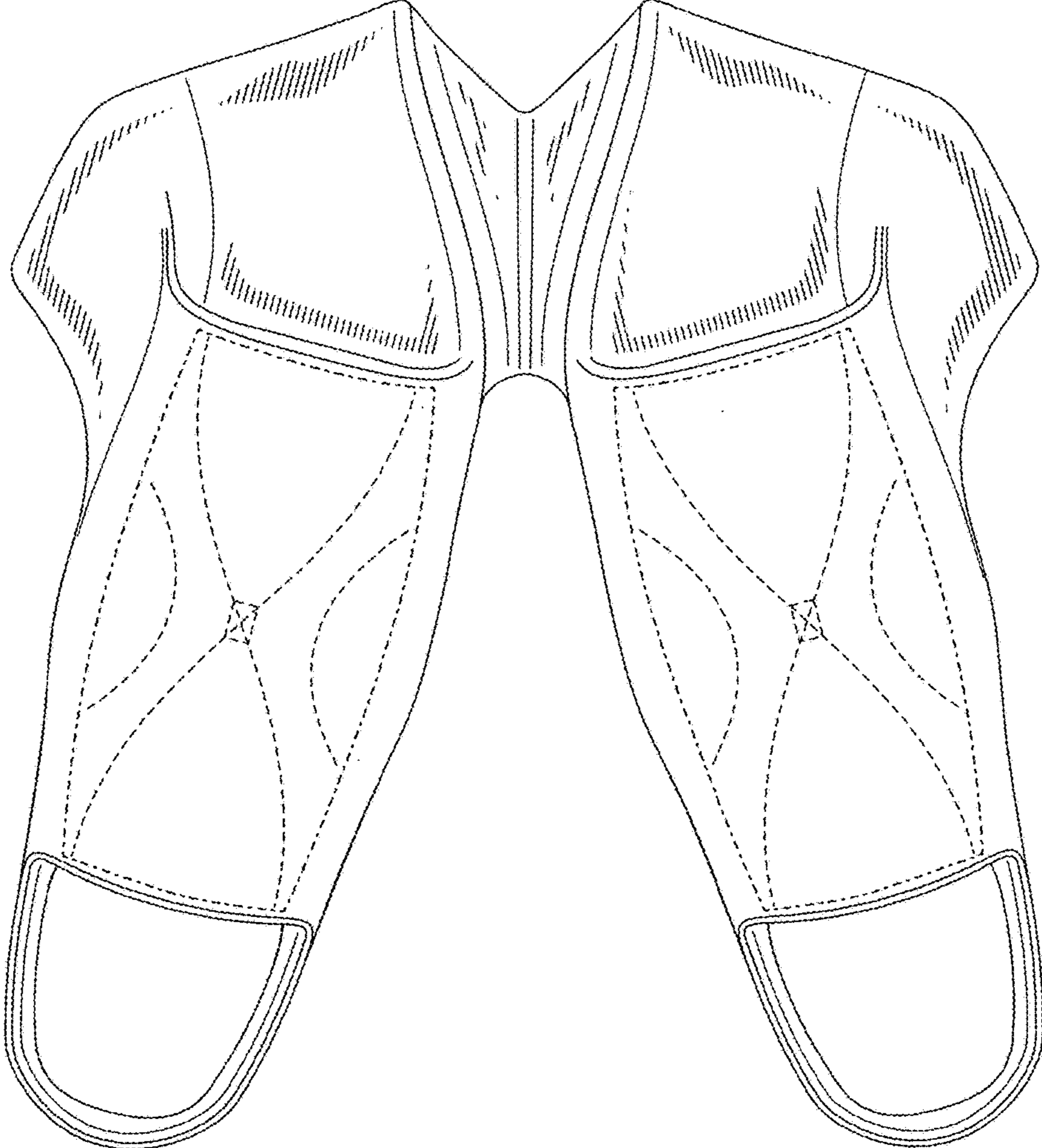

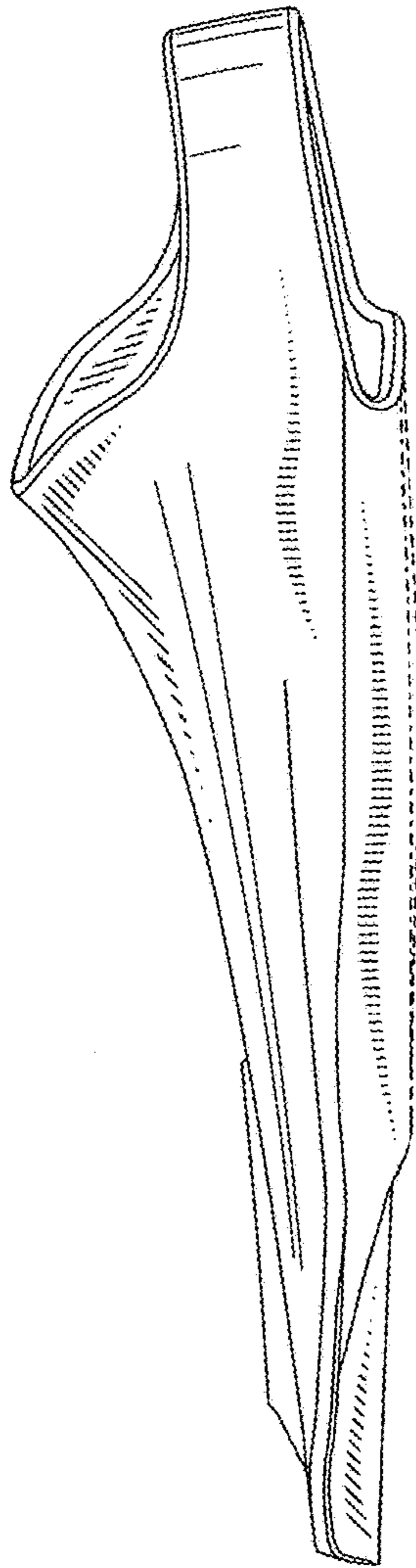

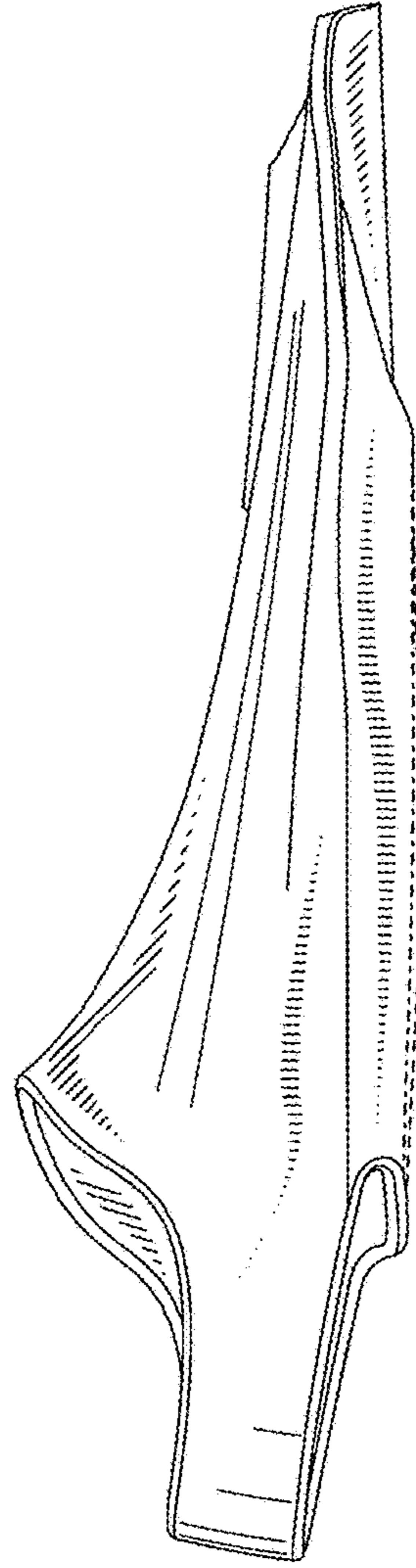

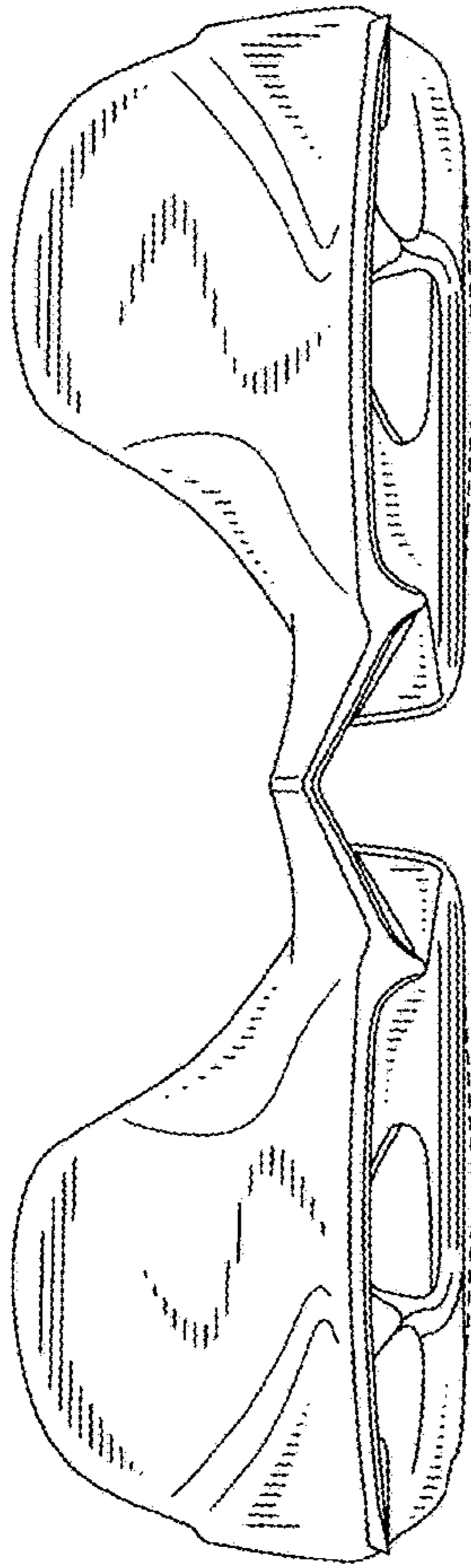

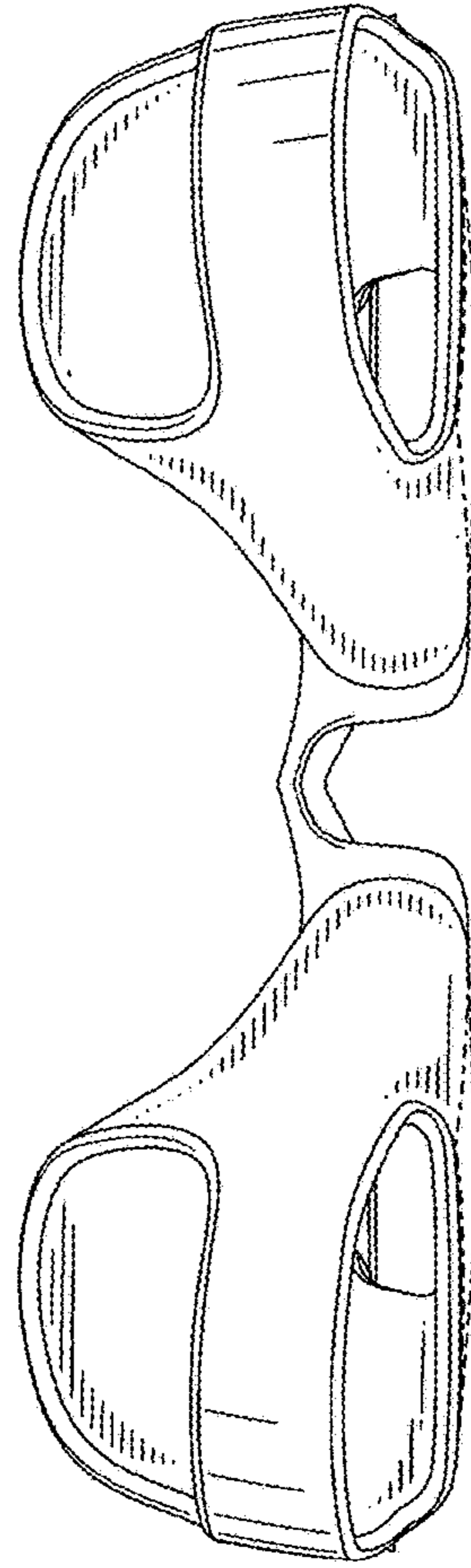
