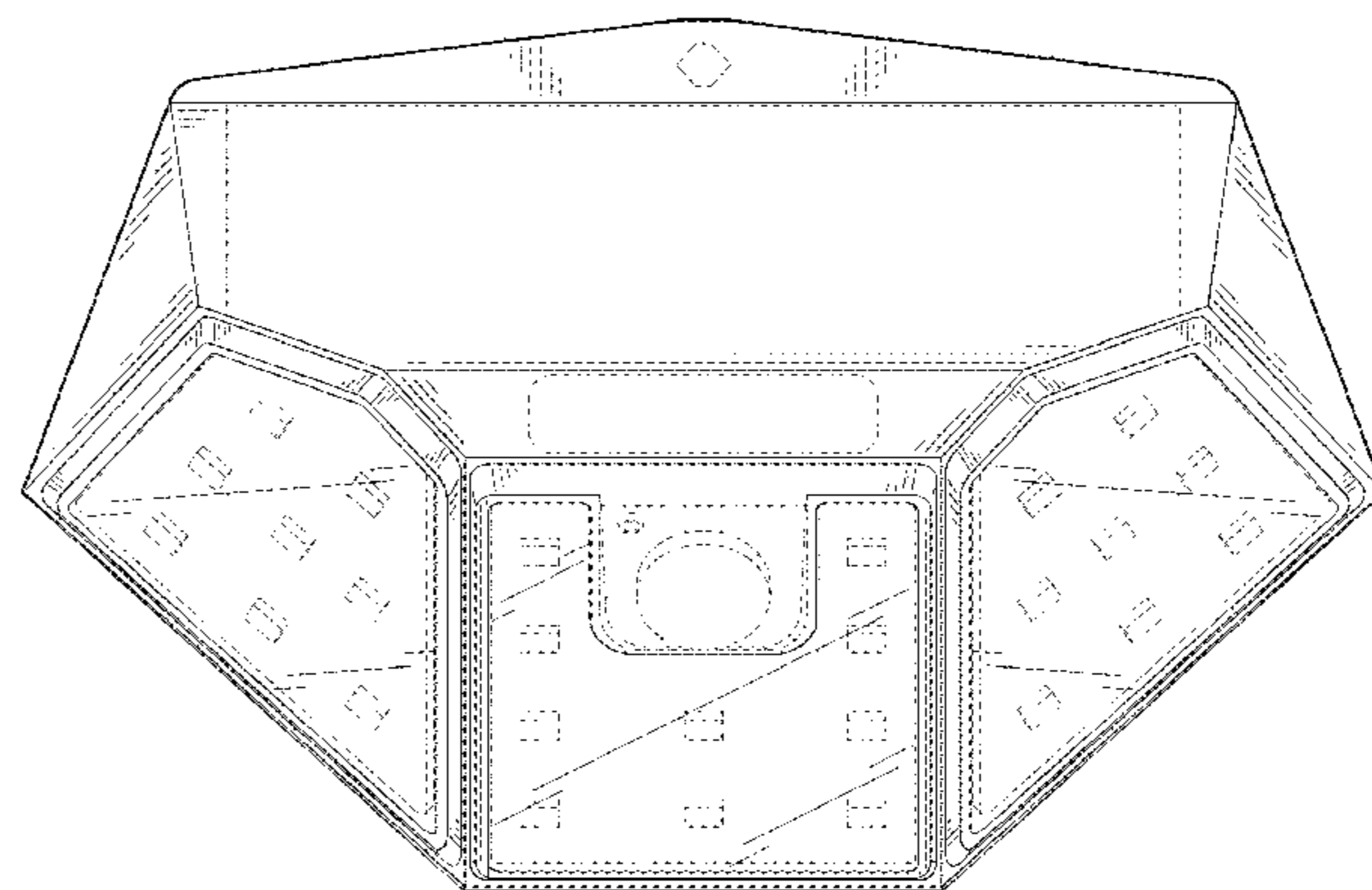
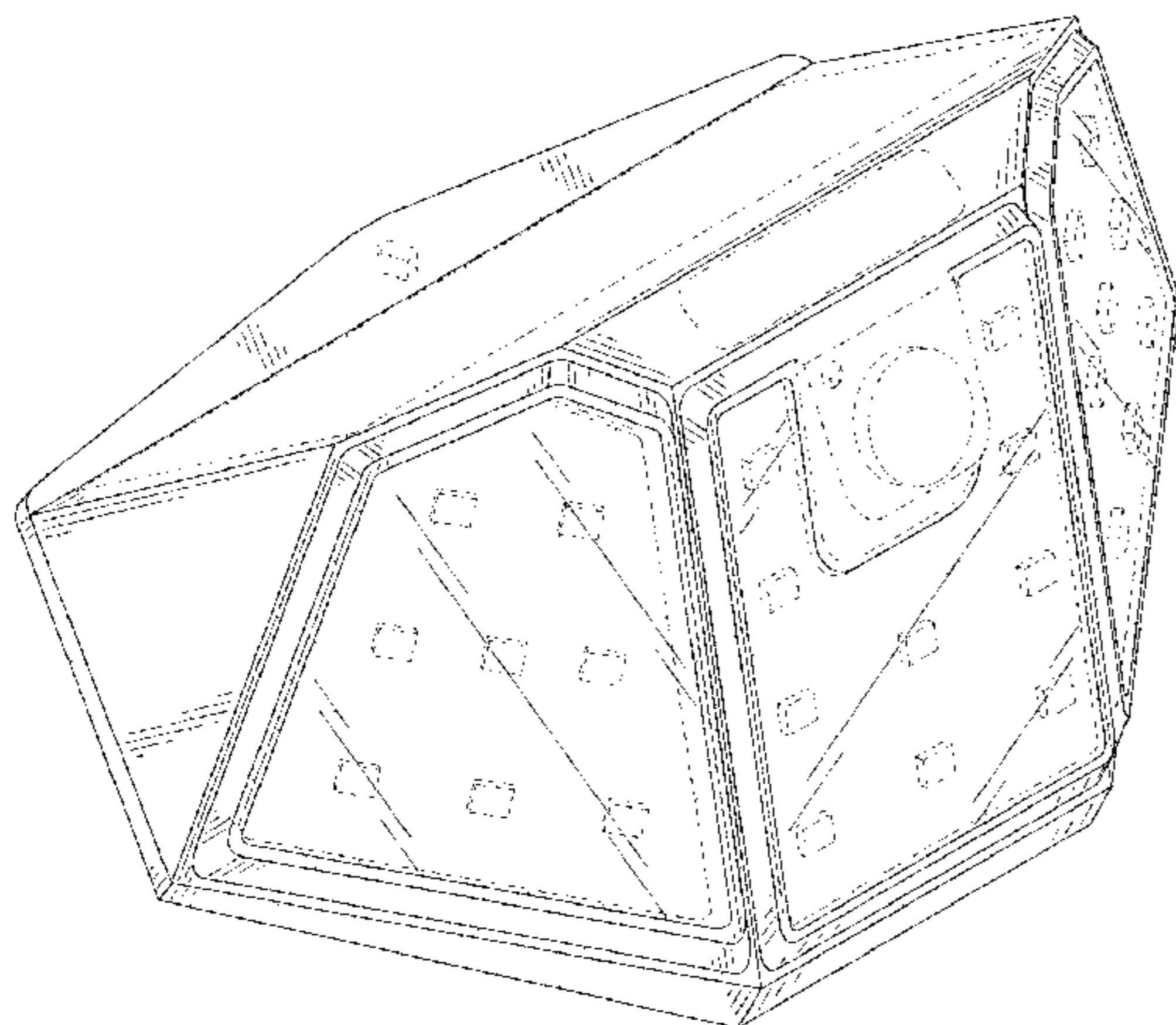
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a first perspective view of an embodiment of a solar lamp showing my new design;
FIG. 2 is a second perspective view of the embodiment of a solar lamp showing my new design;
FIG. 3 is a front elevation view of the embodiment thereof;
FIG. 4 is a rear elevation view of the embodiment thereof;
FIG. 5 is a left side elevation view of the embodiment thereof;

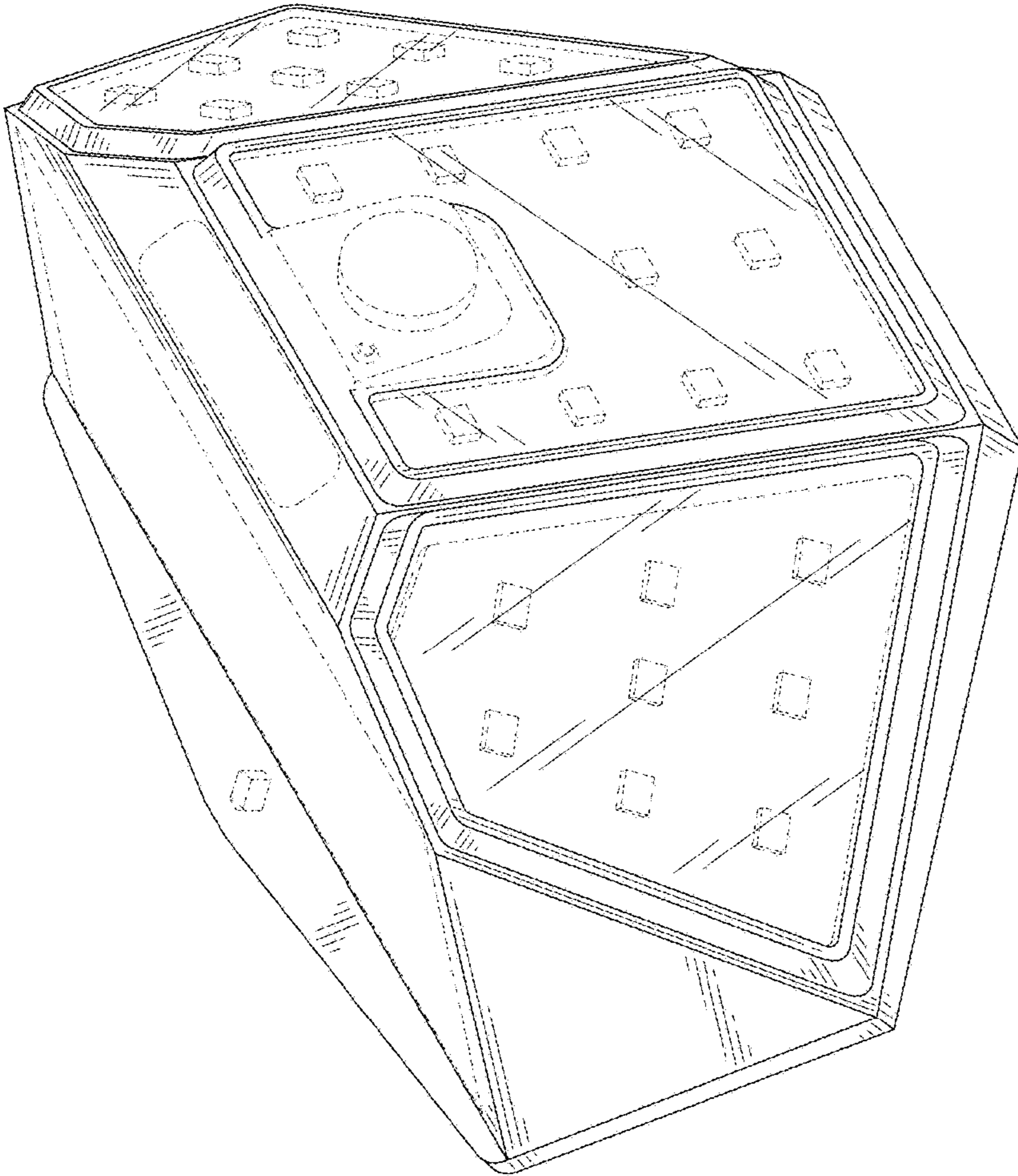

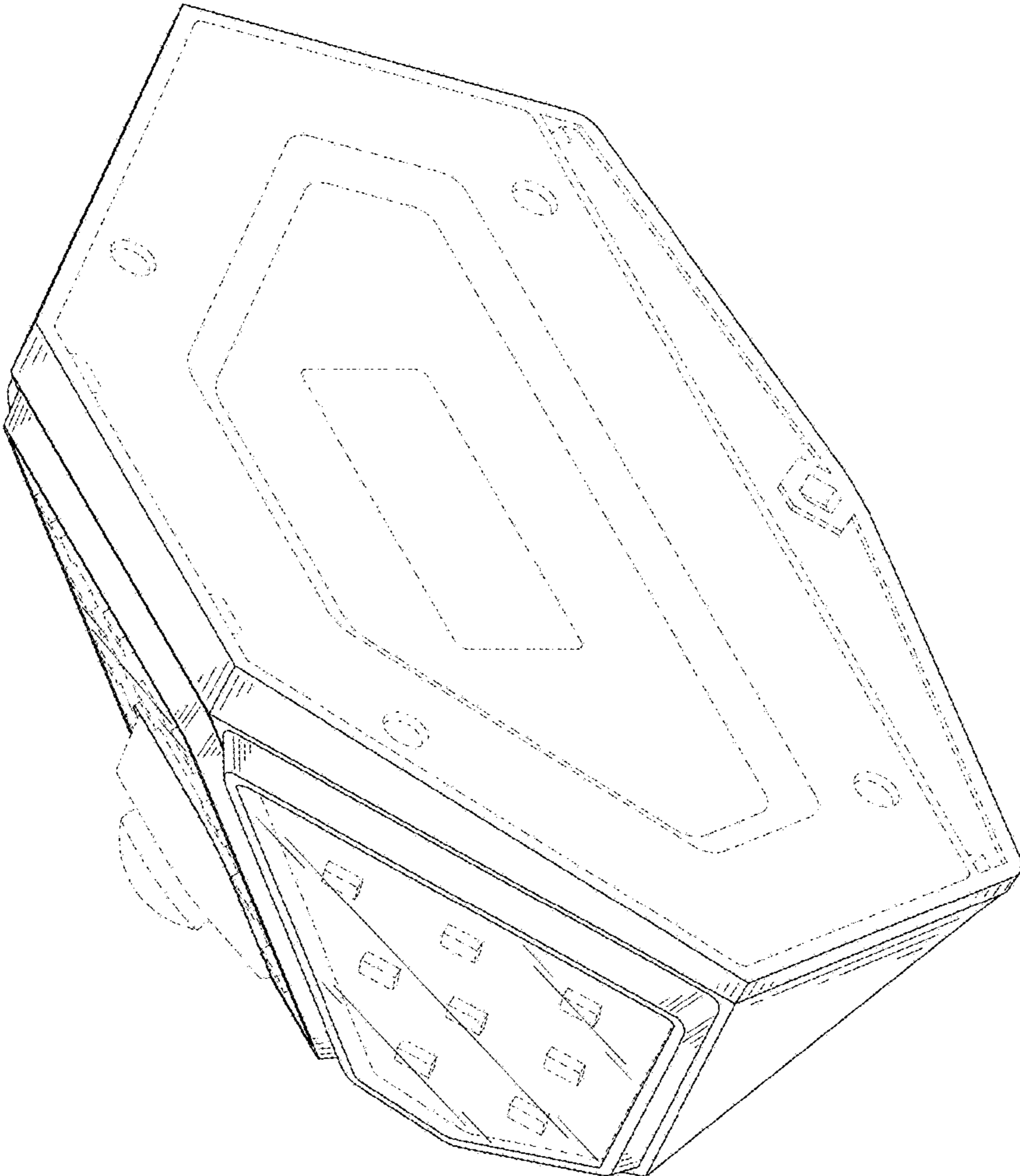

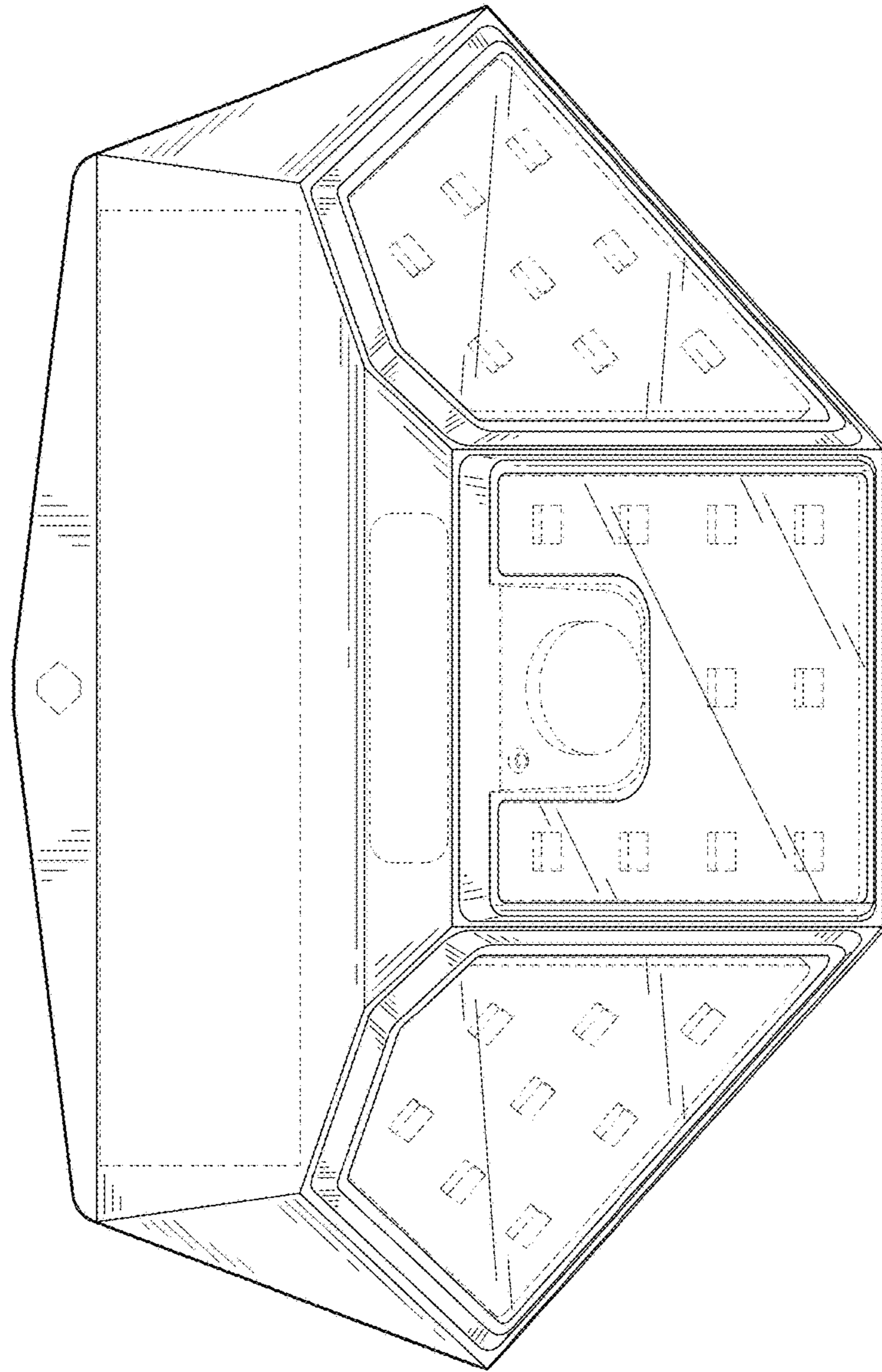

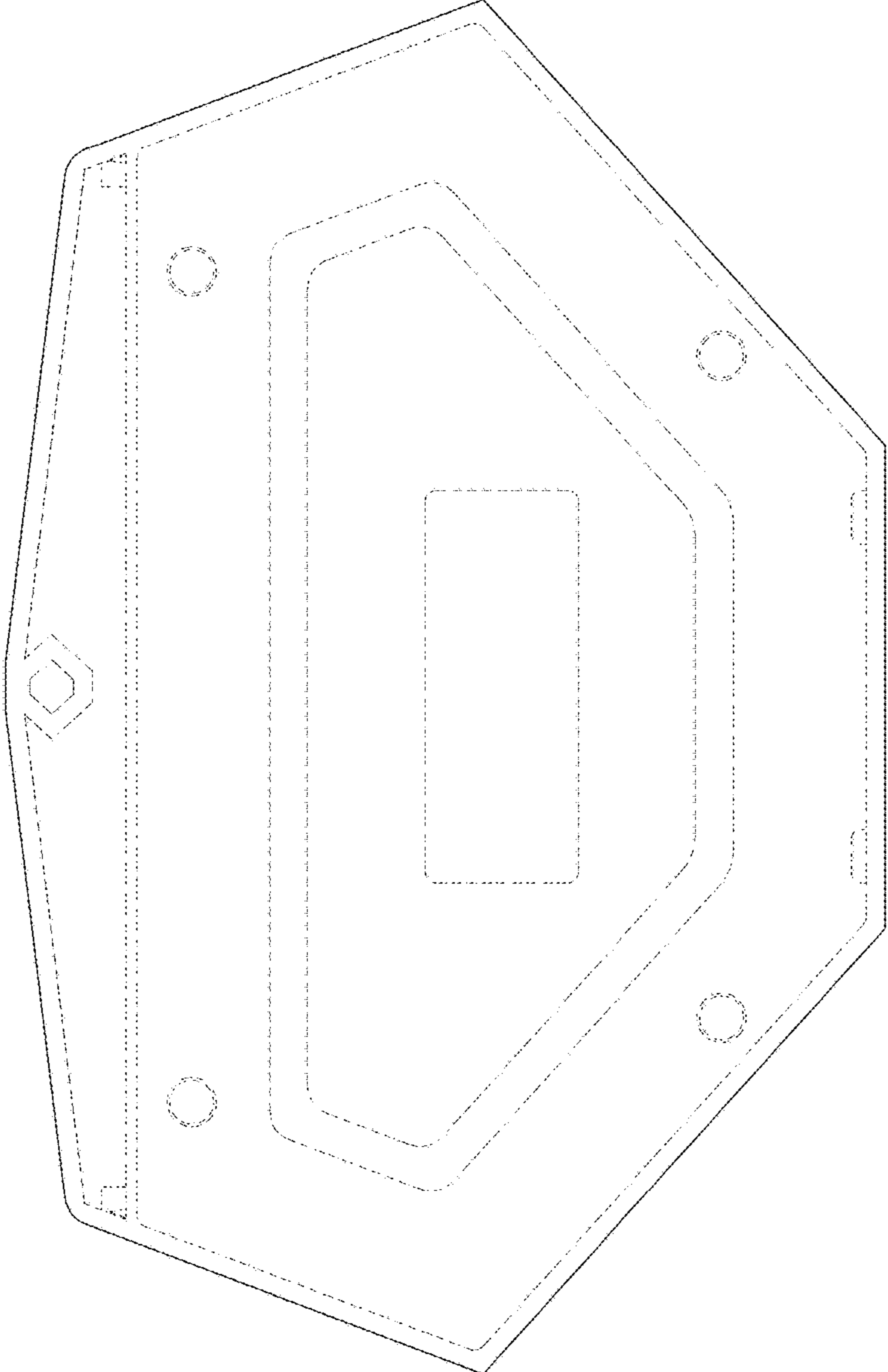

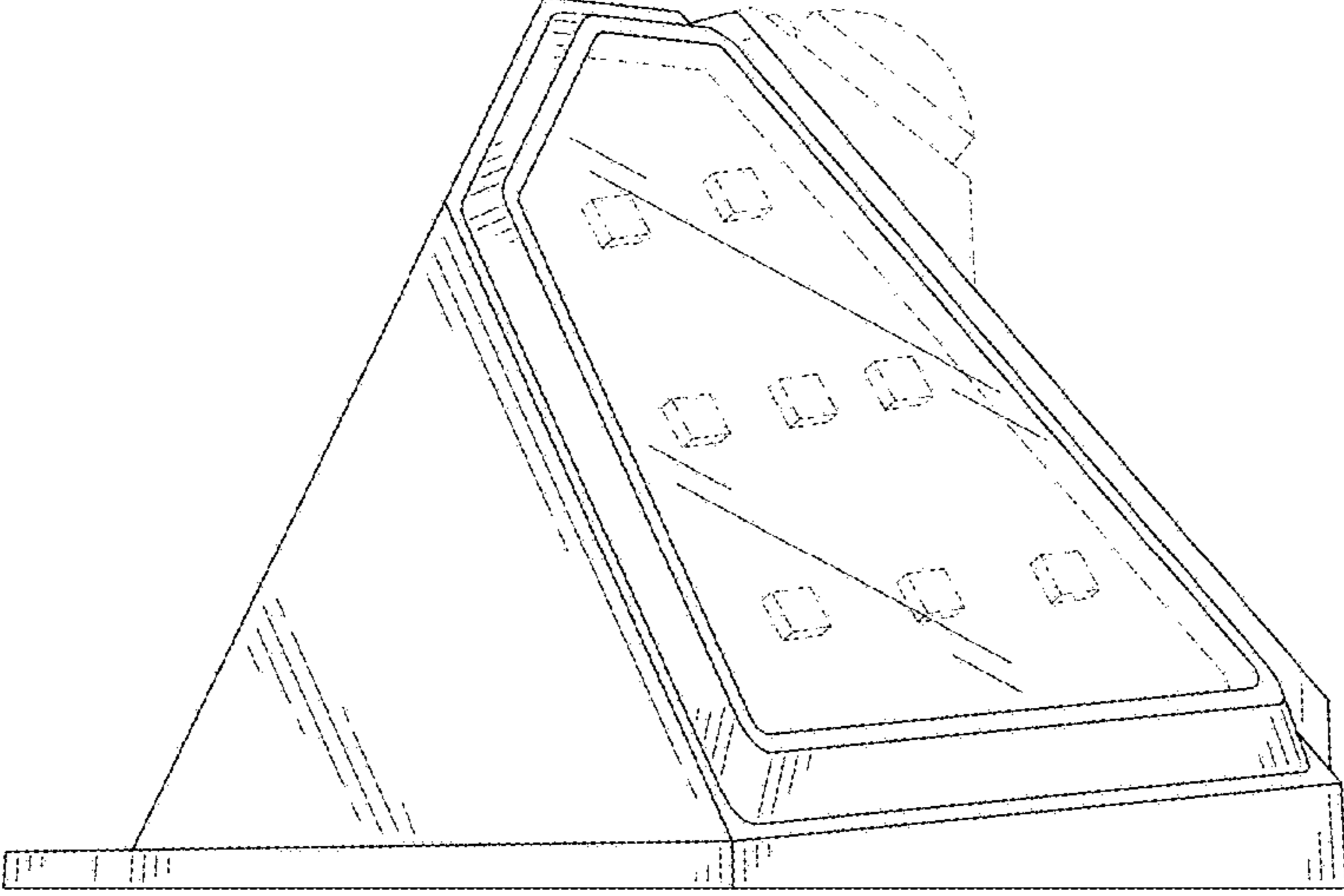

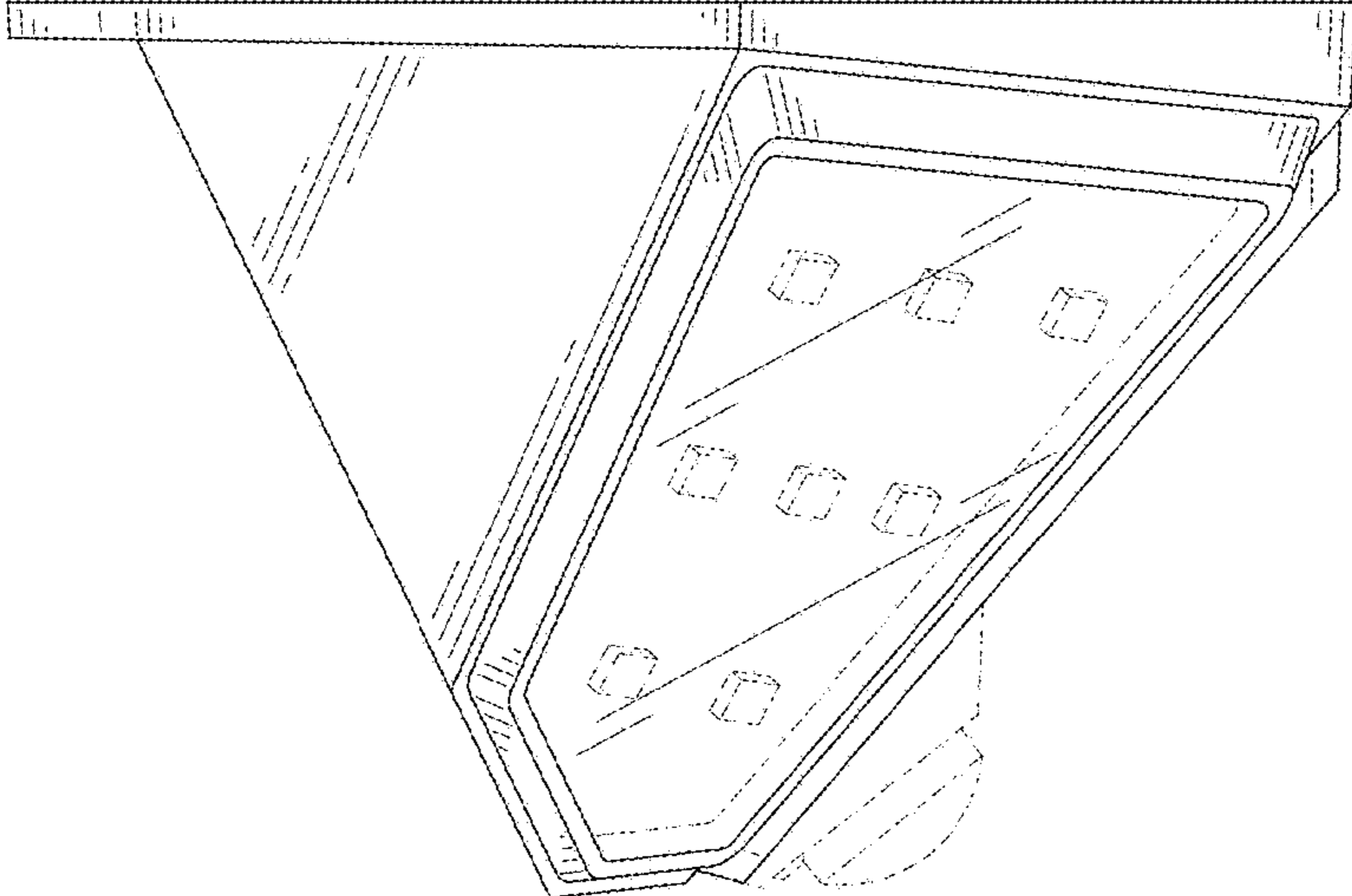

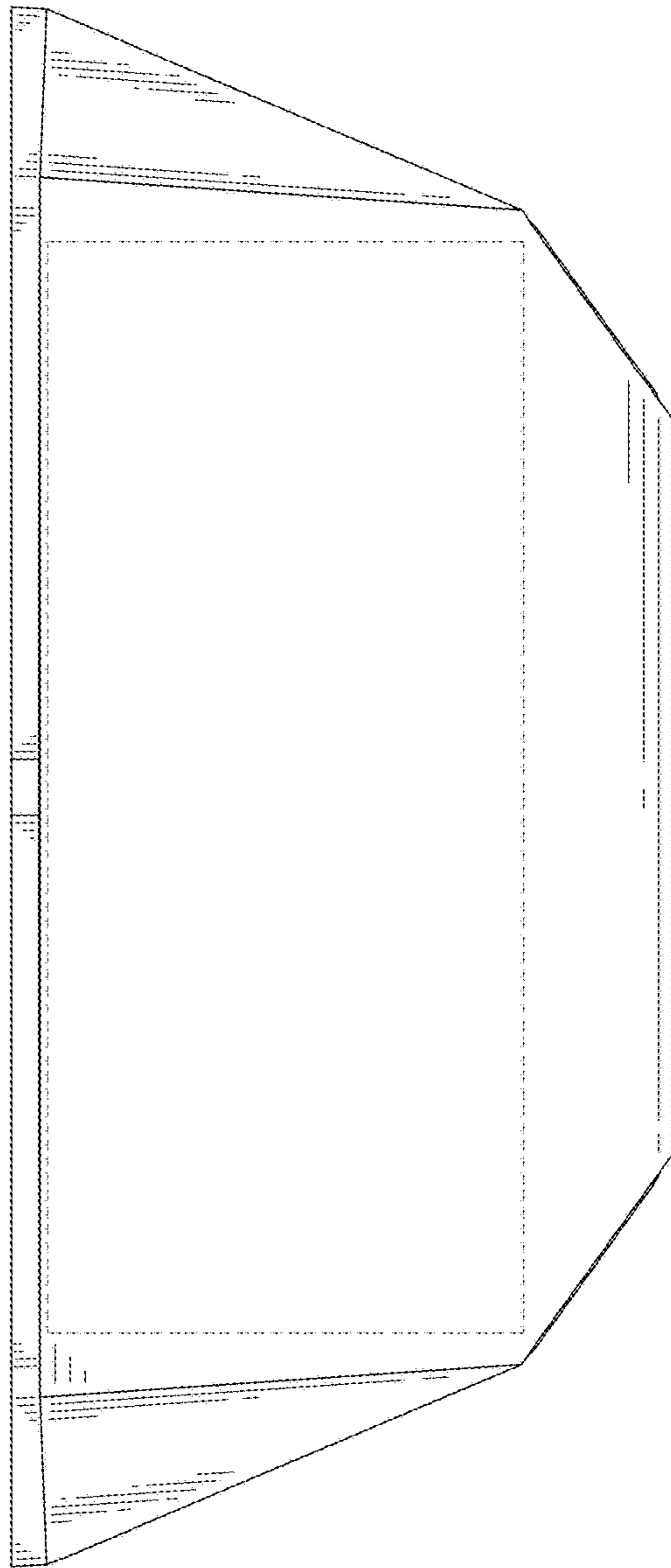

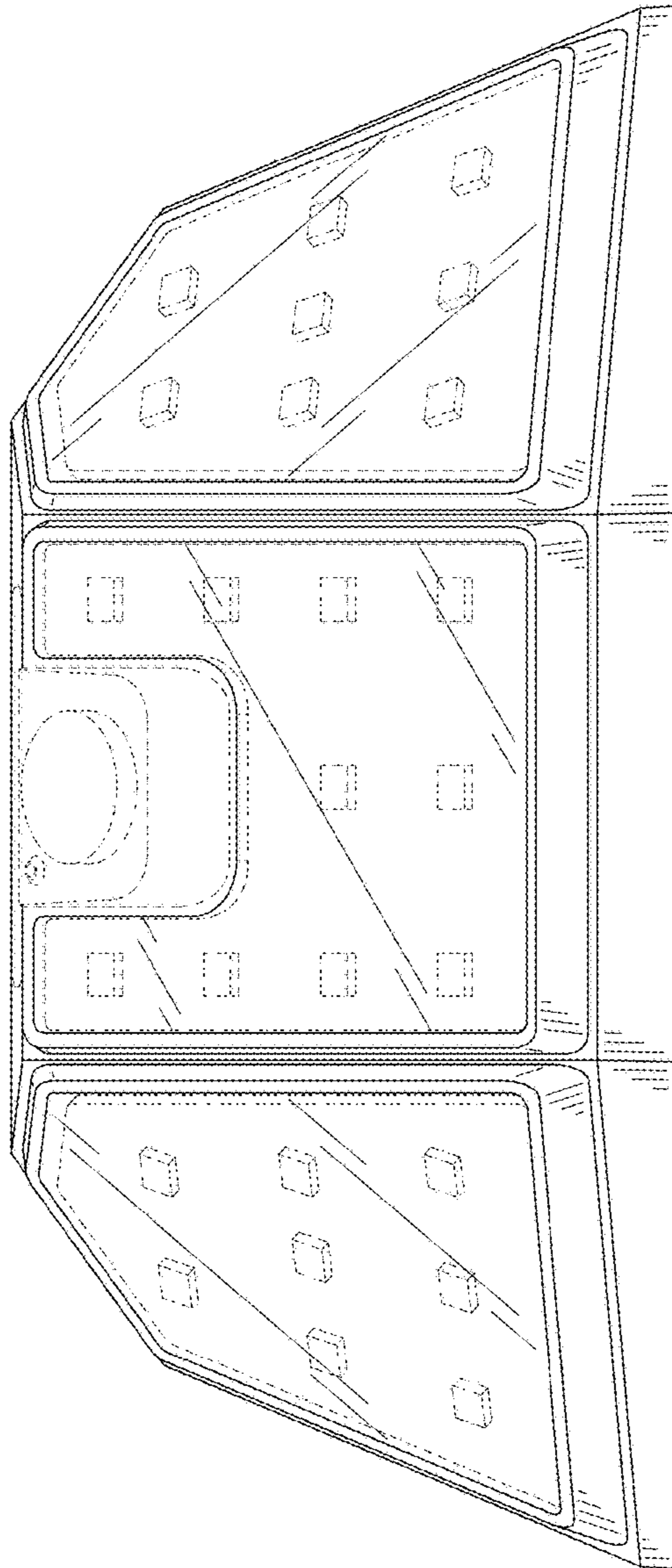
