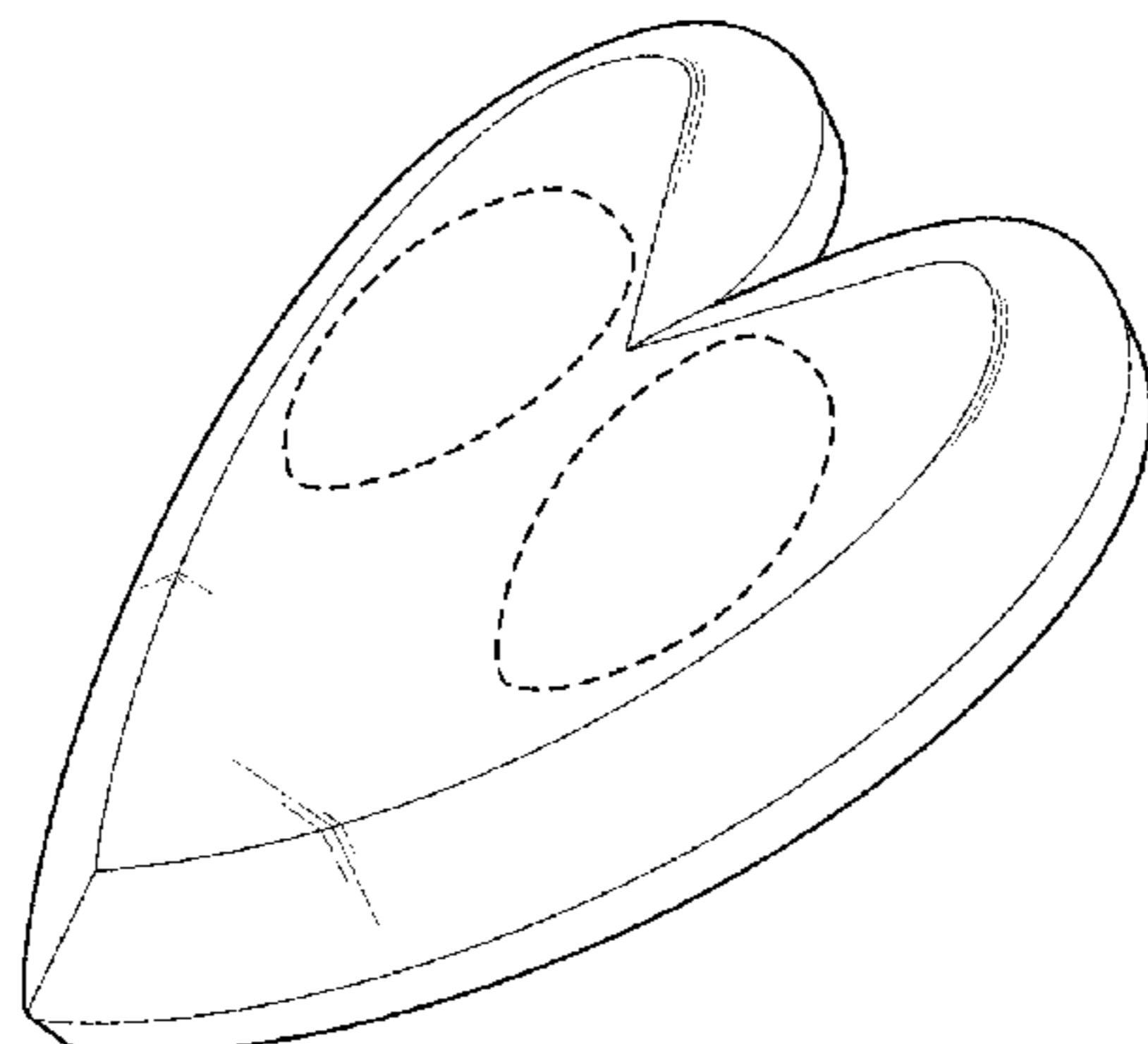
The ornamental design for a depilatory device, as shown and described.

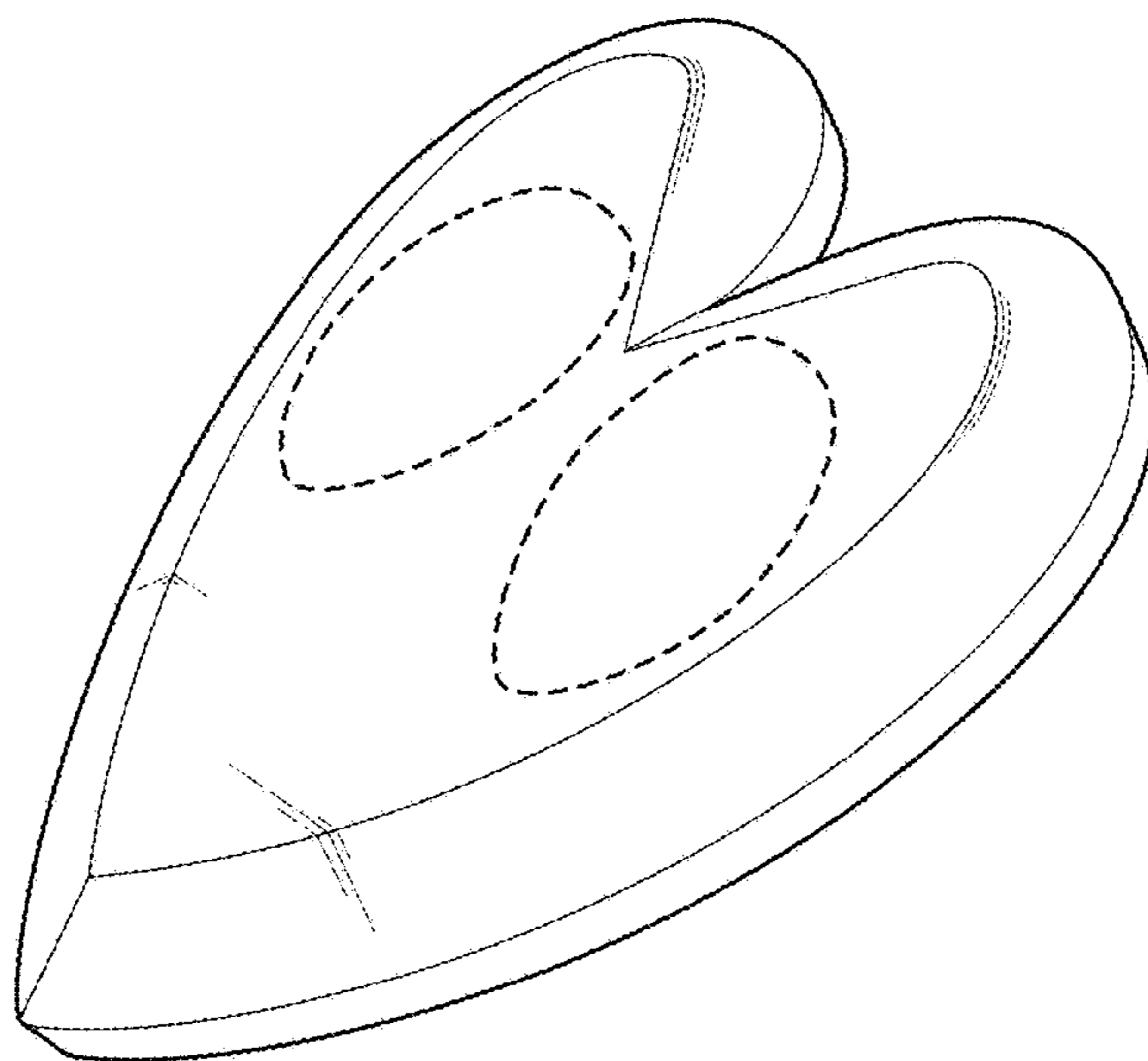
**DESCRIPTION**

The broken lines are included for the purpose of illustrating portions of the depilatory device which form no part of the claimed design.

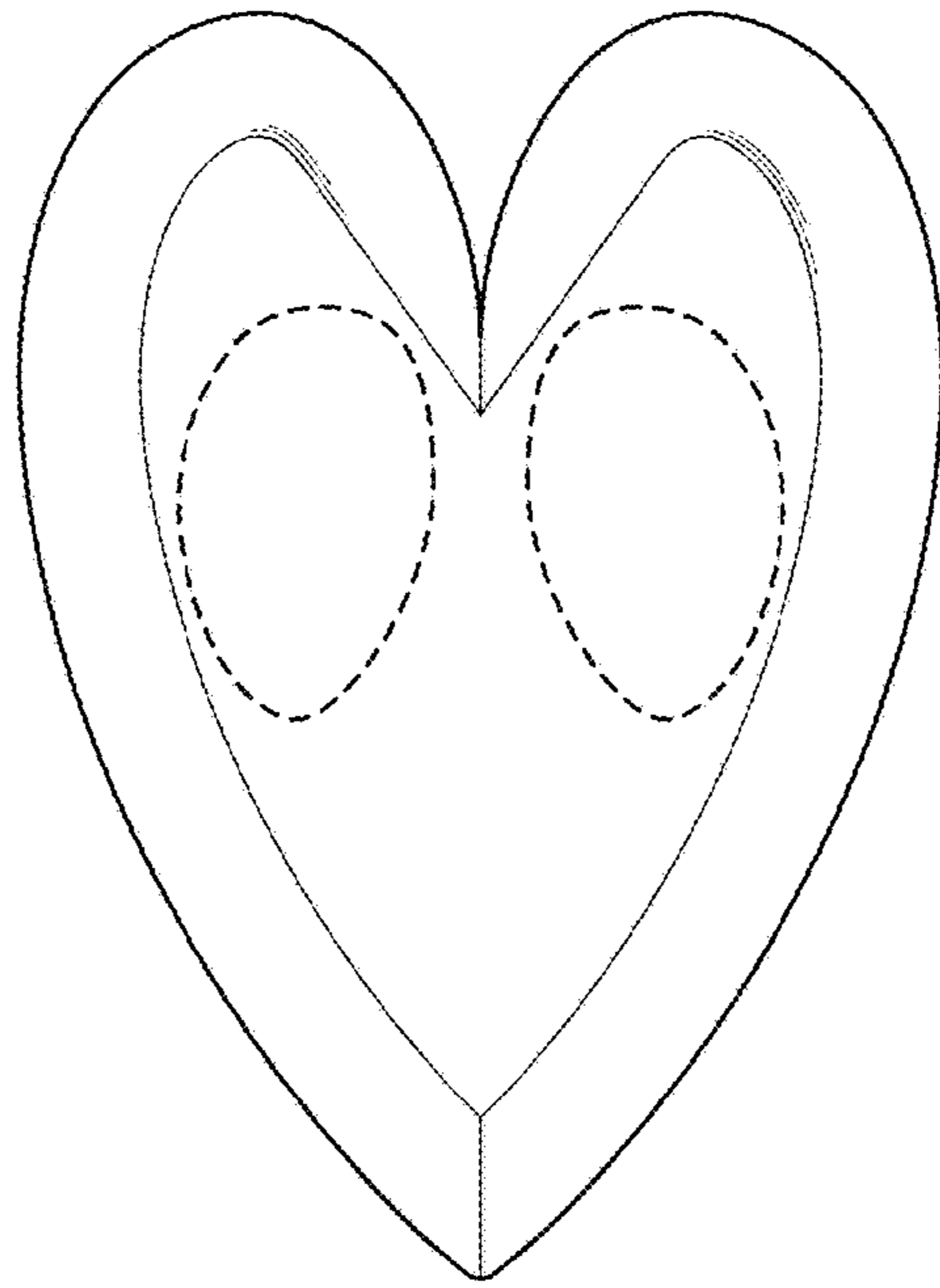

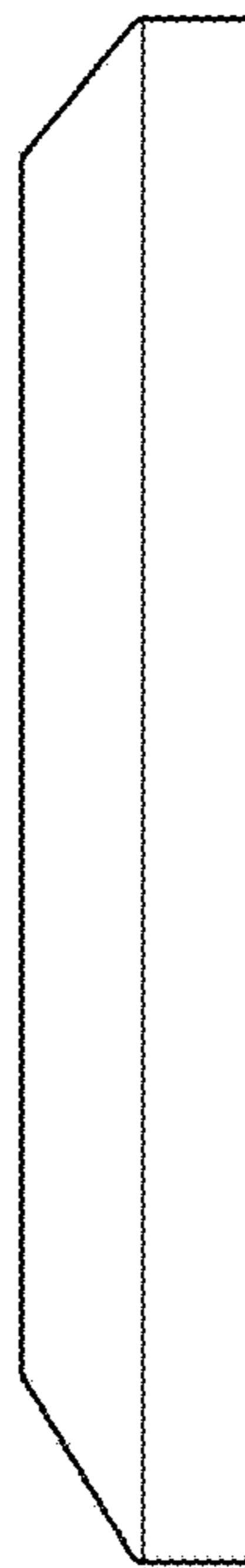




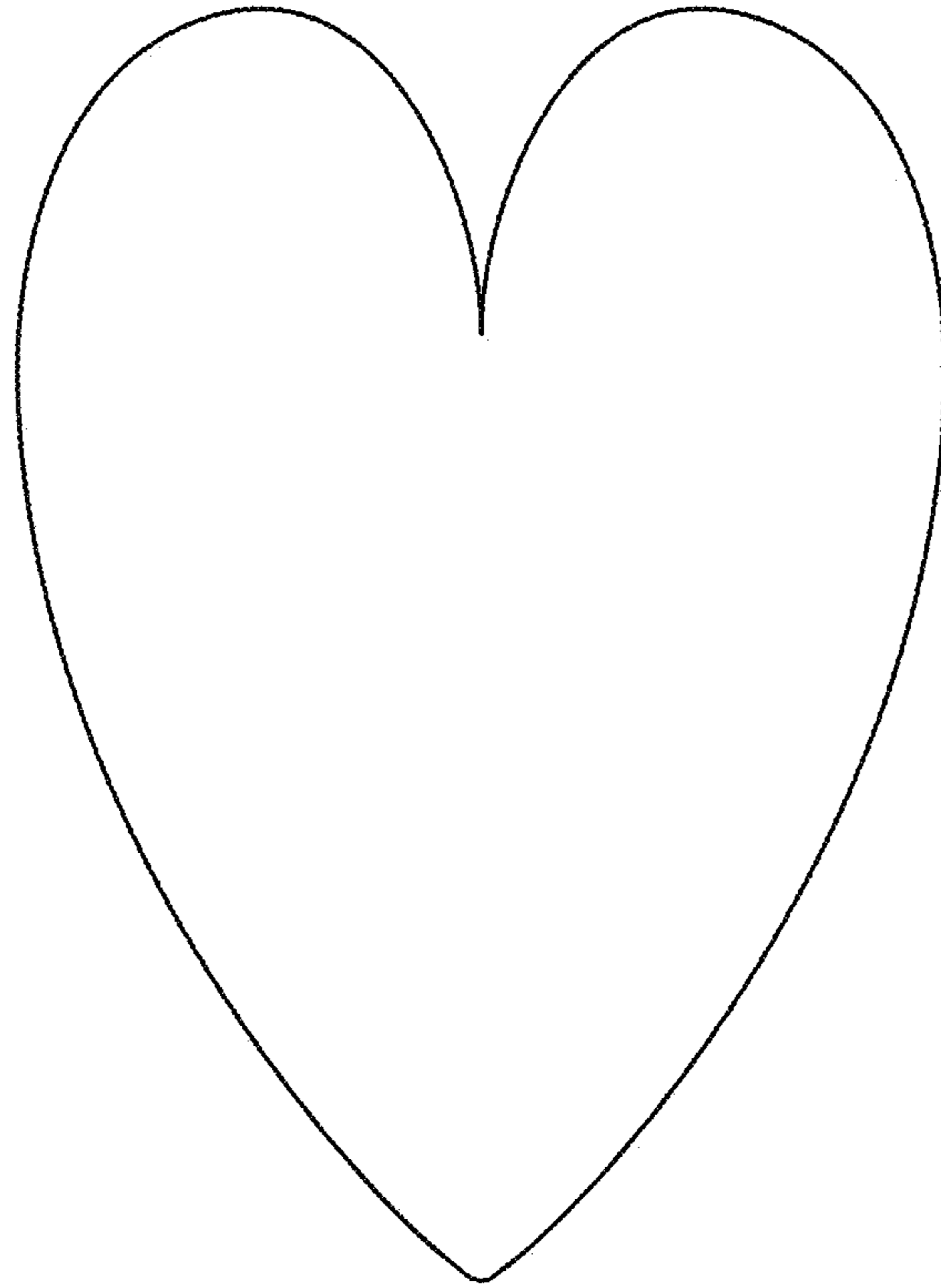

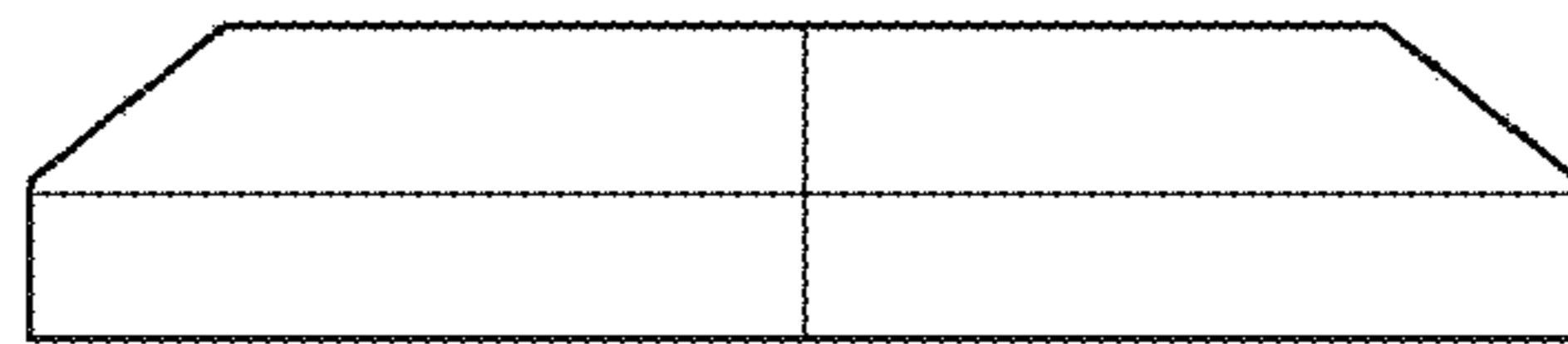

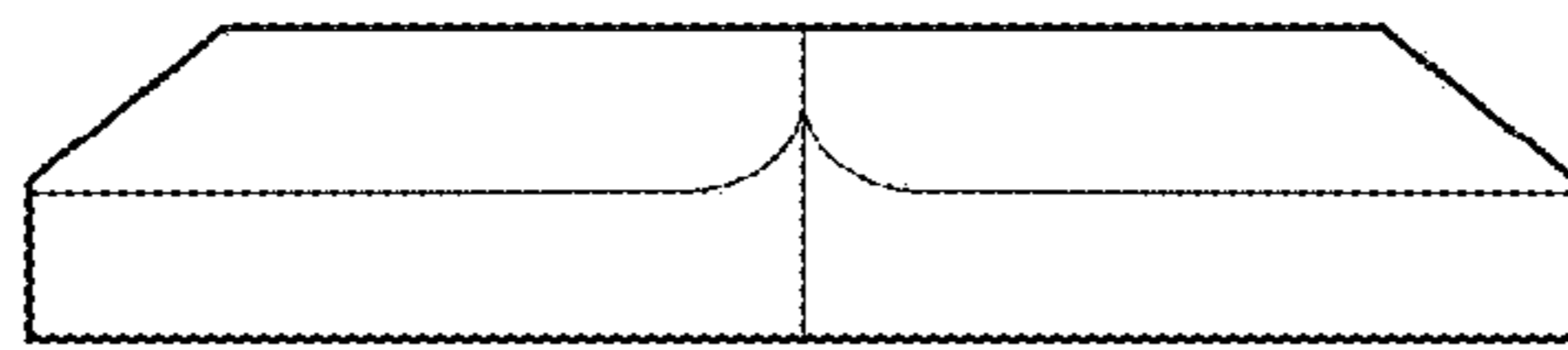
