(57) **CLAIM**

The ornamental design for a grill scraper, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a grill scraper according to my new design;

FIG. 2 is a front view of the grill scraper of FIG. 1;

FIG. 3 is a right side elevation view of the grill scraper of FIG. 1, the left side elevation view being a mirror image thereof;

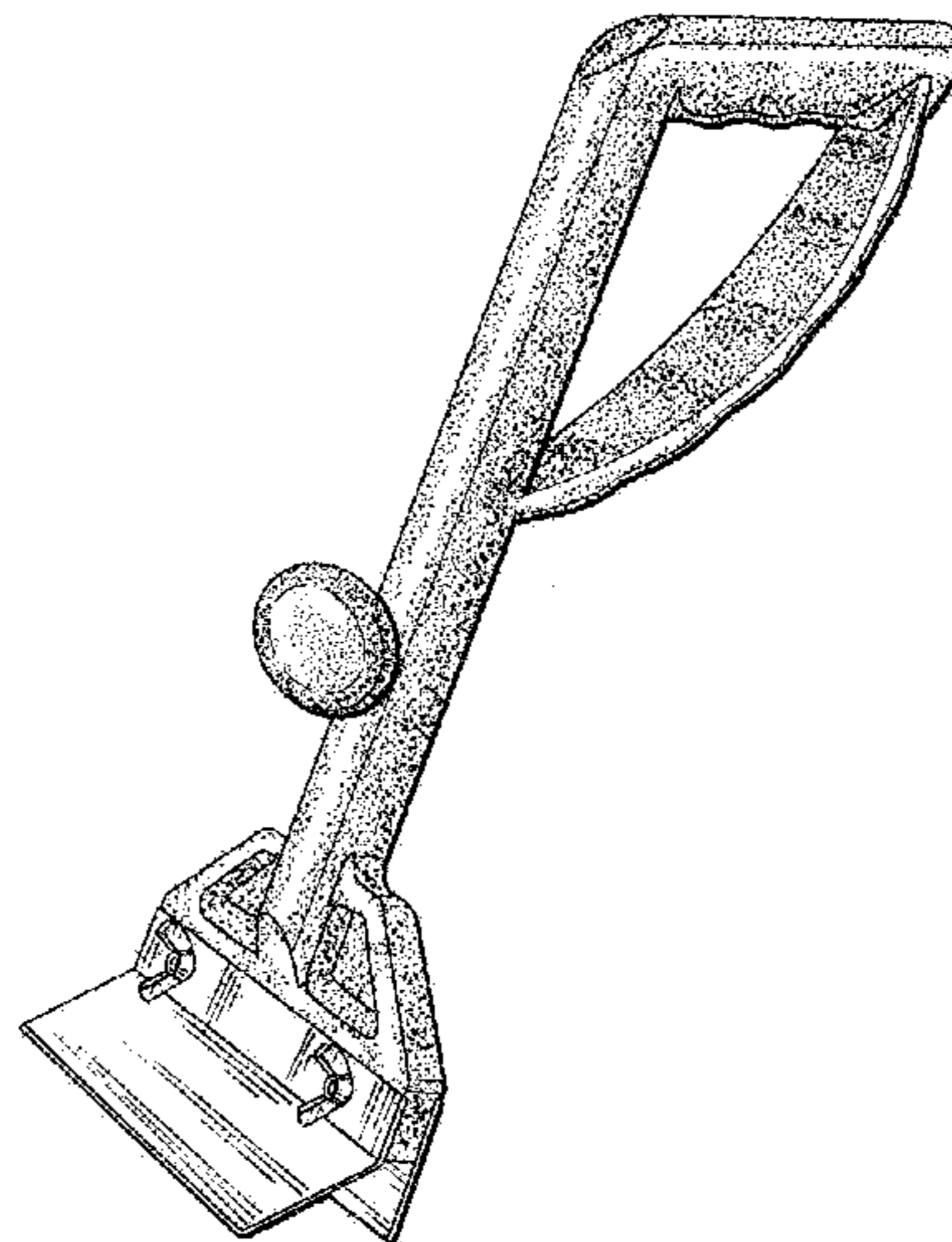
FIG. 4 is a rear view of the grill scraper of FIG. 1;

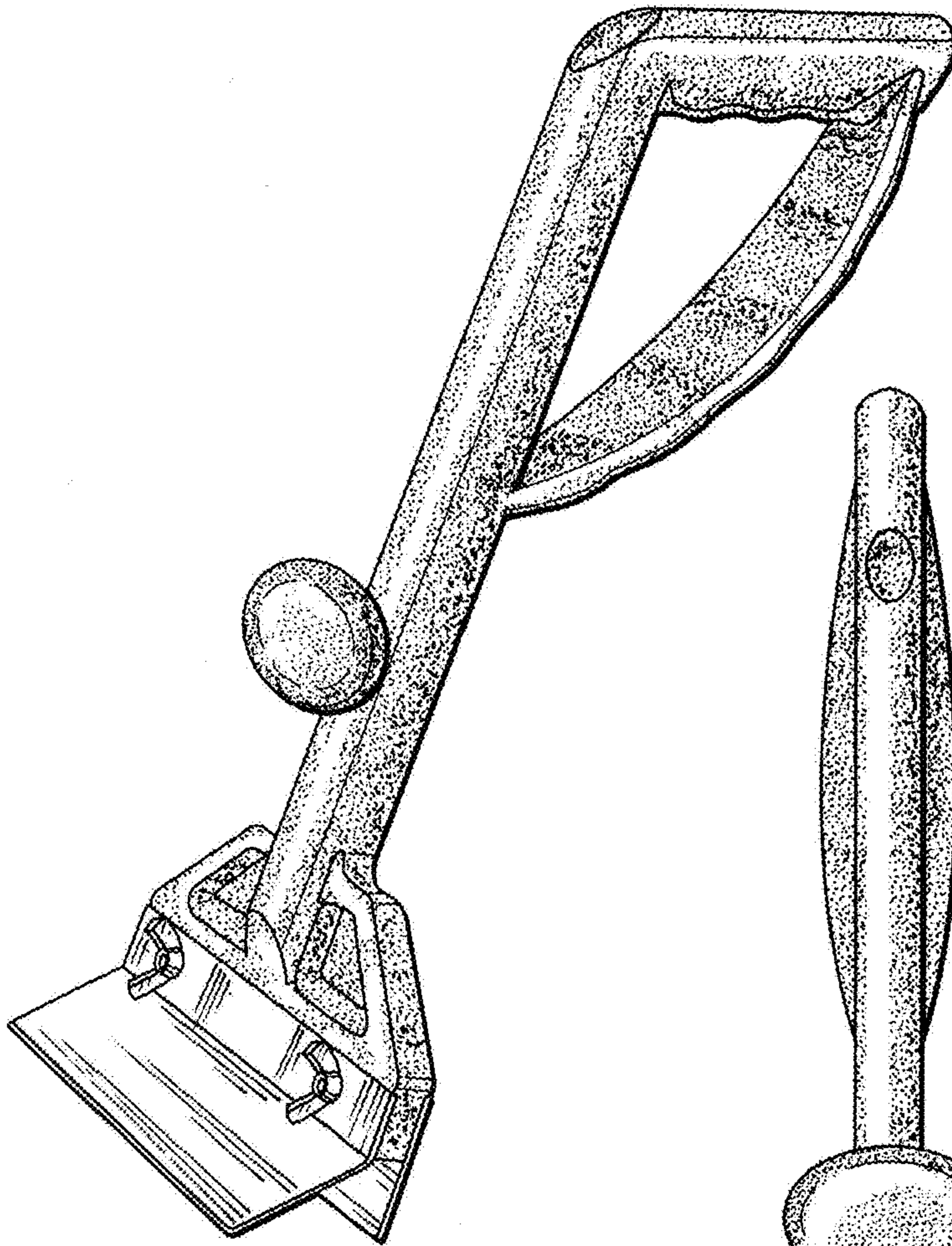
FIG. 5 is a cross-sectional view of the grill scraper of FIG. 1 taken at line 5-5 of FIG. 2;

FIG. 6 is a top view of the grill scraper of FIG. 1. and,

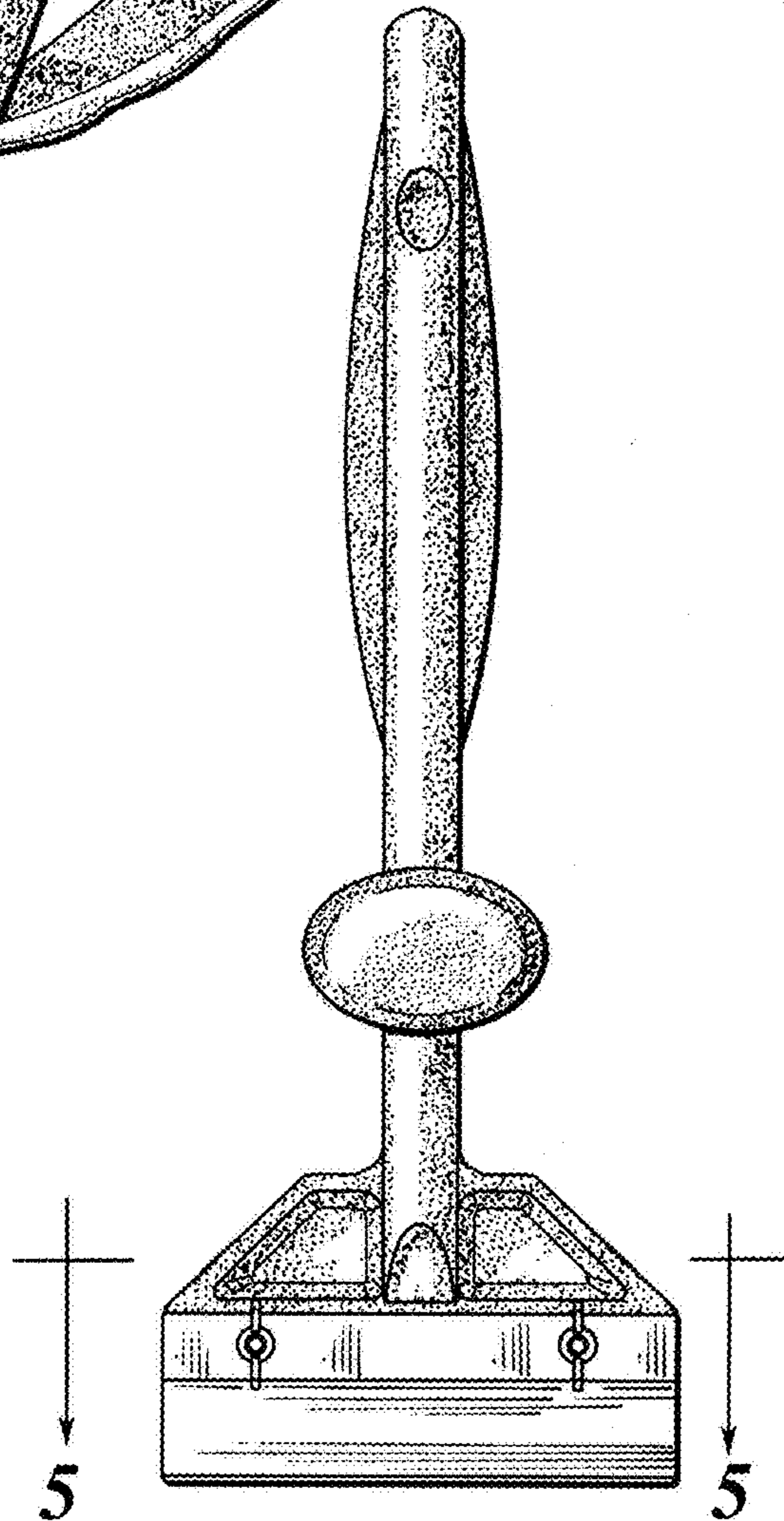
FIG. 7 is a bottom view of the grill scraper of FIG. 1.

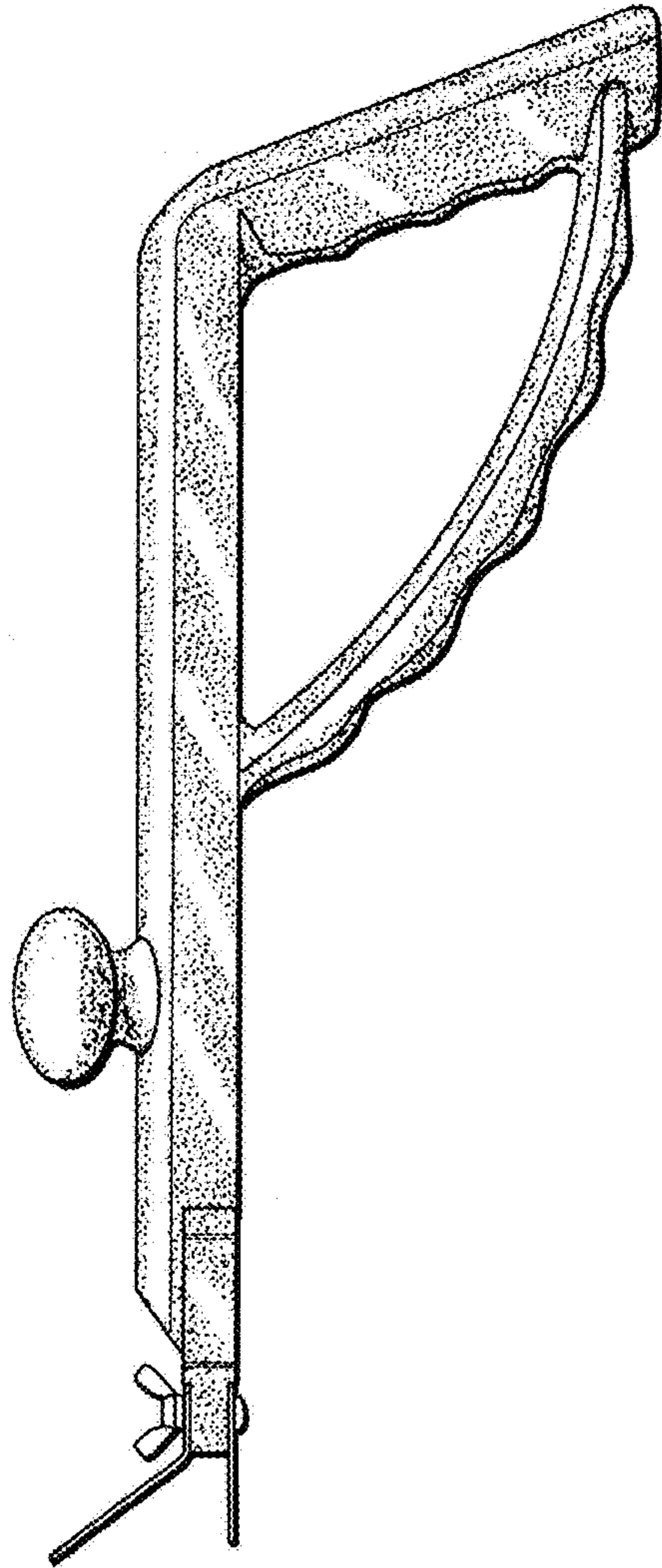




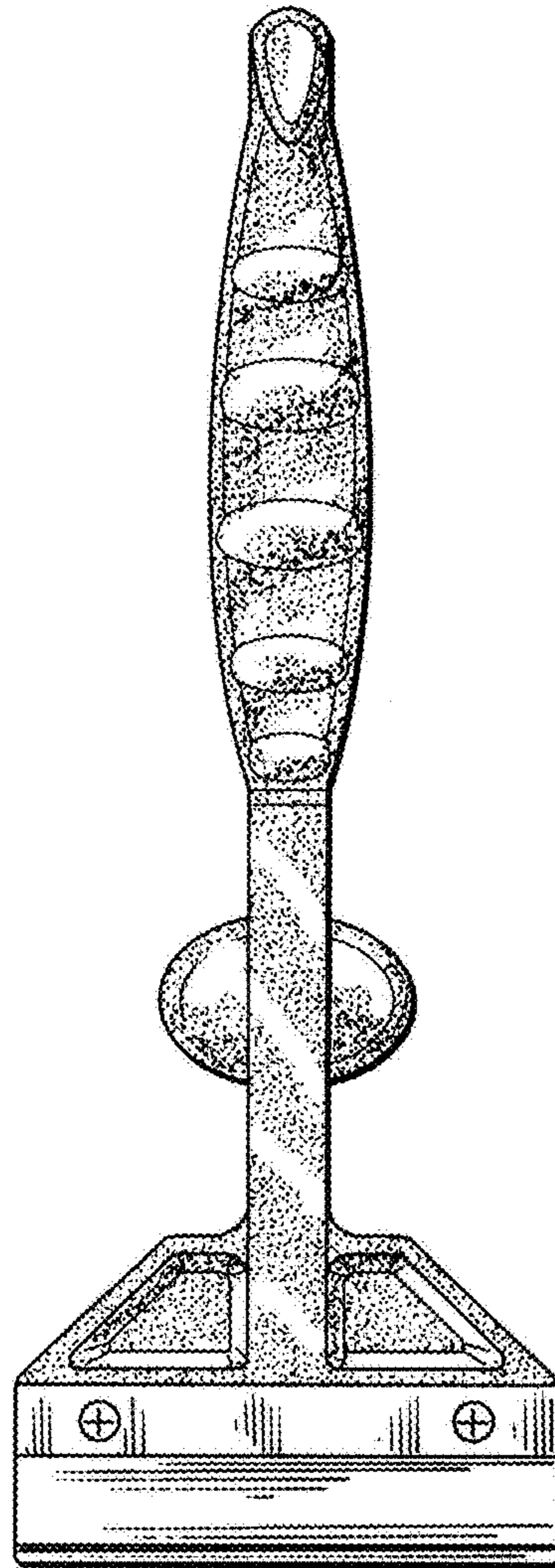

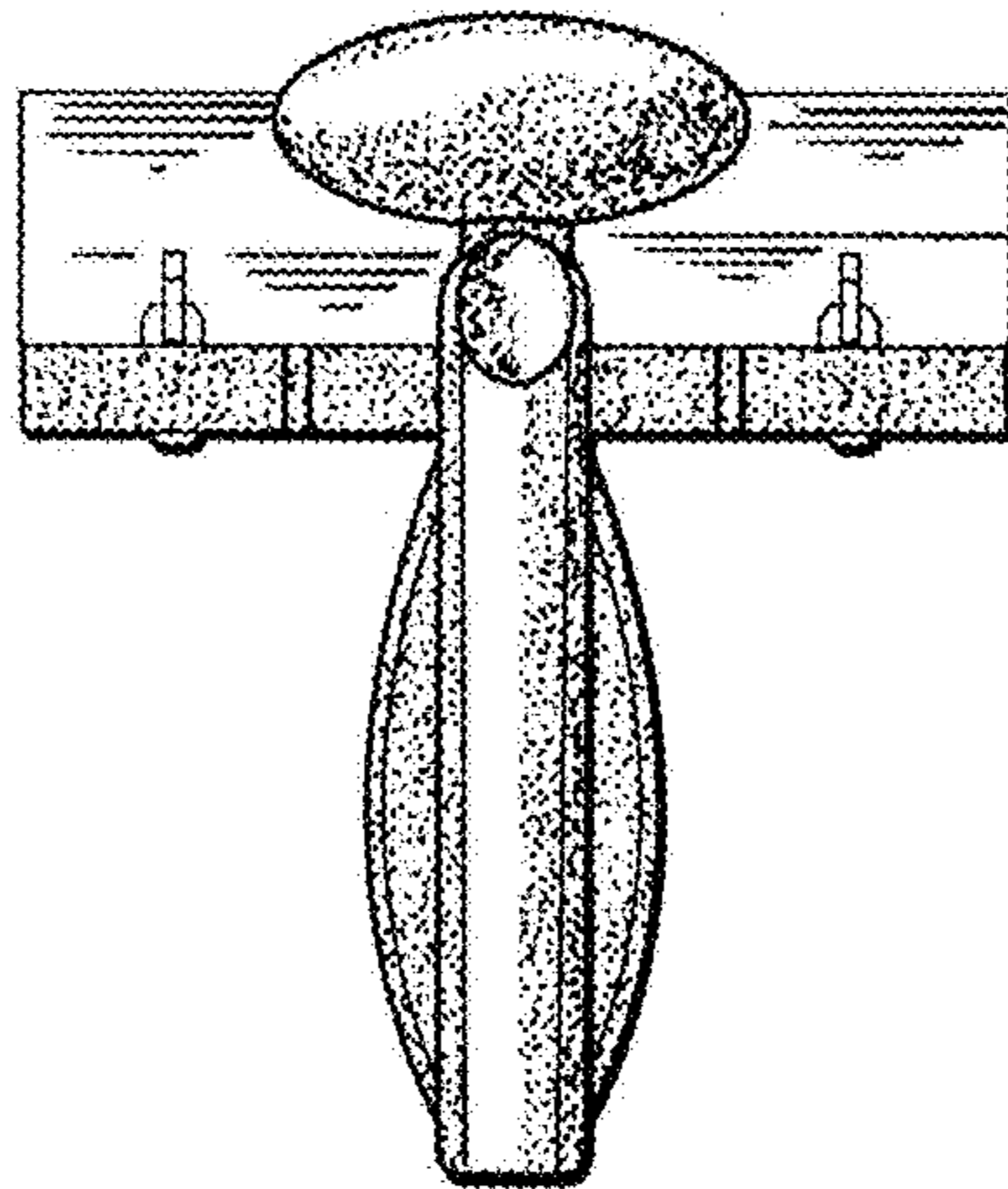

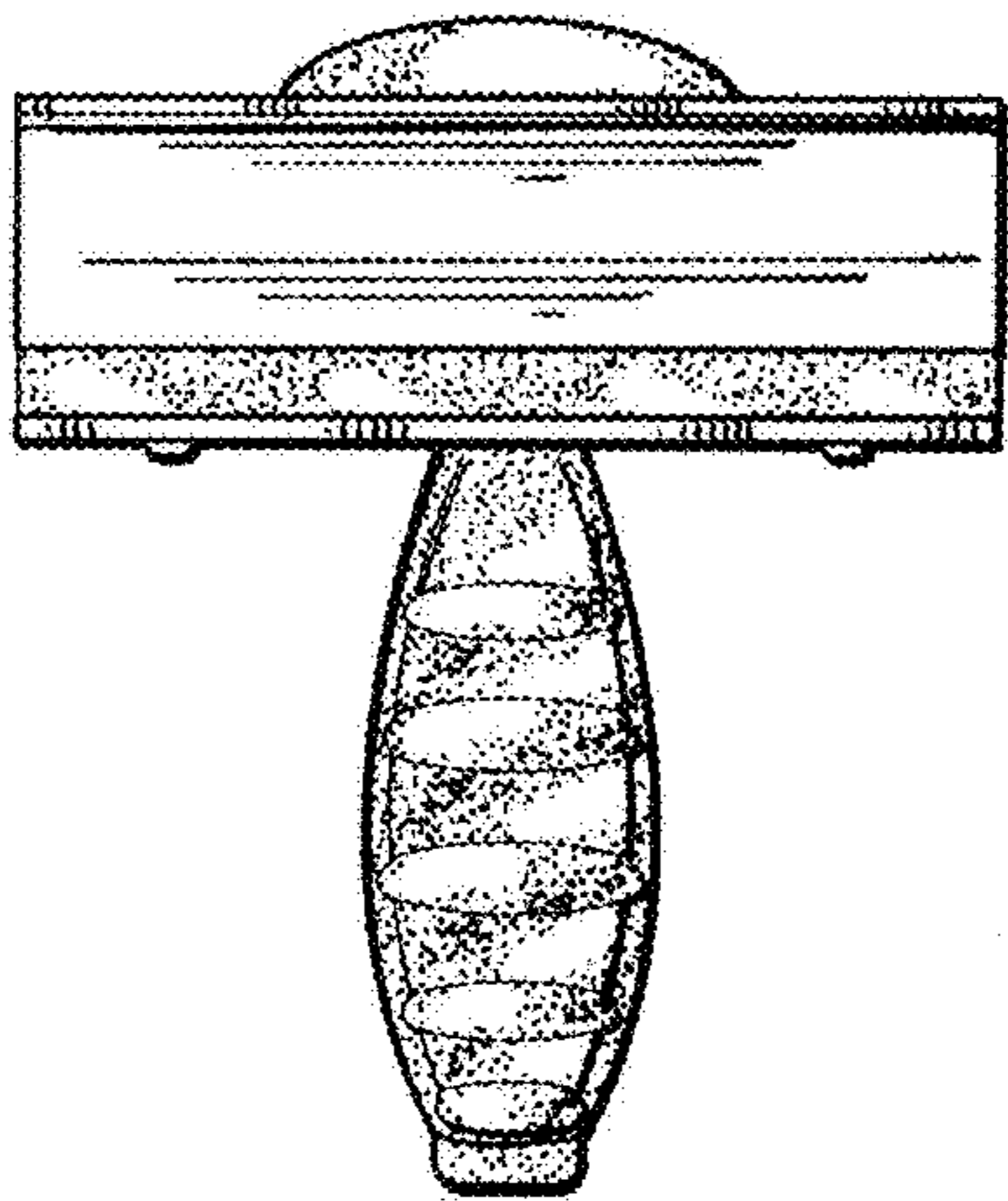
