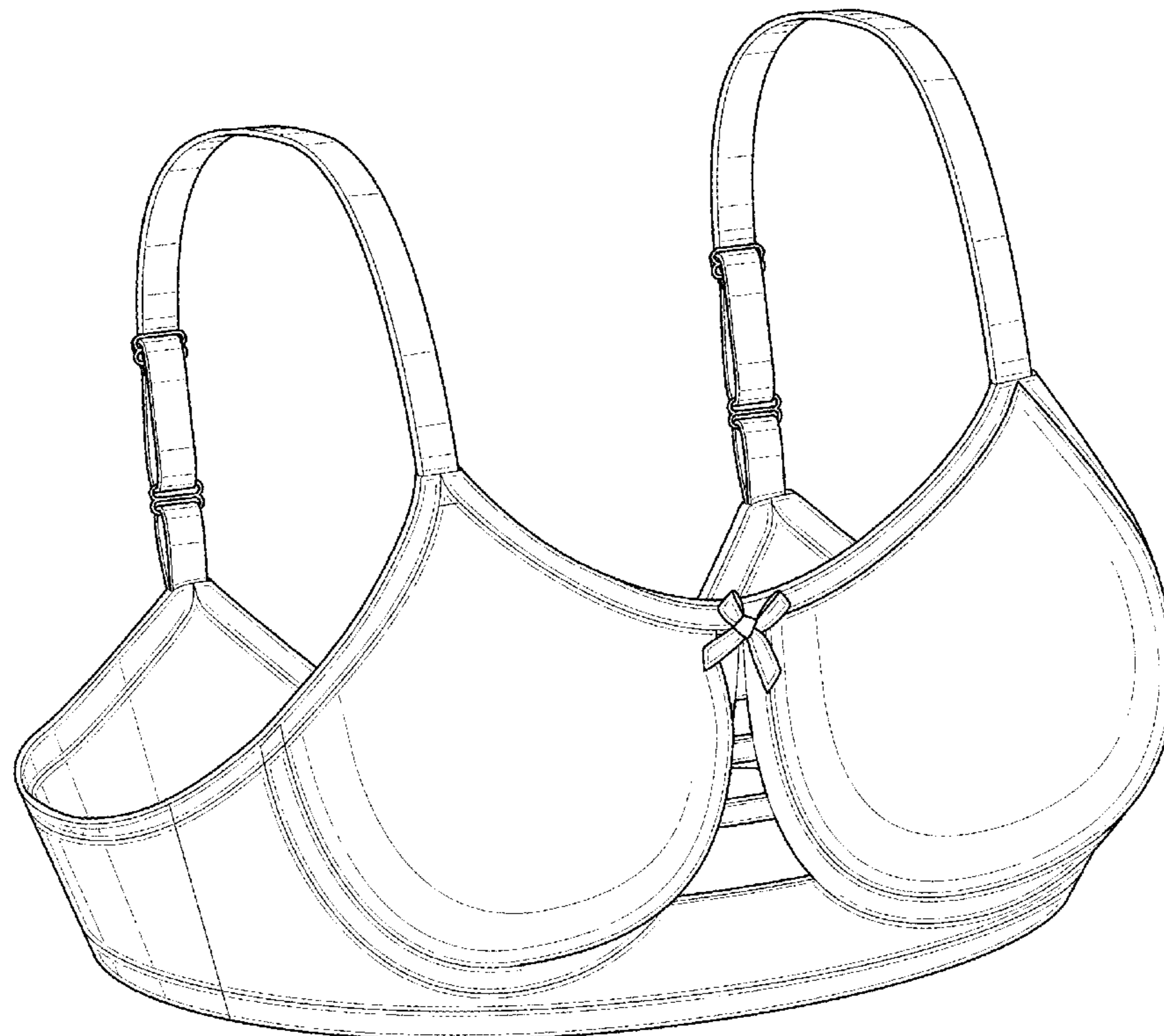
(57) **CLAIM**

I claim the ornamental design for a bra with an extended lower band, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a bra with an extended lower band, showing my new invention; FIG. 2 is a front view of the bra of FIG. 1; FIG. 3 is a back view of the bra of FIG. 1; FIG. 4 is a left side view of the bra of FIG. 1; FIG. 5 is a right side view of the bra of FIG. 1; FIG. 6 is a top side view of the bra of FIG. 1; FIG. 7 is a bottom side view of the bra of FIG. 1; and, FIG. 8 is a cross-sectional view of the bra, taken along line 8-8 in FIG. 6.

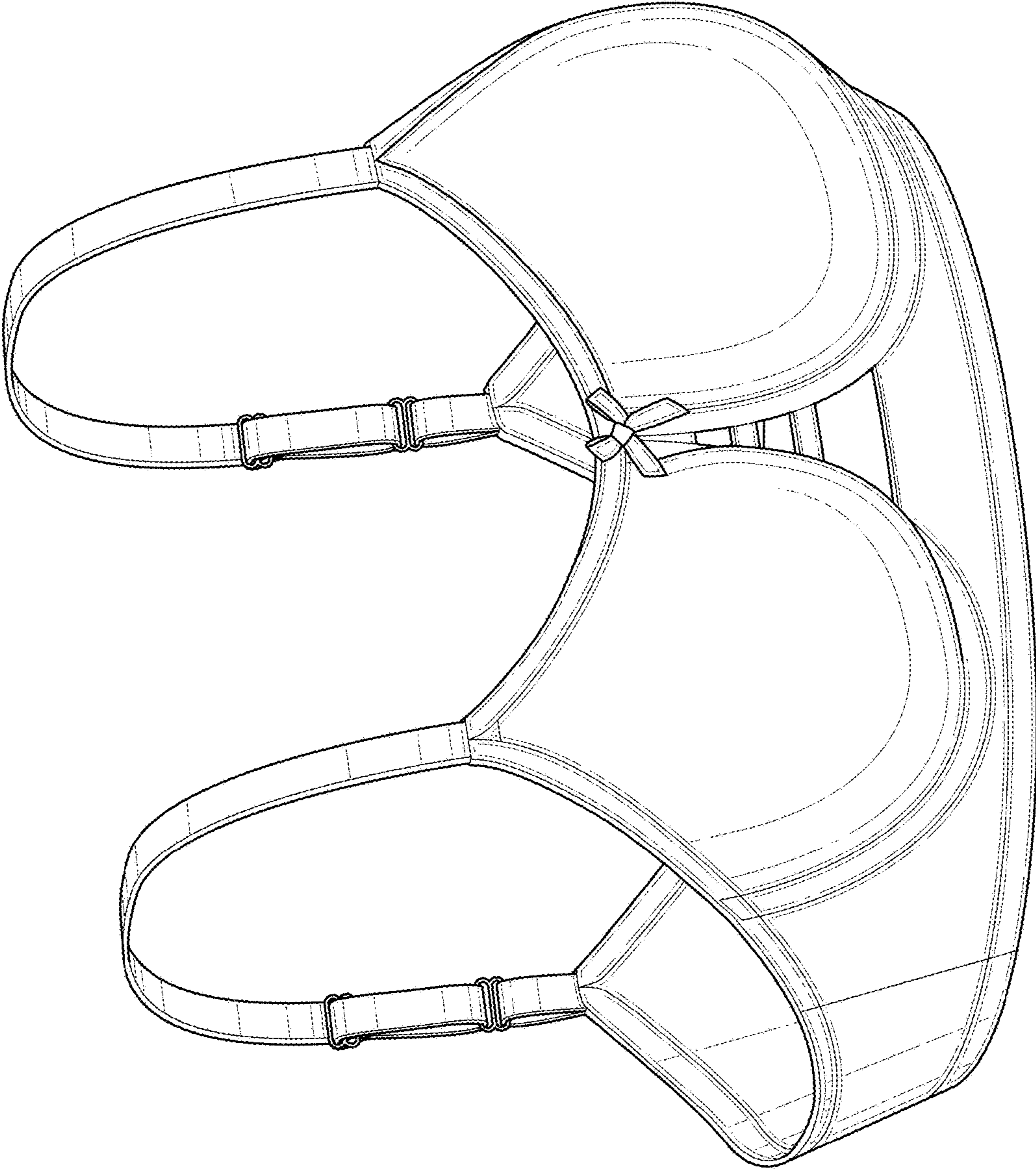

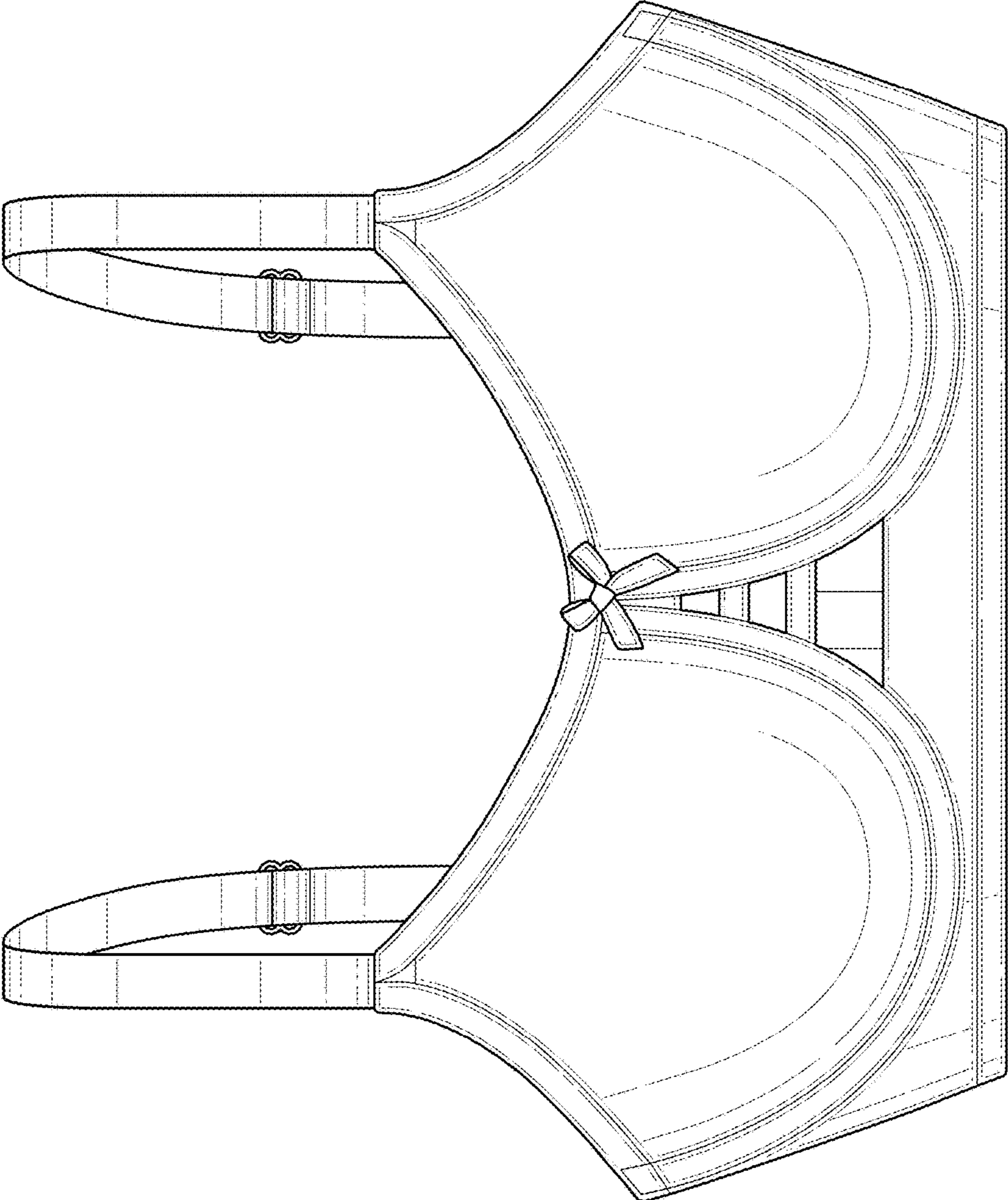

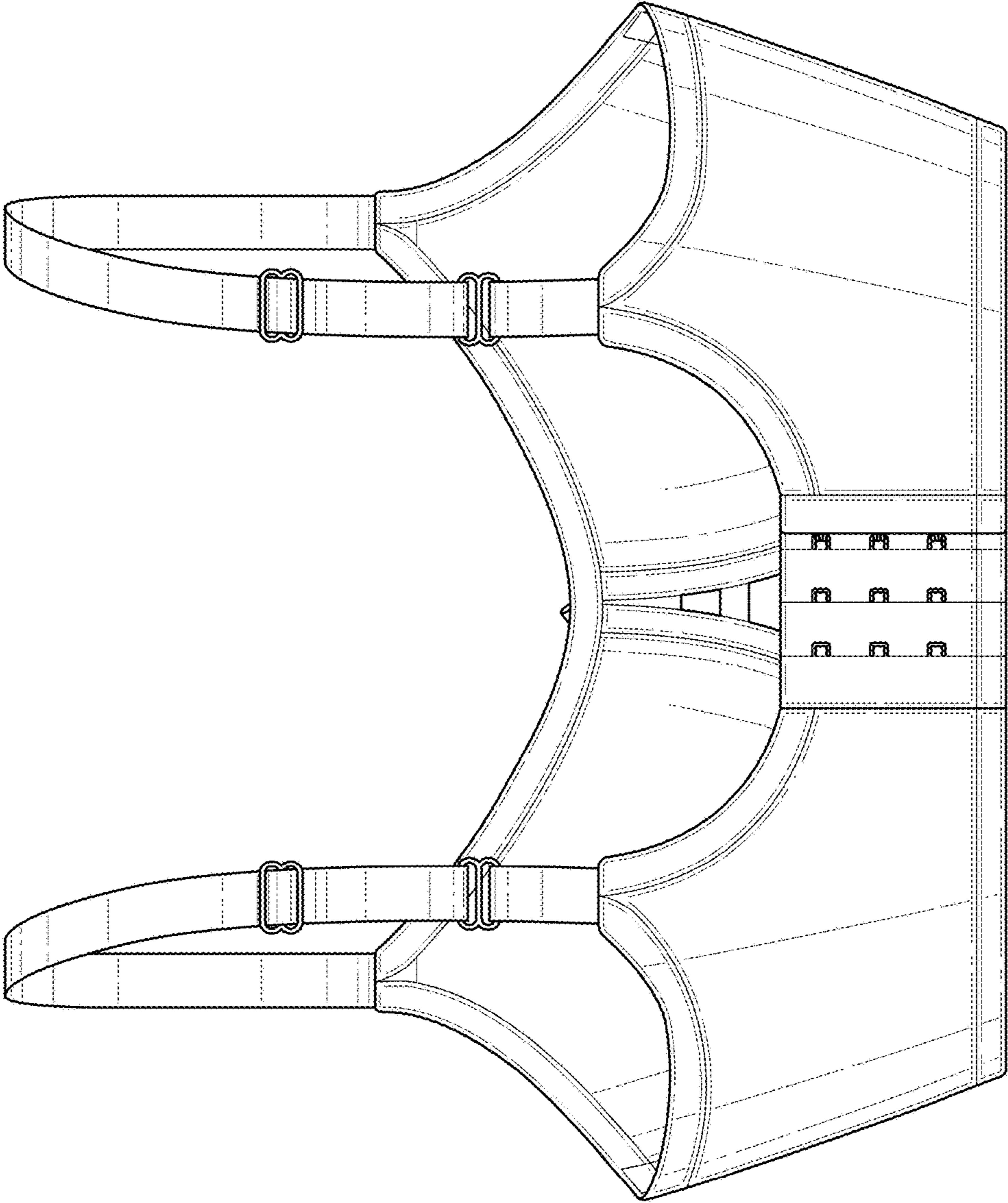

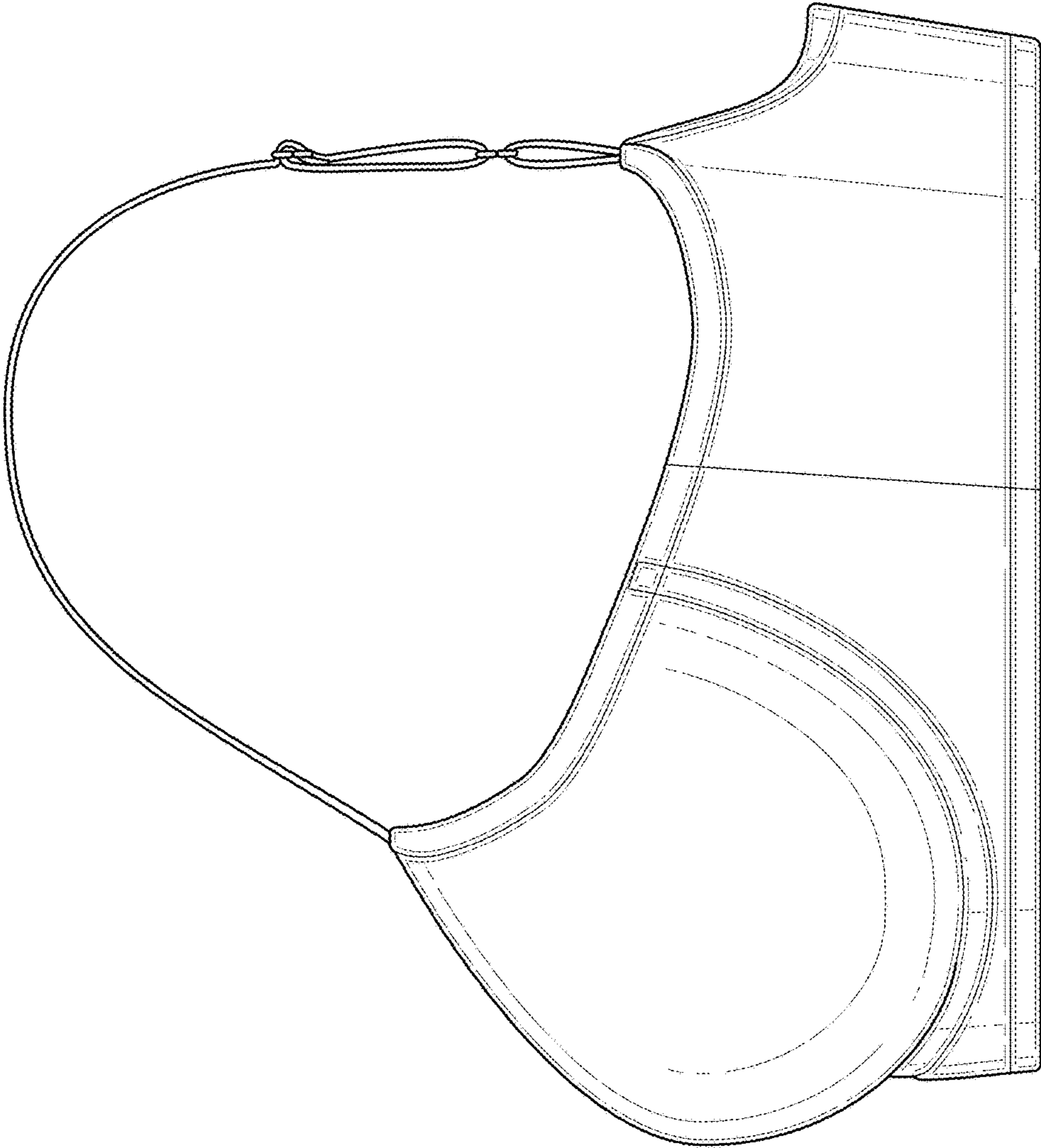

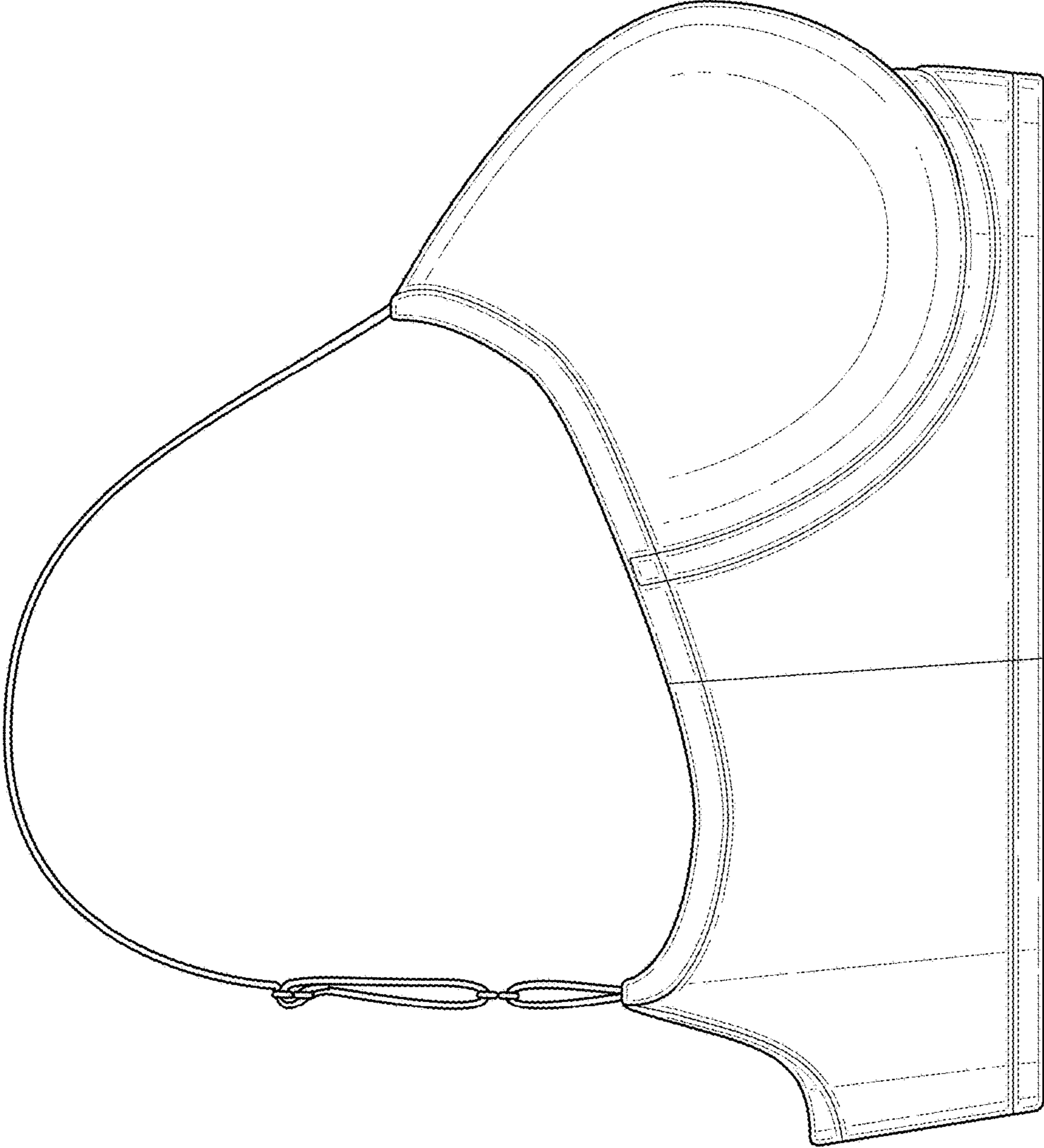

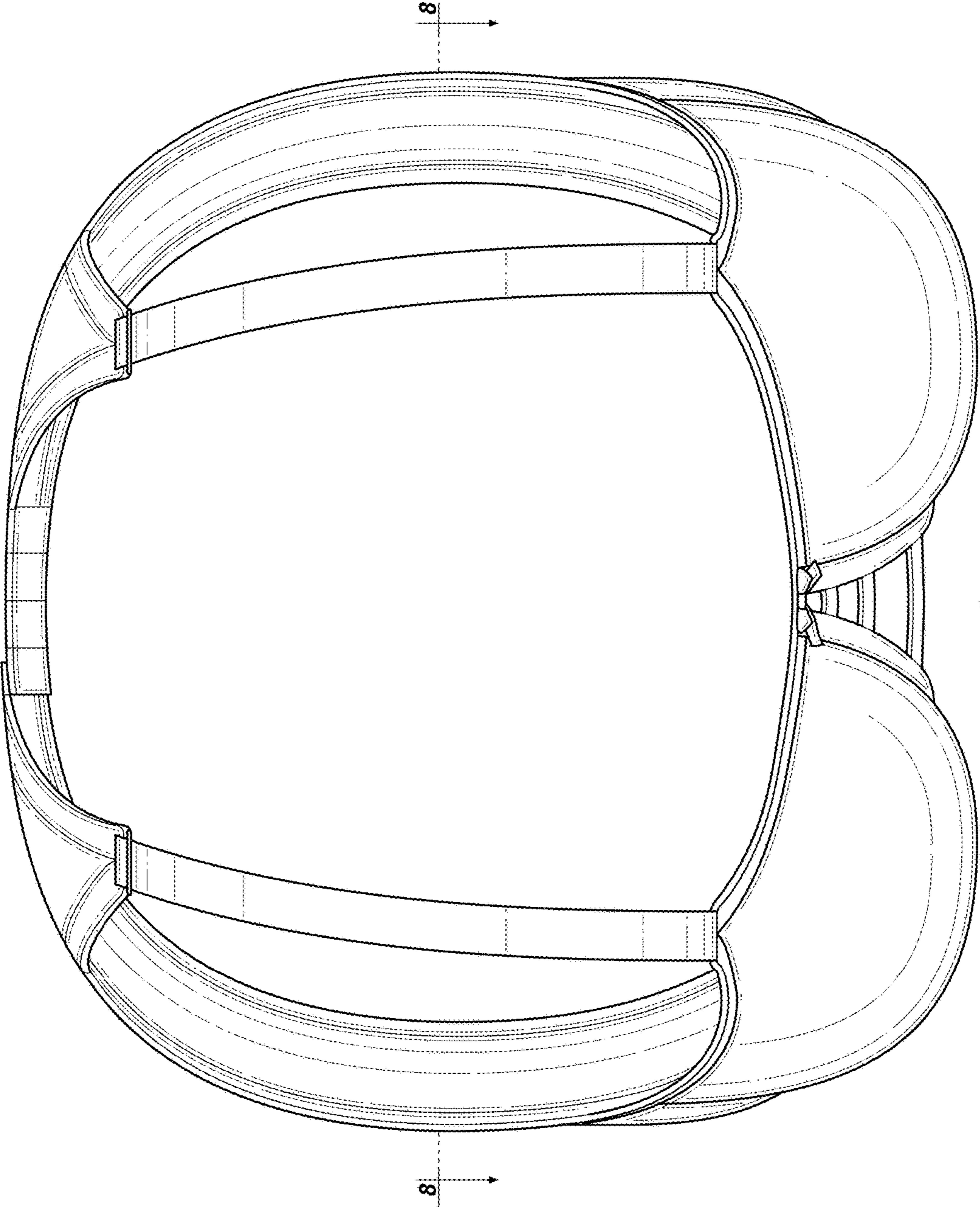

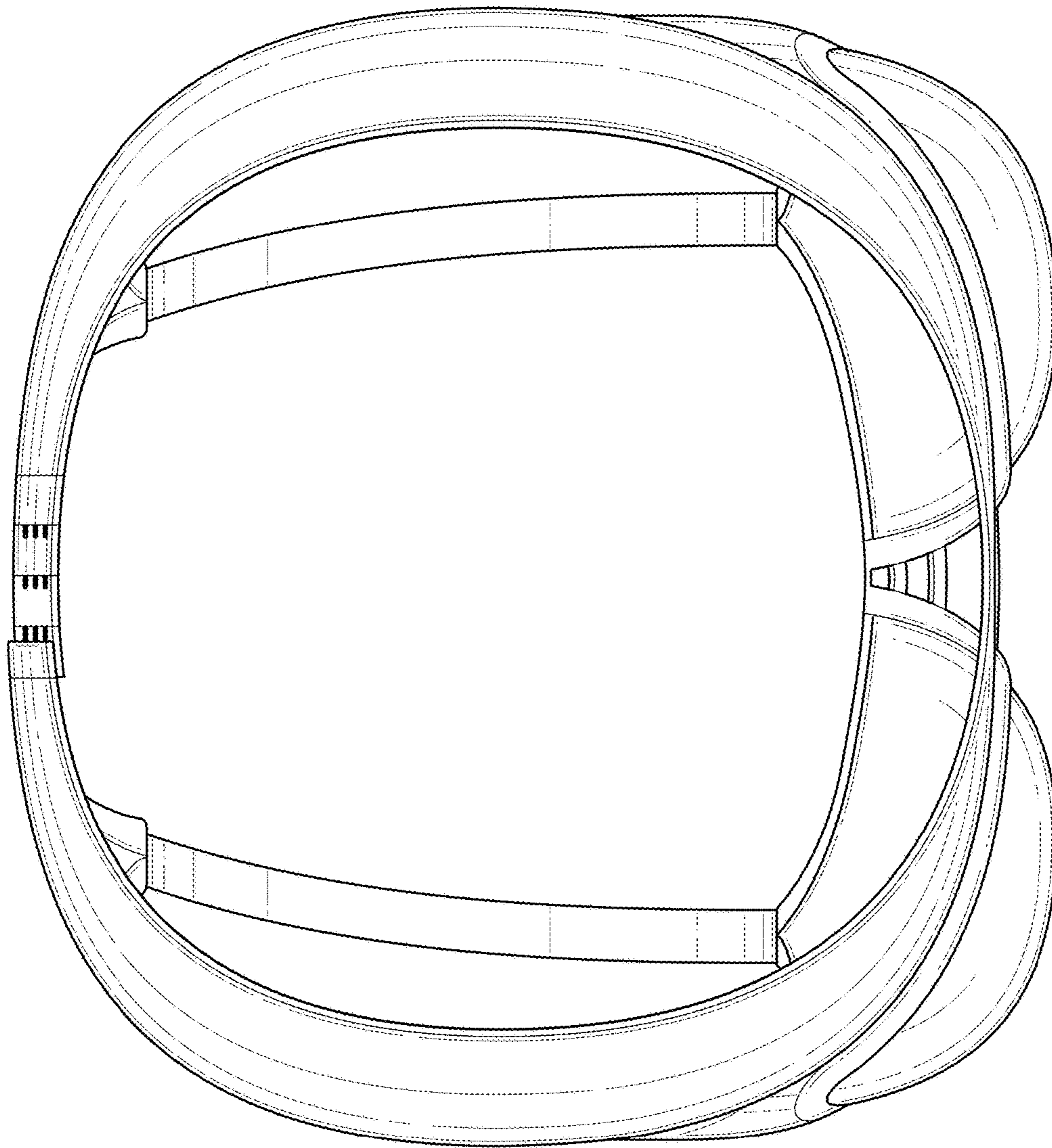

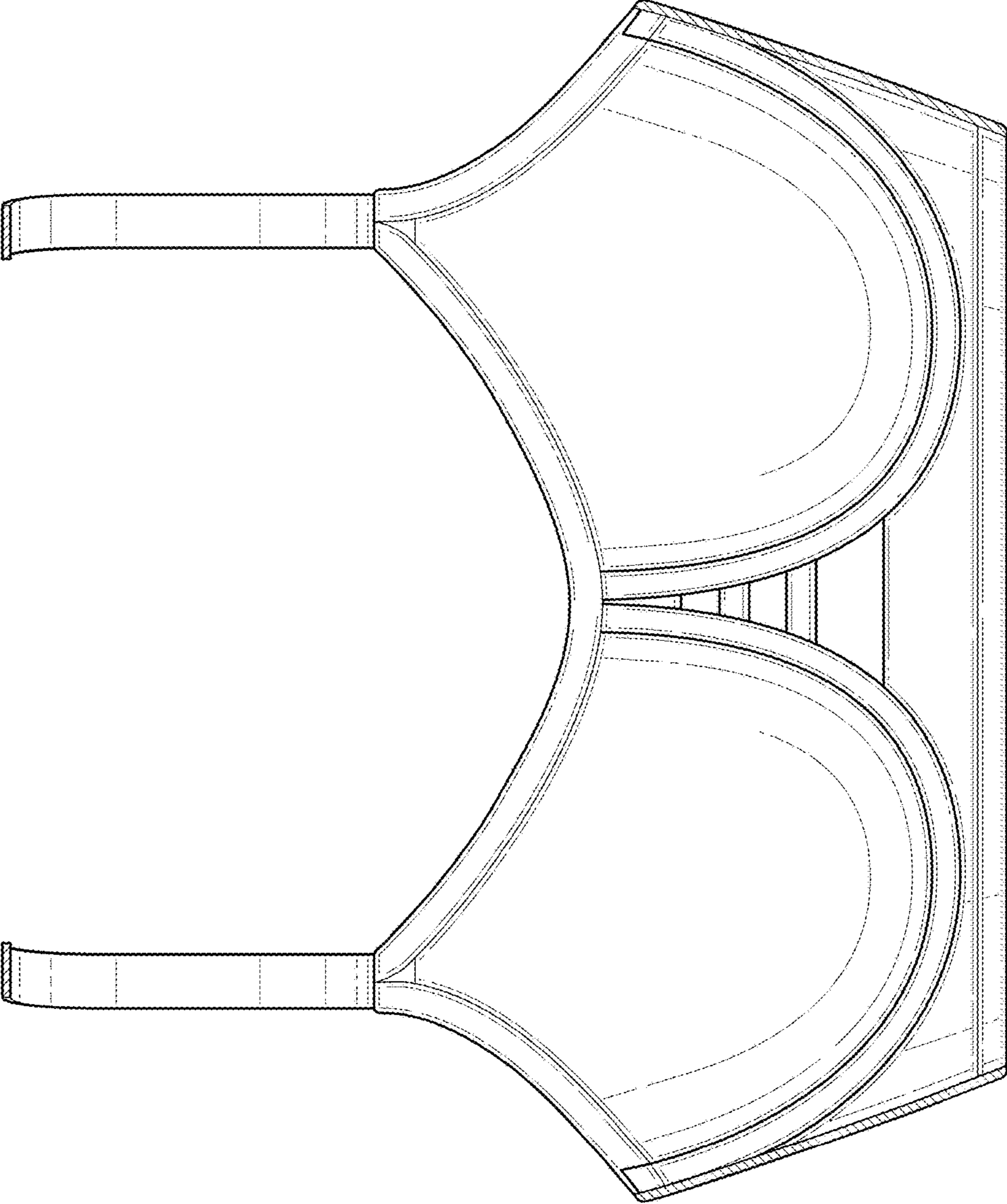
