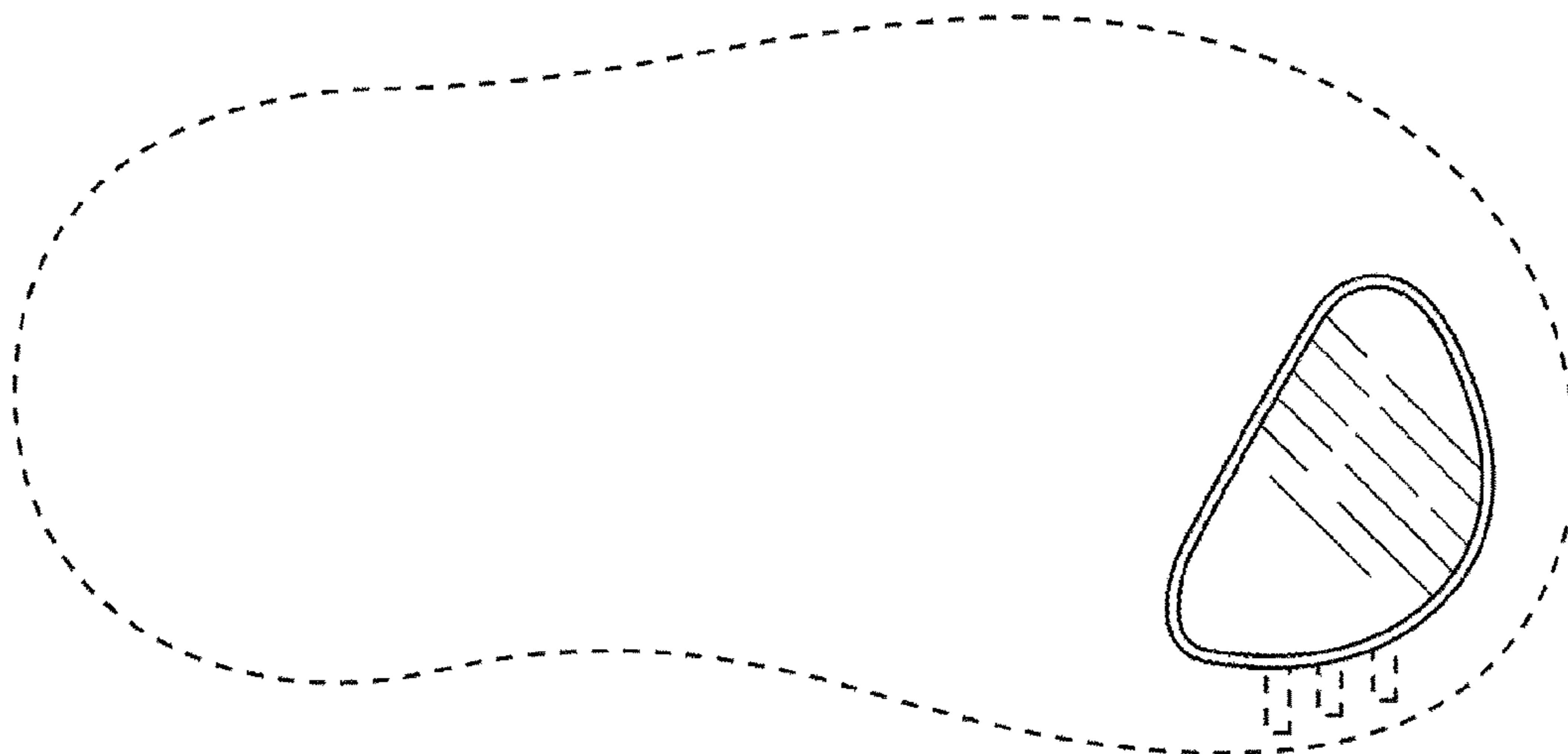
(57) **CLAIM**

The ornamental design for a visual section of shoe tread, substantially as shown.

**DESCRIPTION**

FIG. 1 is a bottom right side view of the visual section of shoe tread according to the present invention; FIG. 2 is a left side view of the bottom thereof; FIG. 3 is a rear view thereof; FIG. 4 is a front view thereof; FIG. 5 is a bottom view thereof; and, FIG. 6 is a view of a cross section of the visual section of shoe tread of the present invention shown in dotted lines to show the structural environment in which the design is associated with the understanding that this figure forms no part of the claimed design. That which is depicted in broken lines in the drawing is included for the purpose of illustrating environment and forms no part of the claimed design.

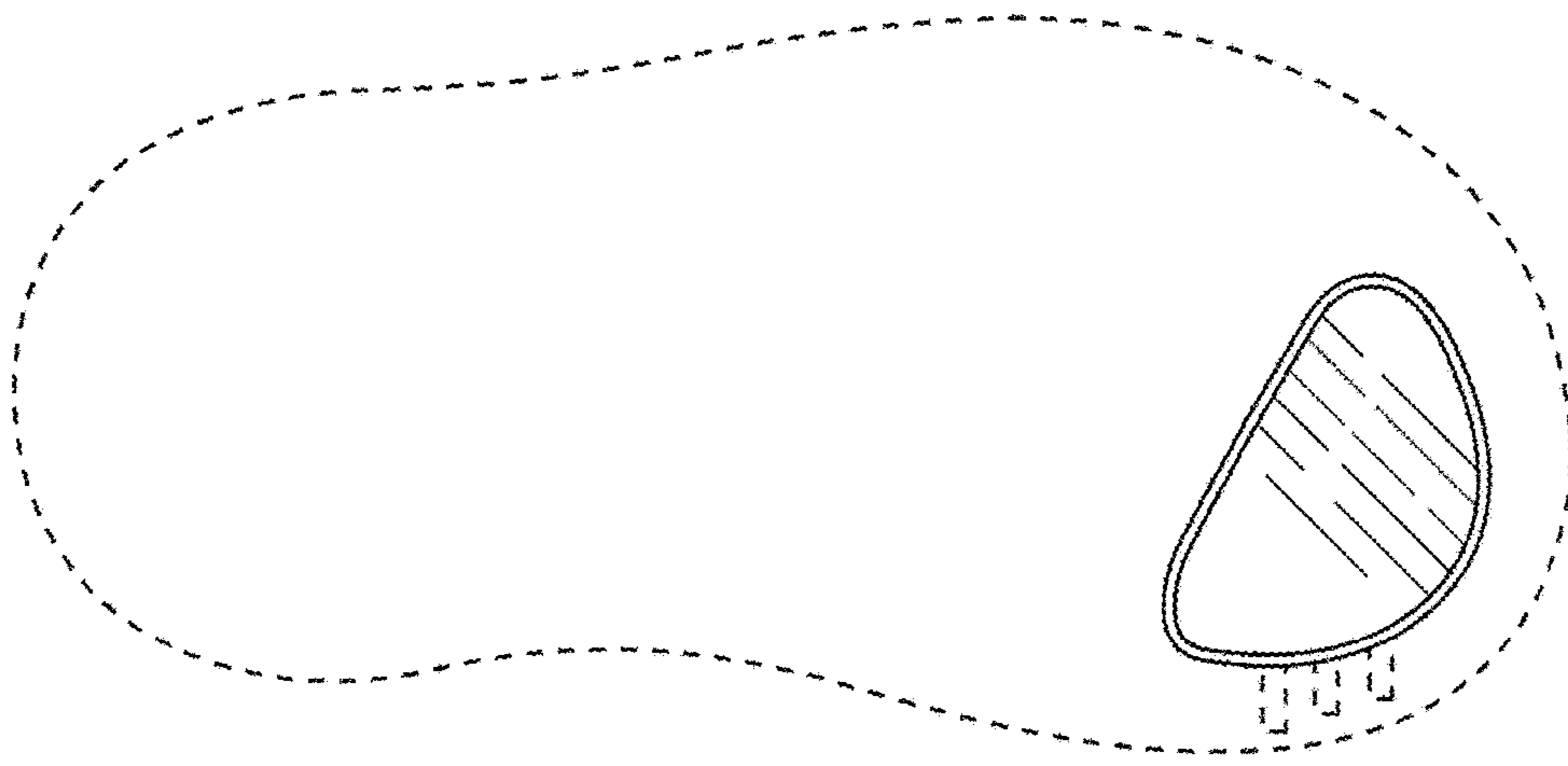

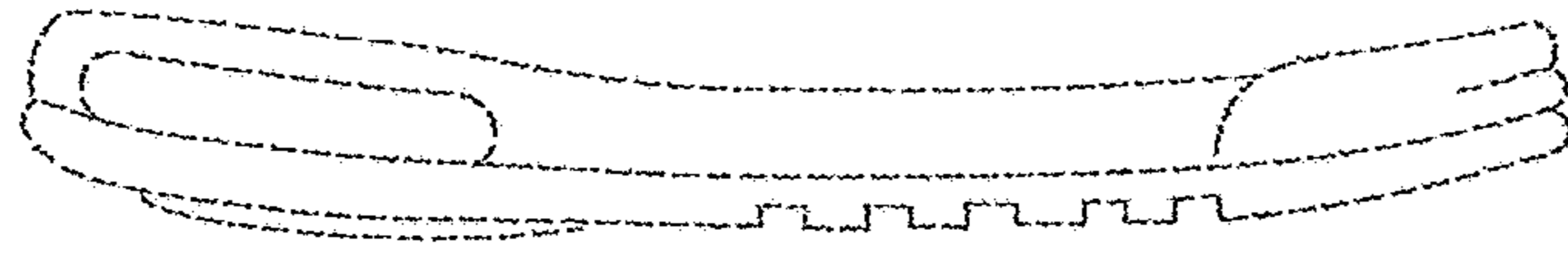

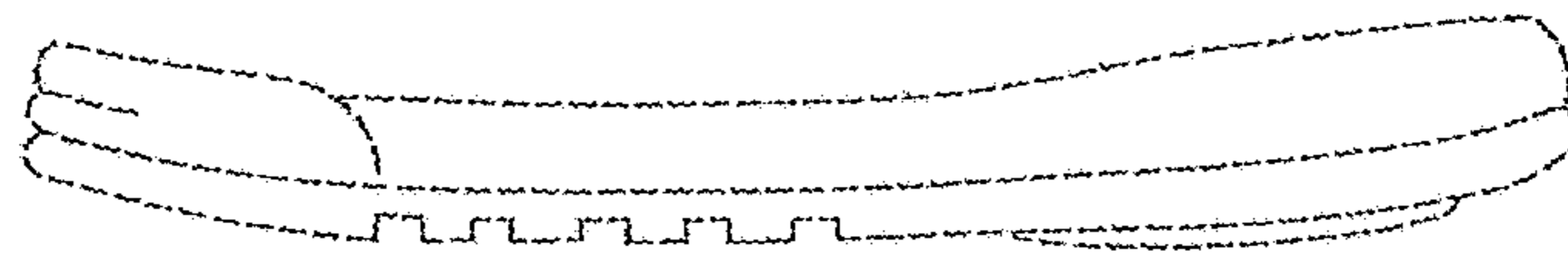

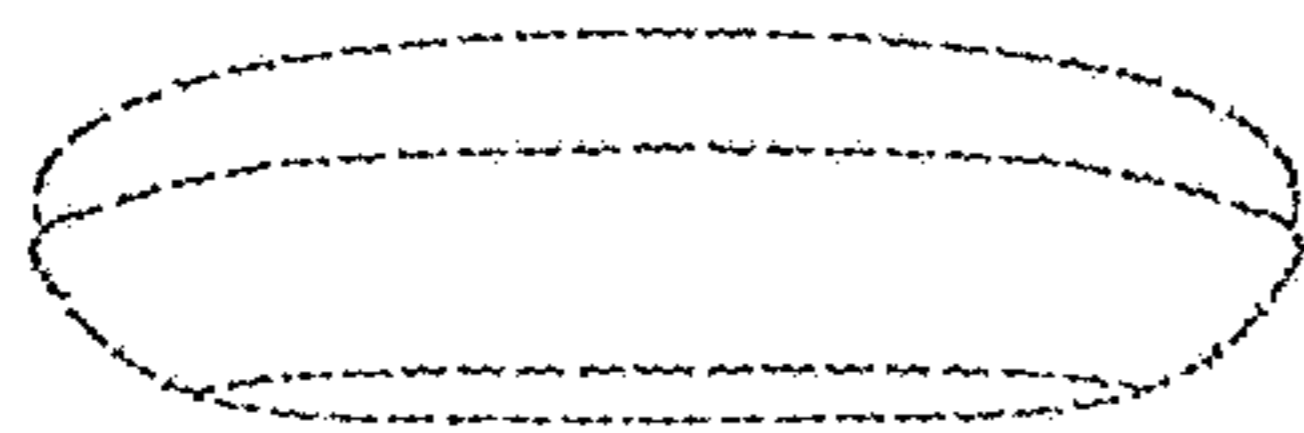

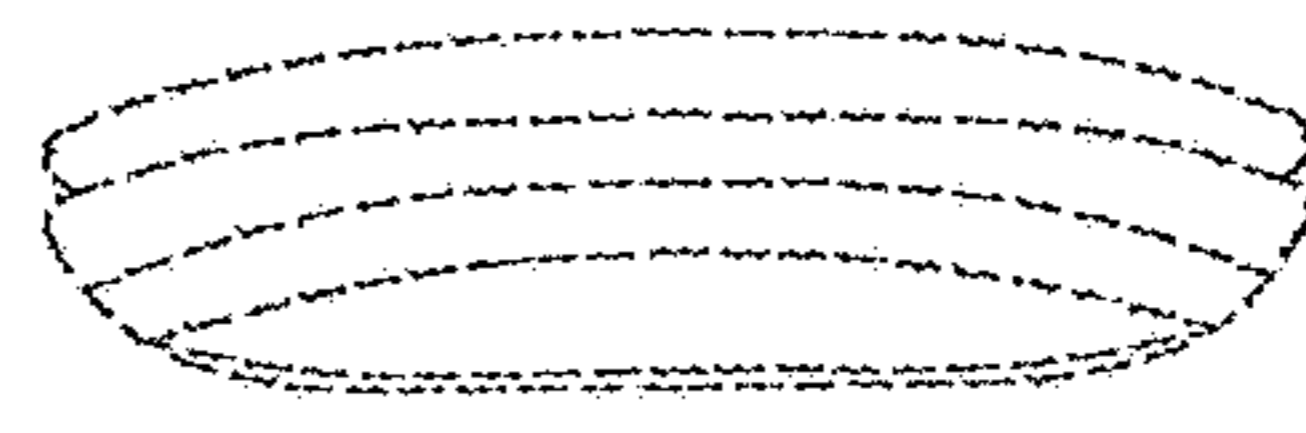
