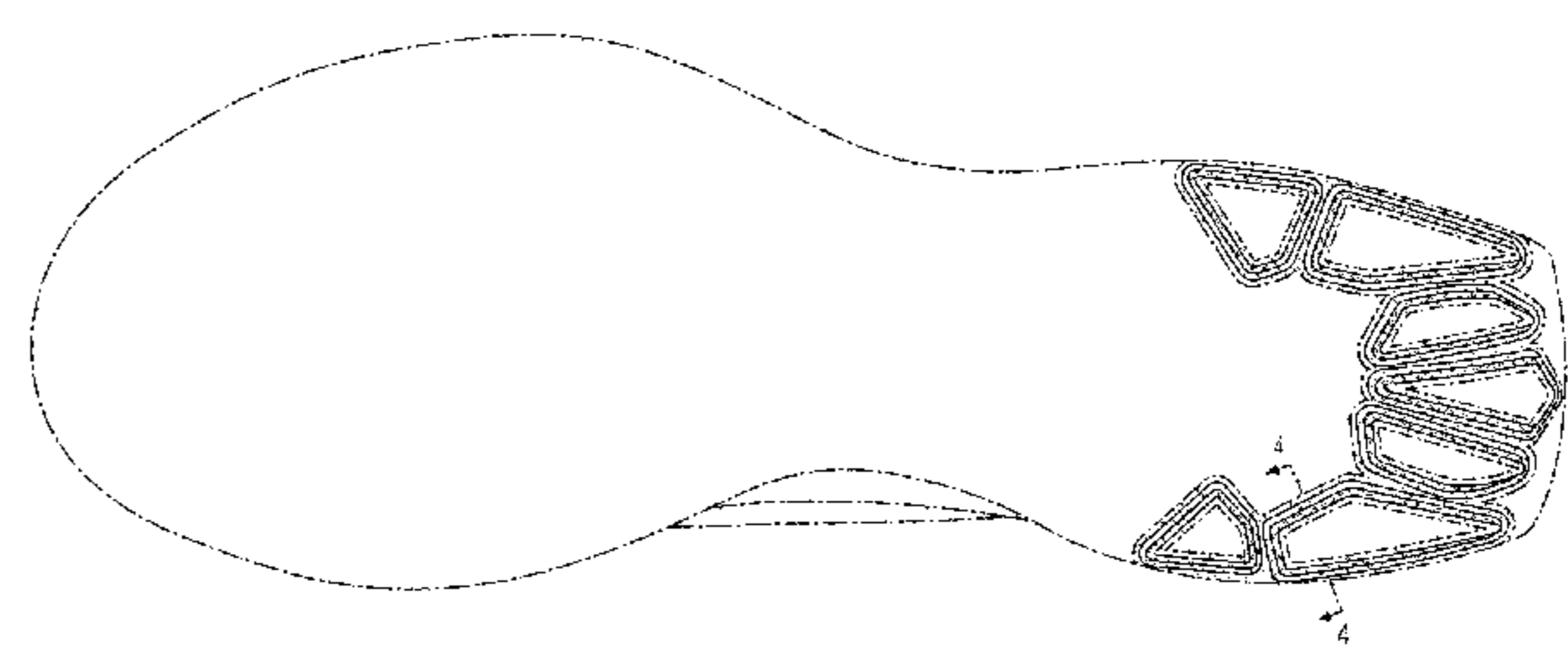
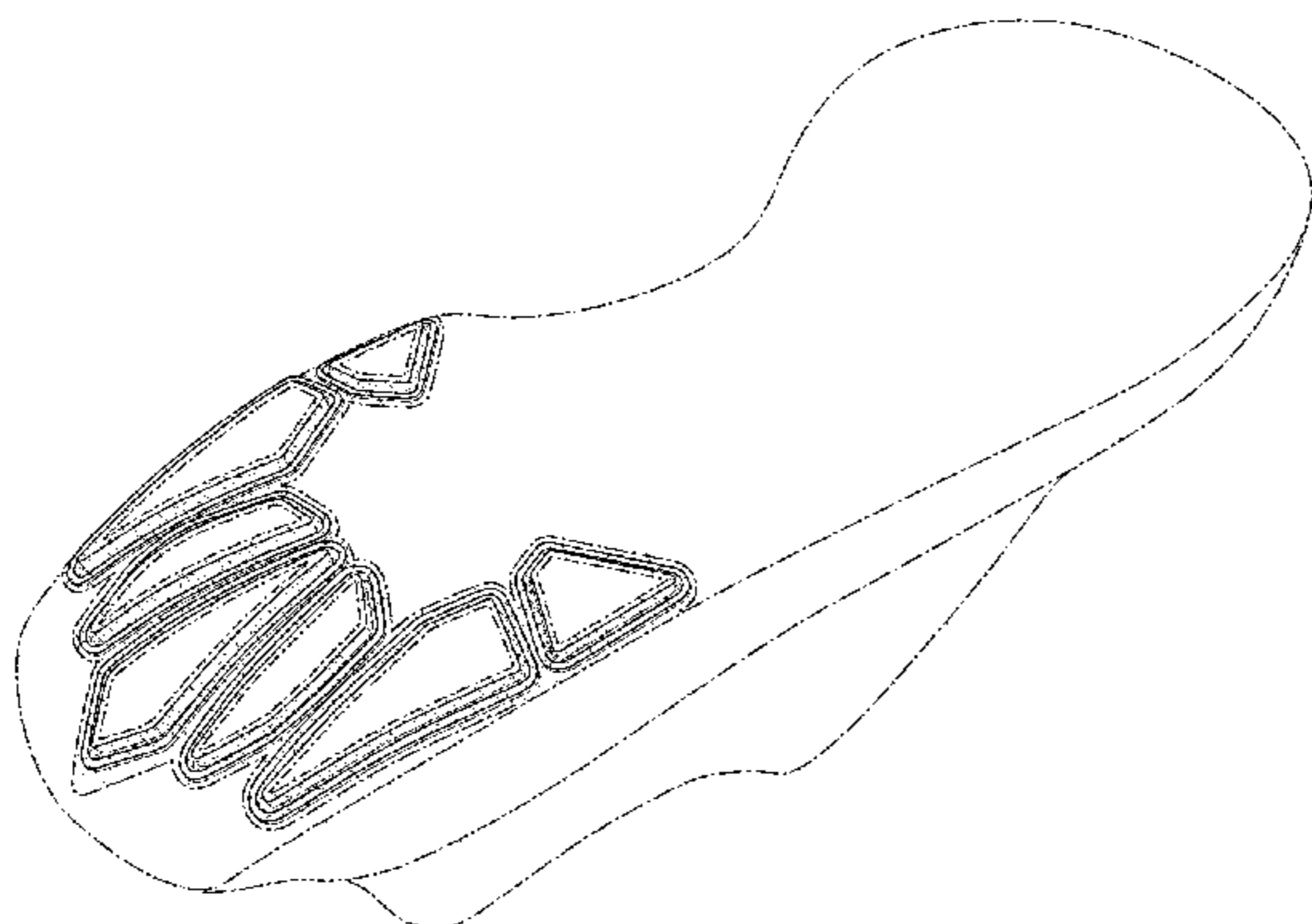
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a shoe showing my new design;
FIG. 2 is a bottom view thereof;
FIG. 3 is an opposite rear perspective view thereof; and,
FIG. 4 is a cross-section taken through line 4-4 of FIG. 2.
The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The seven unshaded polygons demarcated by broken lines represent features which form no part of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

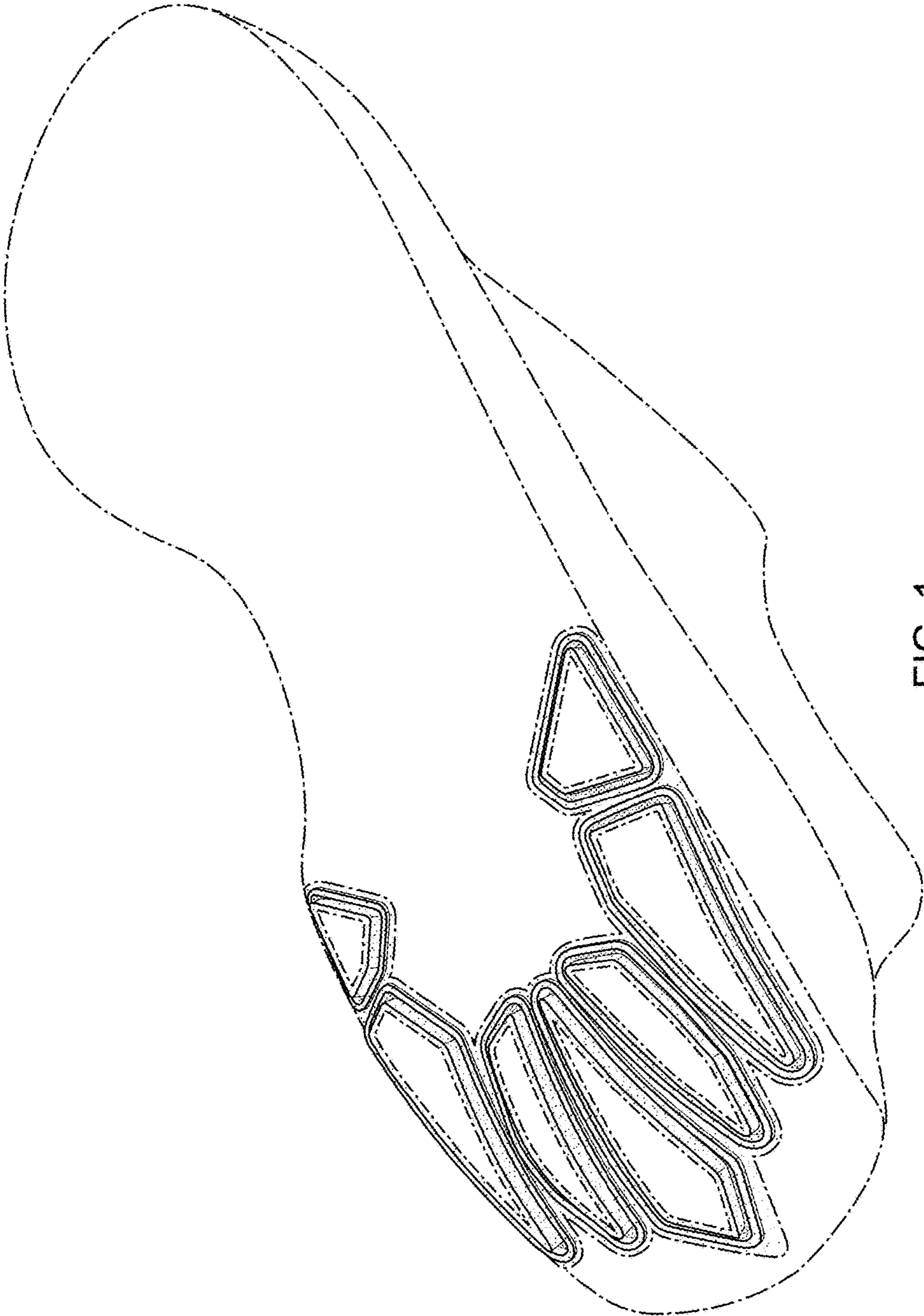

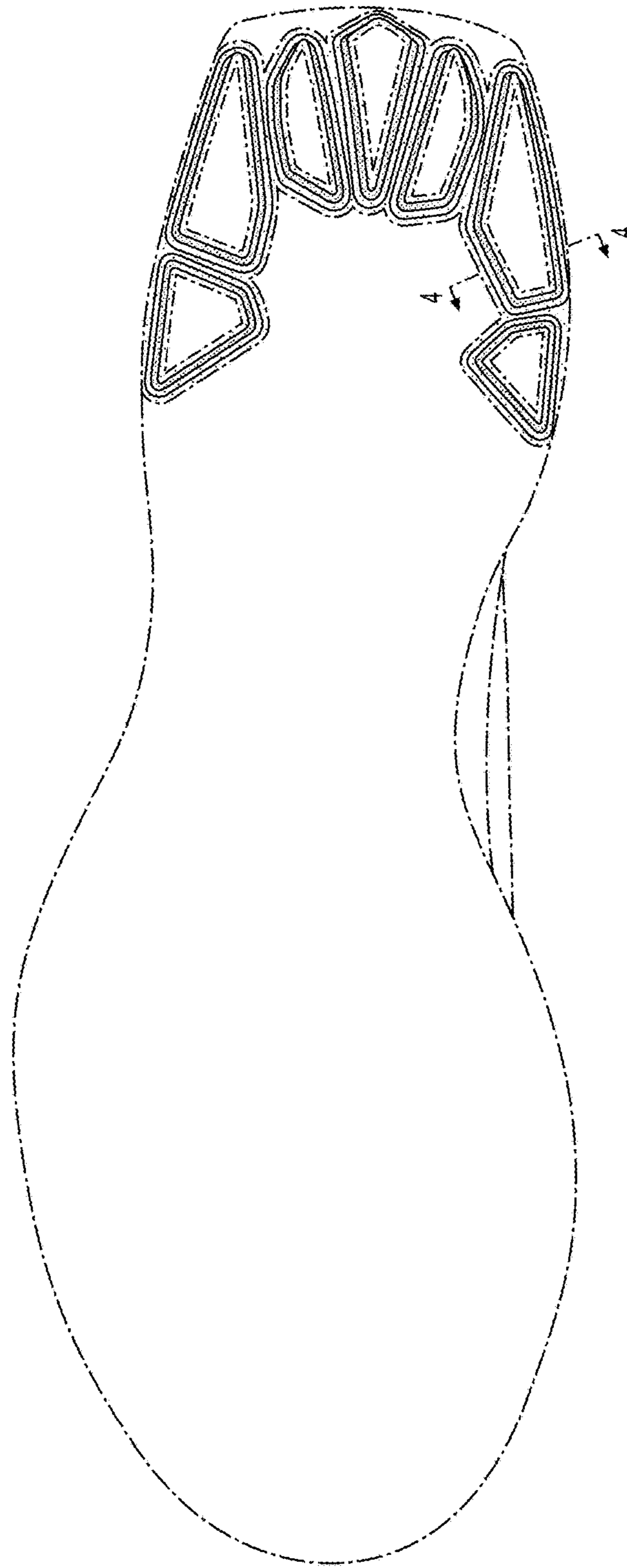

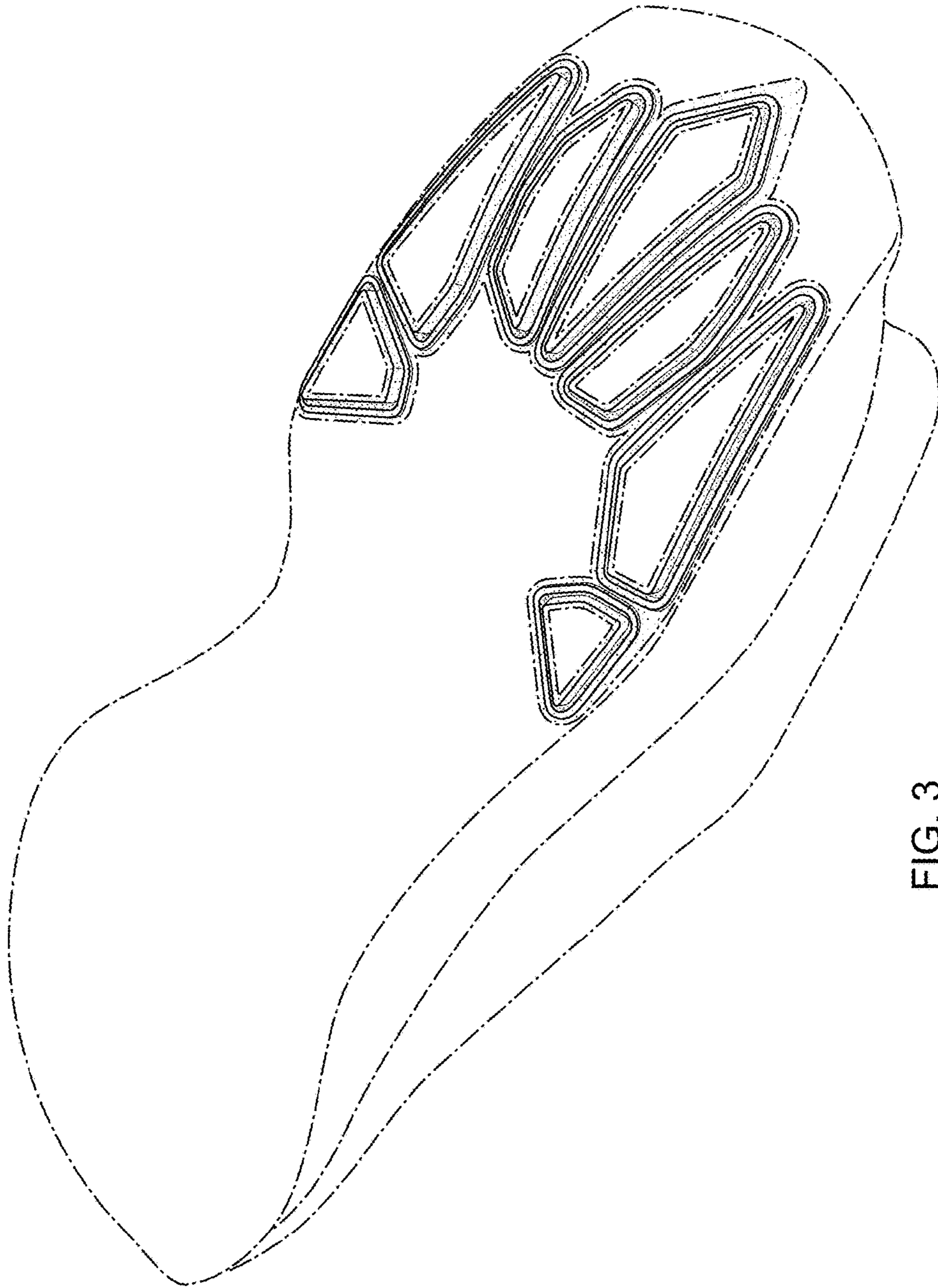
