The ornamental design for a beverage container, as shown and described.

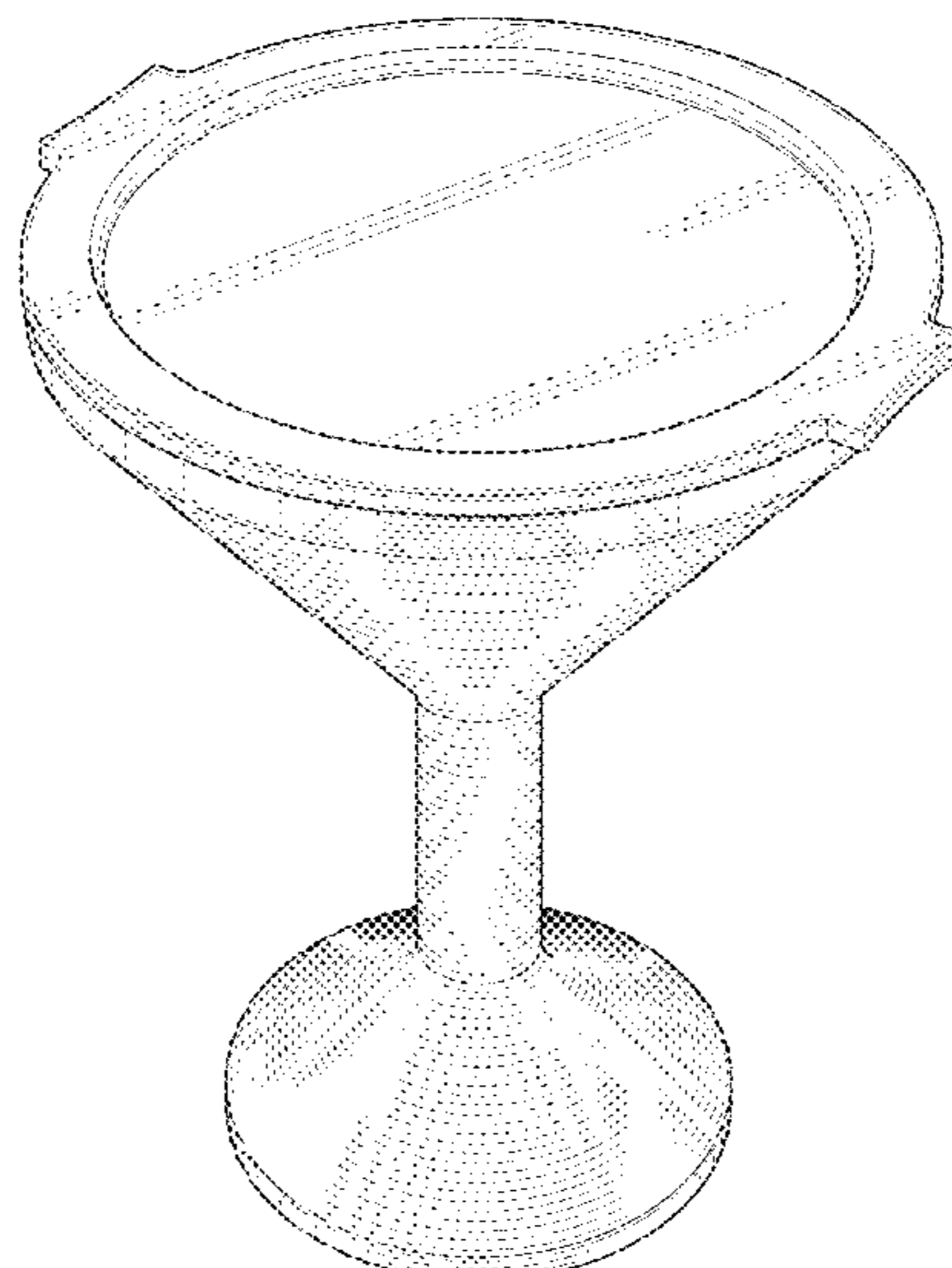
DESCRIPTION

FIG. 1 is a perspective view of a beverage container;
FIG. 2 is a front side view, with the rear view being a mirror image thereof;
FIG. 3 is a left side view, with the right-side view being a mirror image thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a perspective view of the beverage container shown without the lid for ease of disclosure; and,
FIG. 7 is a cross sectional view of the beverage container taken along lines 7-7 of FIG. 4.
The broken lines depict portions of the article that form no part of the claimed design.
The dash-dot-dash line depicts the boundary of the claim and is not part of the claimed design.

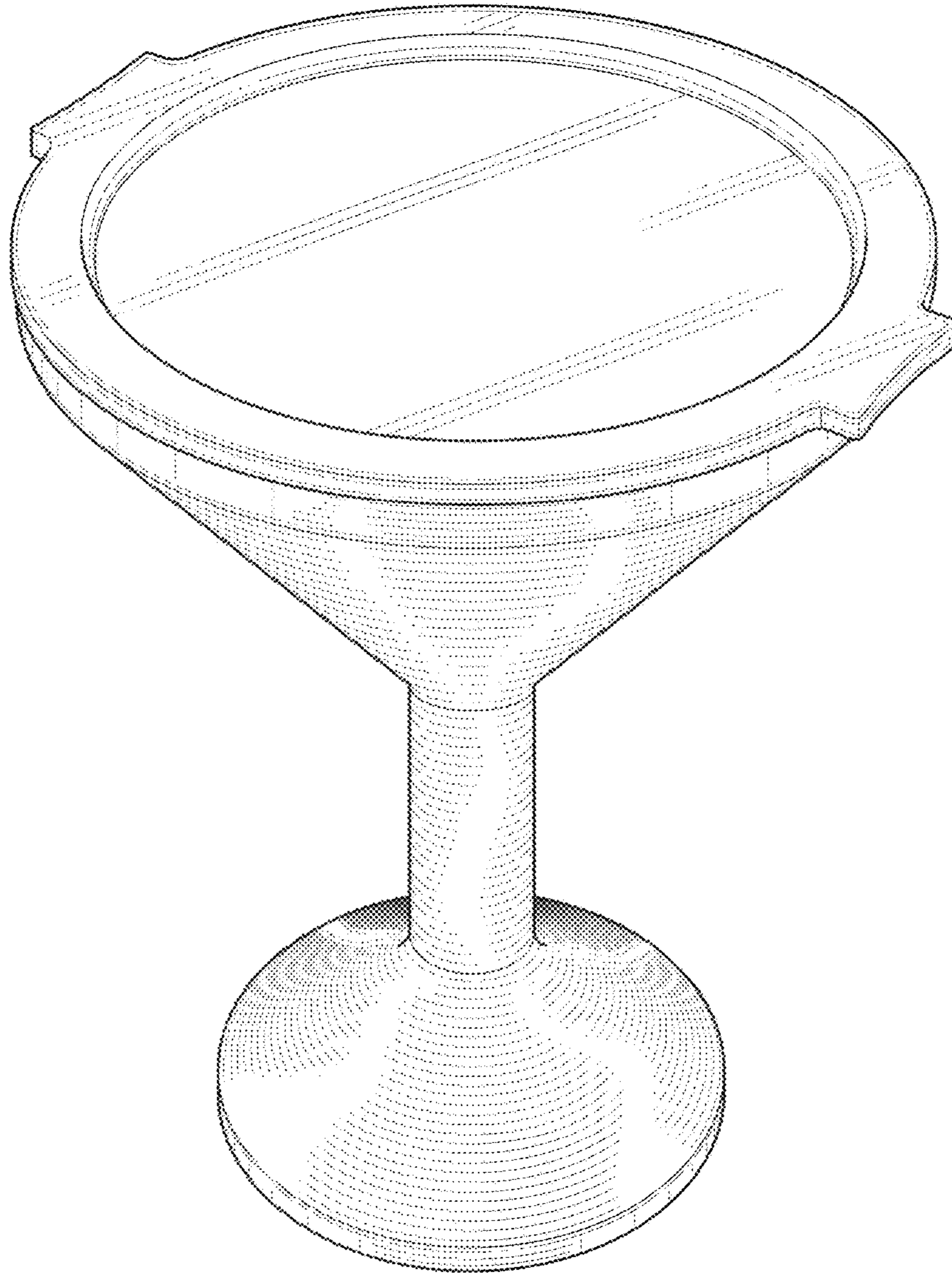

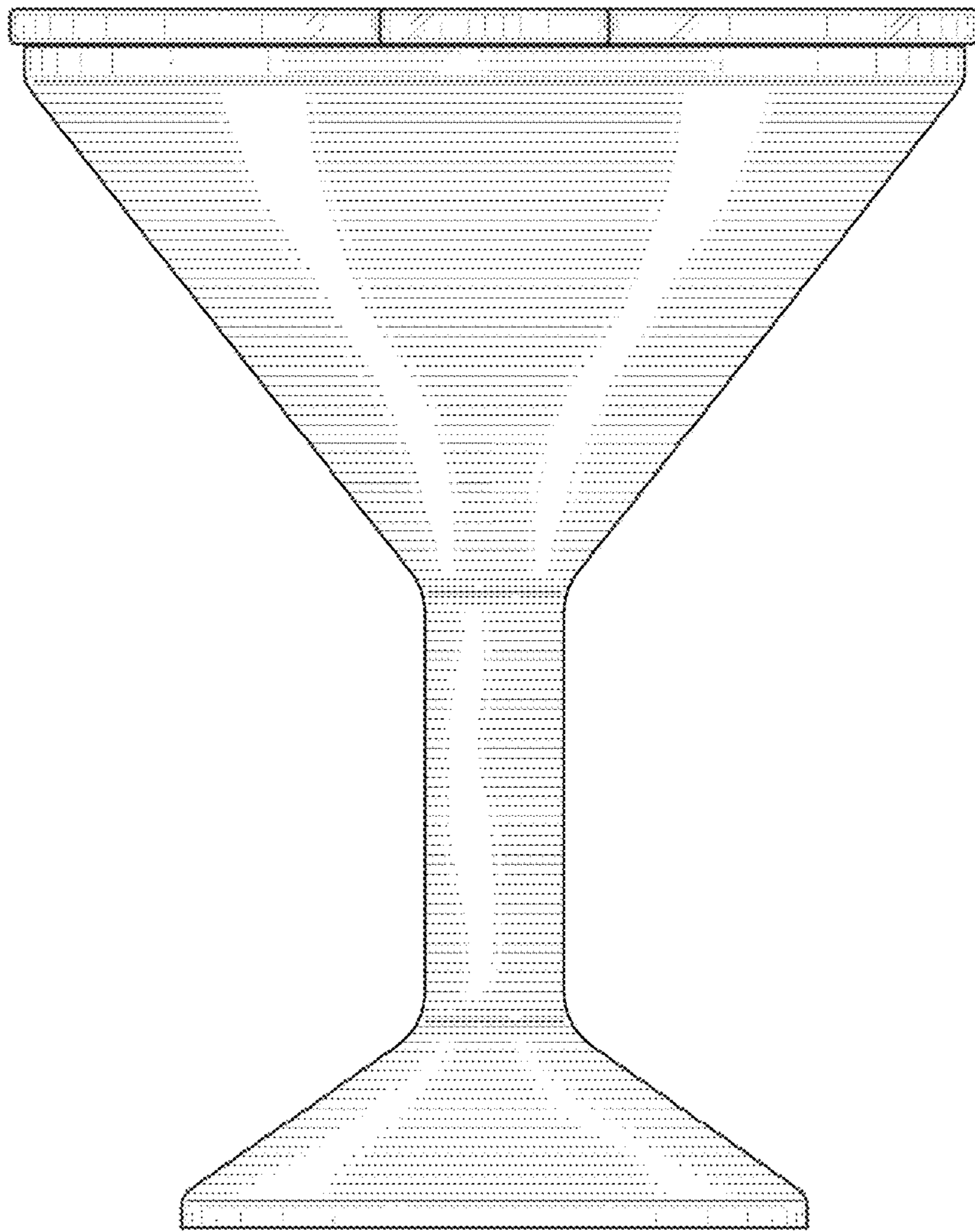

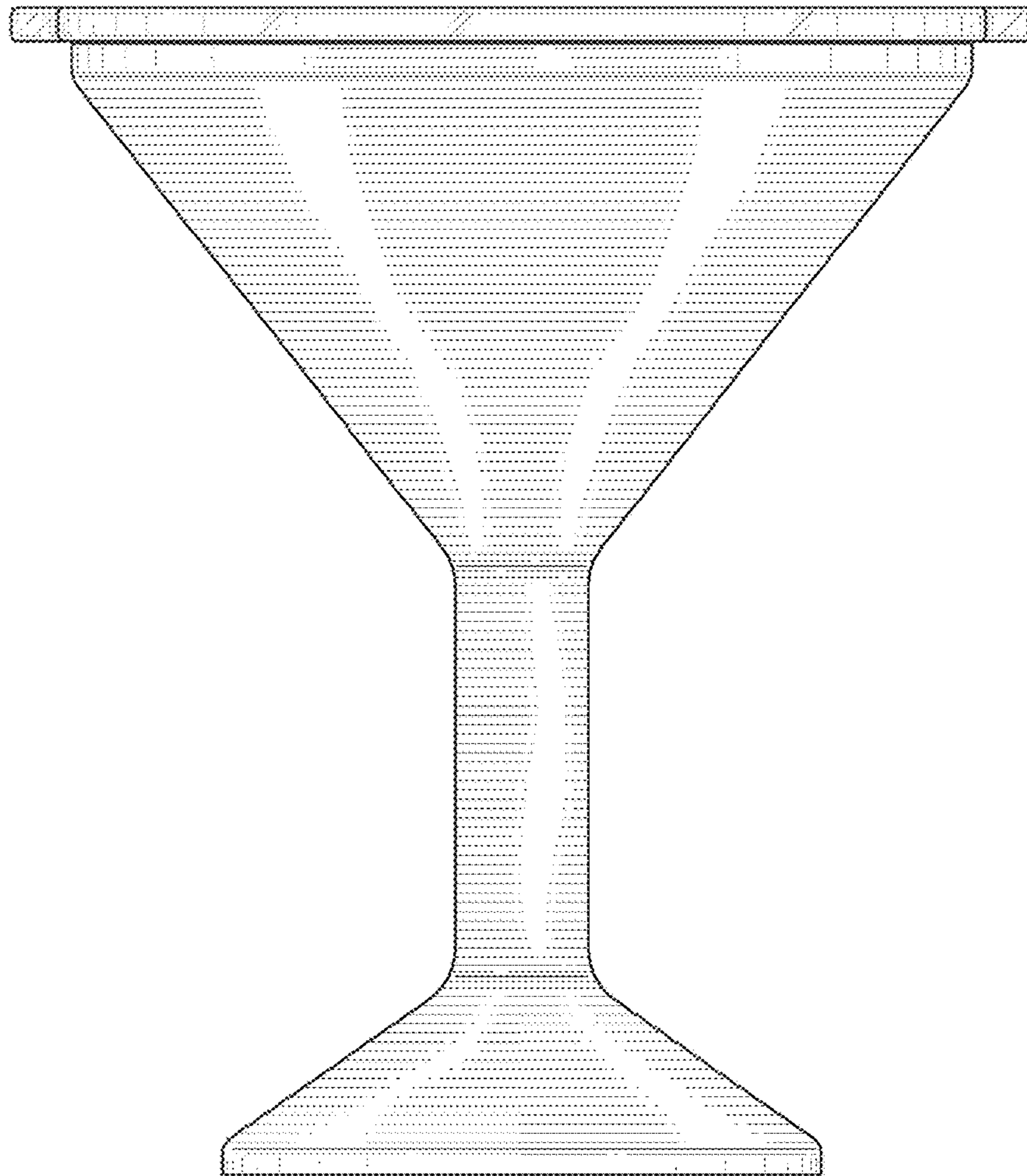

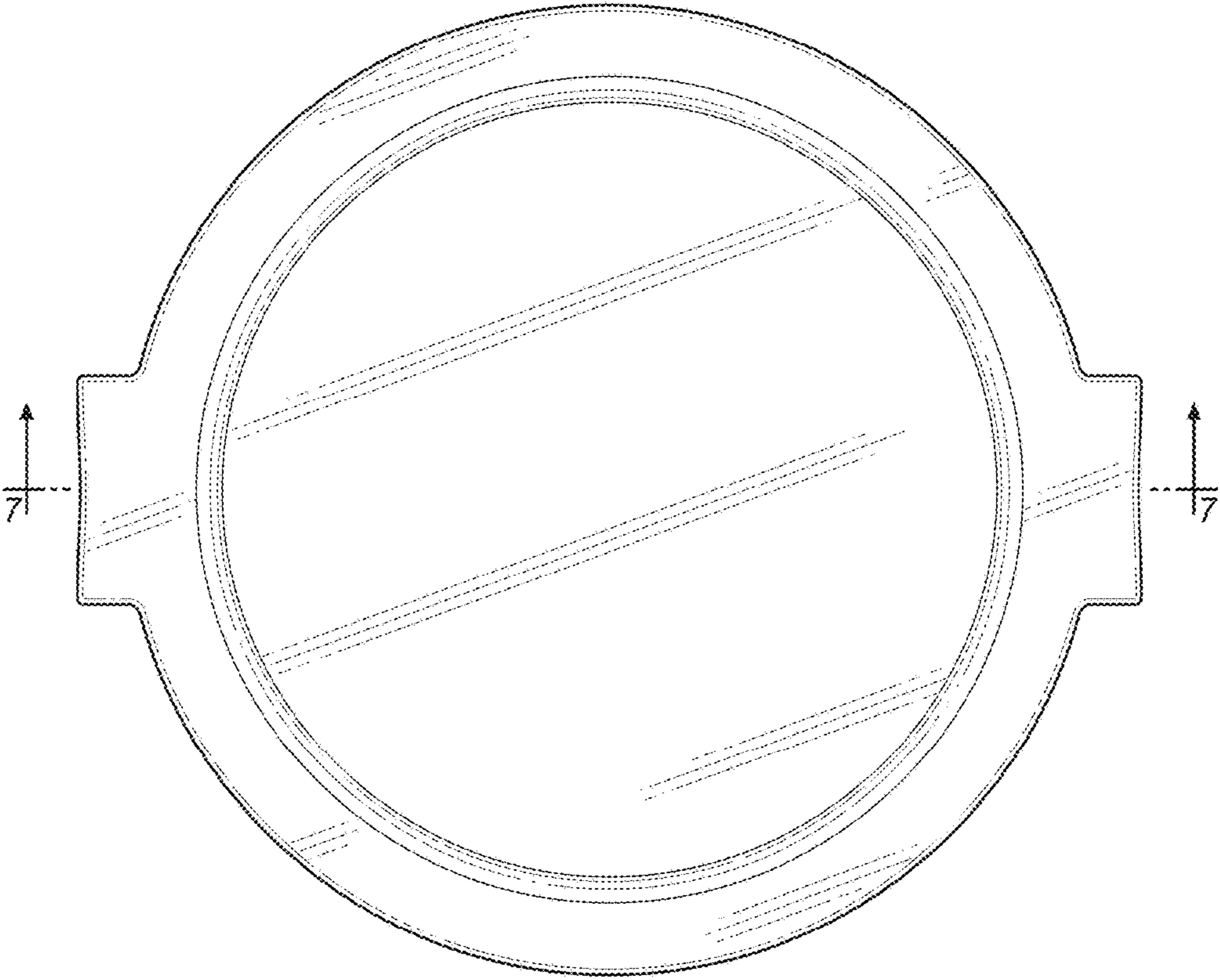

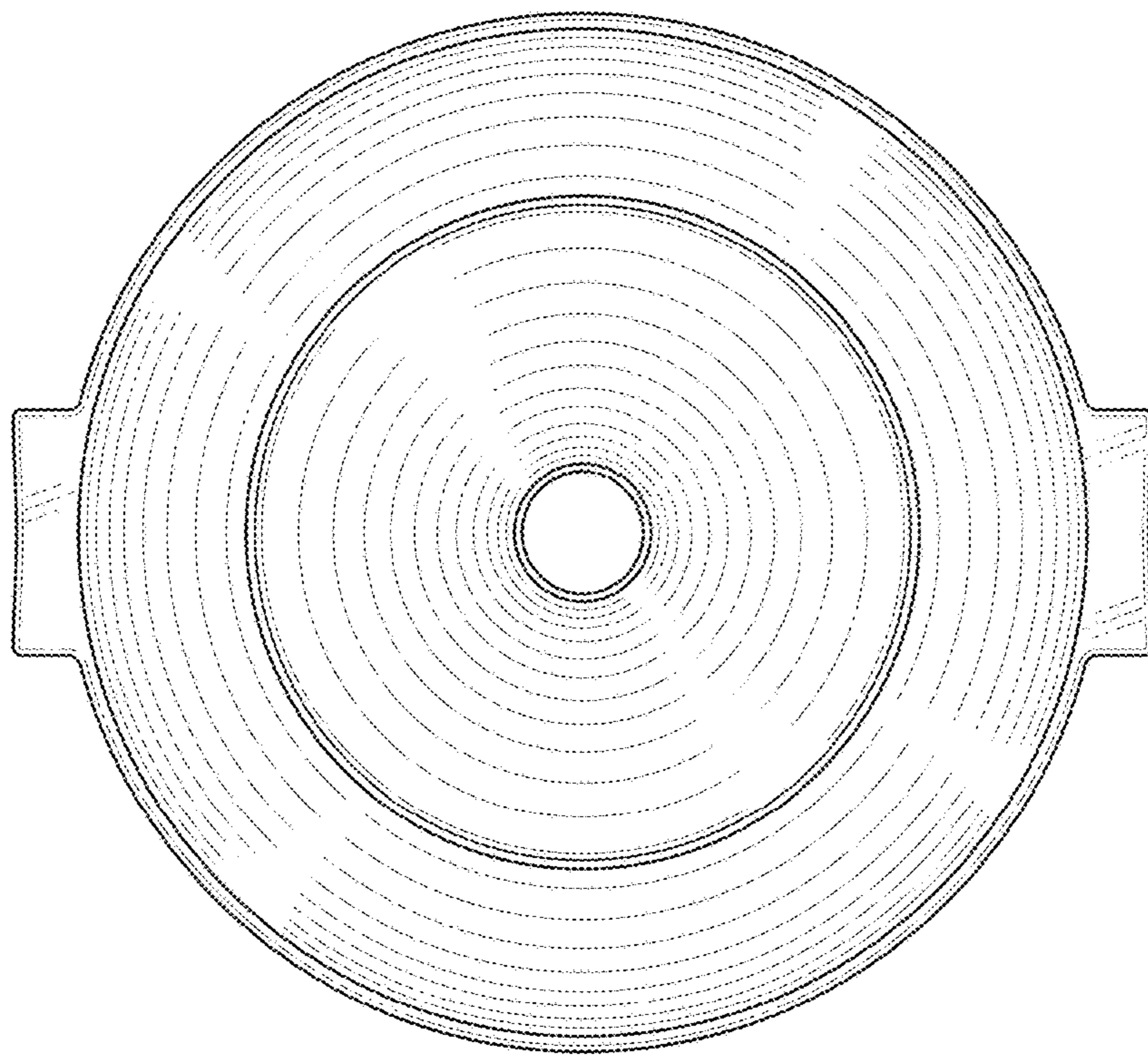

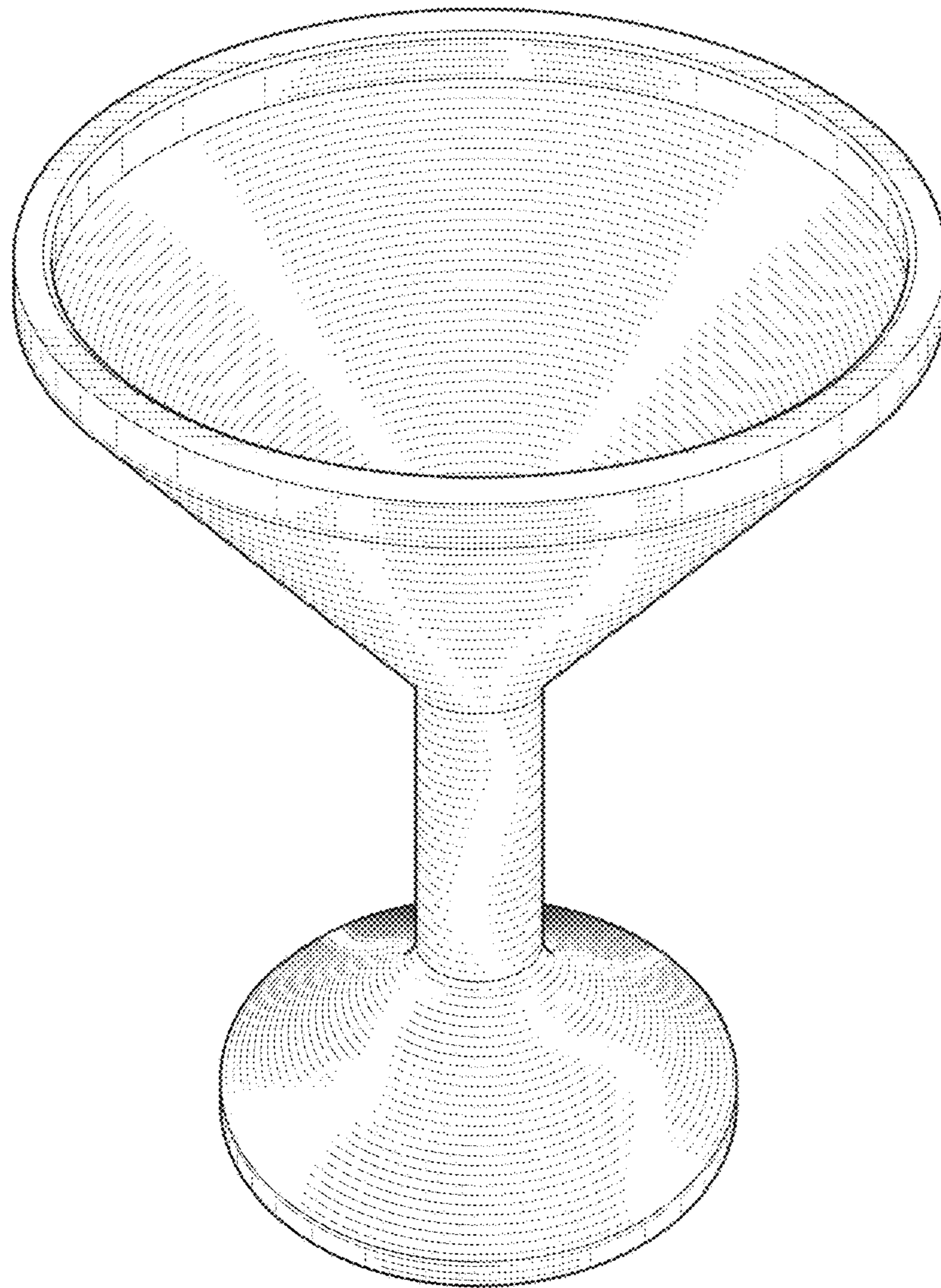

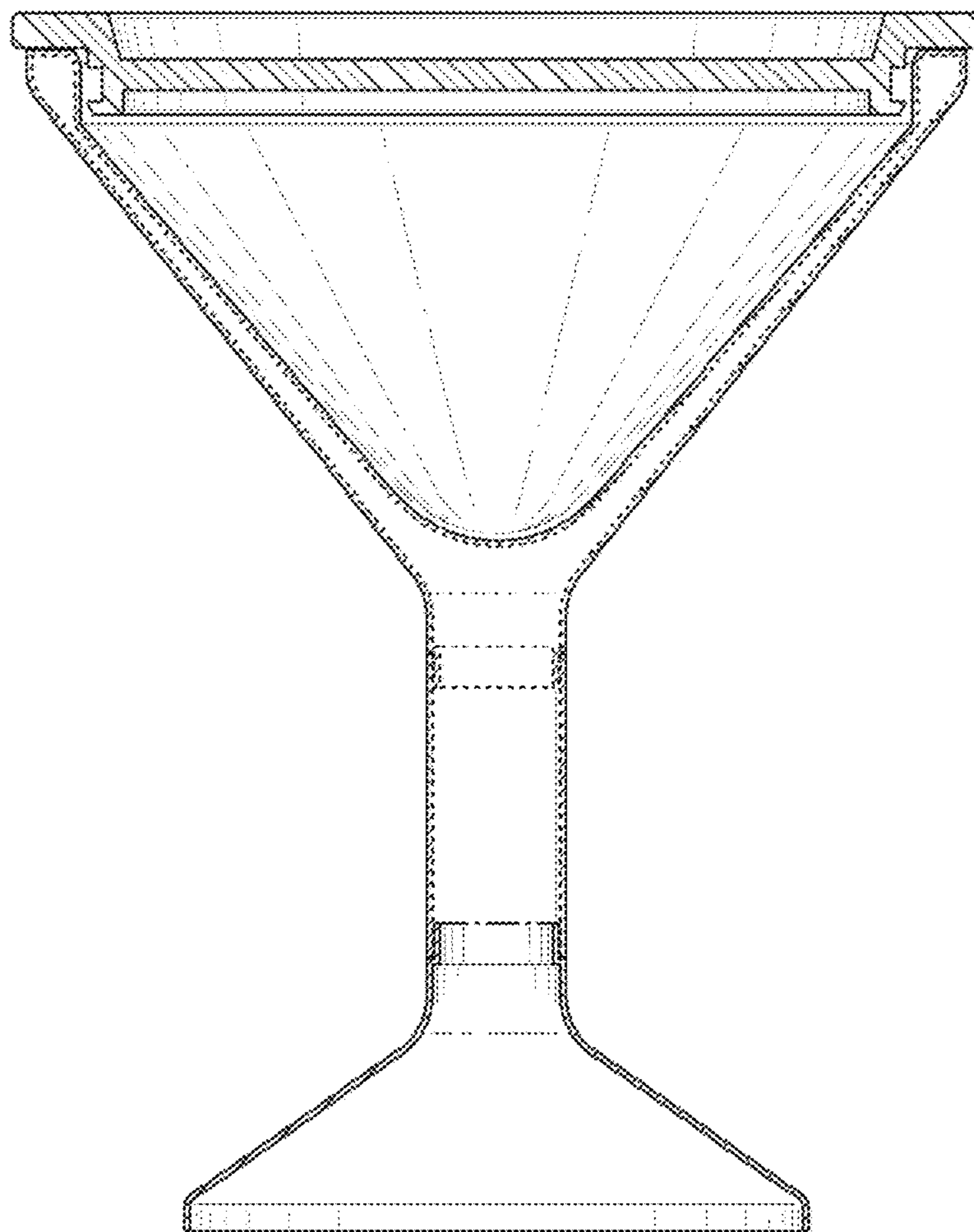
