FIG. 2 is a front perspective view of a handbag in the form of a cat;

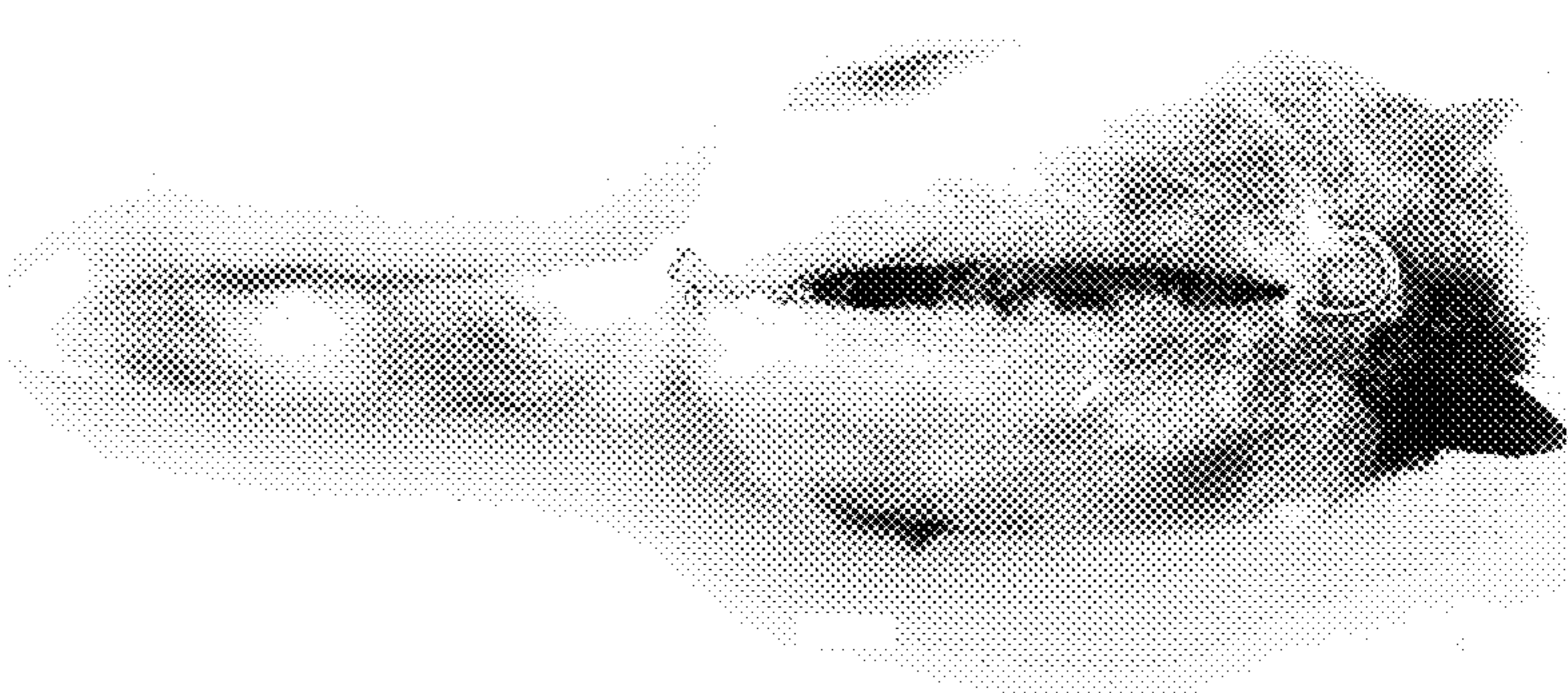
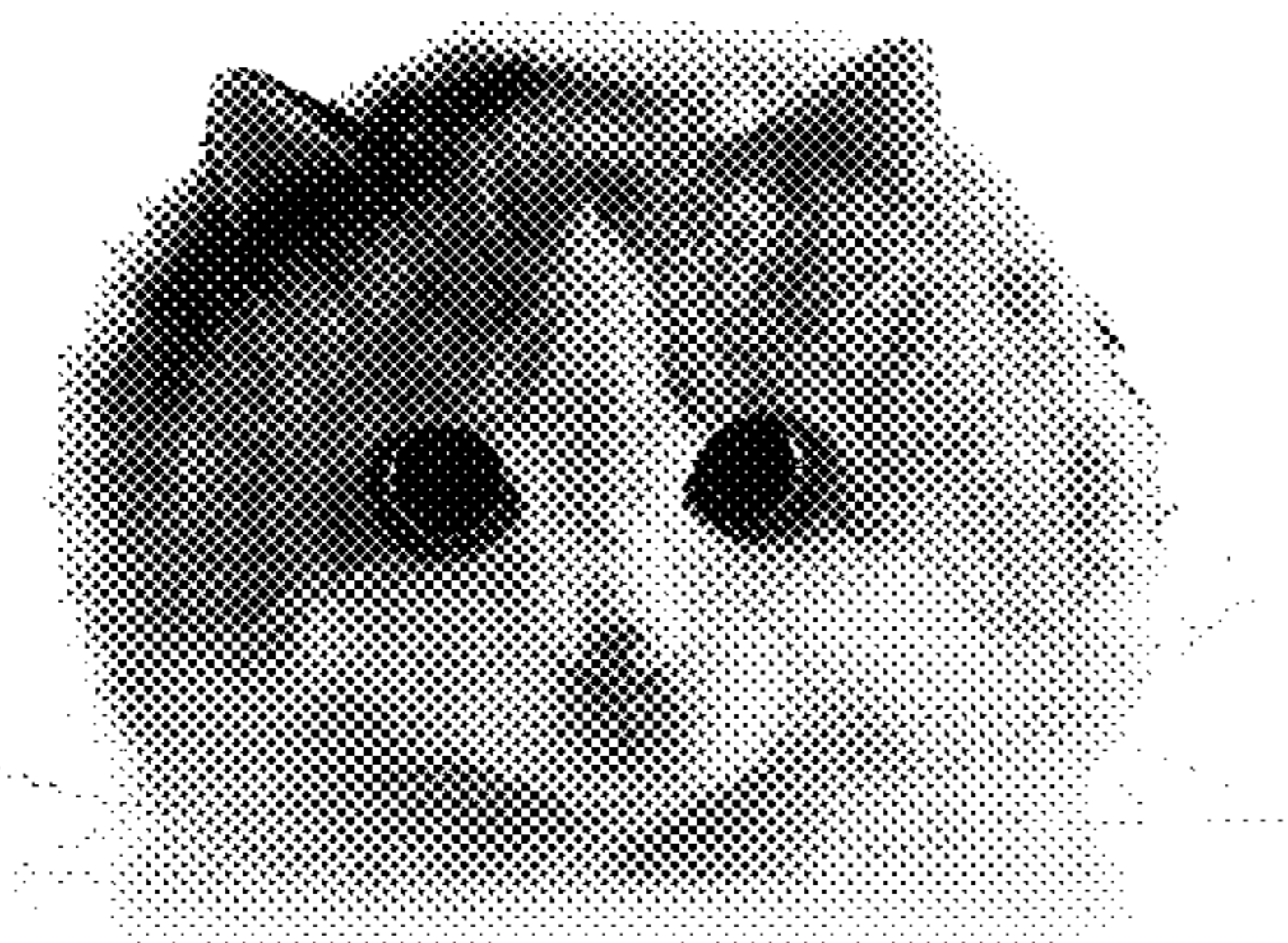
FIG. 3 is a left end elevational view of the handbag in the form of a cat shown in FIG. 1;

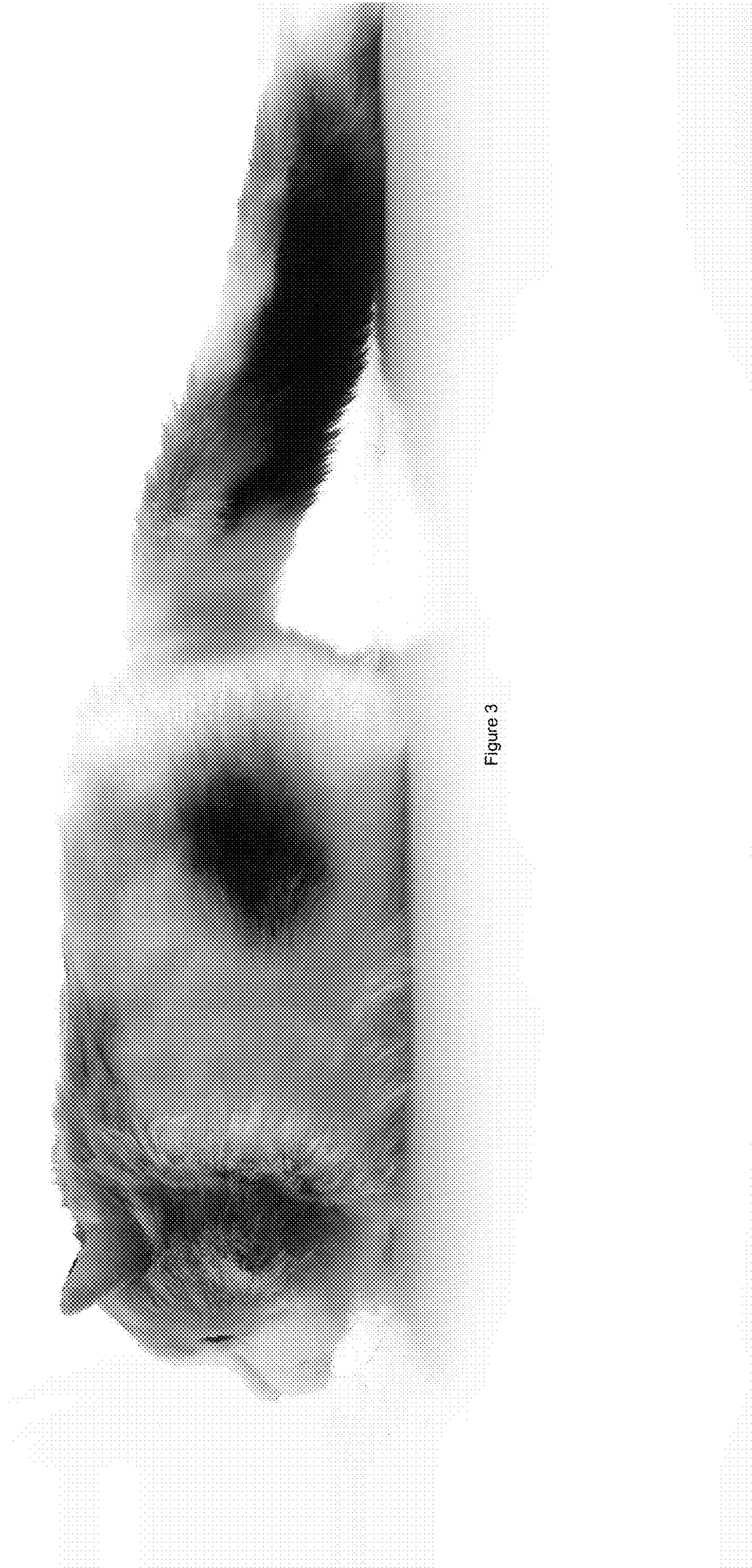

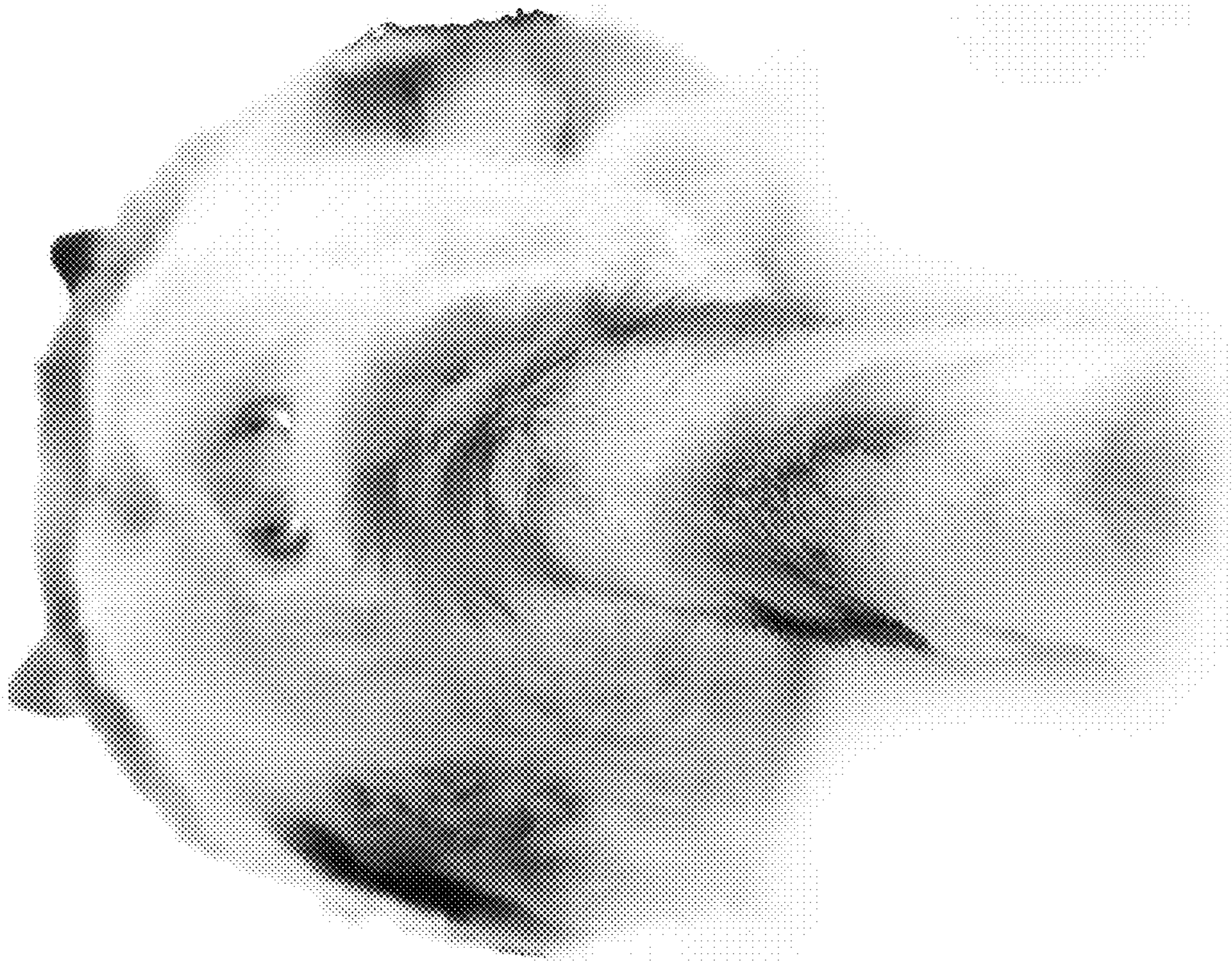

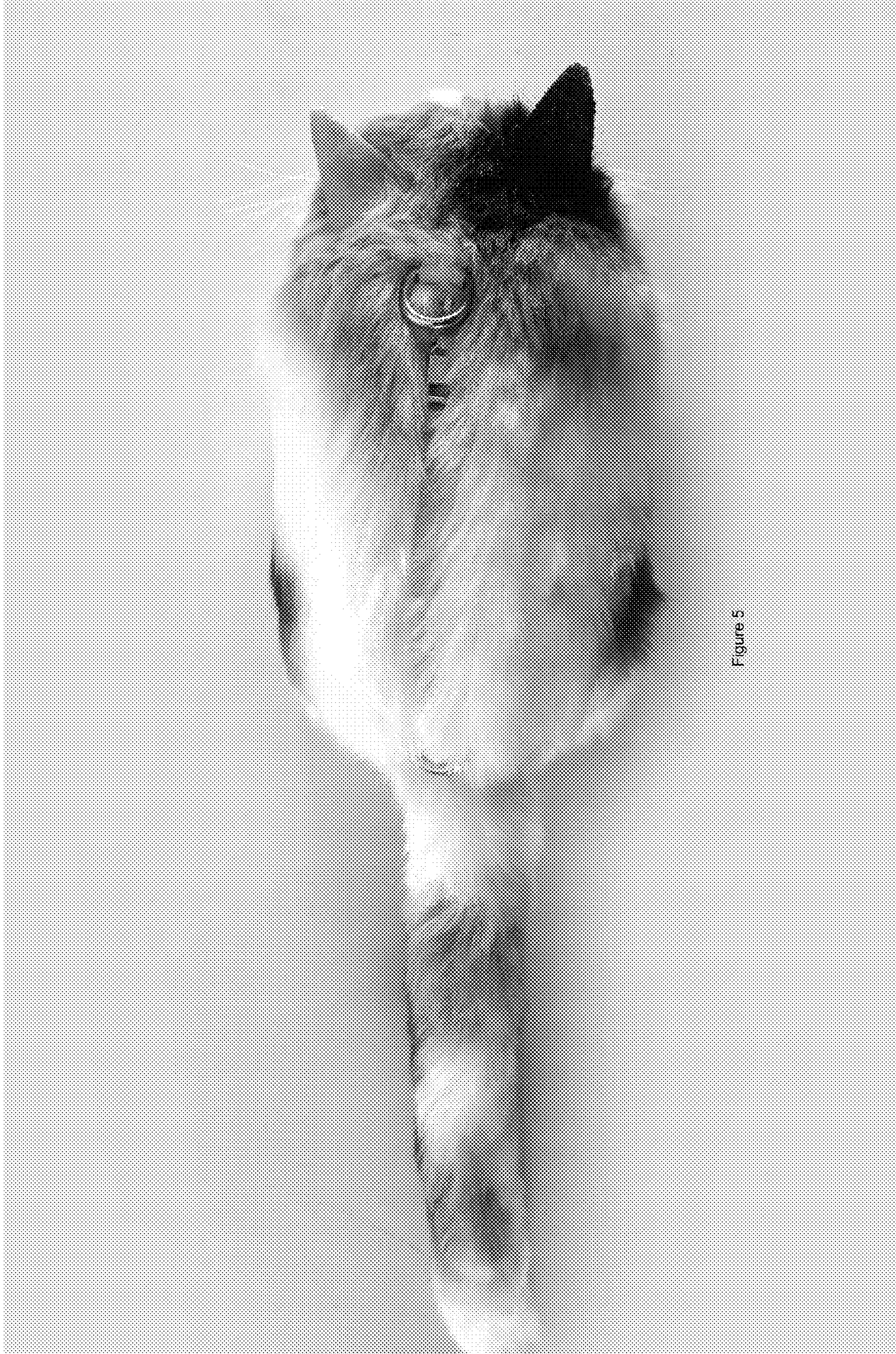
