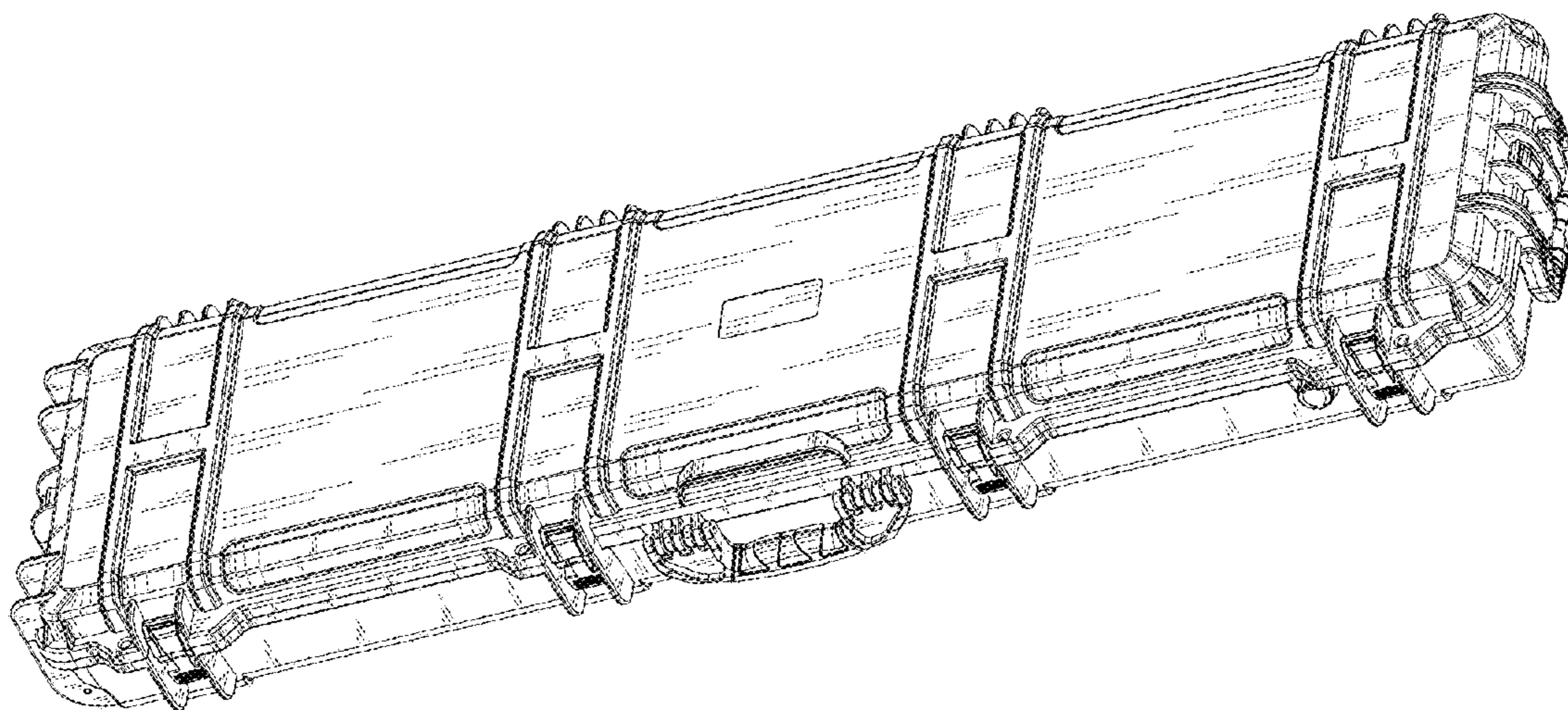
(57) **CLAIM**

The ornamental design for a gun box, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a gun box showing my new design; FIG. 2 is a rear view thereof; FIG. 3 is a top view thereof; FIG. 4 is a bottom view thereof; FIG. 5 is a perspective view thereof; FIG. 6 is an enlarged detailed view of the indicated area "6" in the FIG. 1; FIG. 7 is an enlarged detailed view of the indicated area "7" in the FIG. 2; FIG. 8 is an enlarged detailed view of the indicated area "8" in the FIG. 3; FIG. 9 is an enlarged detailed view of the indicated area "9" in the FIG. 4; FIG. 10 is an enlarged right side view thereof; and, FIG. 11 is an enlarged left side view thereof. The broken lines defining an enlargement portion of the design form no part of the claimed design.

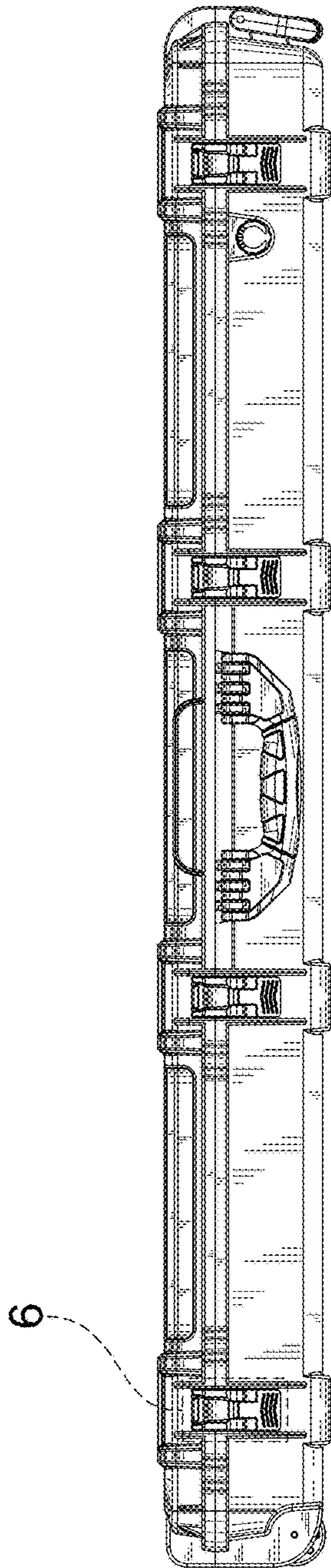

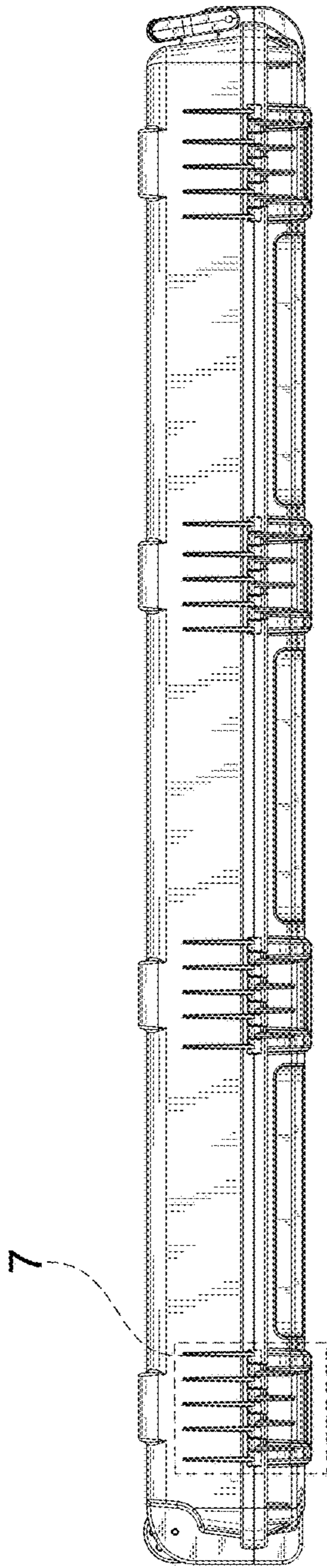

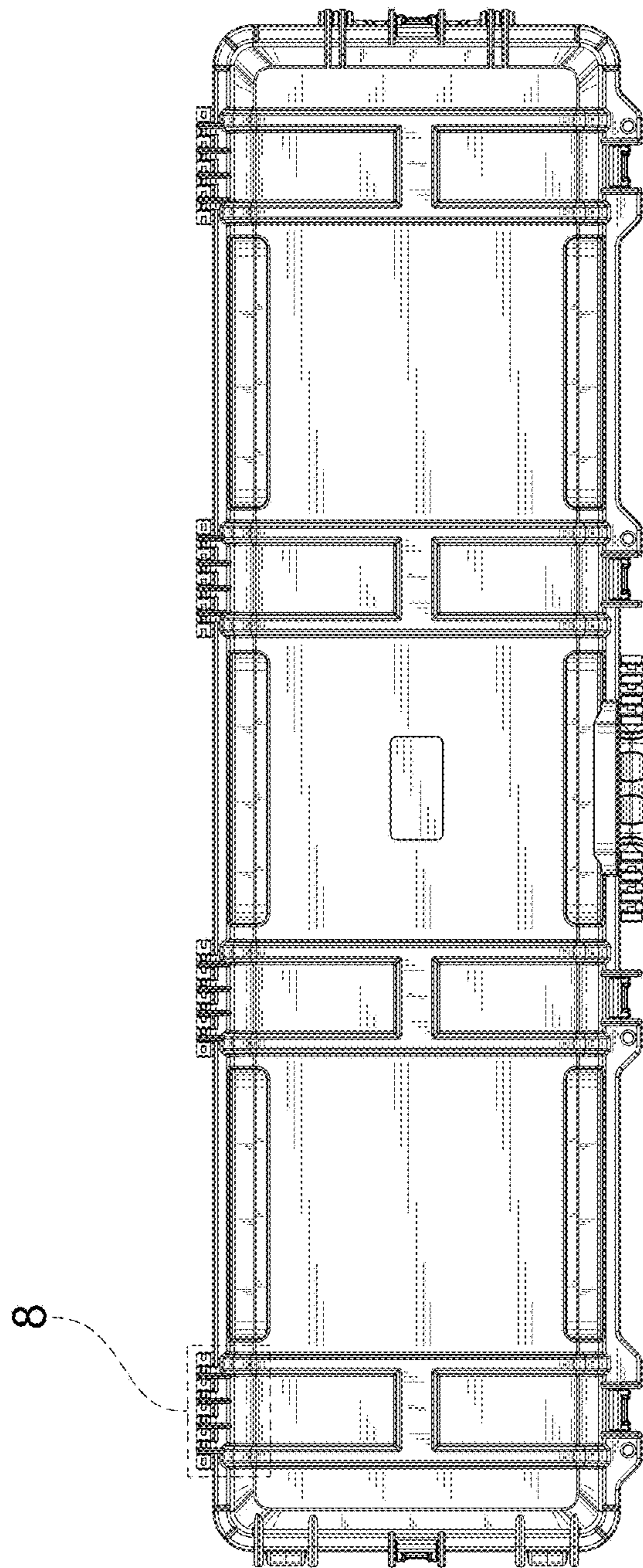

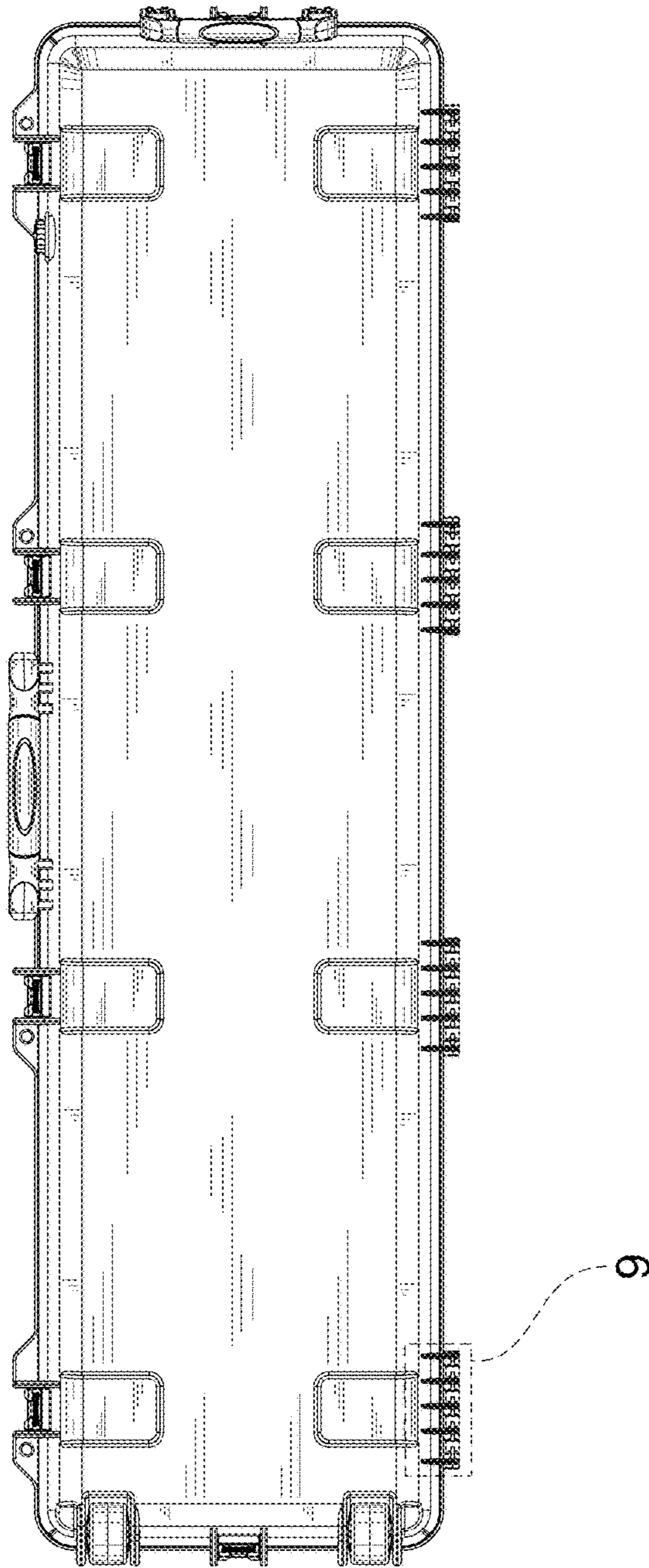

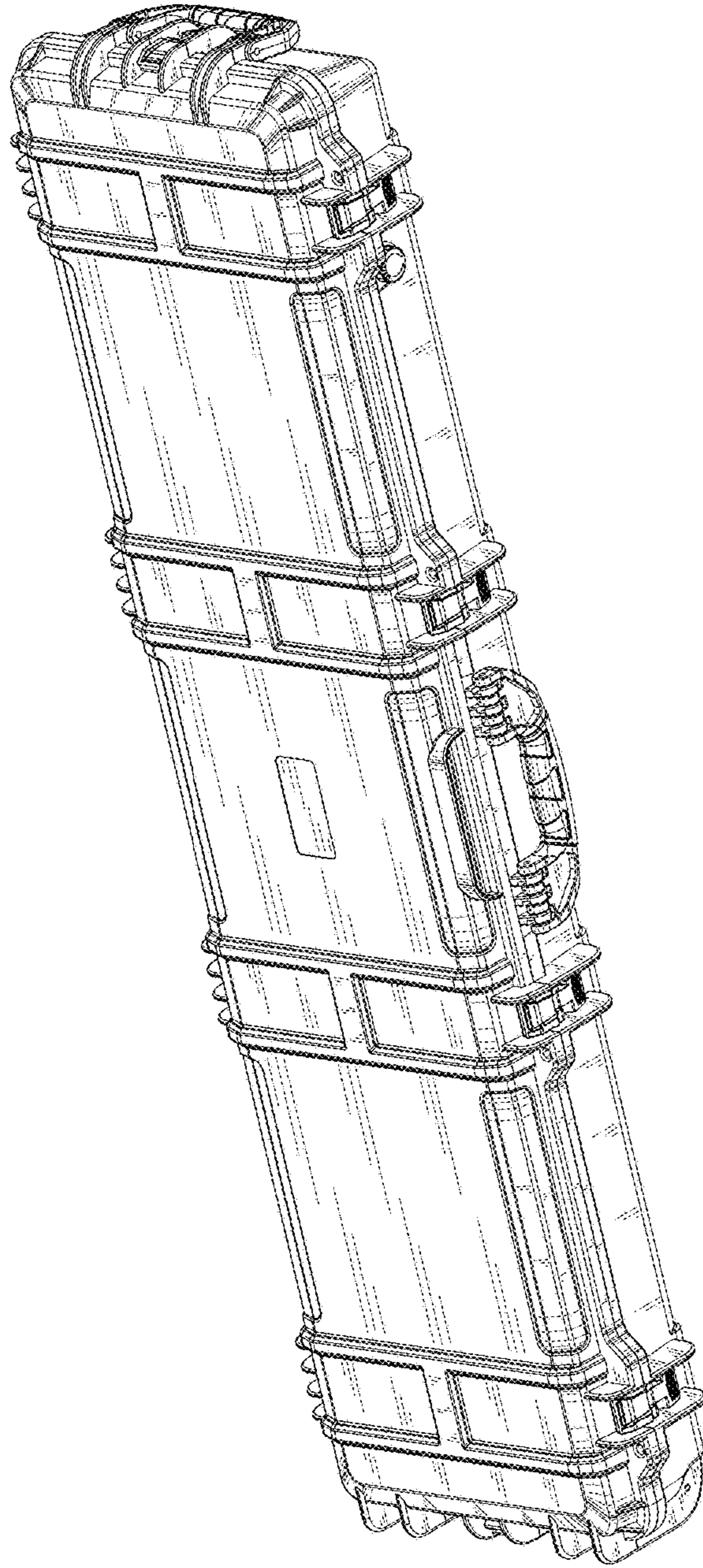

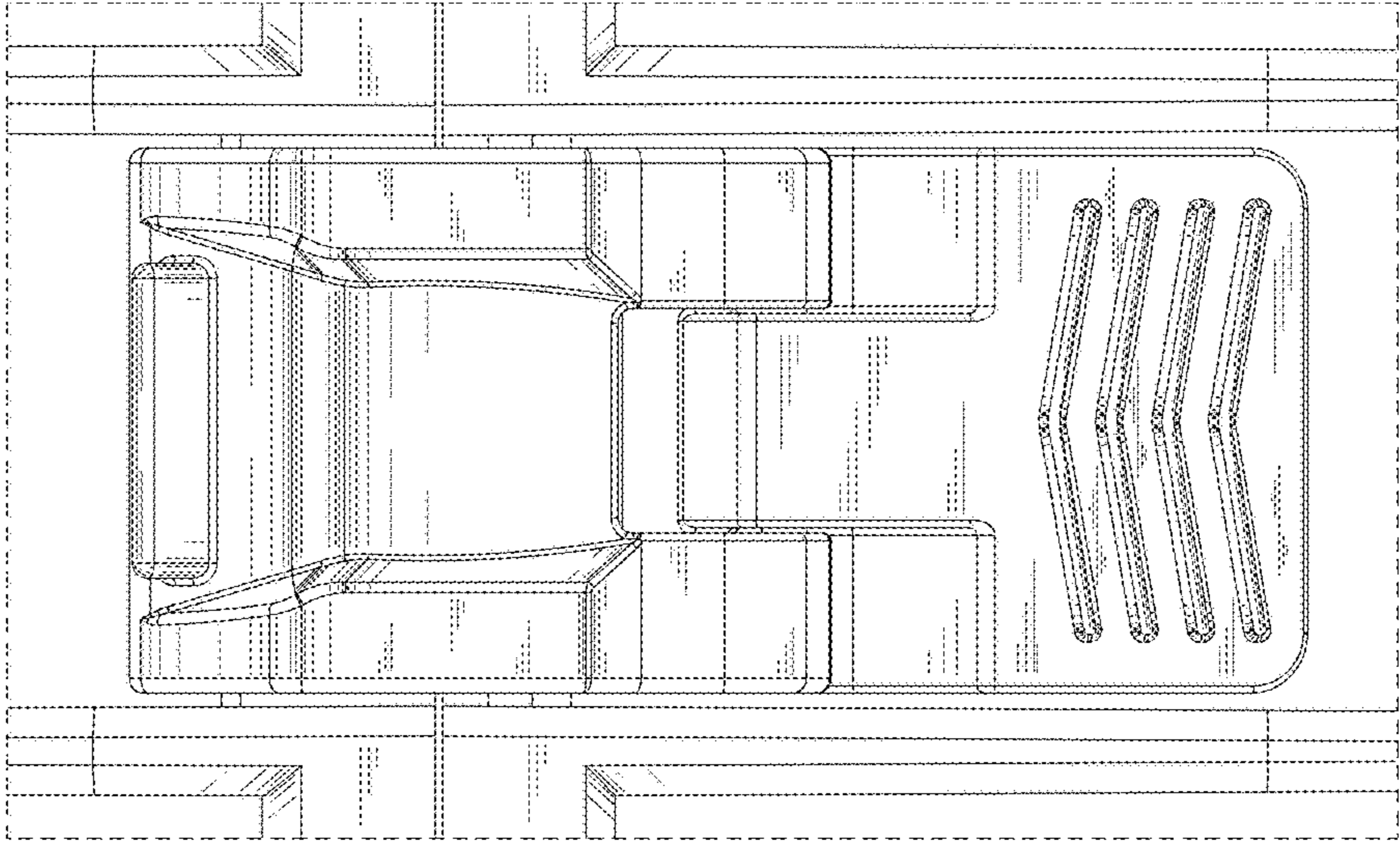

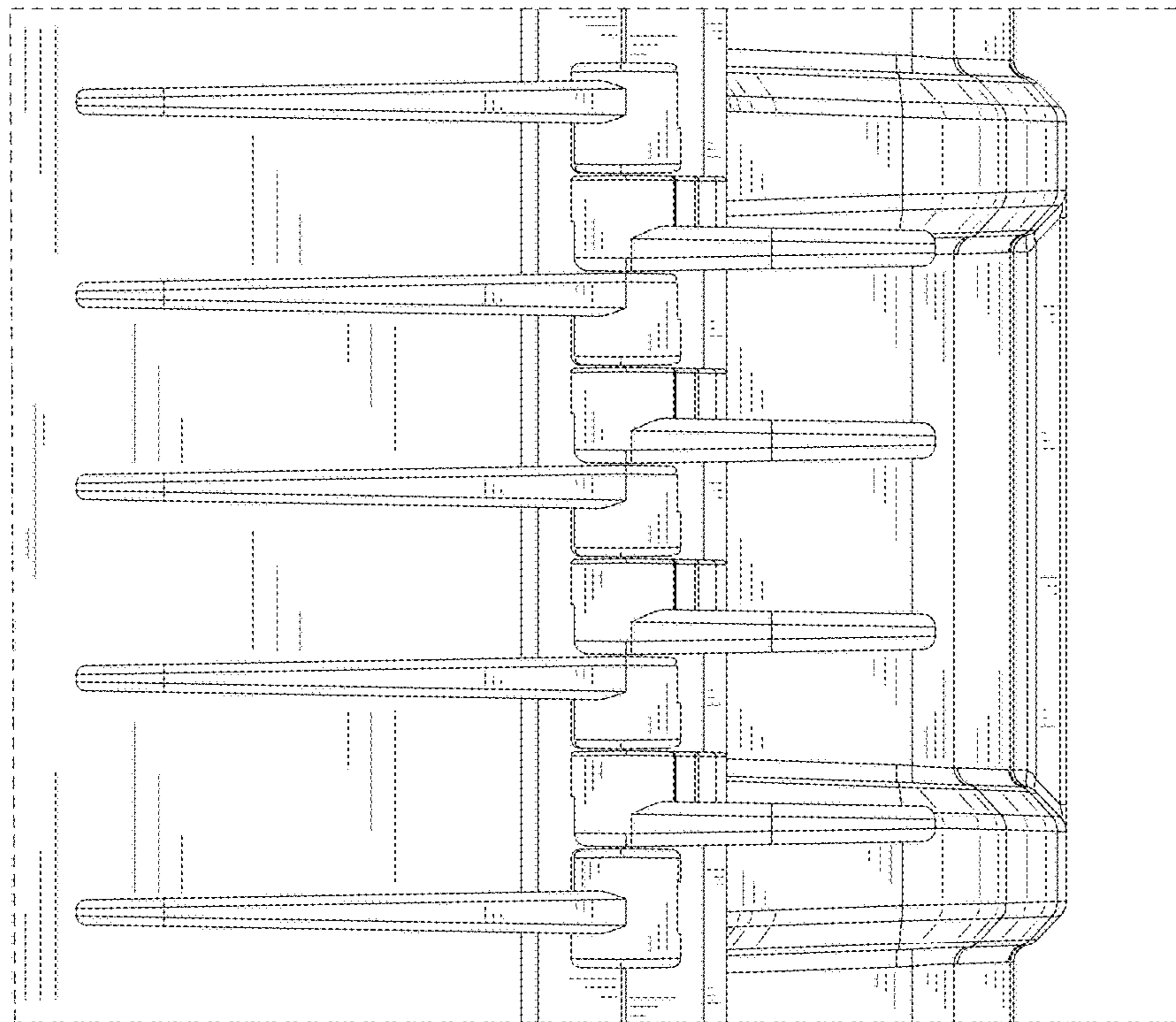

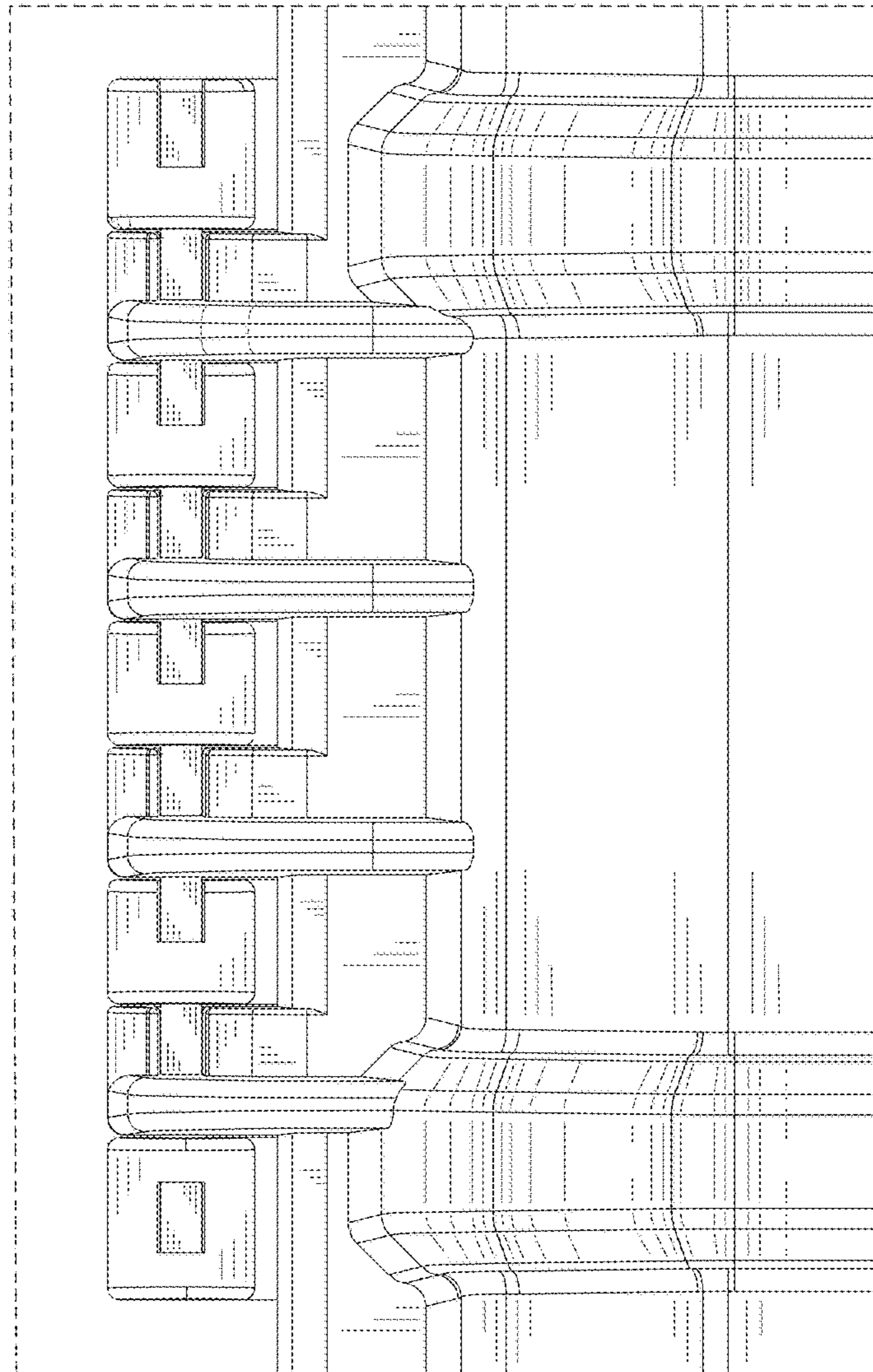

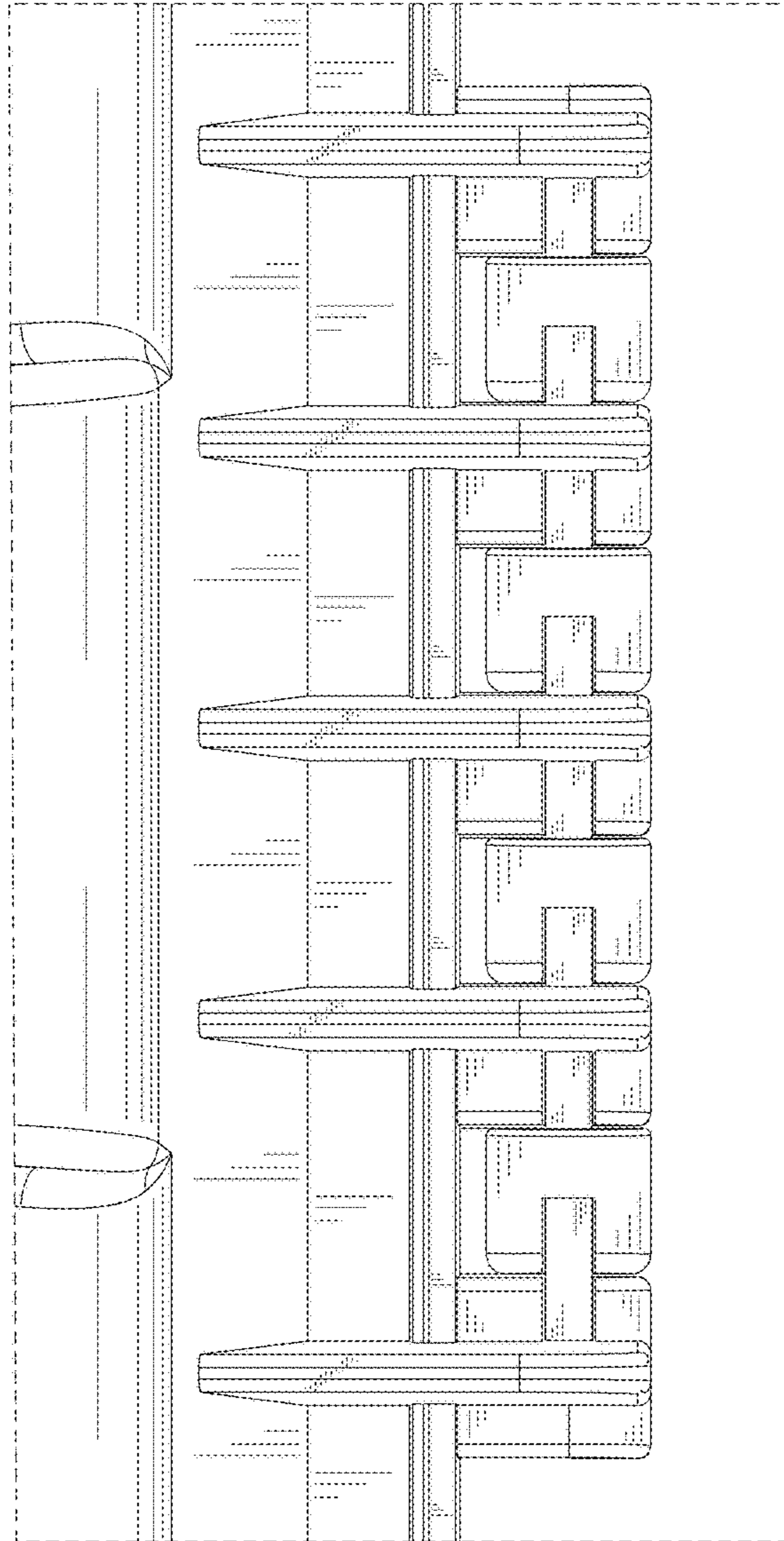

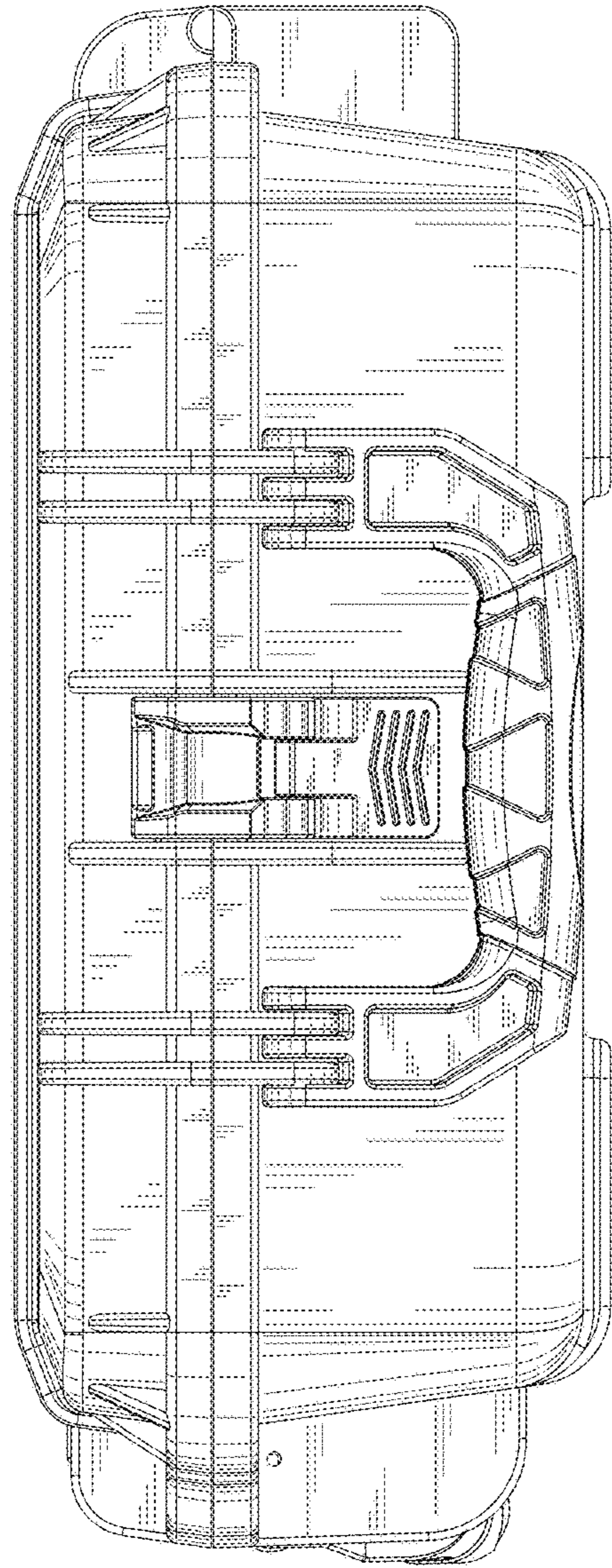

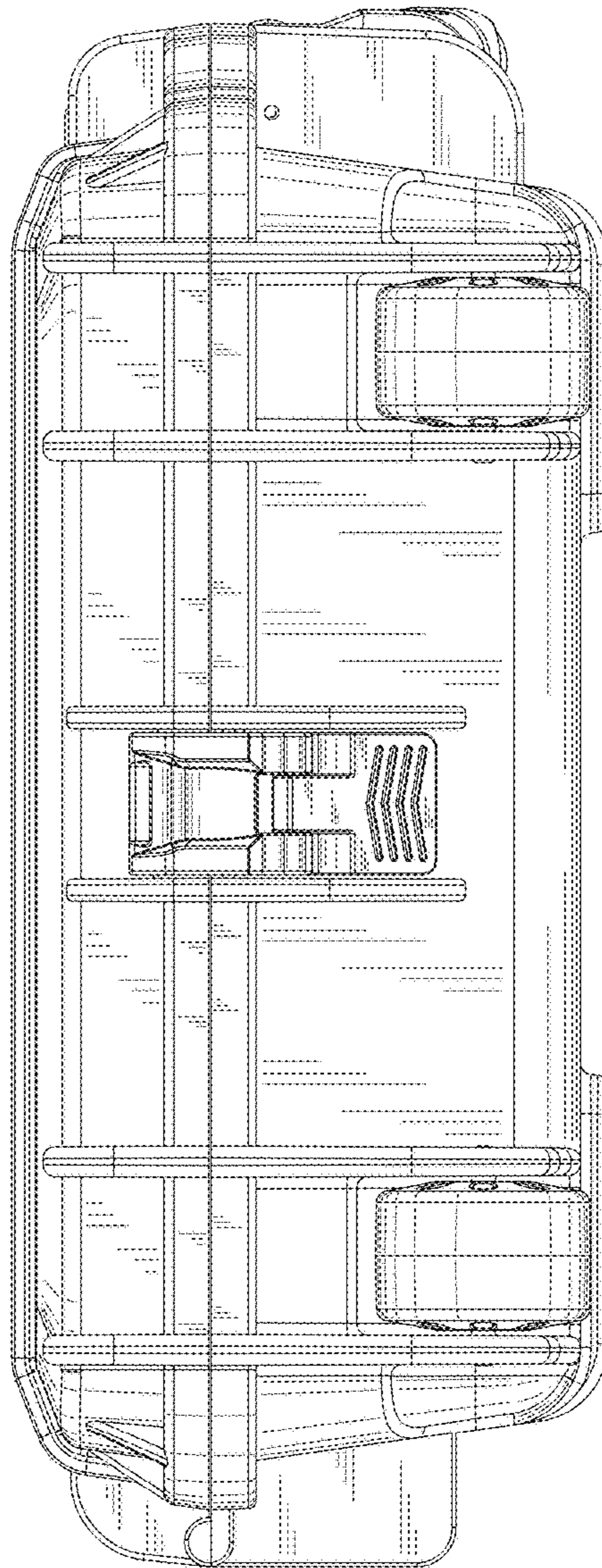
