(57) **CLAIM**

The ornamental design for a handle for a cosmetic brush, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view showing the design for a handle for a cosmetic brush.

FIG. 2 is a side elevational view showing the design for a handle for a cosmetic brush.

FIG. 3 is a front elevational view similar to FIG. 1, taken at an angle to one side, showing the design for a handle for a cosmetic brush.

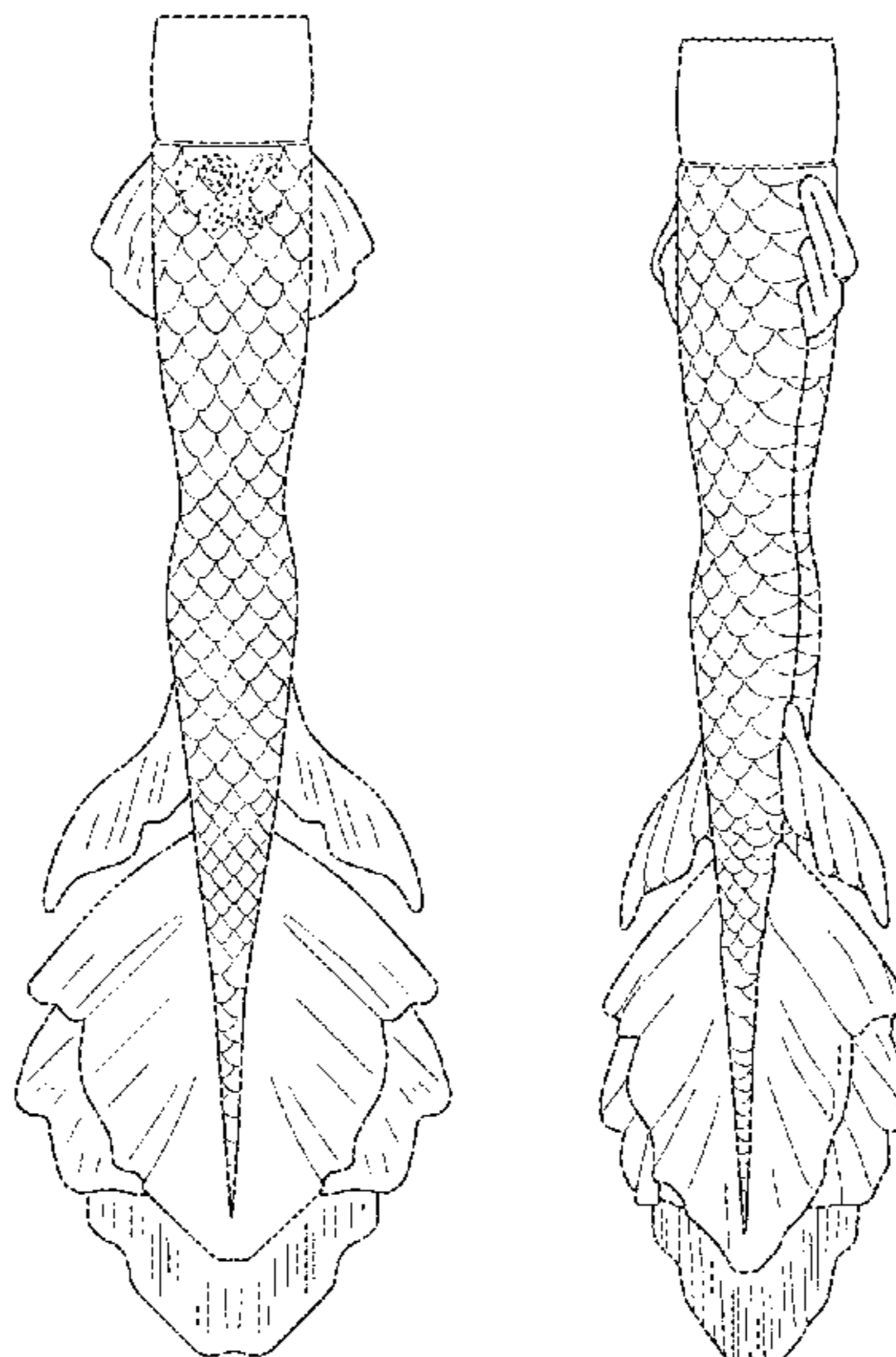
FIG. 4 is a top end view of the design for a handle for a cosmetic brush; and,

FIG. 5 is a bottom end view of the design for a handle for a cosmetic brush.

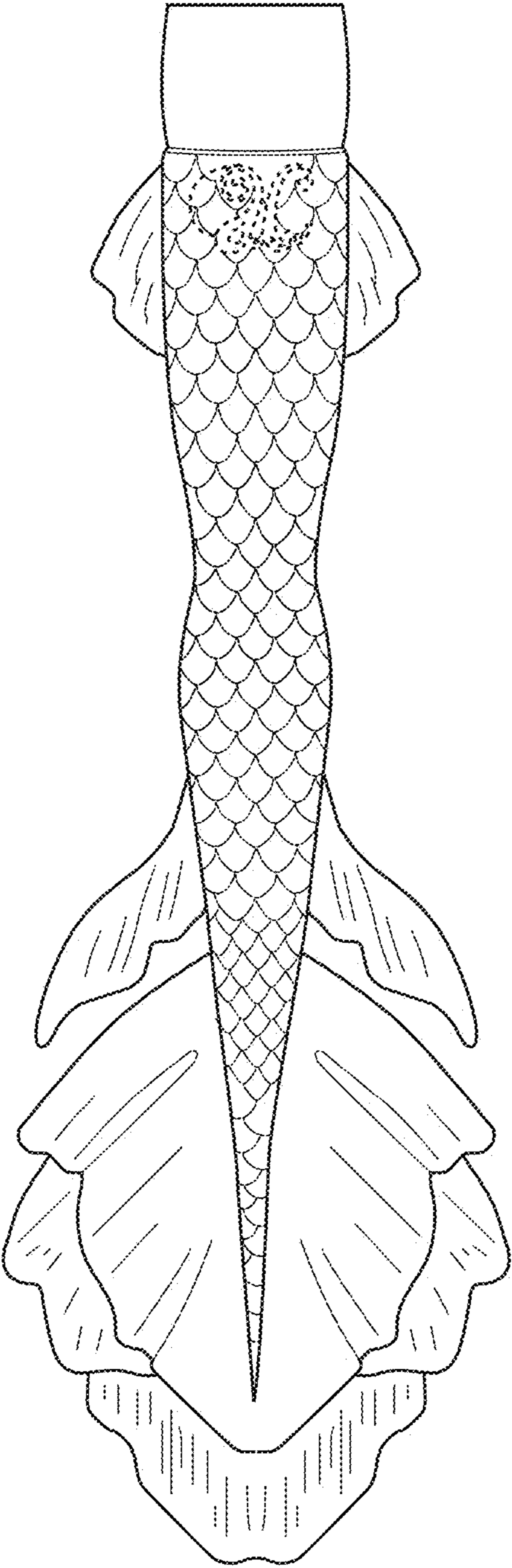

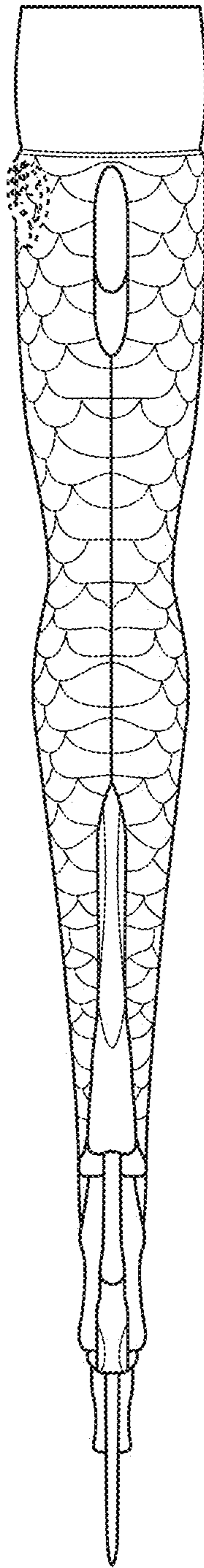

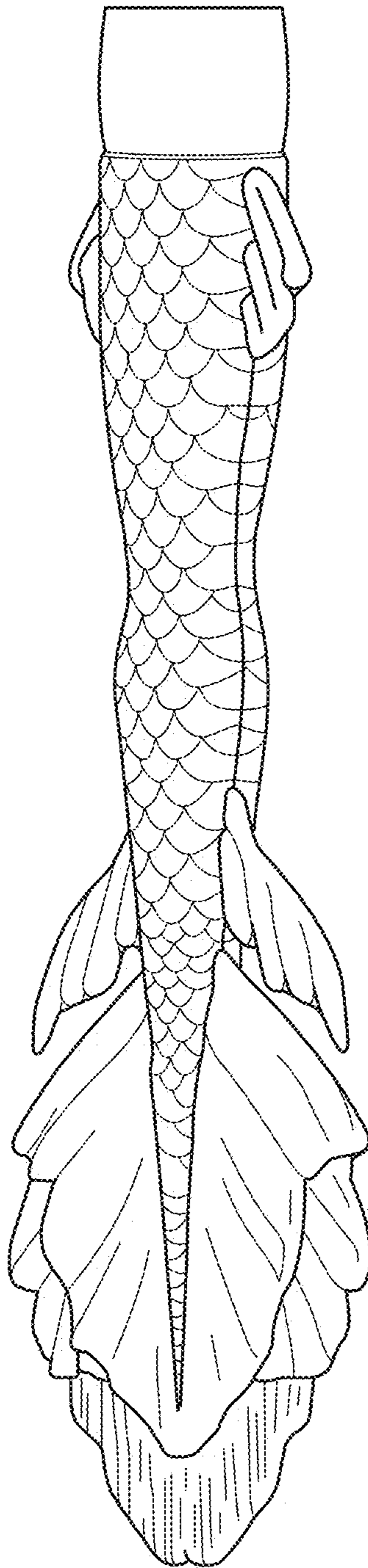

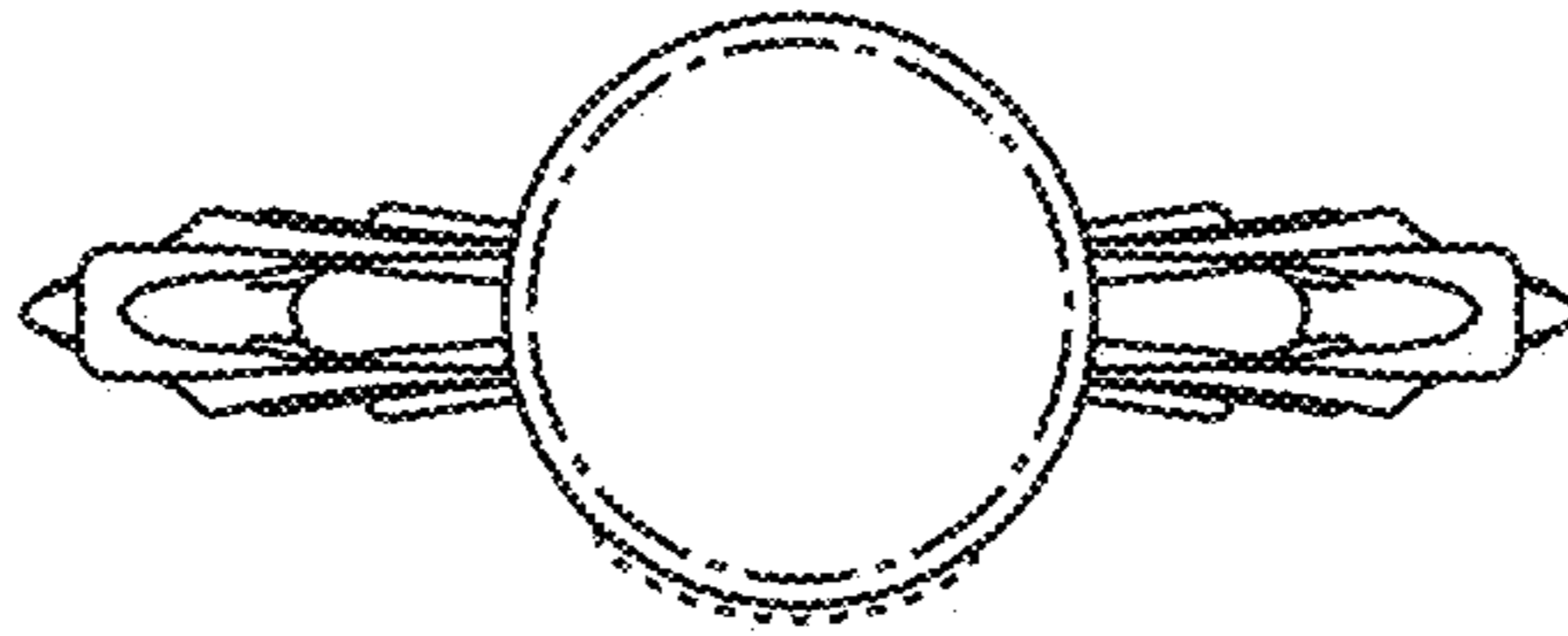

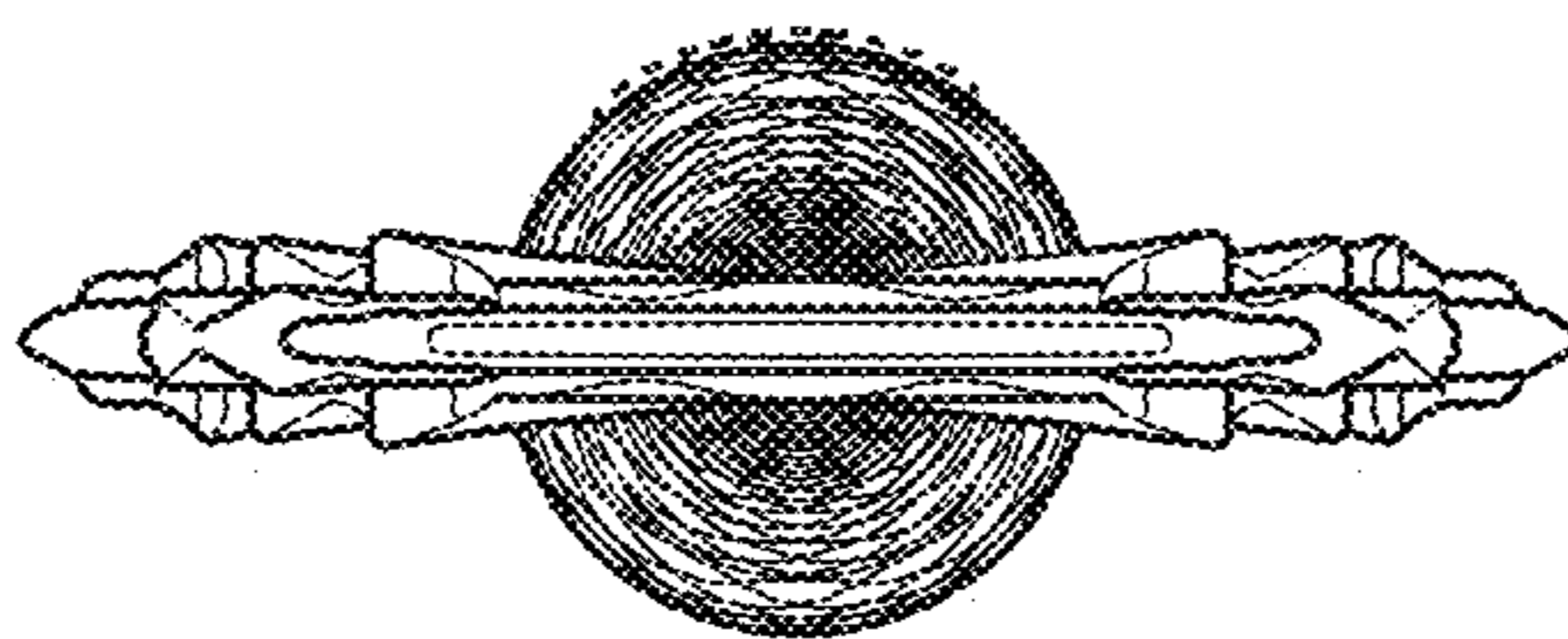
