(57) **CLAIM**

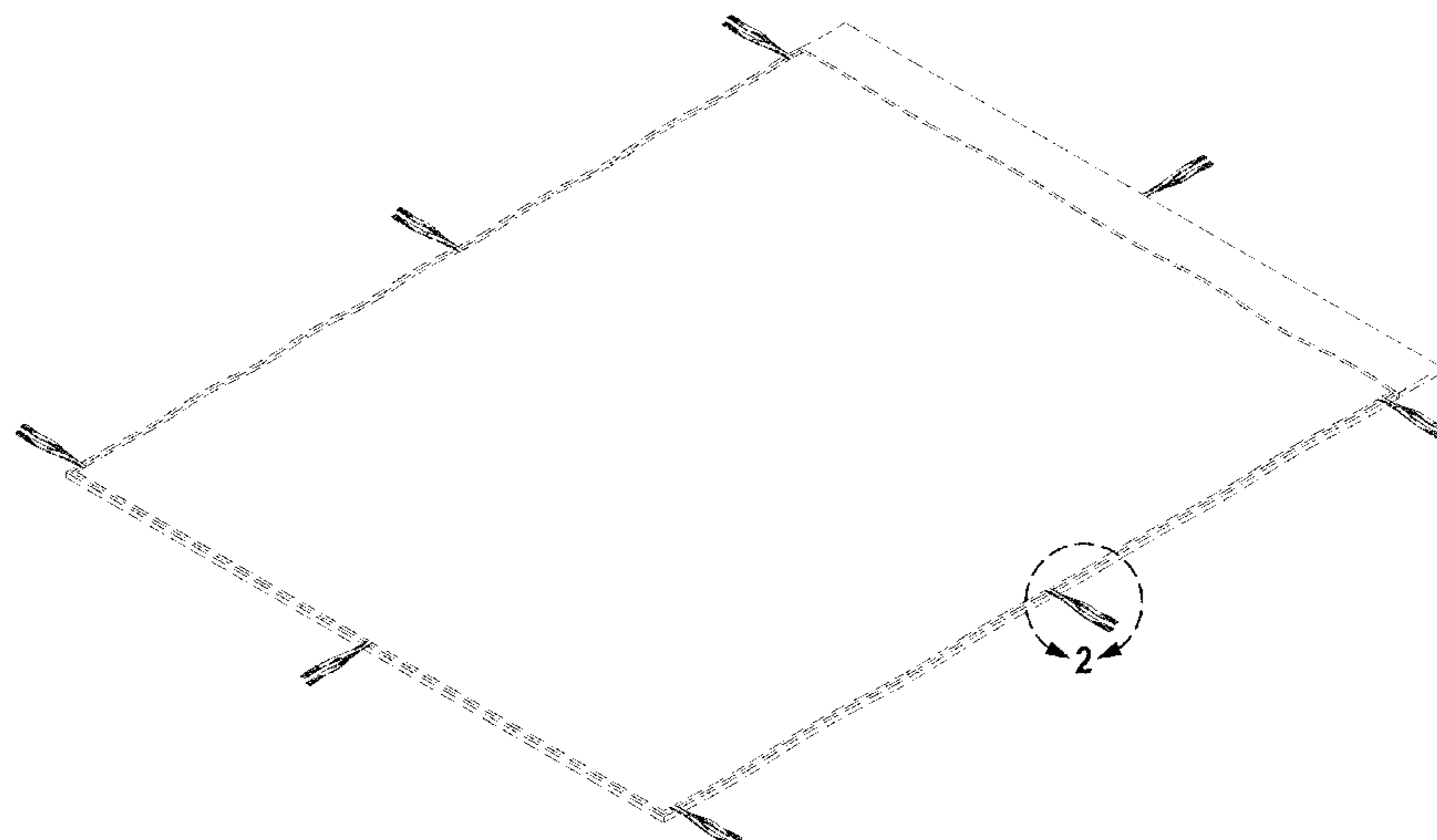
The ornamental design for a duvet fastening system, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of the duvet fastening system shown within a duvet cover environment drawn in broken lines;
 FIG. 2 is an enlarged detail isometric view showing one of eight fasteners within the duvet fastening system;
 FIG. 3 is a front view;
 FIG. 4 is a back view;
 FIG. 5 is a right side view;
 FIG. 6 is a left side view;
 FIG. 7 is a top side view; and,
 FIG. 8 is a bottom side view.
 The broken lines shown in the drawings are included for the purpose of illustrating a duvet cover environment and form no part of the claimed design.

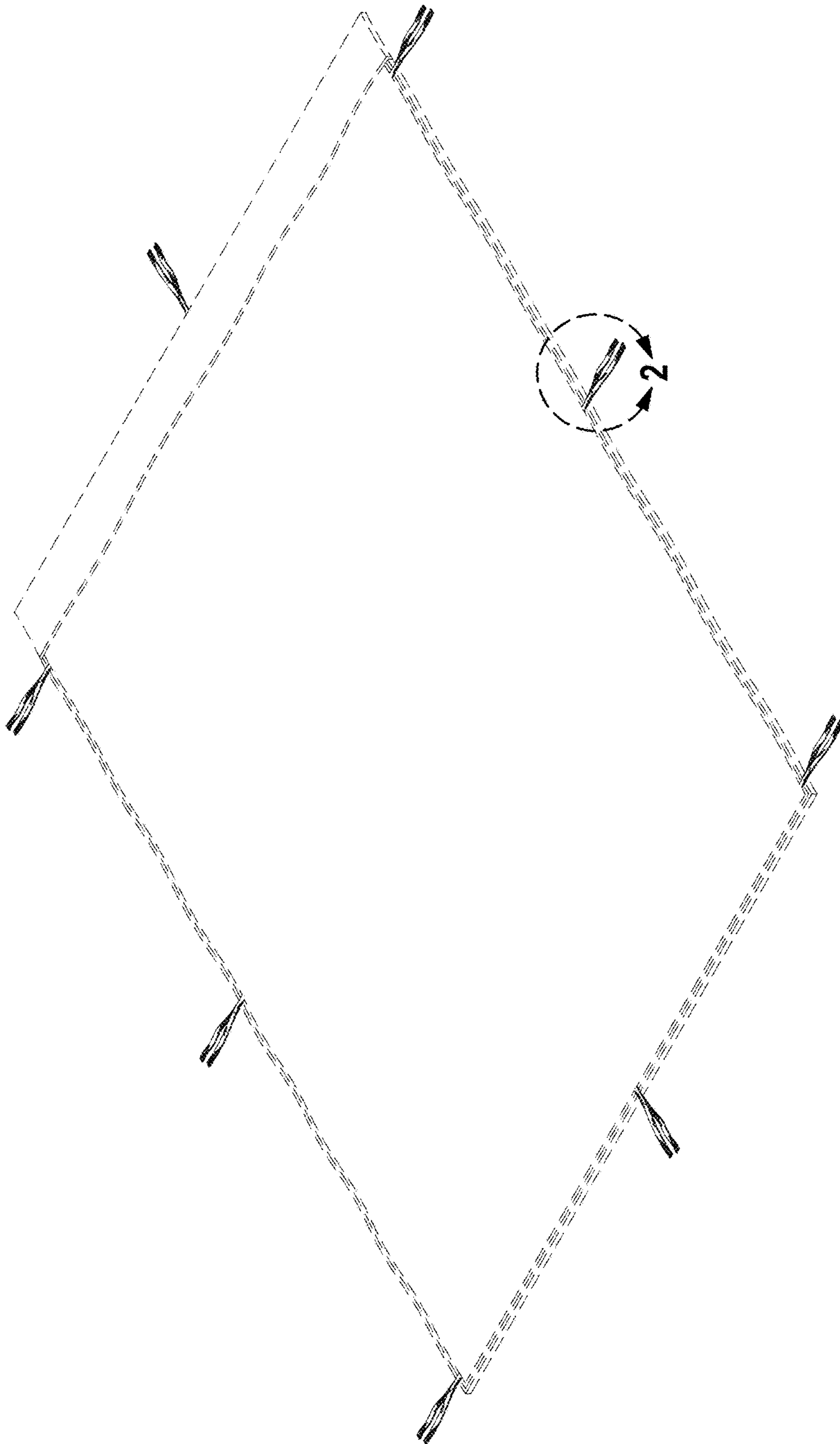

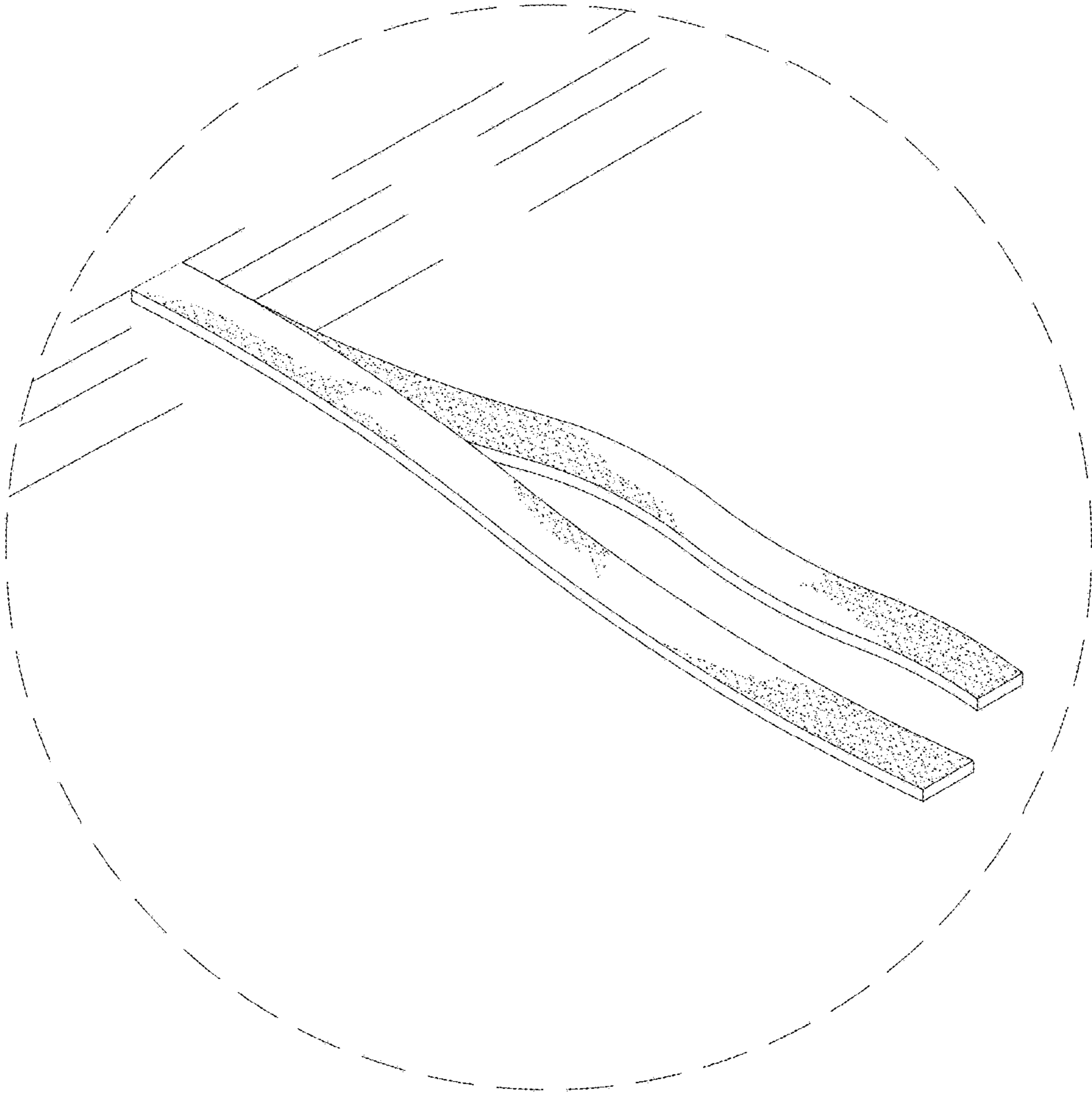

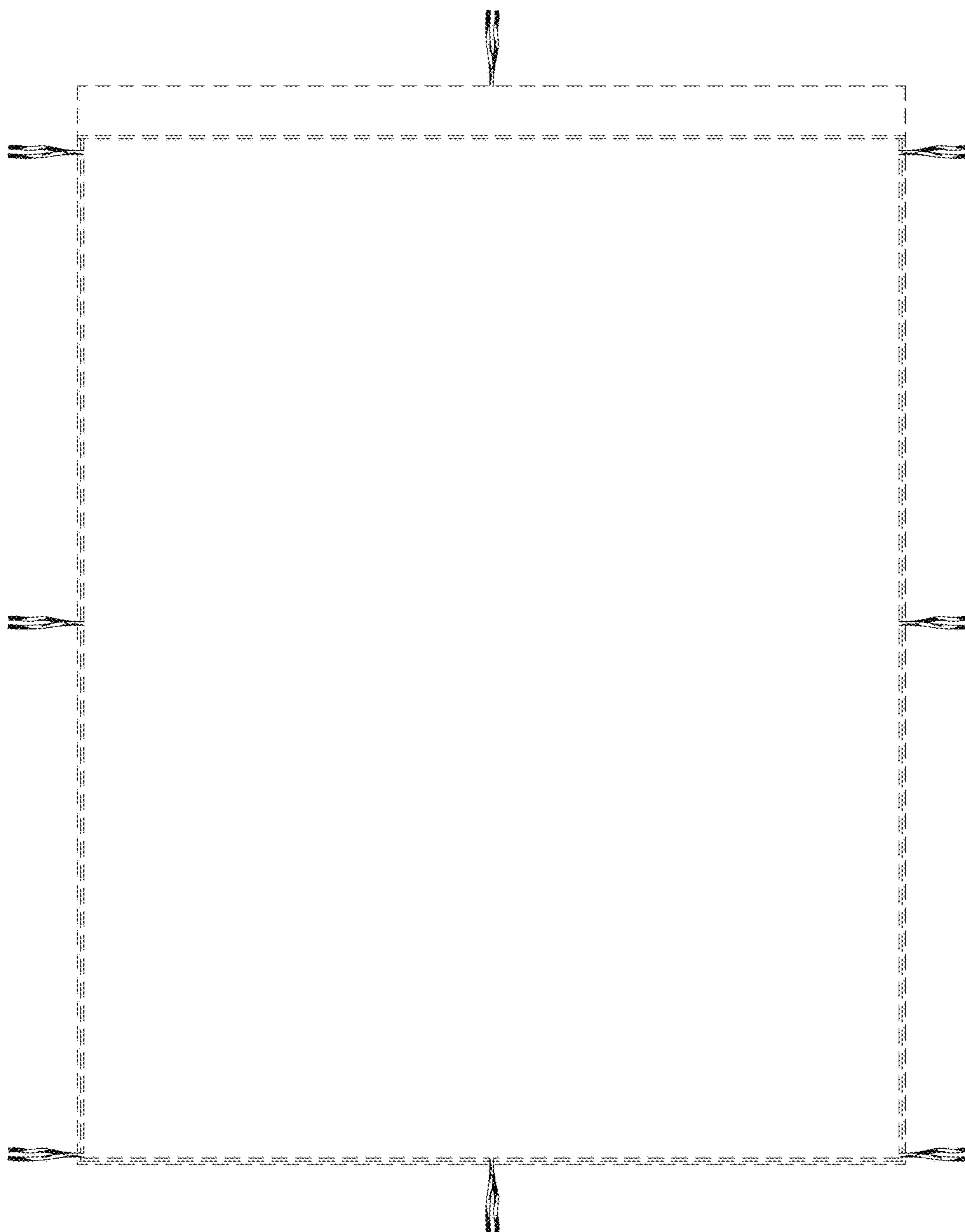

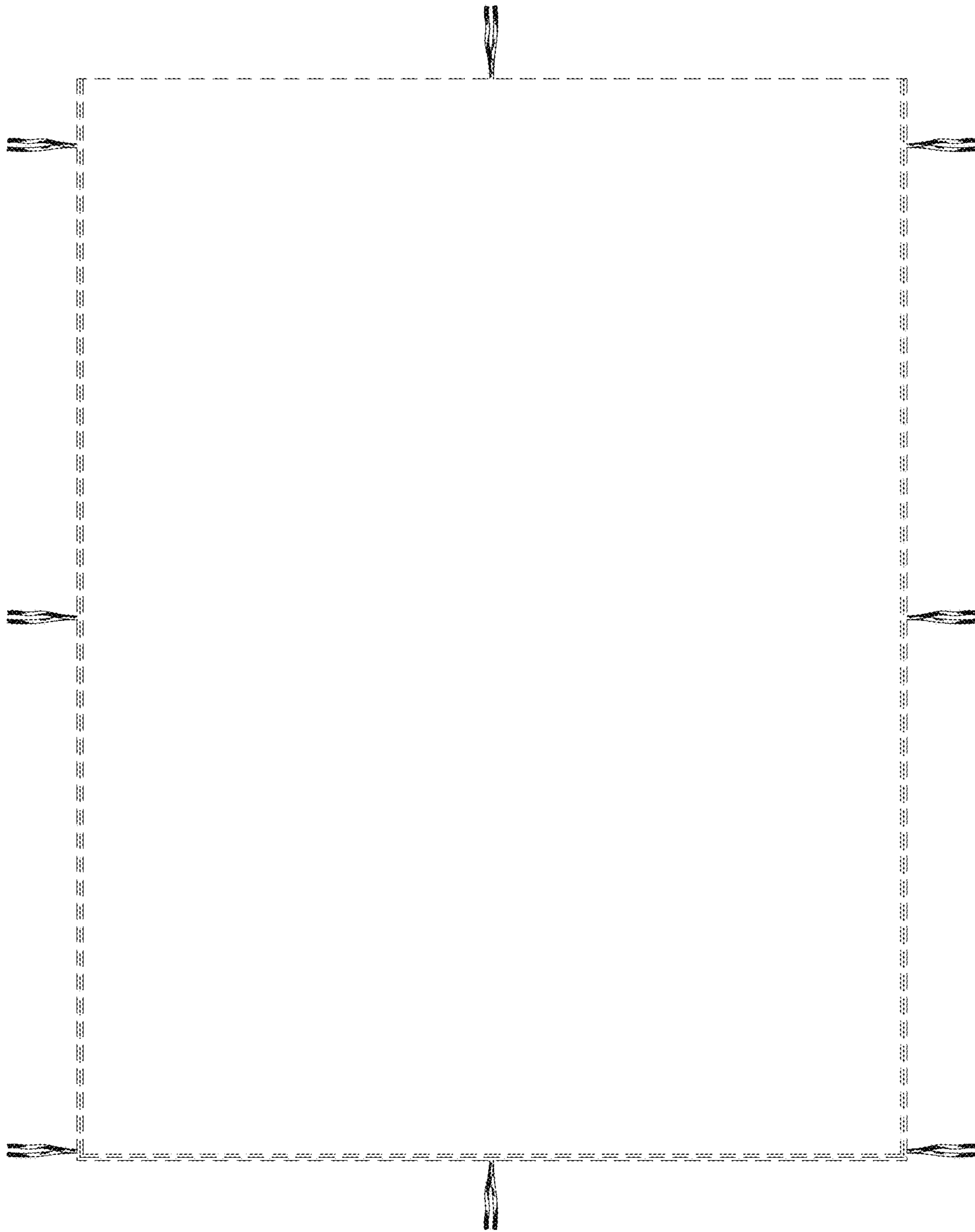

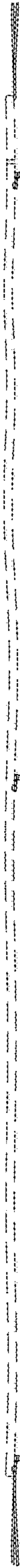

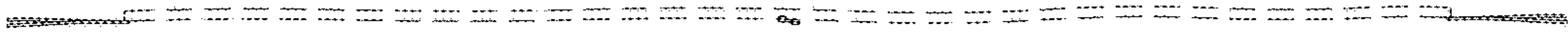

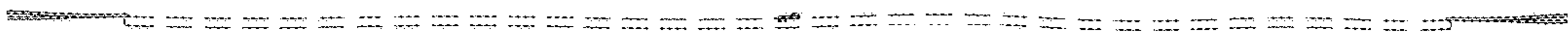
