(57) **CLAIM**

The ornamental design of a beverage flavor cartridge, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a beverage flavor cartridge. FIG. 2 is a front view of the beverage flavor cartridge. FIG. 3 is a back view of the beverage flavor cartridge. FIG. 4 is a left-side view of the beverage flavor cartridge. FIG. 5 is a right-side view of the beverage flavor cartridge. FIG. 6 is a top view of the beverage flavor cartridge. FIG. 7 is a bottom view of the beverage flavor cartridge; and, FIG. 8 is an environmental view of the beverage flavor cartridge.

The broken lines shown in the drawings illustrate portions of the beverage flavor cartridge that form no part of the claimed design.

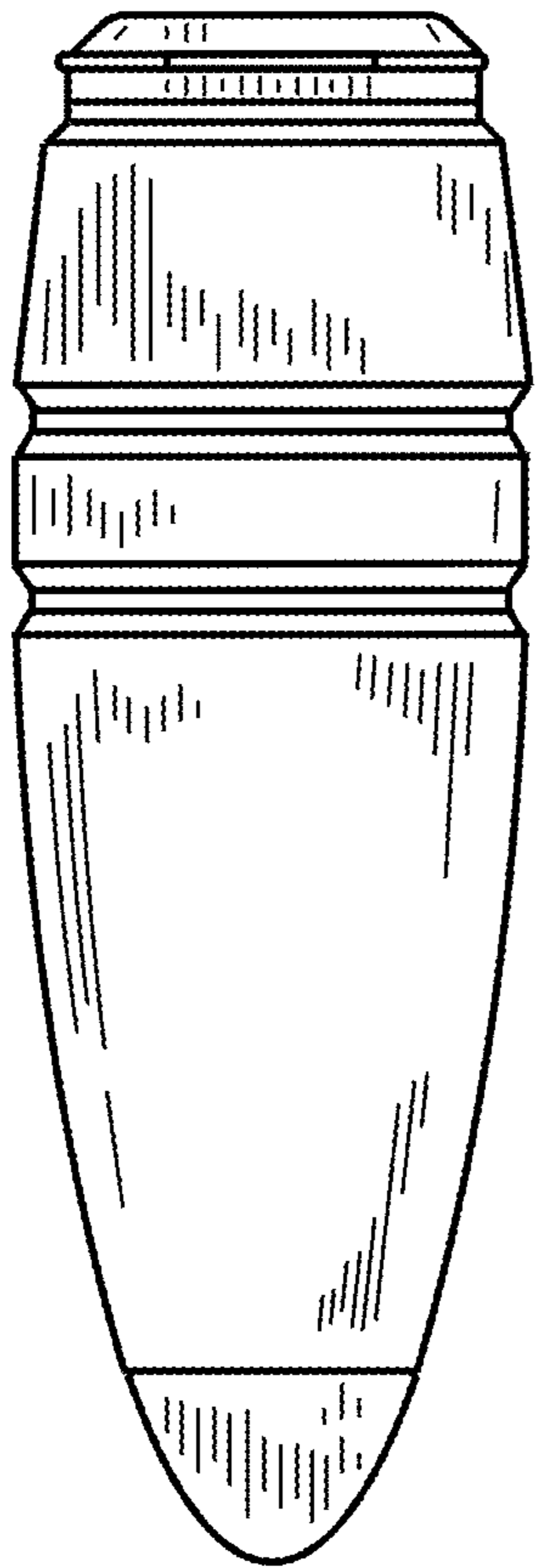

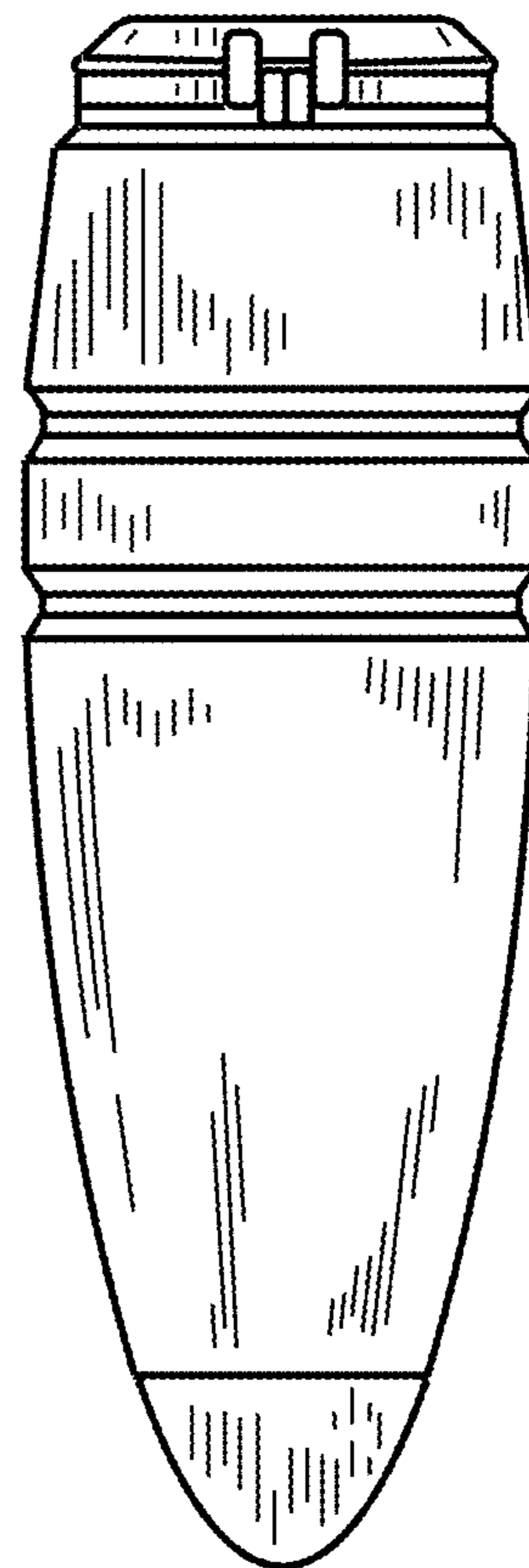

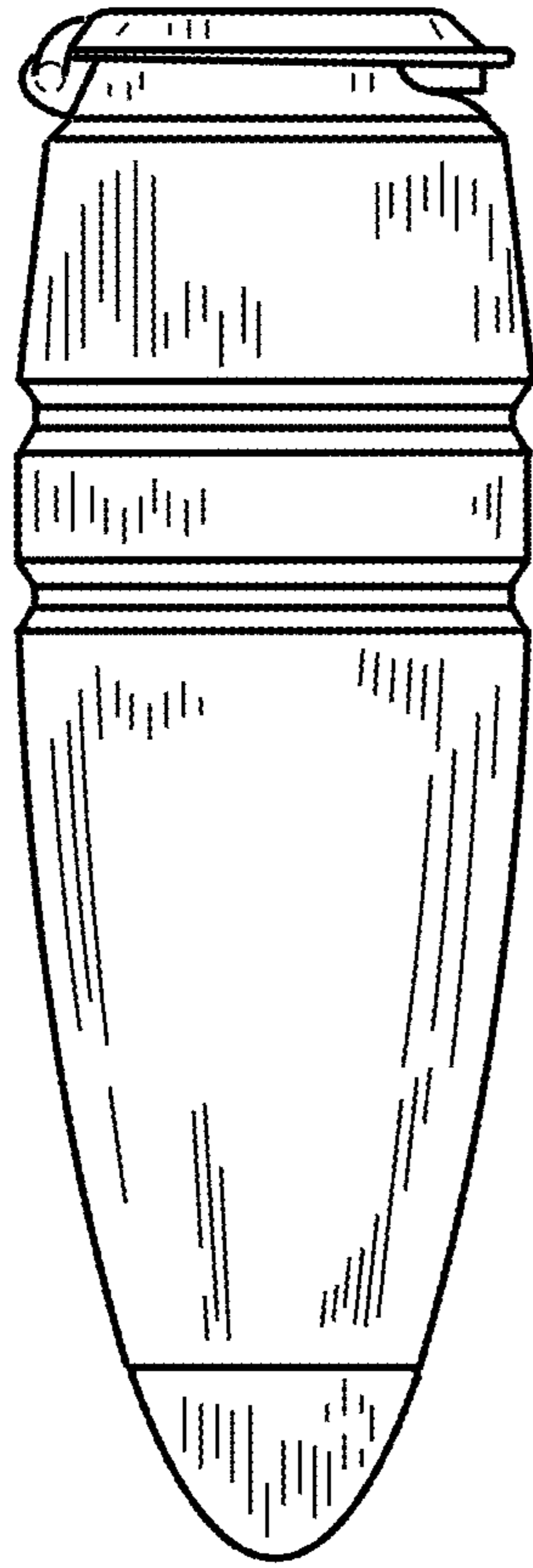

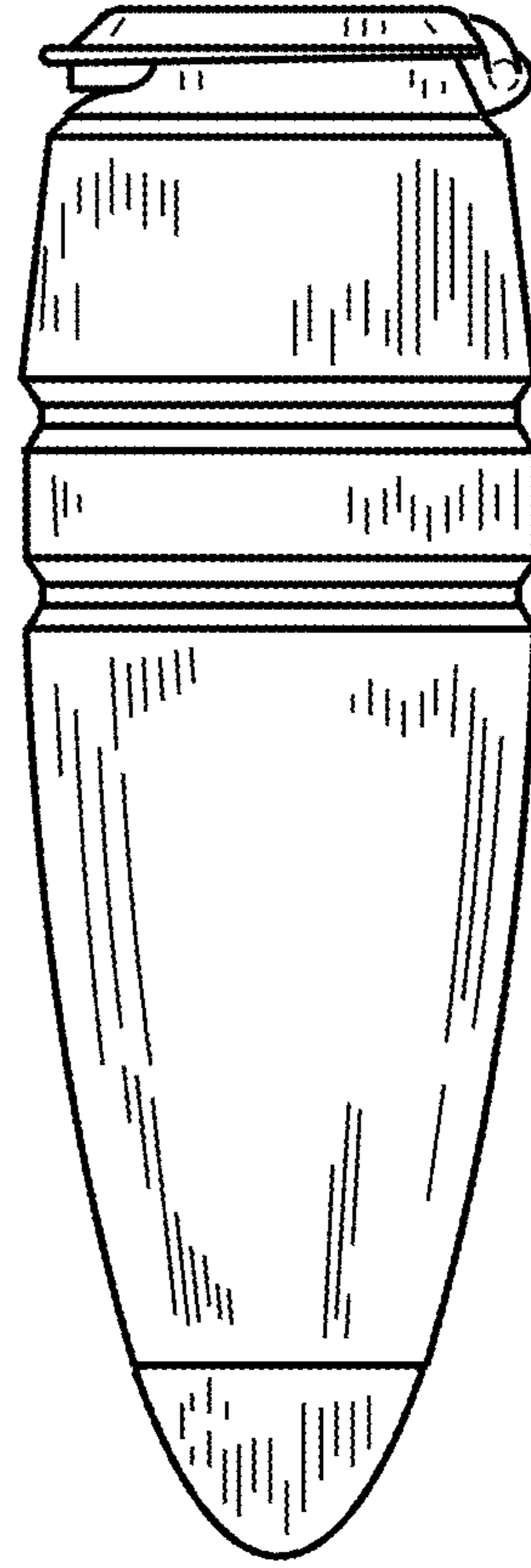

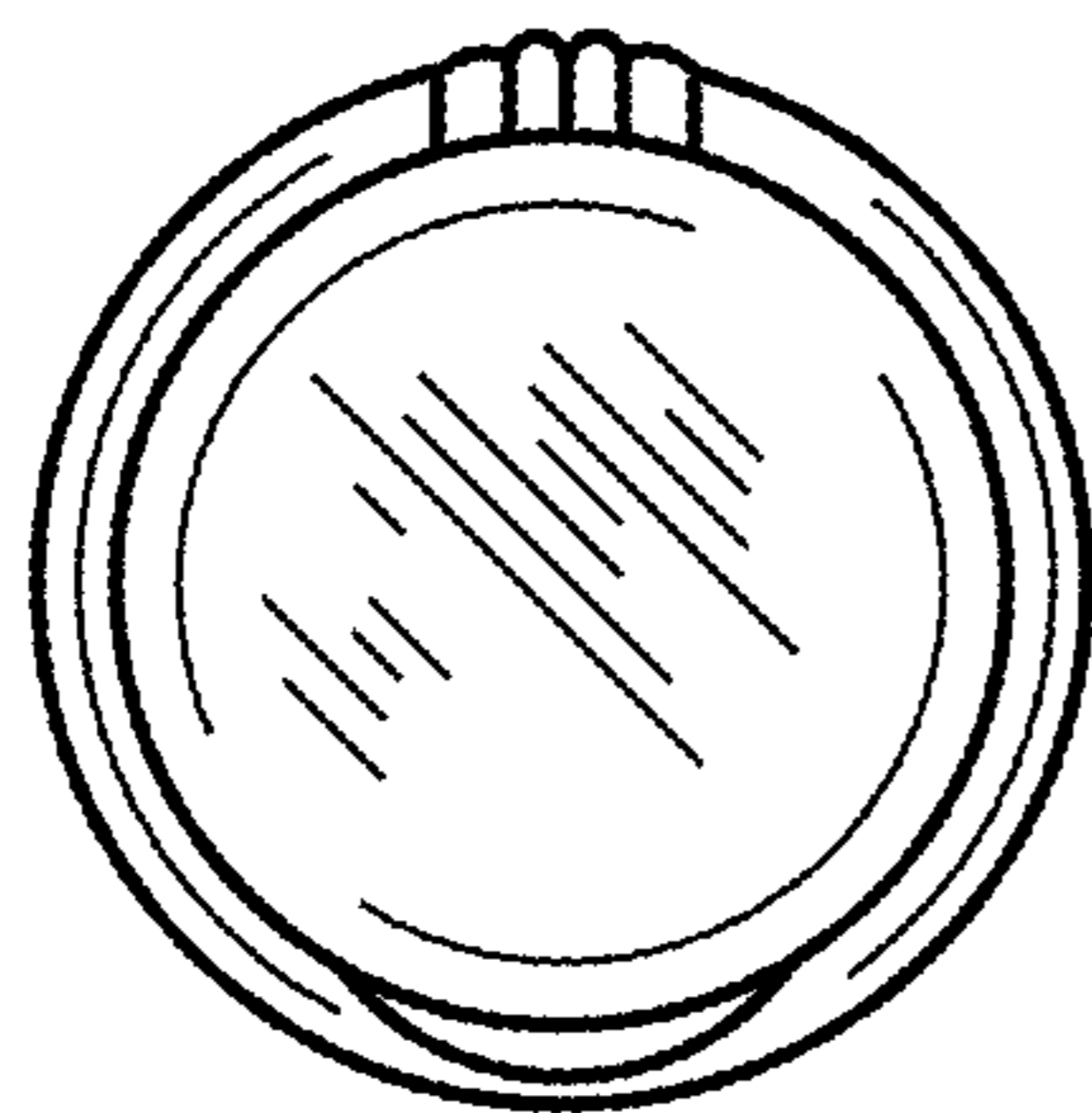

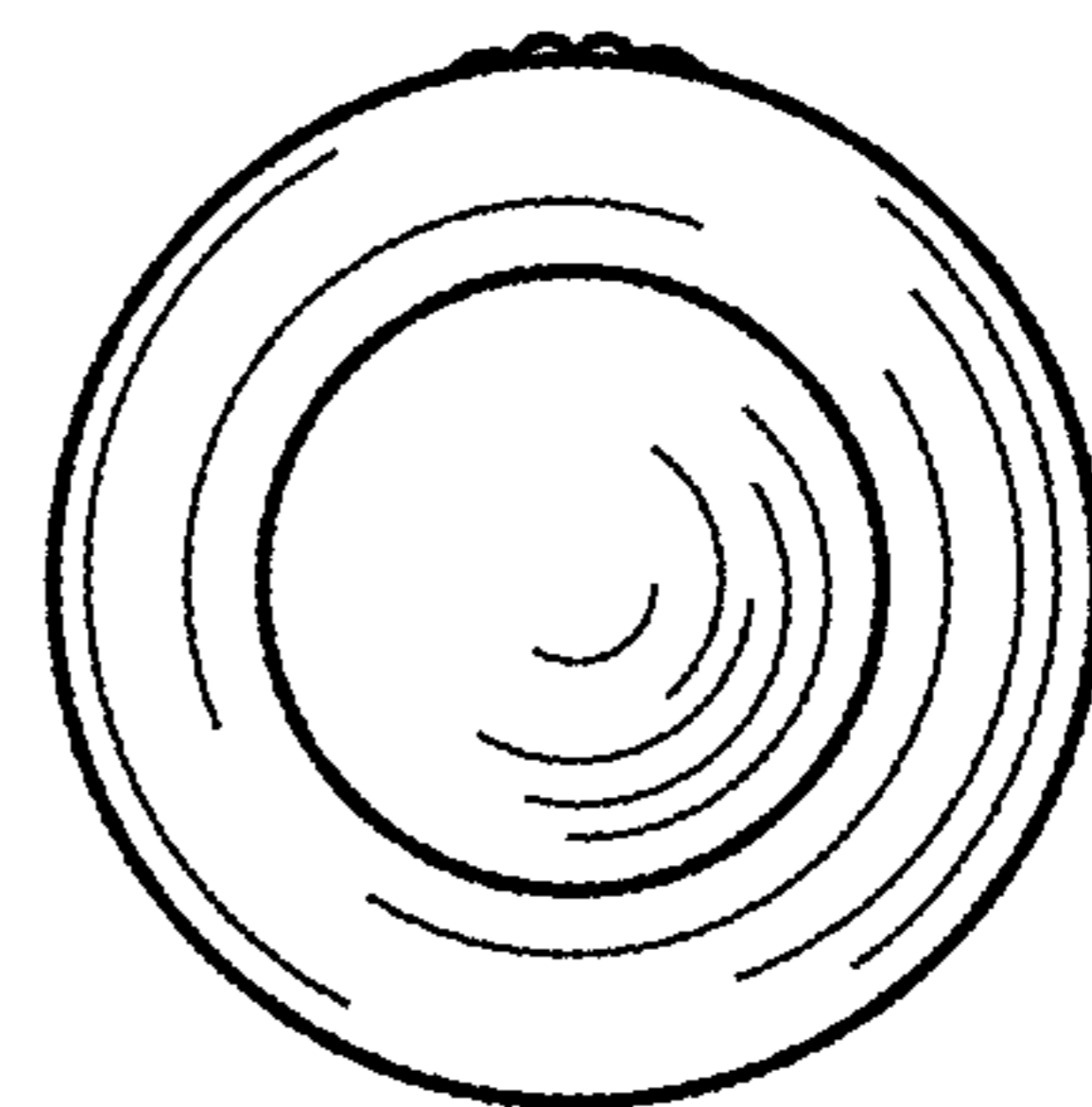

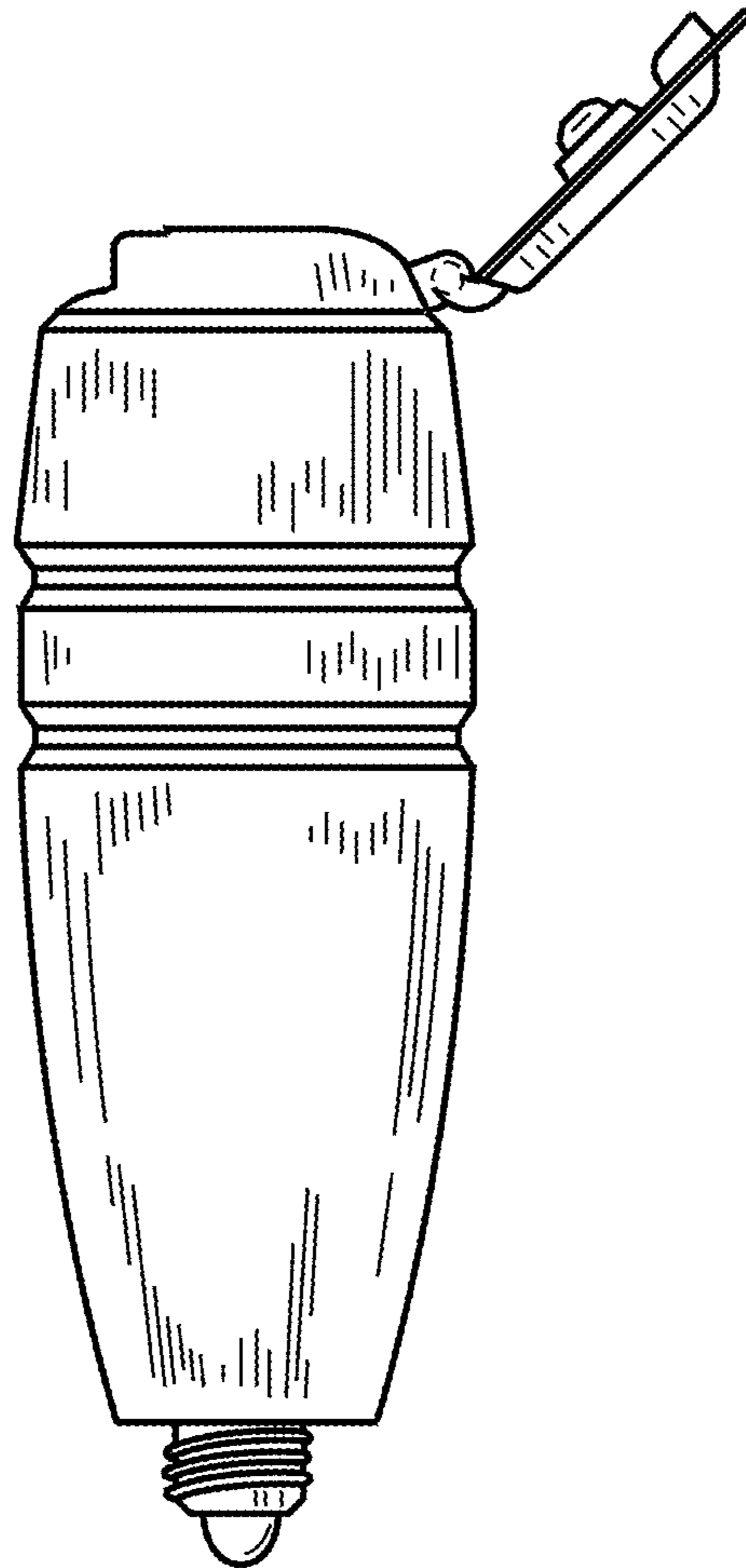
