DESCRIPTION

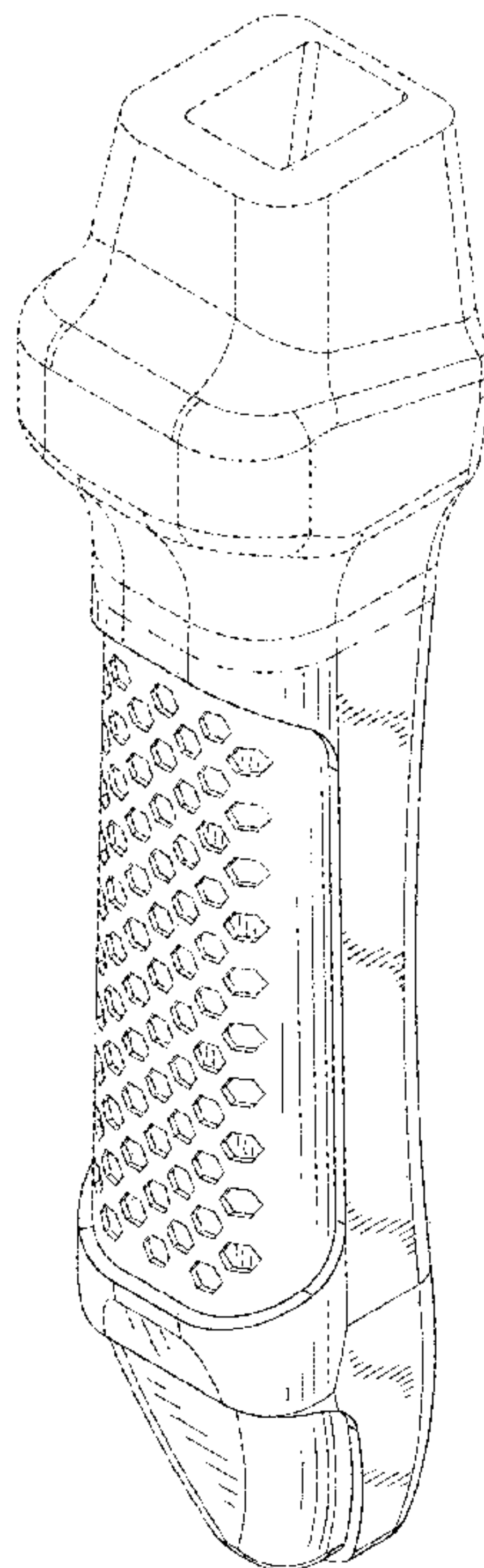
FIG. 1 is a right, front, and top perspective view of a tool handle showing my new design;

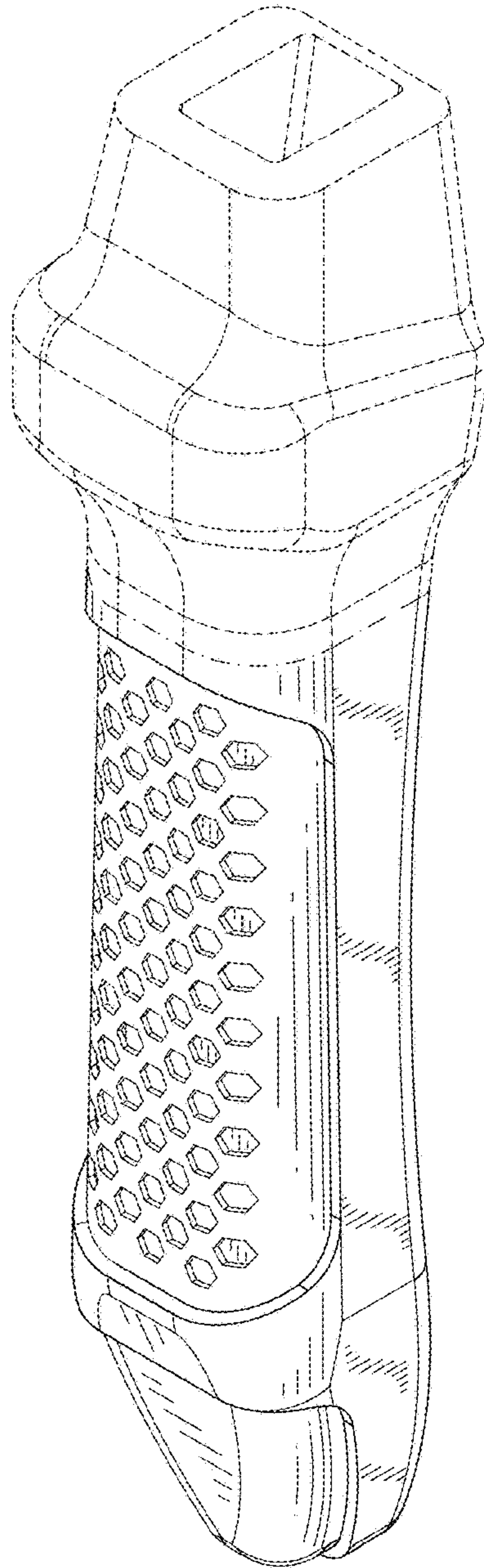

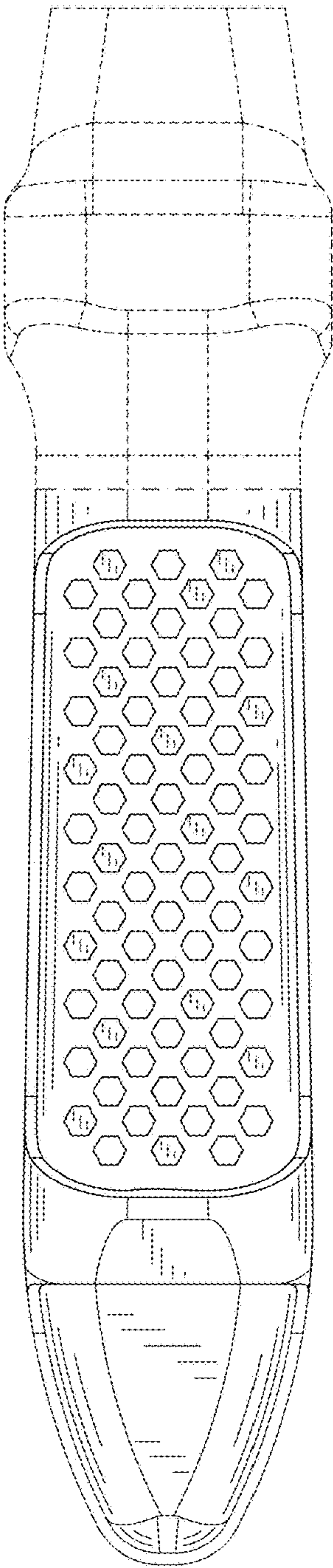

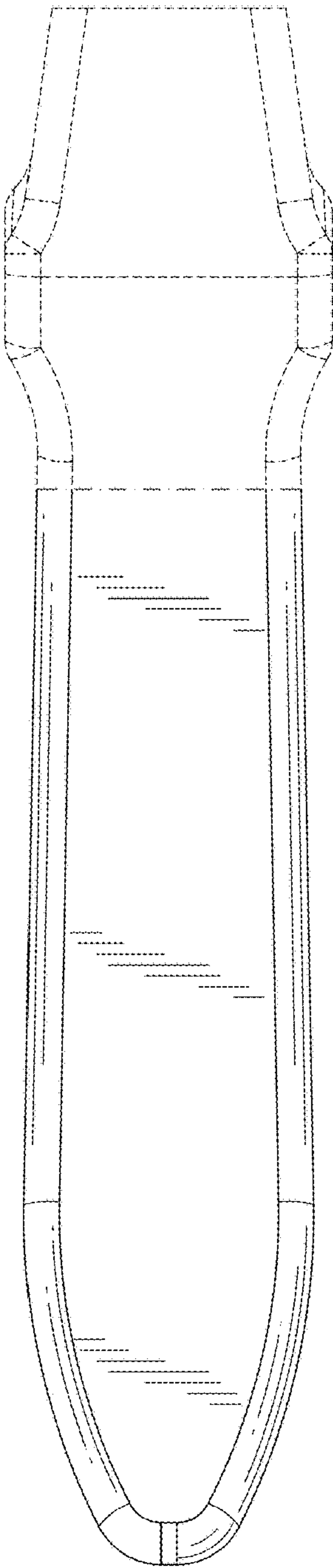

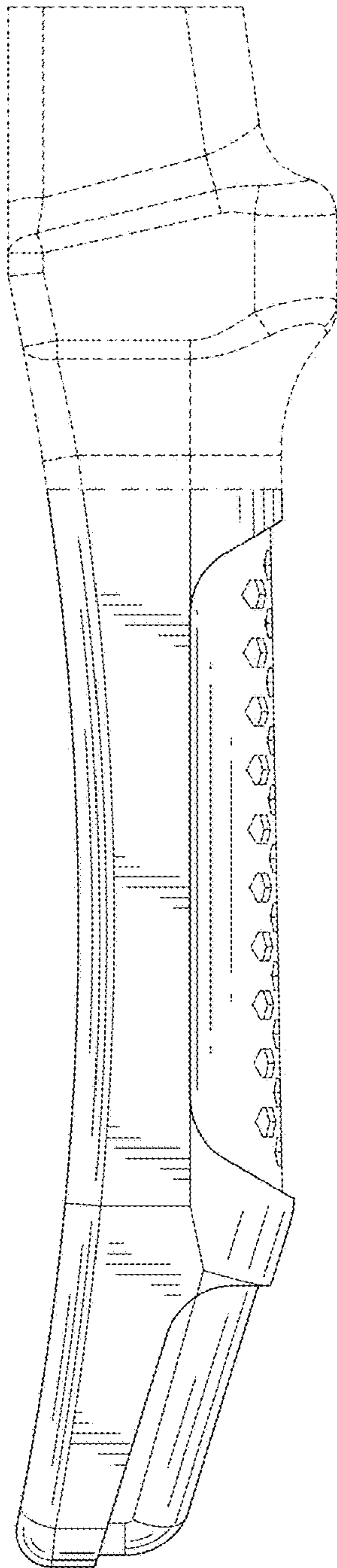

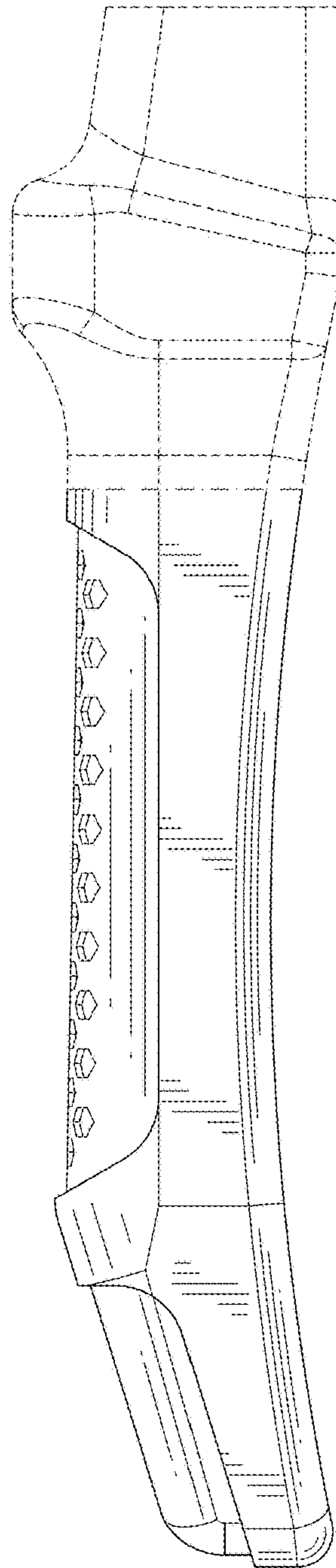

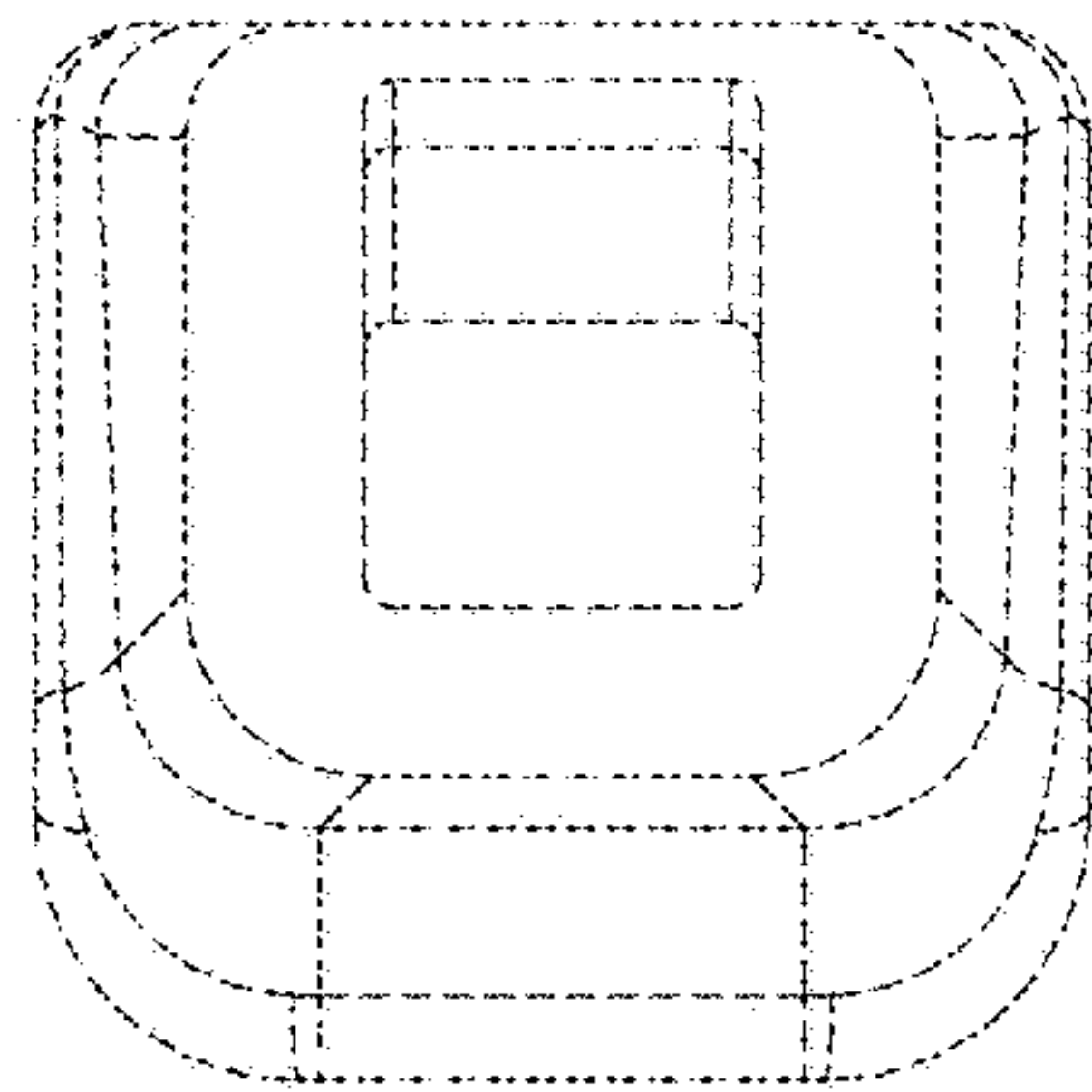

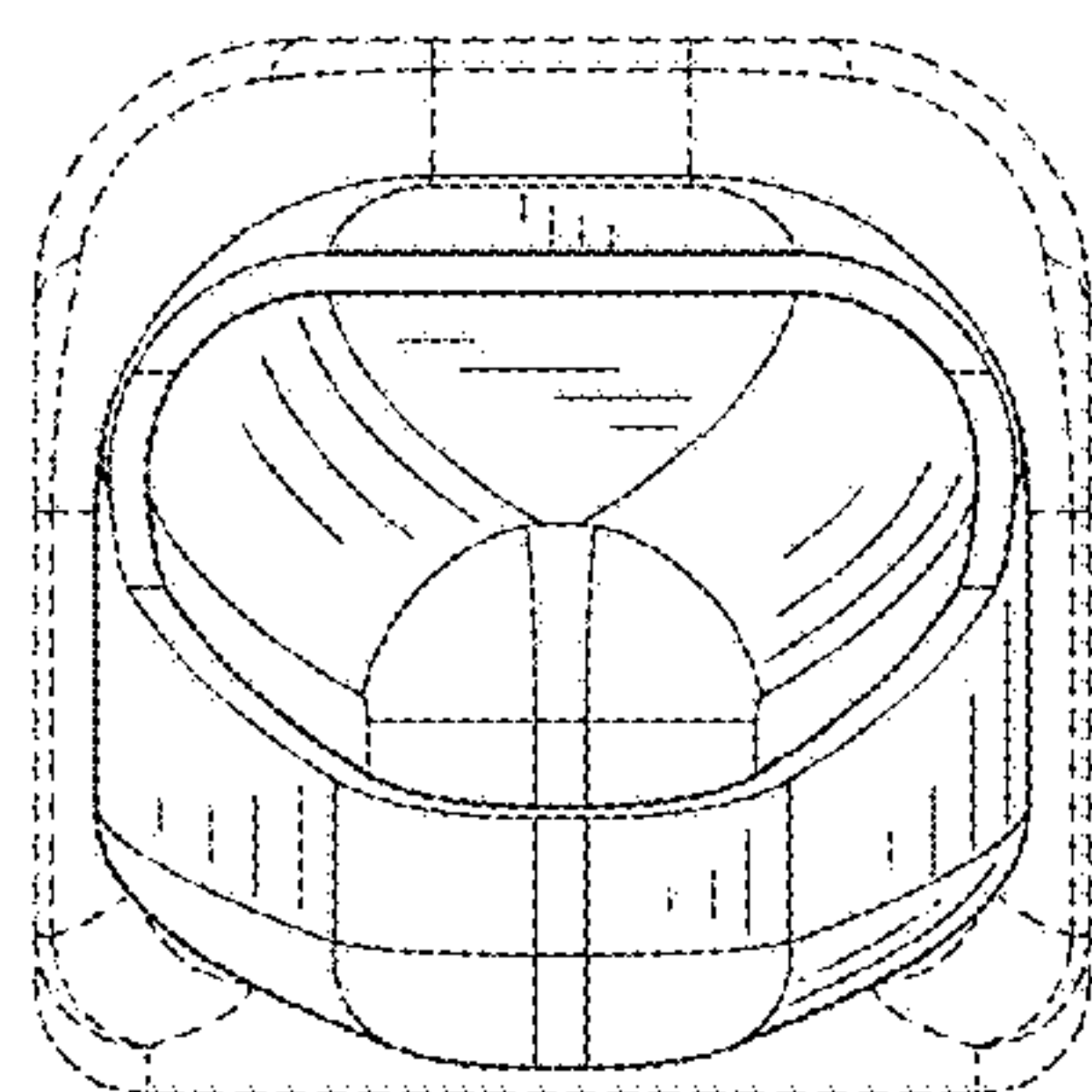

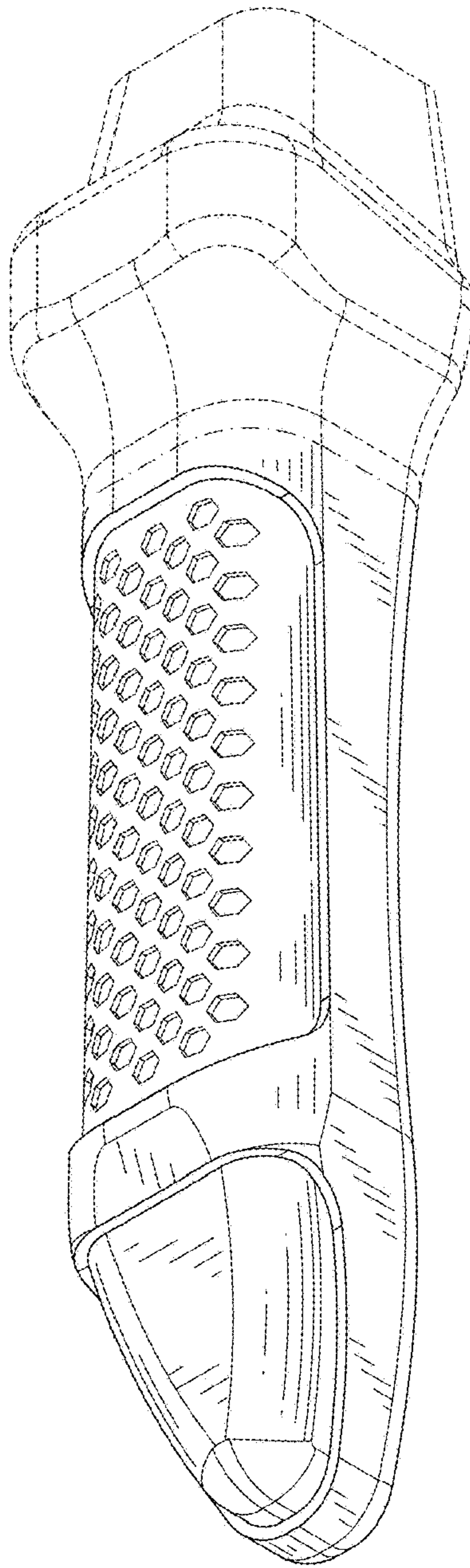

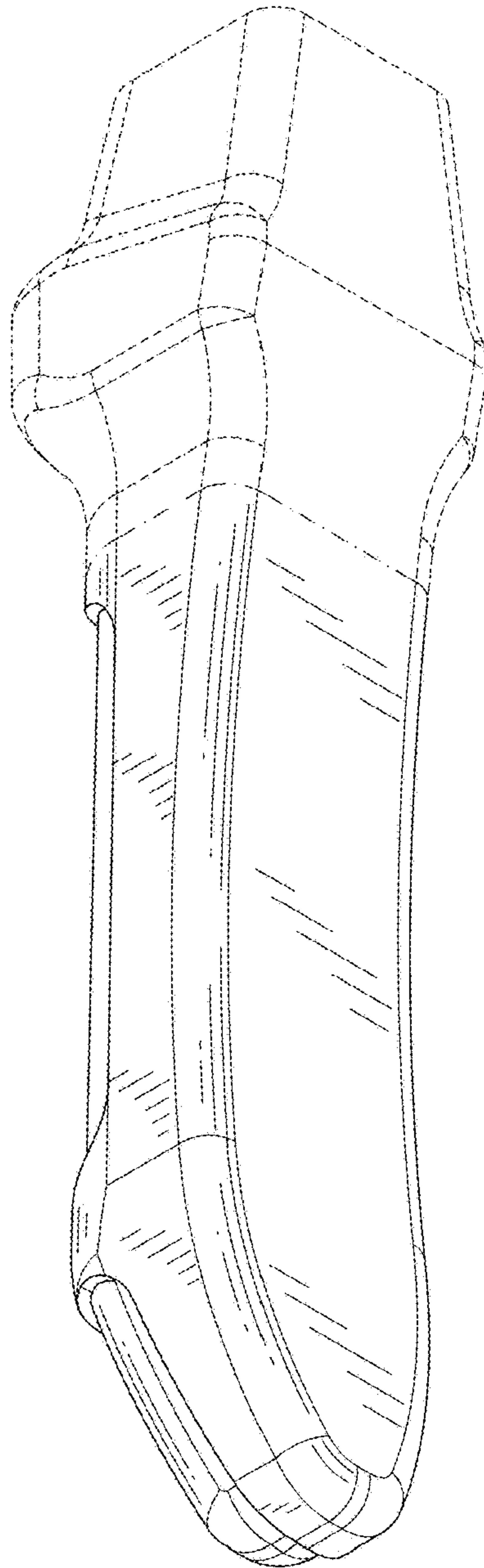
