(57) **CLAIM**

The ornamental design for a watch body, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a watch body, depicted with a watch band shown in broken lines to indicate that the watch band forms no part of the claimed design;

FIG. 2 is a front elevation view of the watch body shown in FIG. 1;

FIG. 3 is a rear elevation view of the watch body of FIG. 1;

FIG. 4 is a right side elevation view of the watch body of FIG. 1;

FIG. 5 is a left side elevation view of the watch body of FIG. 1;

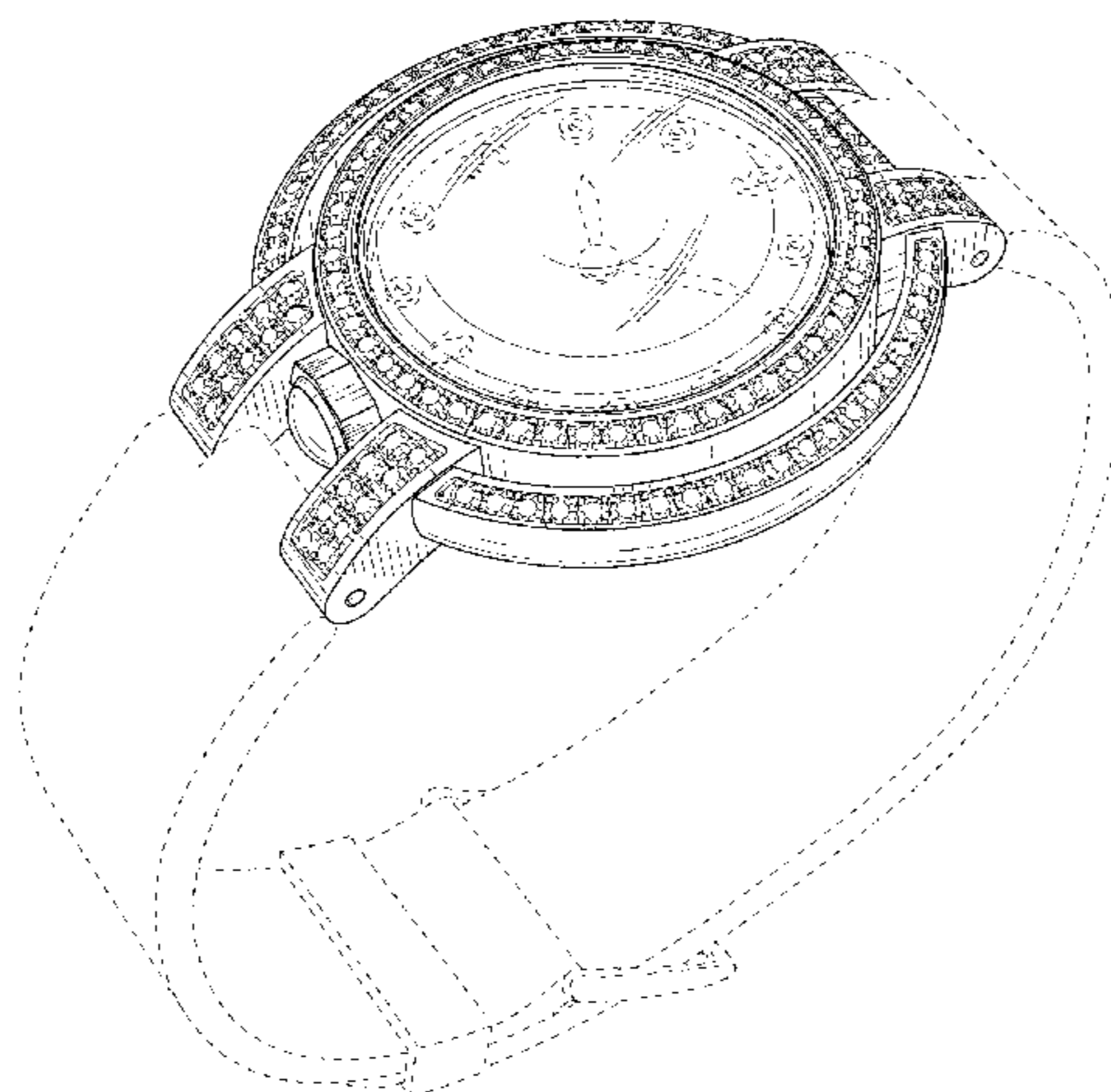
FIG. 6 is a top plan view of the watch body of FIG. 1;

FIG. 7 is a bottom plan view of the watch body of FIG. 1; and,

FIG. 8 is a perspective view of the watch body shown in FIG. 1, depicted with another watch band shown in broken lines to indicate that the watch band forms no part of the claimed design.

The broken lines shown in FIGS. 1, 2, and 3 illustrate environmental structure only and do not form part of the claimed design.

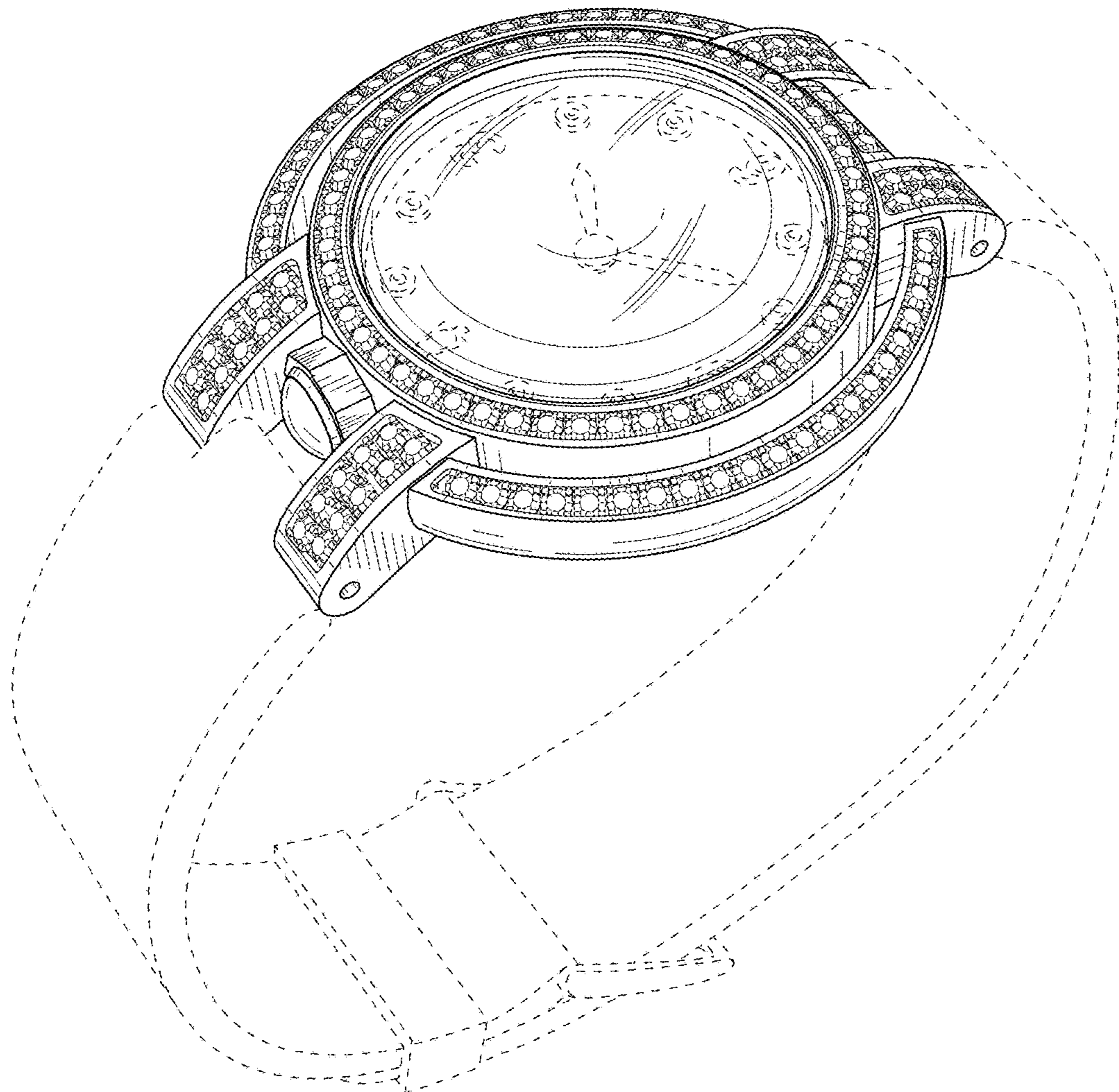

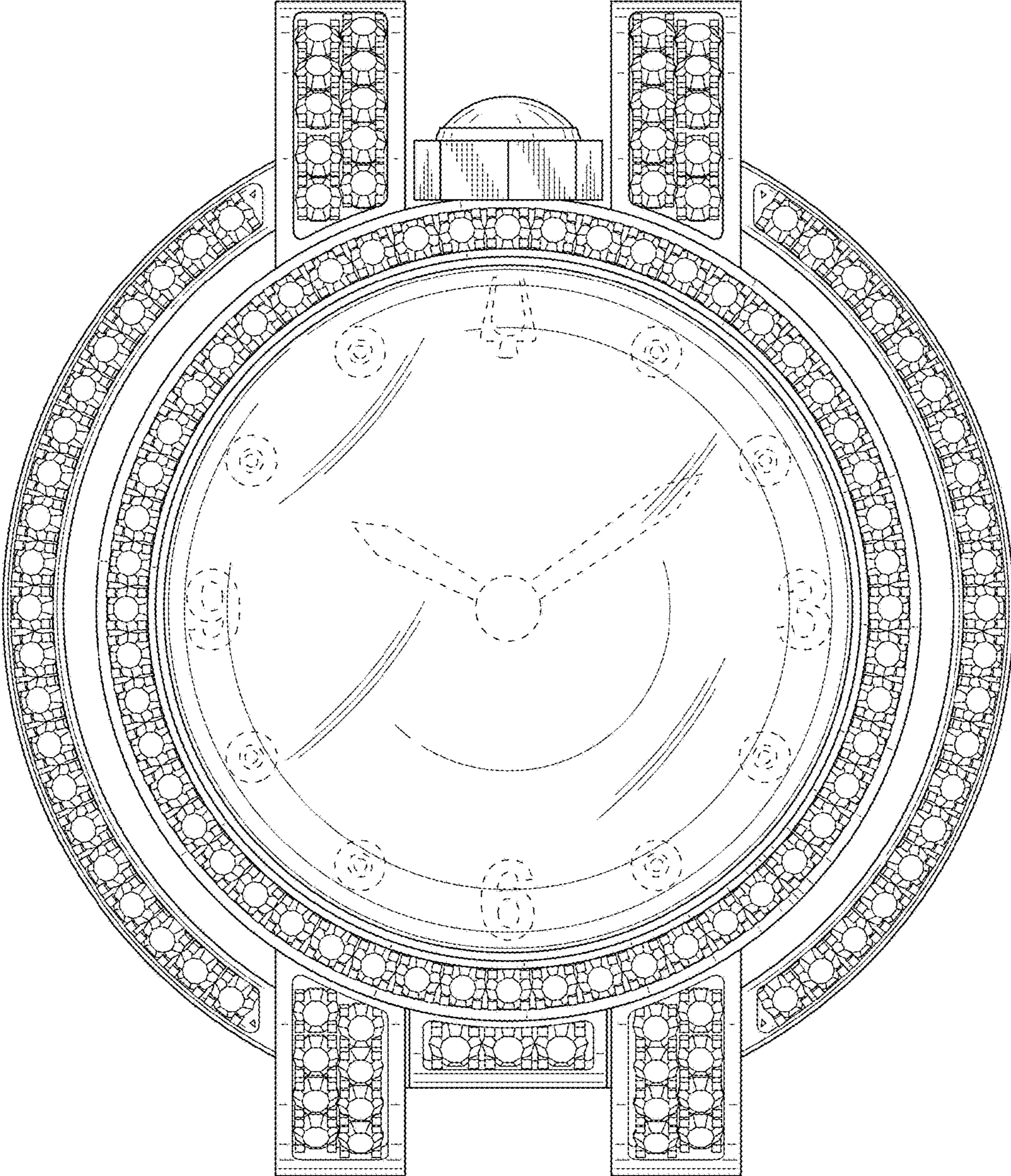

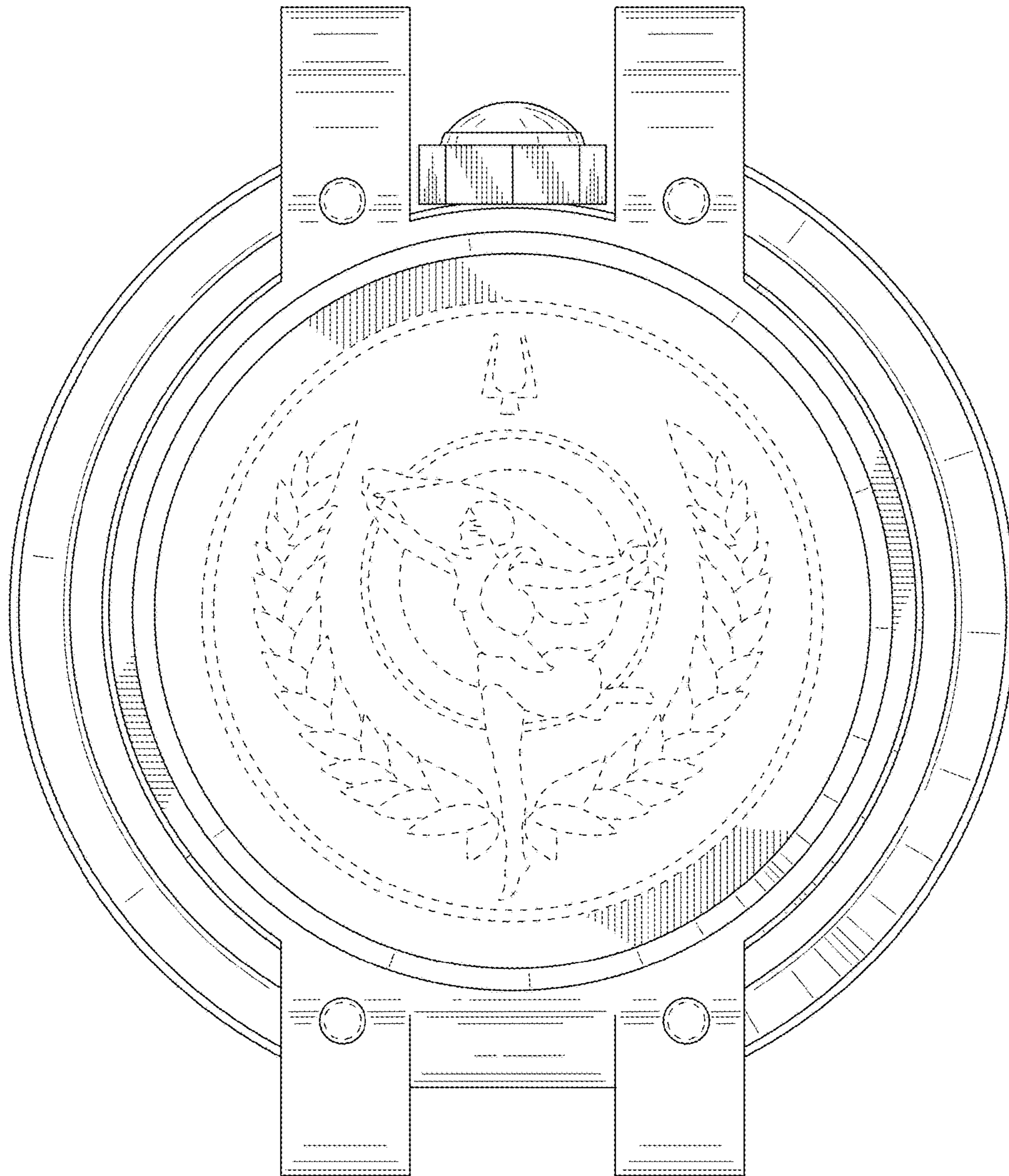

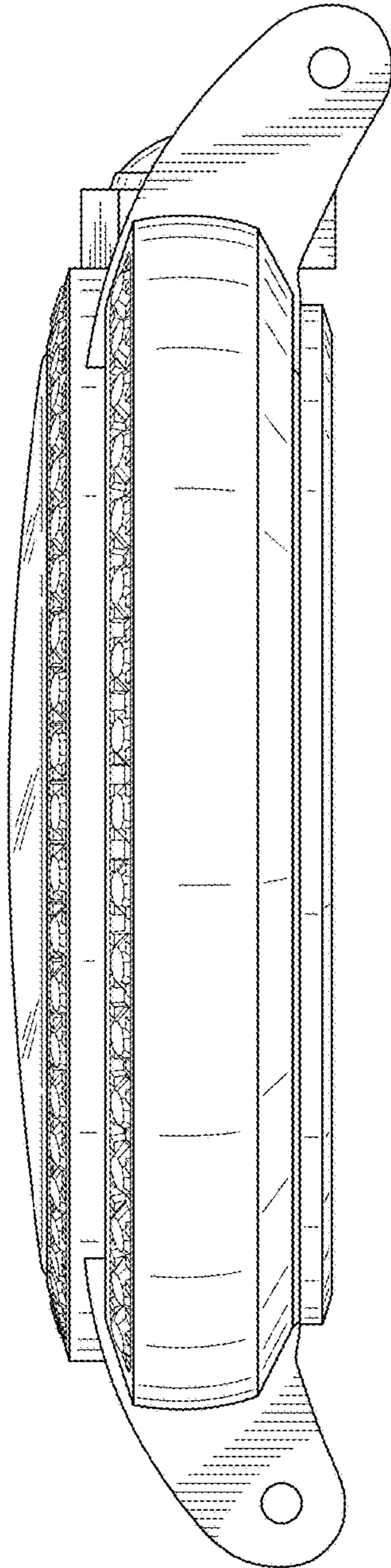

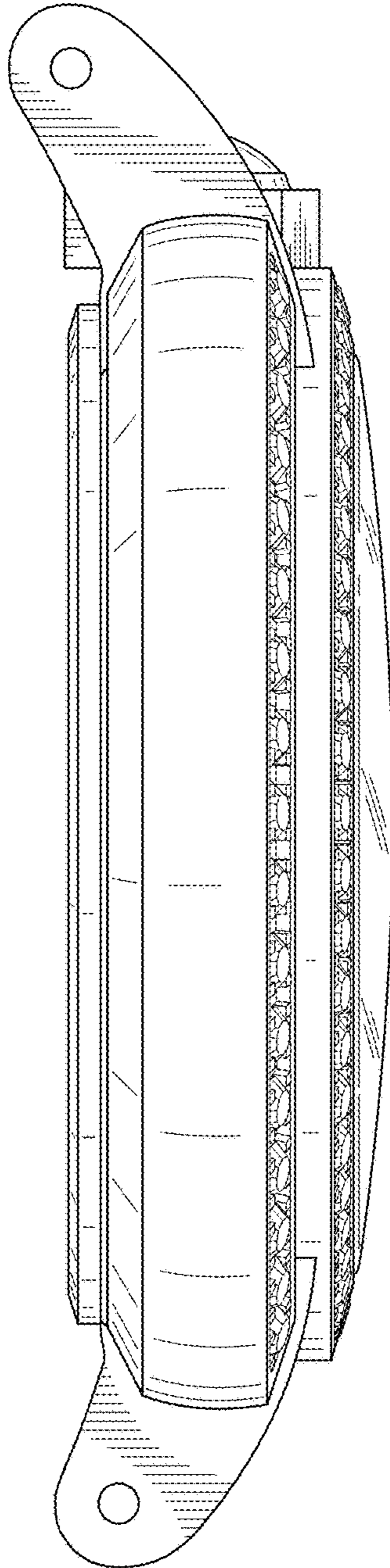

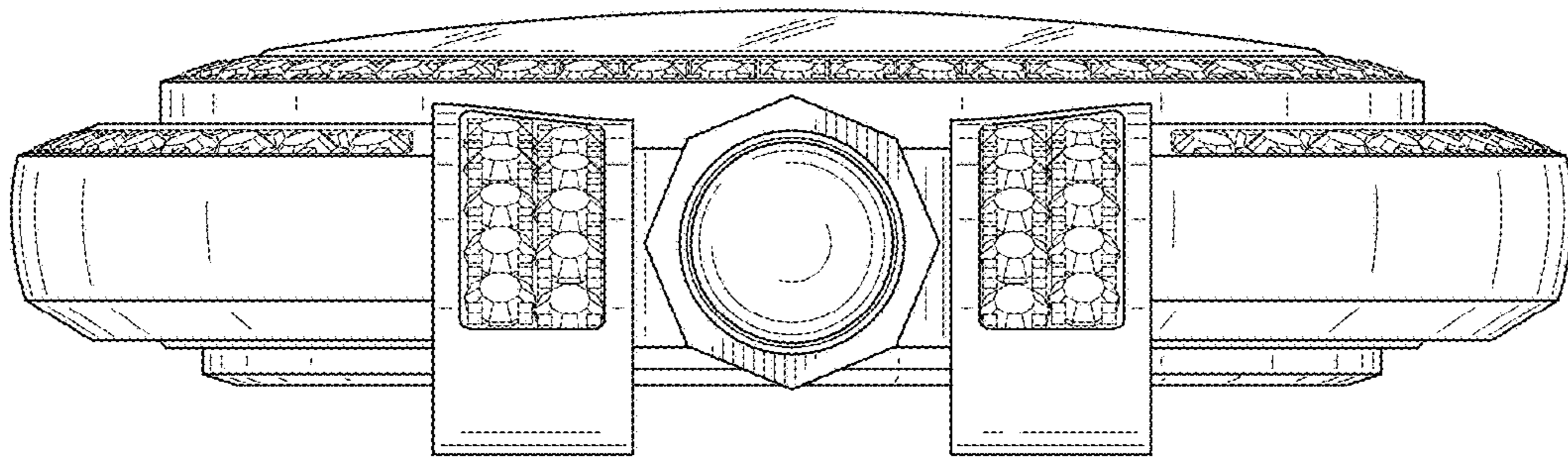

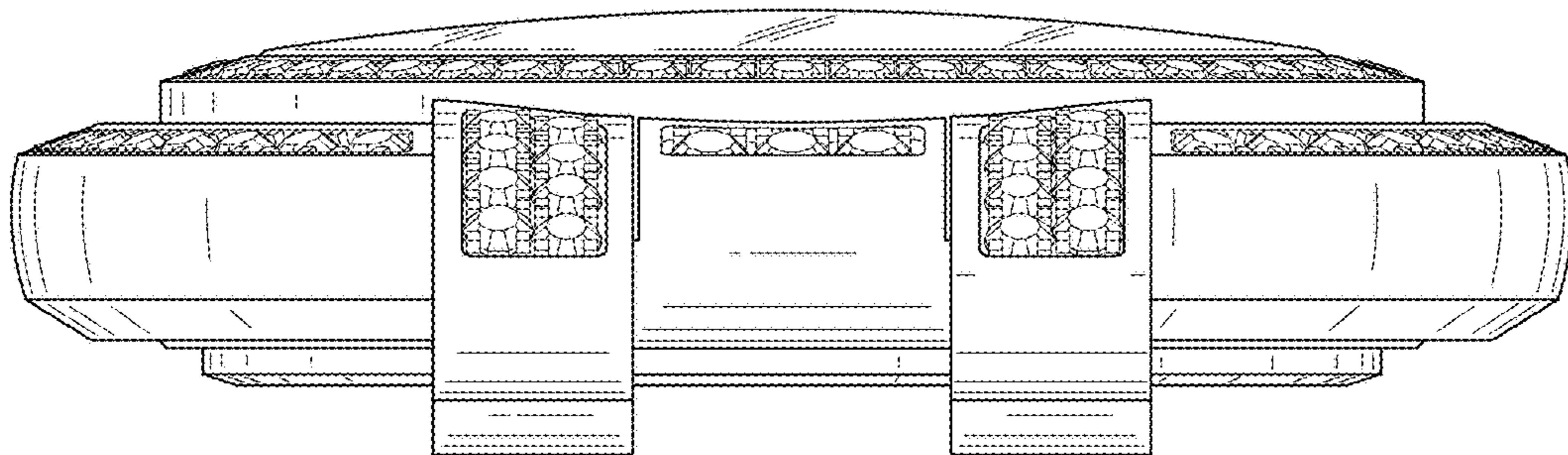

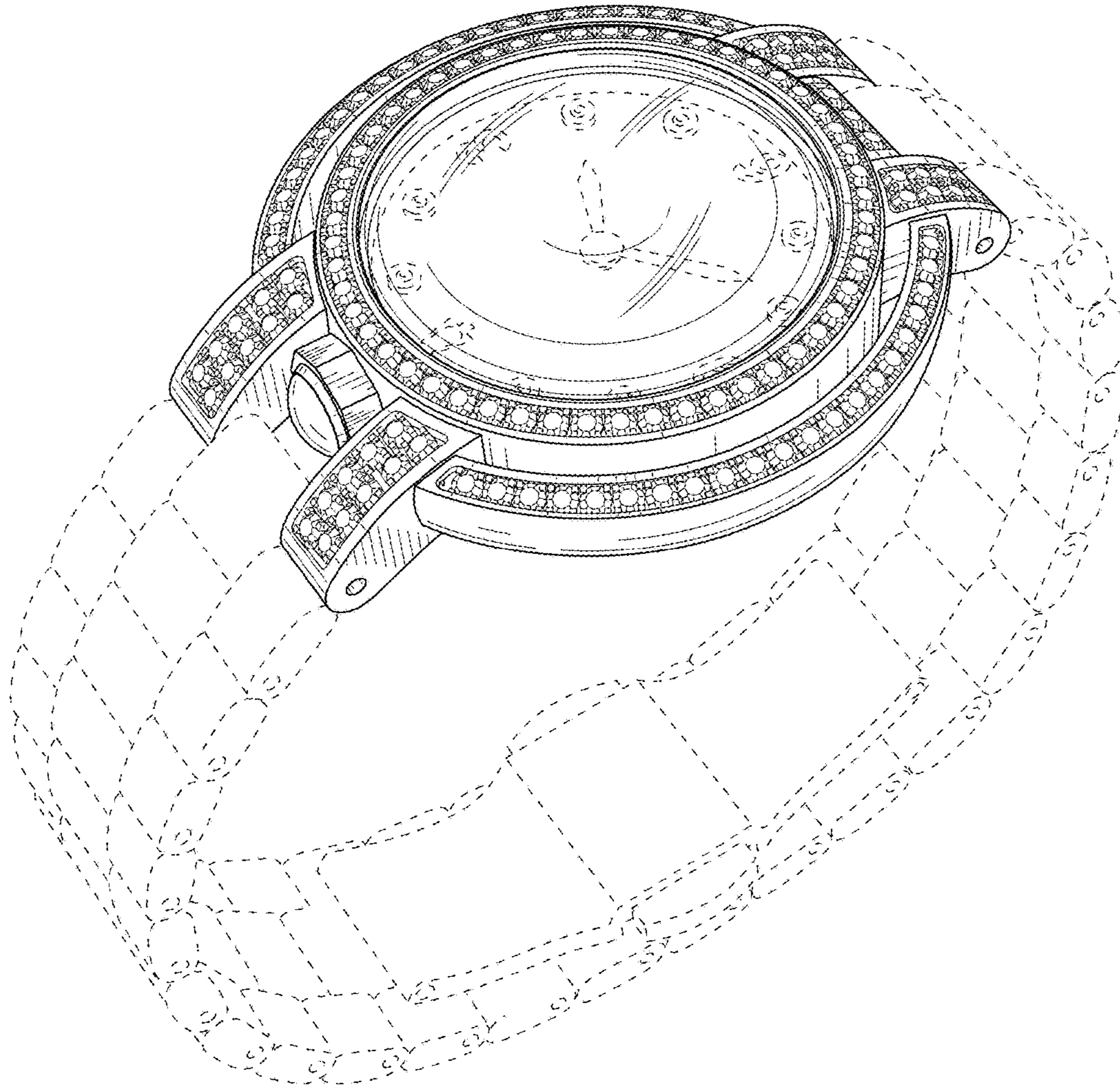
