The ornamental design for a vehicle front lower valance, as shown and described.

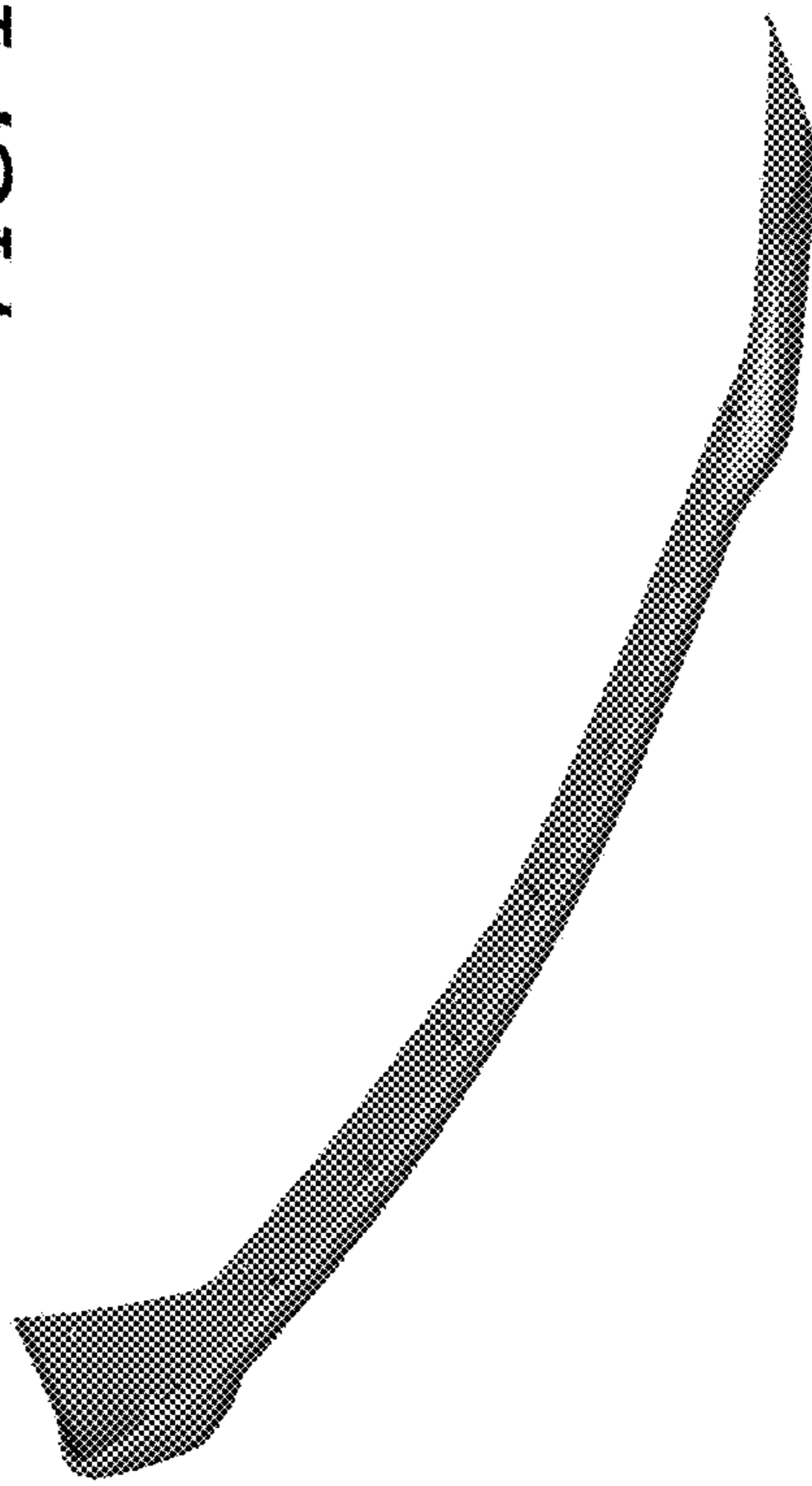
DESCRIPTION

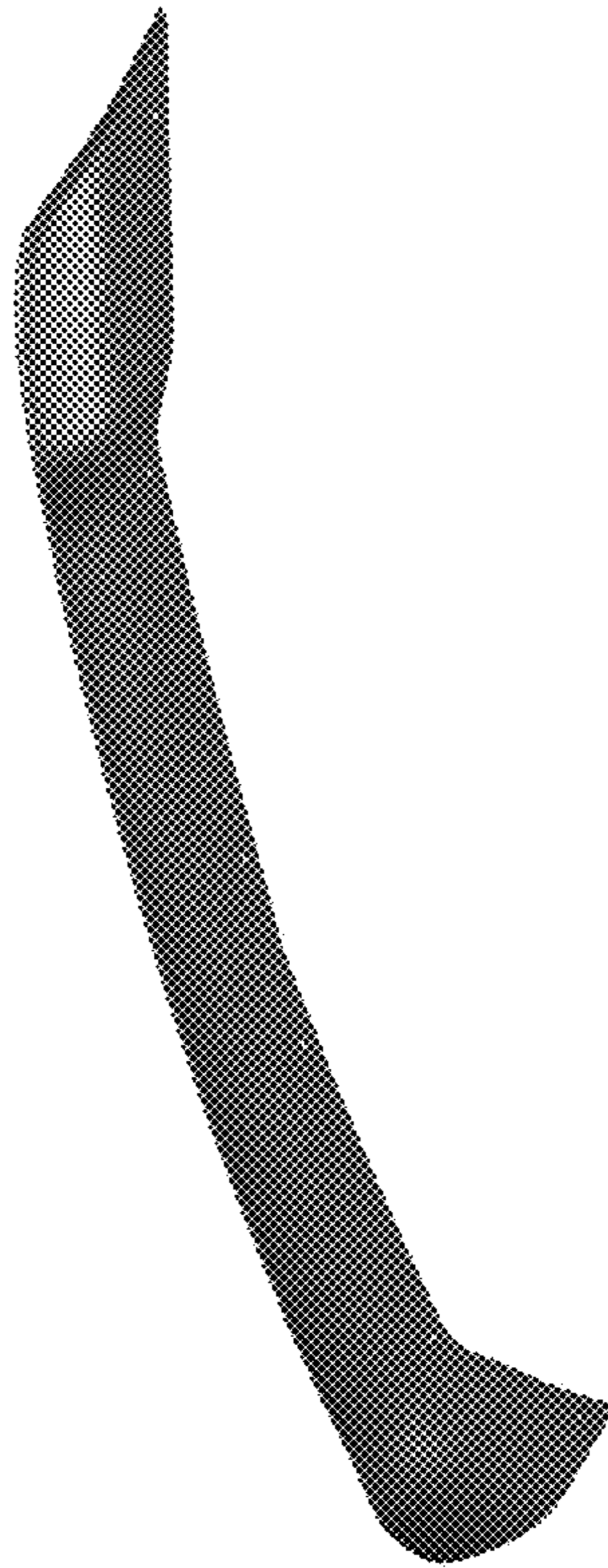

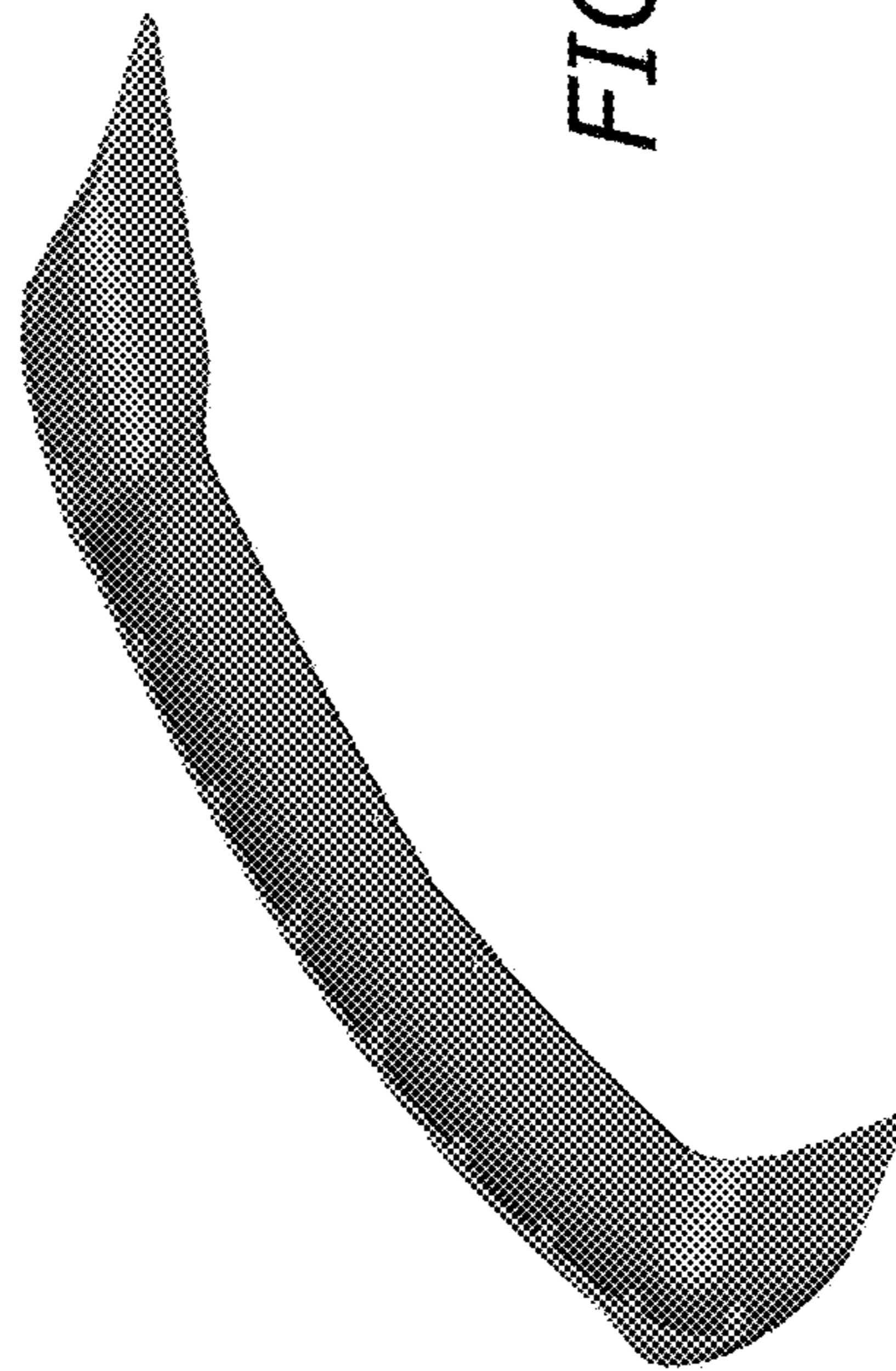

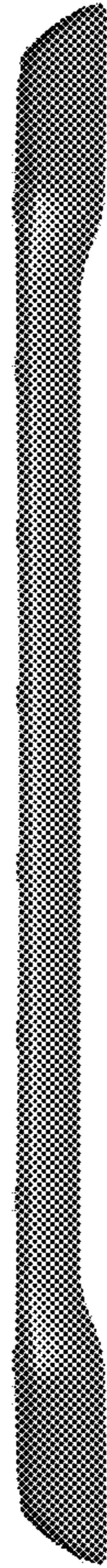

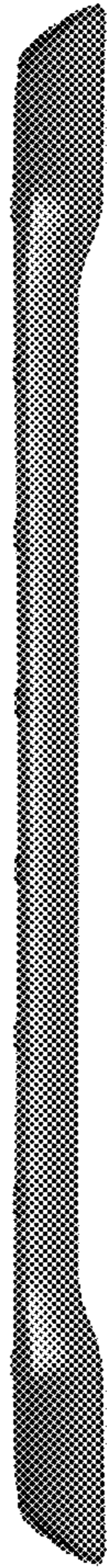

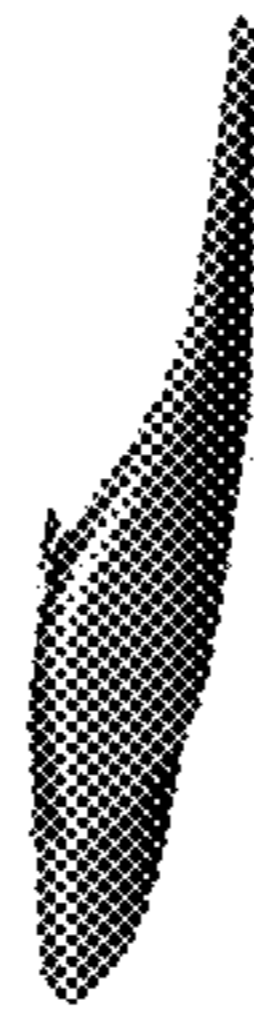

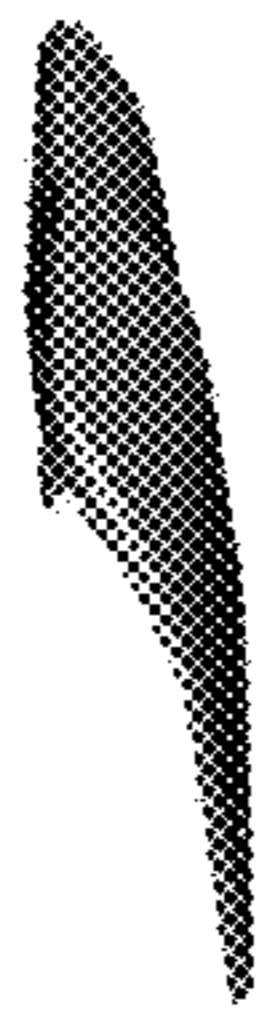

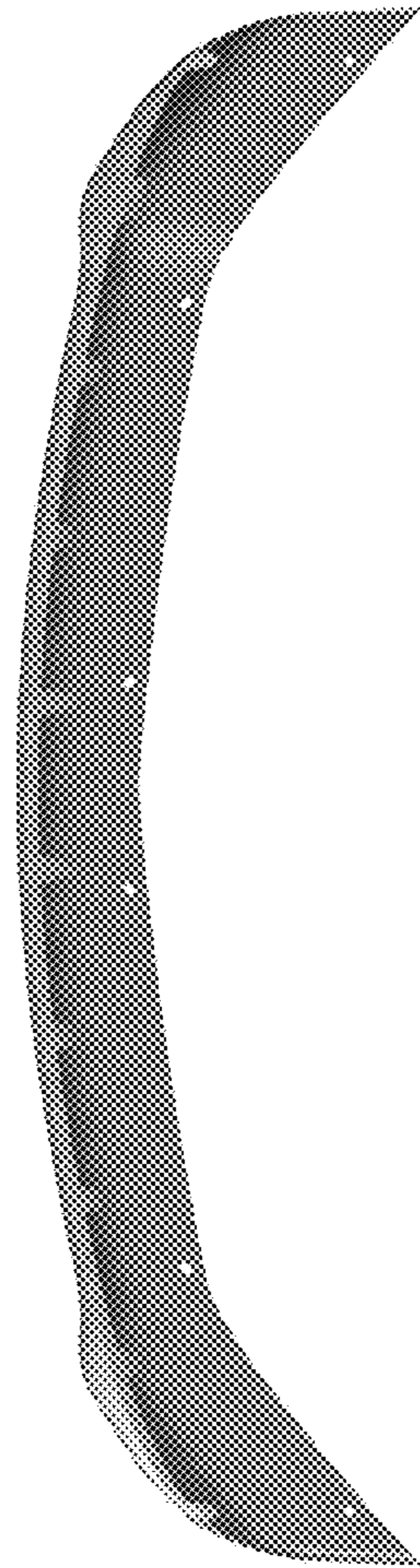

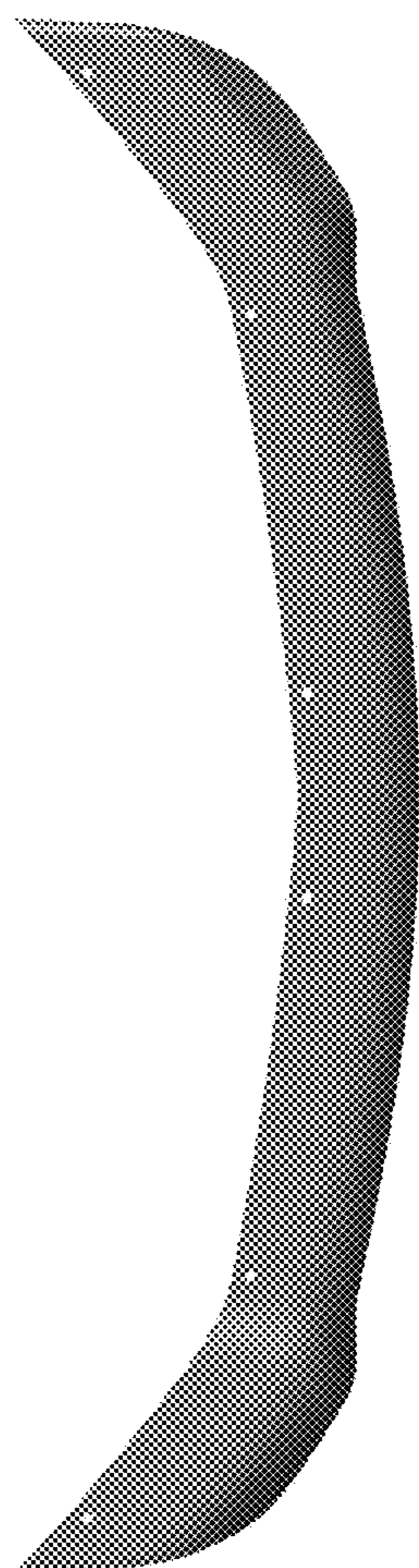
