DESCRIPTION

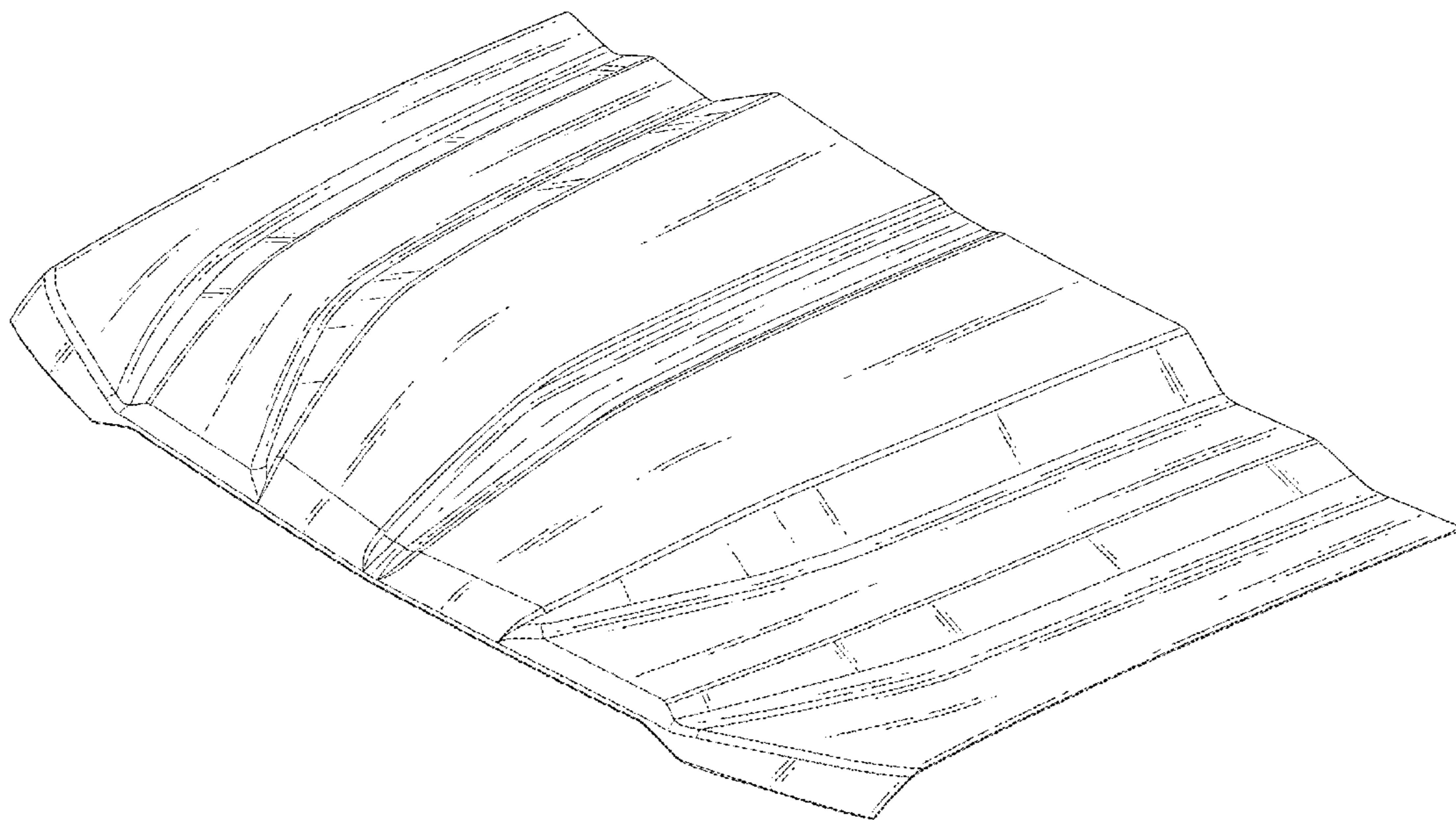
FIG. 1 is a front perspective view of a vehicle hood showing my new design;

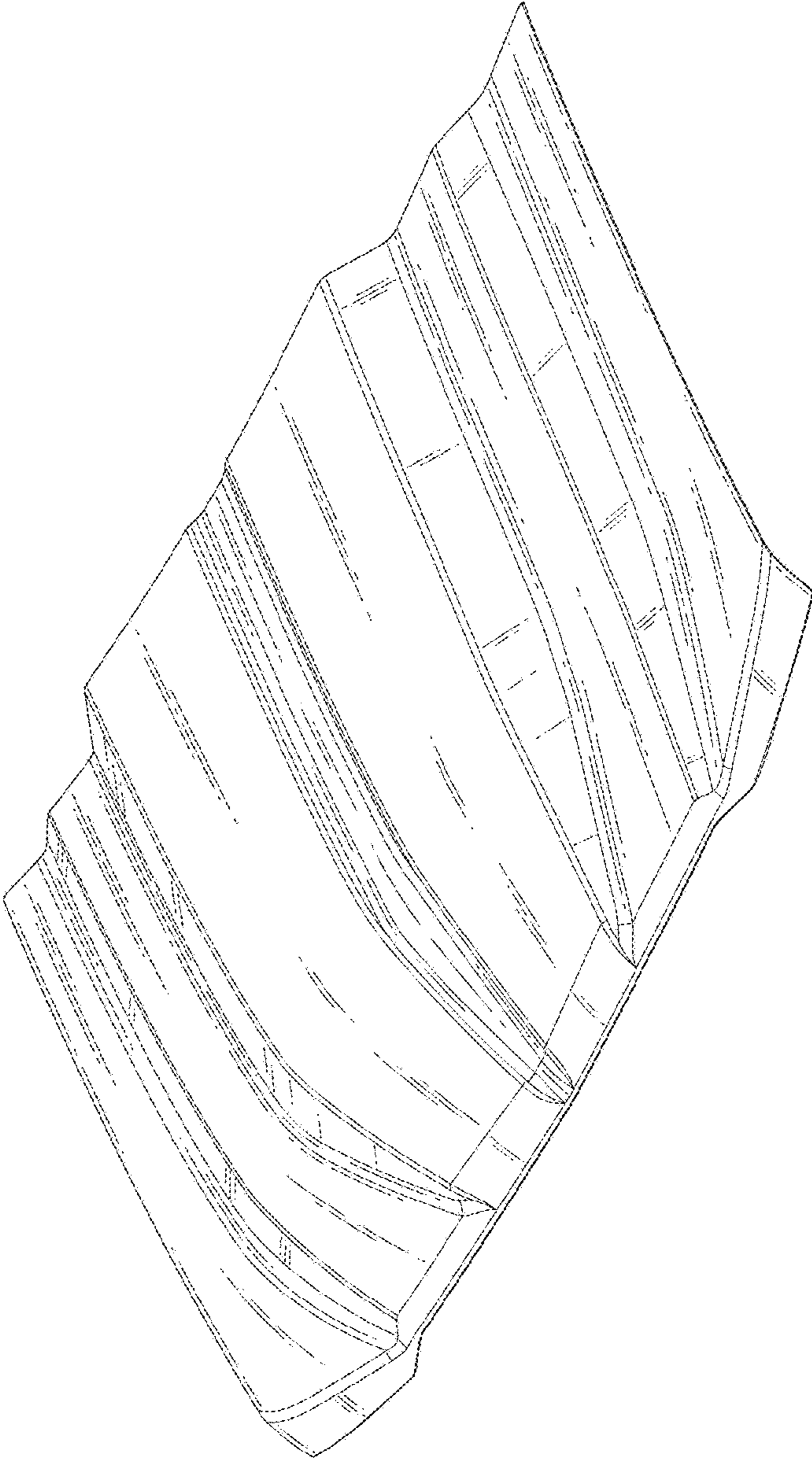

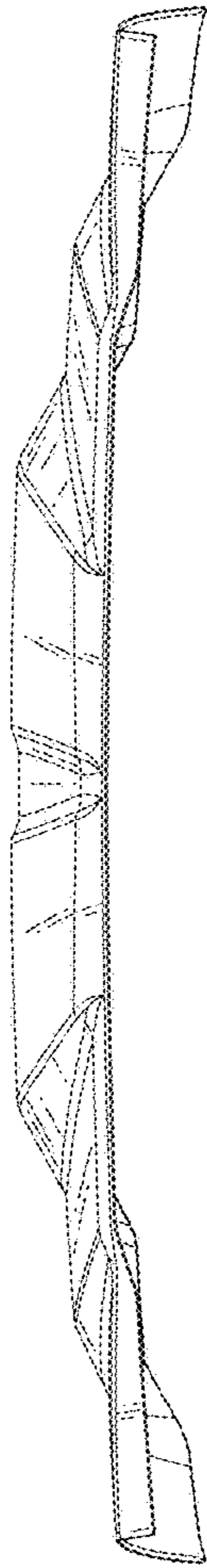

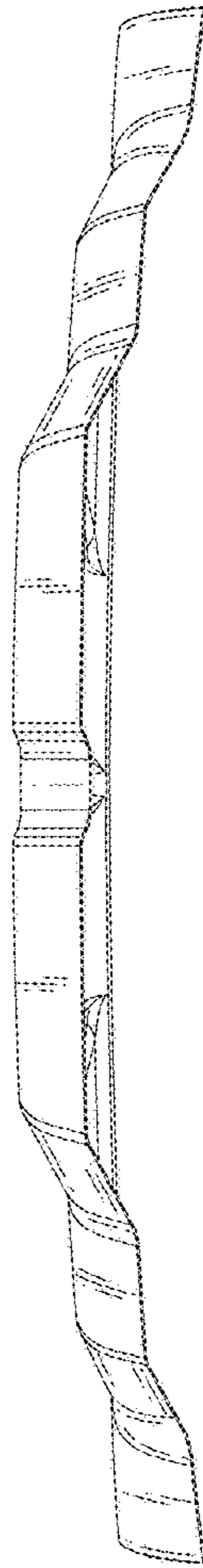

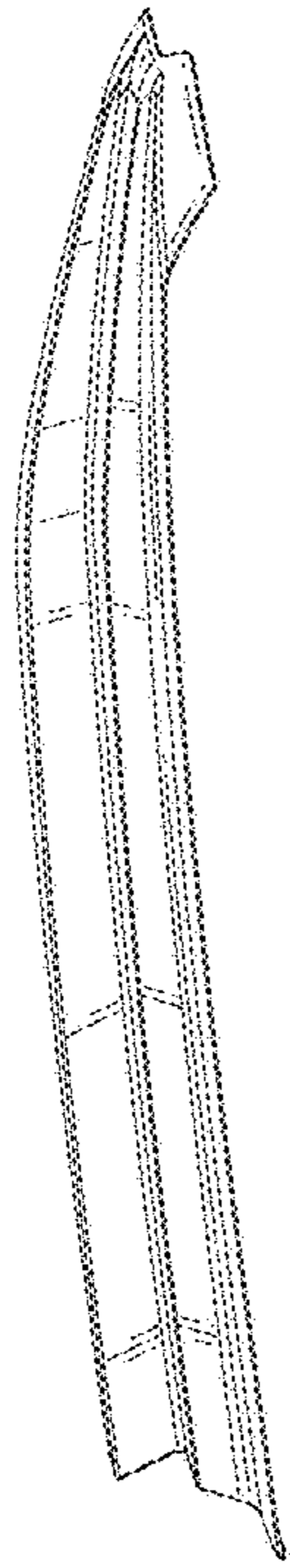

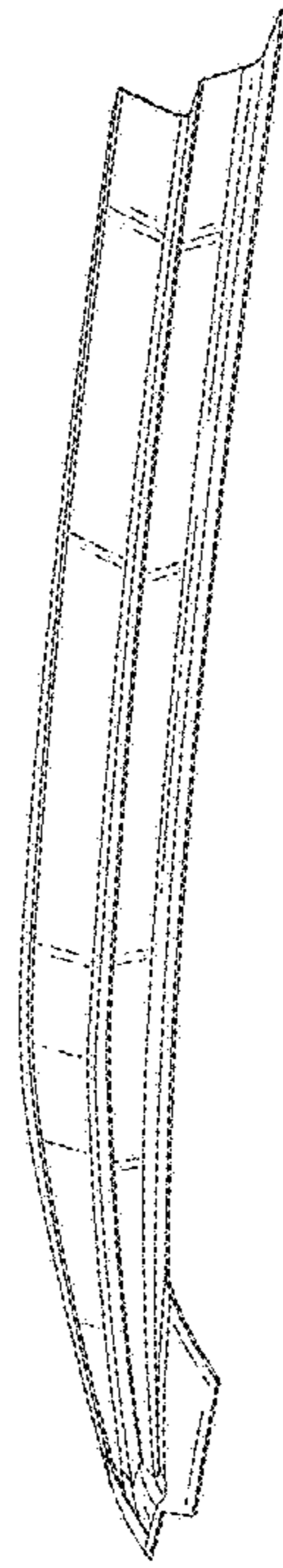

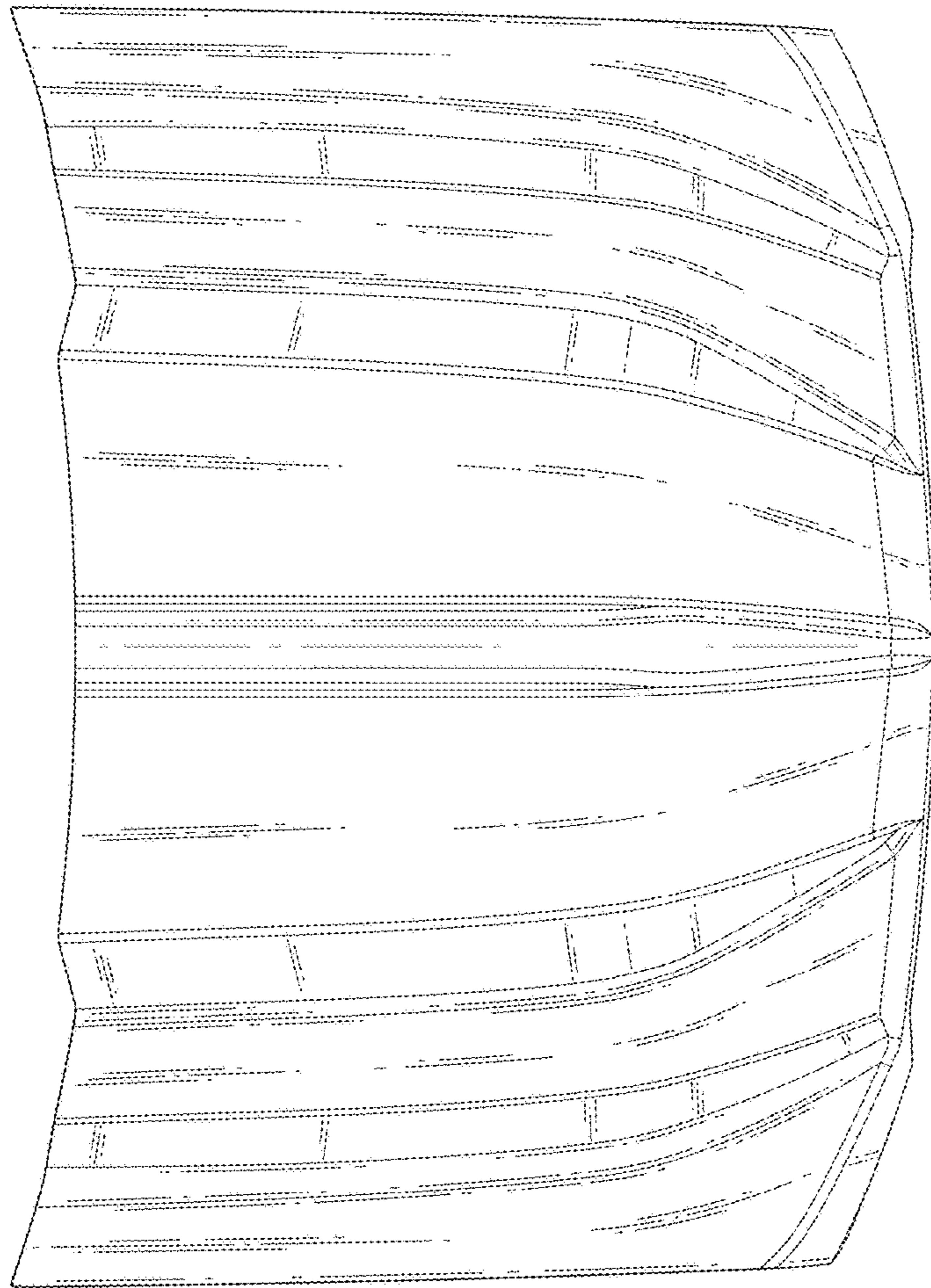

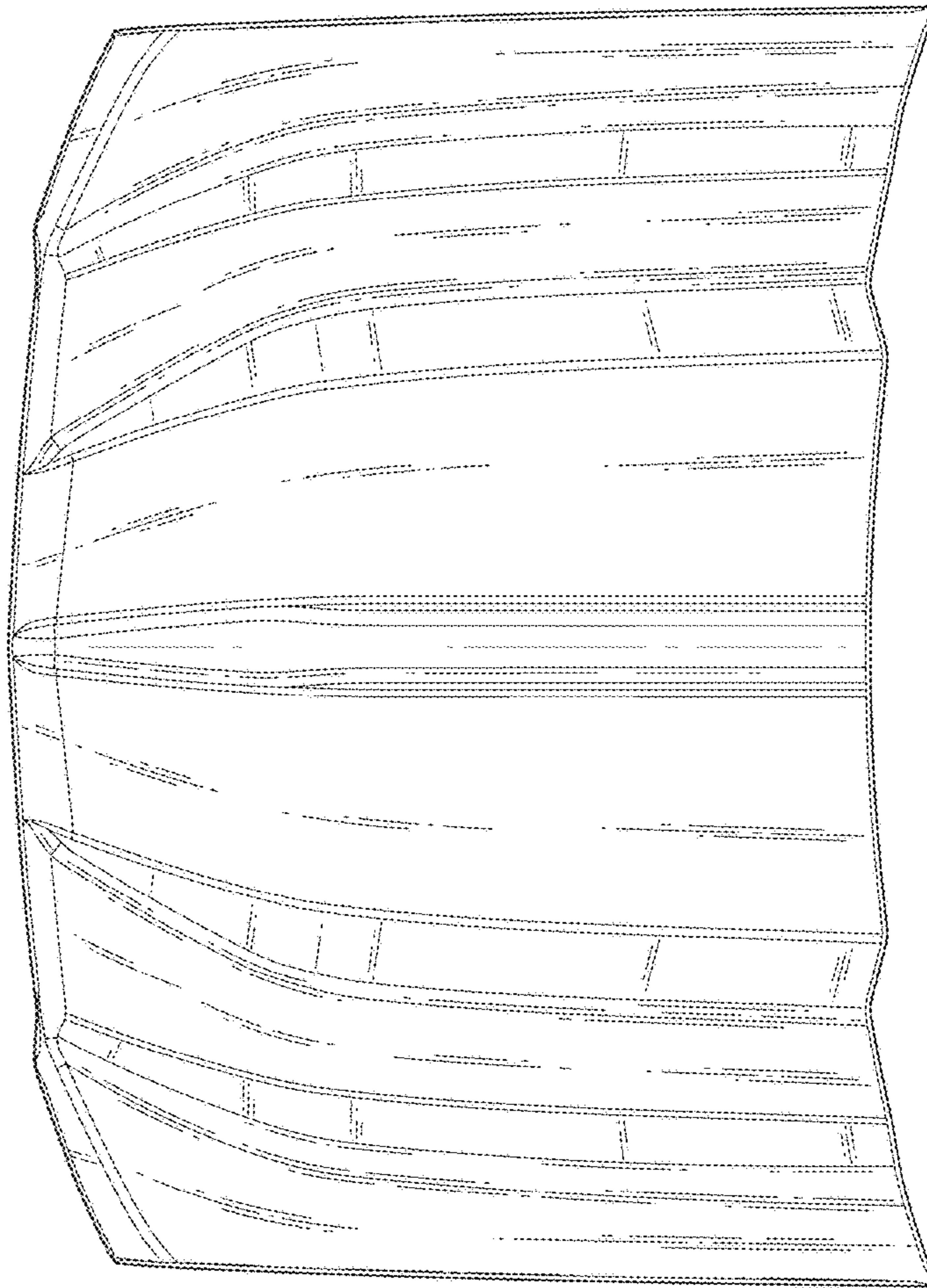
