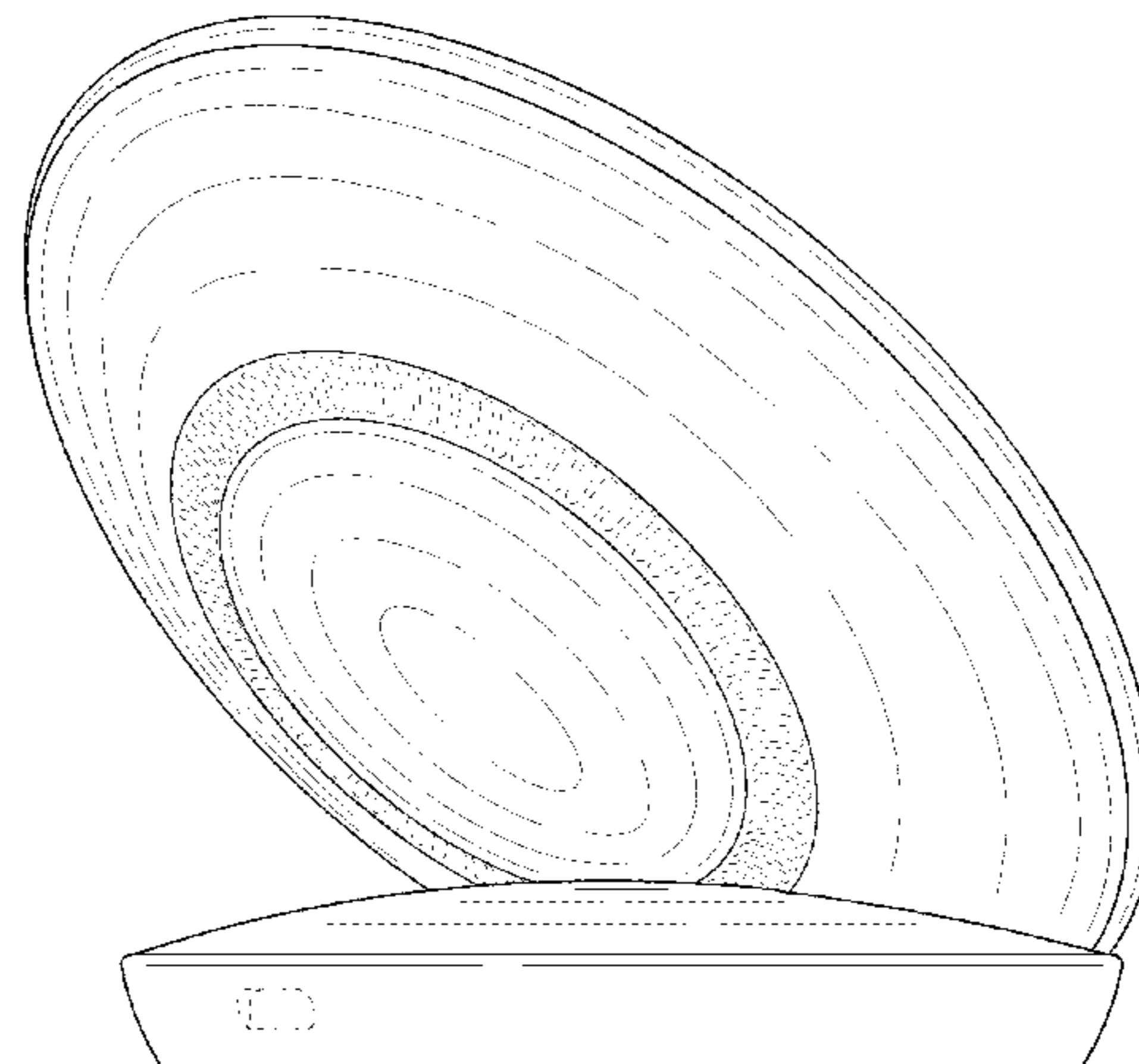
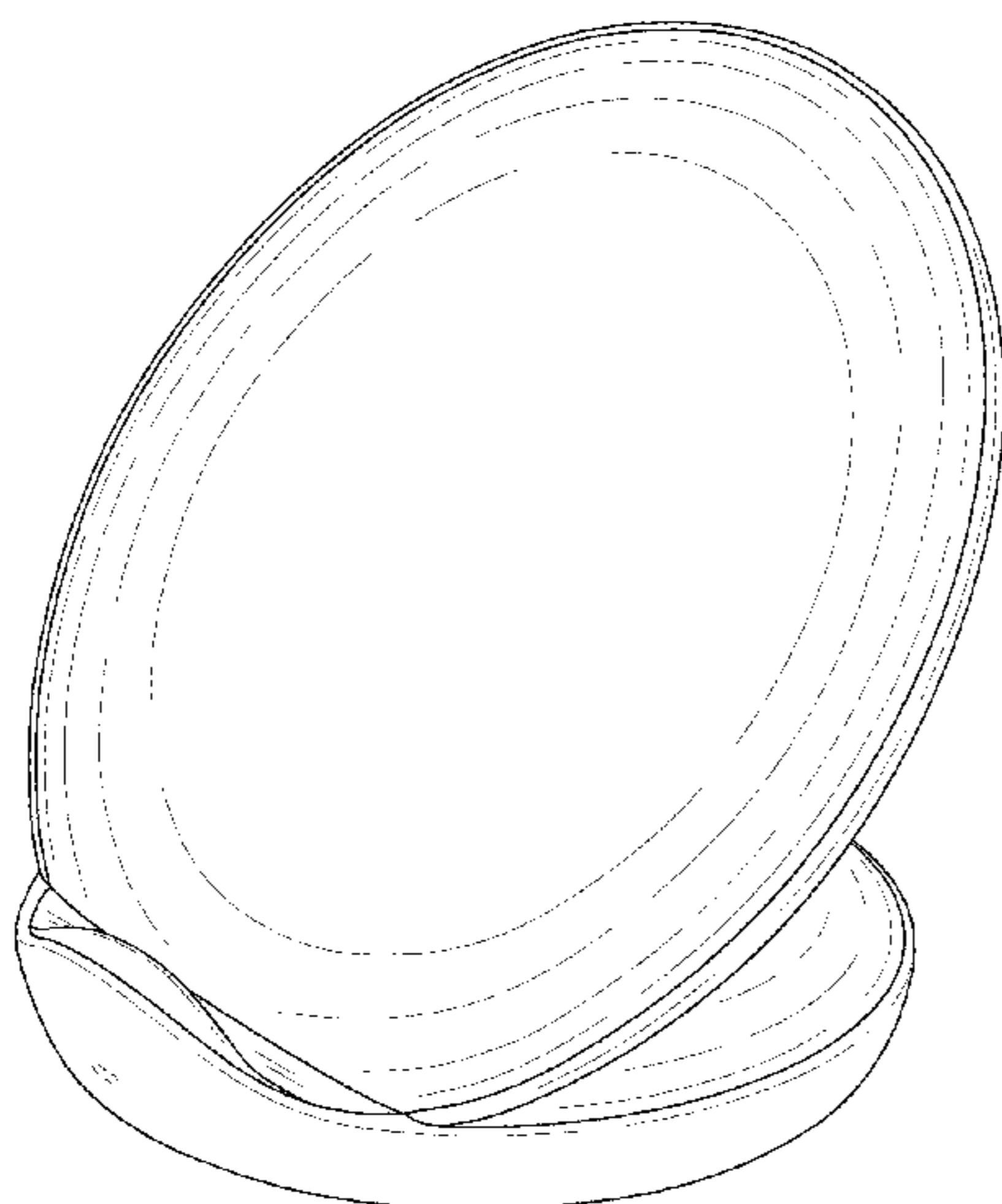
(57) **CLAIM**

The ornamental design for a wireless charger, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a wireless charger showing our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,

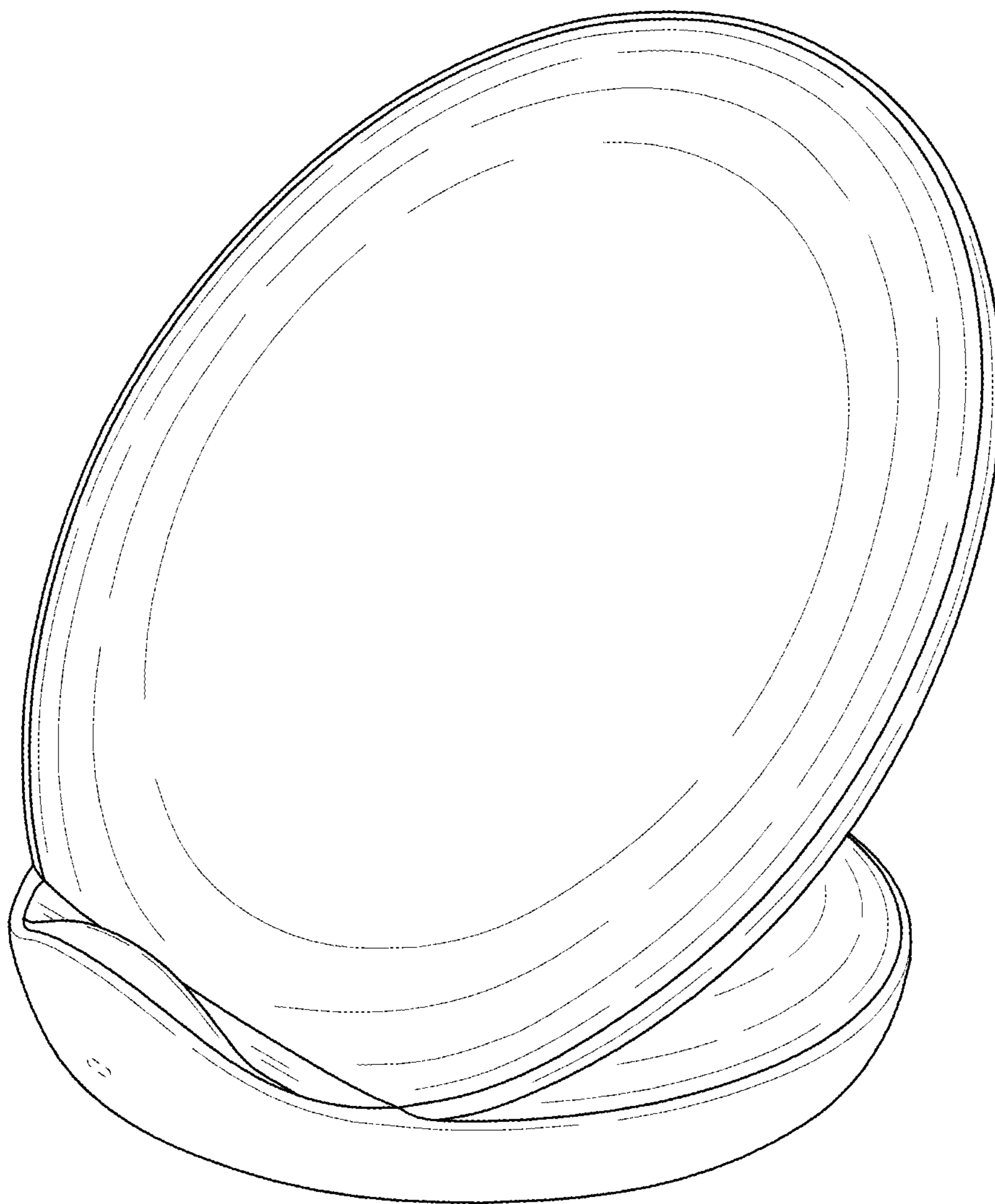

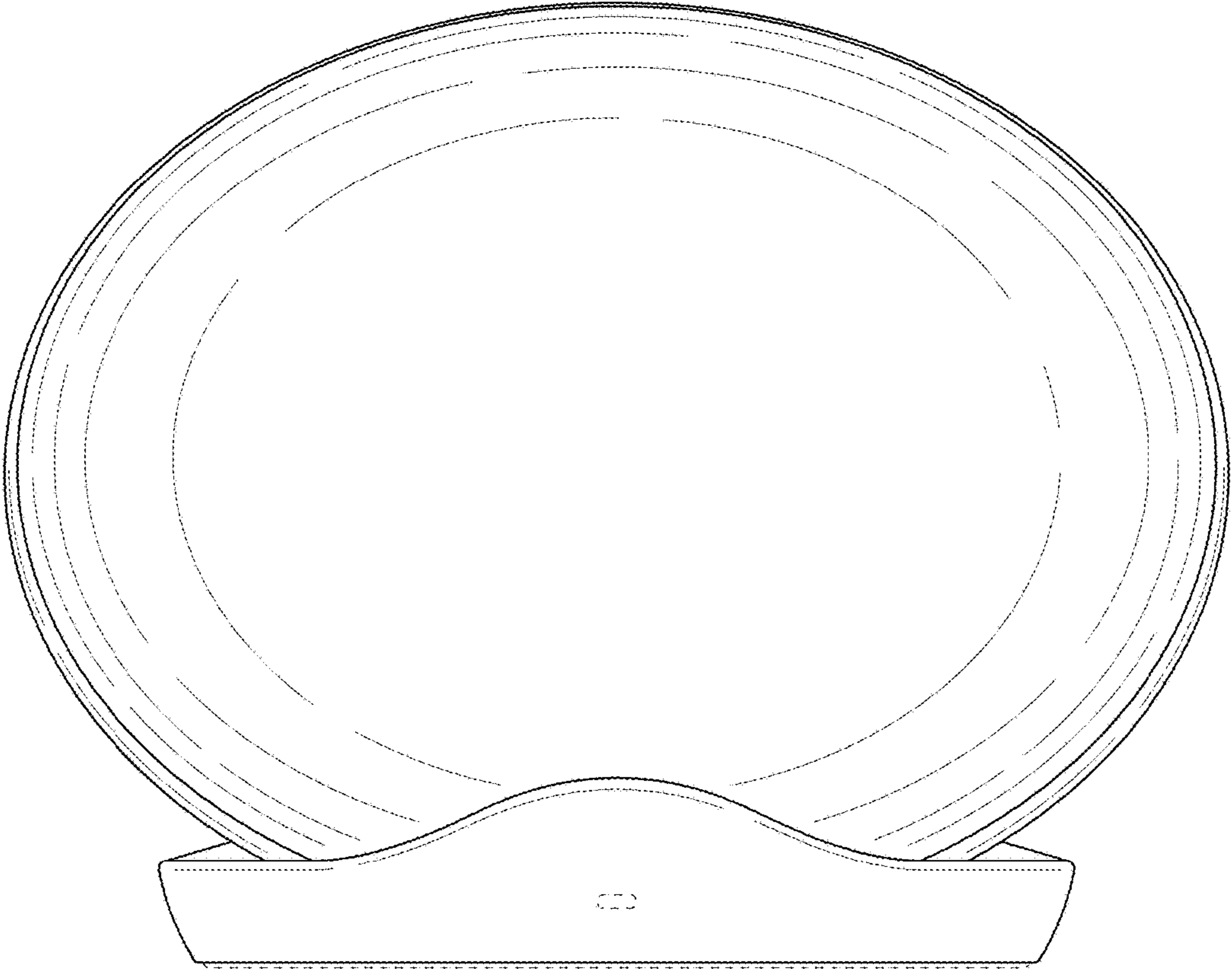

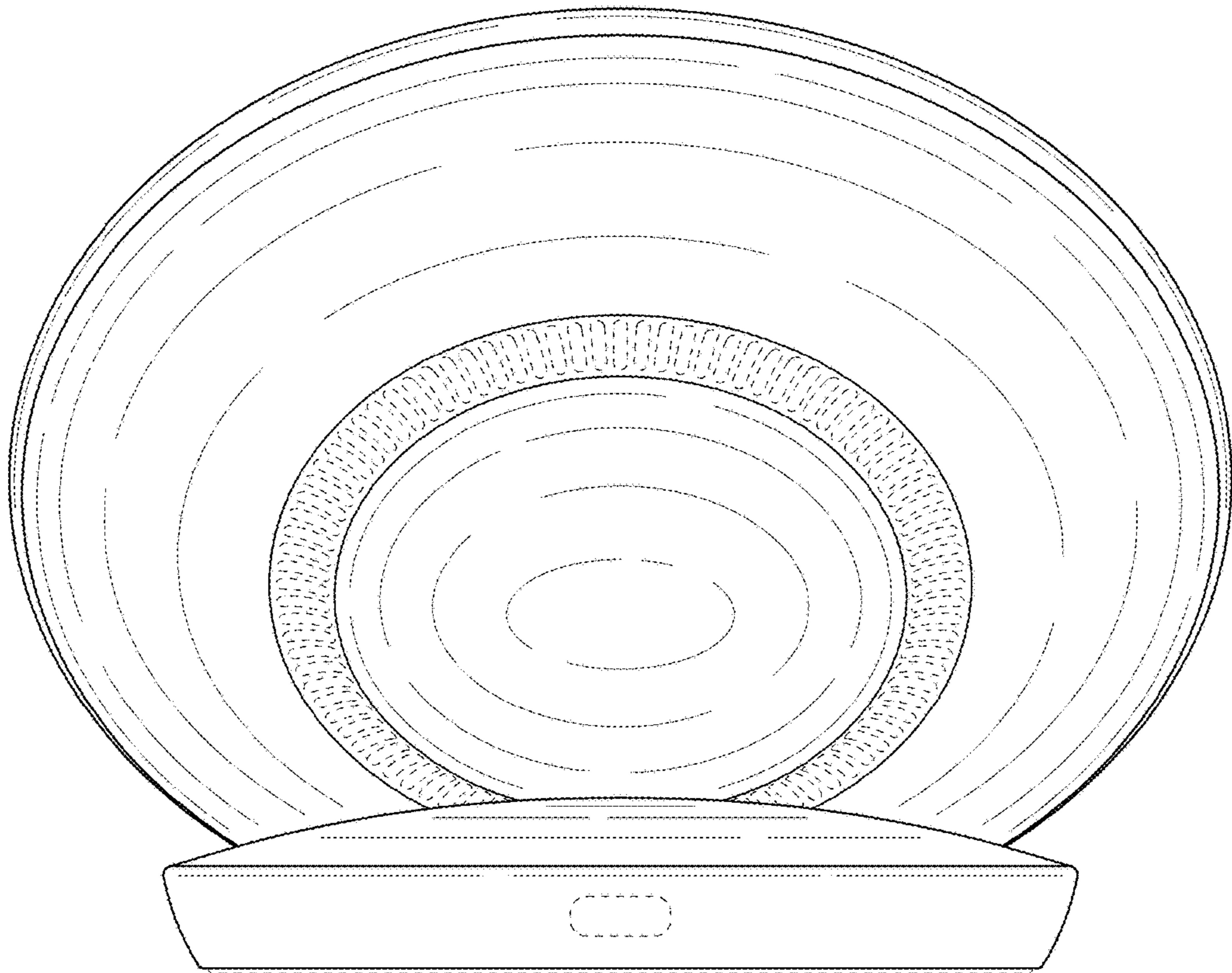

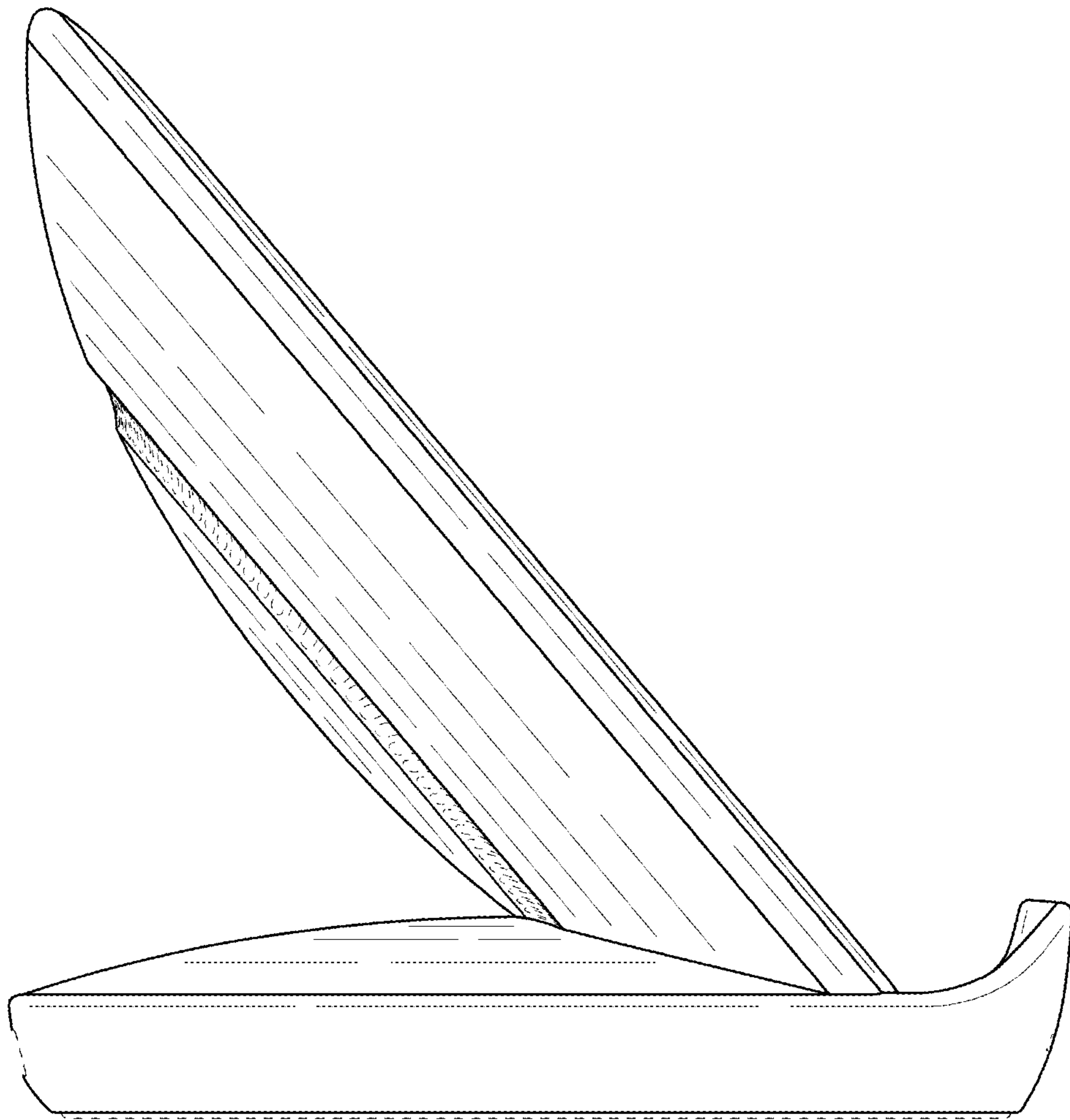

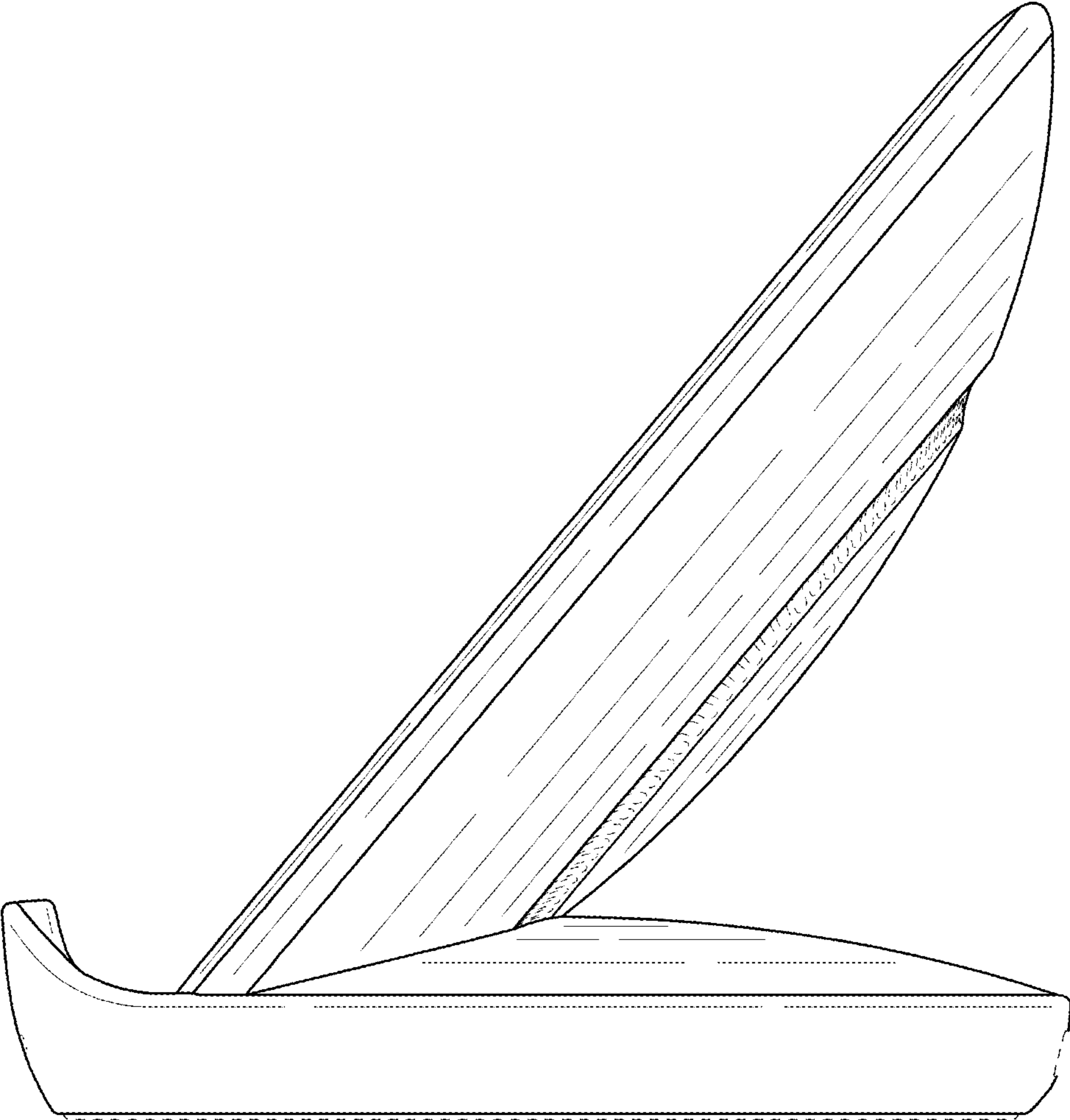

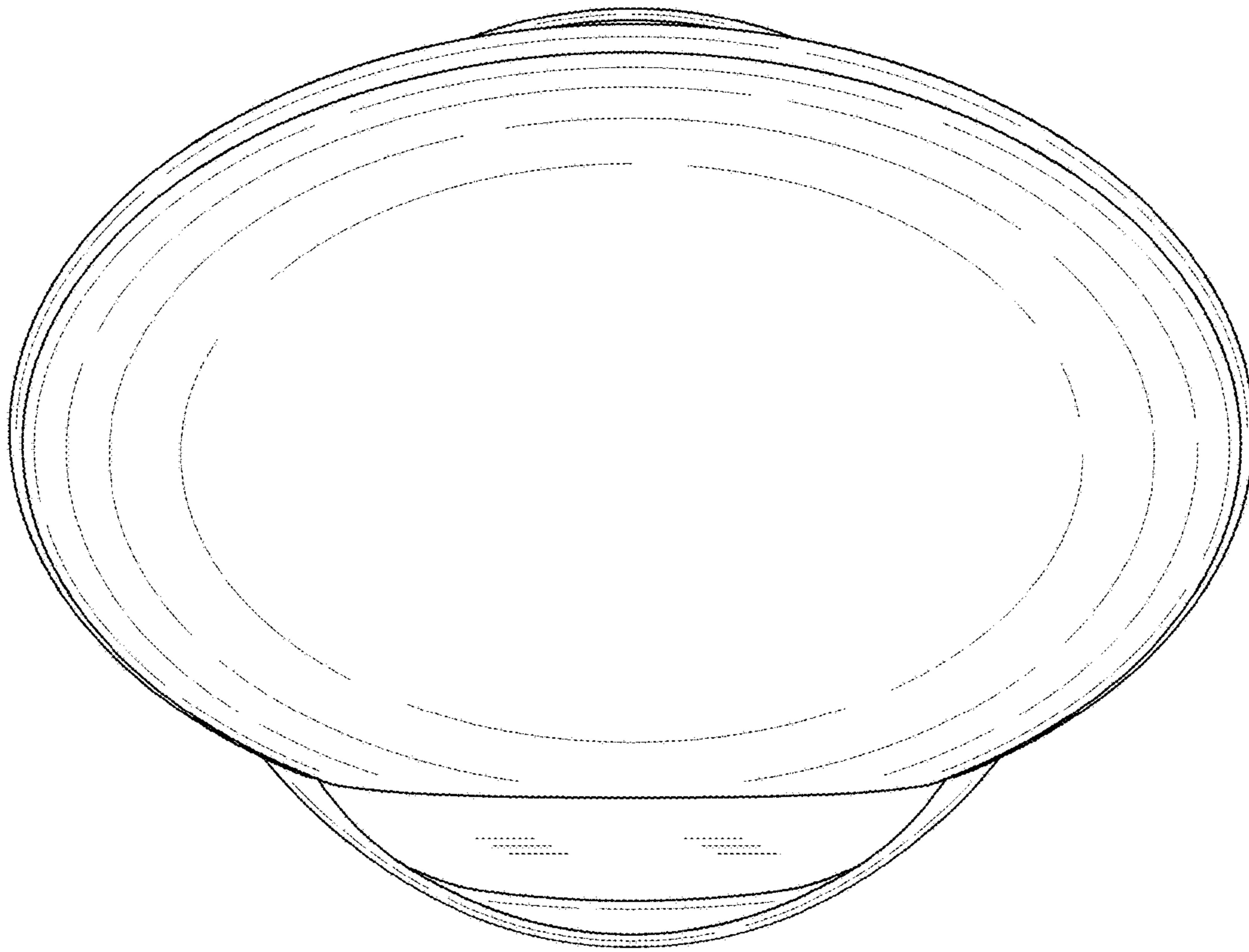

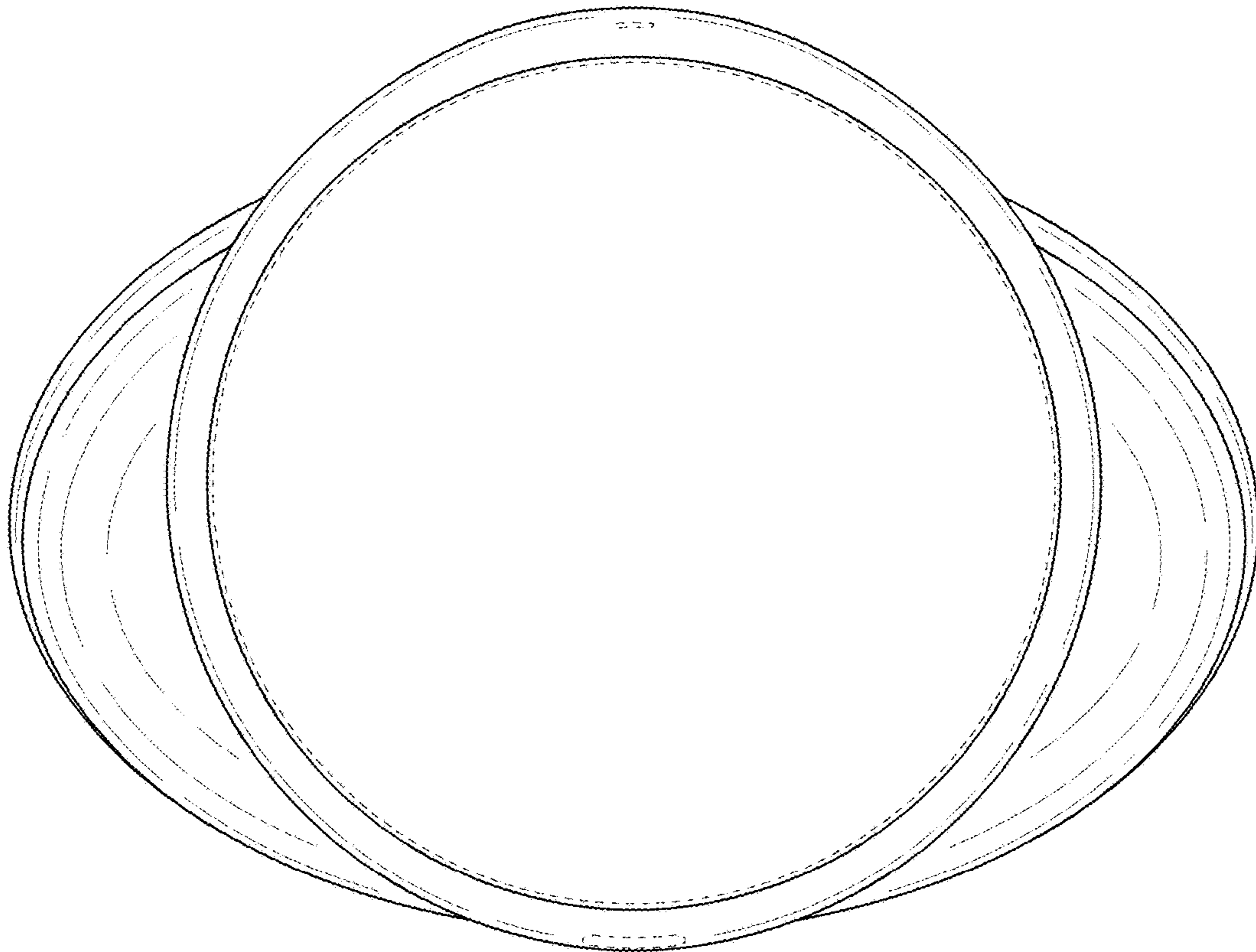
