(57) **CLAIM**

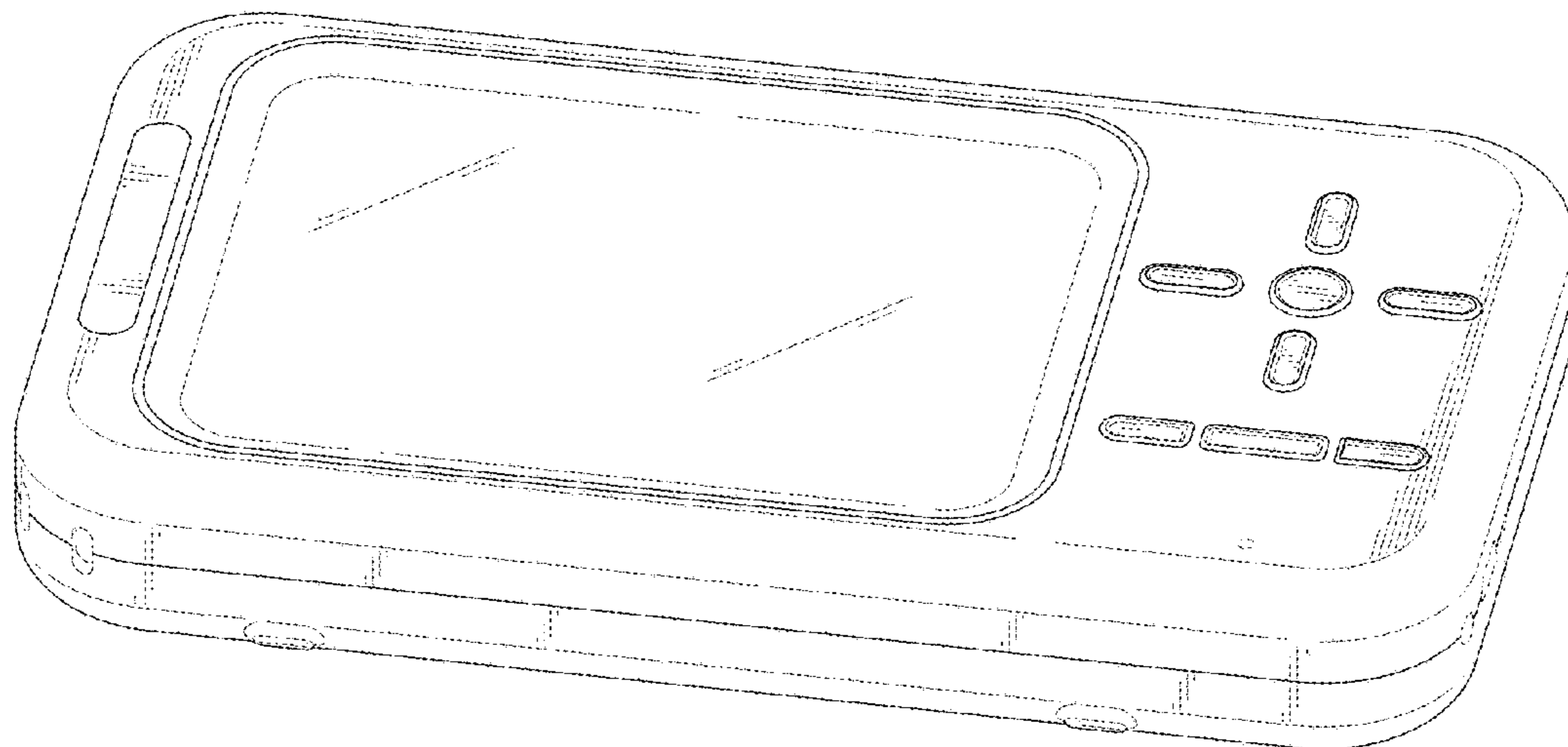
The ornamental design for a baby monitor master controller, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of an embodiment of a baby monitor master controller showing the claimed new design; FIG. 2 is a second perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a right side elevation view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof.

The broken lines represent boundaries of the claimed design. The broken lines depict environmental subject matter that forms no part of the claimed design. 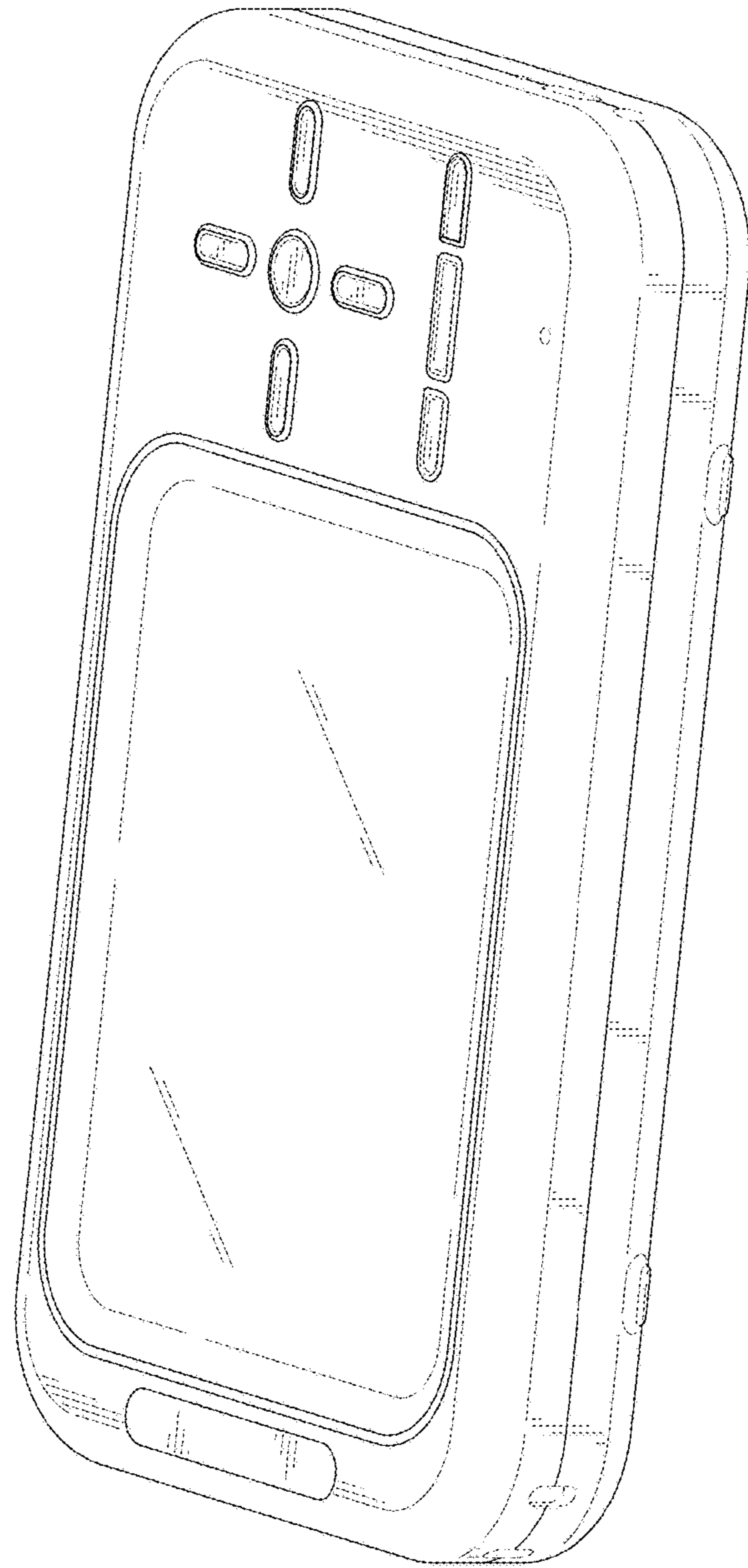

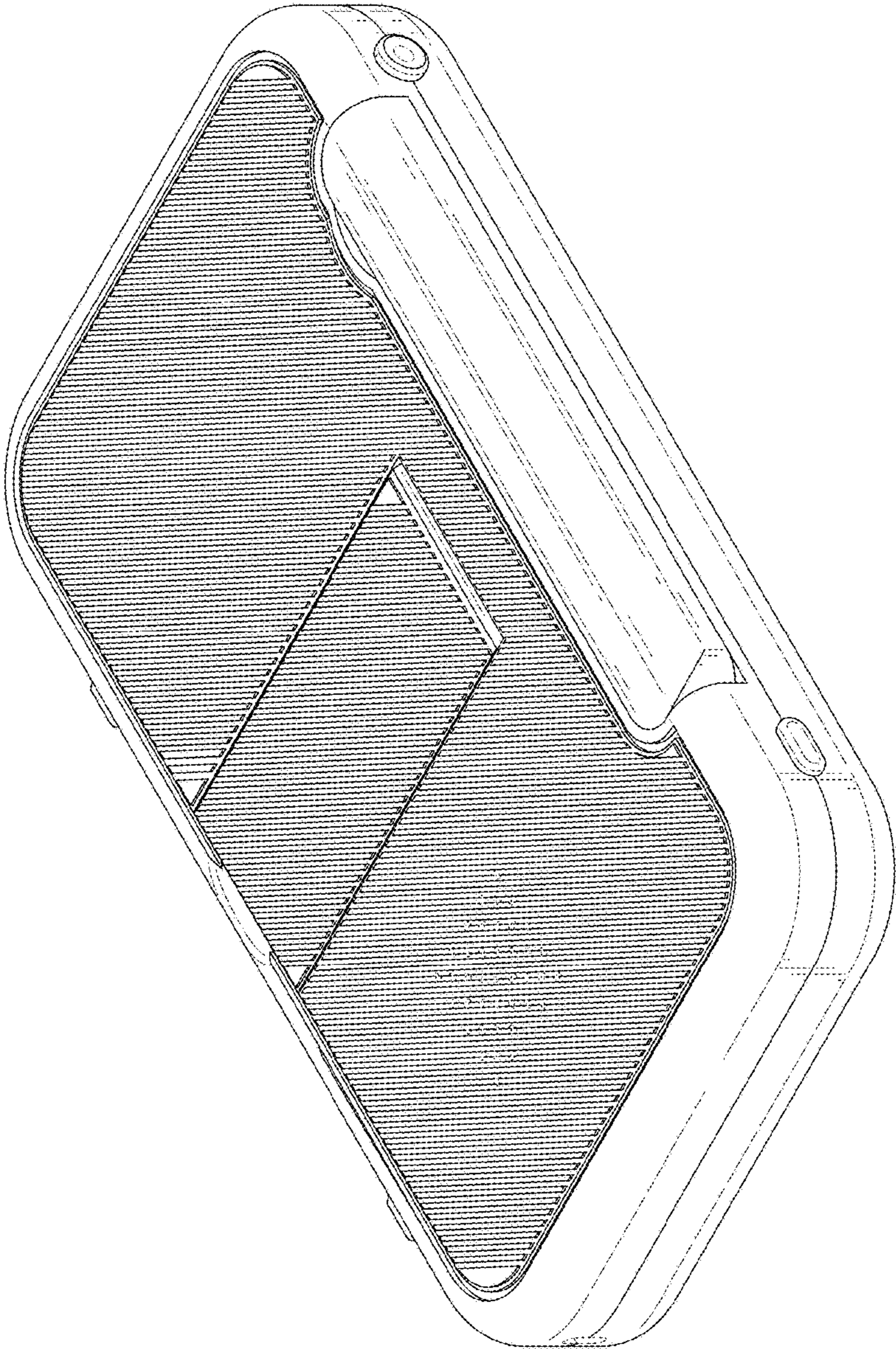

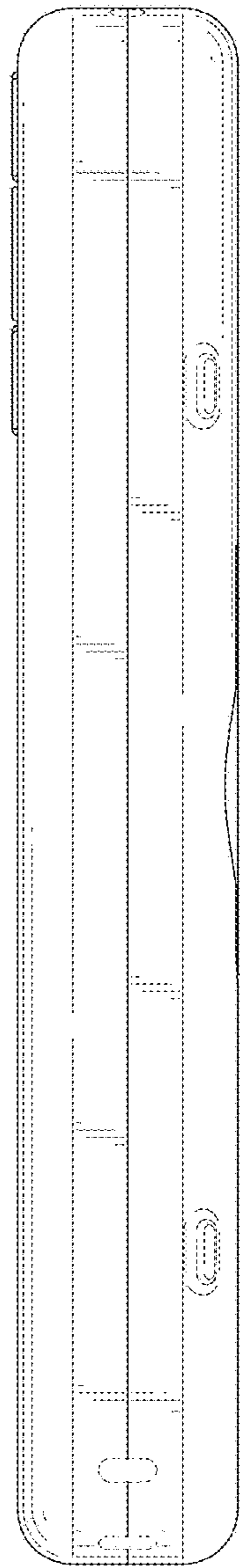

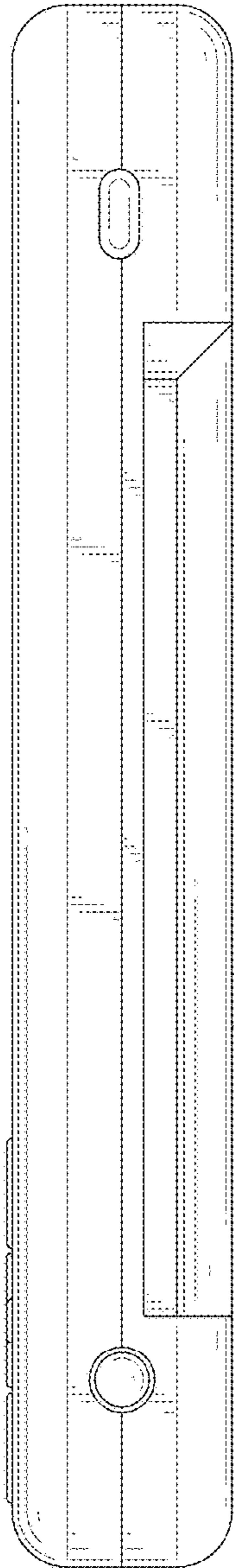

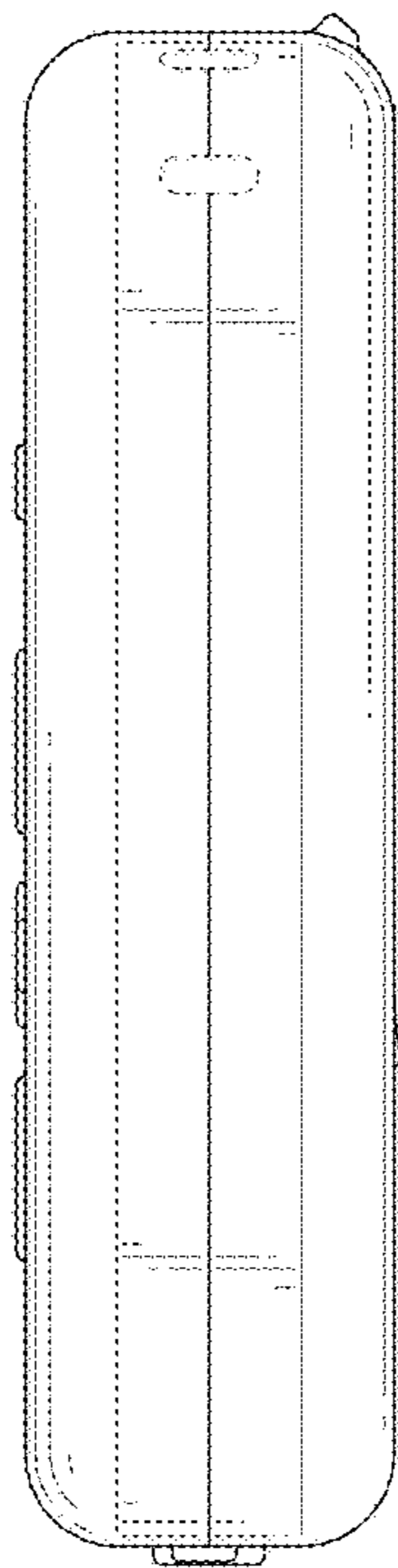

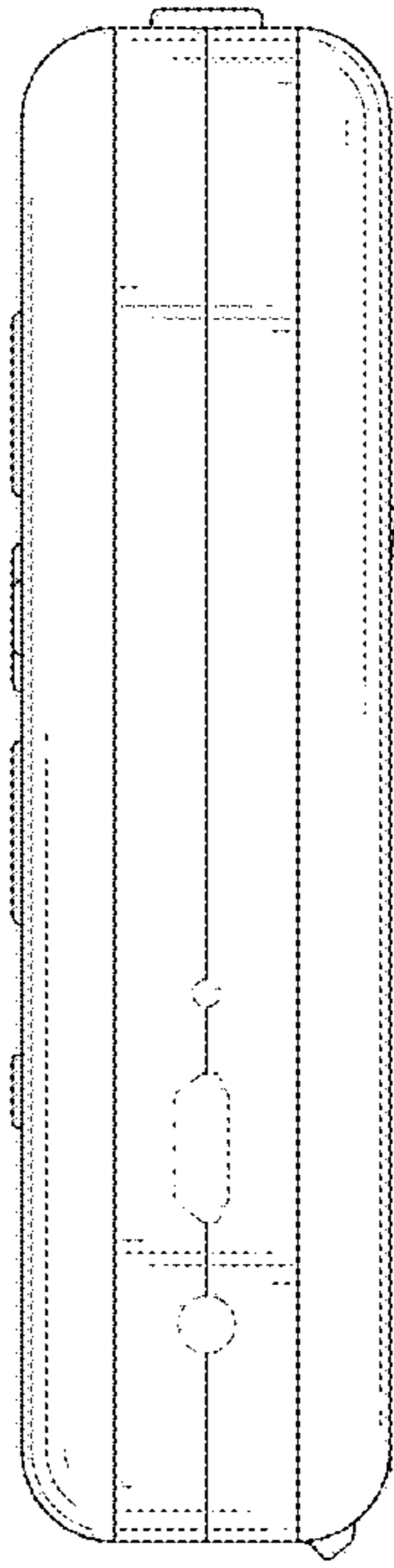

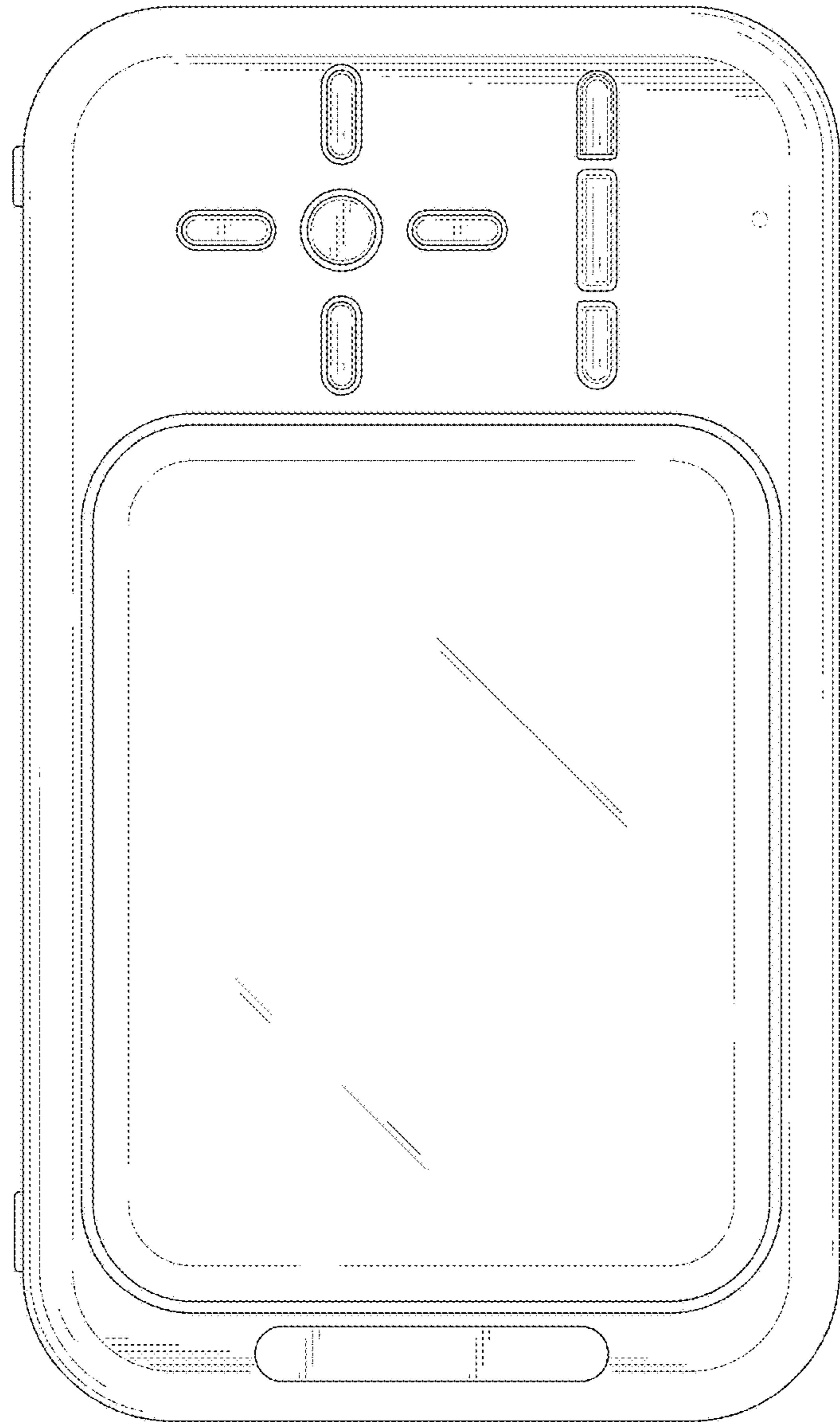

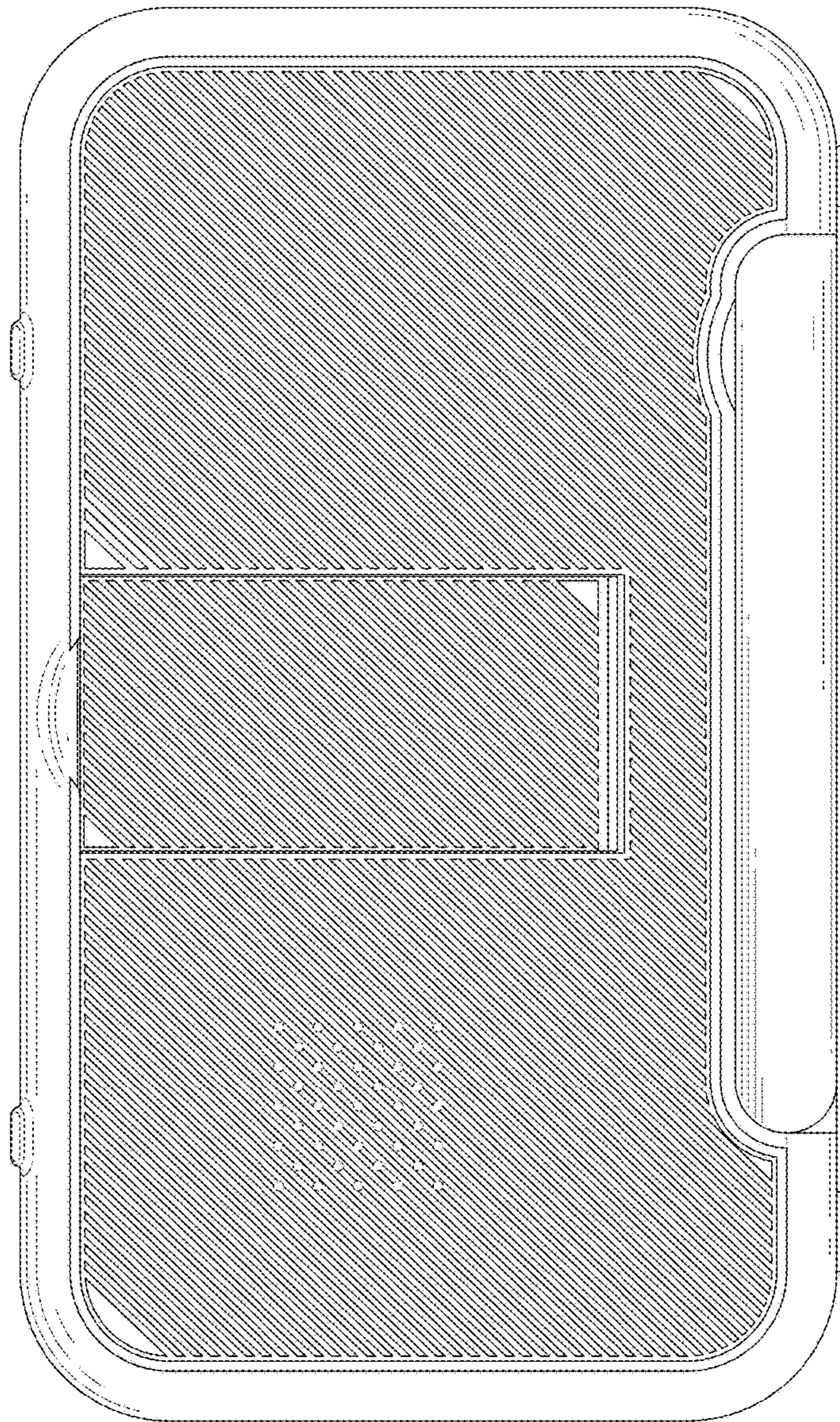
