headphone with surface treatment enlarged.

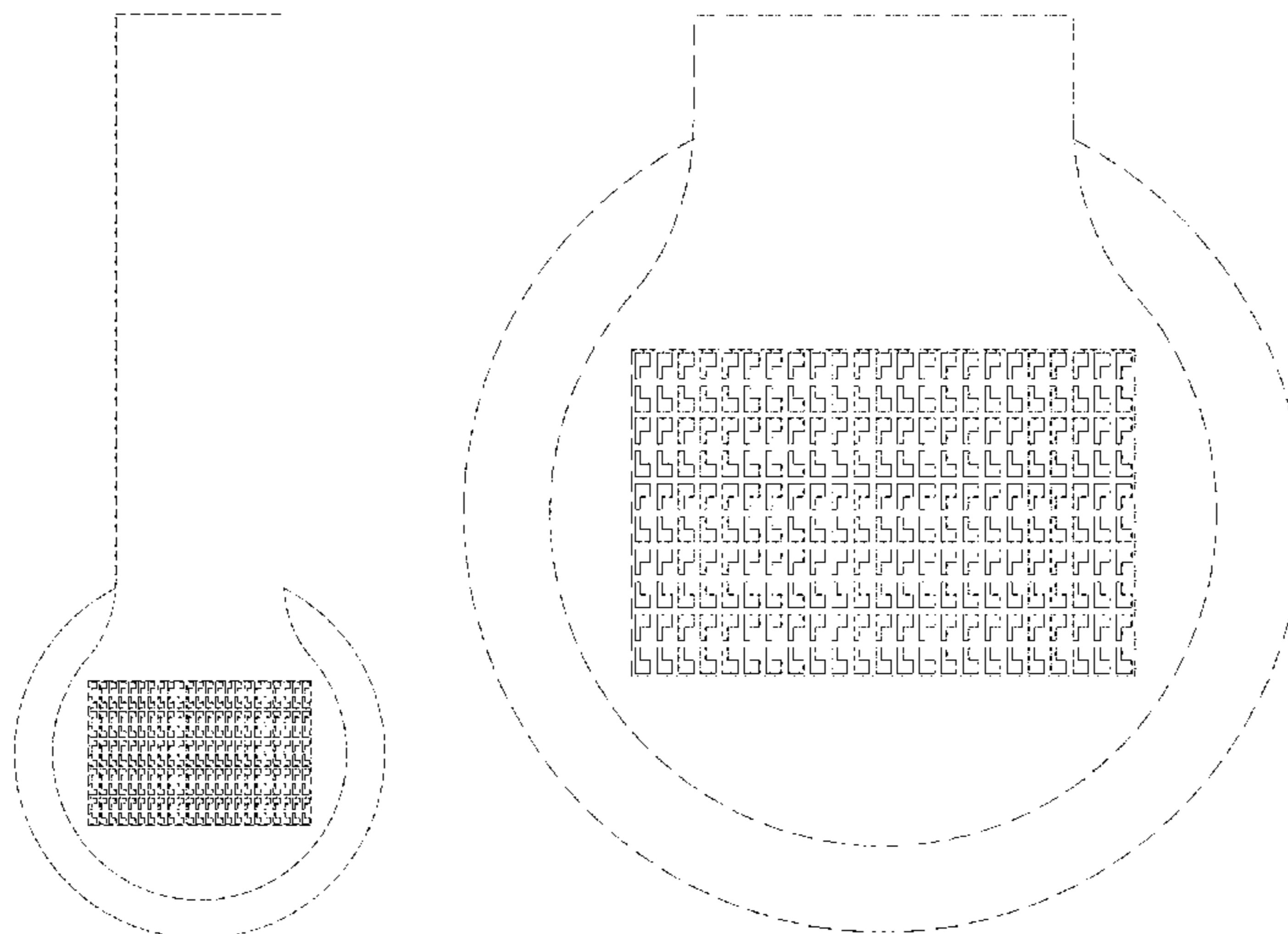

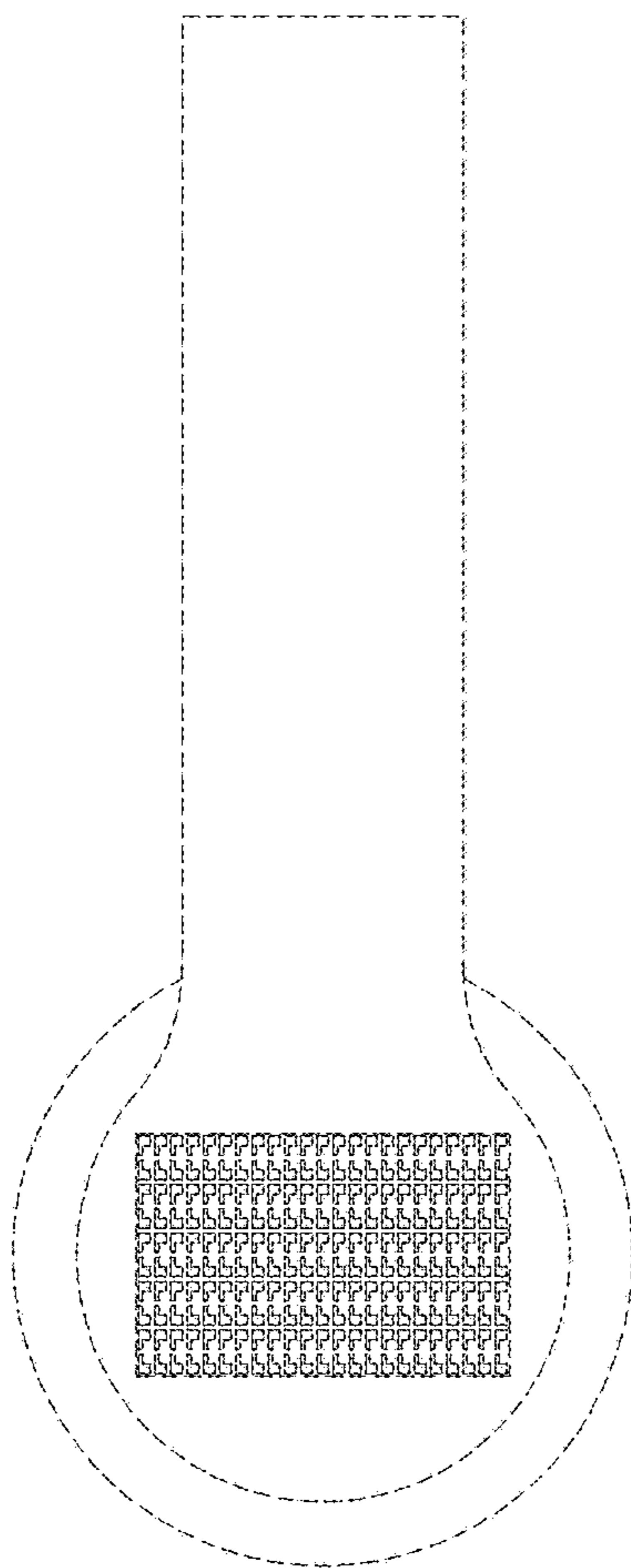

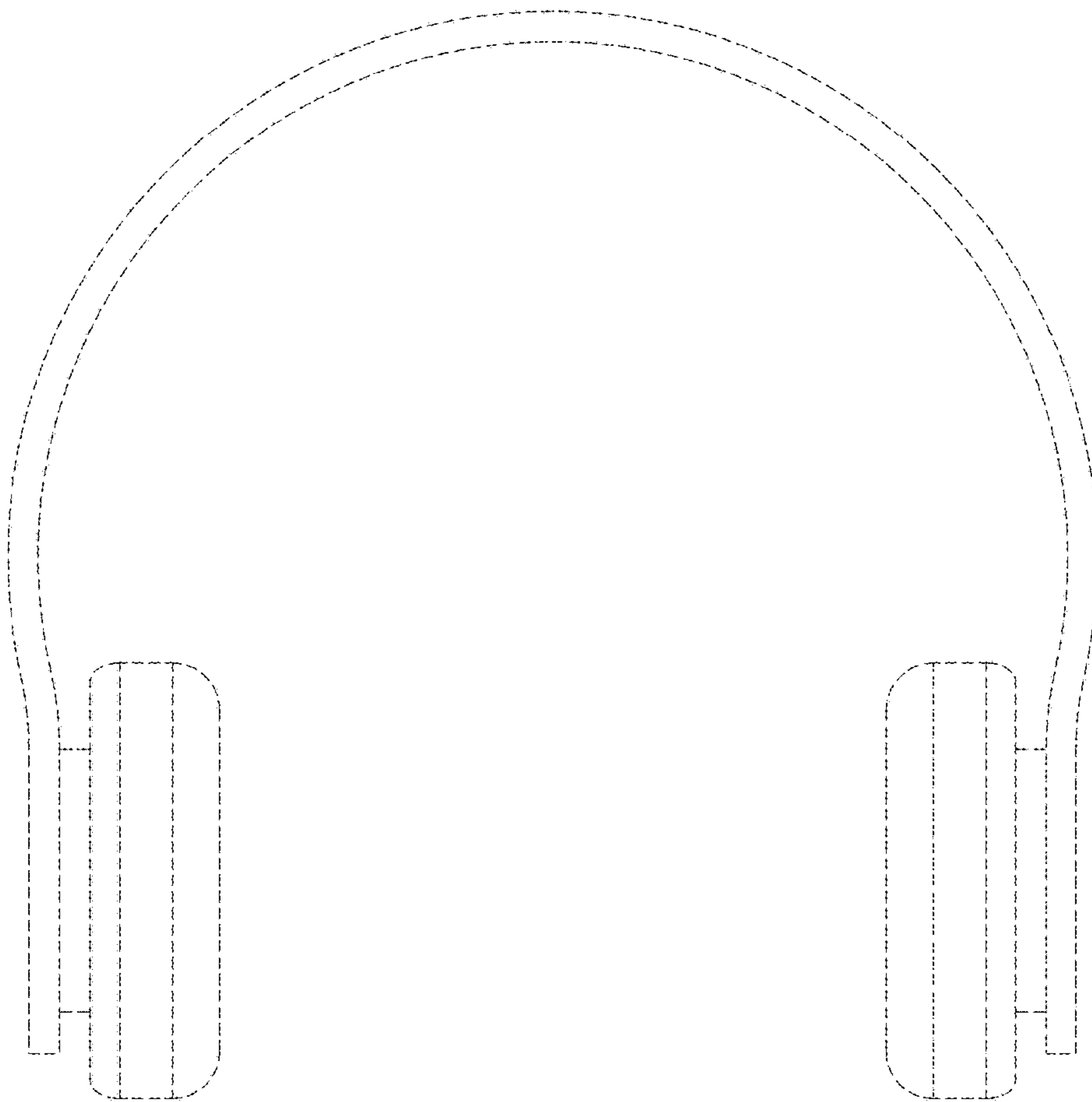

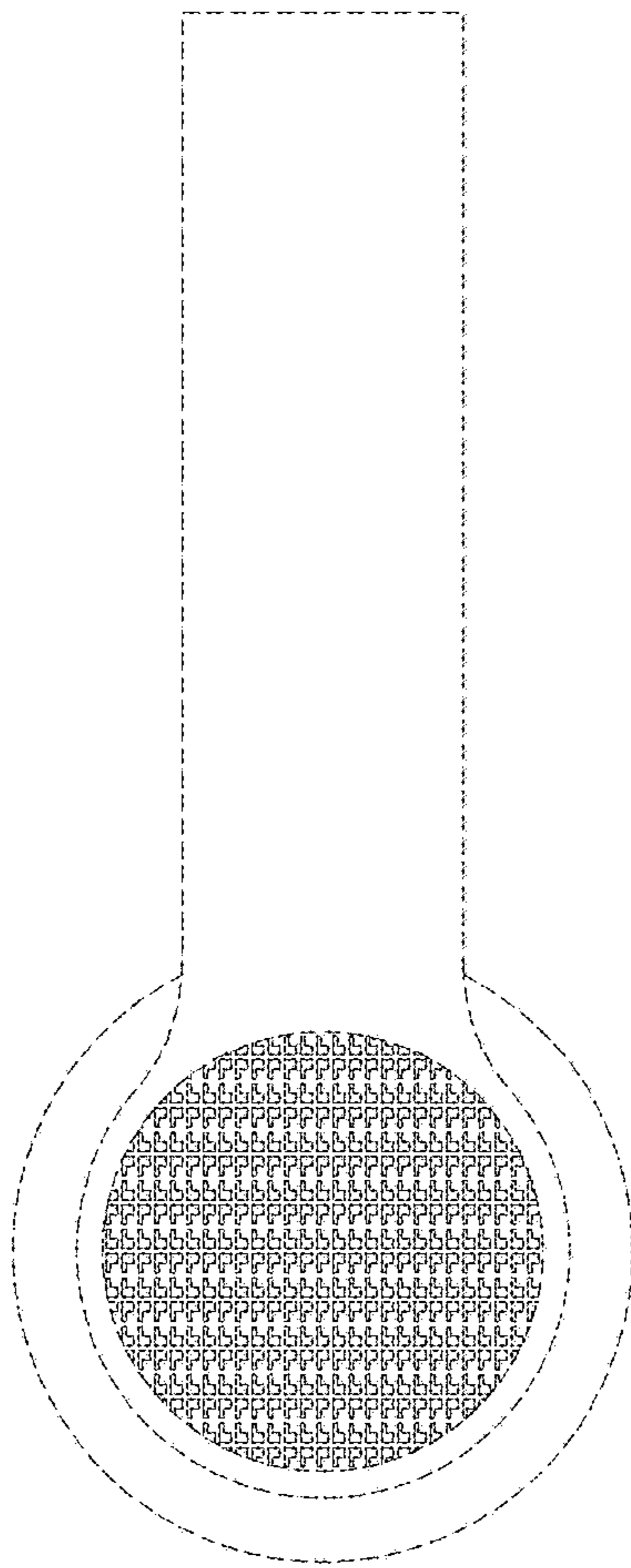

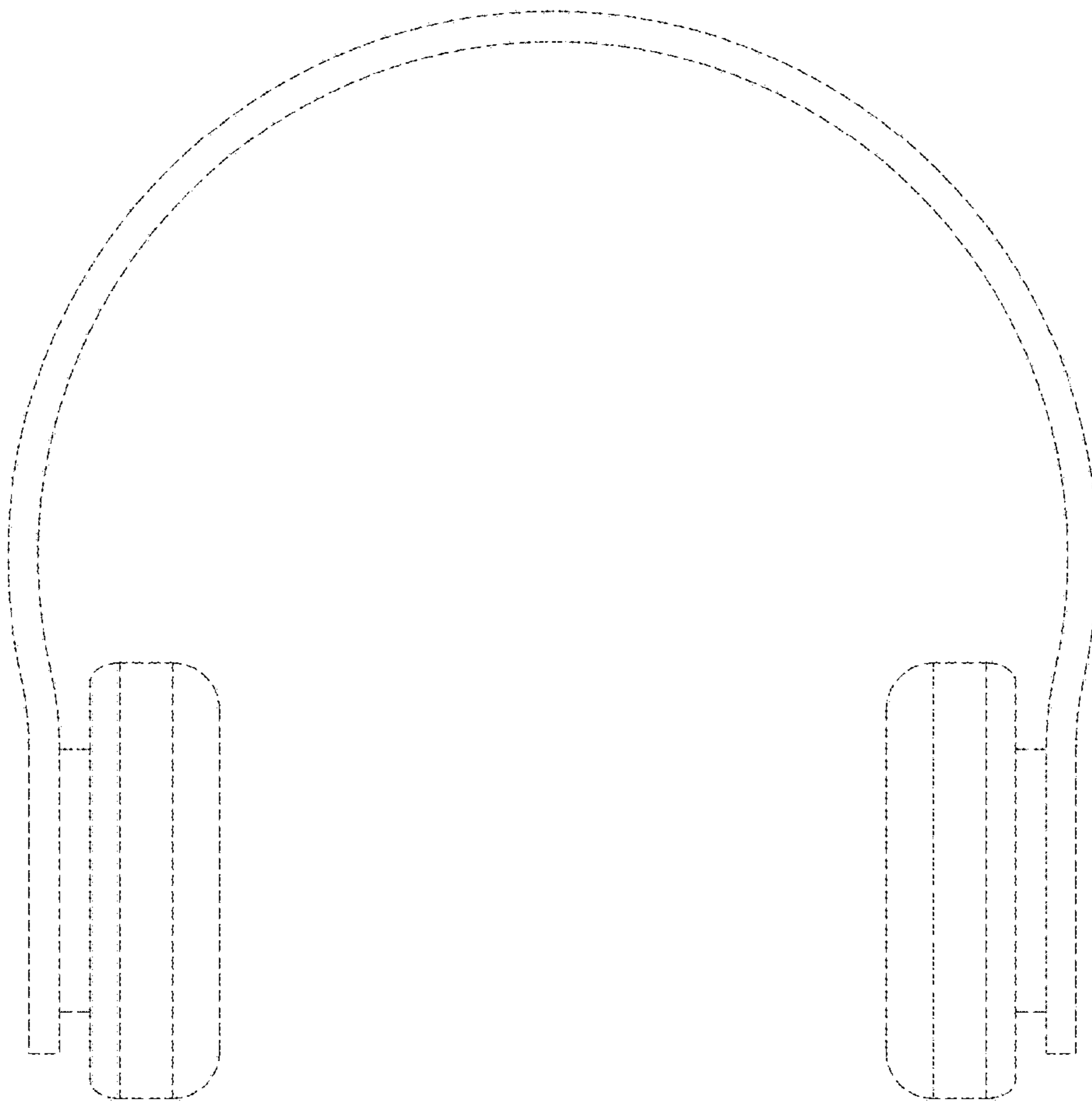

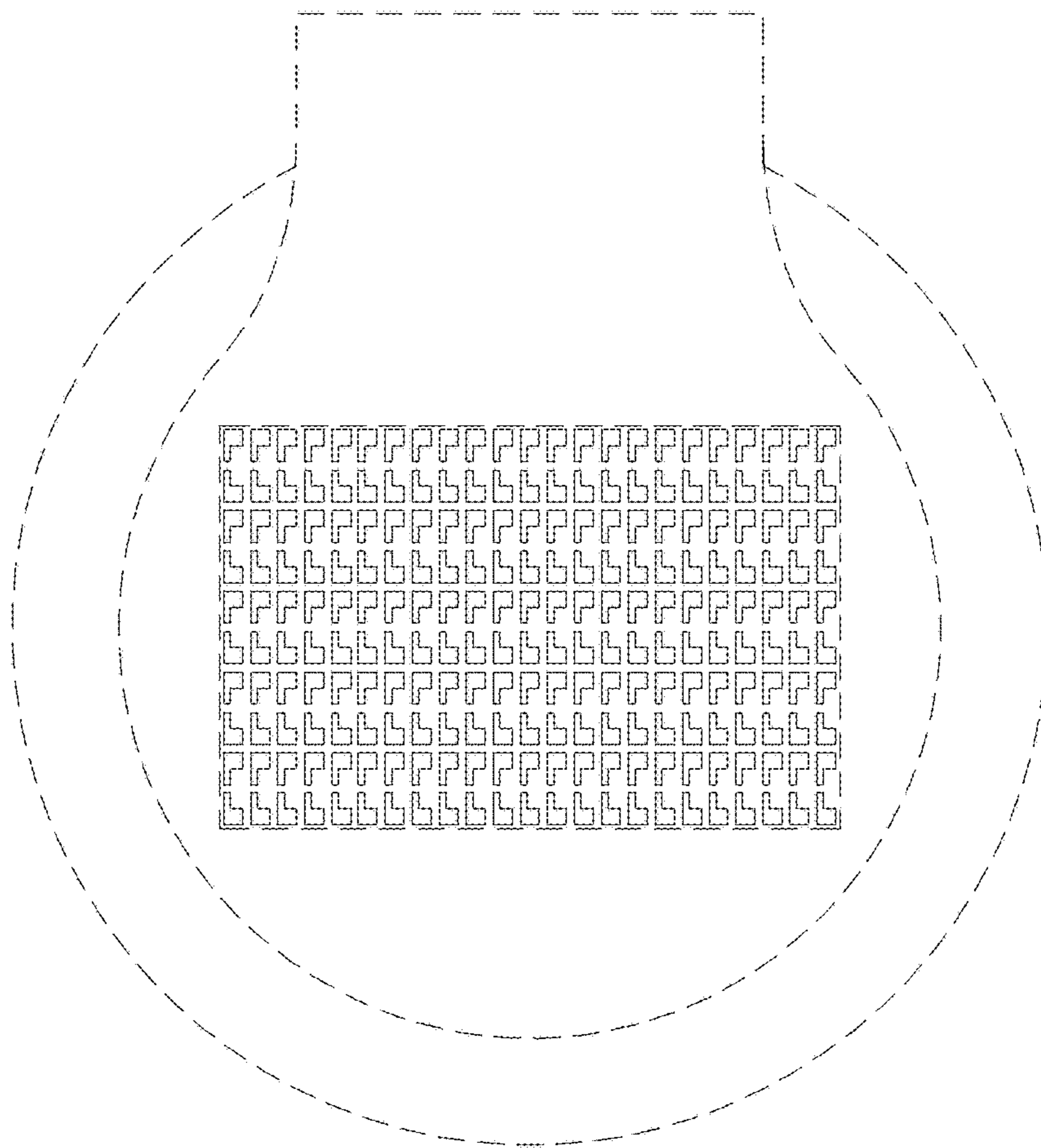

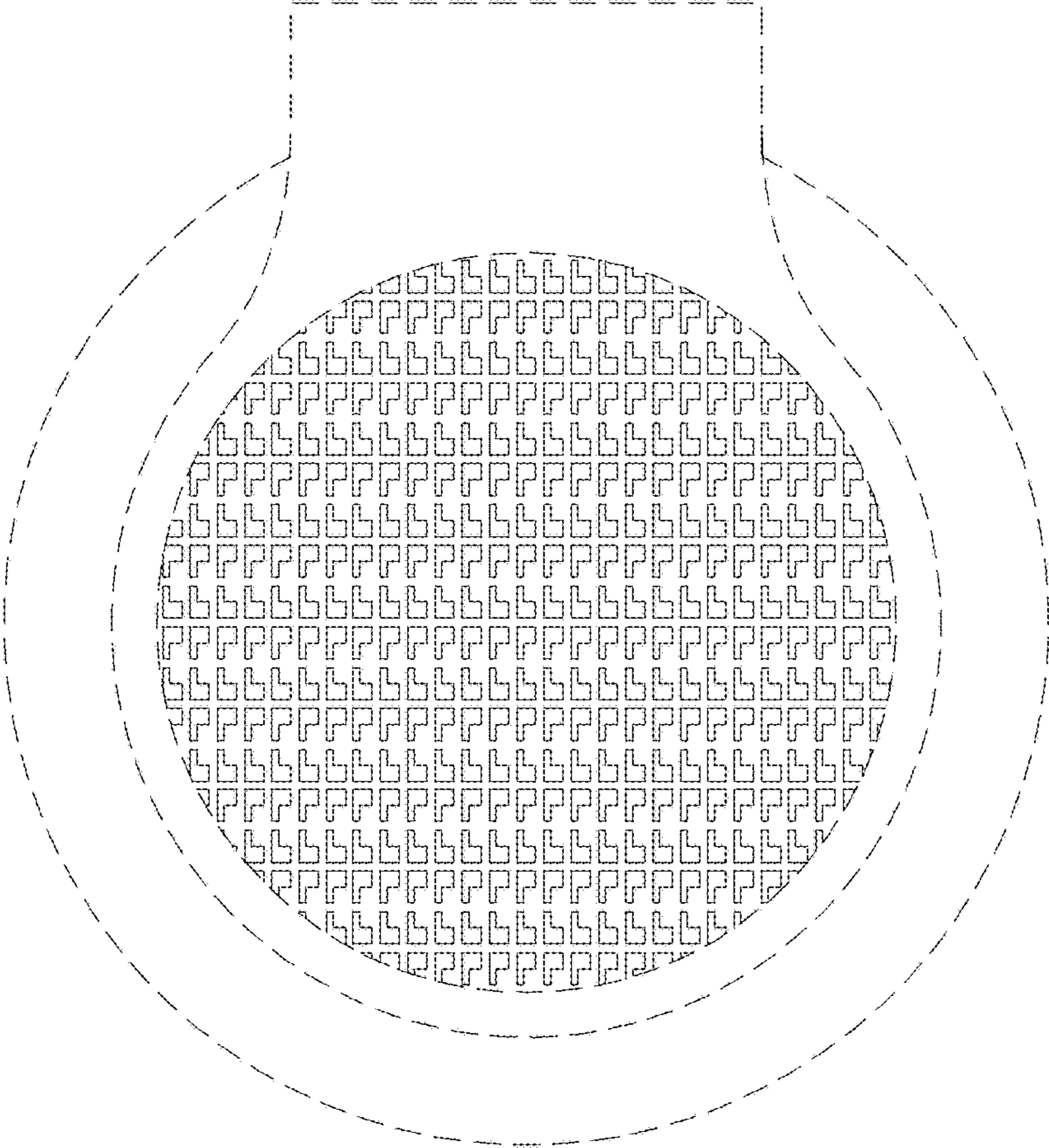
