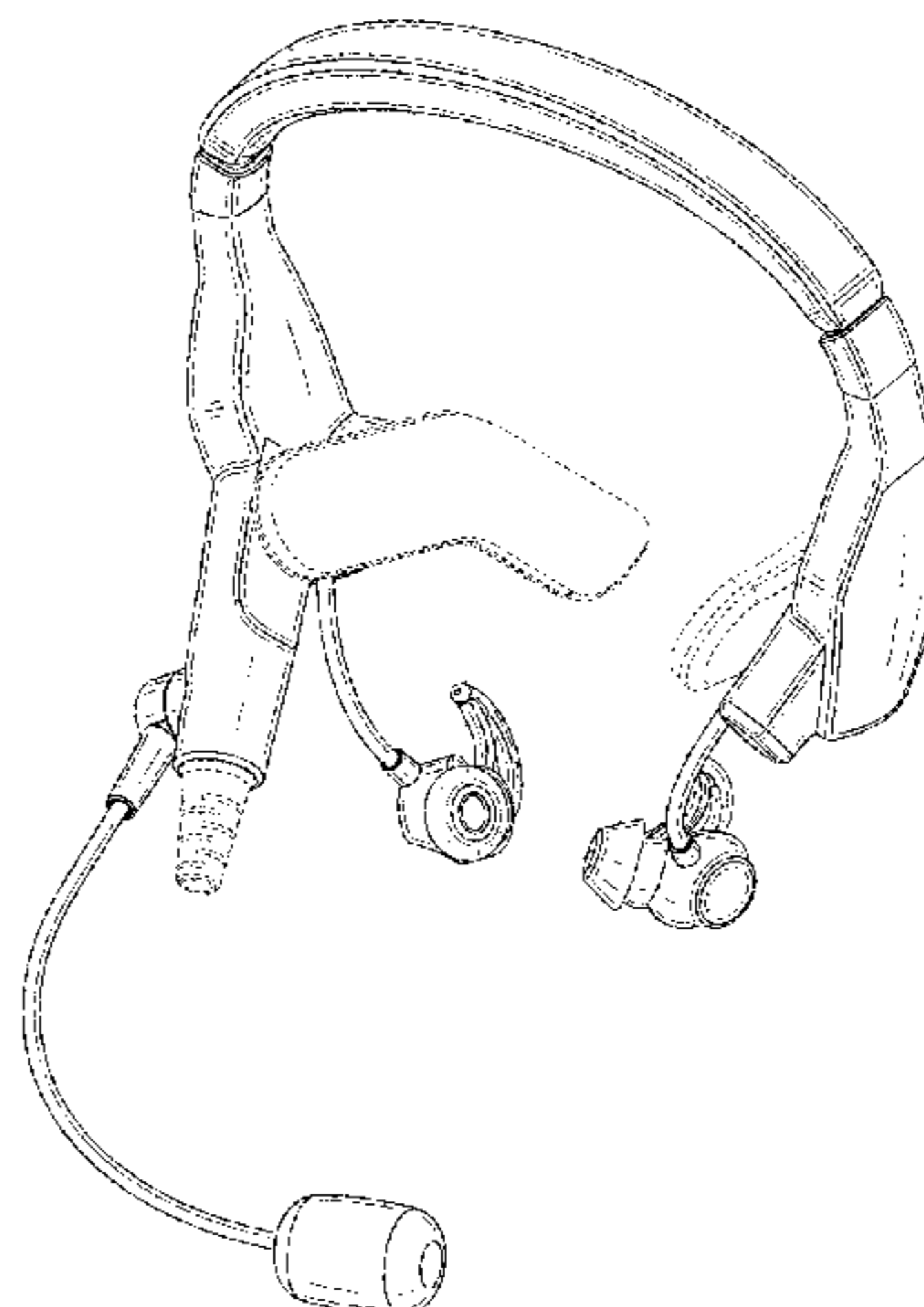
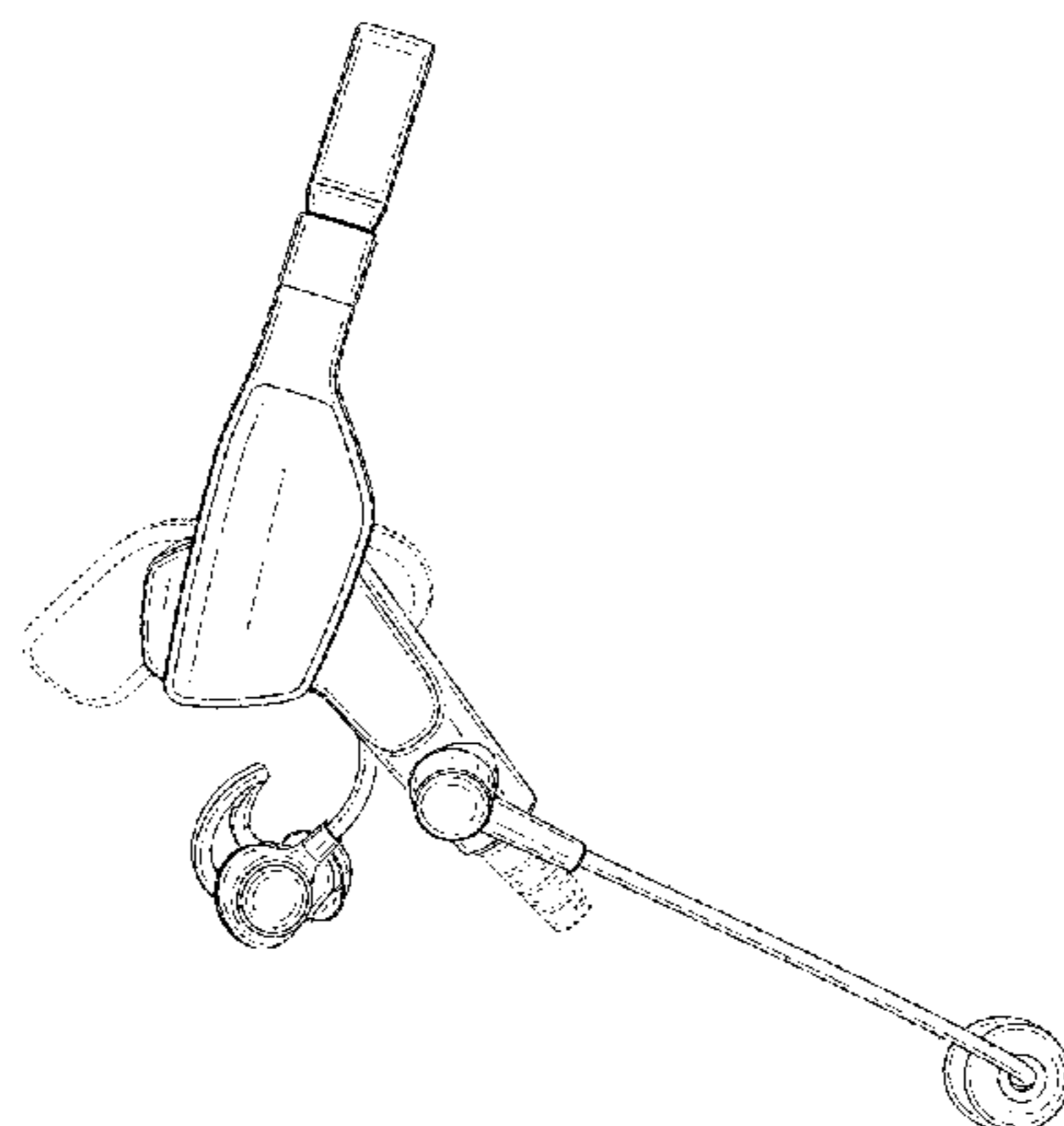
(57) **CLAIM**

The ornamental design for headset with boom microphone, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a front and right side perspective view of a headset with a boom microphone showing our new design, the headset with a boom microphone connected to the left-side housing is a mirror image;

 FIG. 3 is a left side view thereof;  
 FIG. 4 is a back view thereof;  
 FIG. 5 is a right side view thereof;  
 FIG. 6 is a top view thereof;

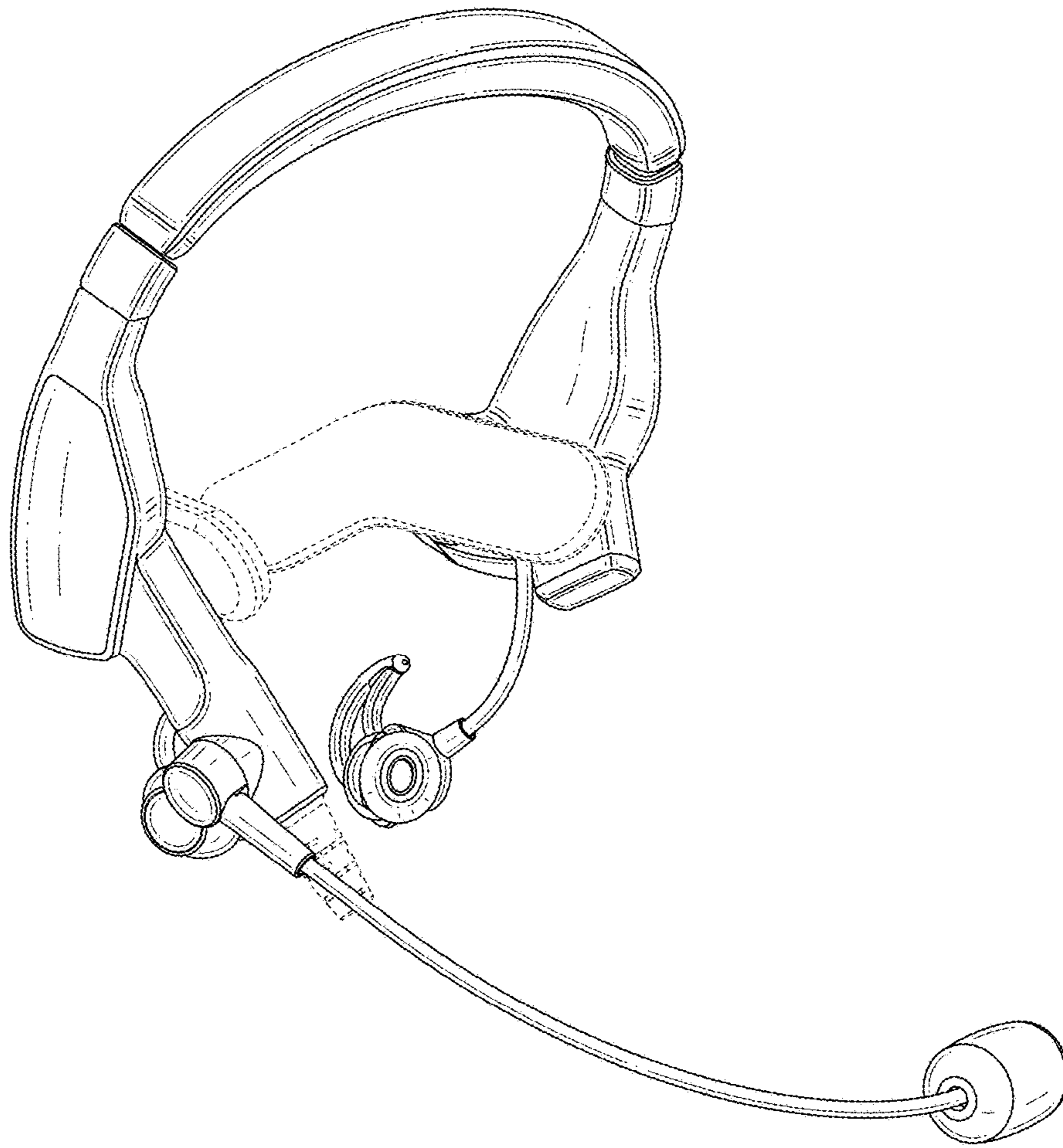

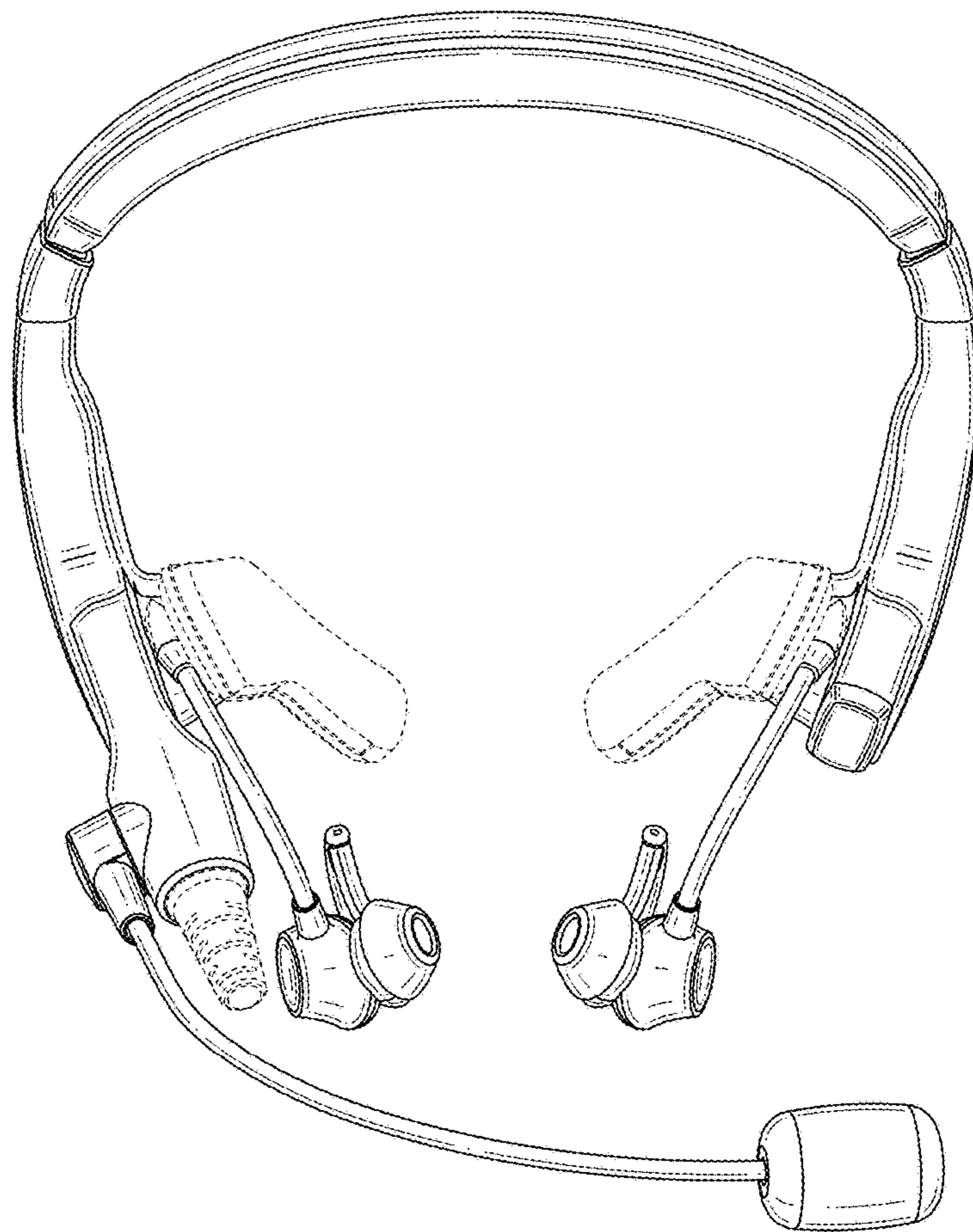

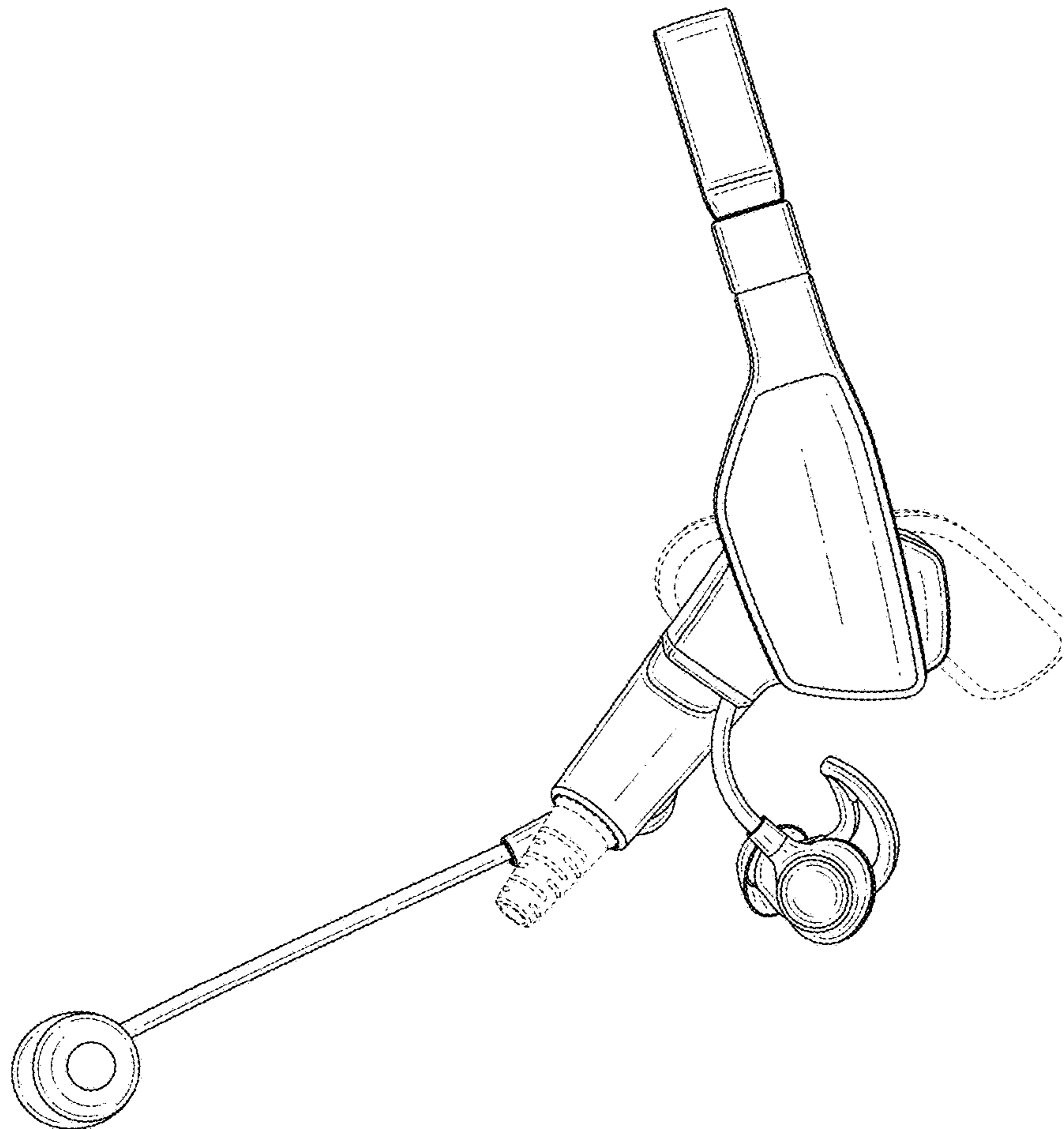

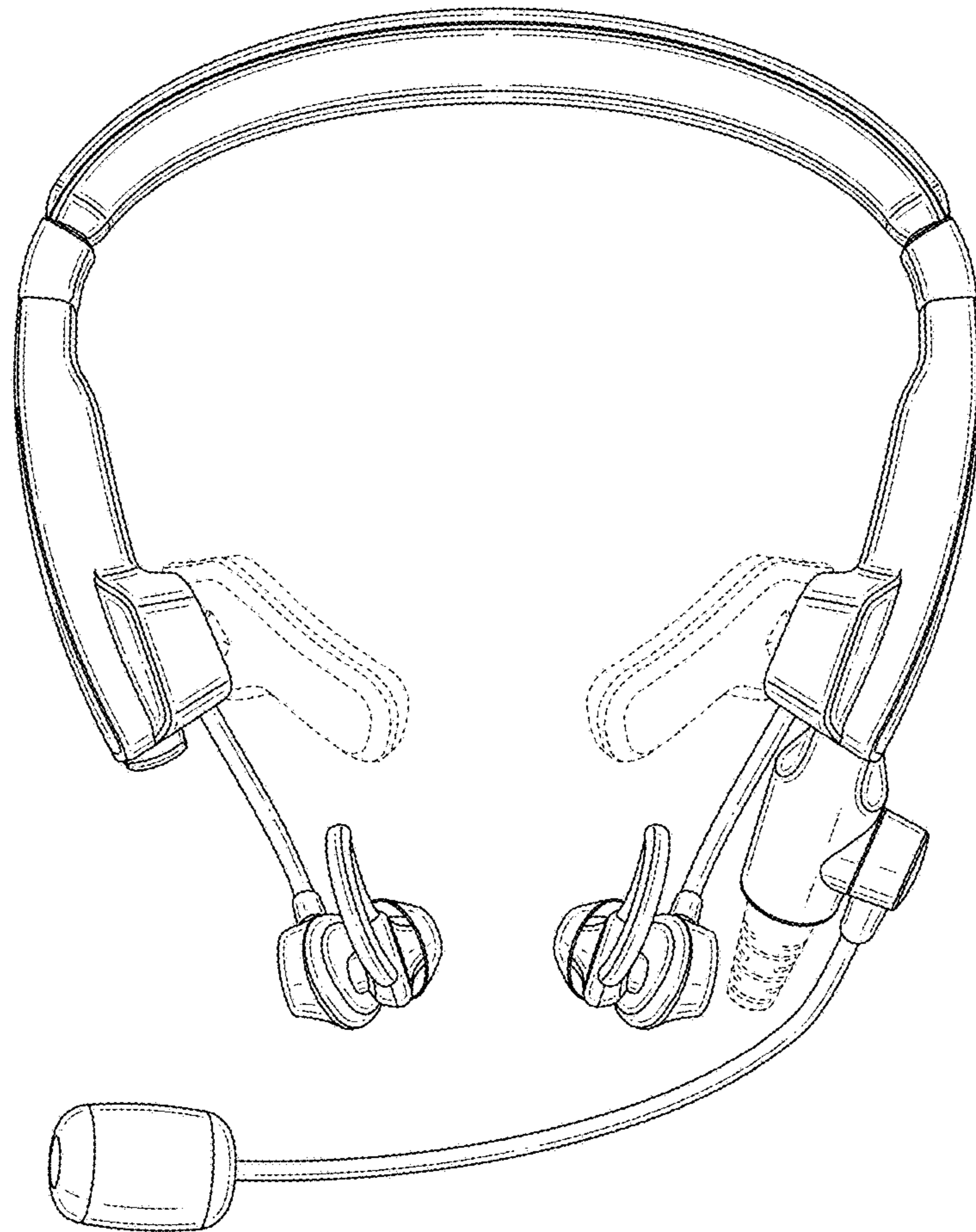




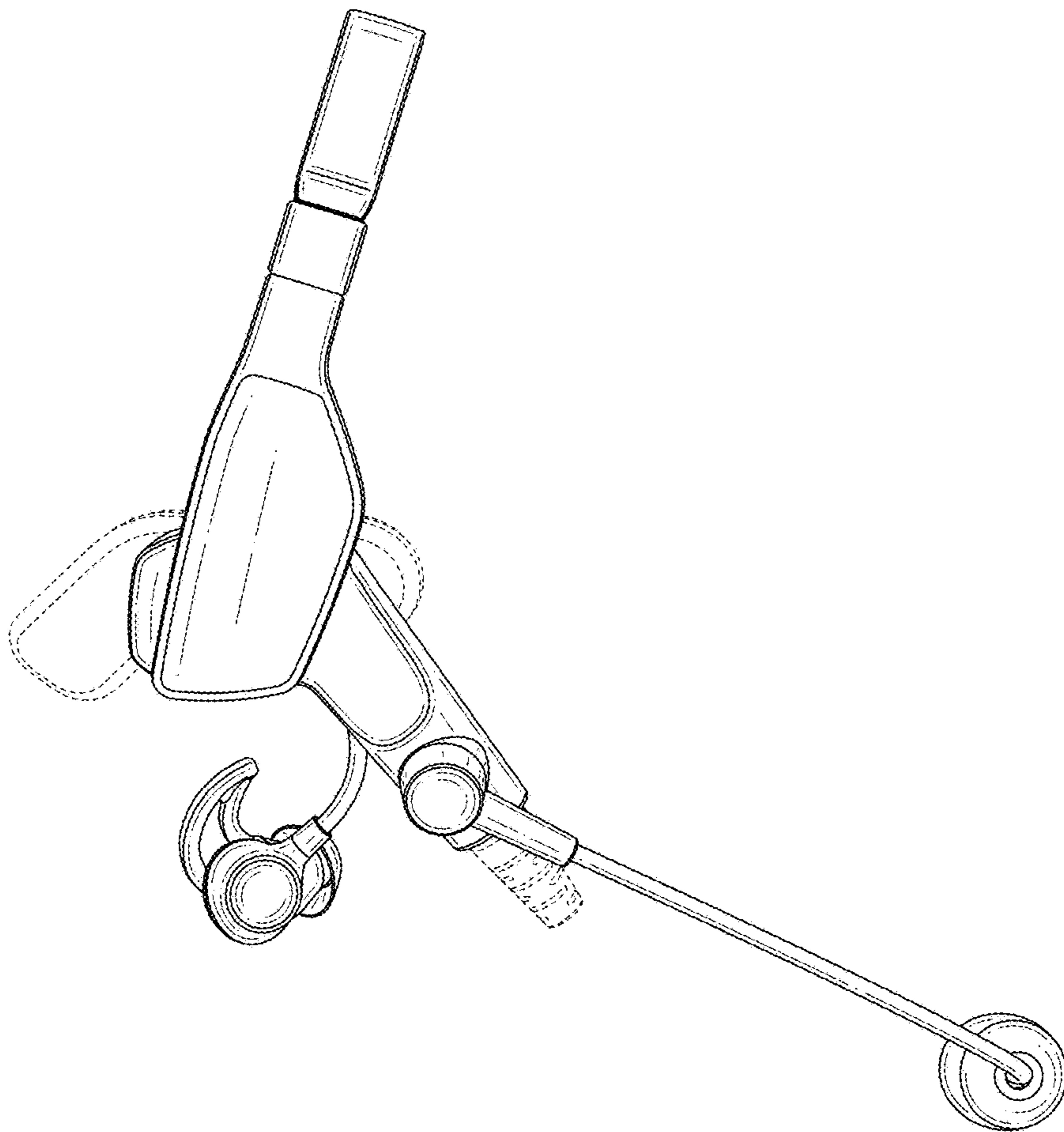

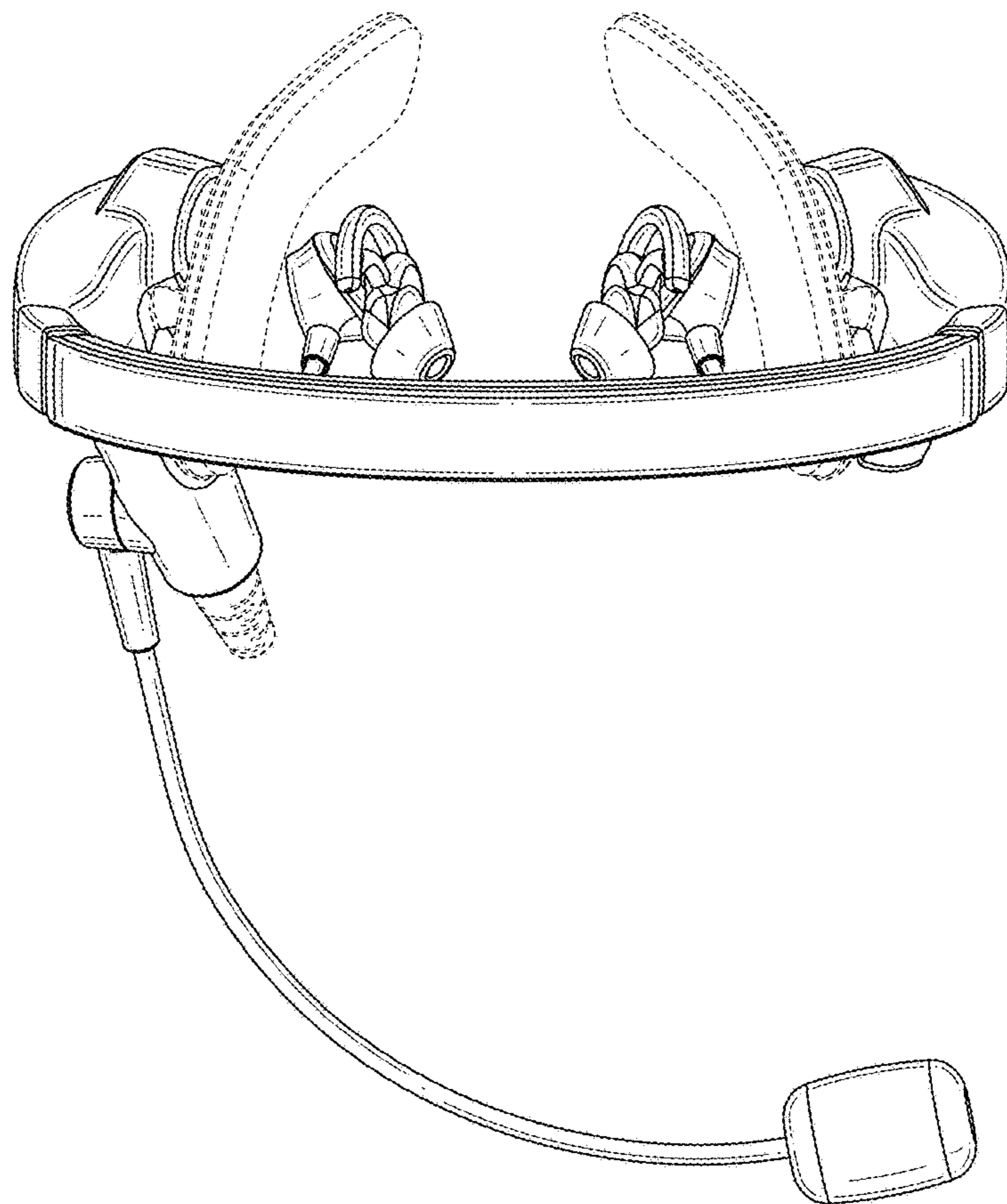

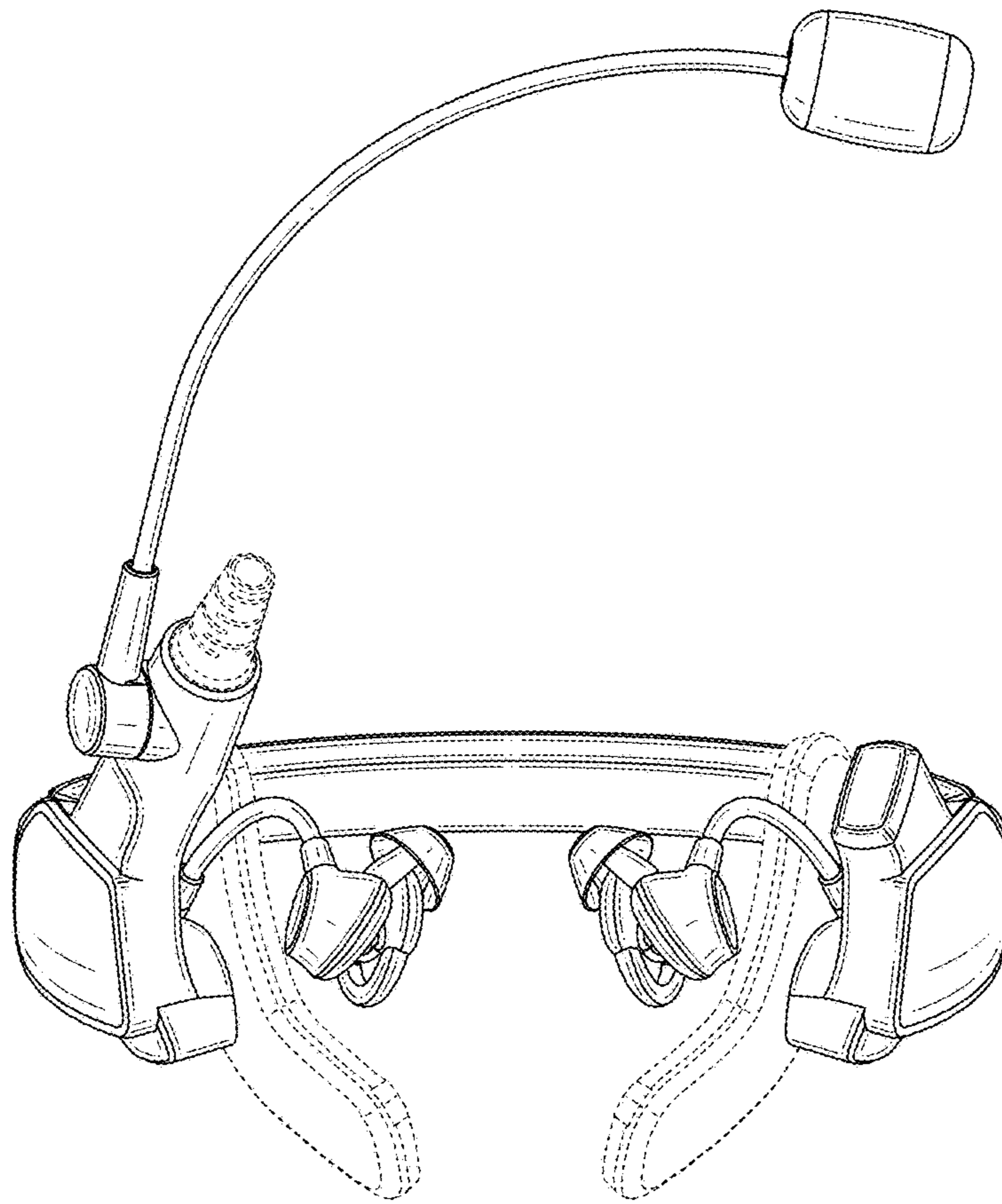

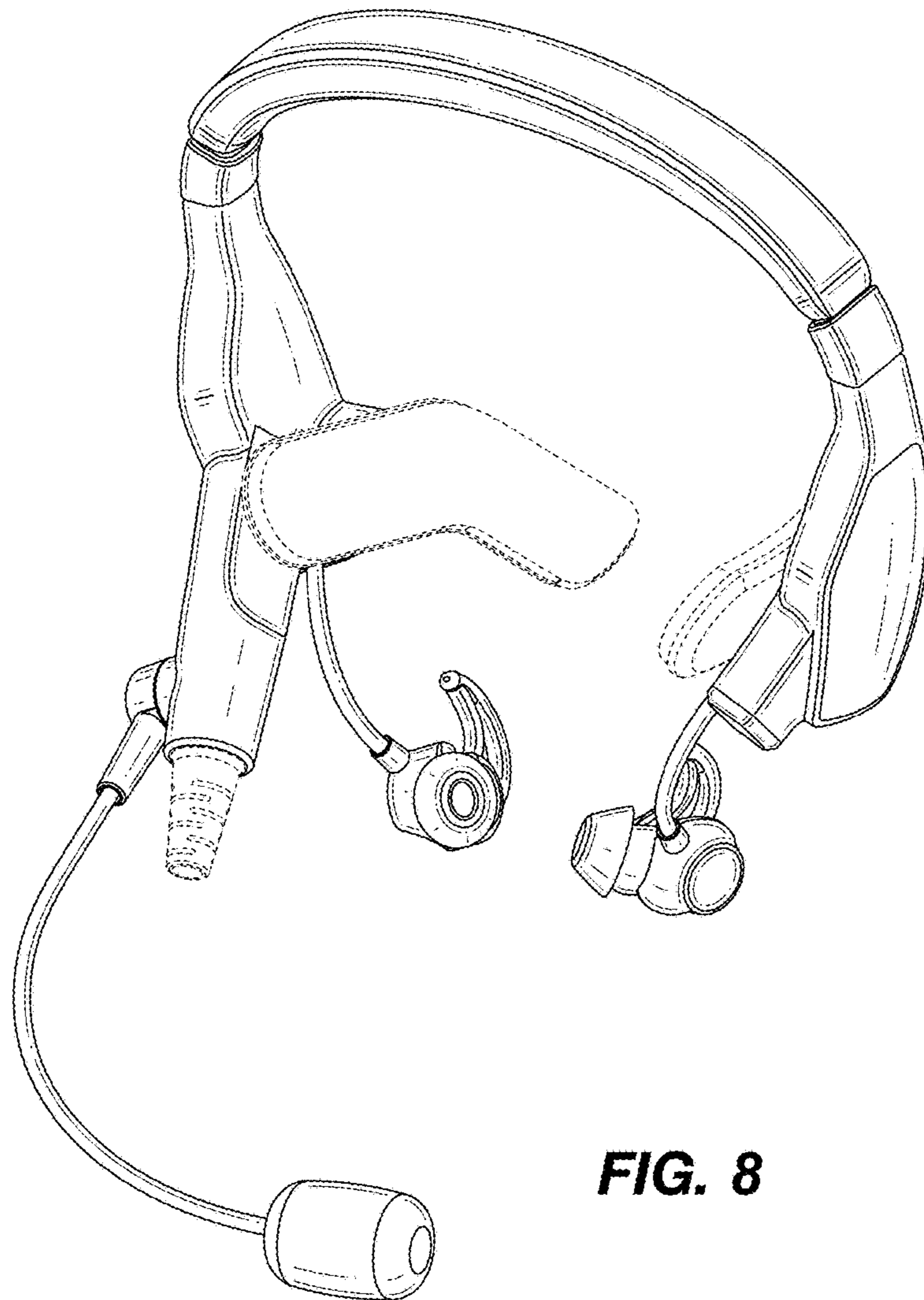
