The ornamental design for wireless router, as shown and described.

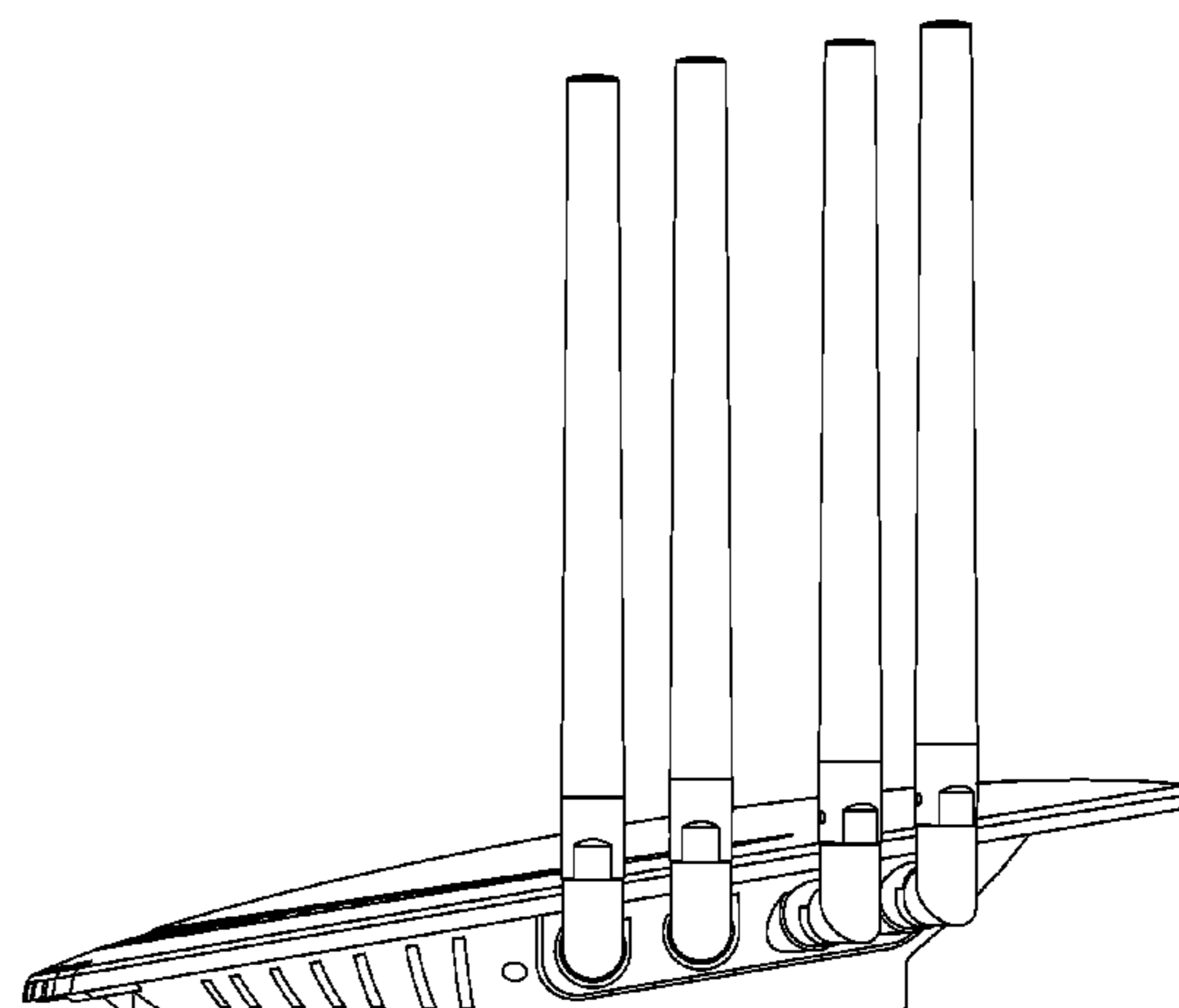
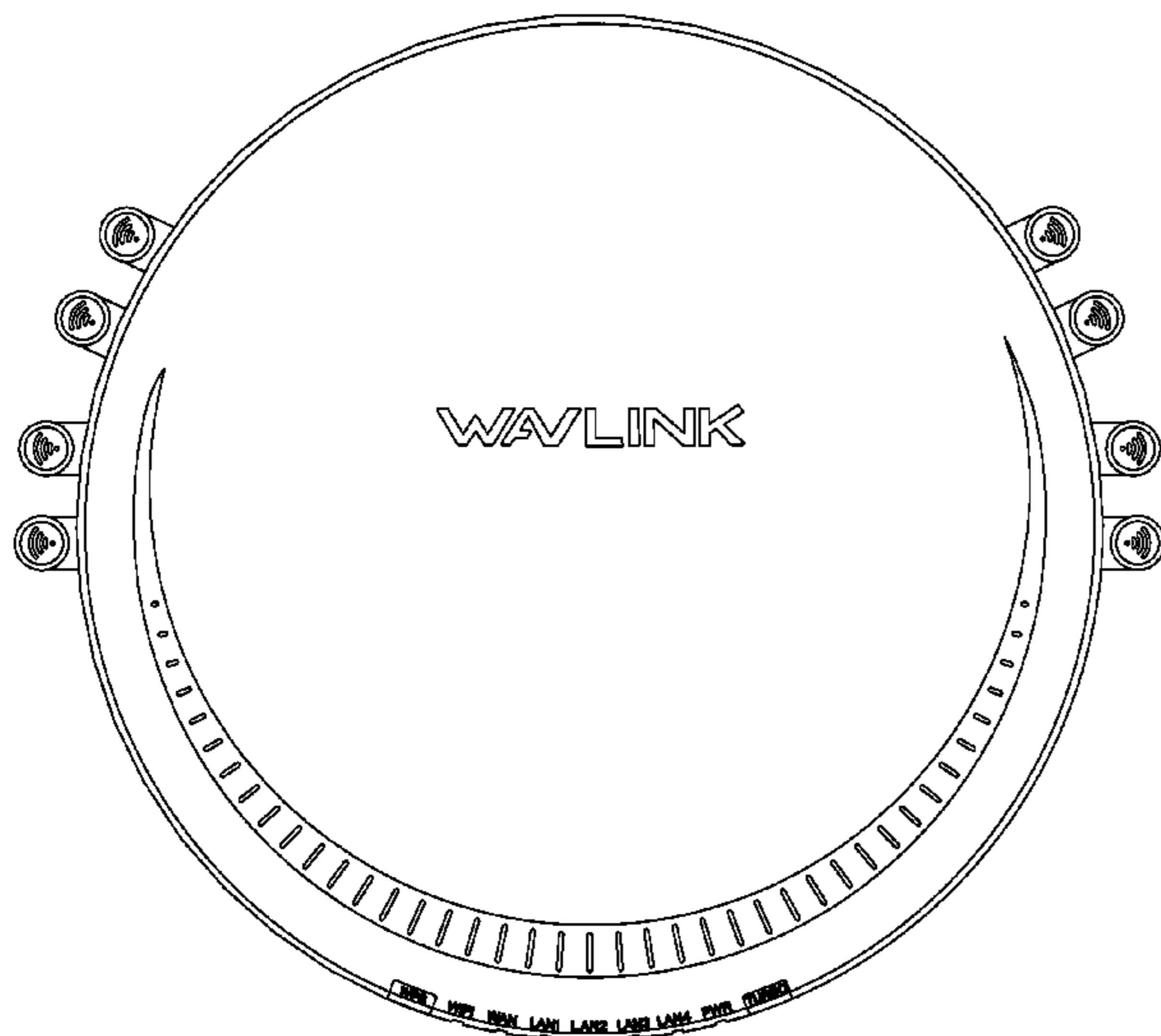
DESCRIPTION

FIG. 1 is a top right perspective view of a wireless router, showing my new design;

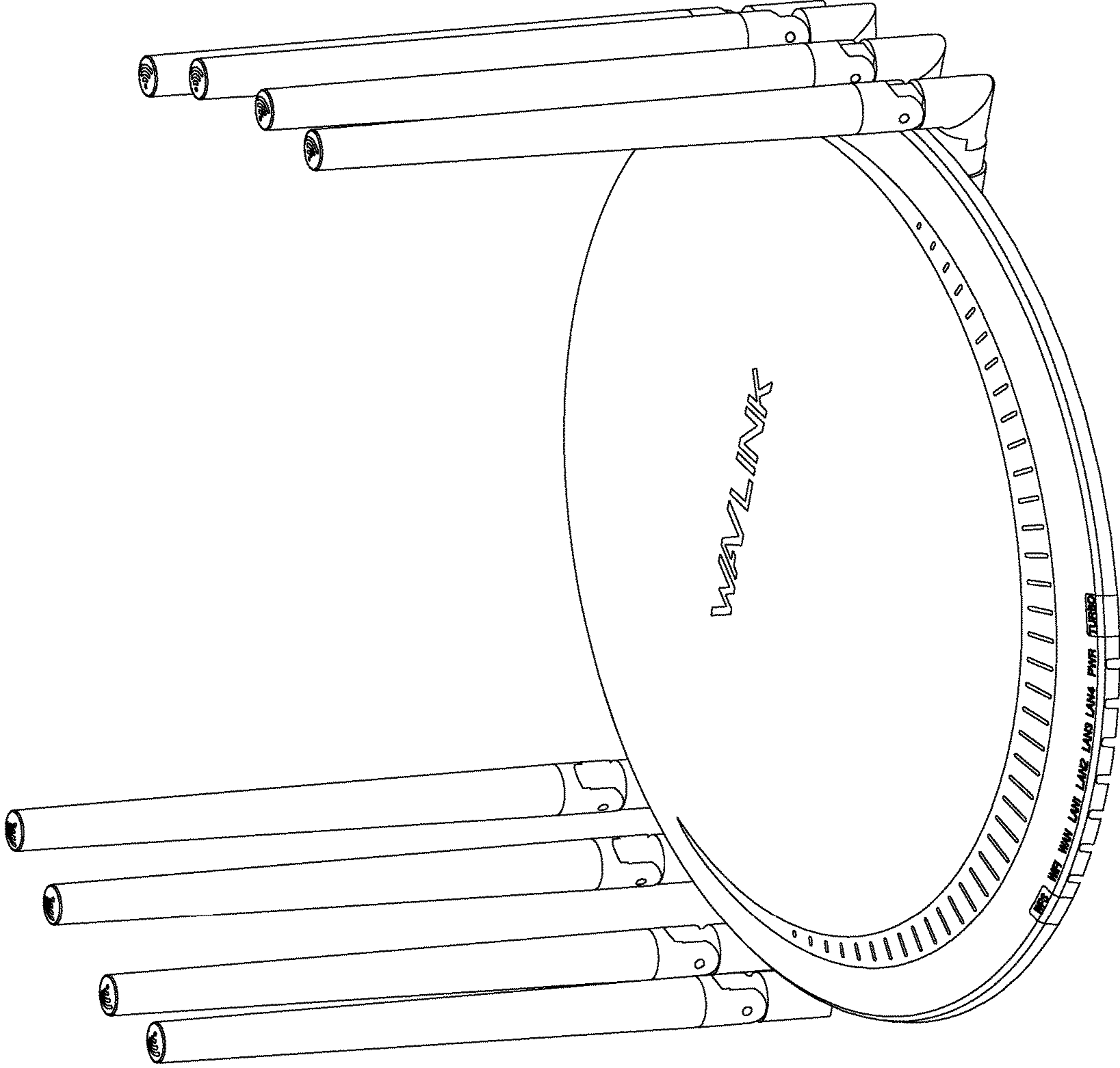

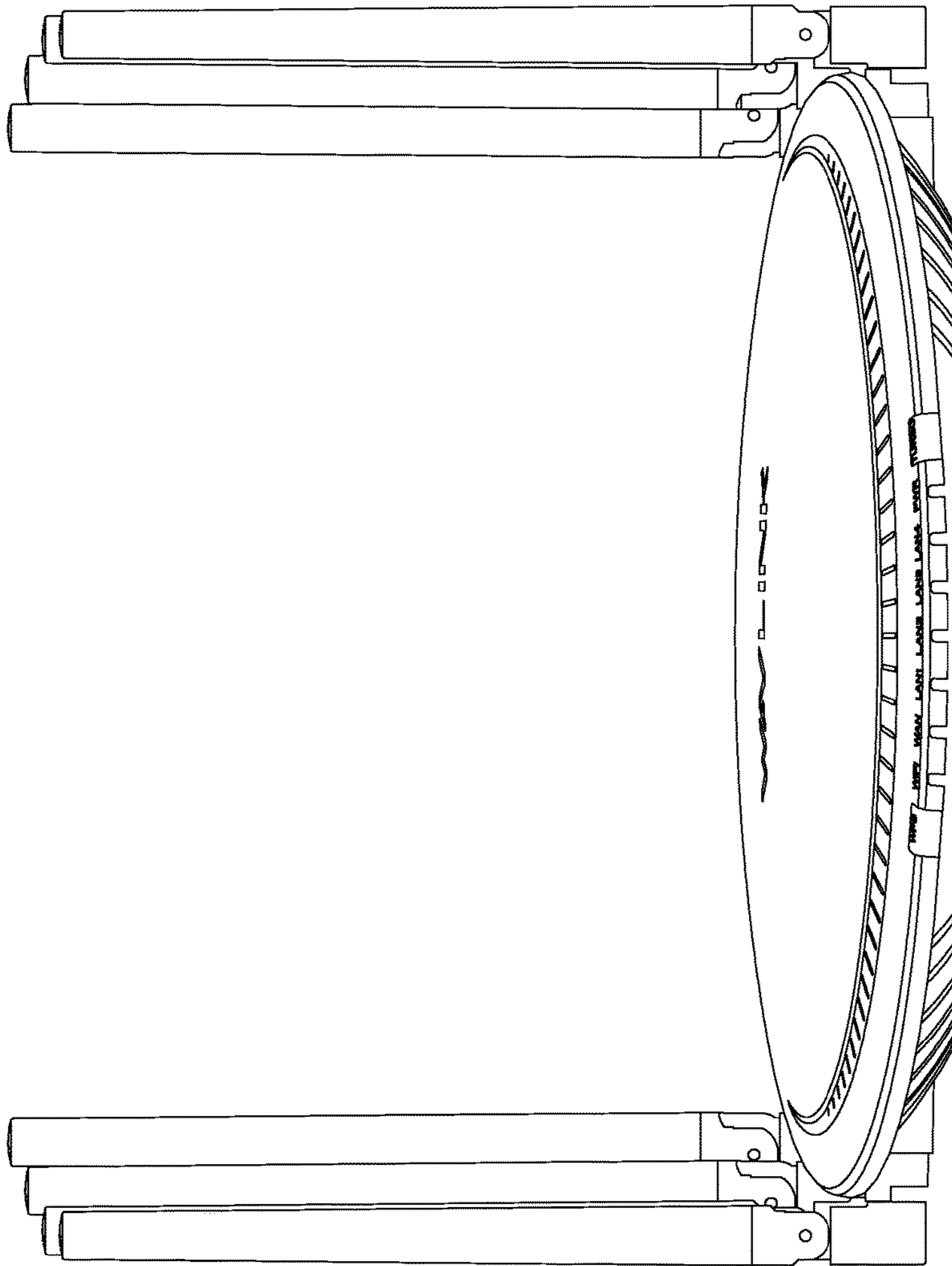

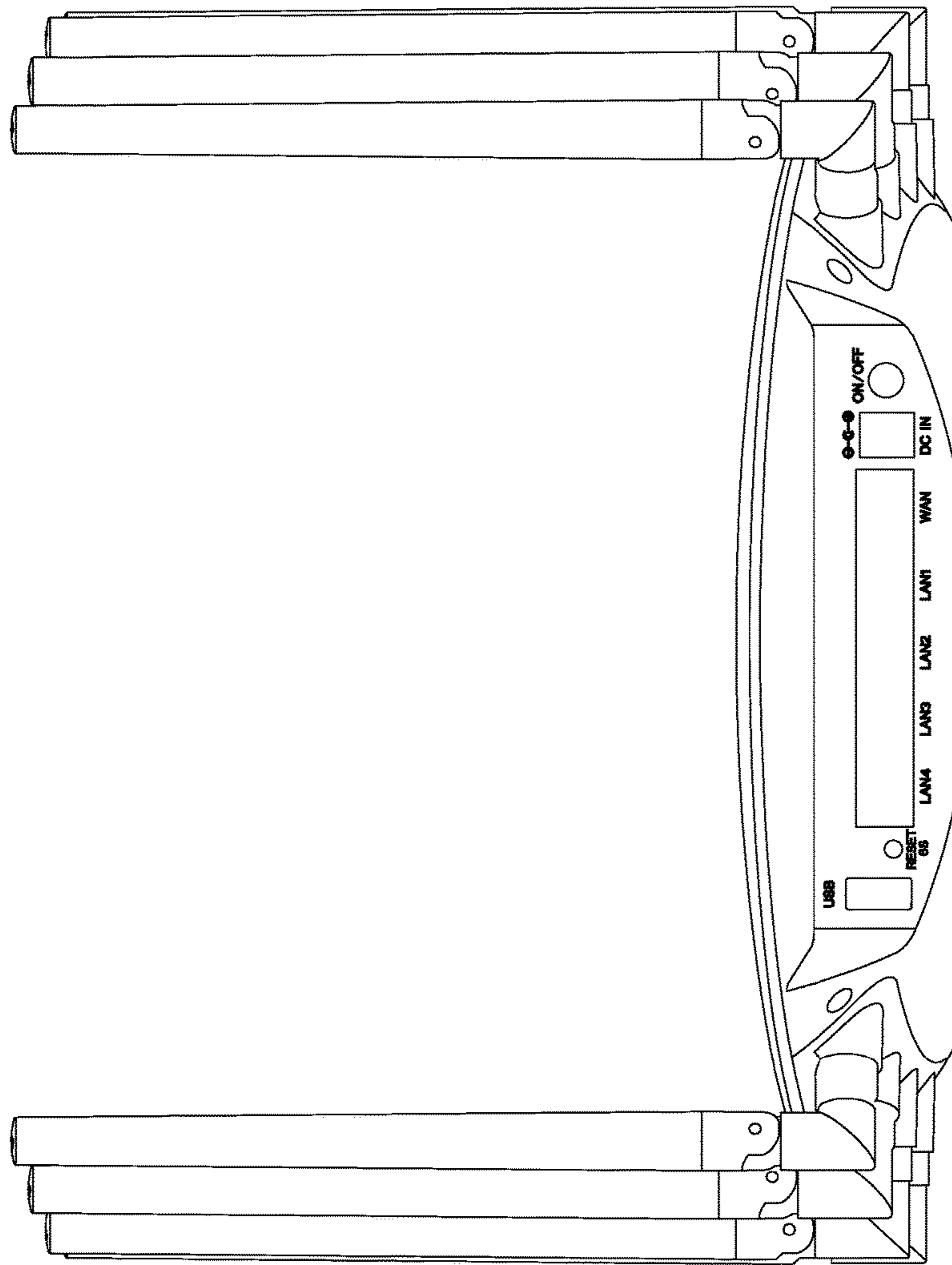

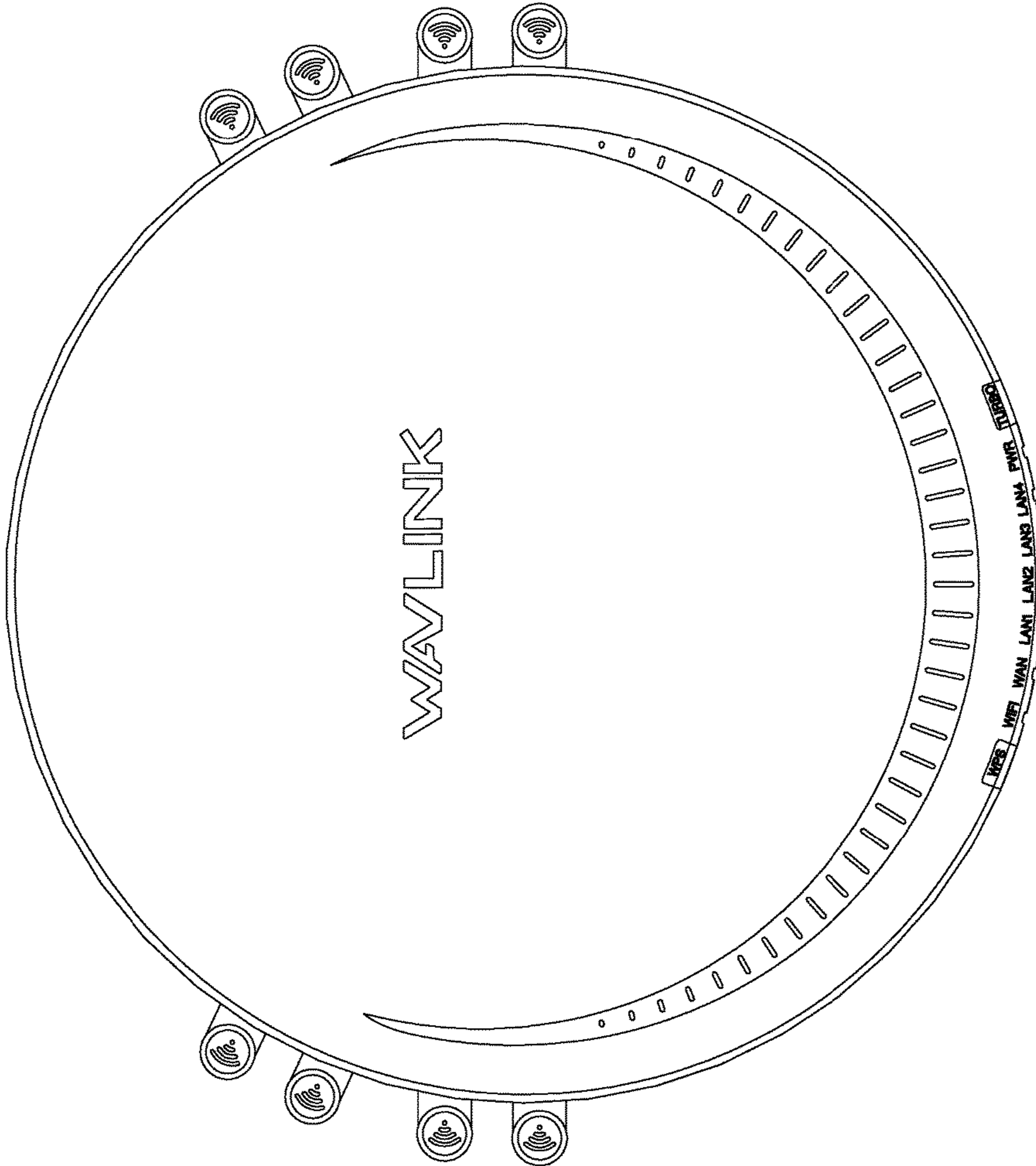

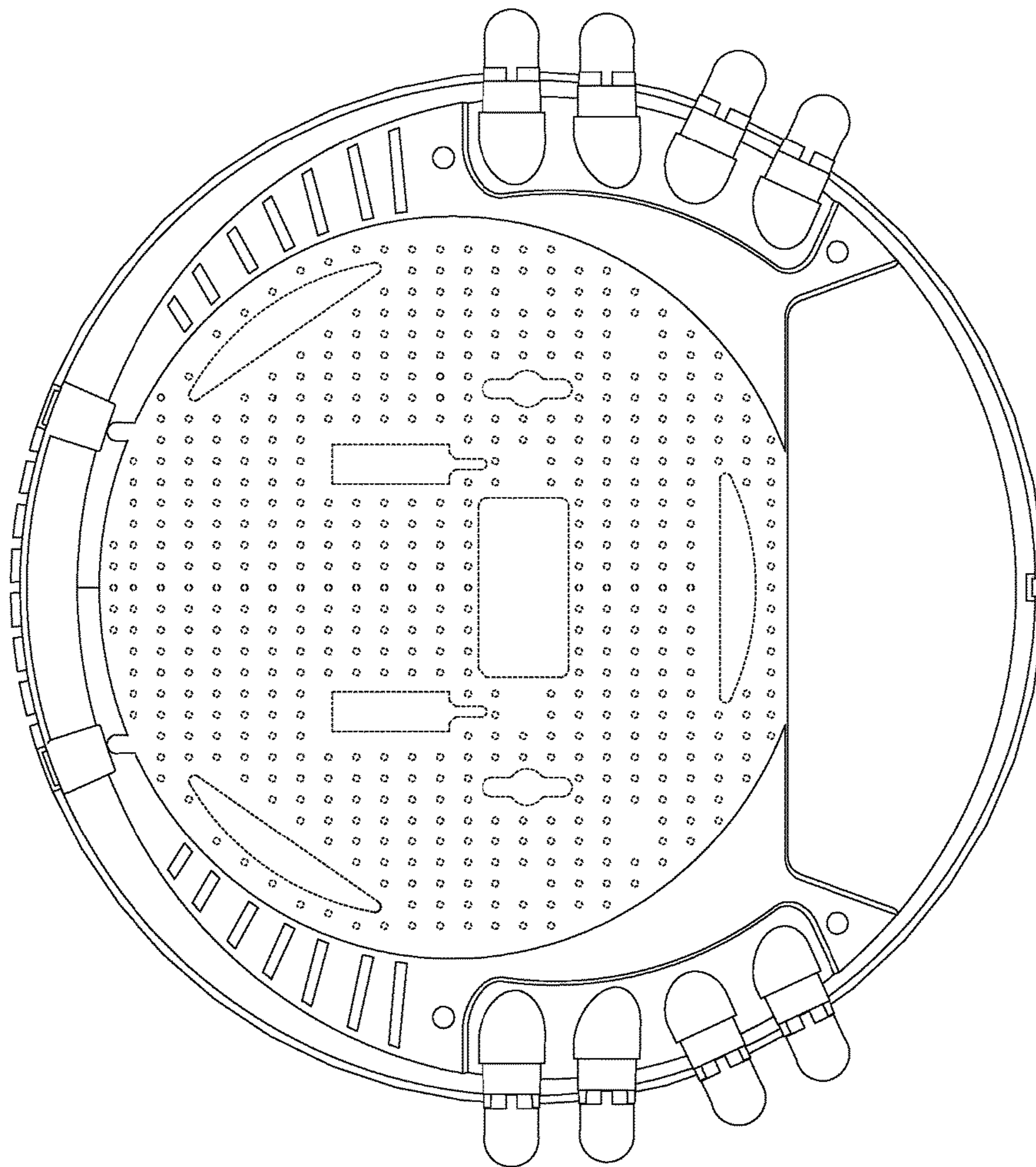

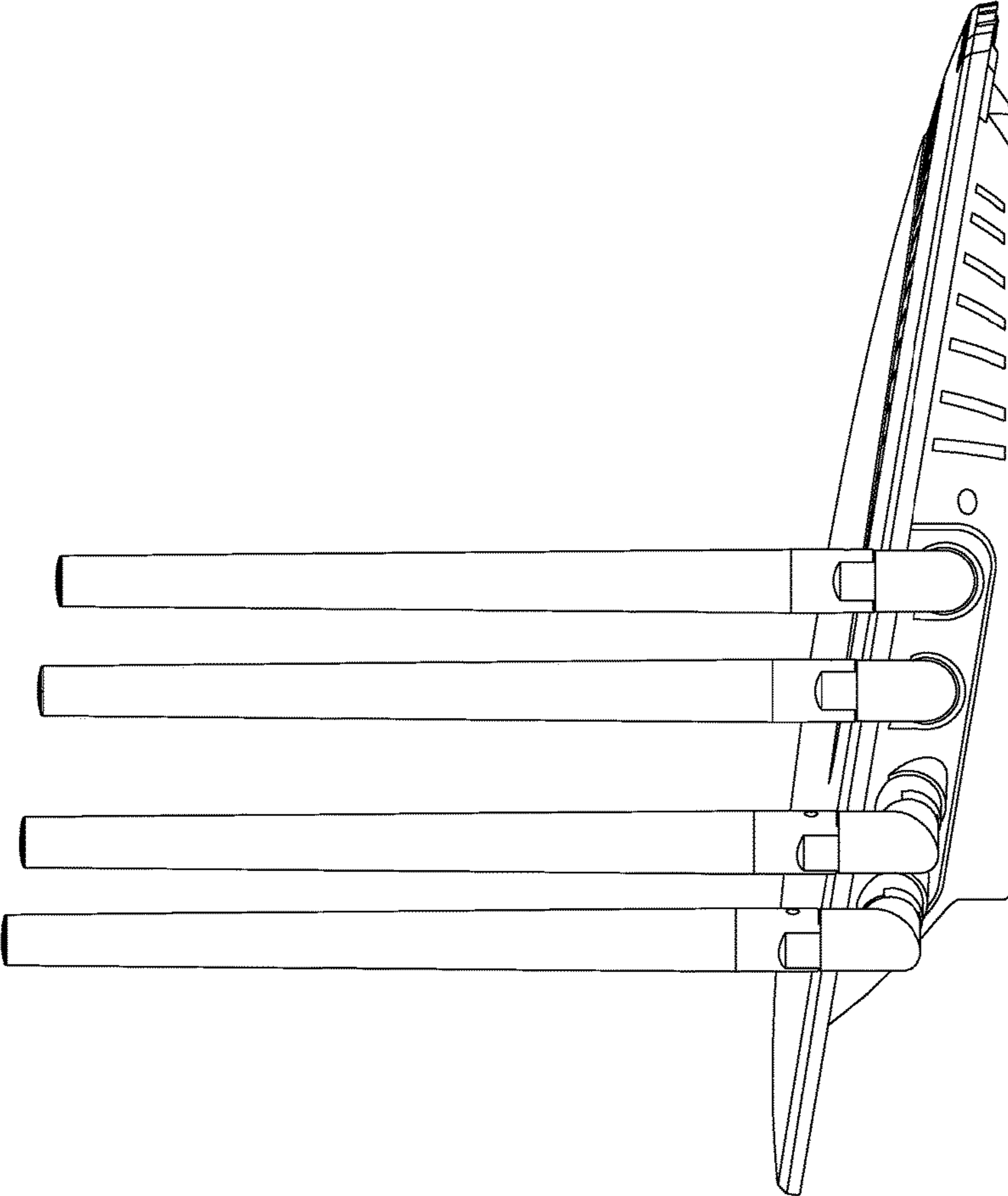

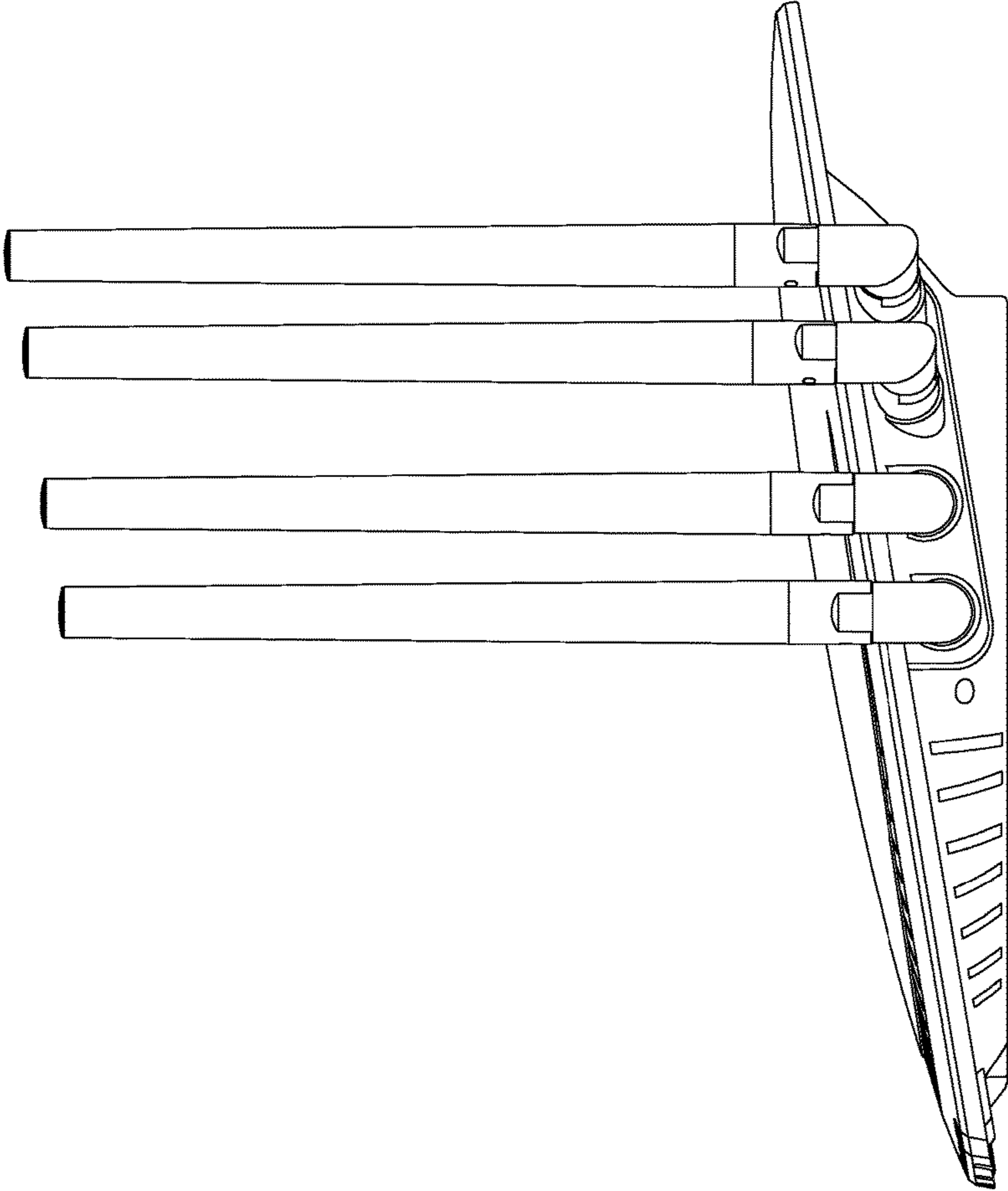
