FIG. 4 front side elevation view of FIG. 1.

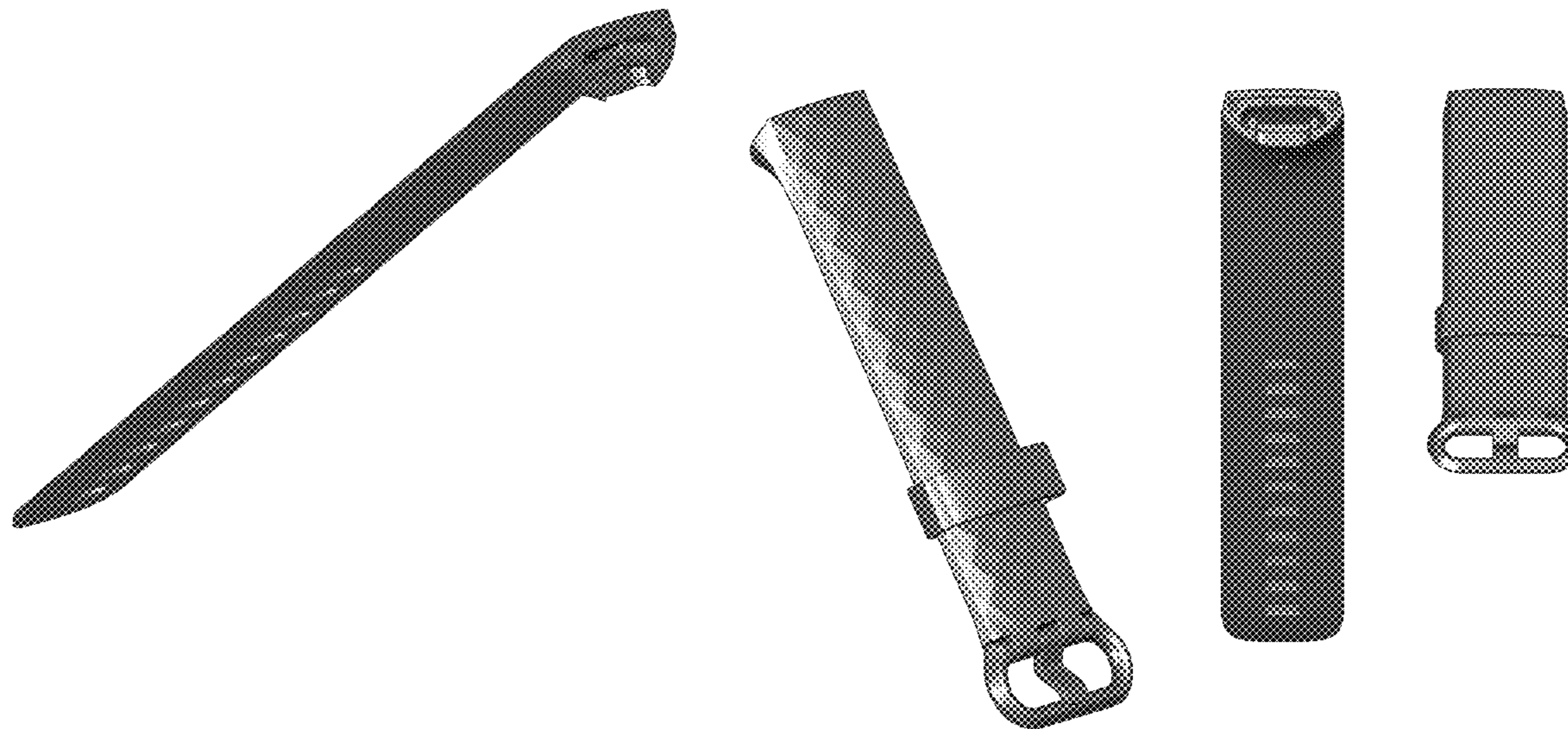
FIG. 5 is a back side elevation view of FIG. 1.

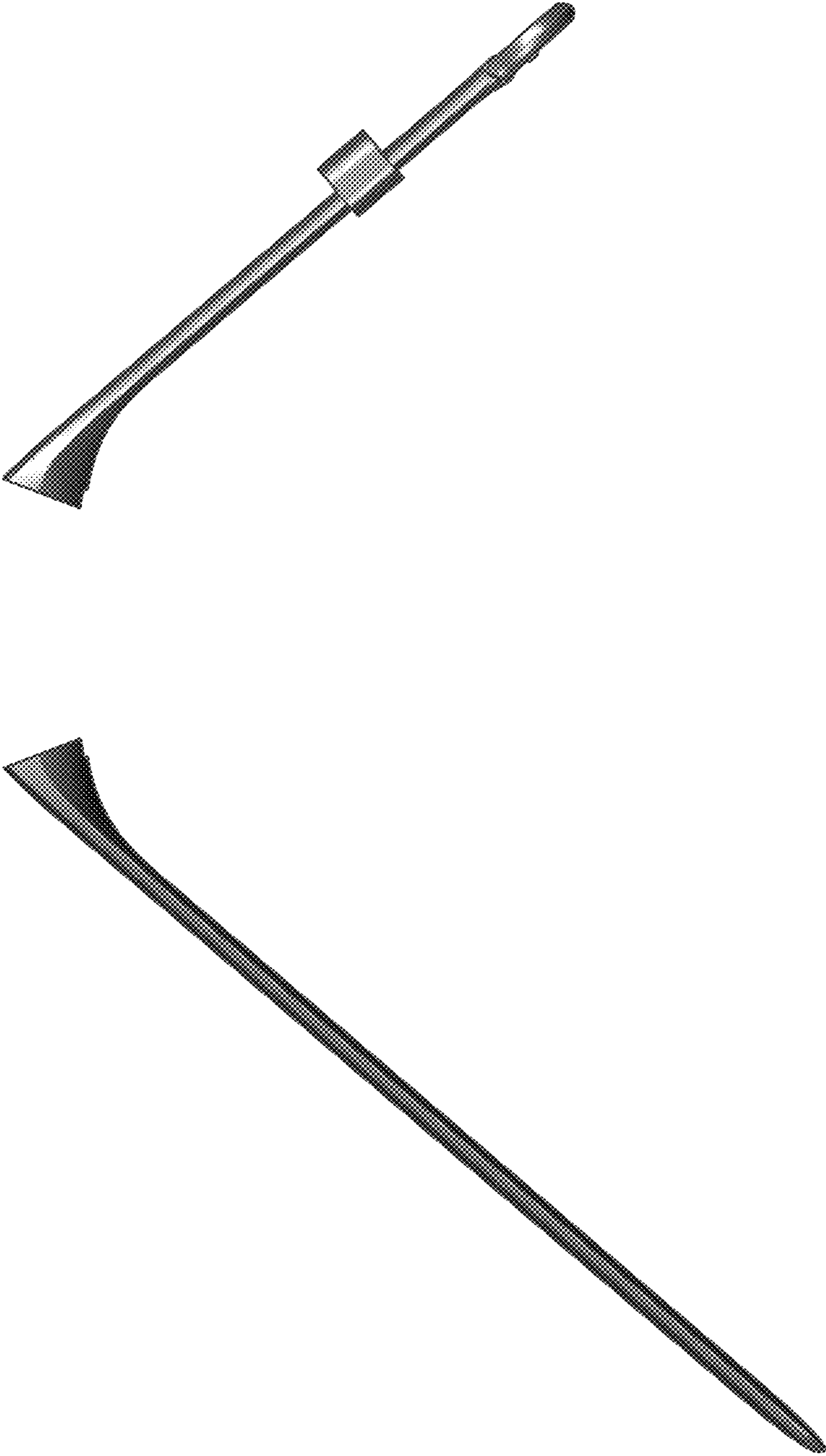

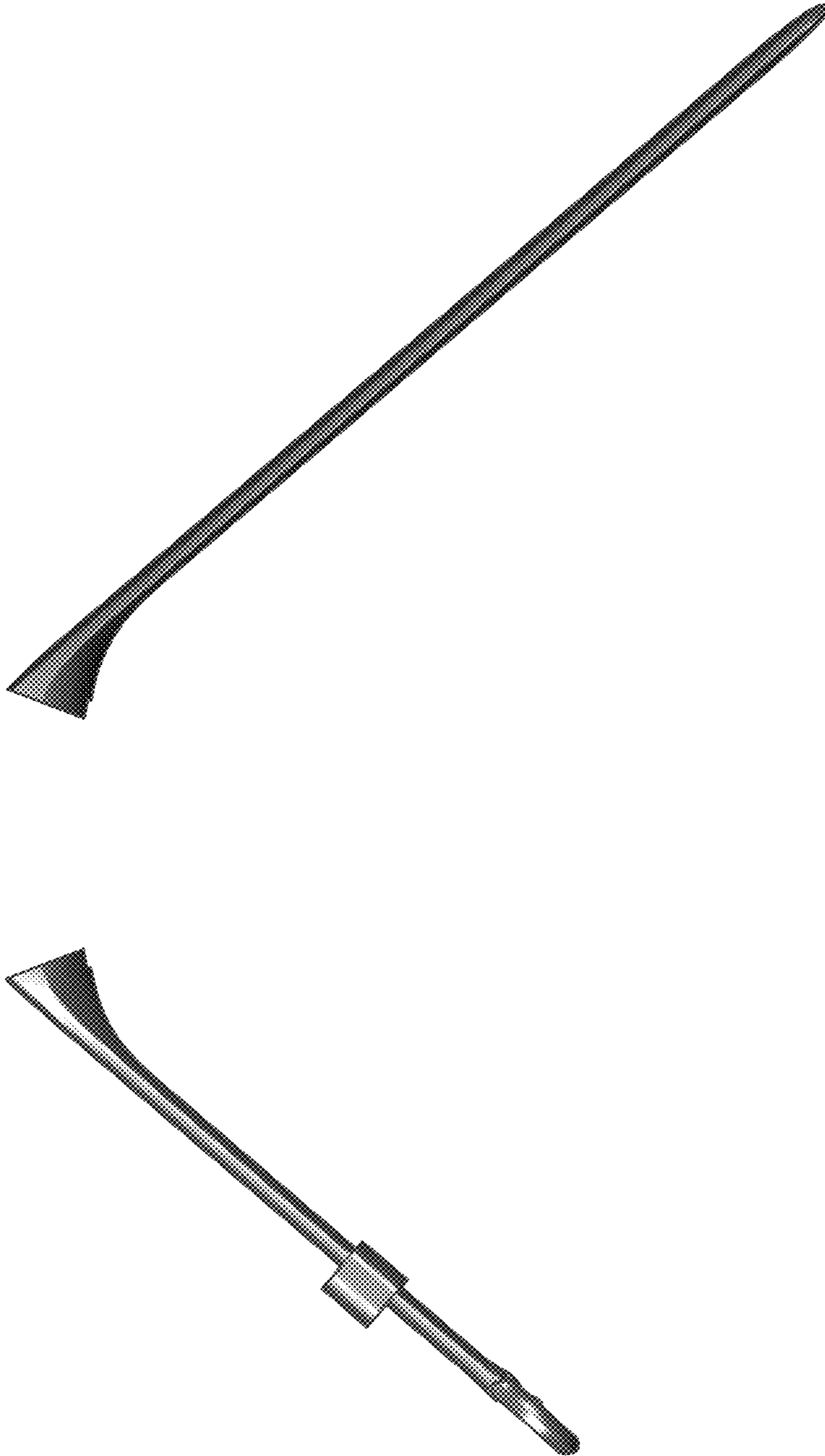

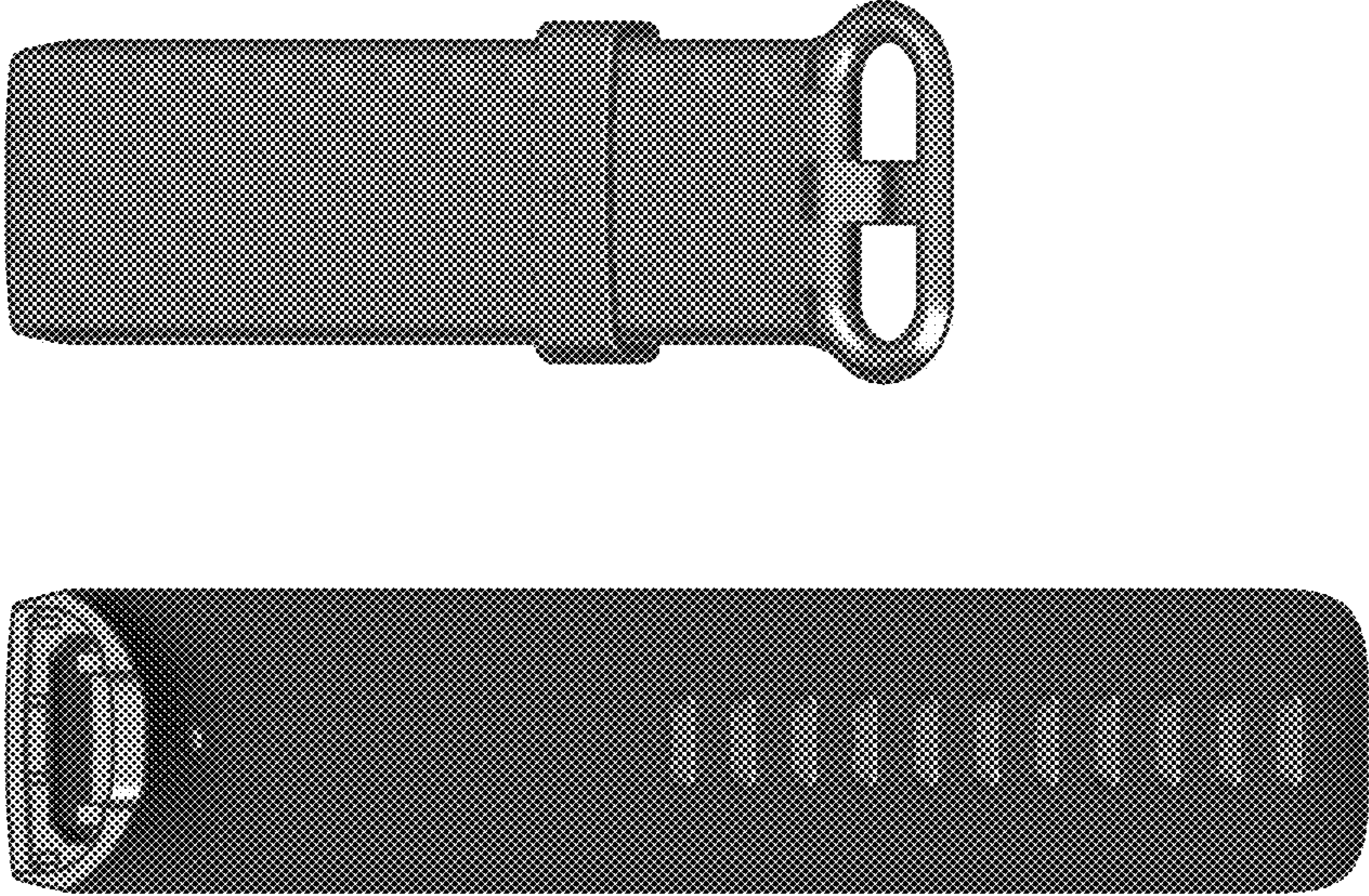

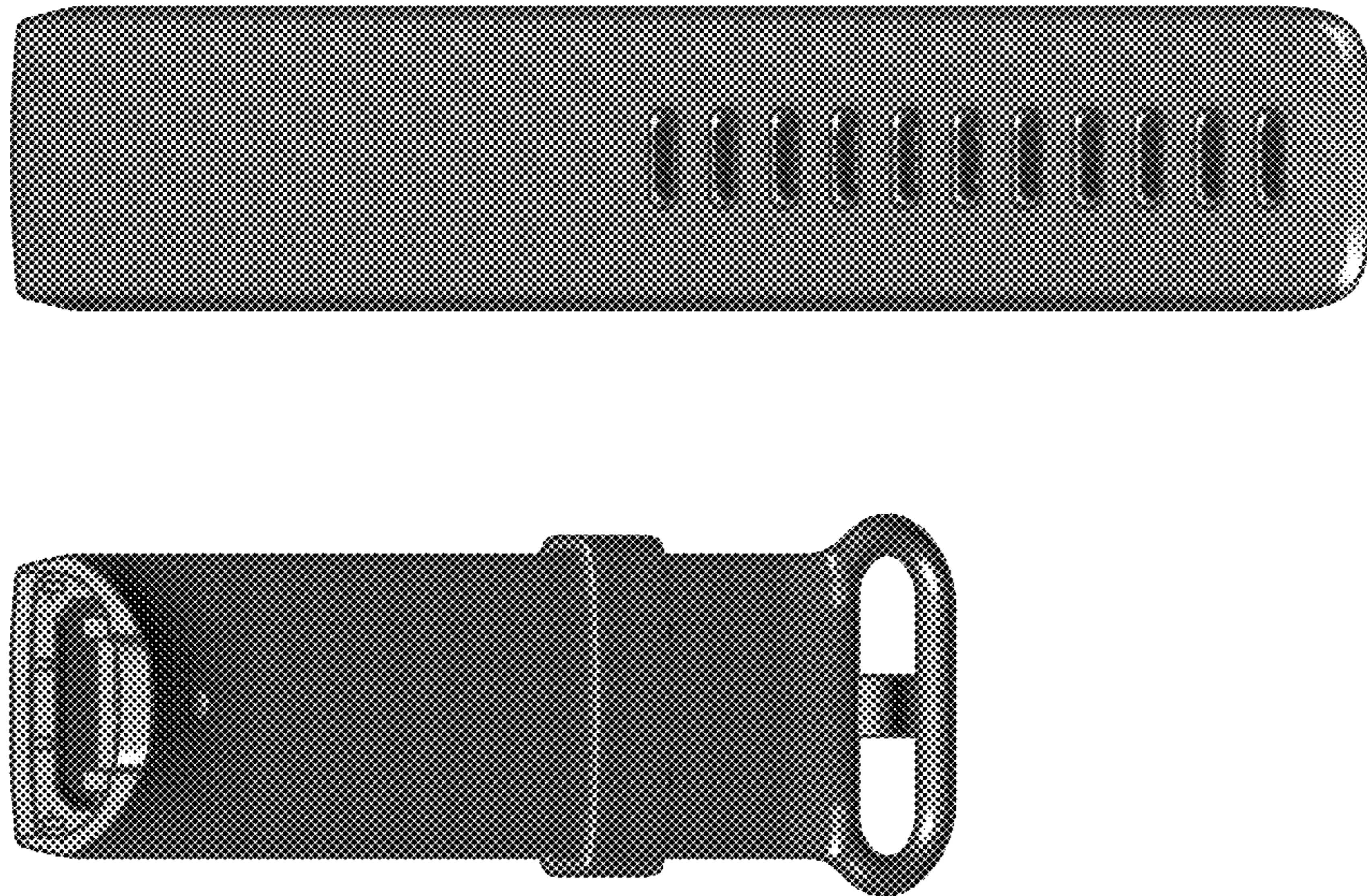

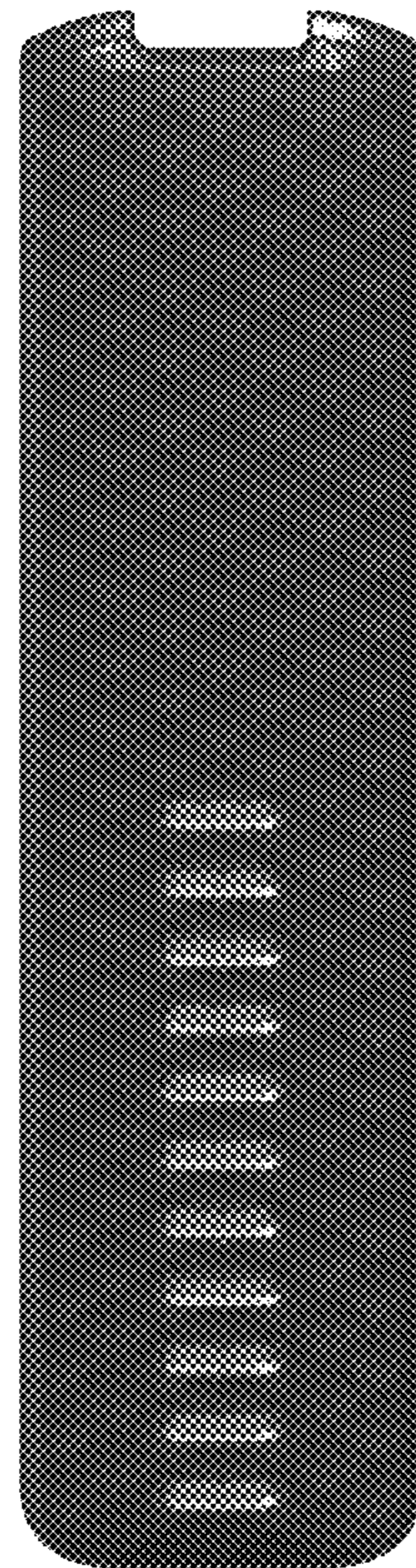
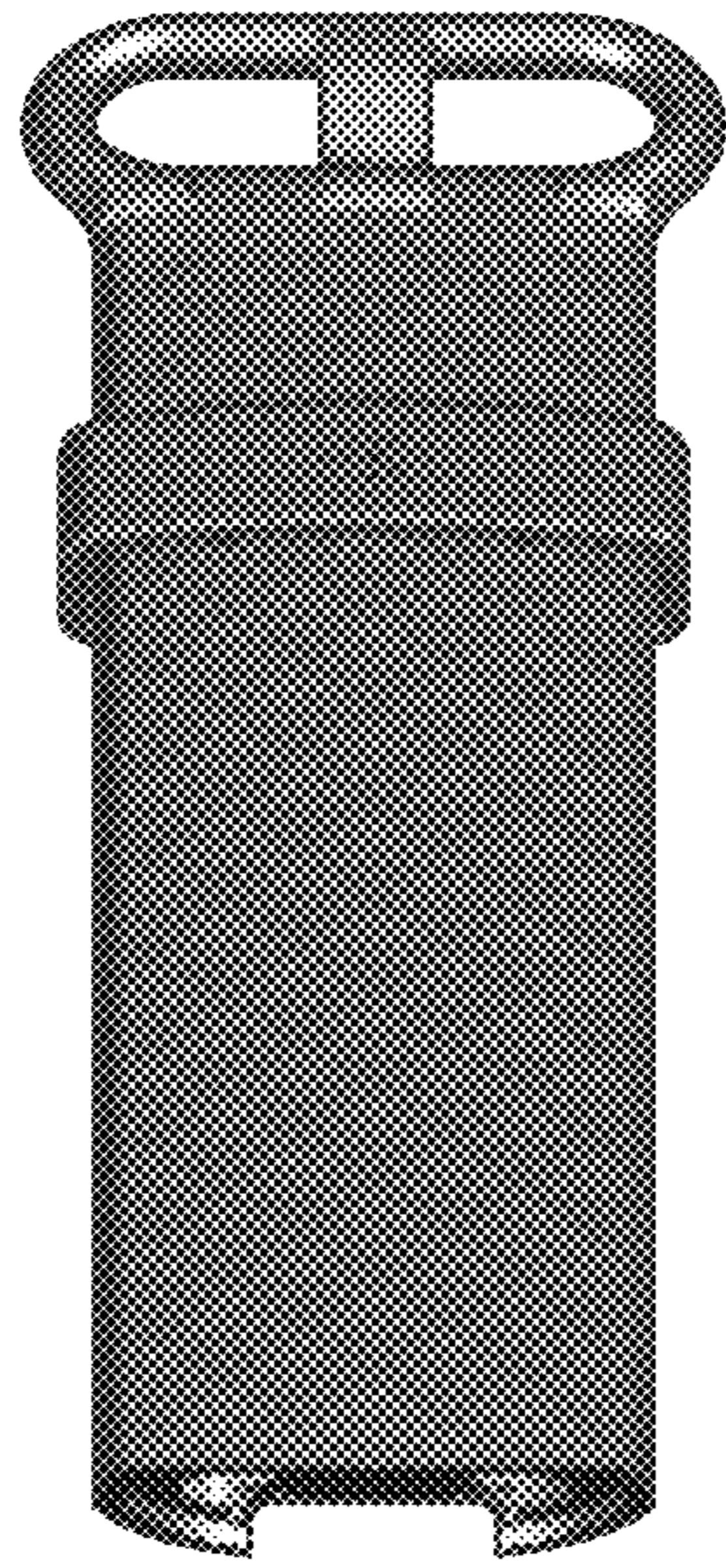

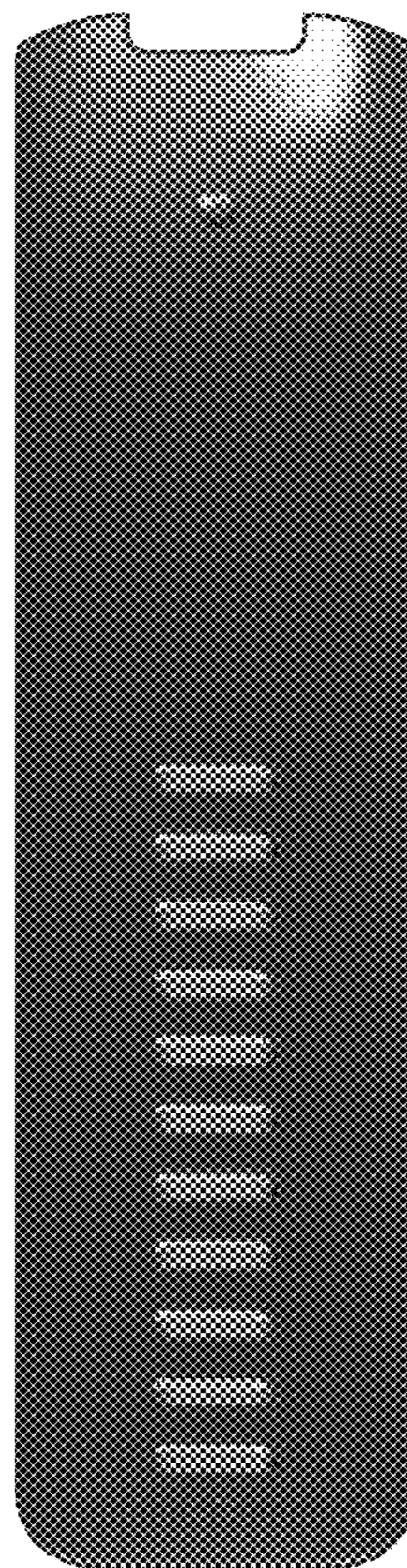
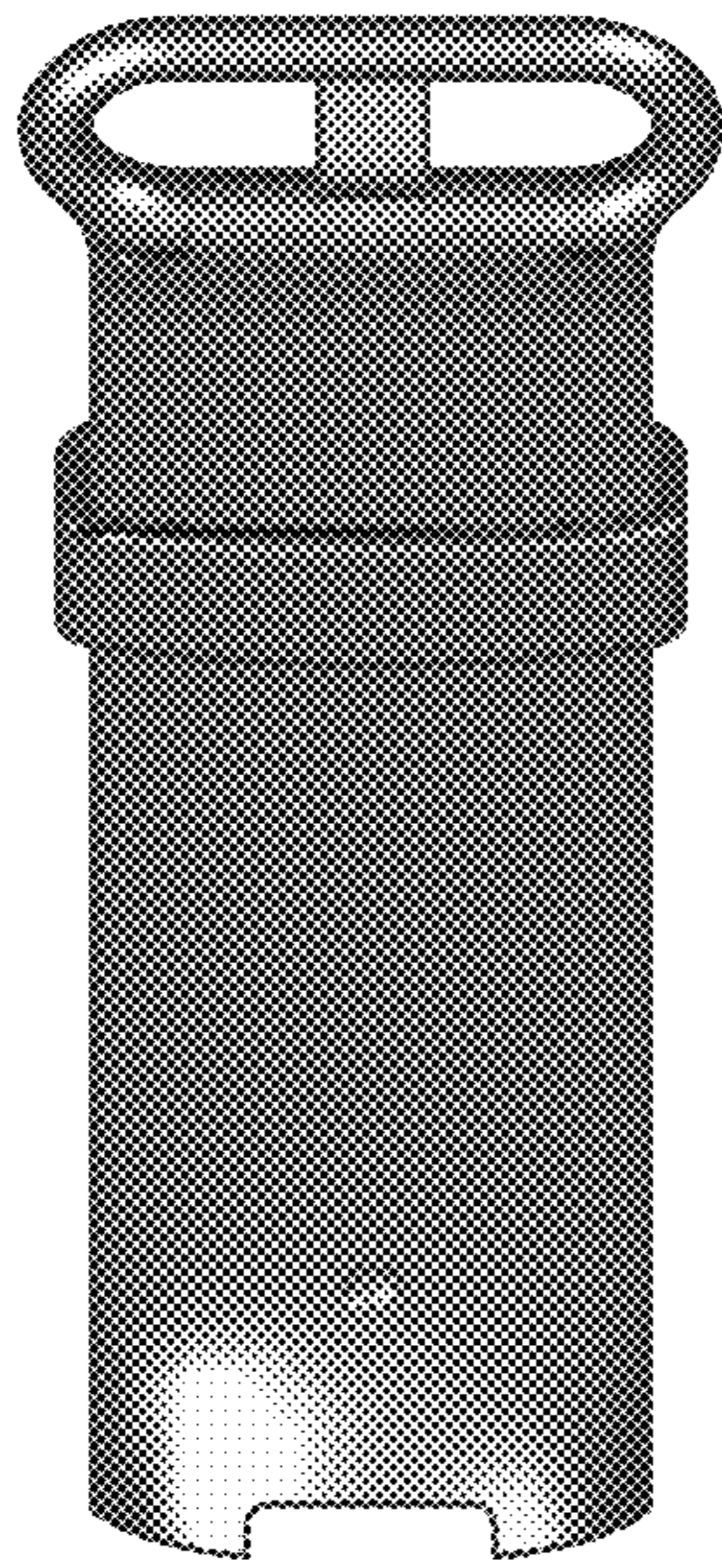
