(57) **CLAIM**

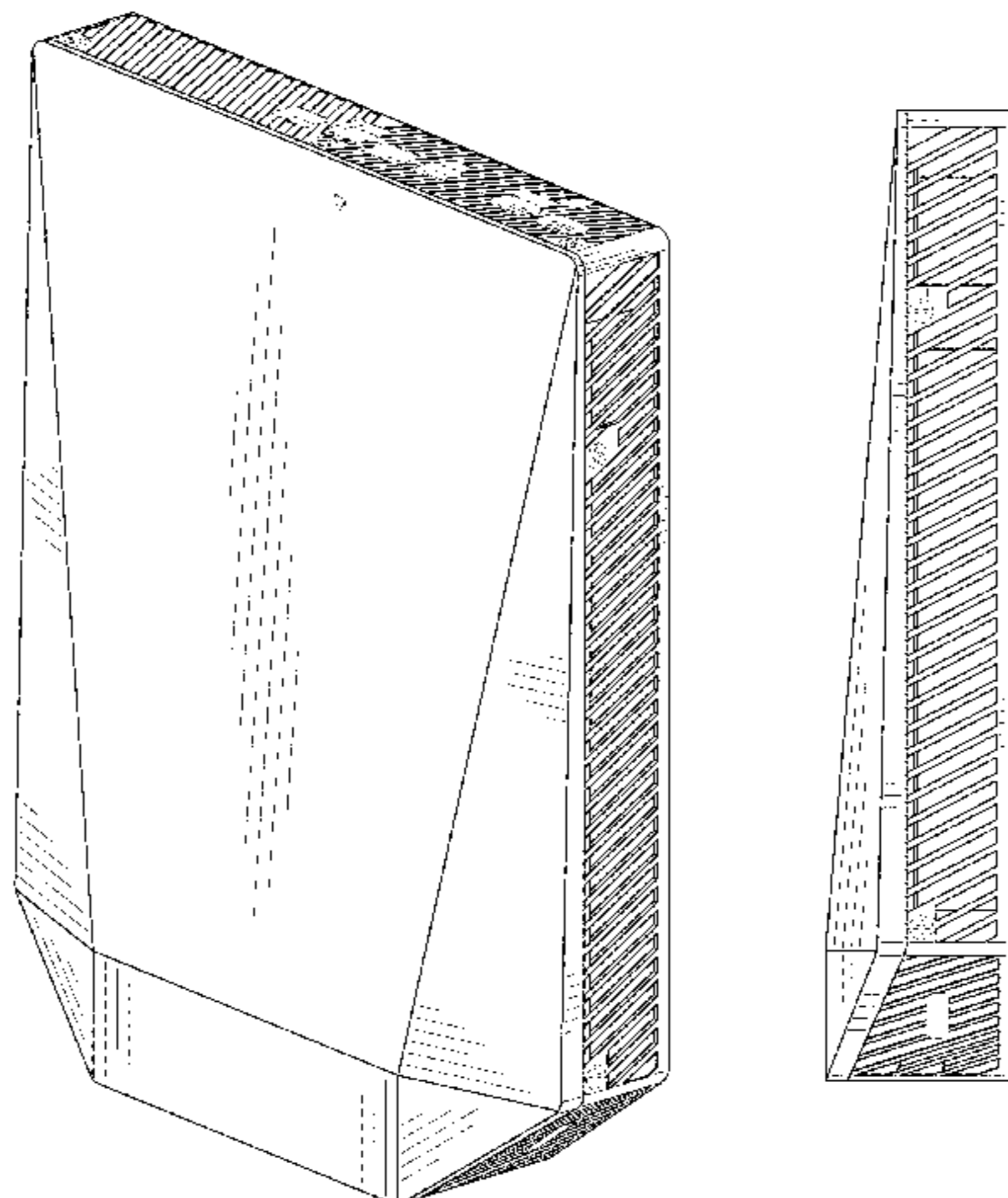
The ornamental design for a computing component for a wearable device, as shown and described.

DESCRIPTION

FIG. 1 is a top right perspective view of a computing component for a wearable device showing the new design; FIG. 2 is a top view thereof; FIG. 3 is a bottom view thereof; FIG. 4 is a right-side view thereof; FIG. 5 is a left-side view thereof; FIG. 6 is a back view thereof; and, FIG. 7 is a front view of a front view thereof.

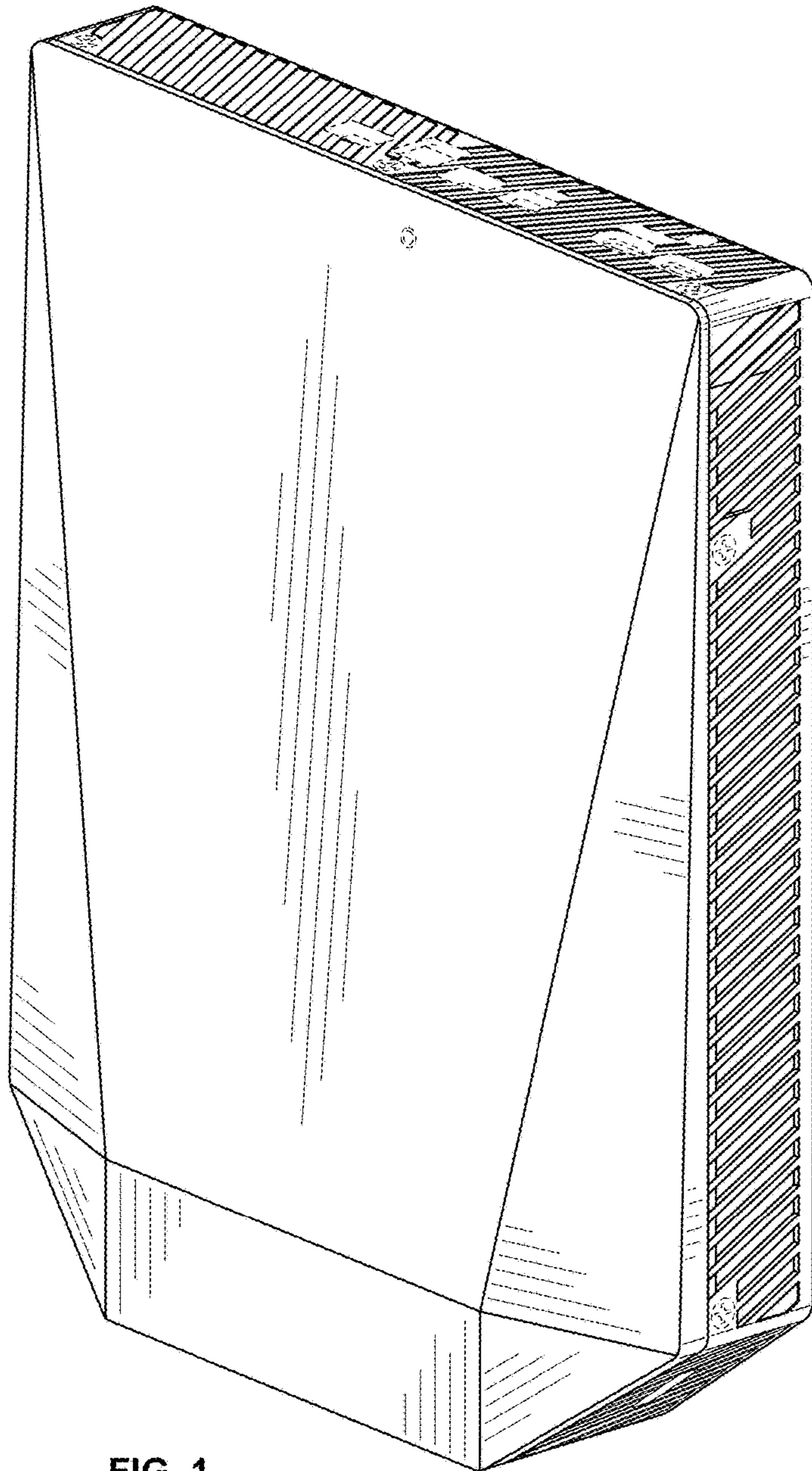

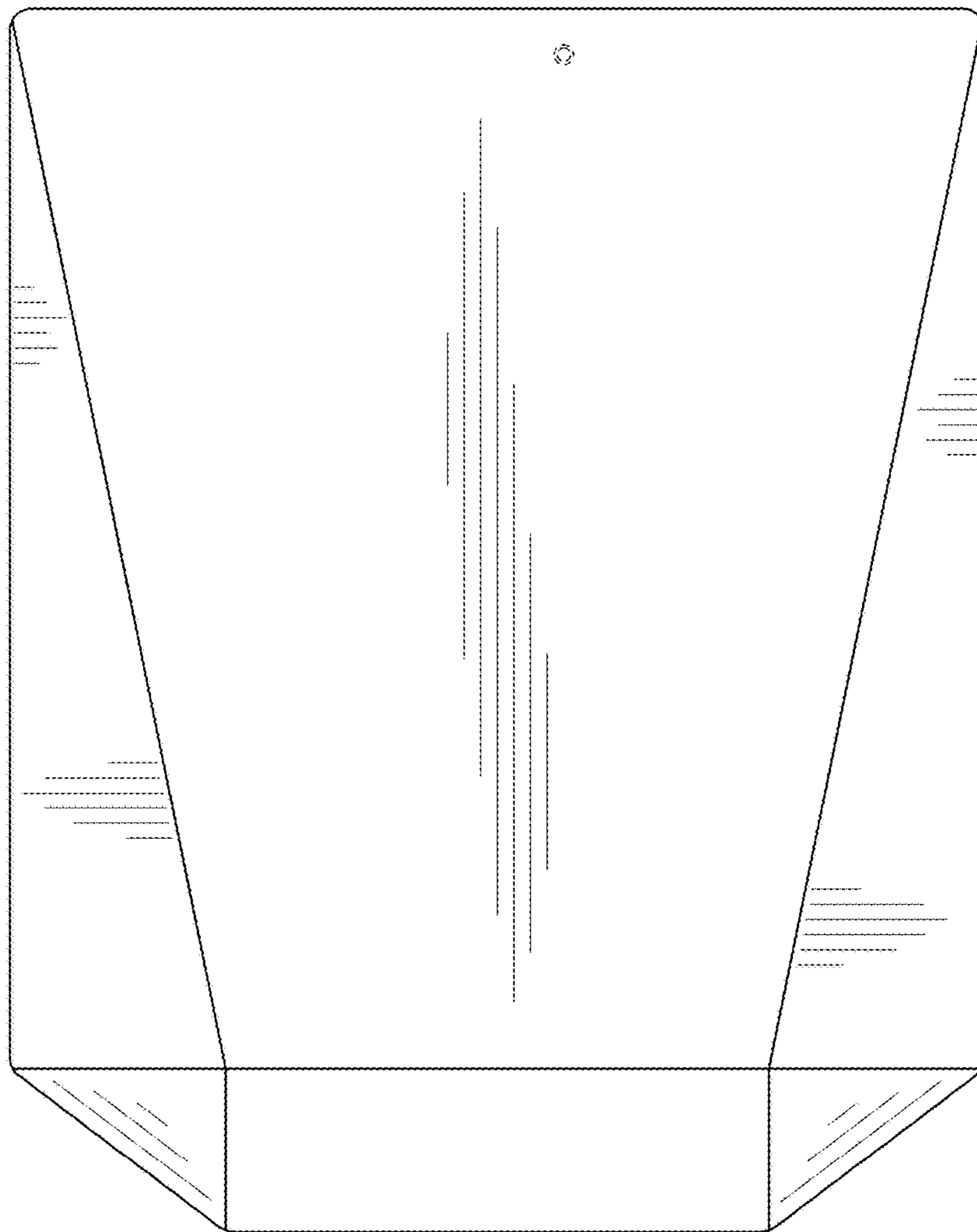

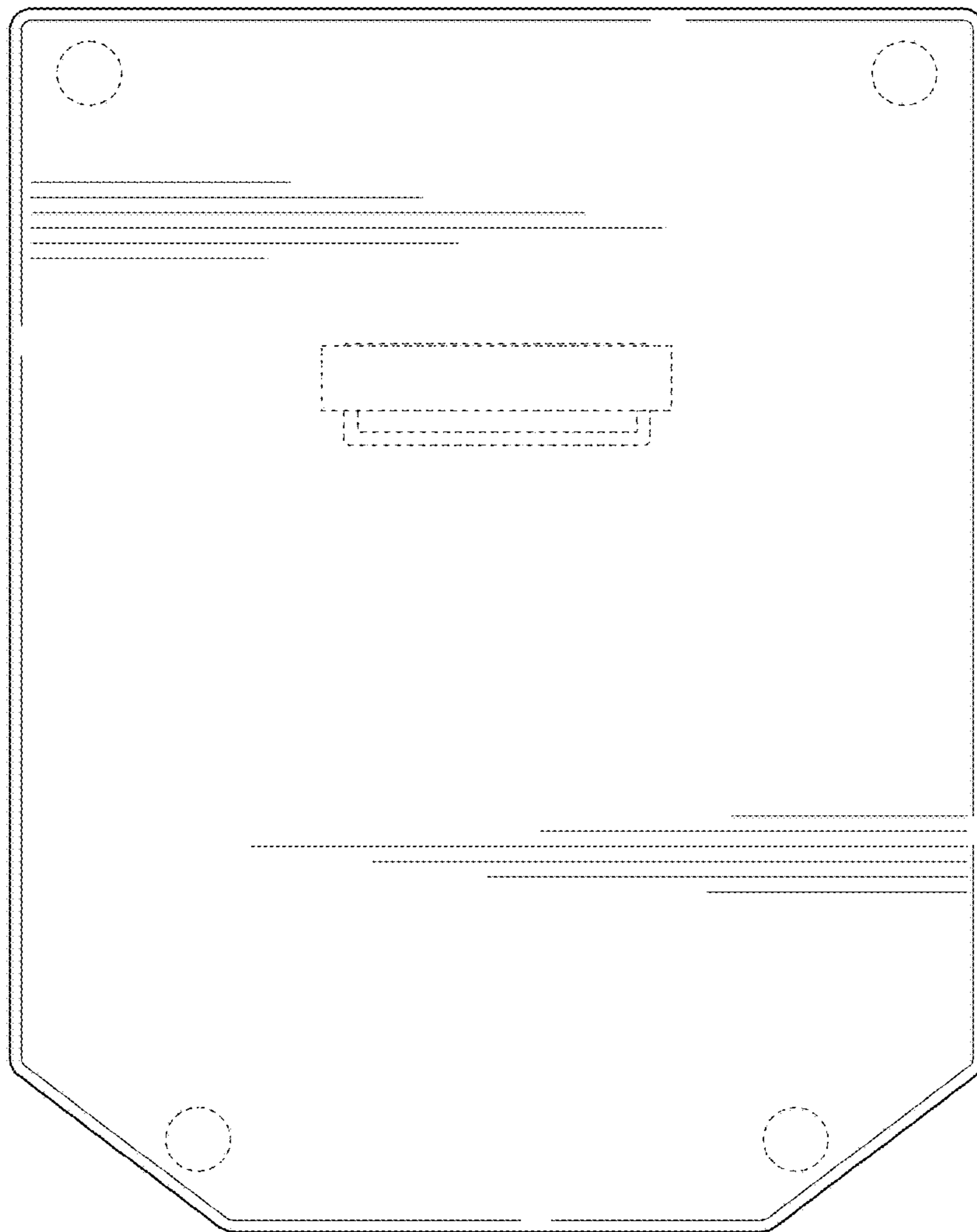

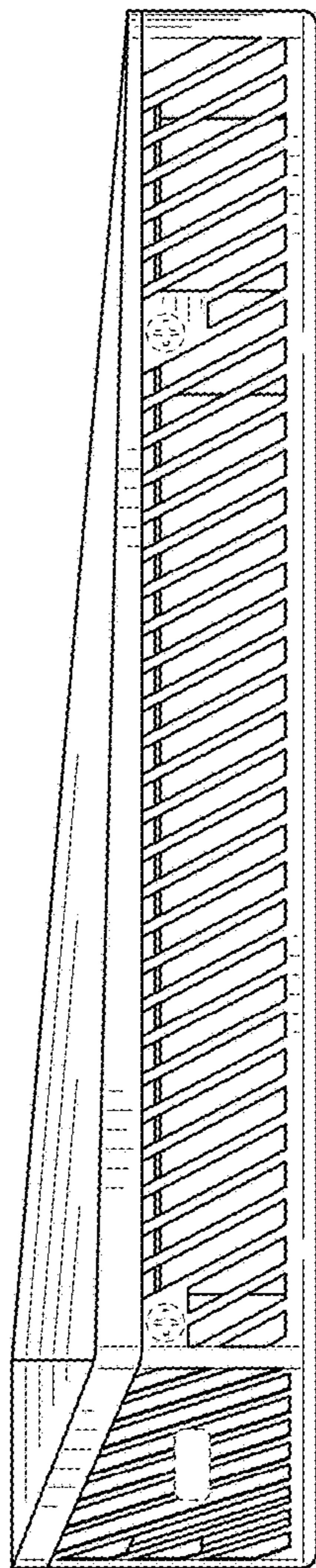

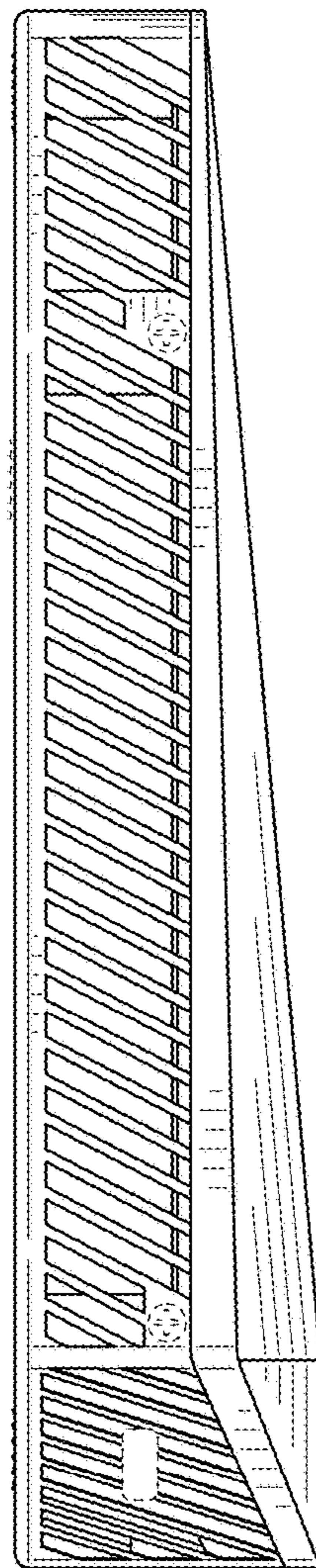

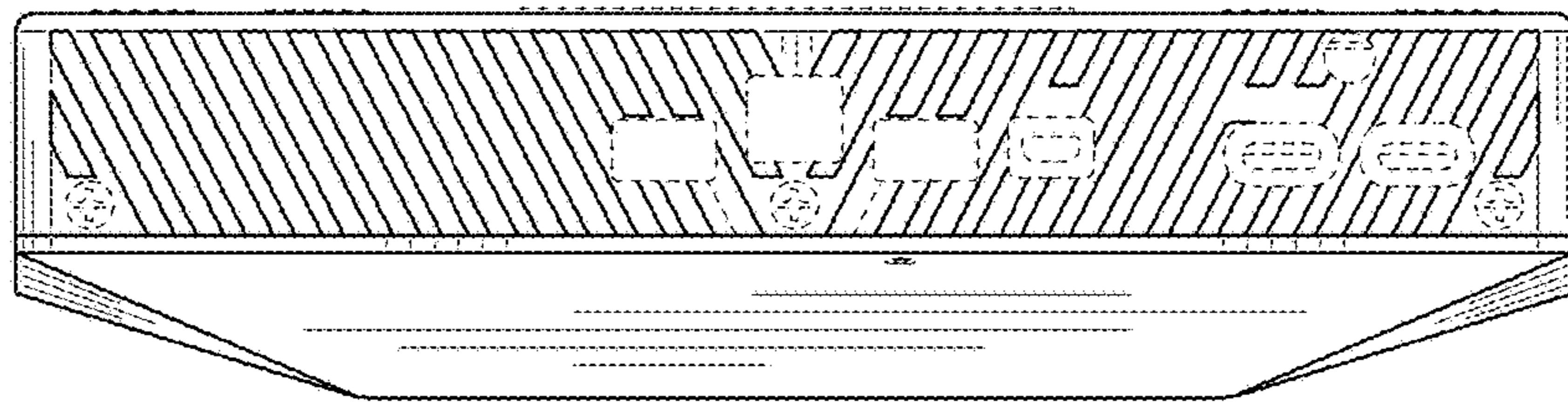

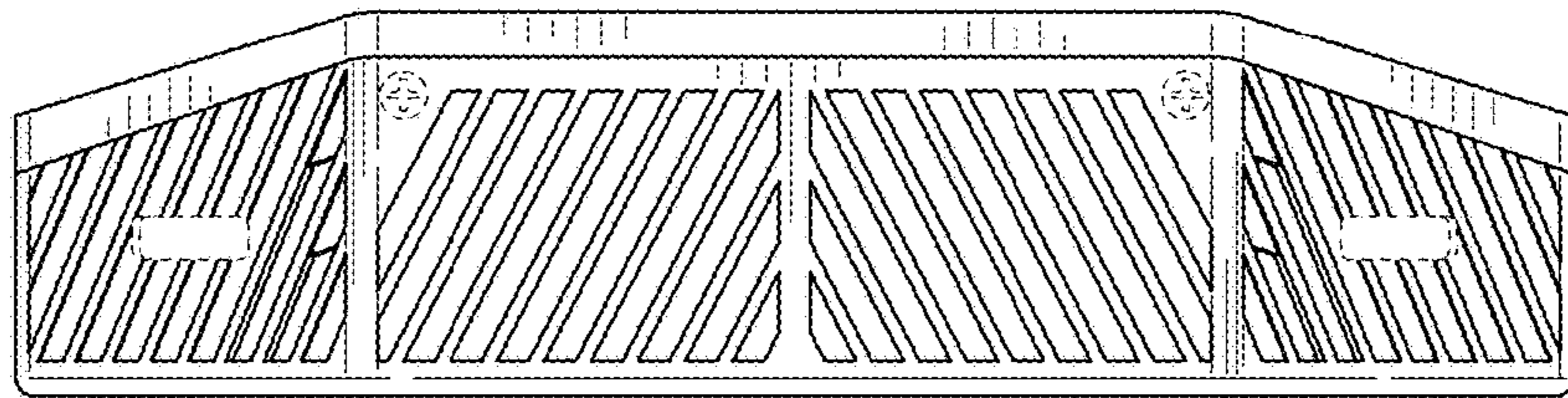
