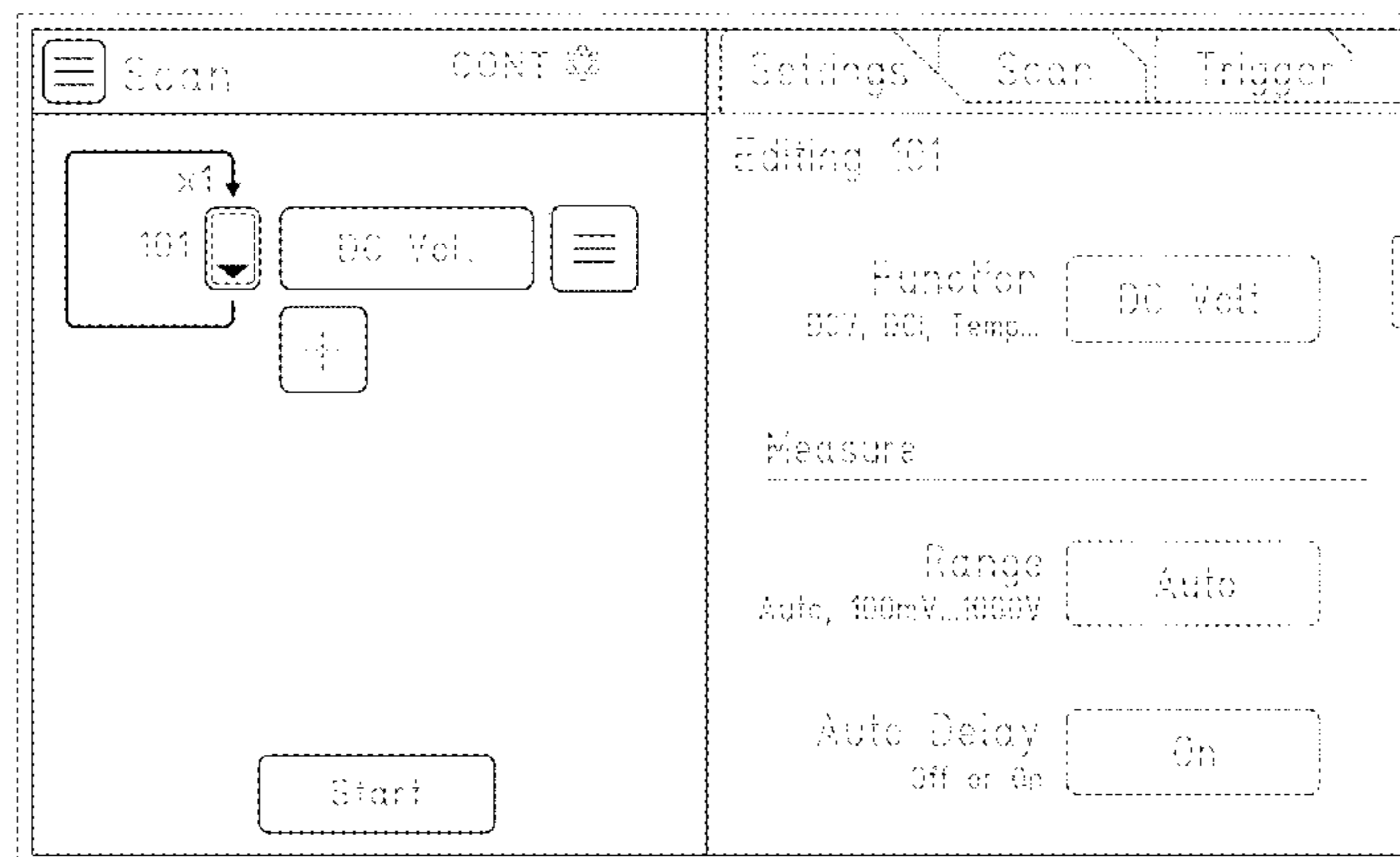
(57) **CLAIM**

The ornamental design for a display screen with a graphical user interface for a measurement device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen for a measurement device with a graphical user interface showing a first embodiment of our new design; FIG. 2 is a second embodiment thereof; FIG. 3 is a third embodiment thereof; FIG. 4 is a fourth embodiment thereof; FIG. 5 is a fifth embodiment thereof; FIG. 6 is a sixth embodiment thereof; and, FIG. 7 is a seventh embodiment thereof. The linear broken lines shown in the drawings illustrate portions of the display screen with a graphical user interface that forms no part of the claimed design.

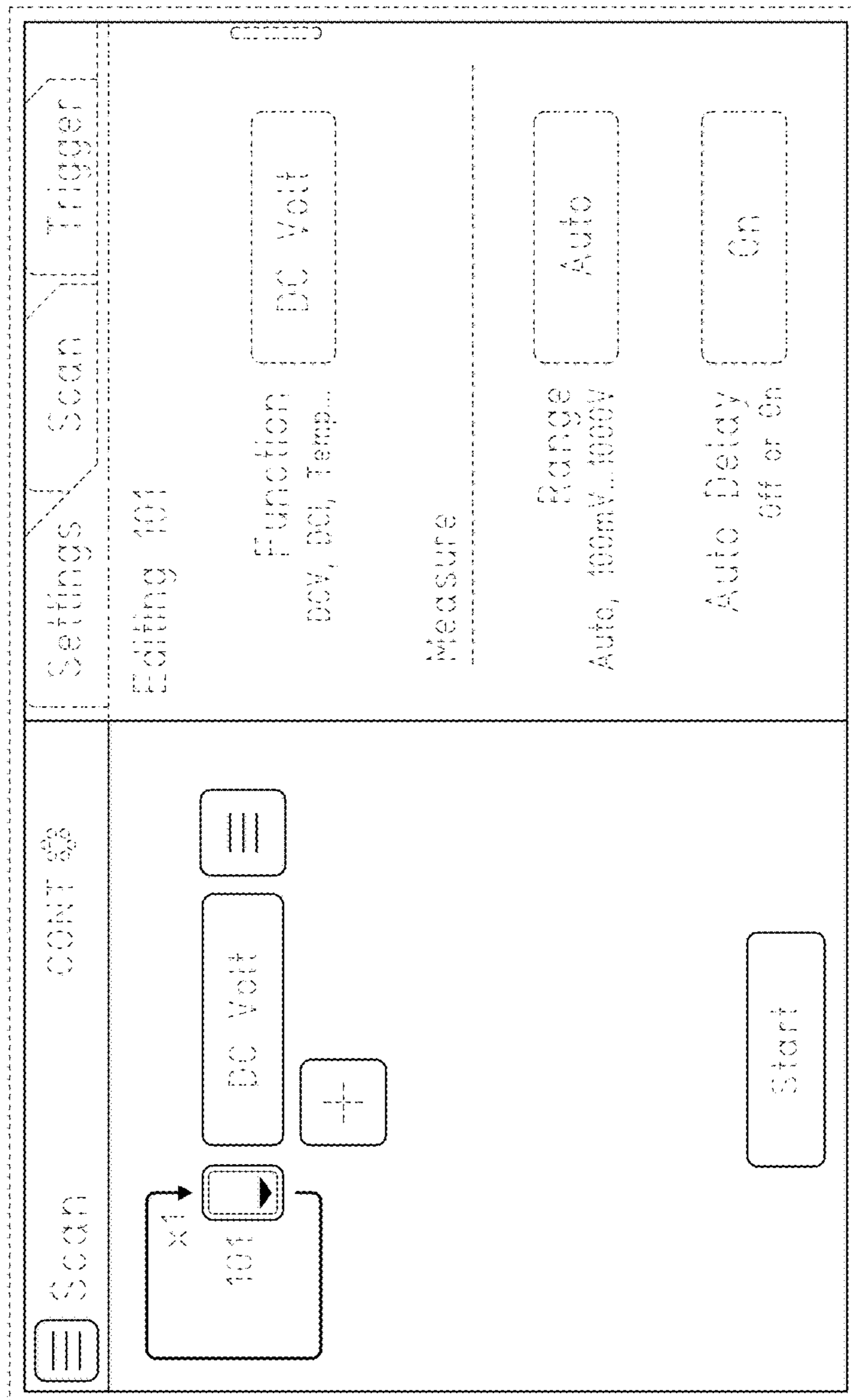

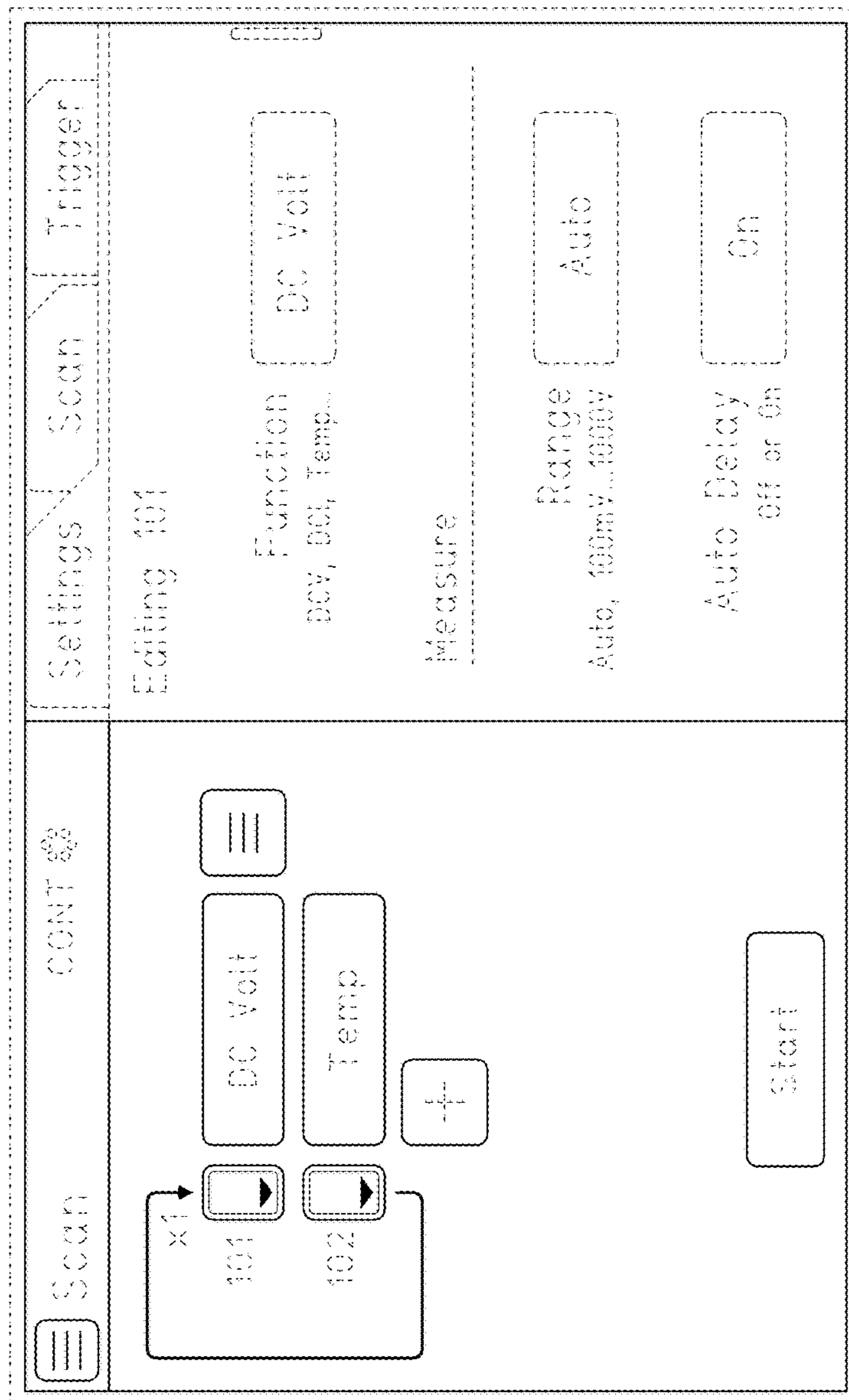

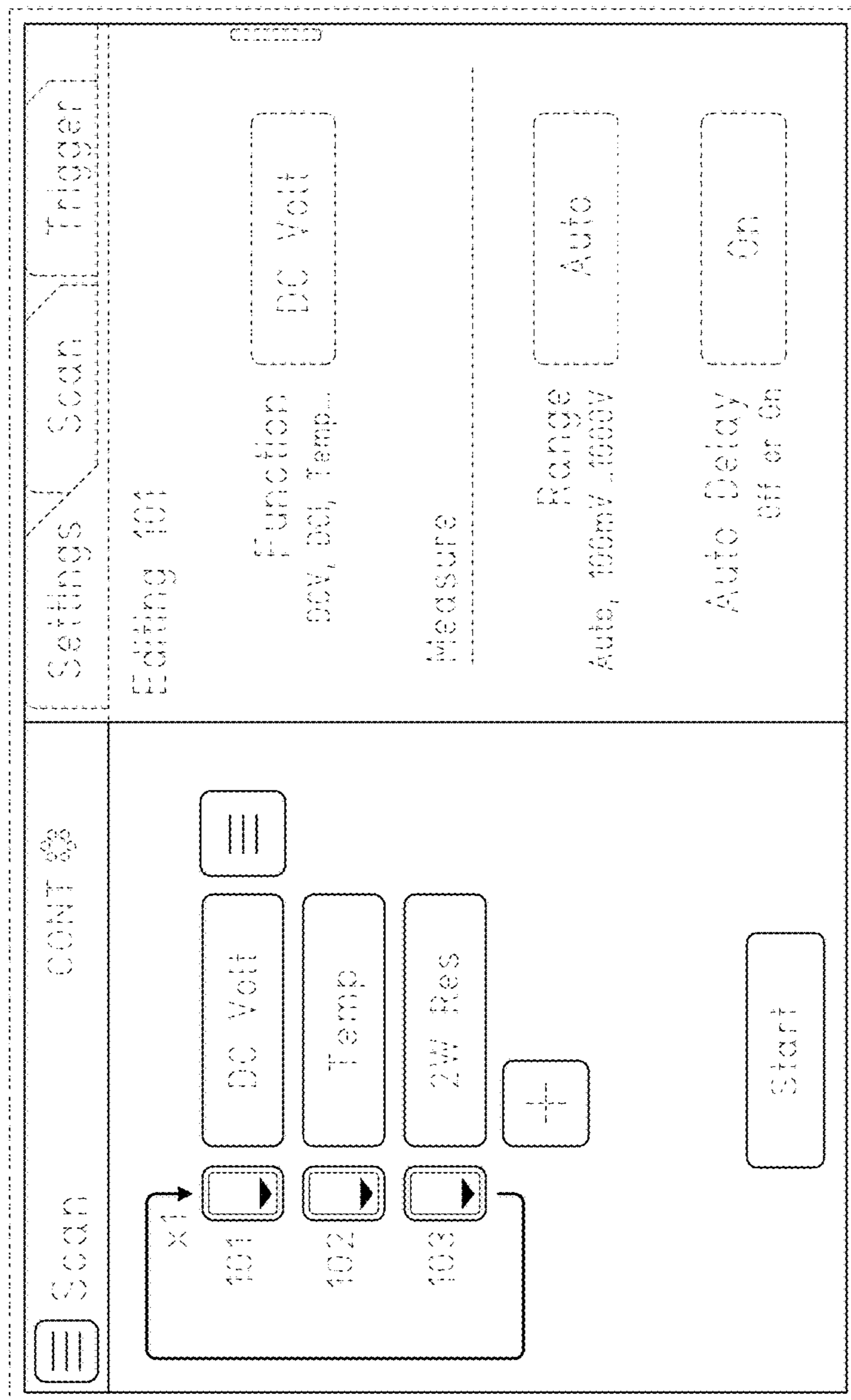

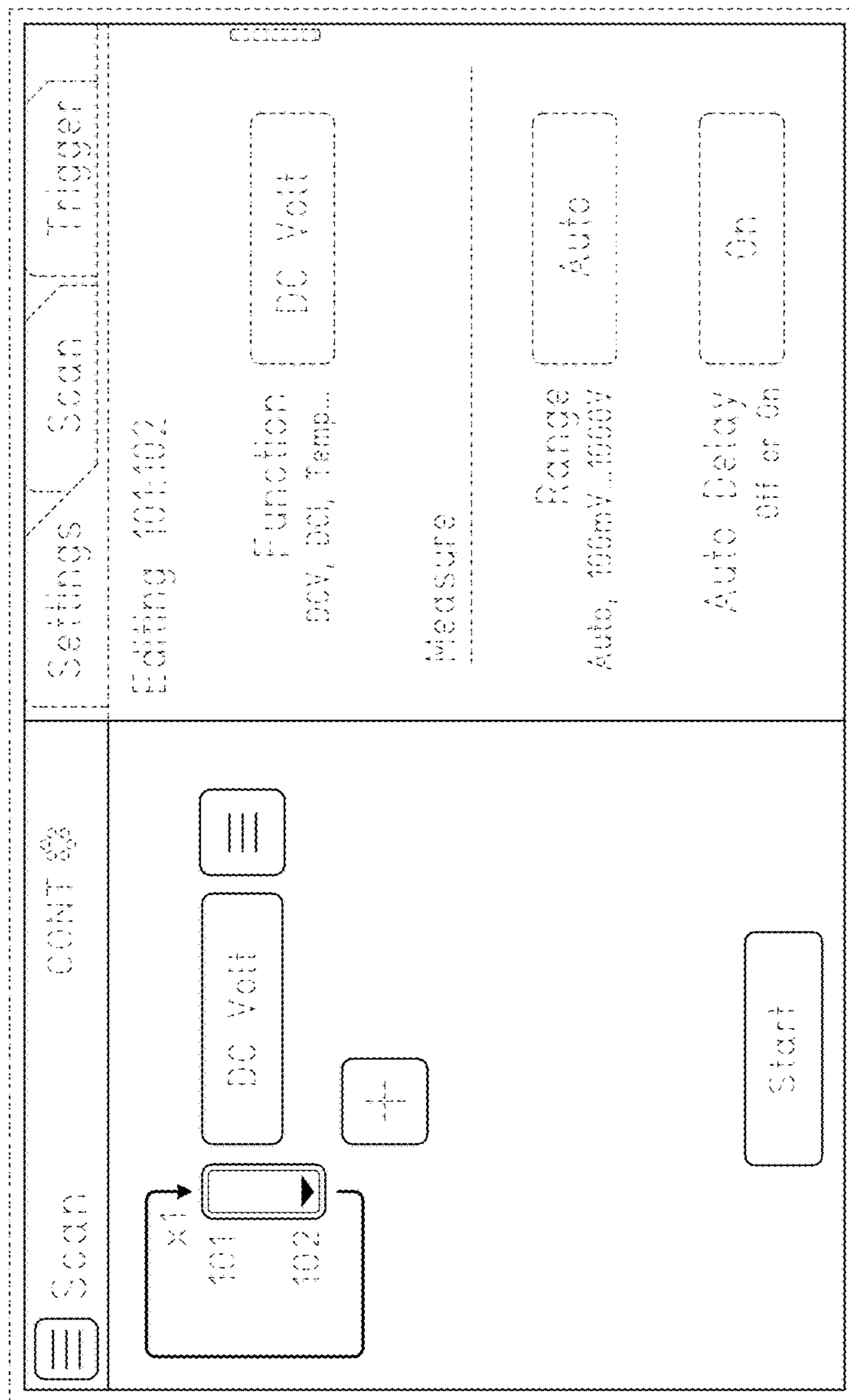

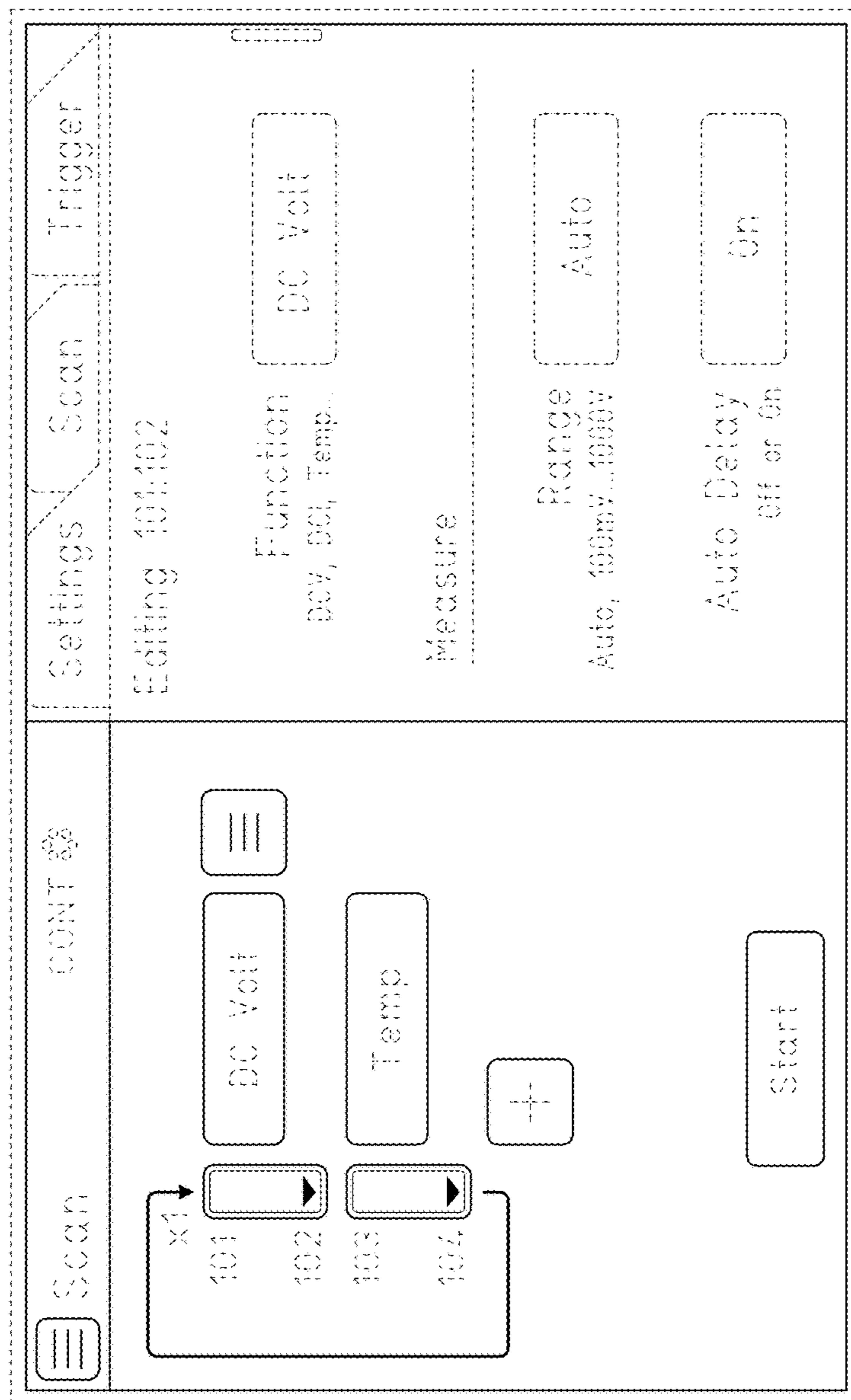

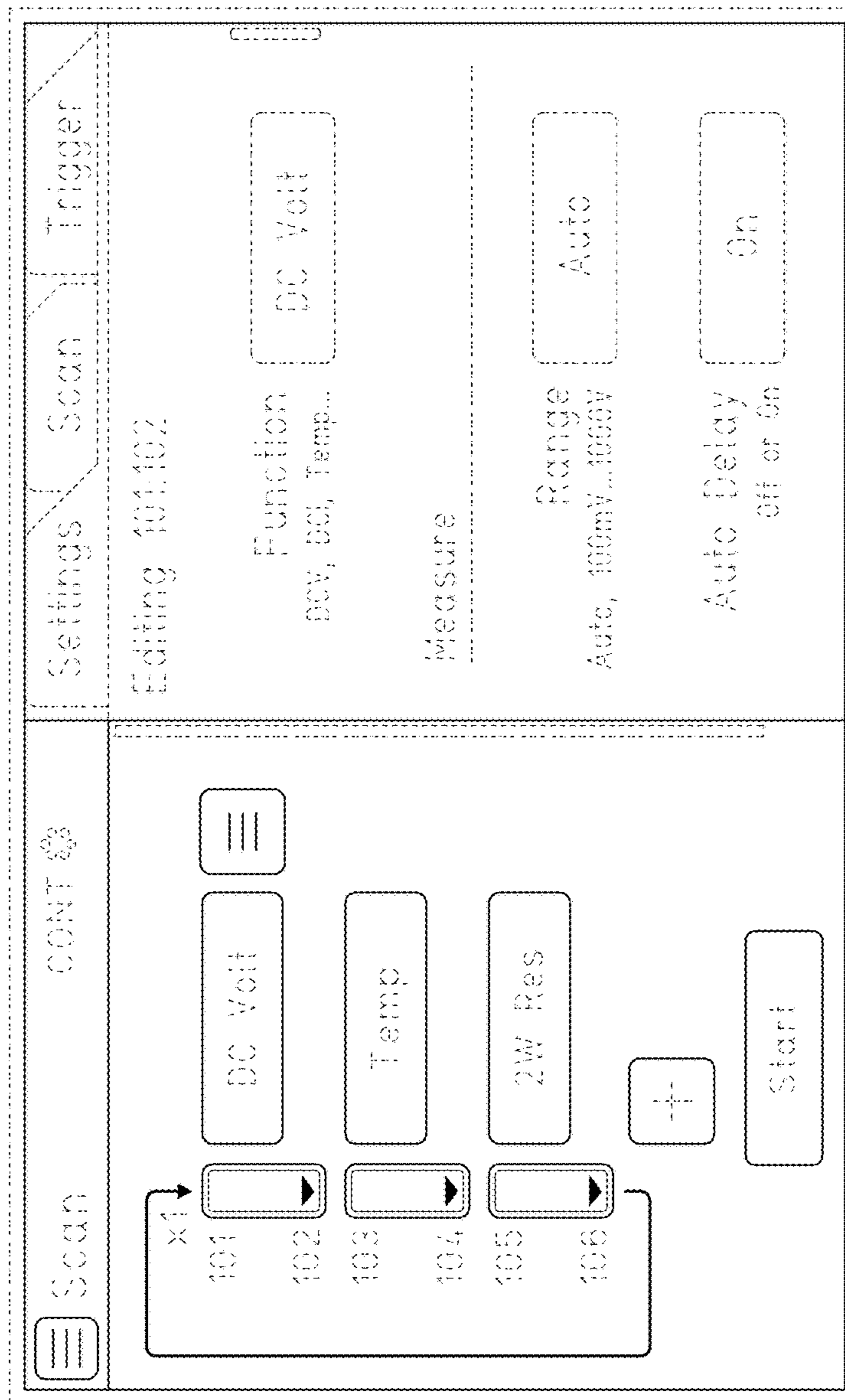

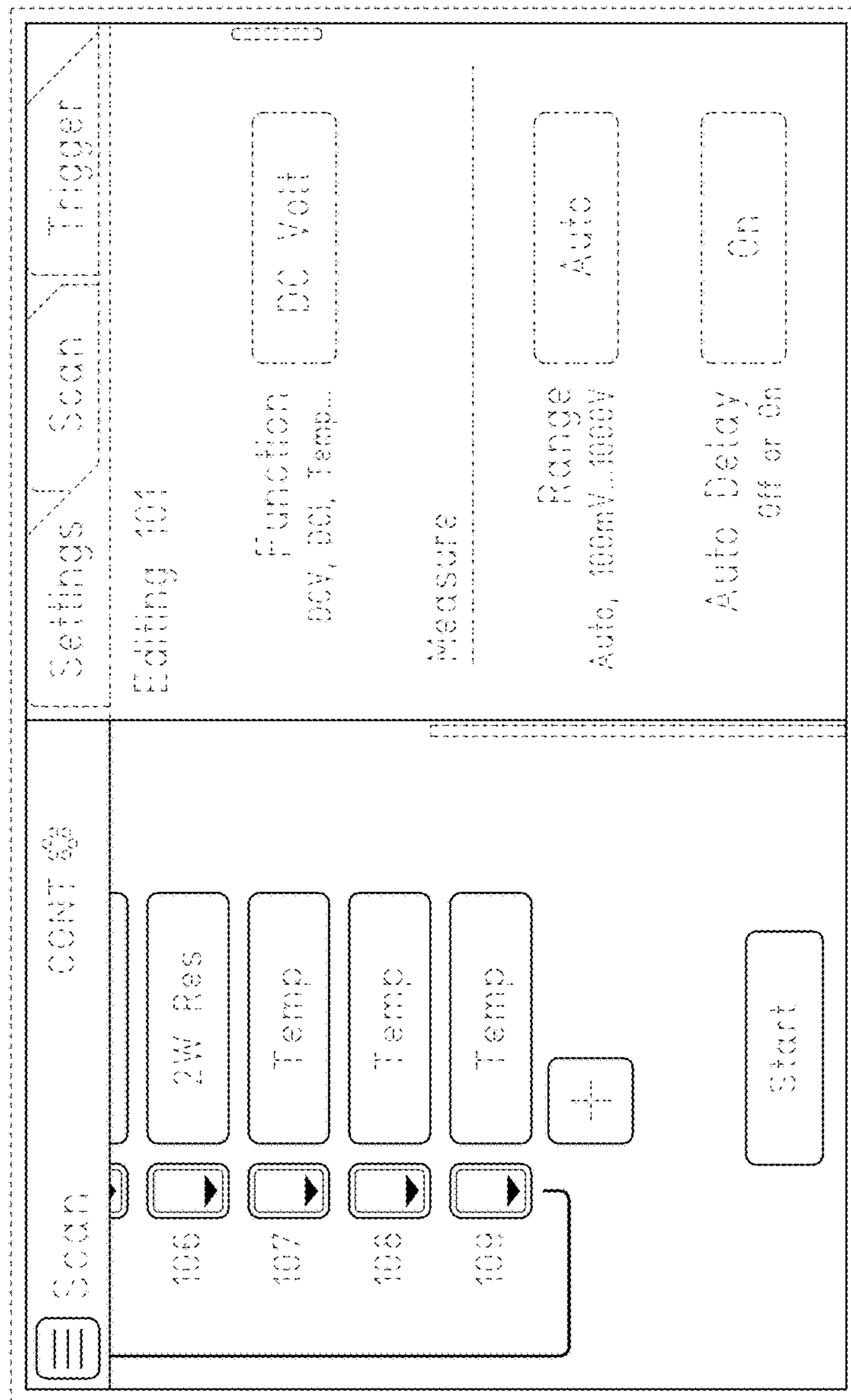
