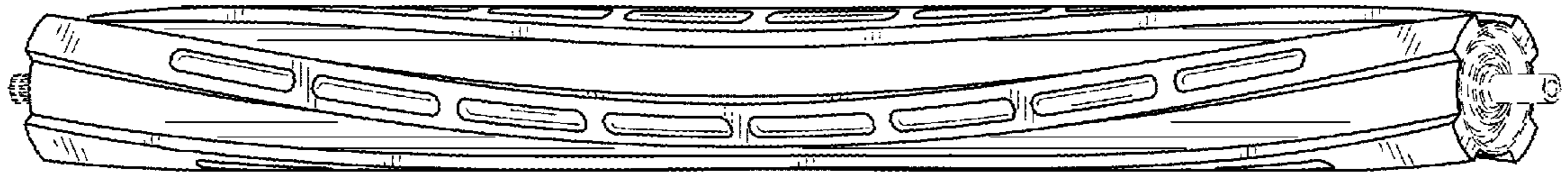
The ornamental design for a roll element, as shown and described.

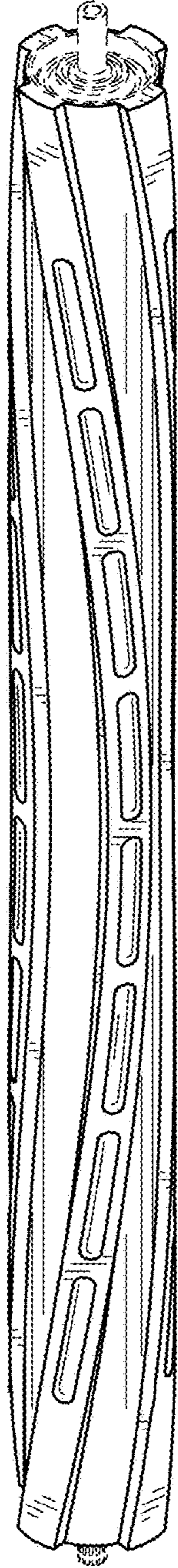

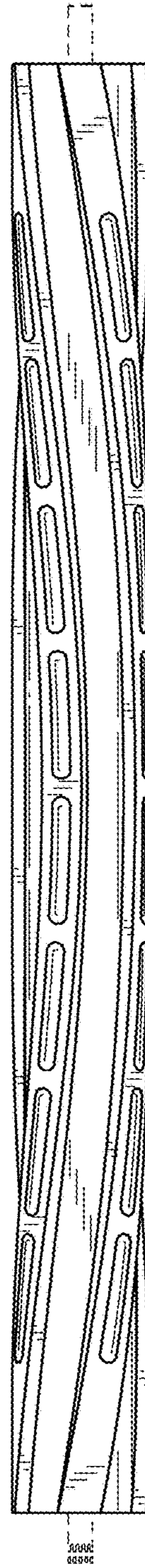

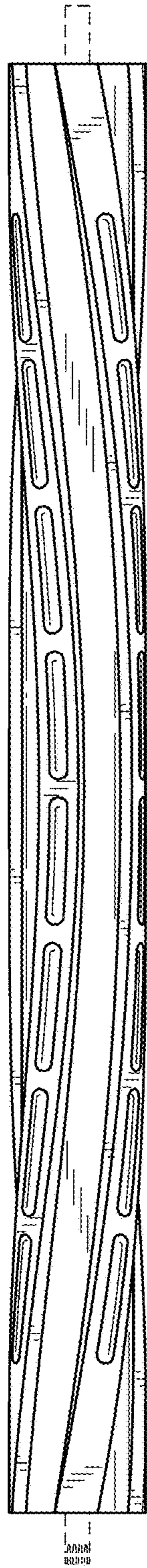

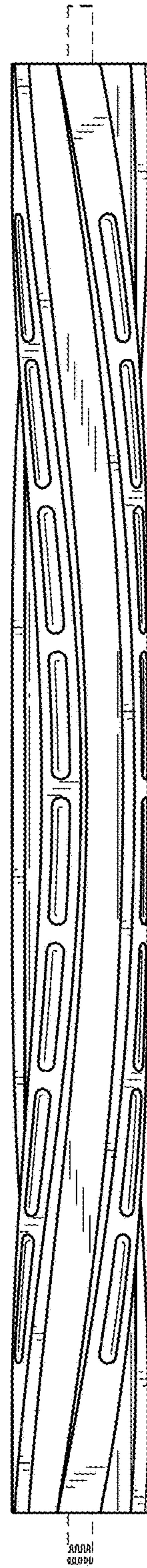

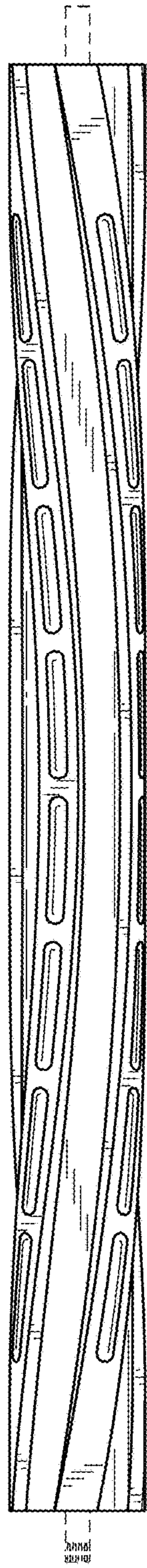

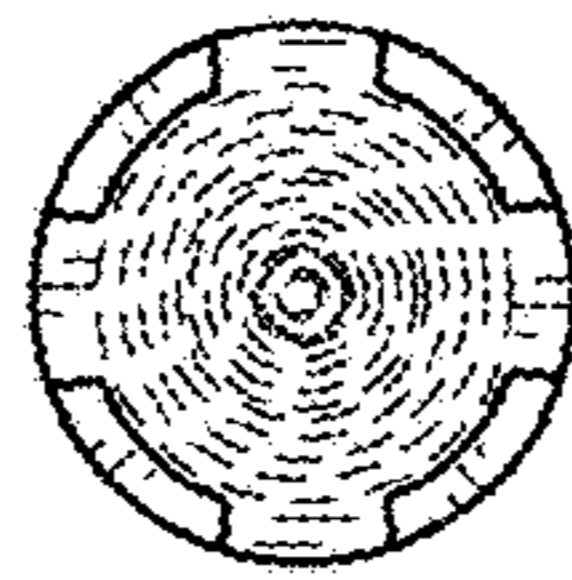

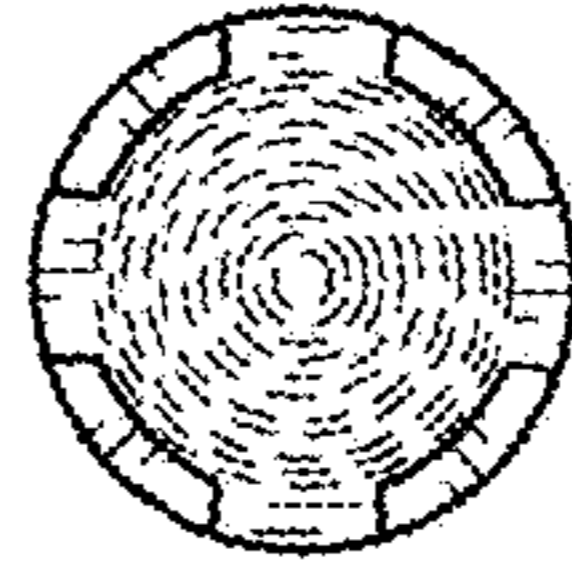
