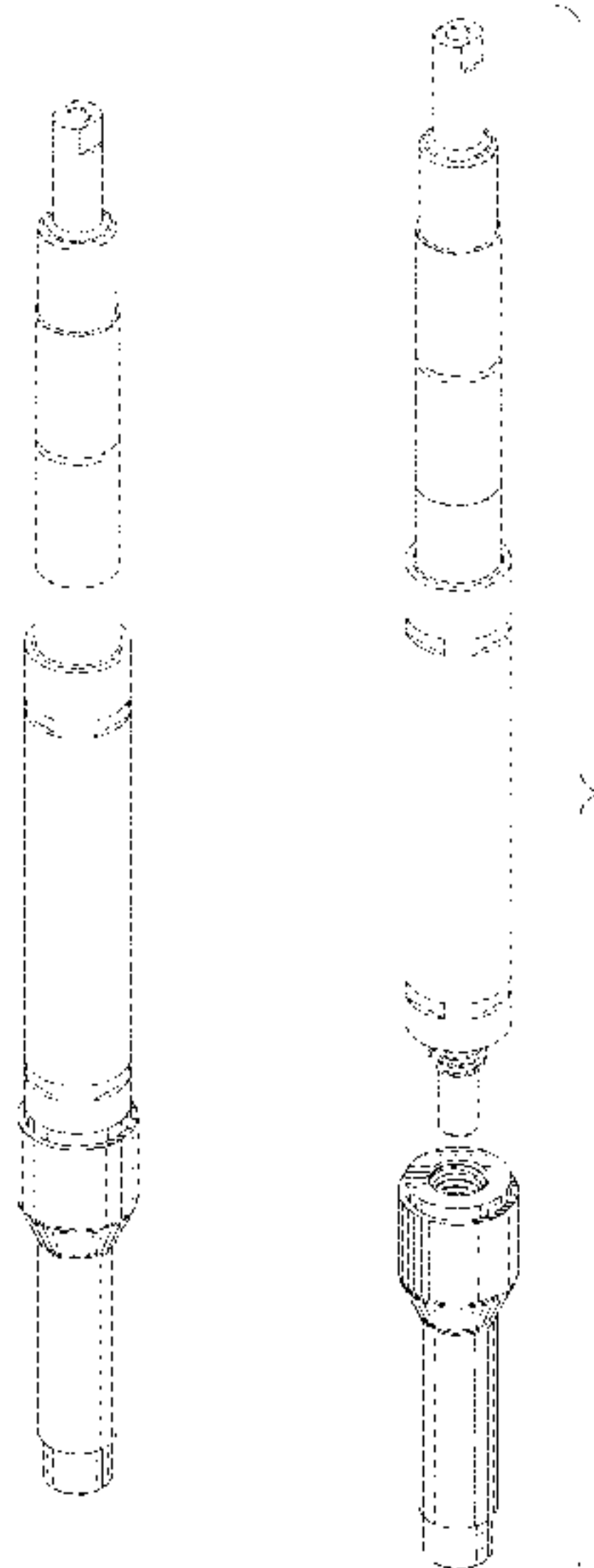

(57) **CLAIM**
We claim the ornamental design for a rotor and shaft assembly, as shown and described.

DESCRIPTION
FIG. 1 is a perspective view of a rotor and shaft assembly showing our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a side elevation view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a cross-sectional view thereof, taken along the midpoint; and,
FIG. 7 is a perspective view thereof, shown disassembled. The broken lines show portions of a rotor and shaft assembly that form no part of the claimed design.
