DESCRIPTION

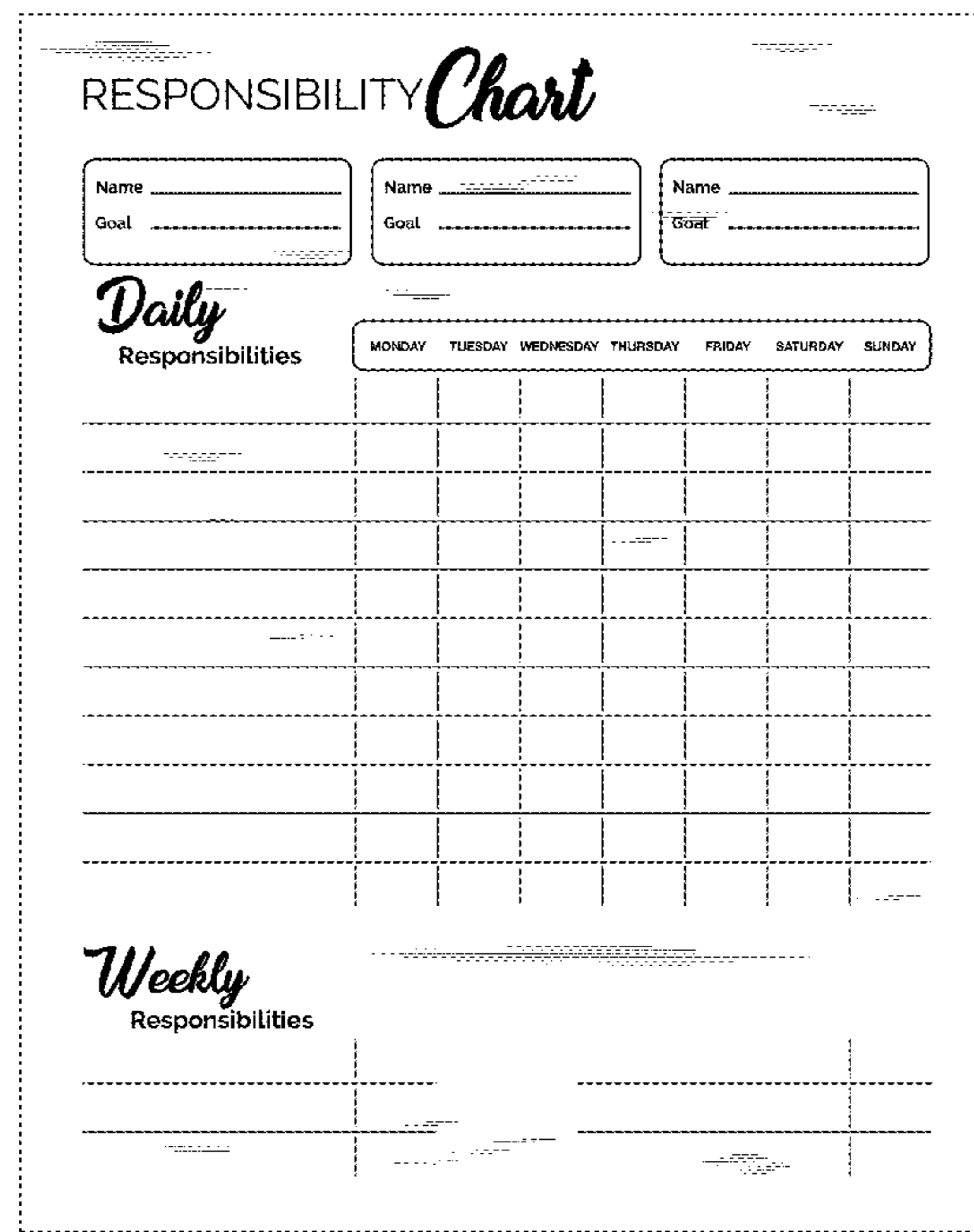
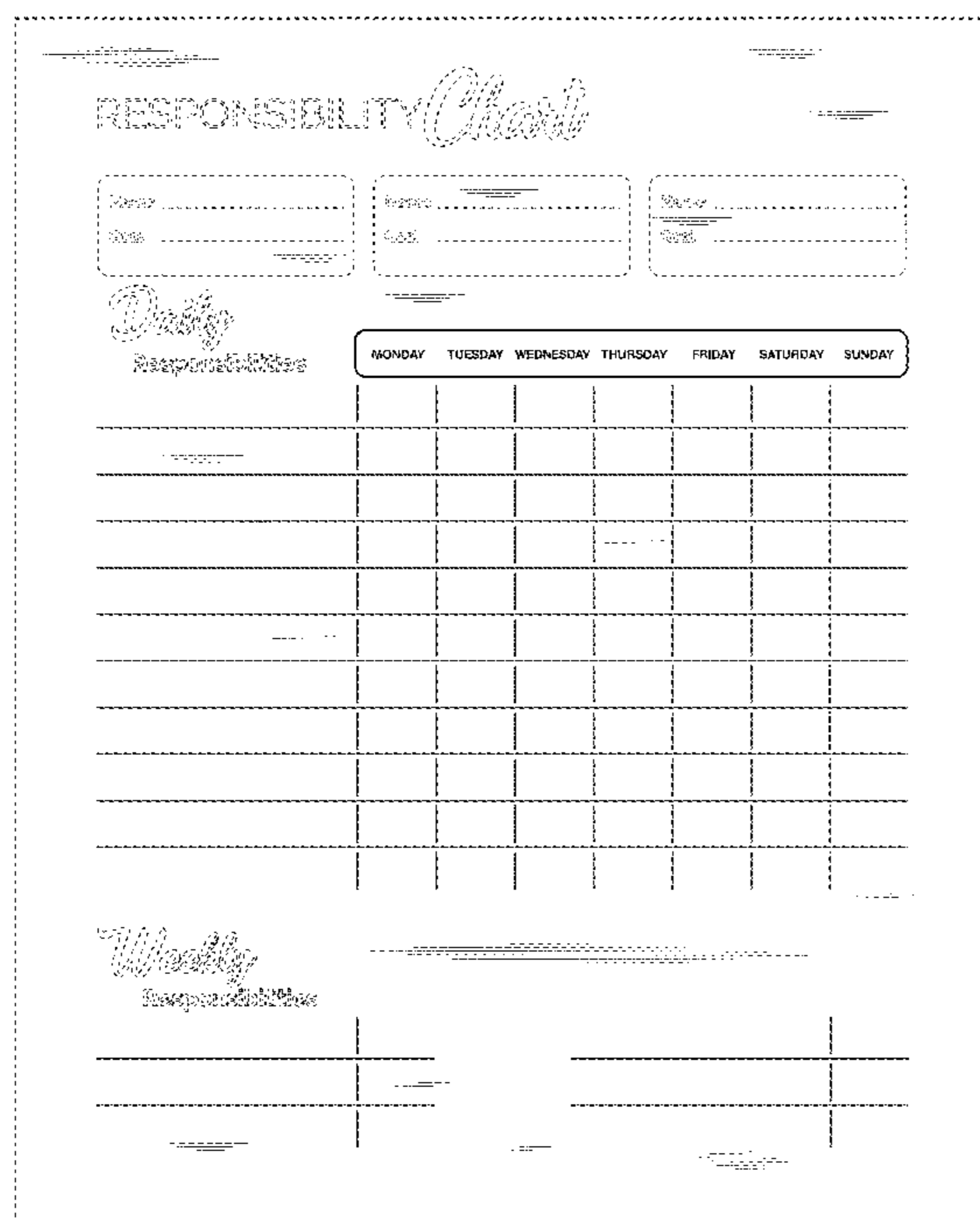
