(57) **CLAIM**

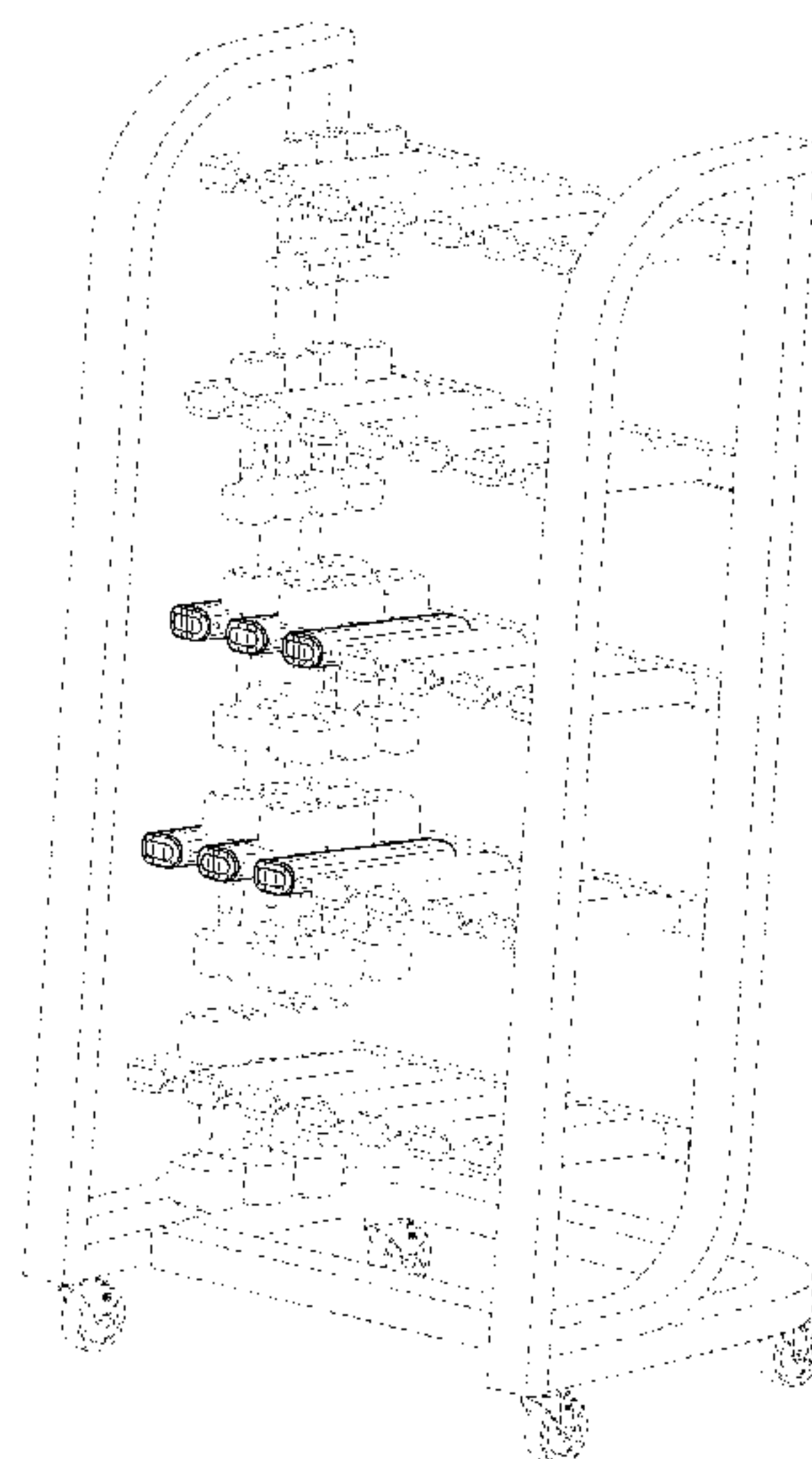
The ornamental design for a support rack for free weights, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a support rack for free weights, showing my new design; FIG. 2 is a right side view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a front view thereof; FIG. 5 is a rear view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view.

The broken lines shown in the figures are for the purpose of illustrating portions of the support rack for free weights, which form no part of the claimed design.

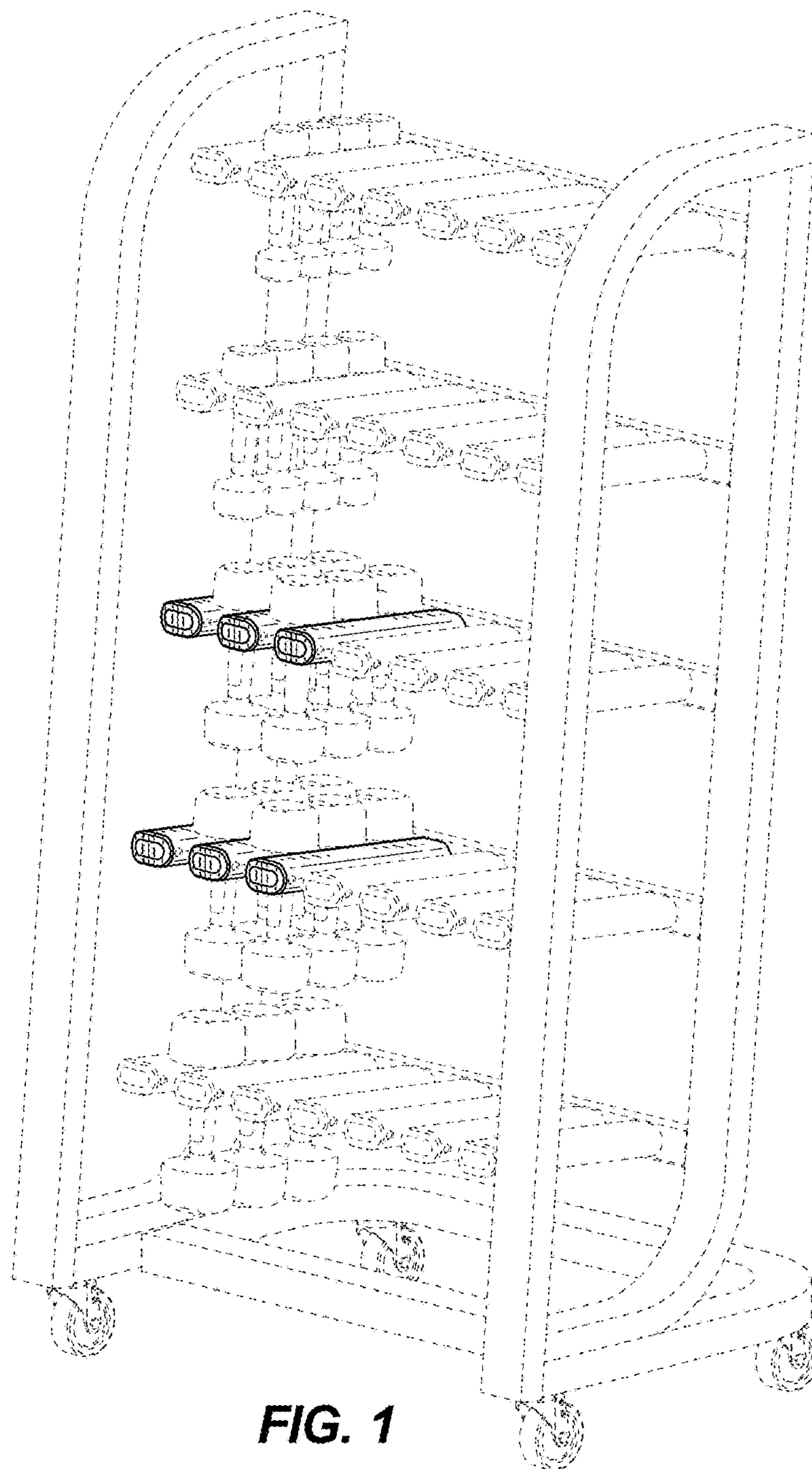

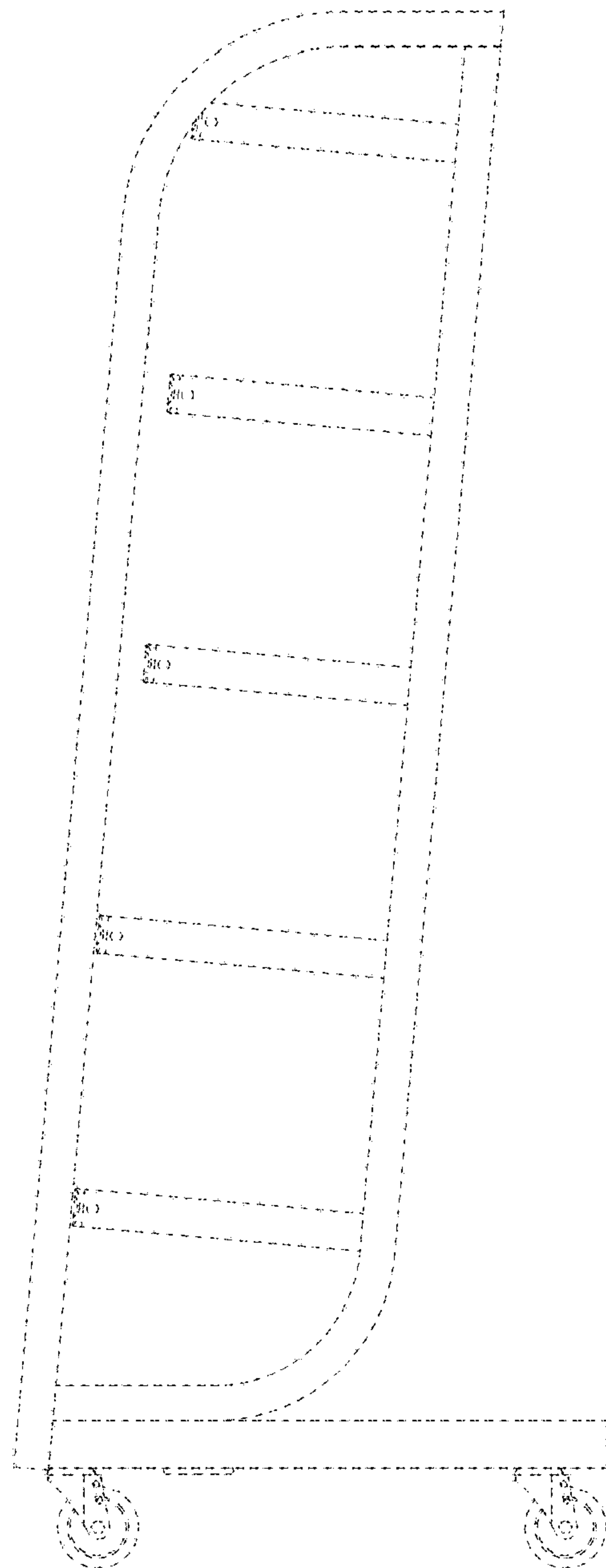

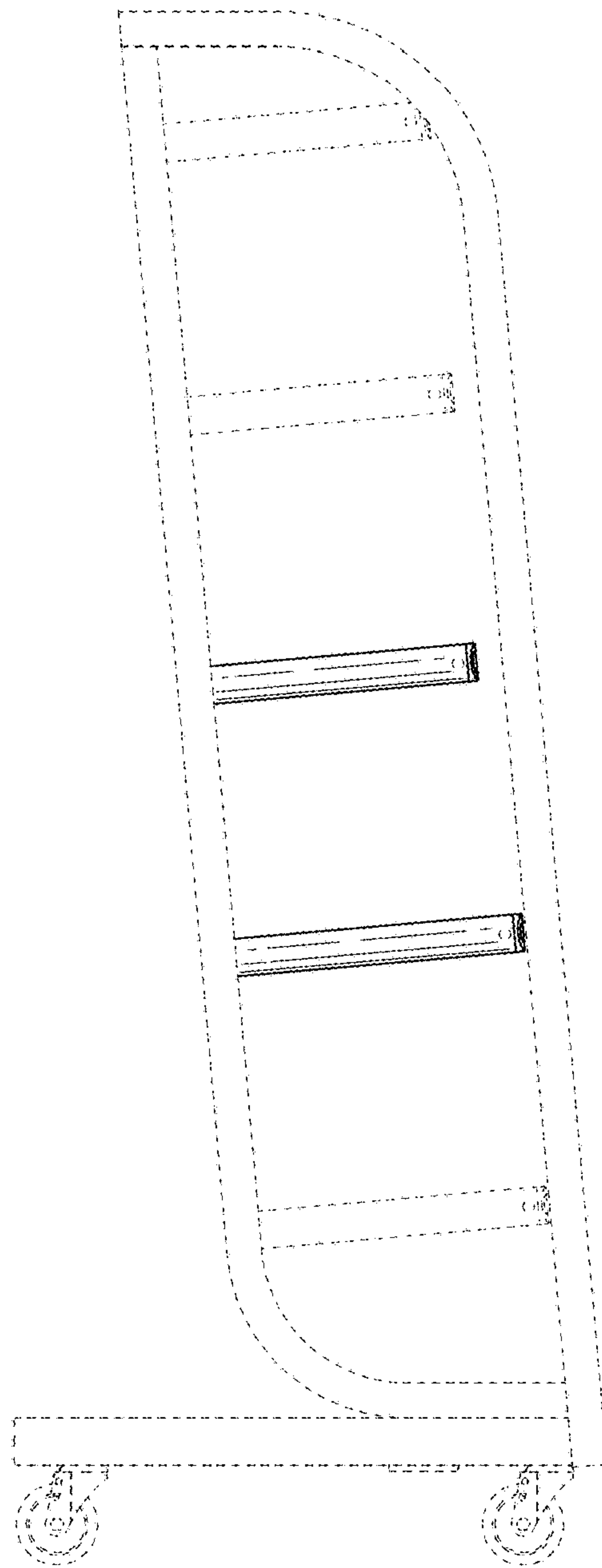

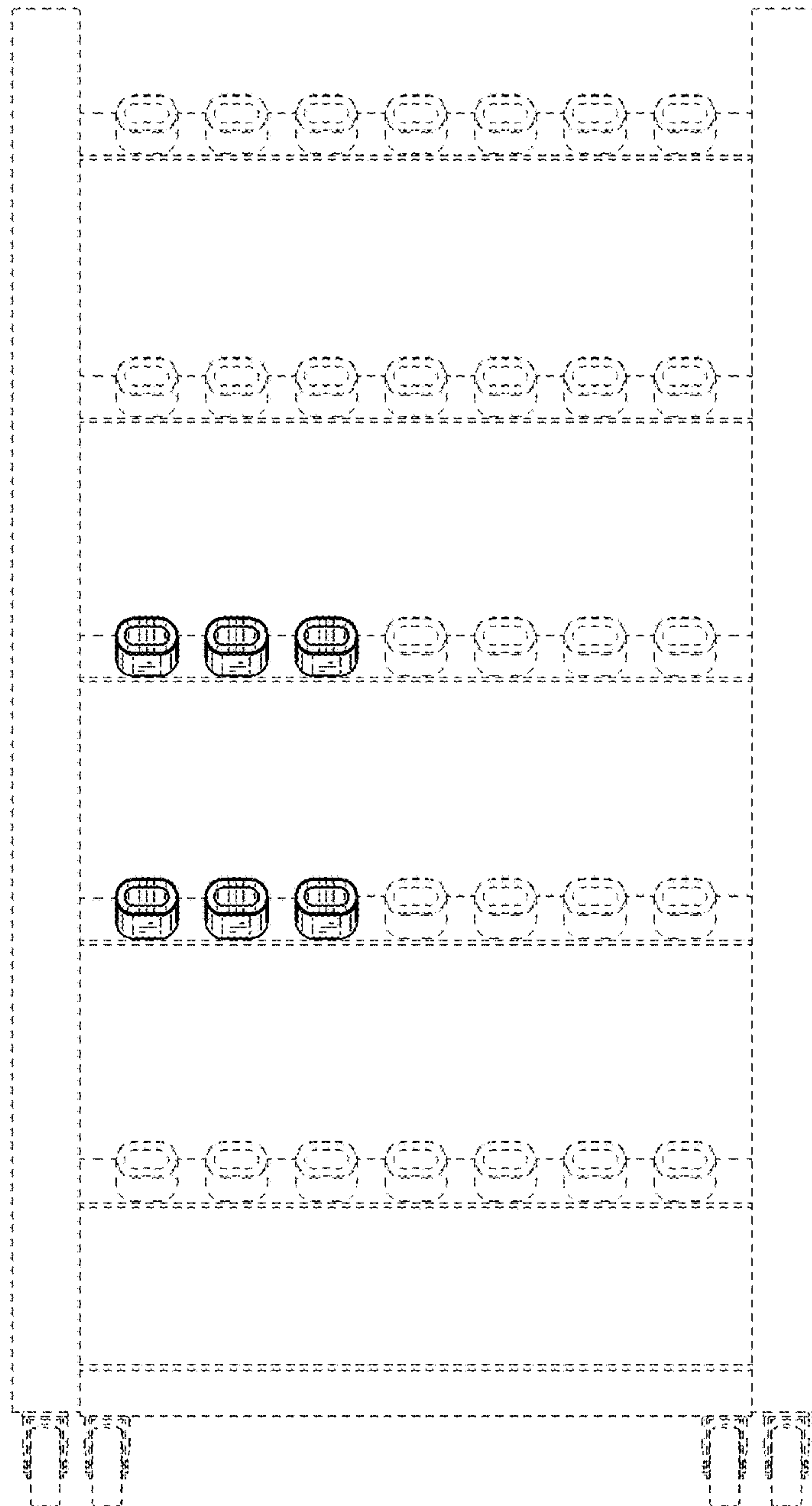

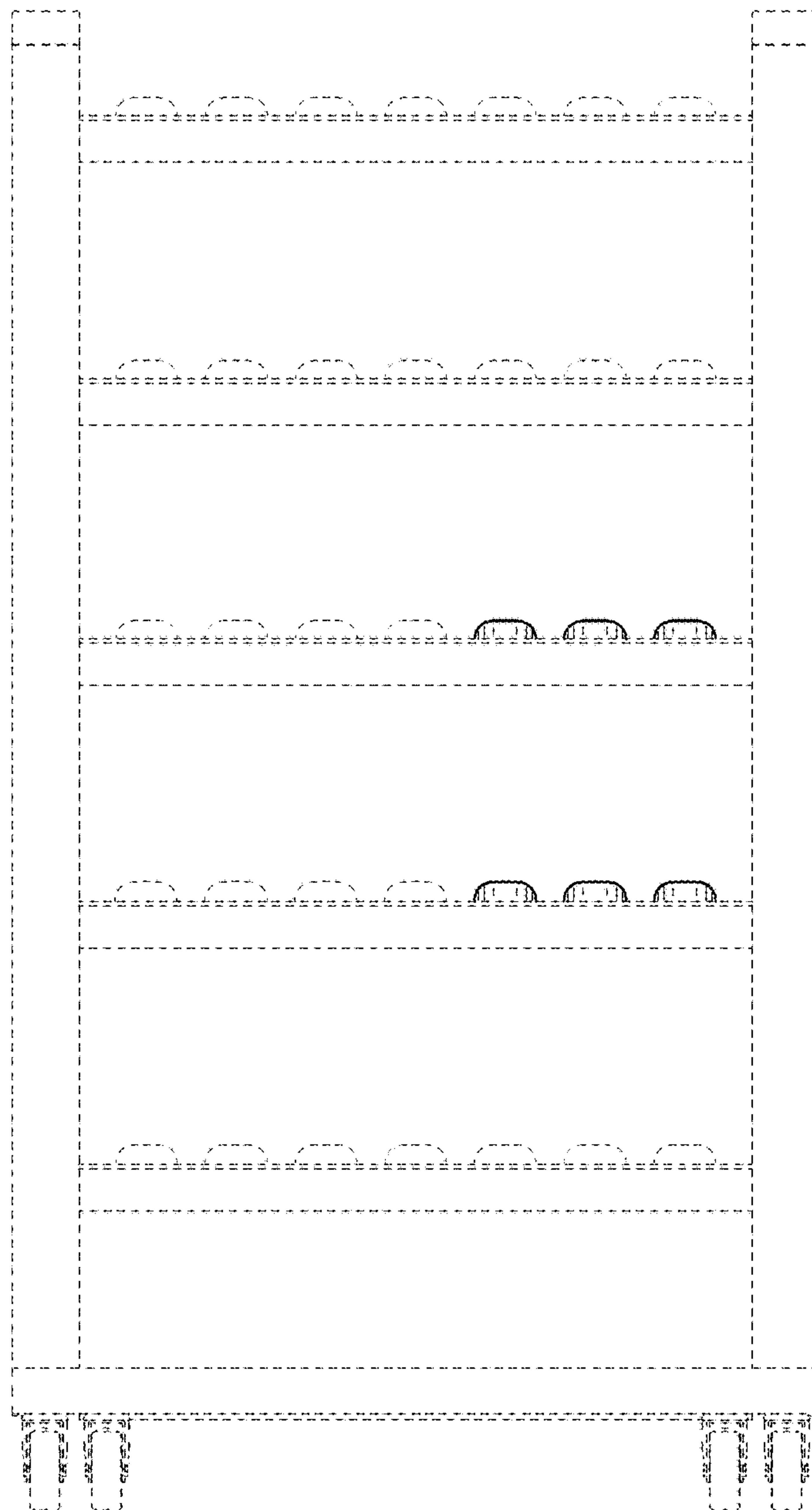

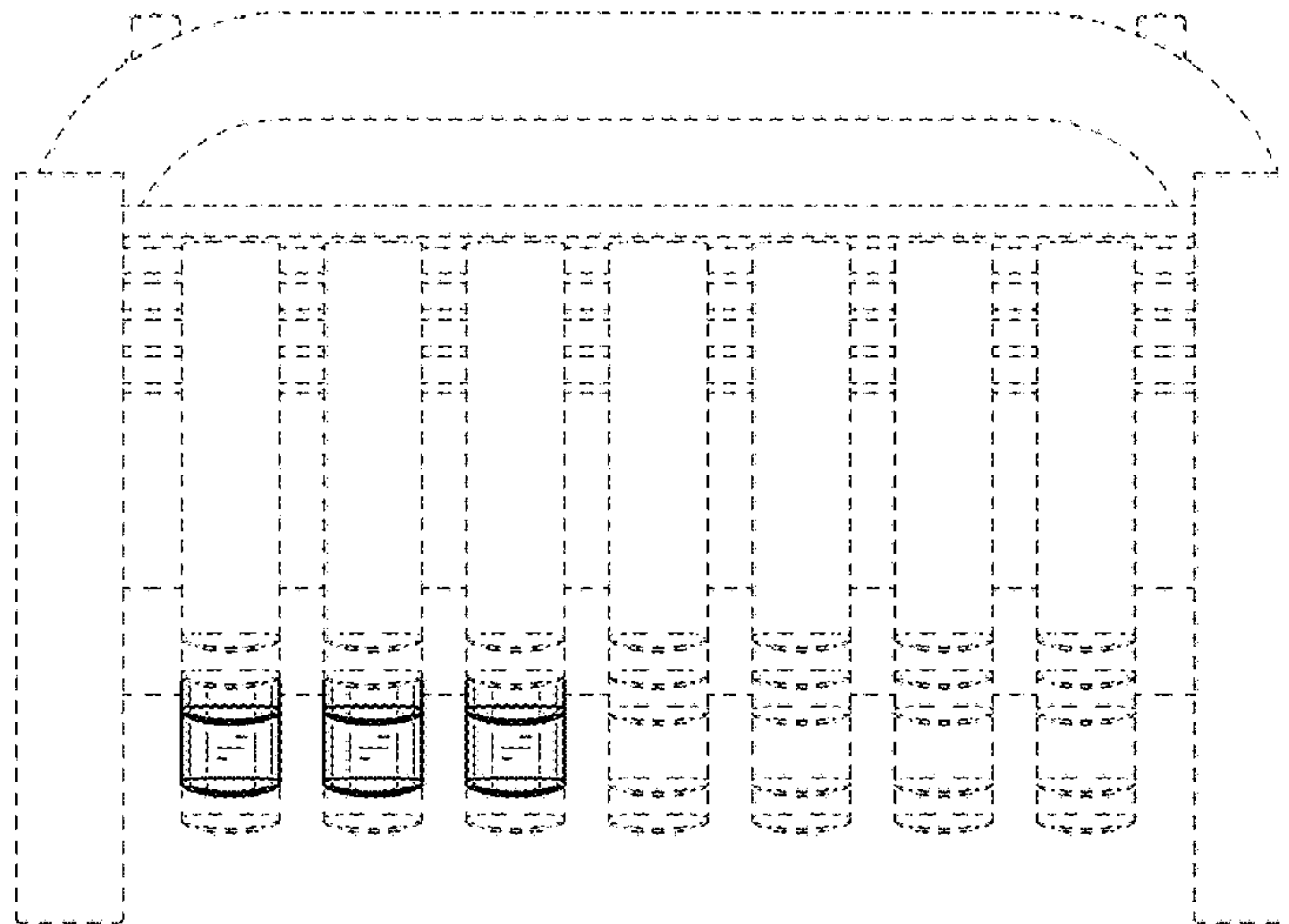




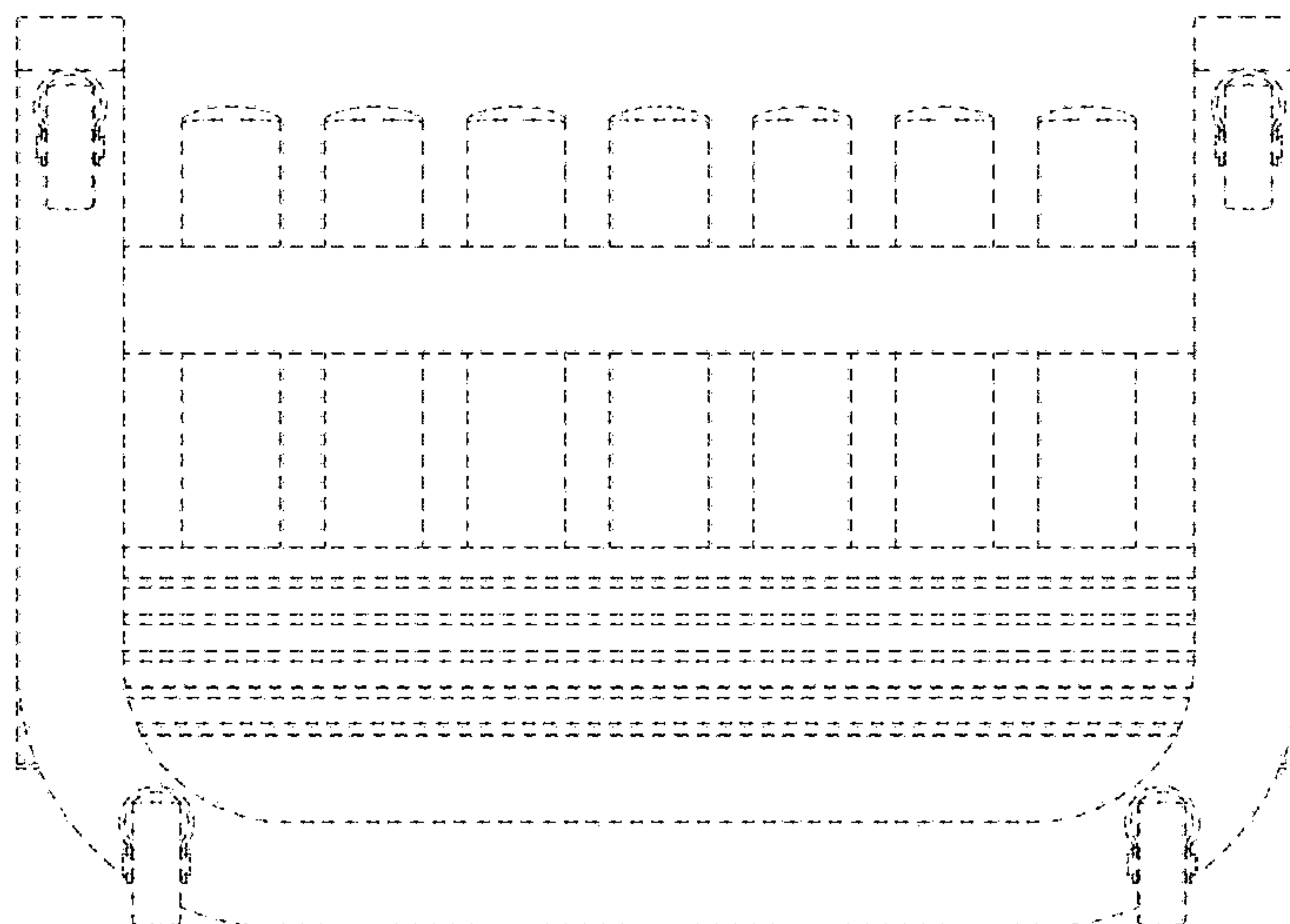
