DESCRIPTION

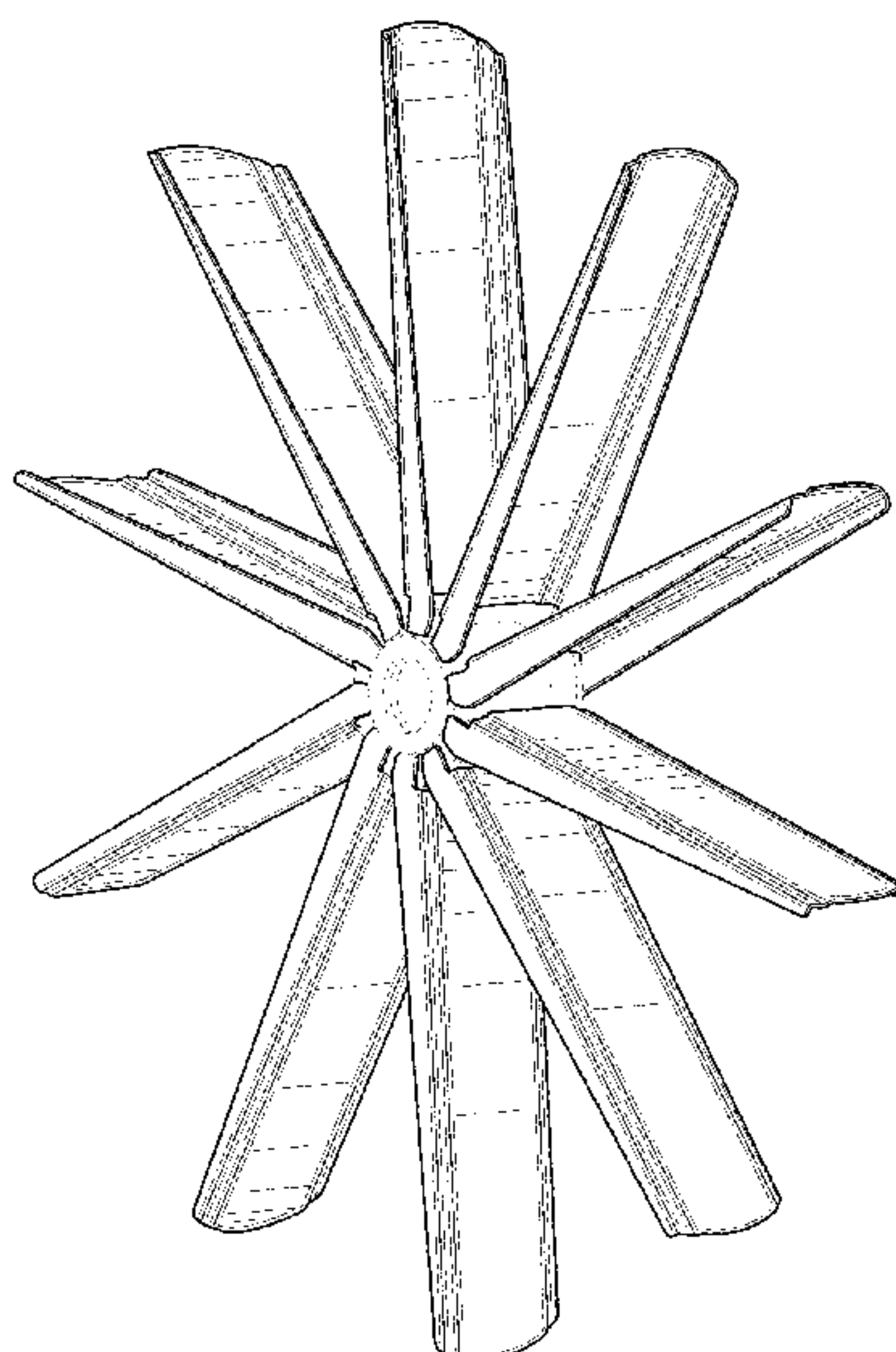
FIG. 1 is a top, front, right perspective view of a fan showing our new design;

FIG. 5 is a right side view thereof;
FIG. 6 is a left side view thereof;
FIG. 7 is a top view thereof;
FIG. 8 is a bottom view thereof; and,
FIG. 9 is a top, front, right perspective view of the design in FIGS. 1-8 positioned in an exercise bike shown as example environment.
The broken lines depicting the remainder of the fan of FIGS. 1-8 and the example environment in FIG. 9 show features that form no part of the claimed design.

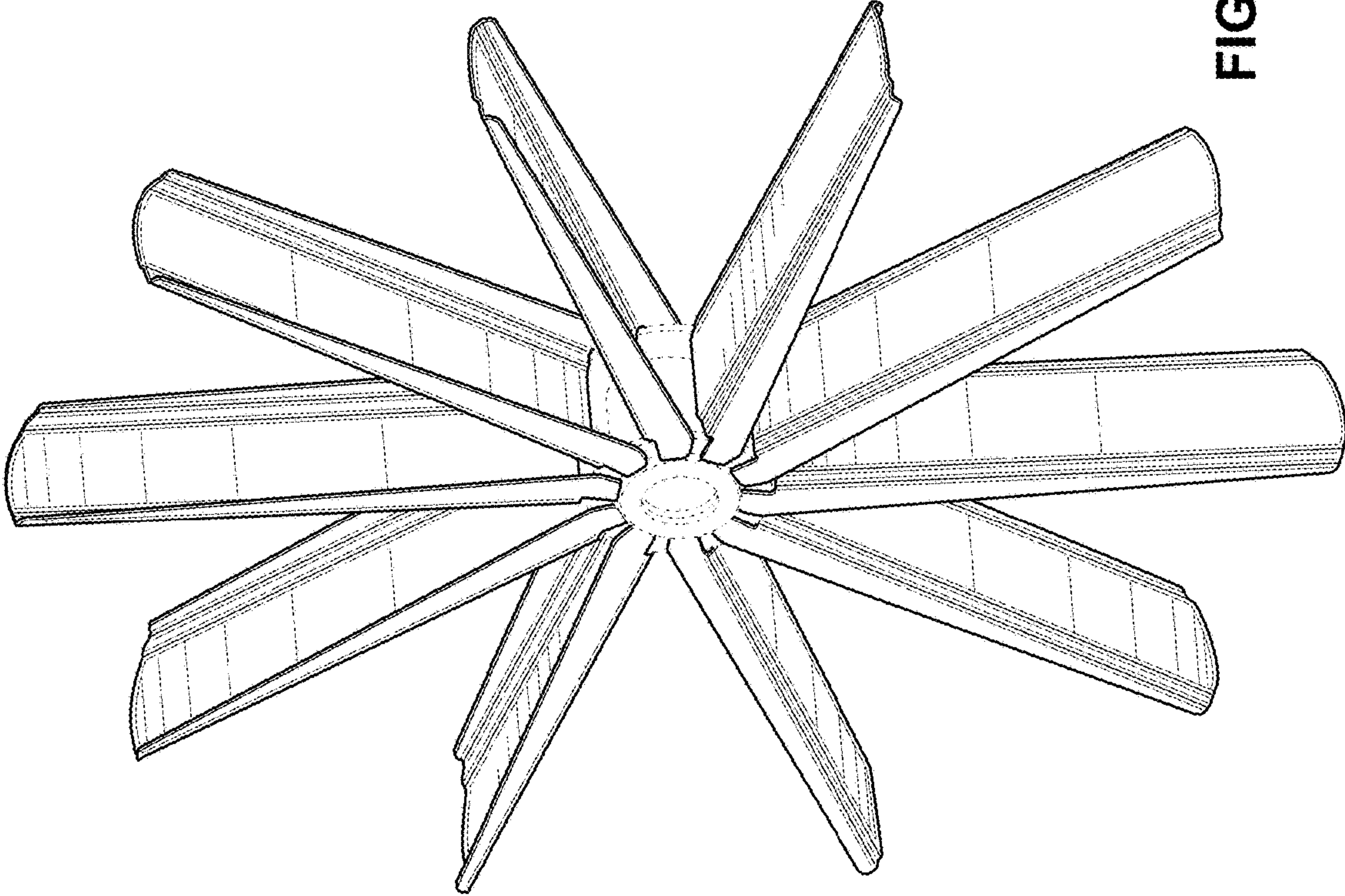

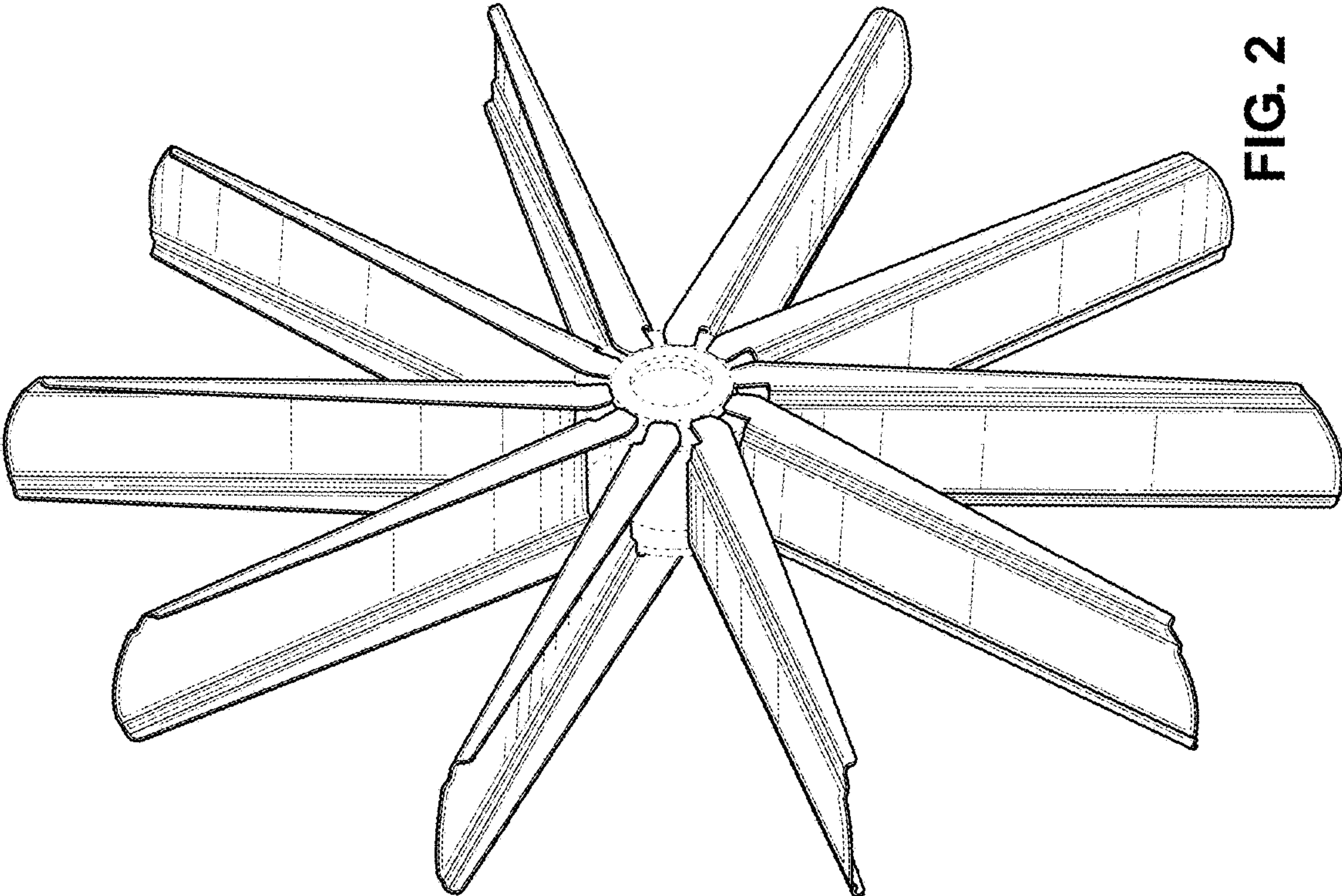

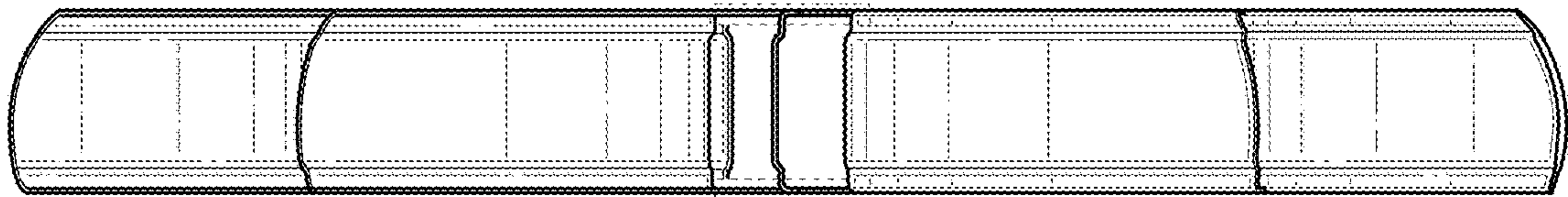

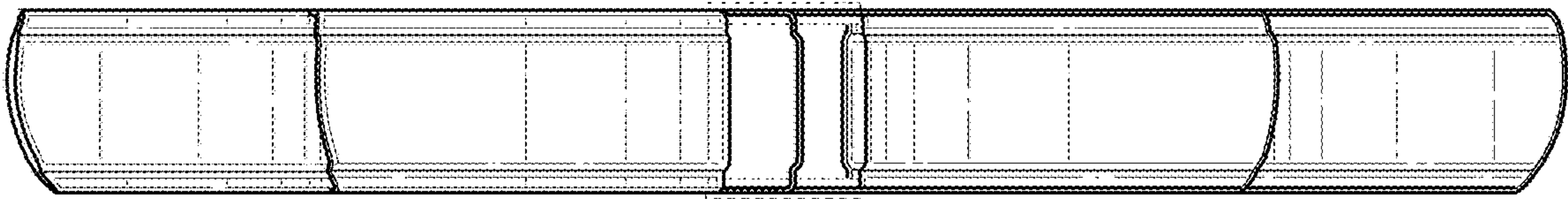

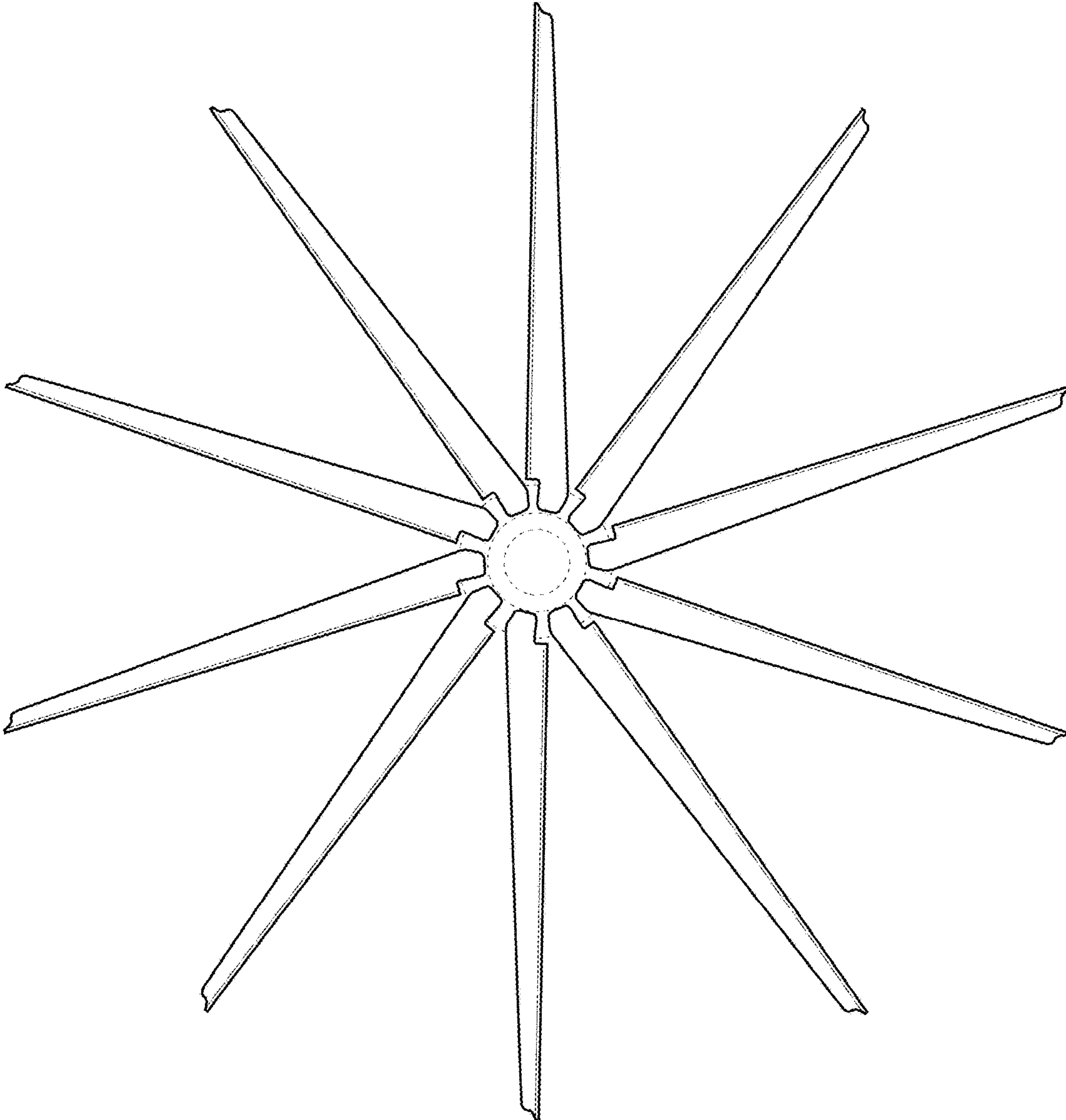

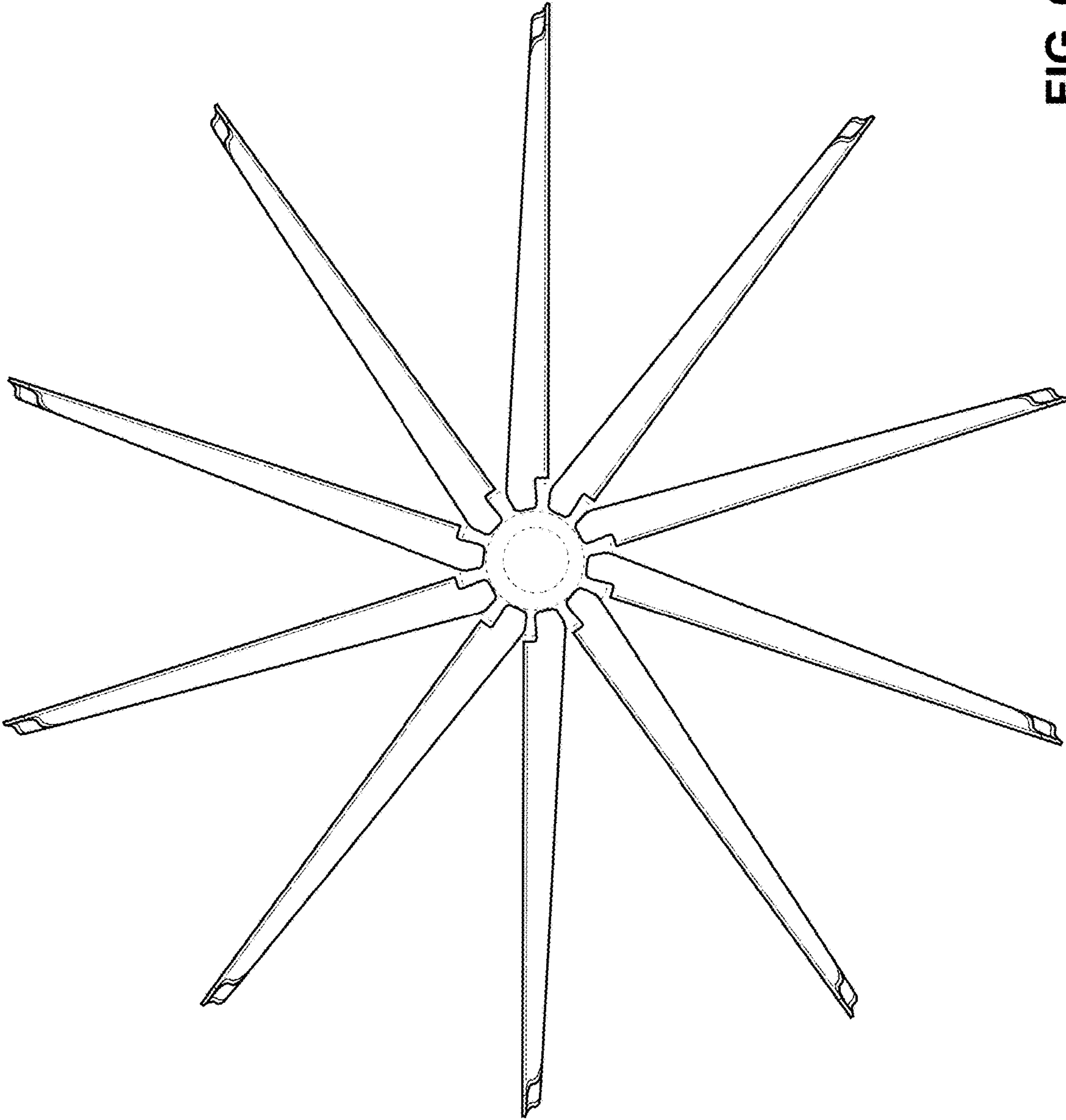

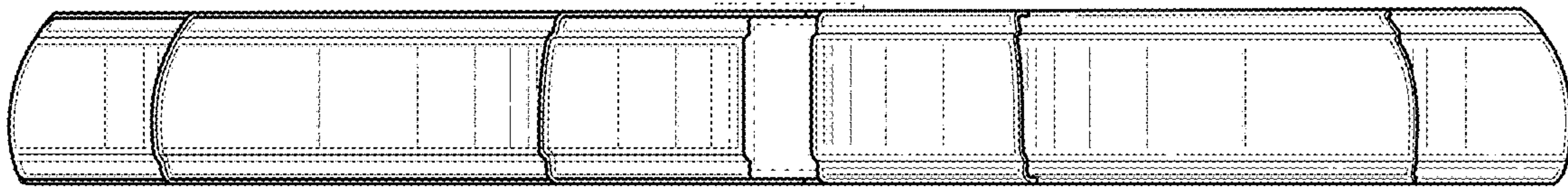

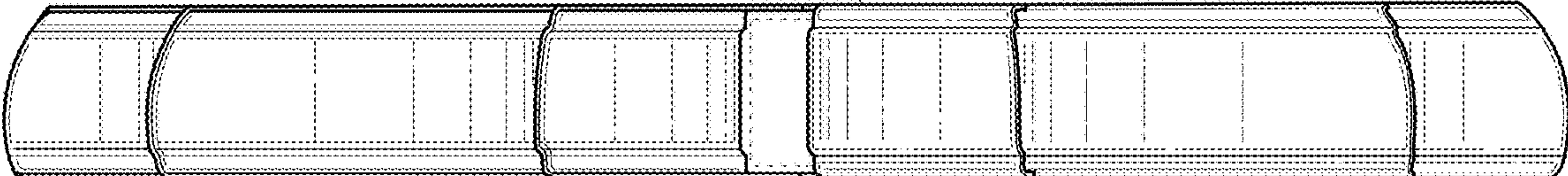
