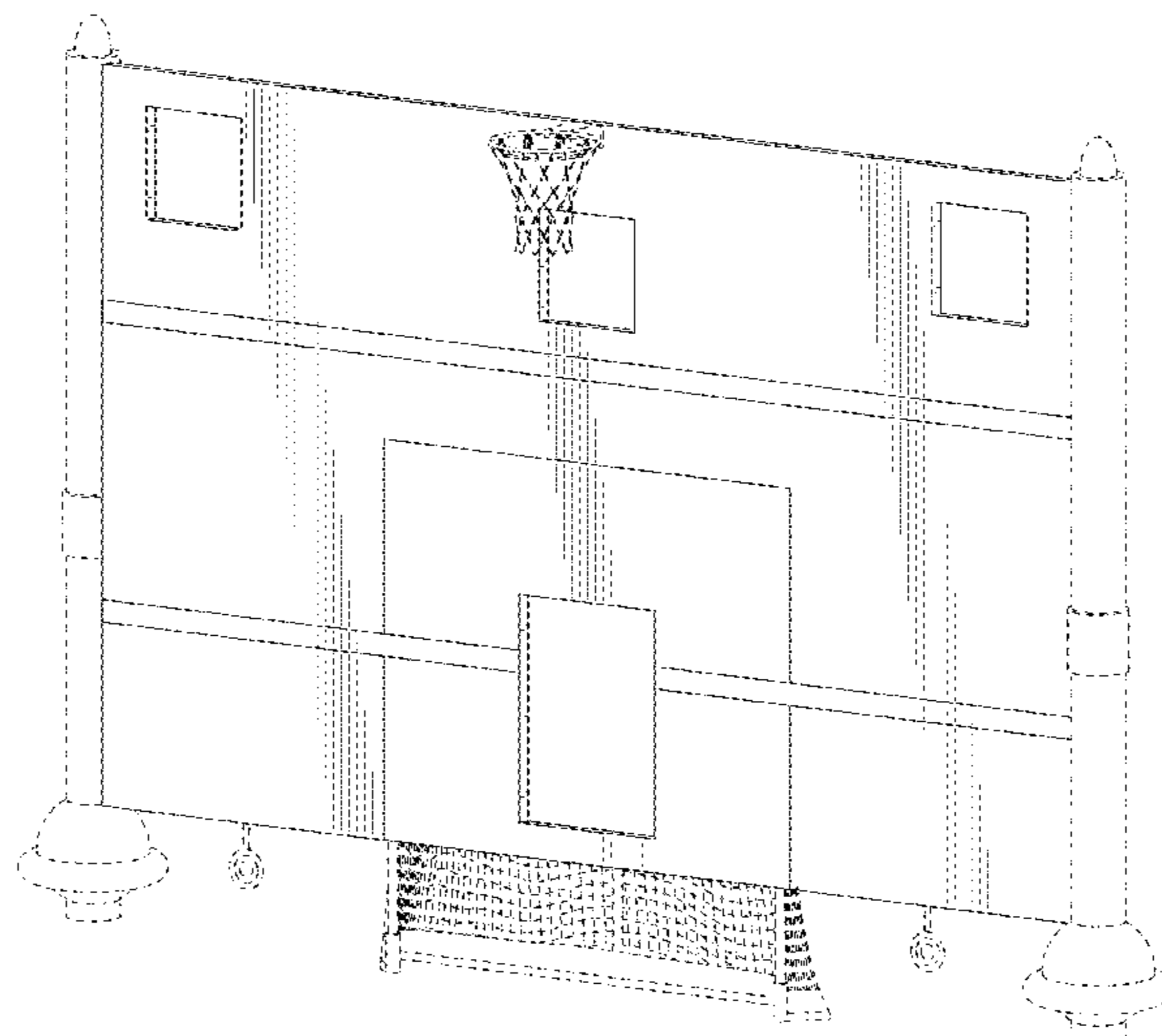
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of the multi-purpose sports training wall showing my new design. FIG. 2 is a front elevation view thereof. FIG. 3 is a rear elevation view thereof. 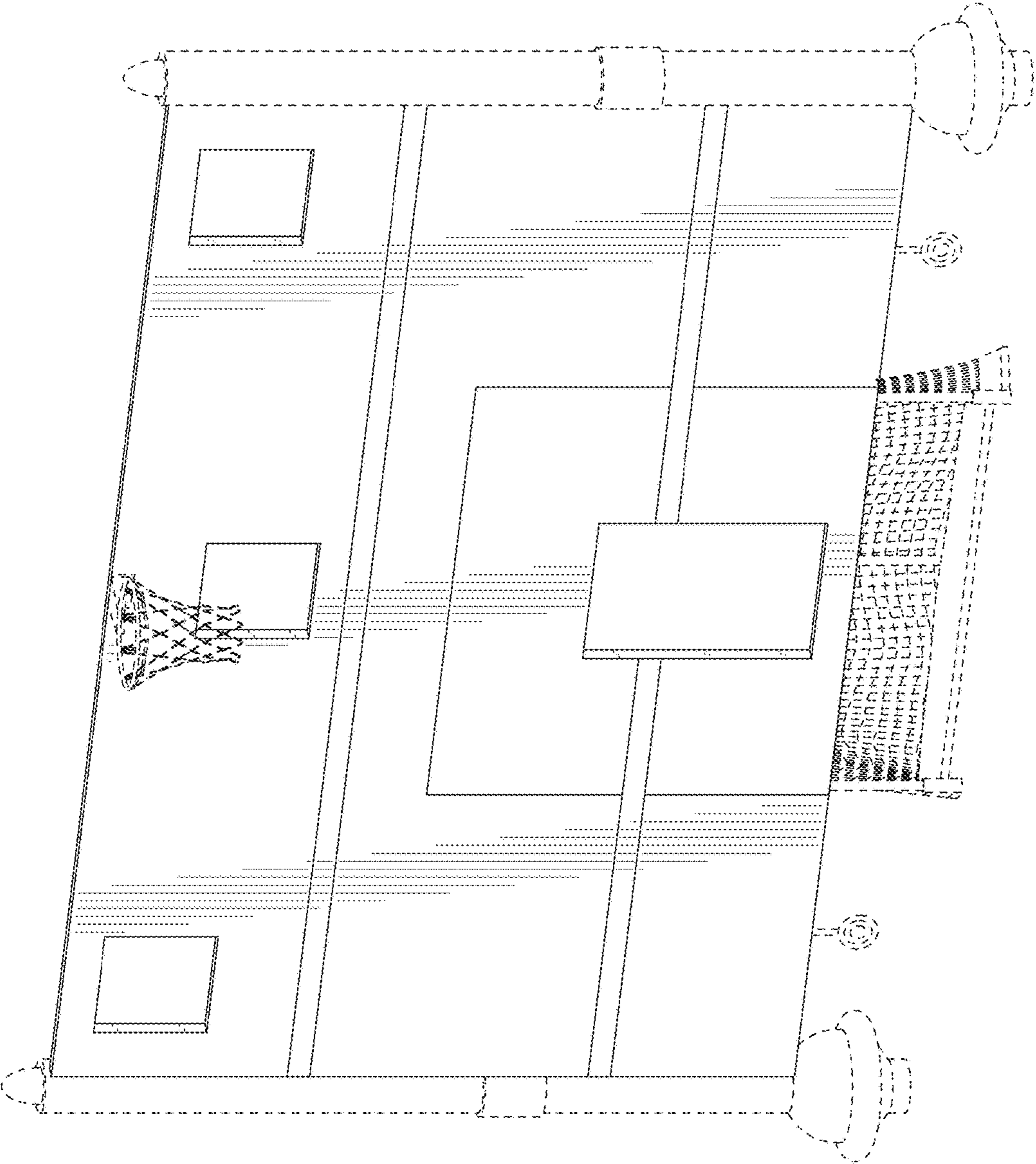

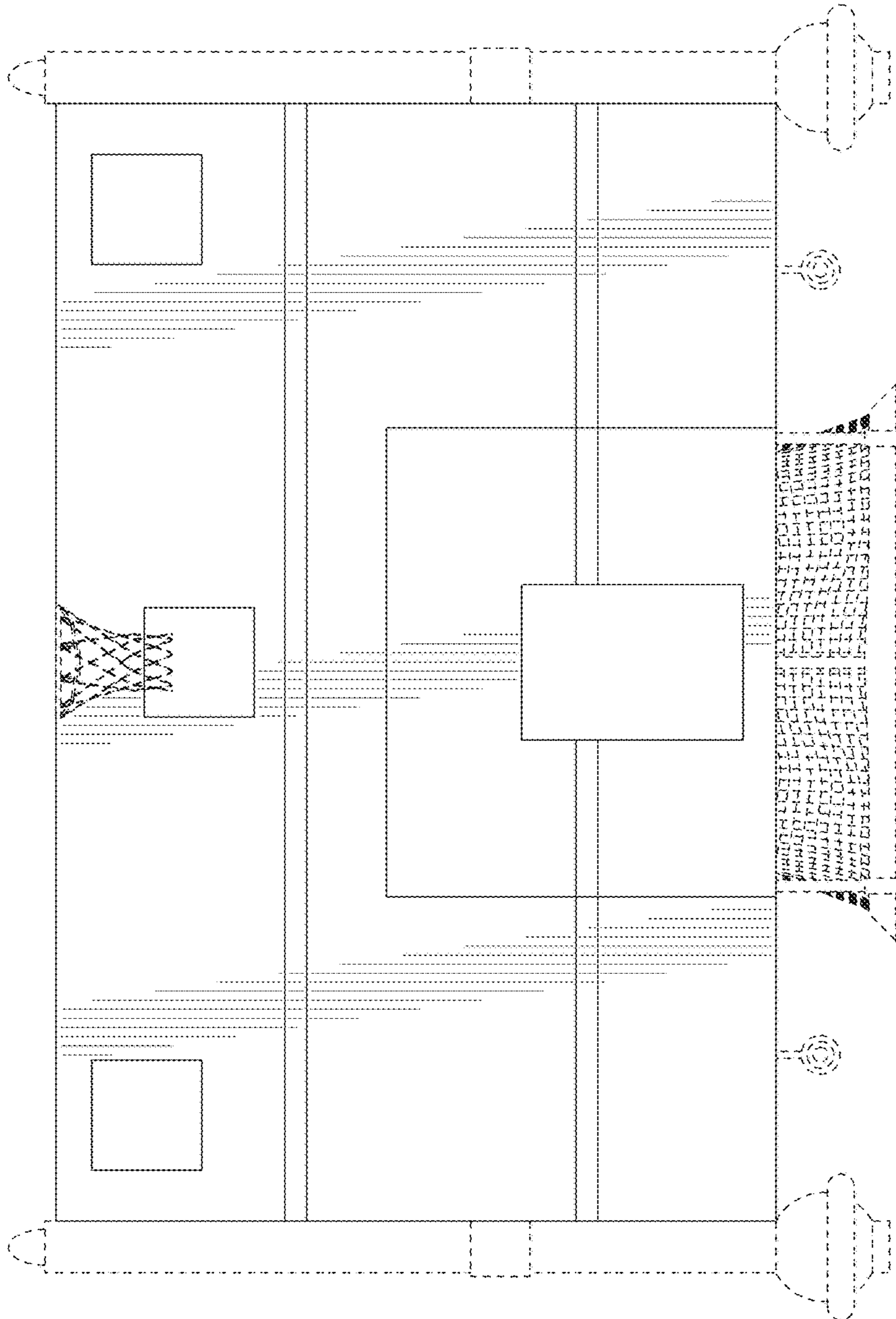

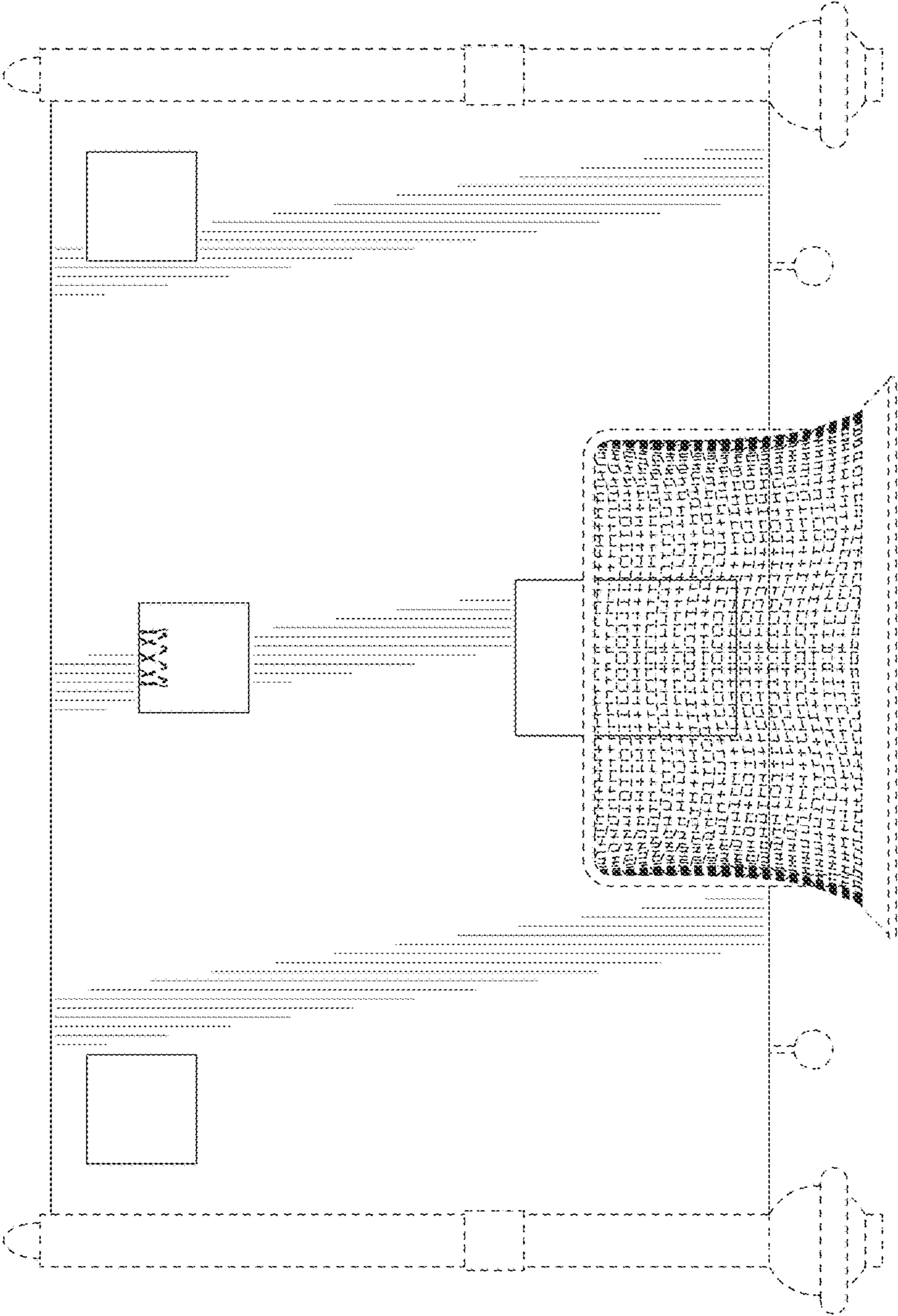

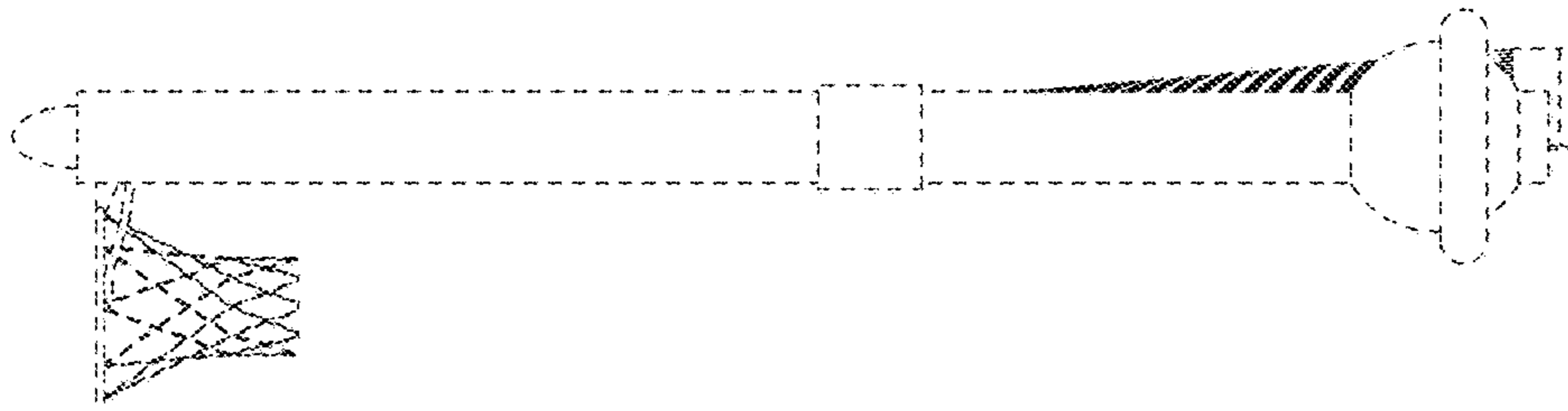

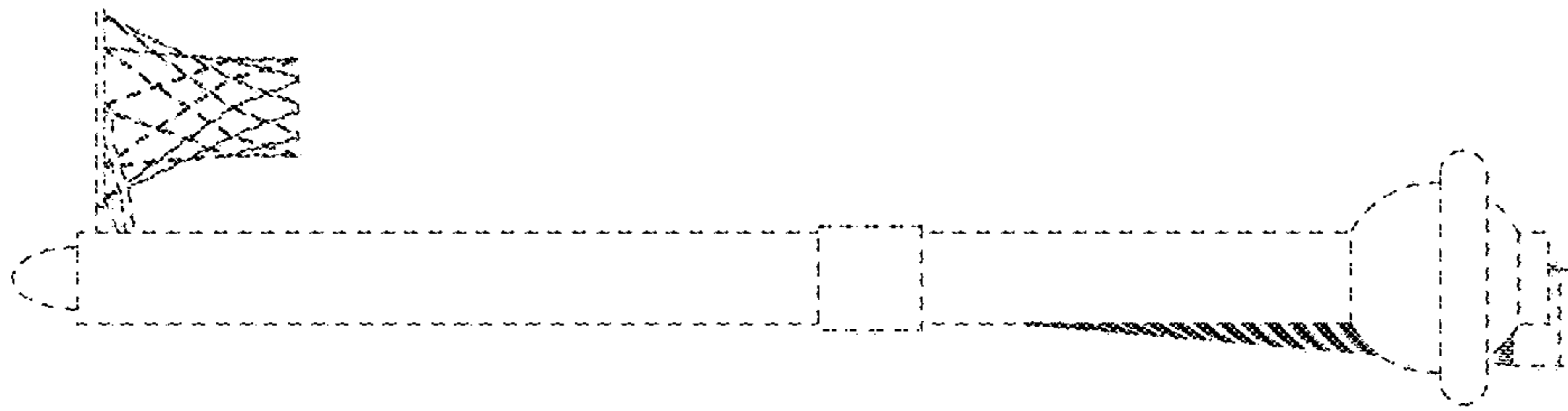

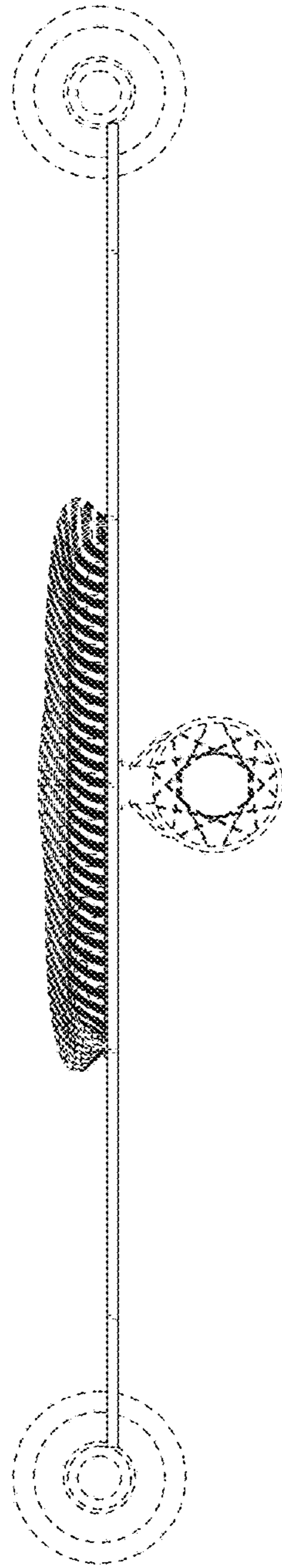

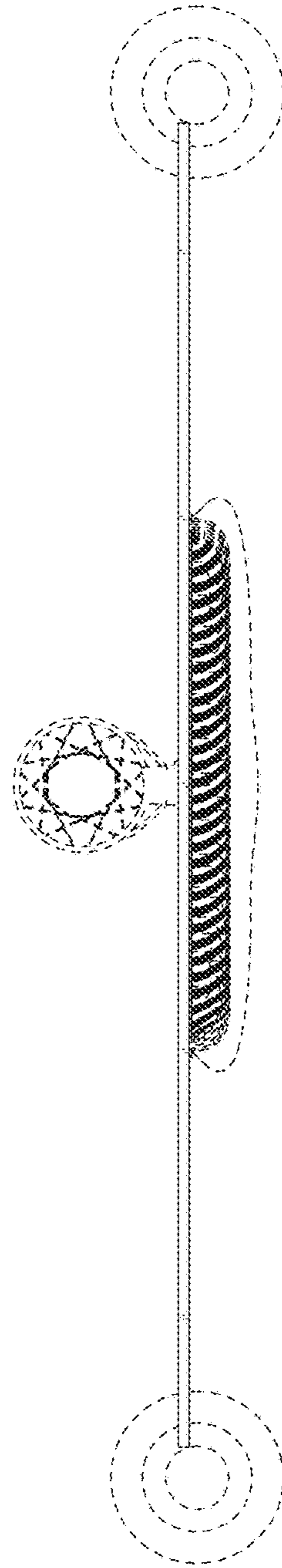
