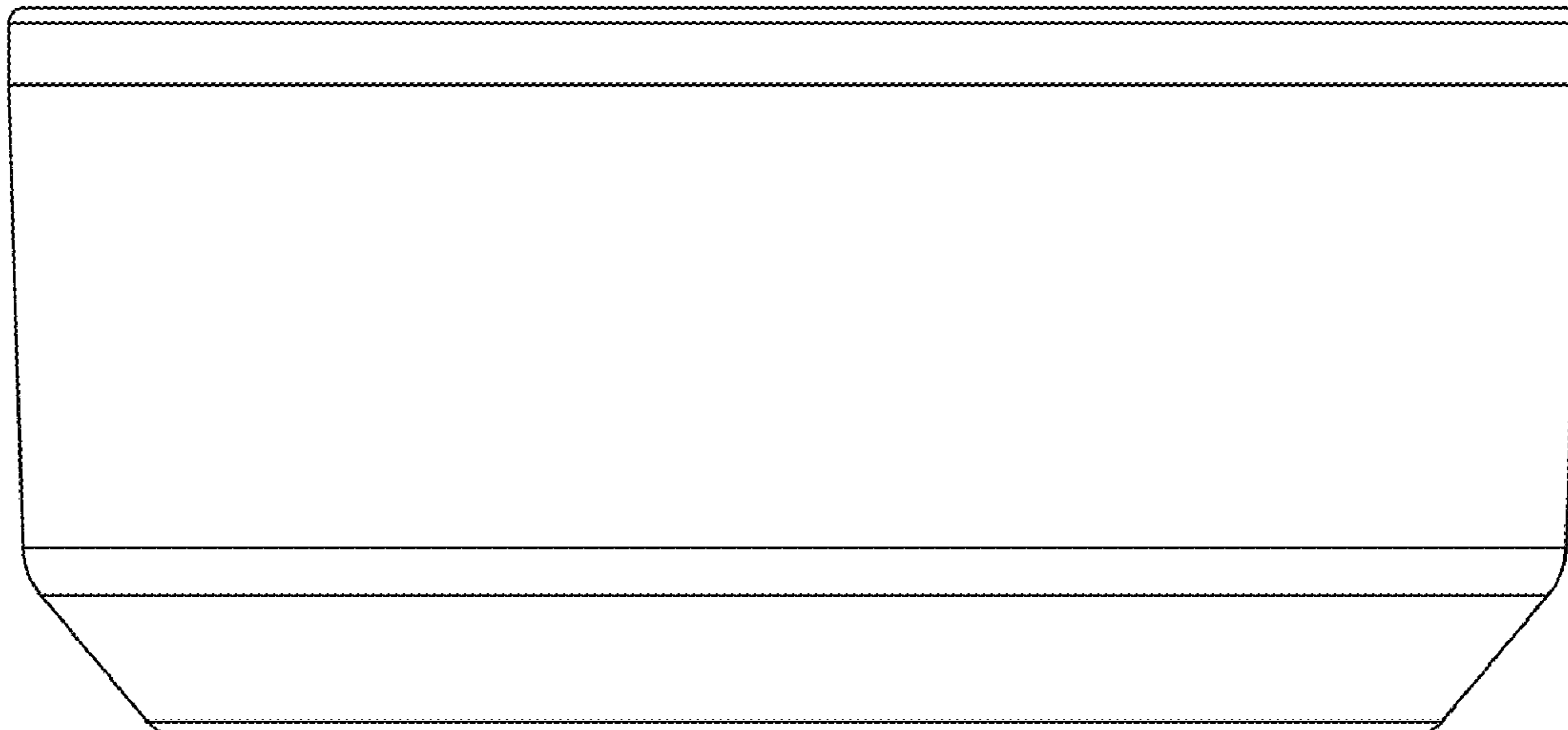
(57) **CLAIM**
The ornamental design for a valve seat, as shown and
described.

DESCRIPTION

FIG. 1 is a side elevation view of a valve seat showing our
new design, the right side, left side, front side and back side
being identical;
FIG. 2 is a sectional plan view thereof, taken along line 2-2
from FIG. 3.
FIG. 3 is a bottom plan view thereof, with a cutting line 2-2
shown, illustrating the location of the view of FIG. 2.
FIG. 4 is a top plan view thereof;
FIG. 5 is a top perspective view thereof; and,
FIG. 6 is a bottom perspective view thereof.

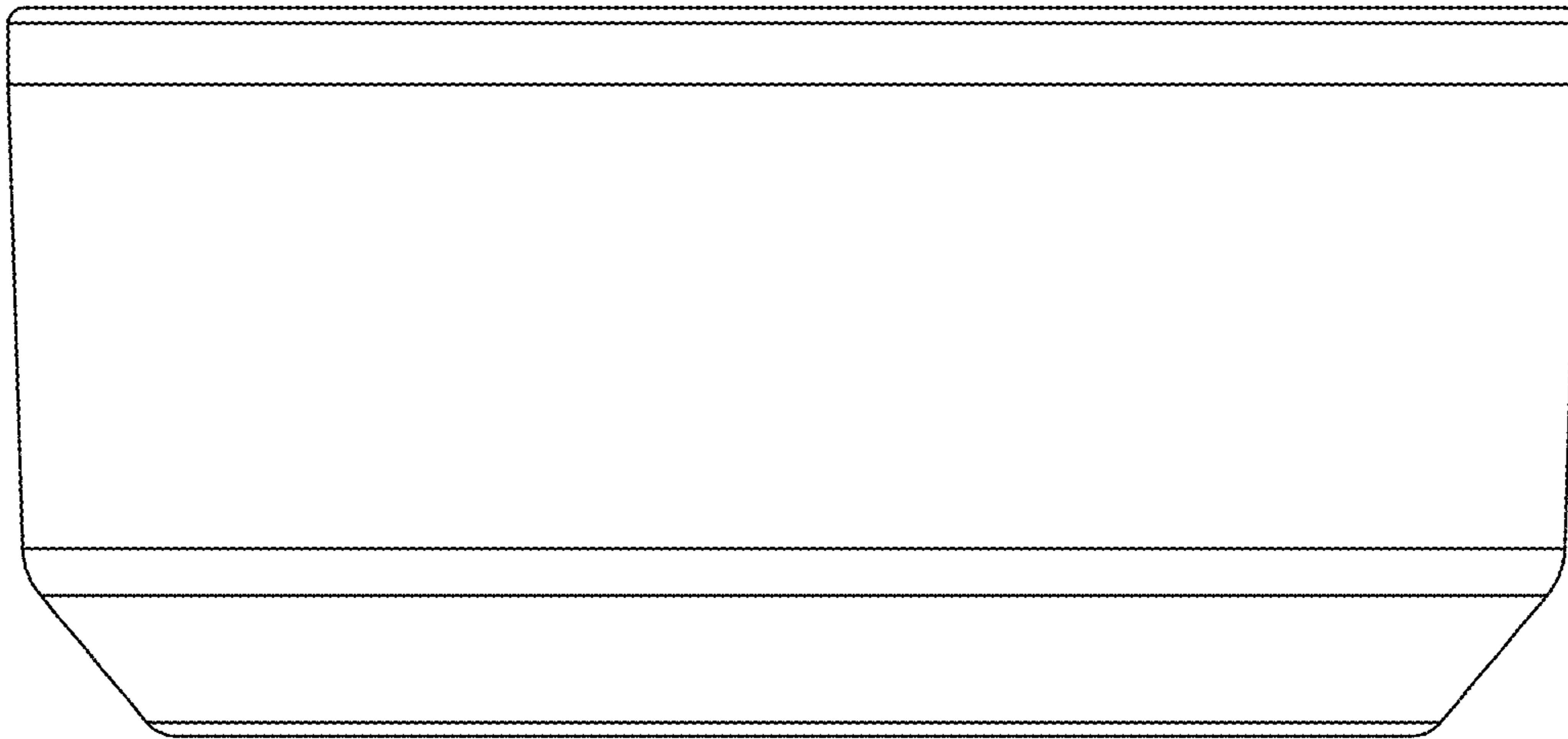

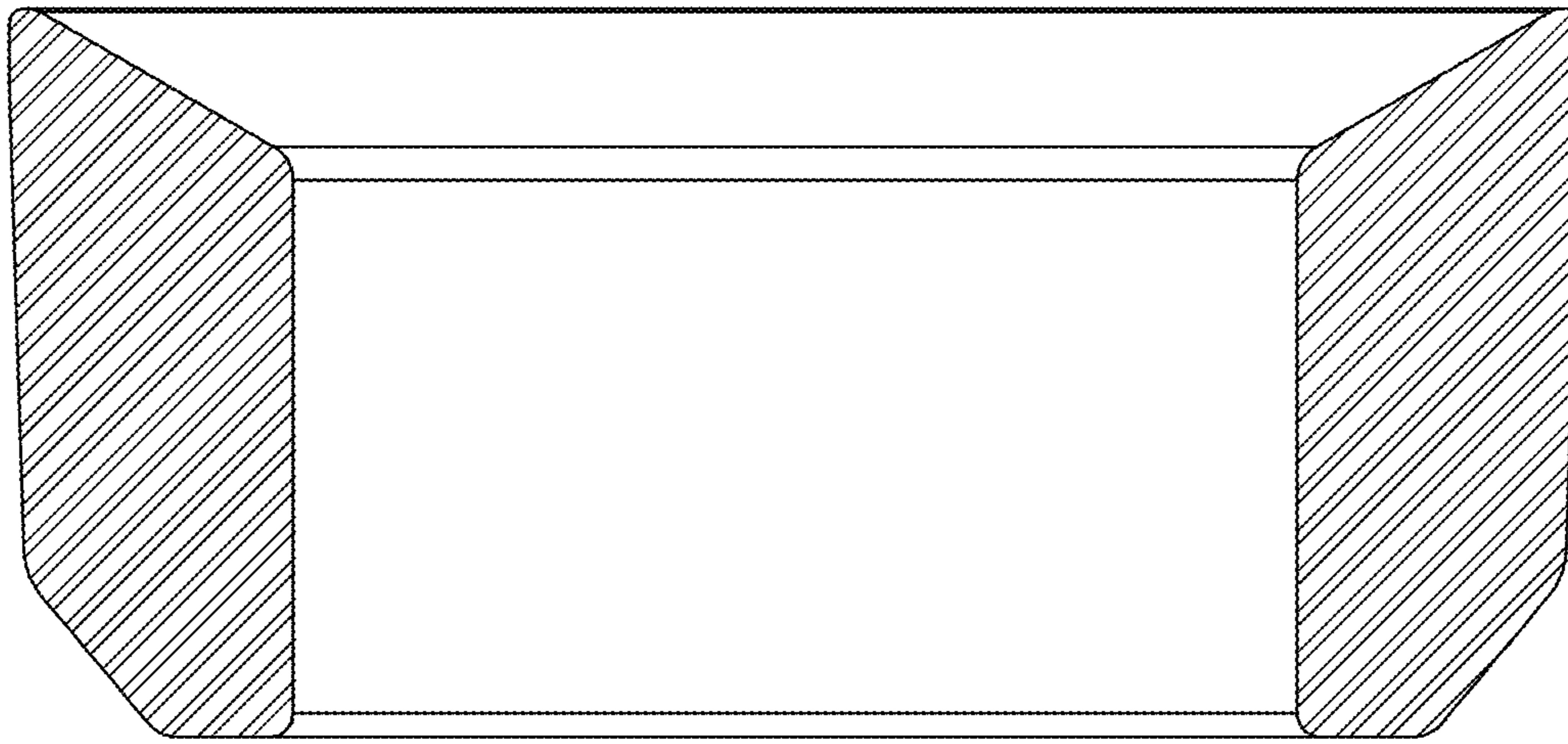

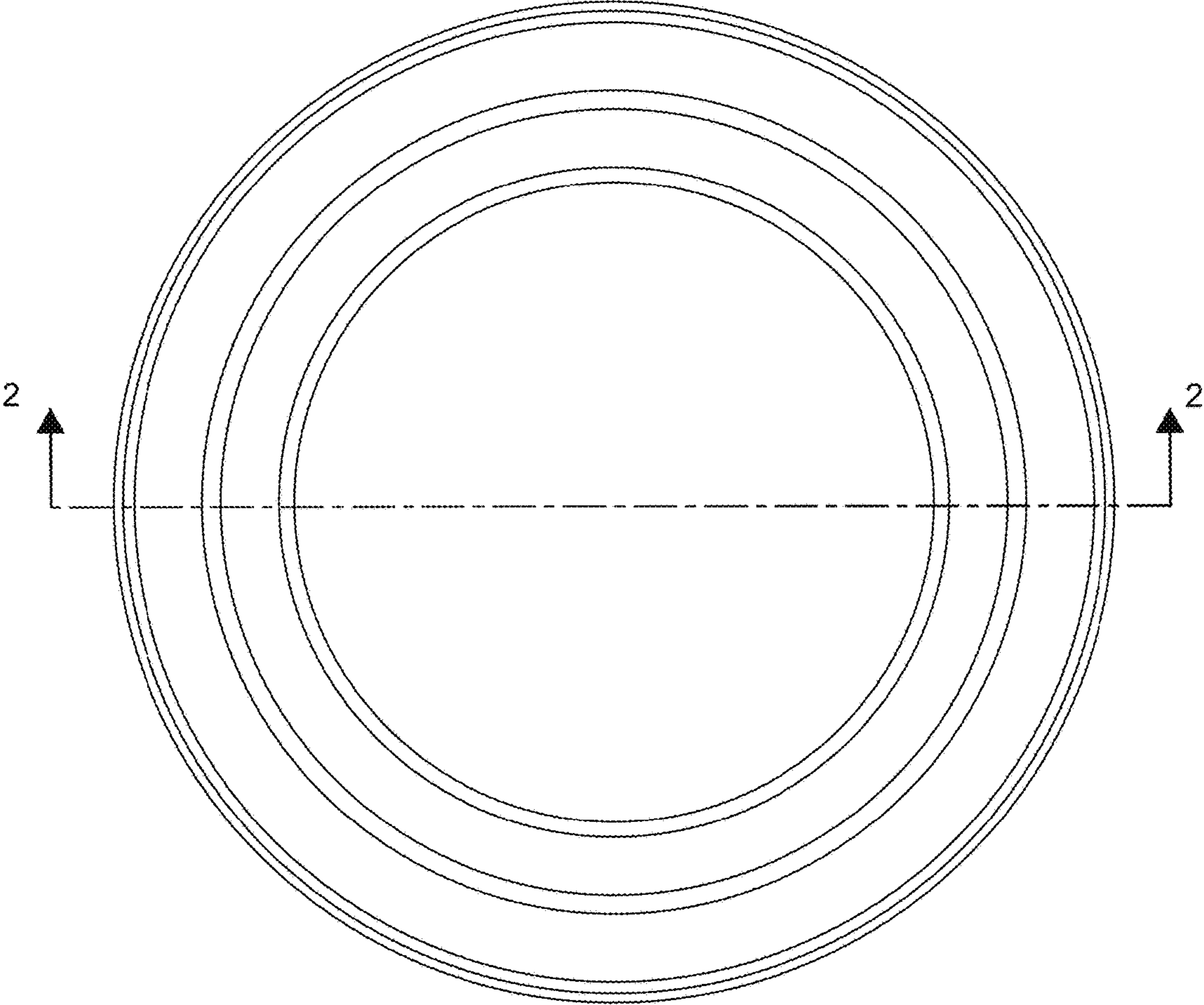

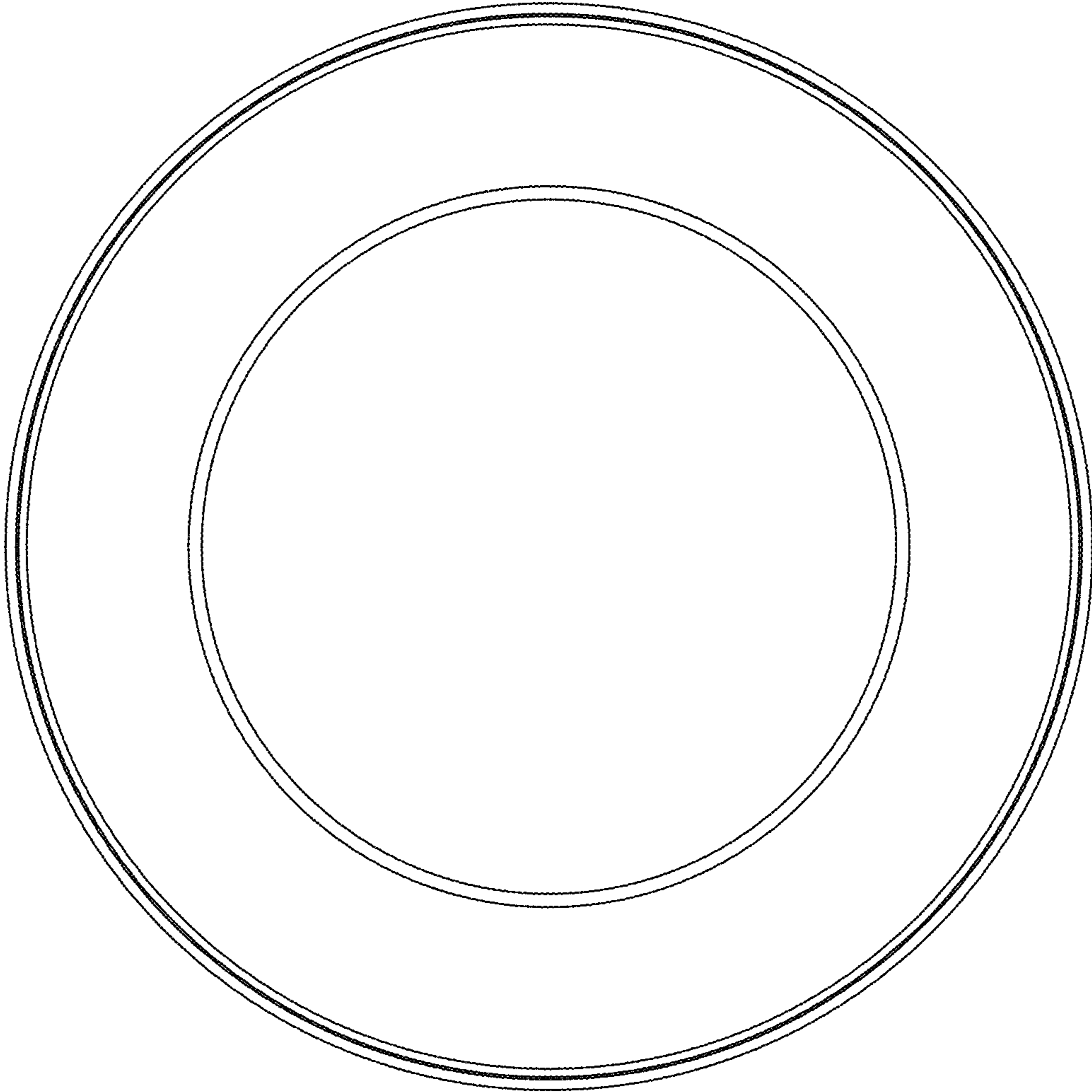

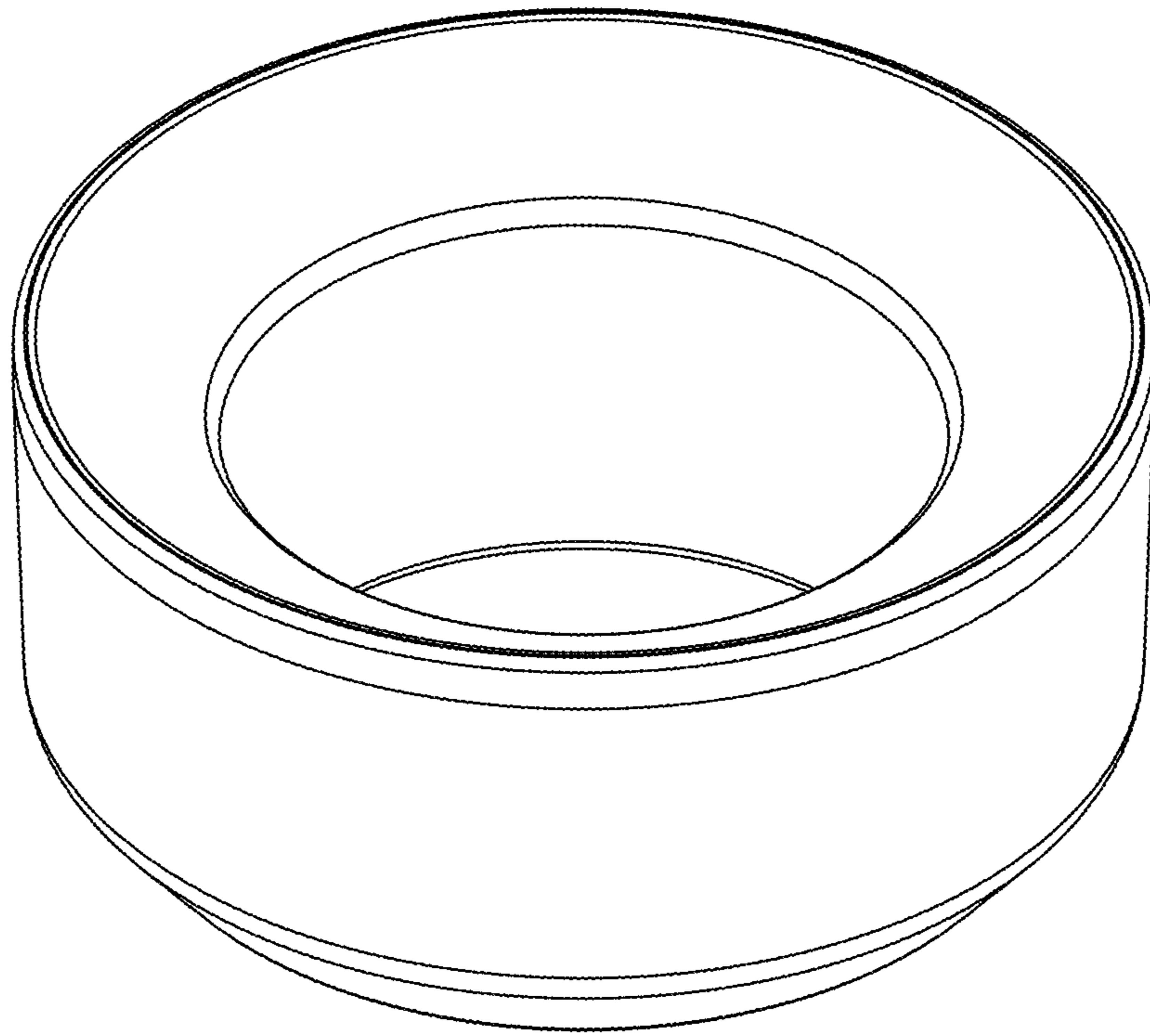

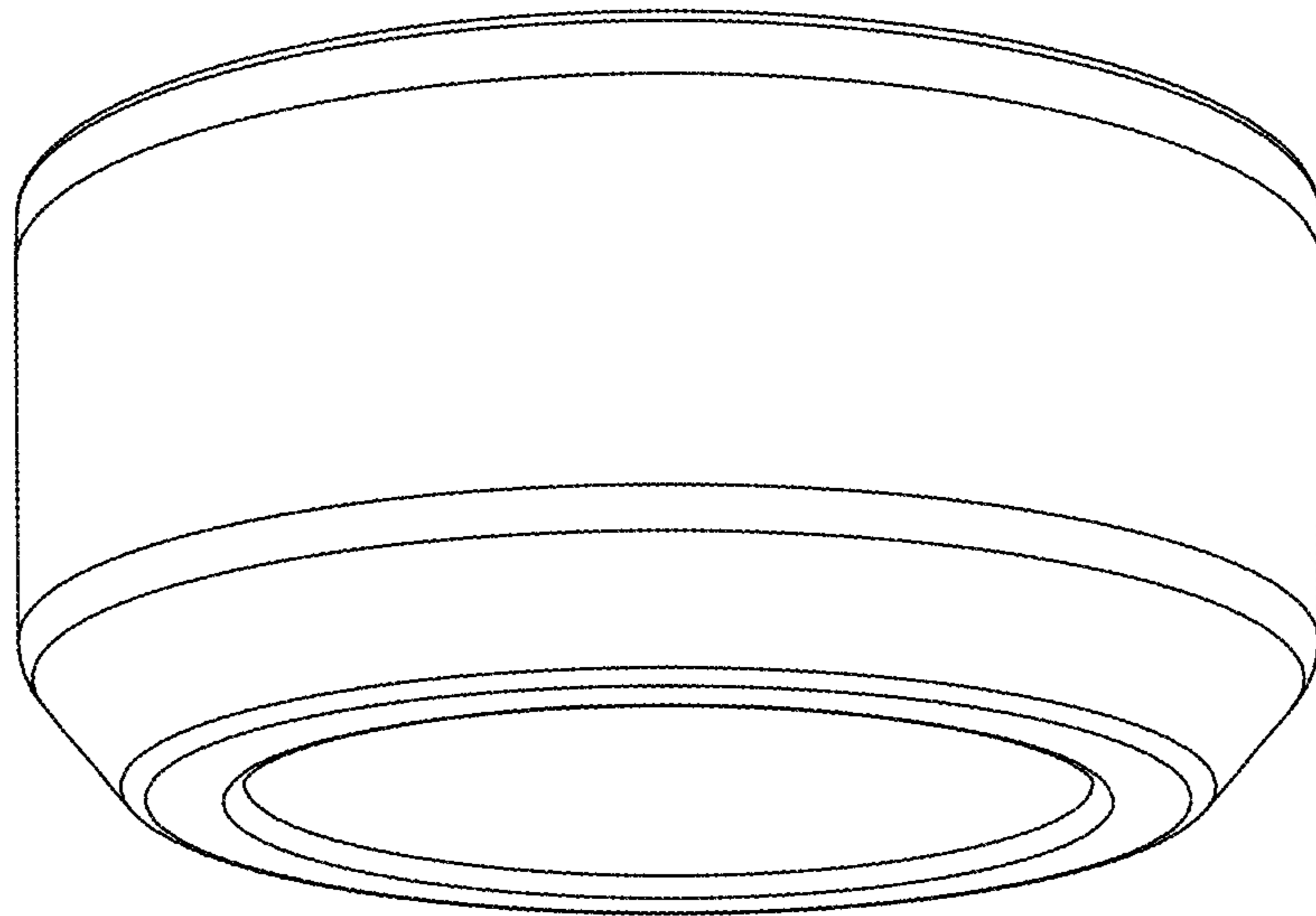
