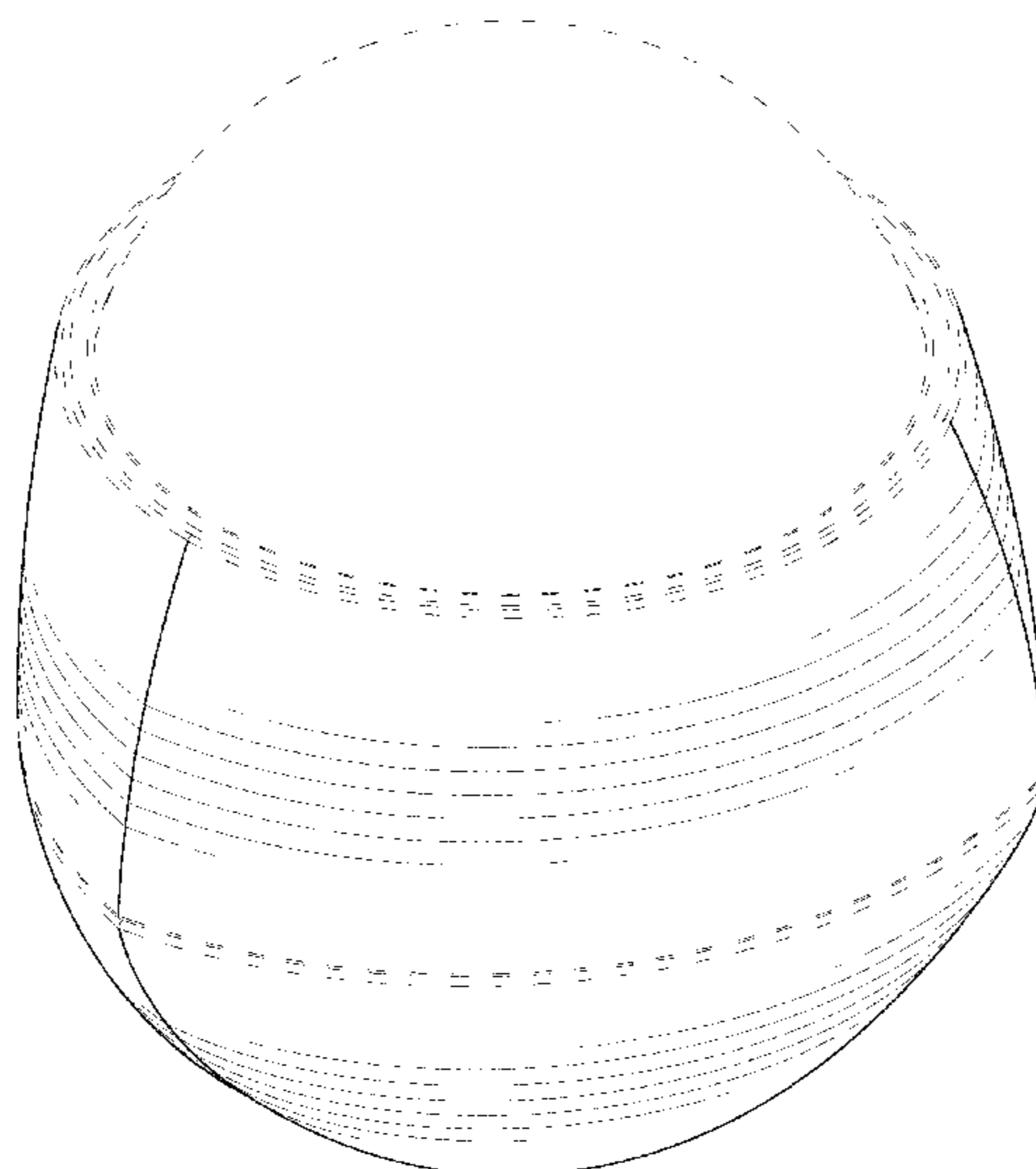
The ornamental design for a ball roller assembly, as shown and described.

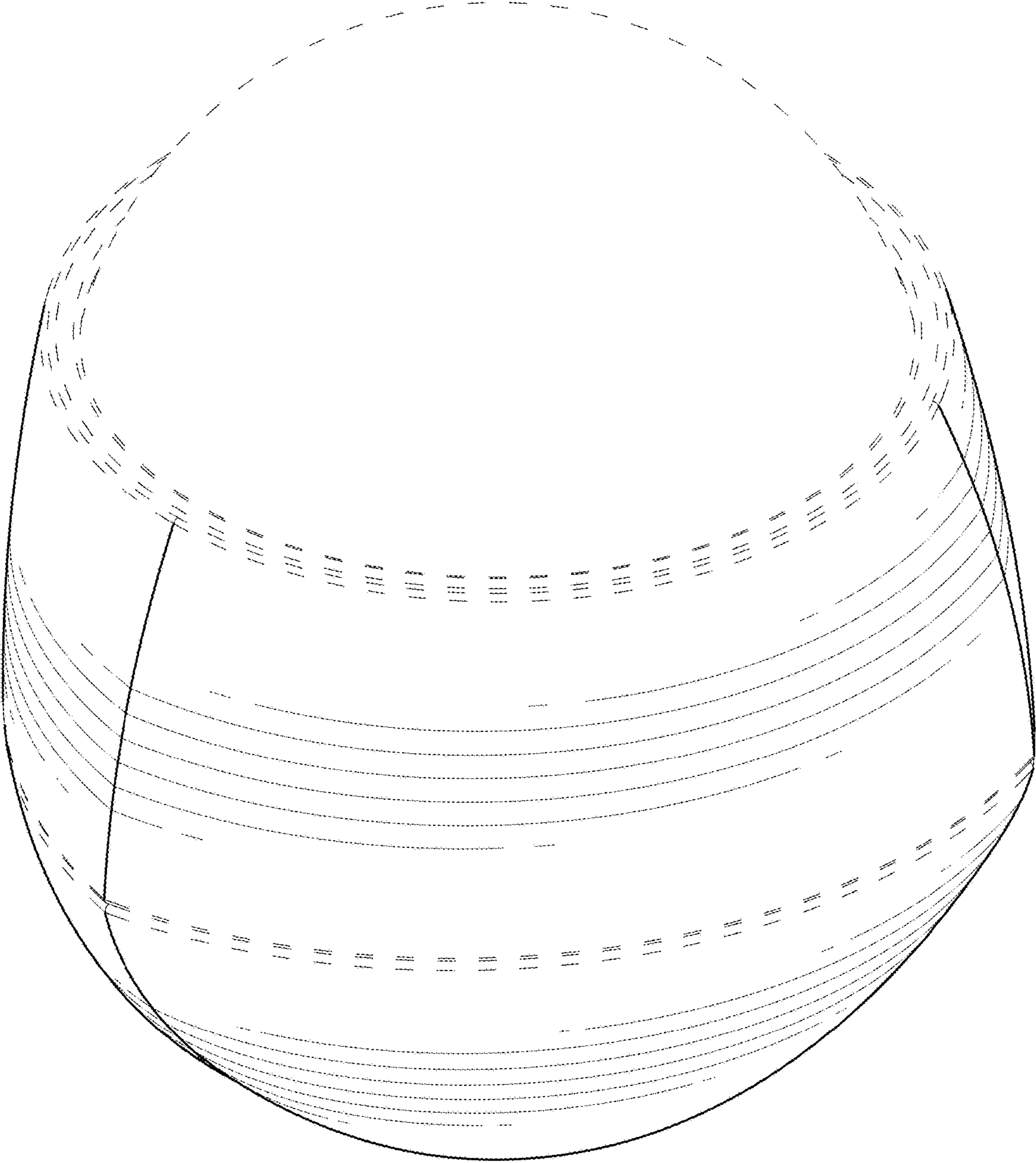

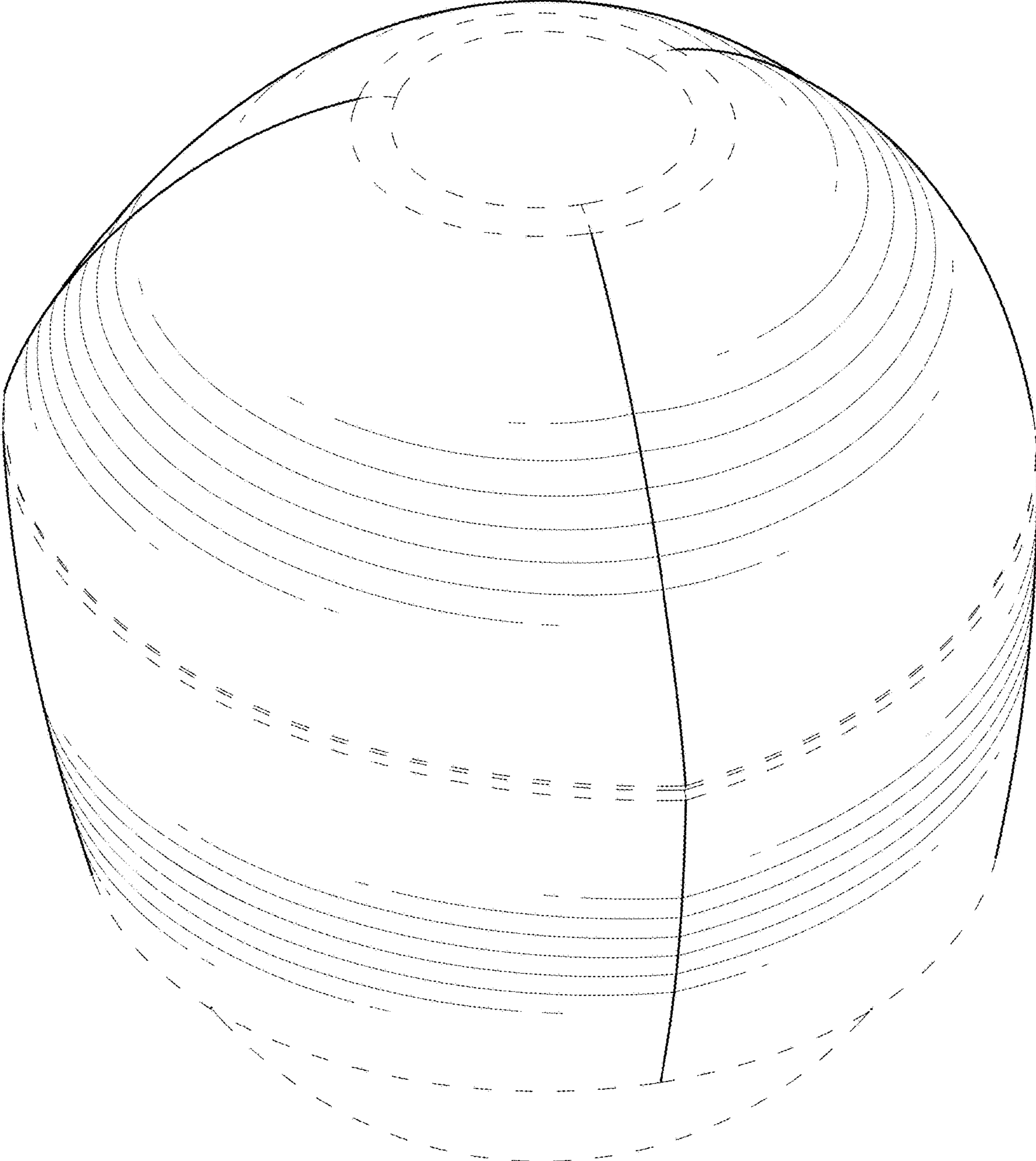

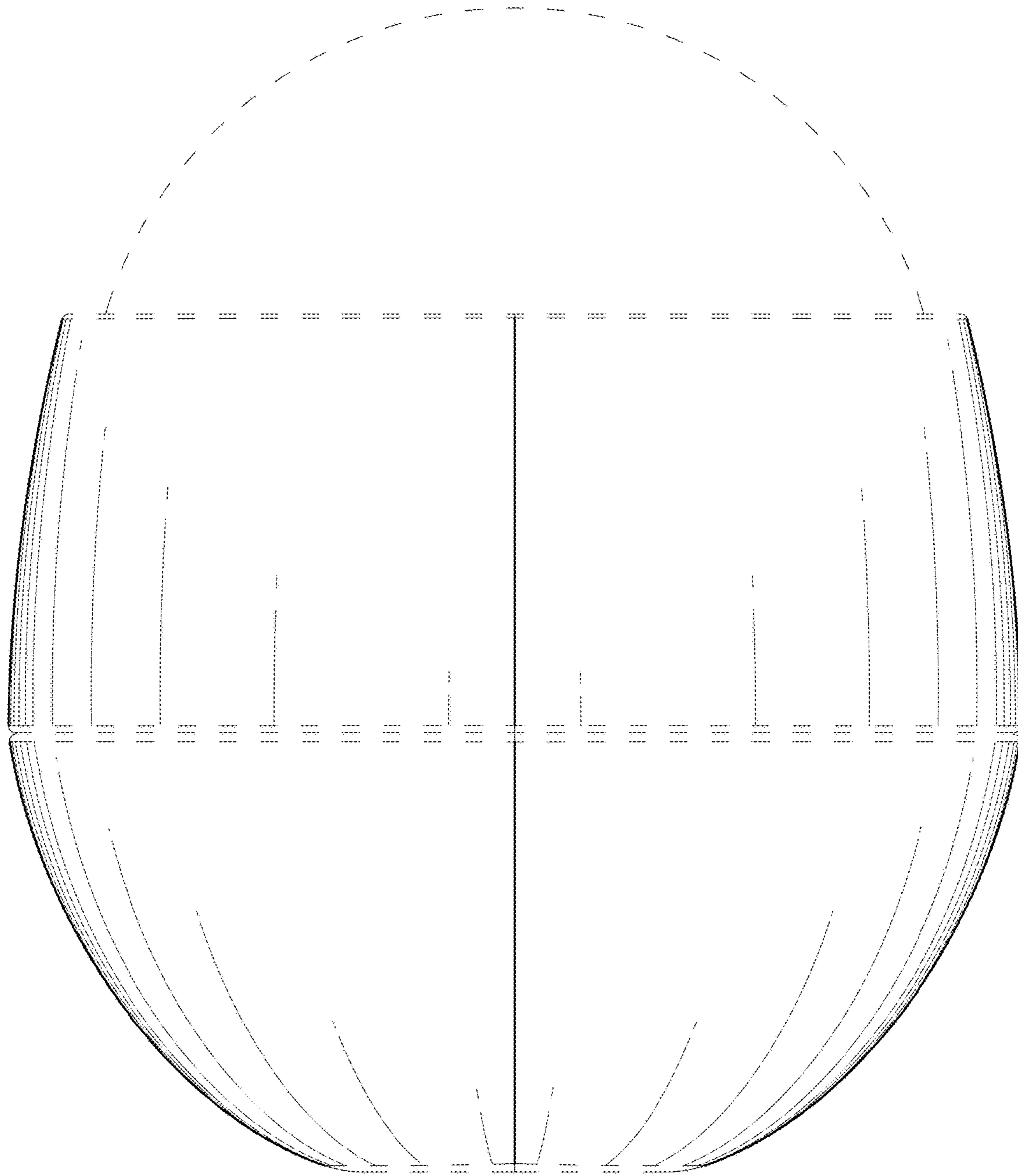

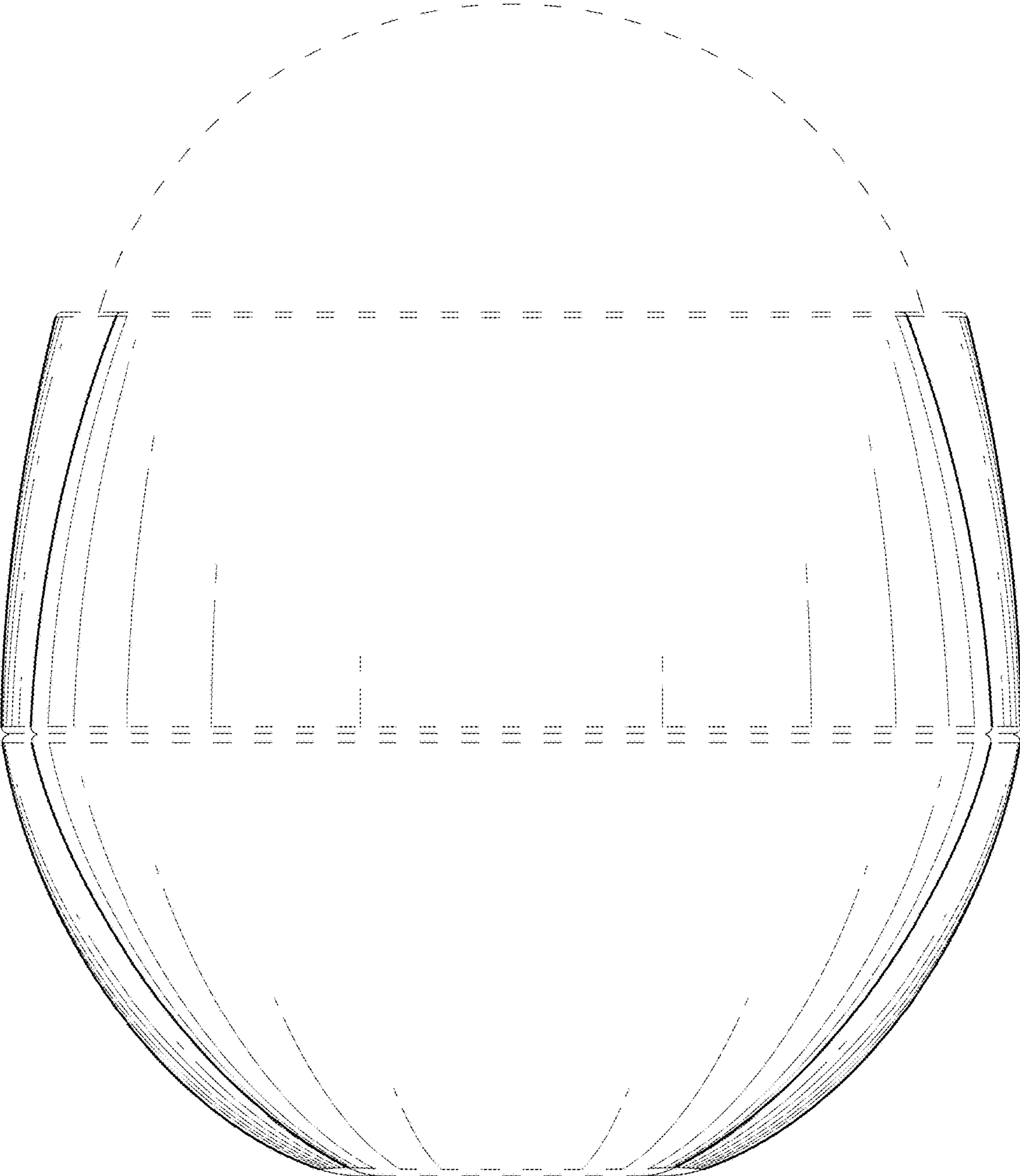

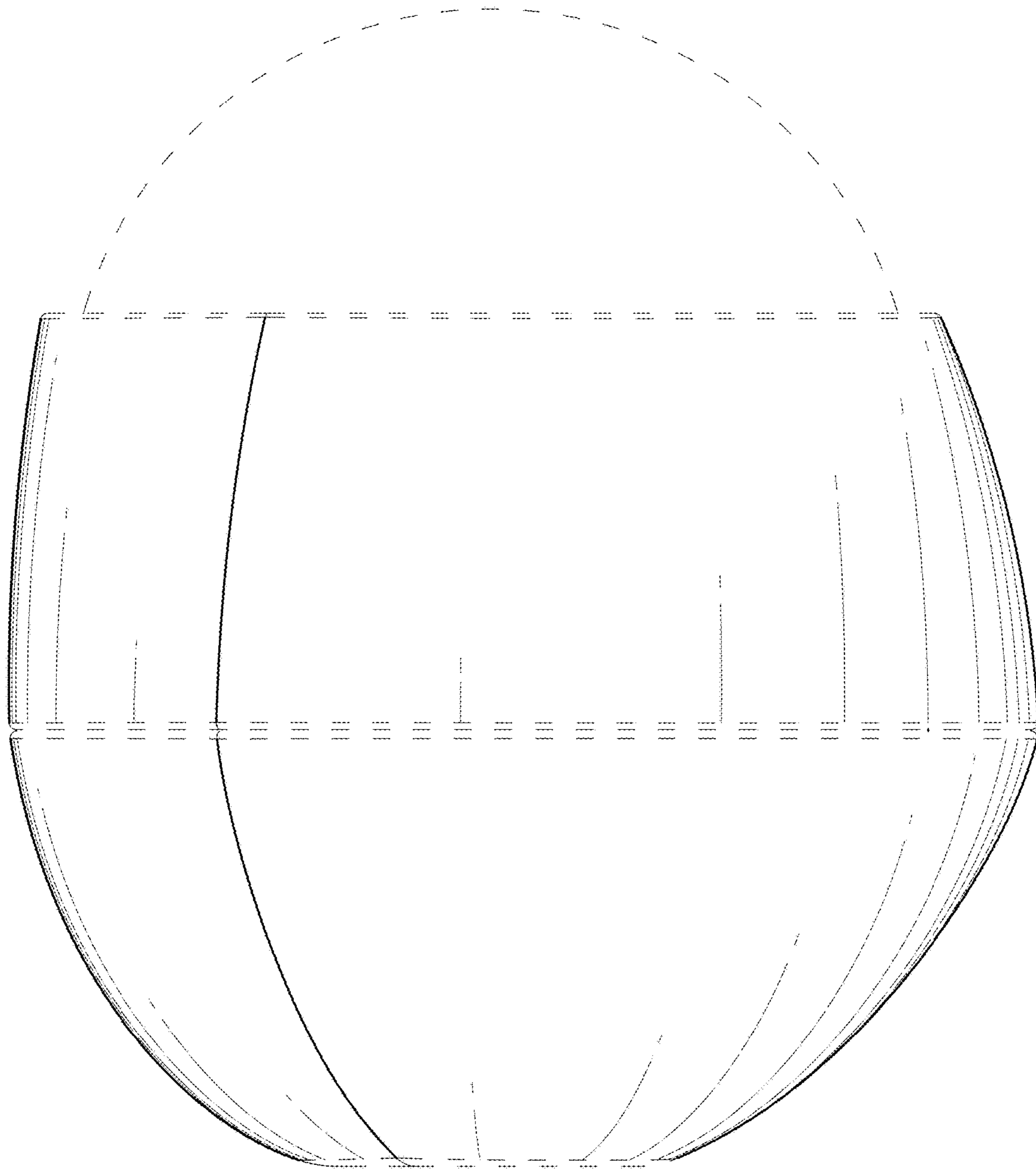

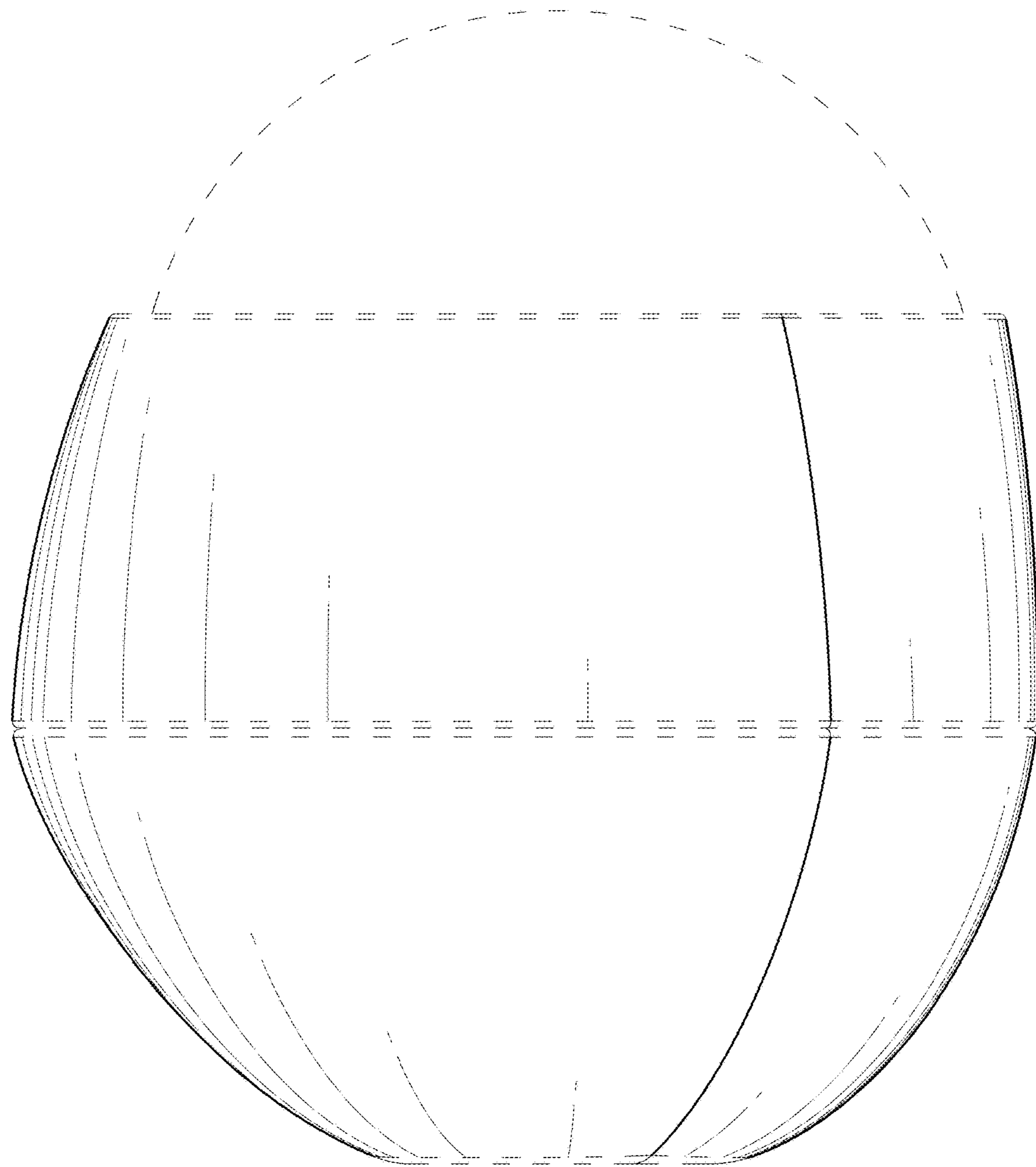

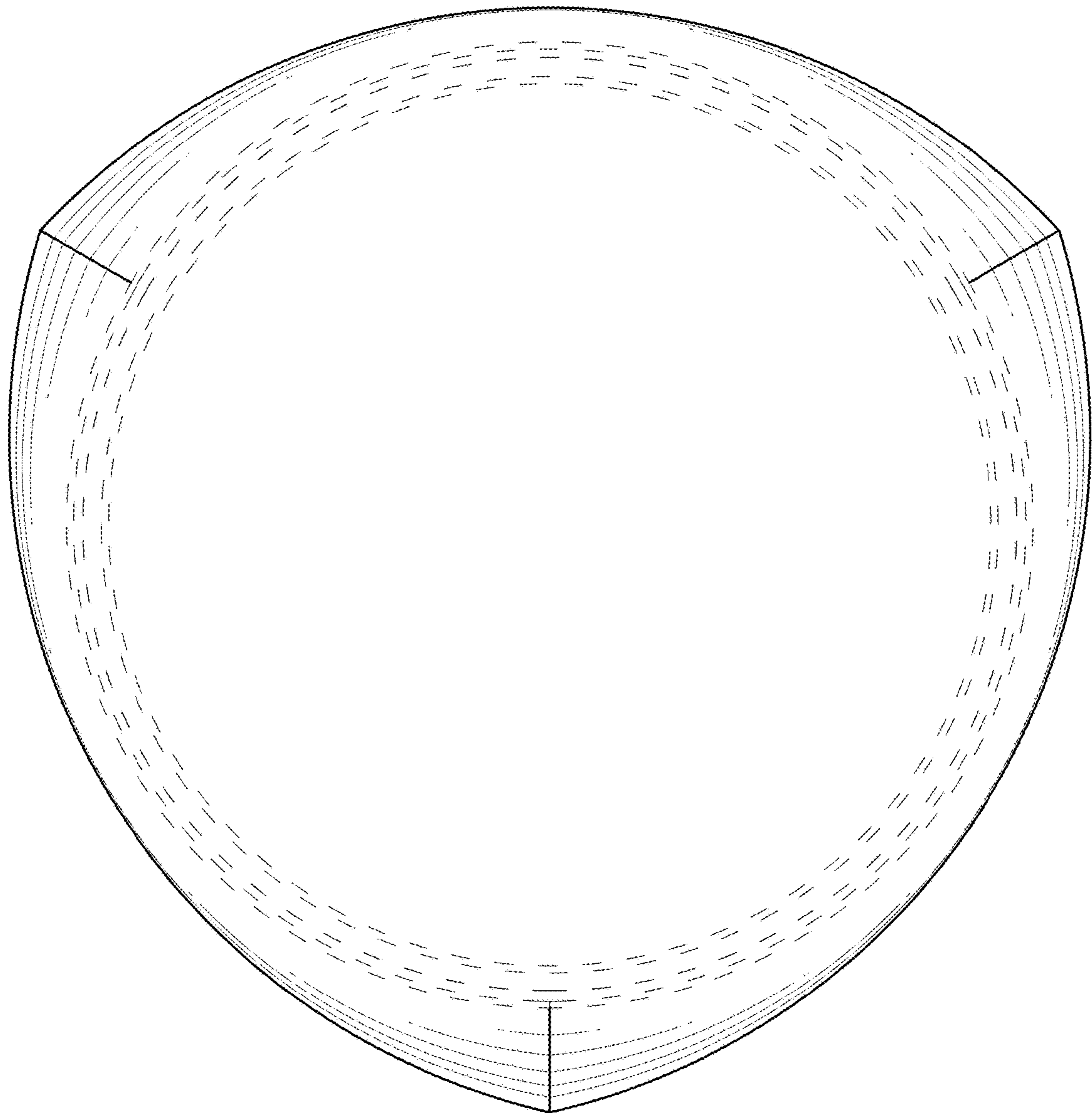

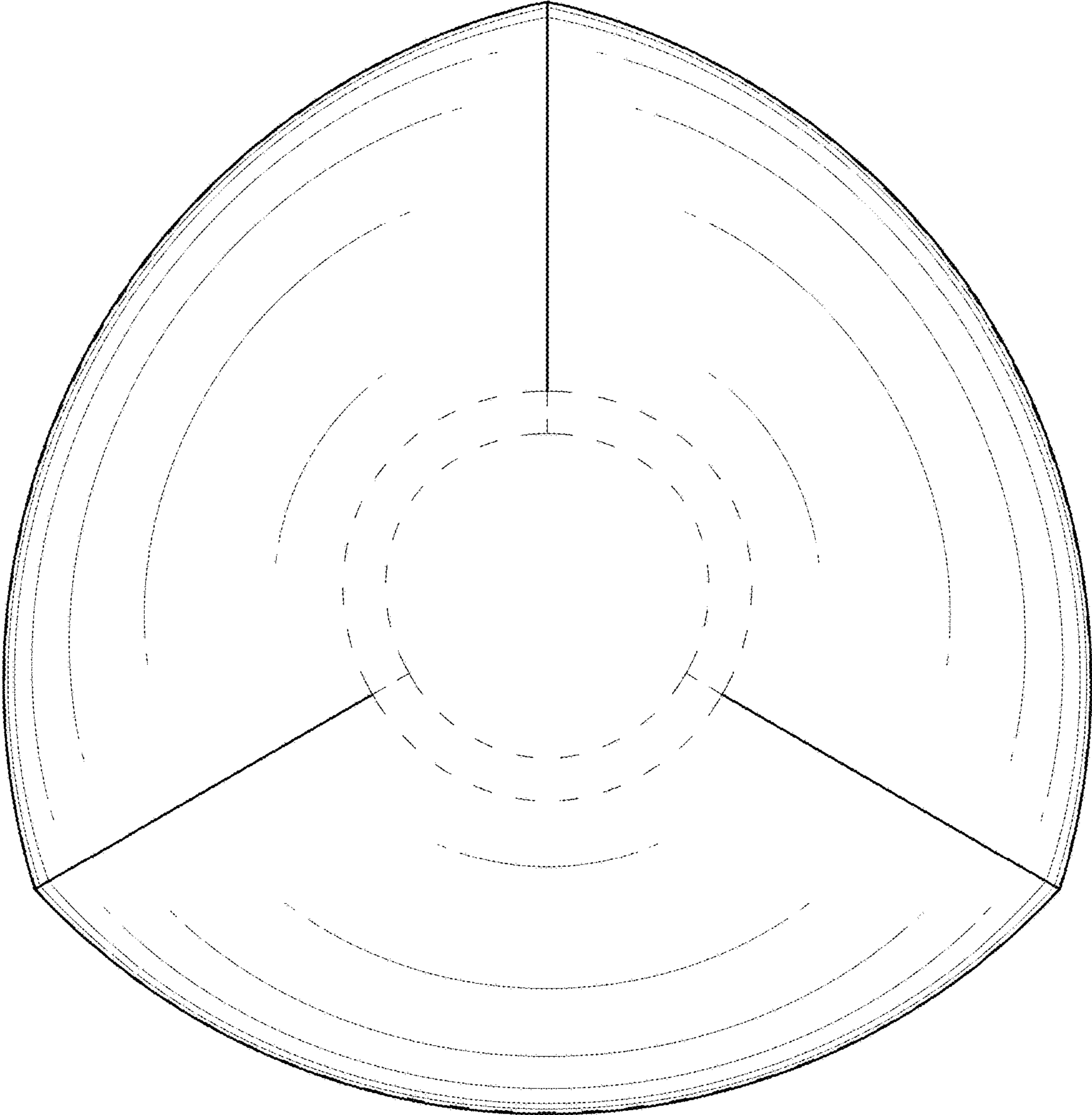
