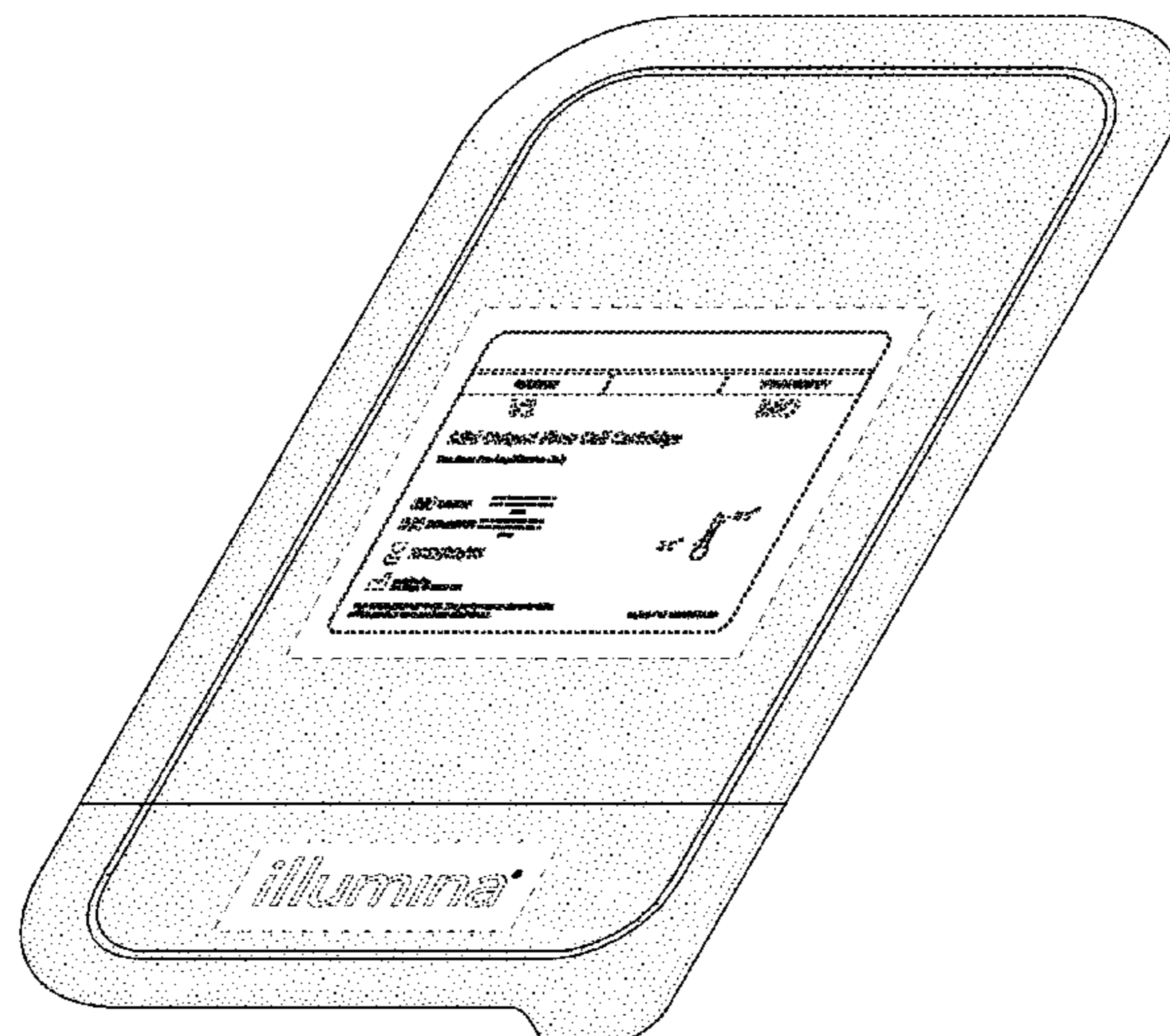
DESCRIPTION

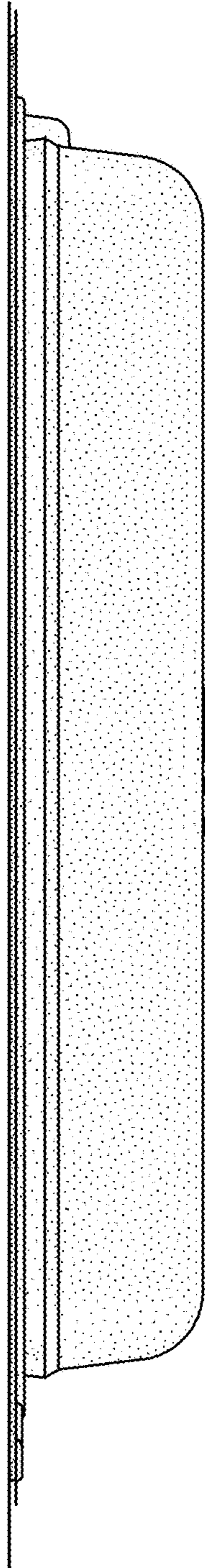

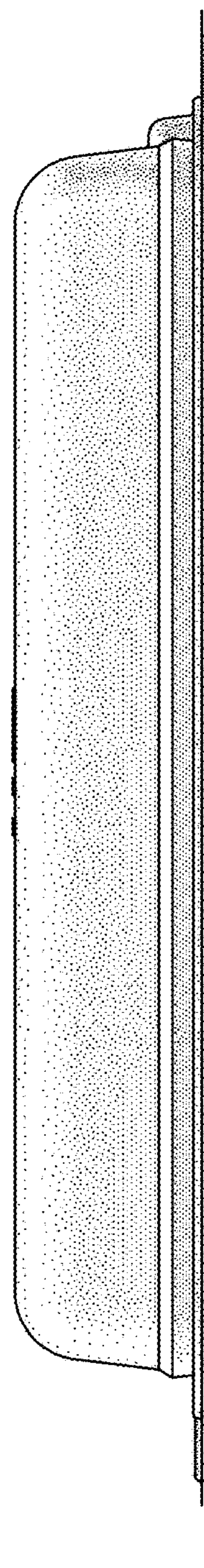

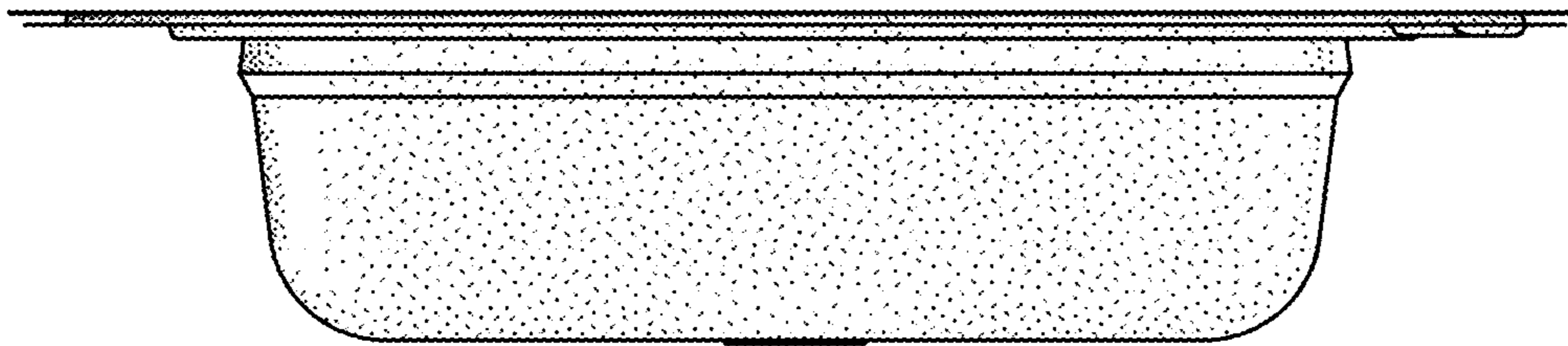

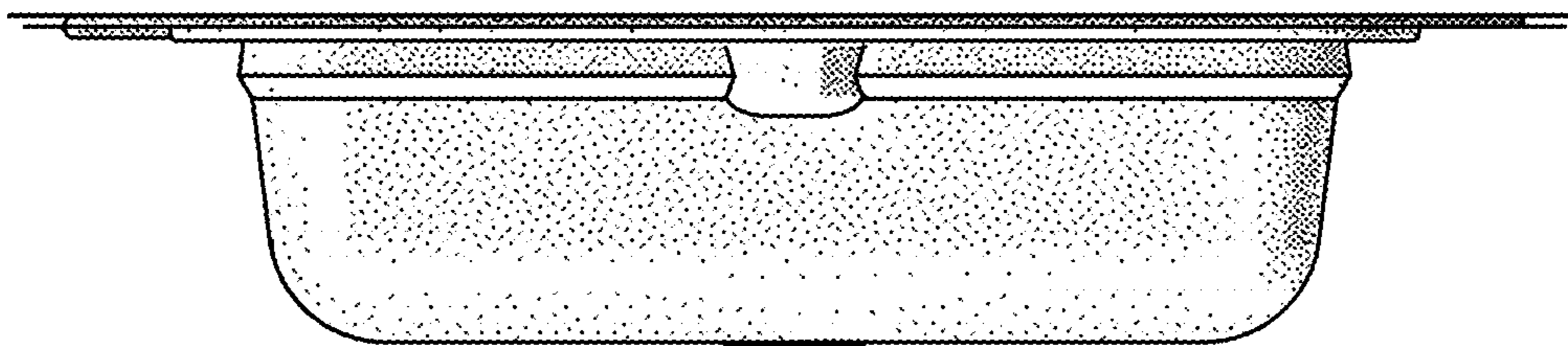

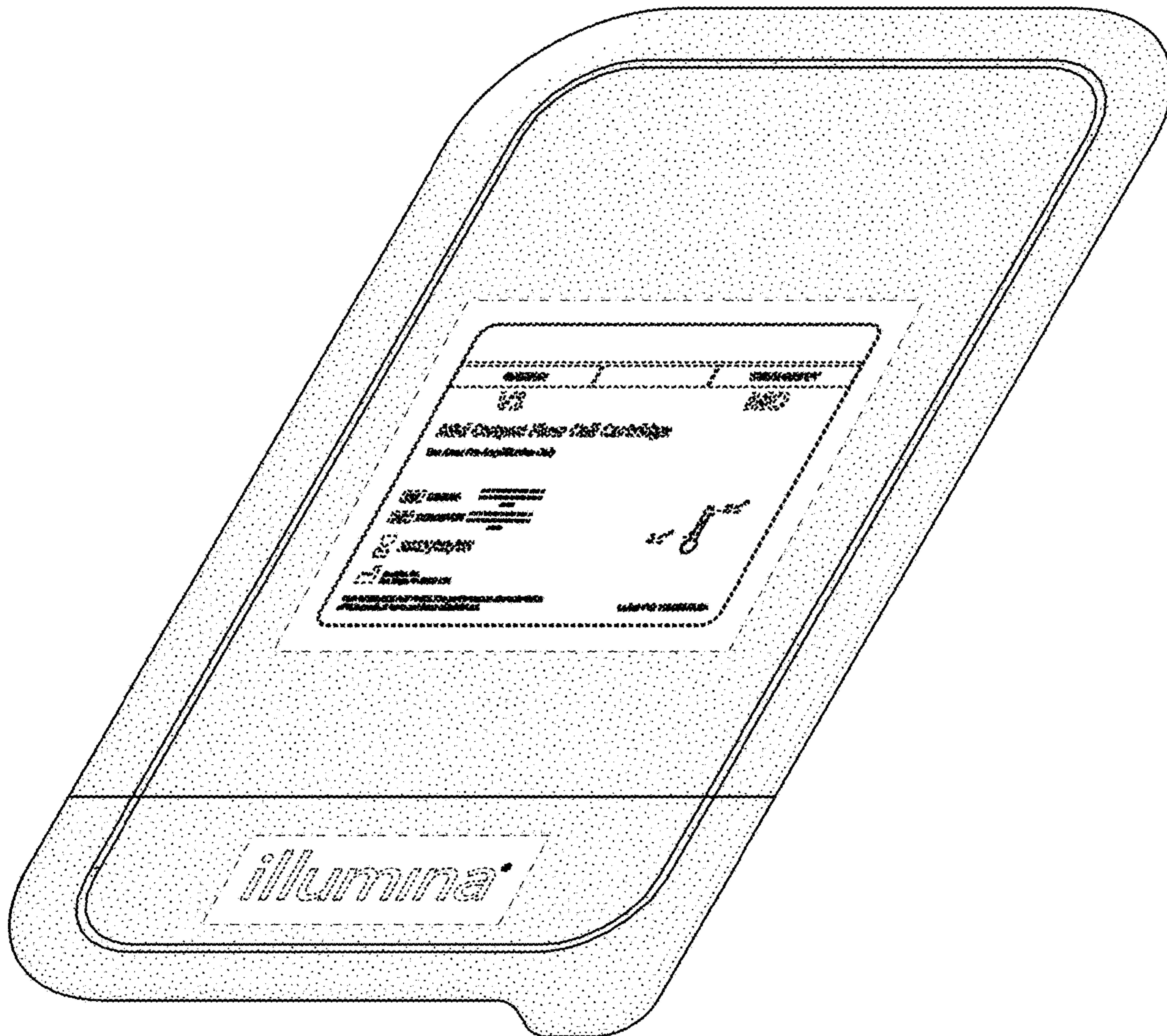

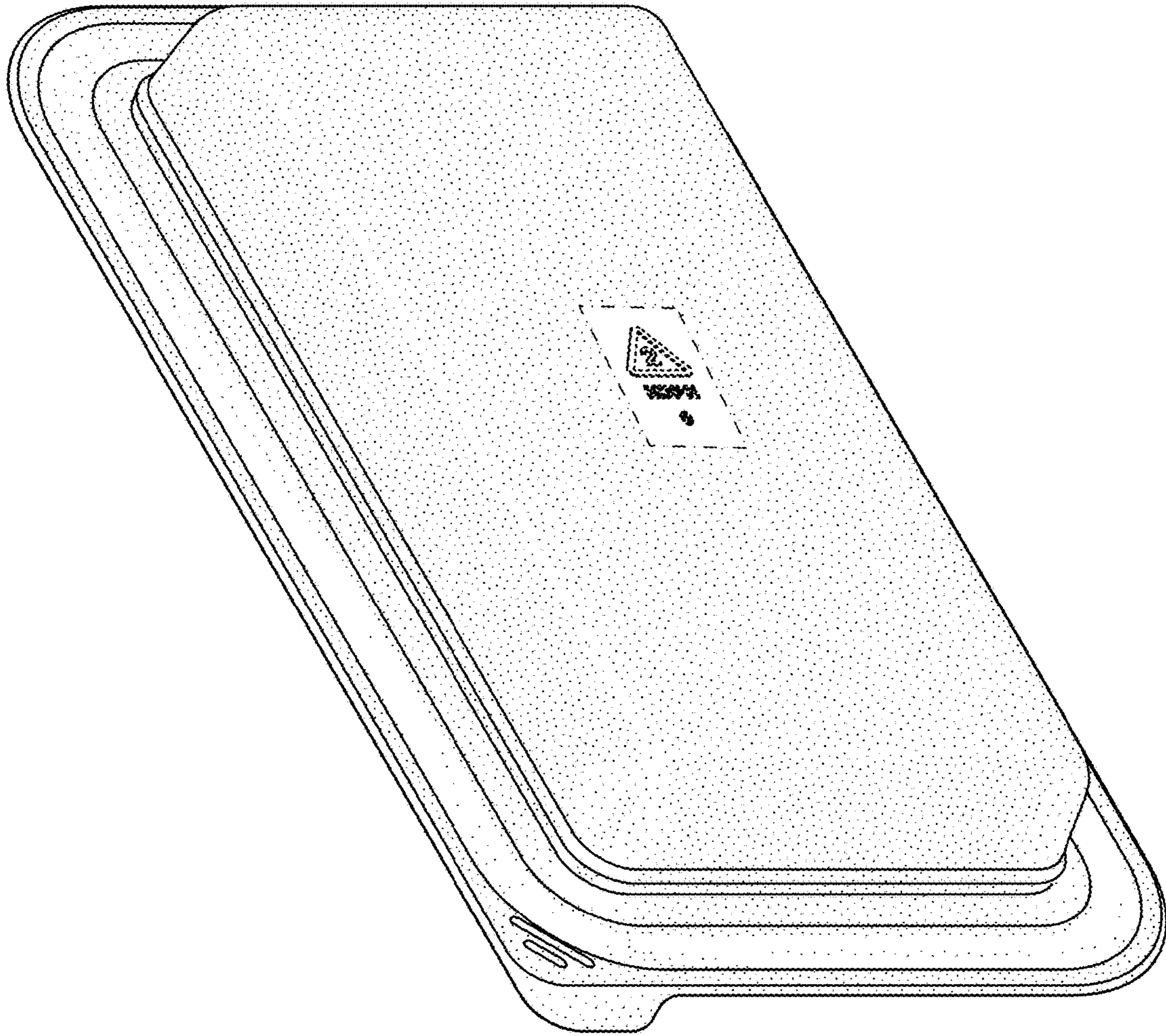

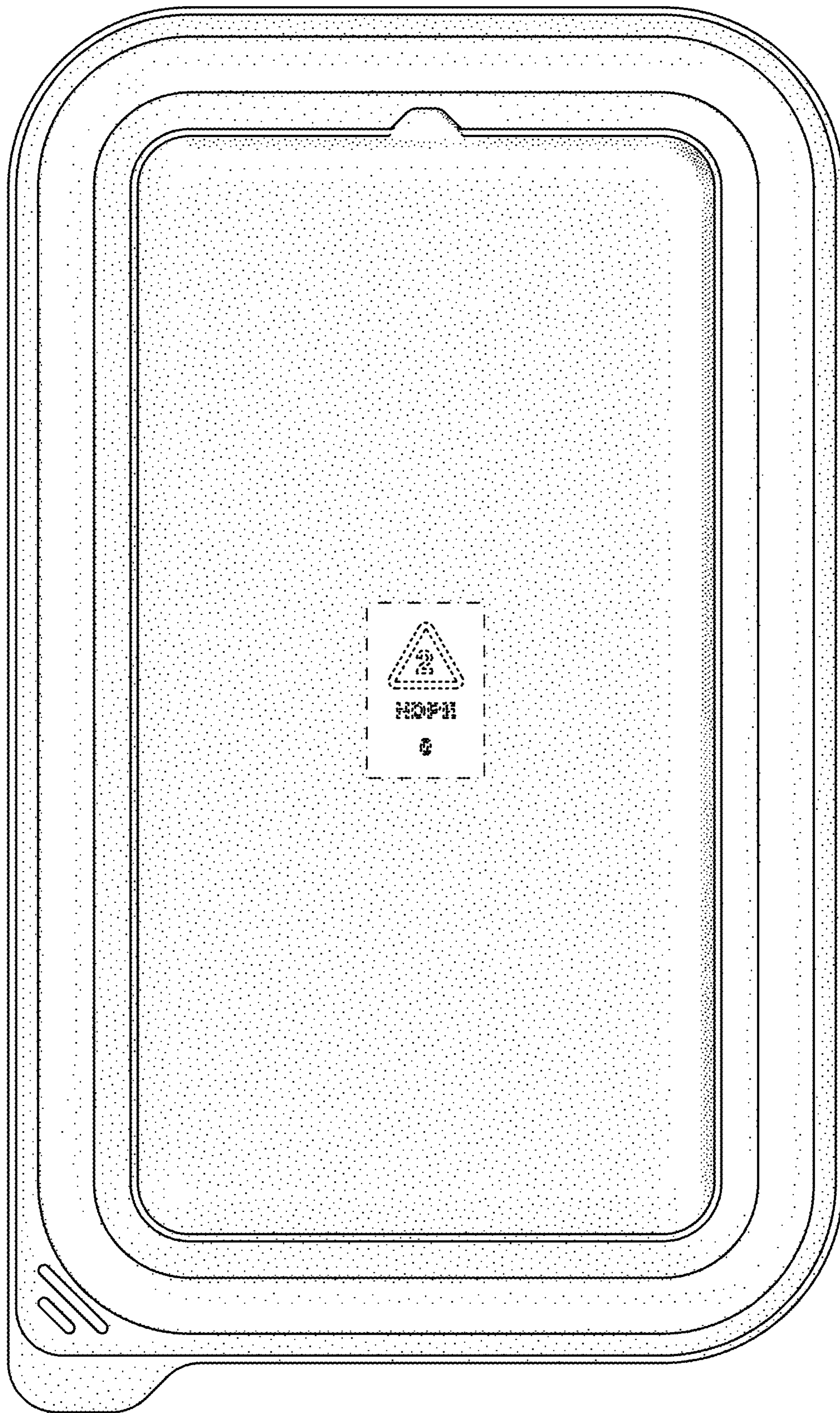

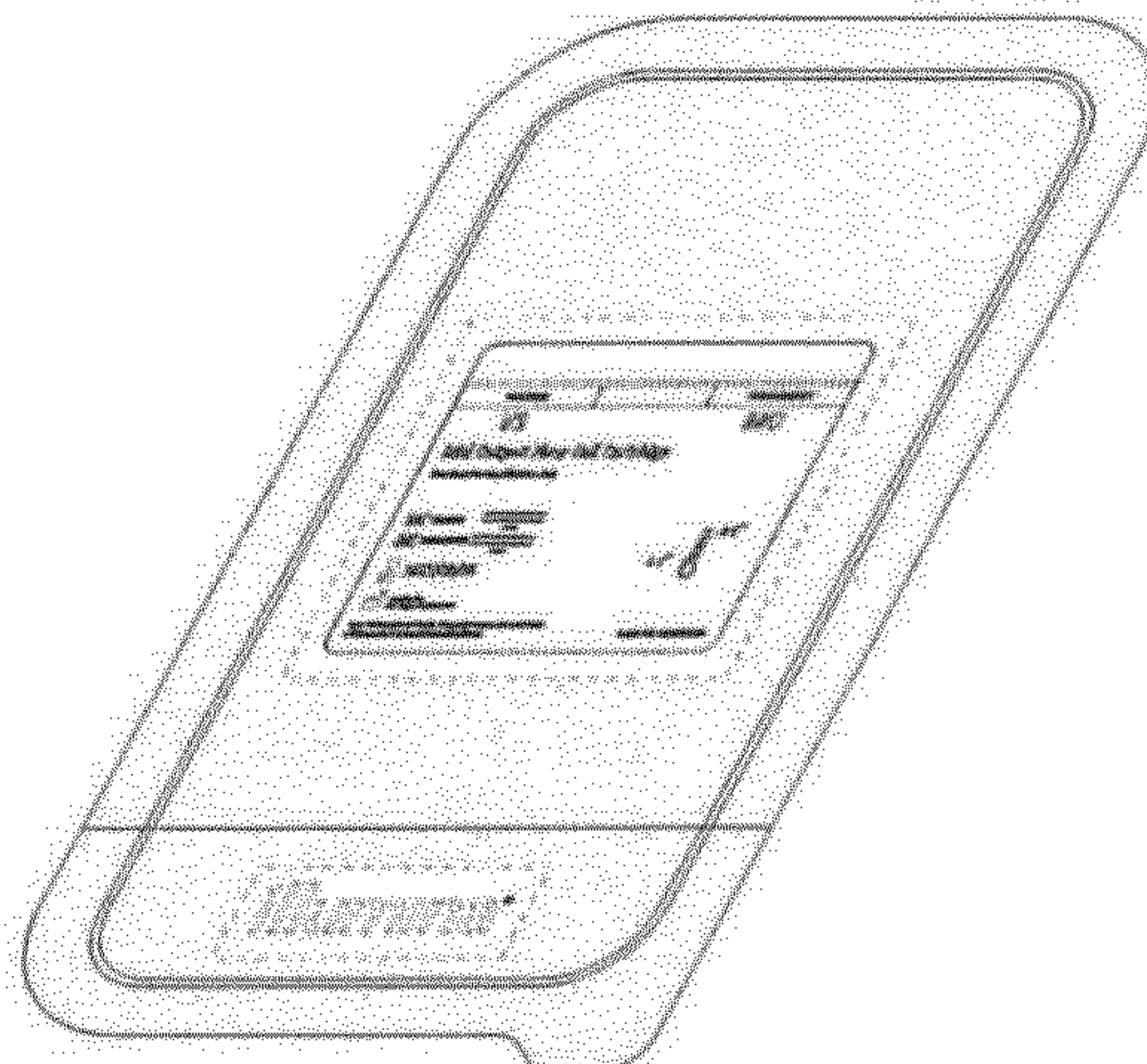

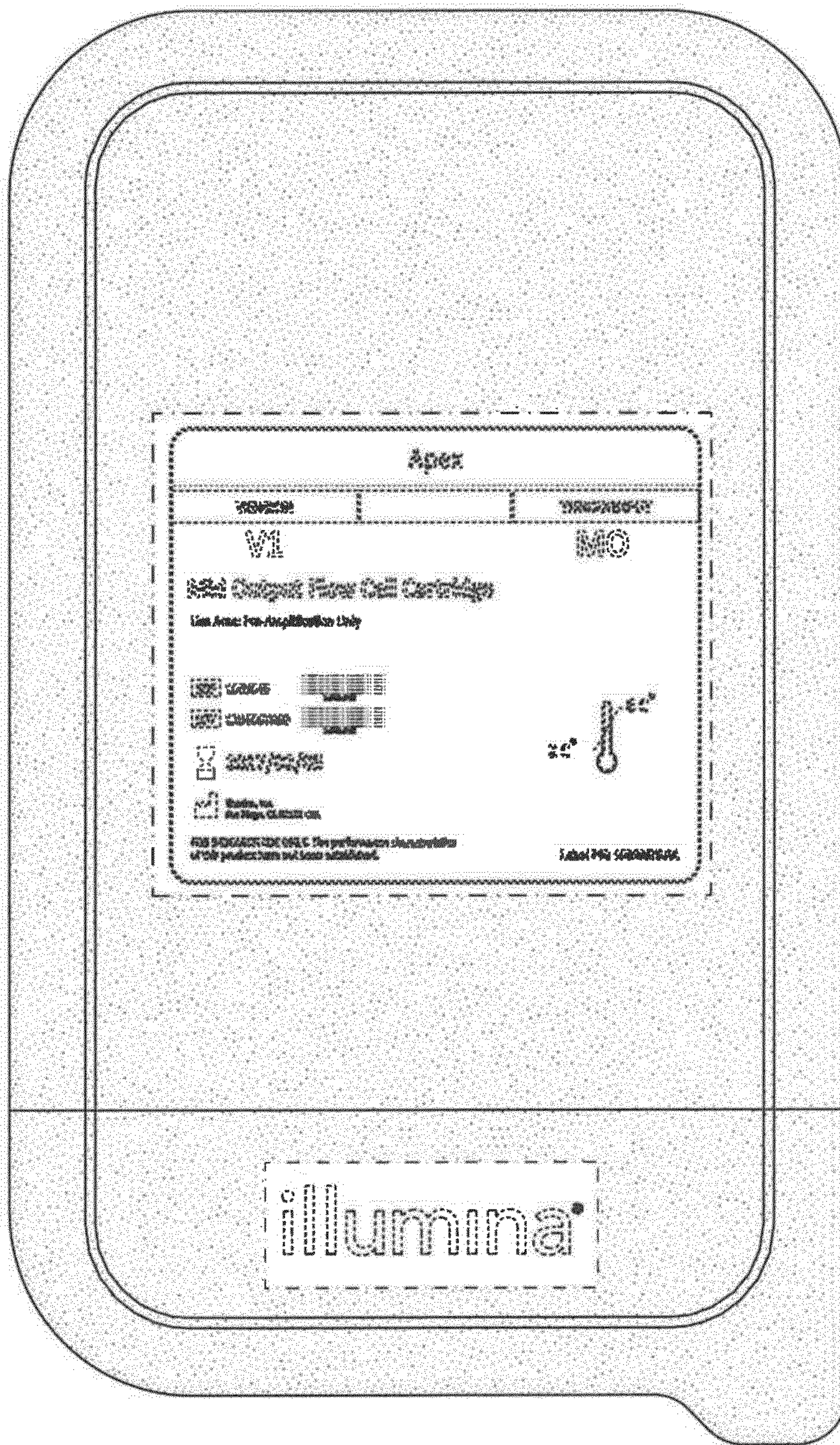

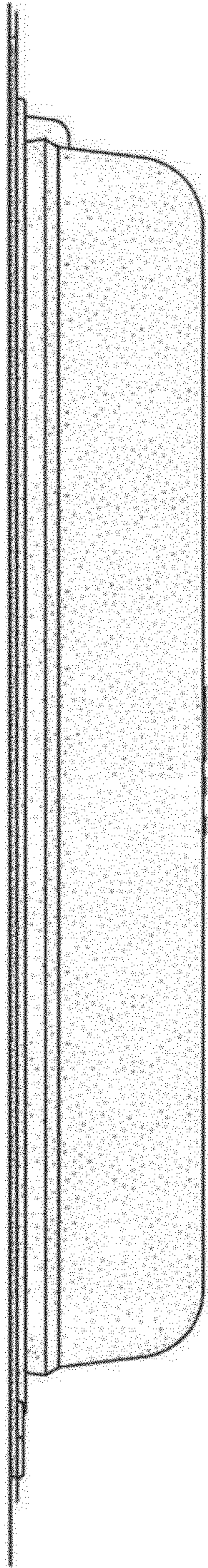

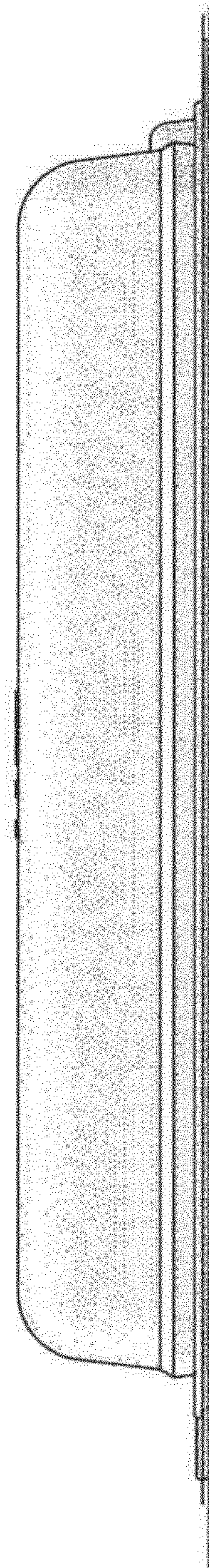

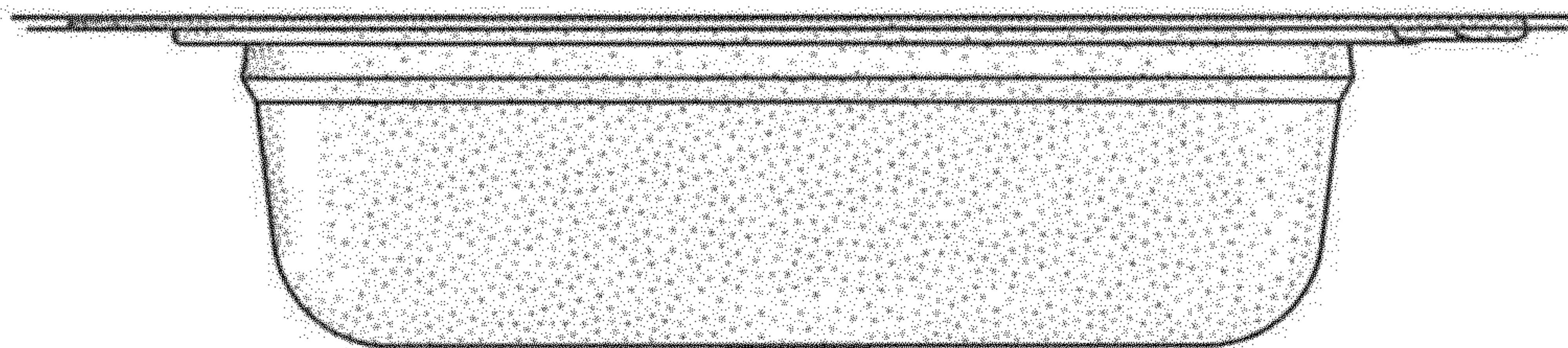

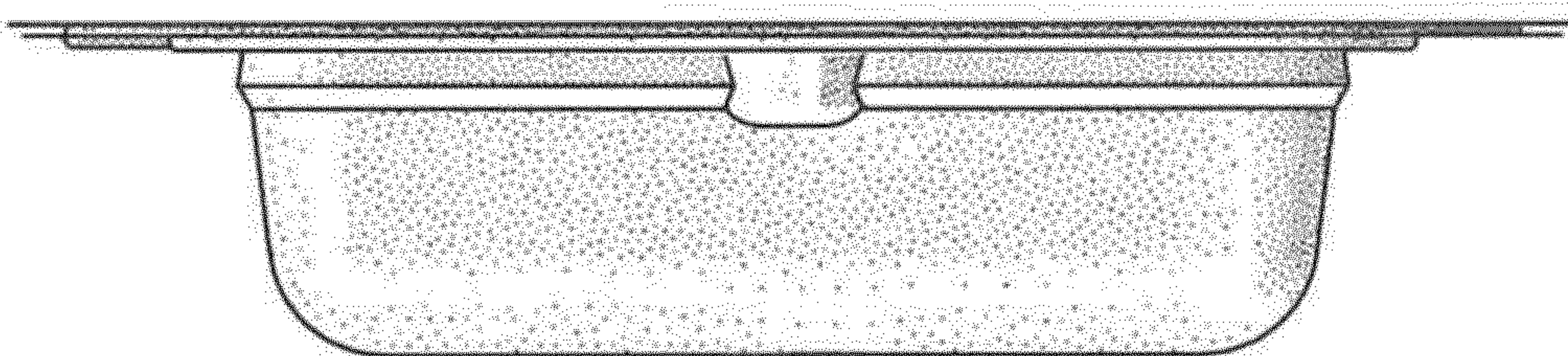

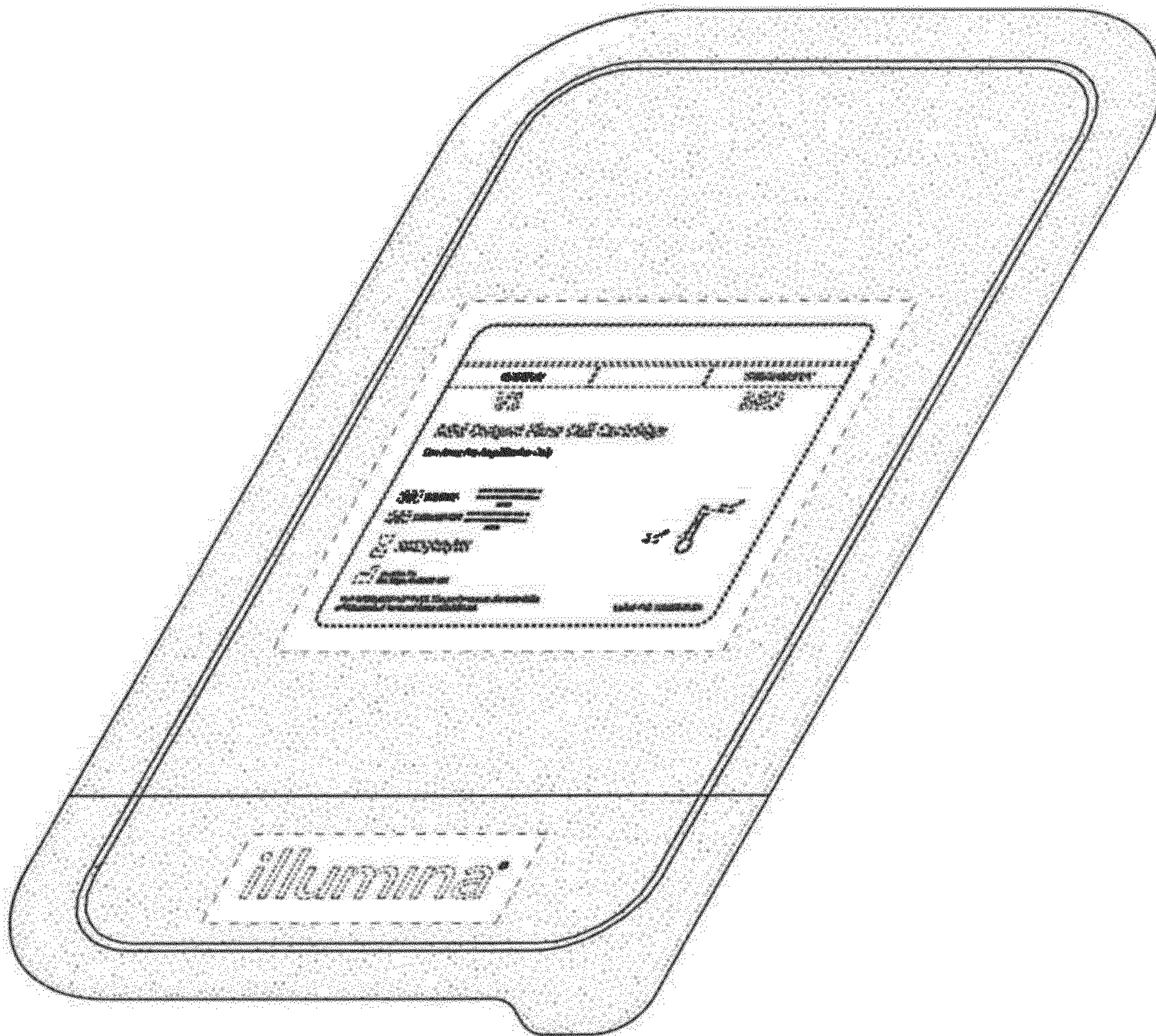

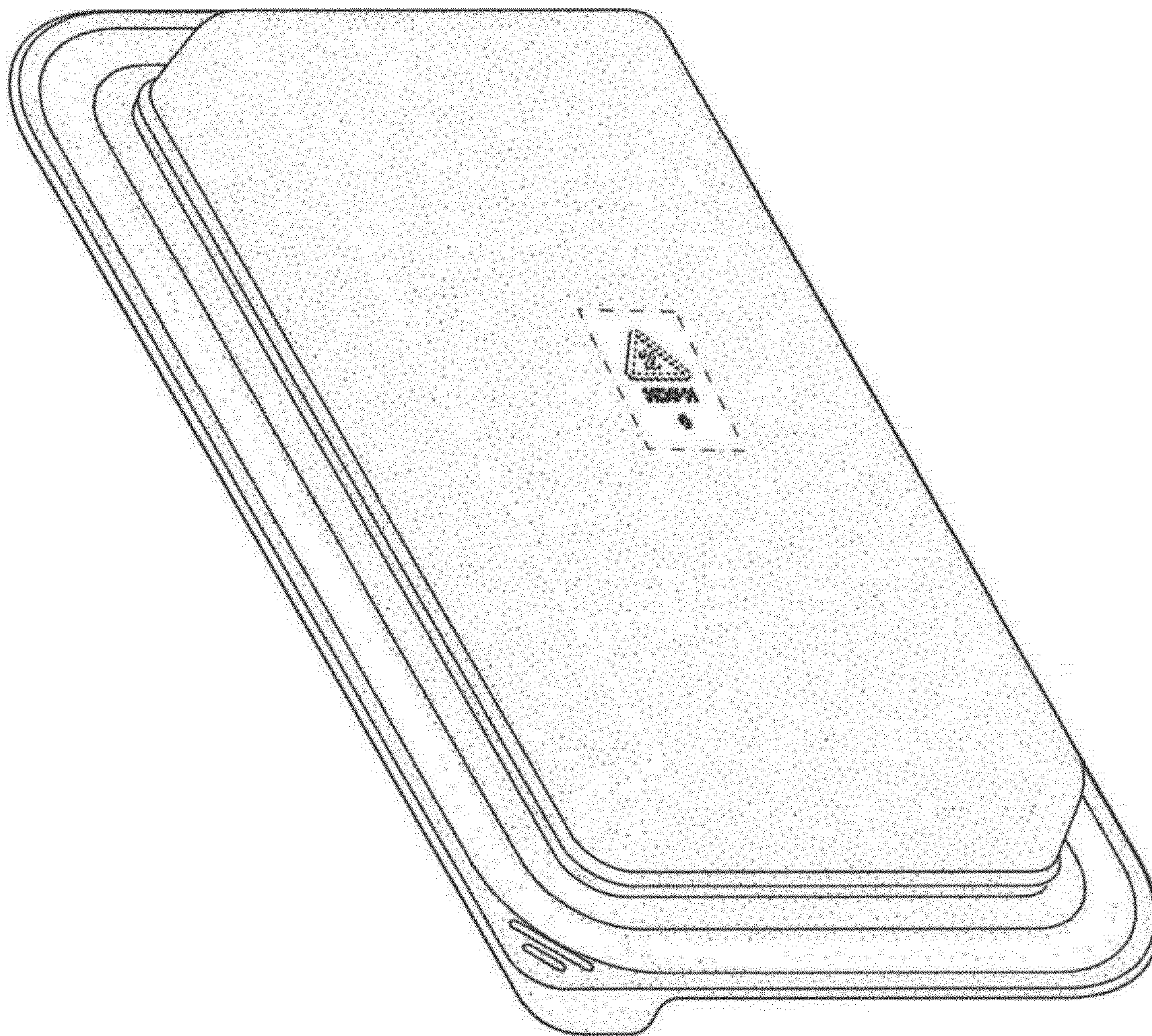

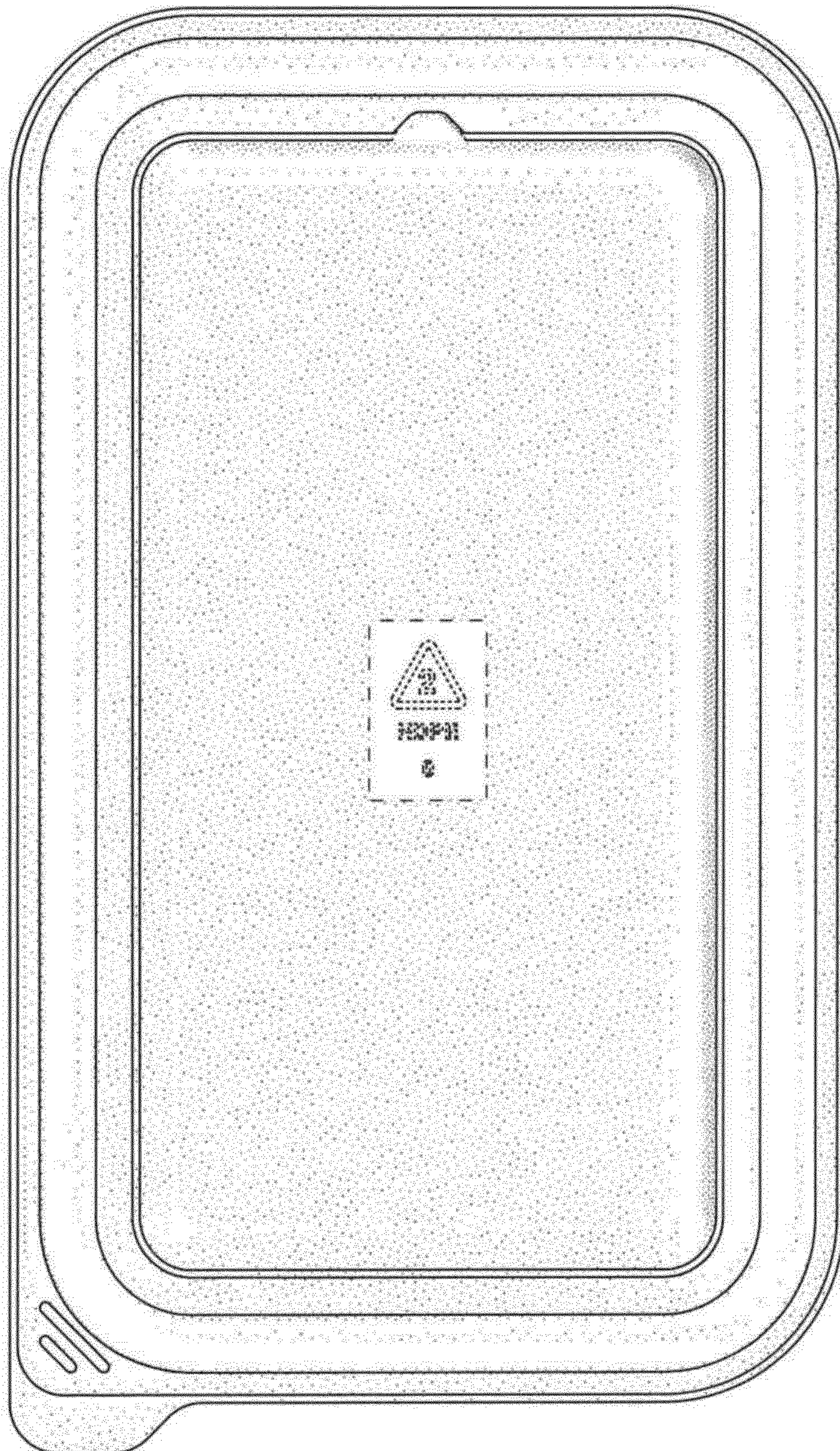
