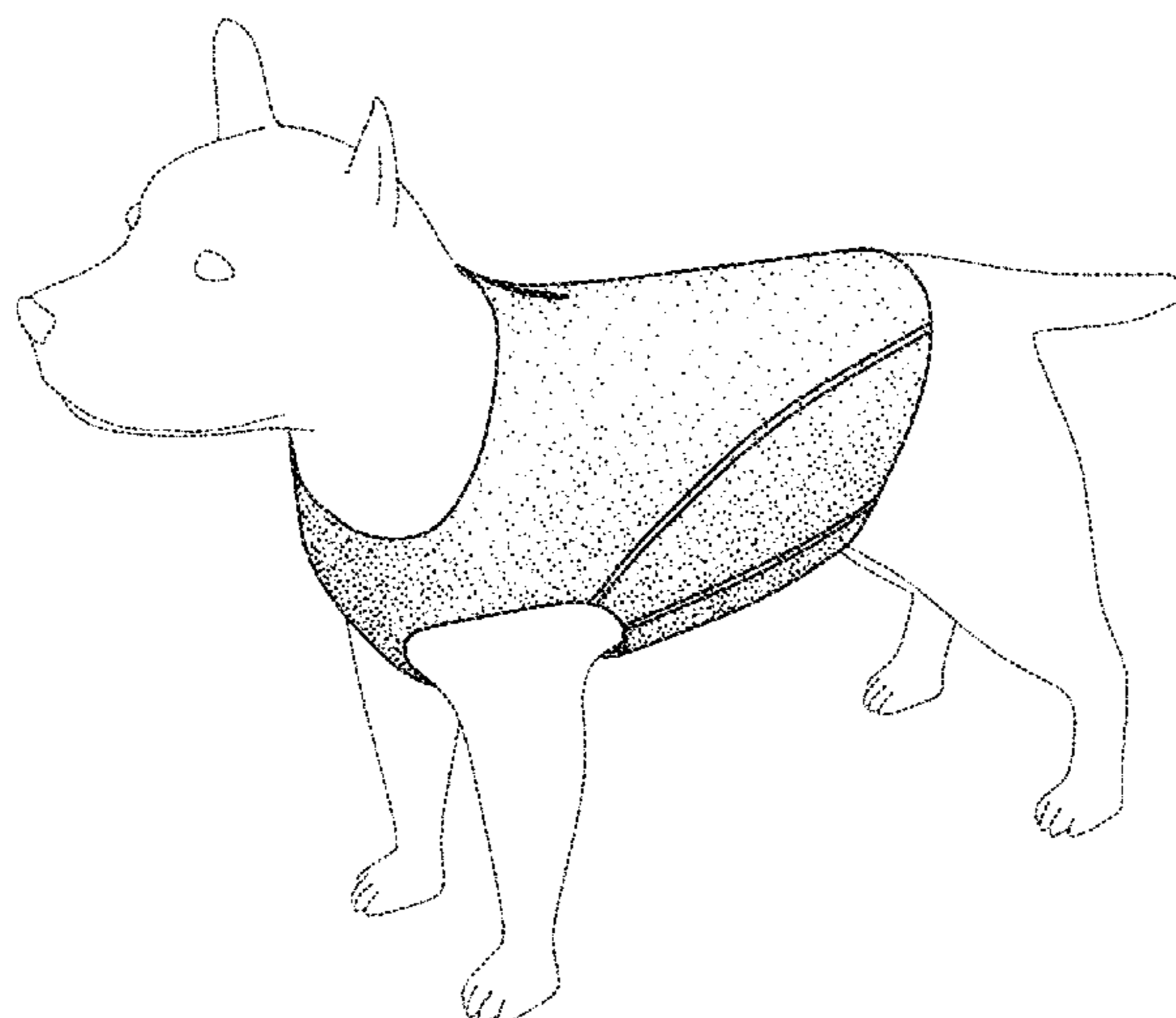
(57) **CLAIM**

The ornamental design for an animal garment, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left perspective view of an animal garment showing my new design in condition of use.
 FIG. 2 is a top view of the animal garment of FIG. 1.
 FIG. 3 is a bottom view thereof.
 FIG. 4 is a front view thereof.
 FIG. 5 is a left view thereof.
 FIG. 6 is a right view thereof.

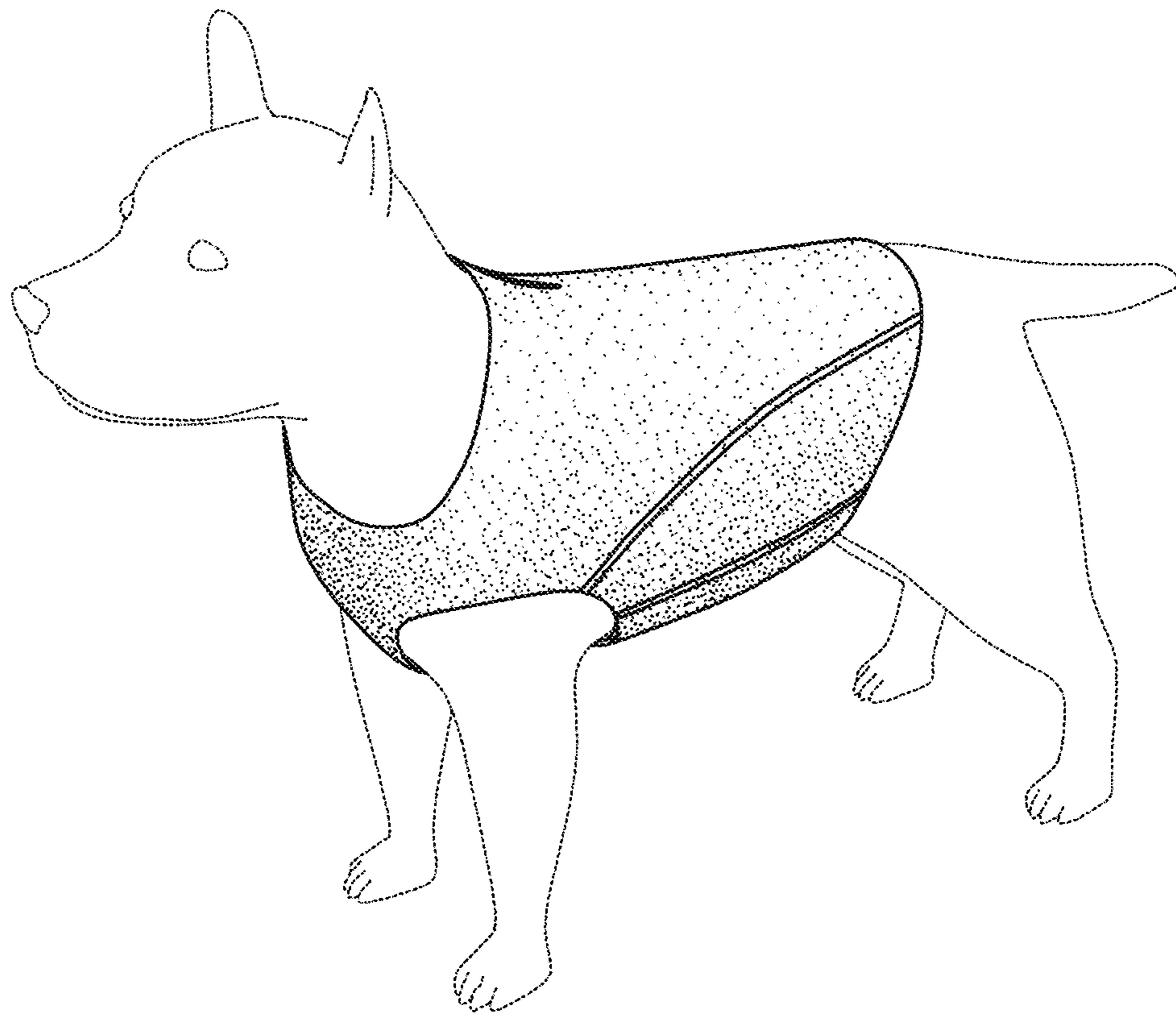

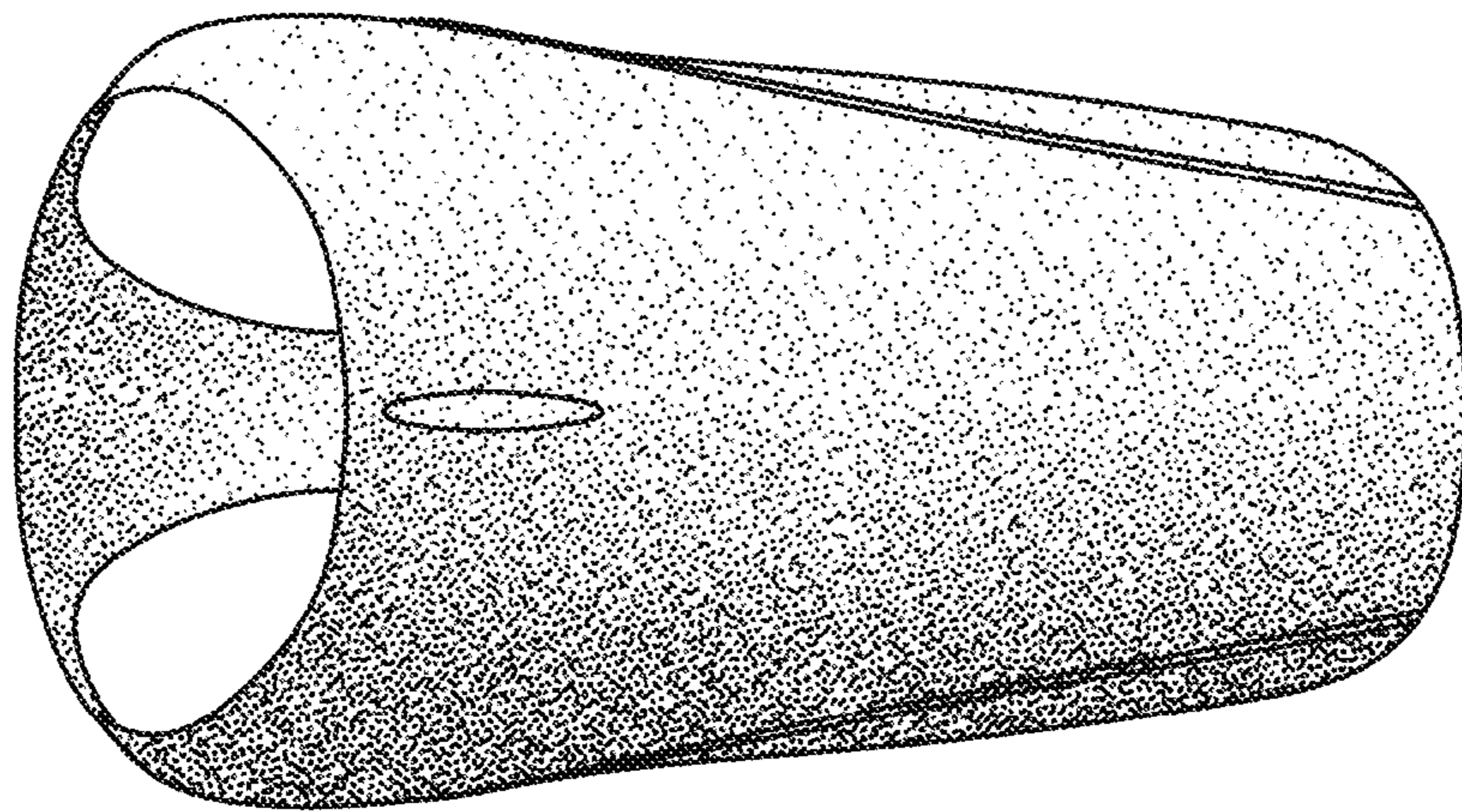

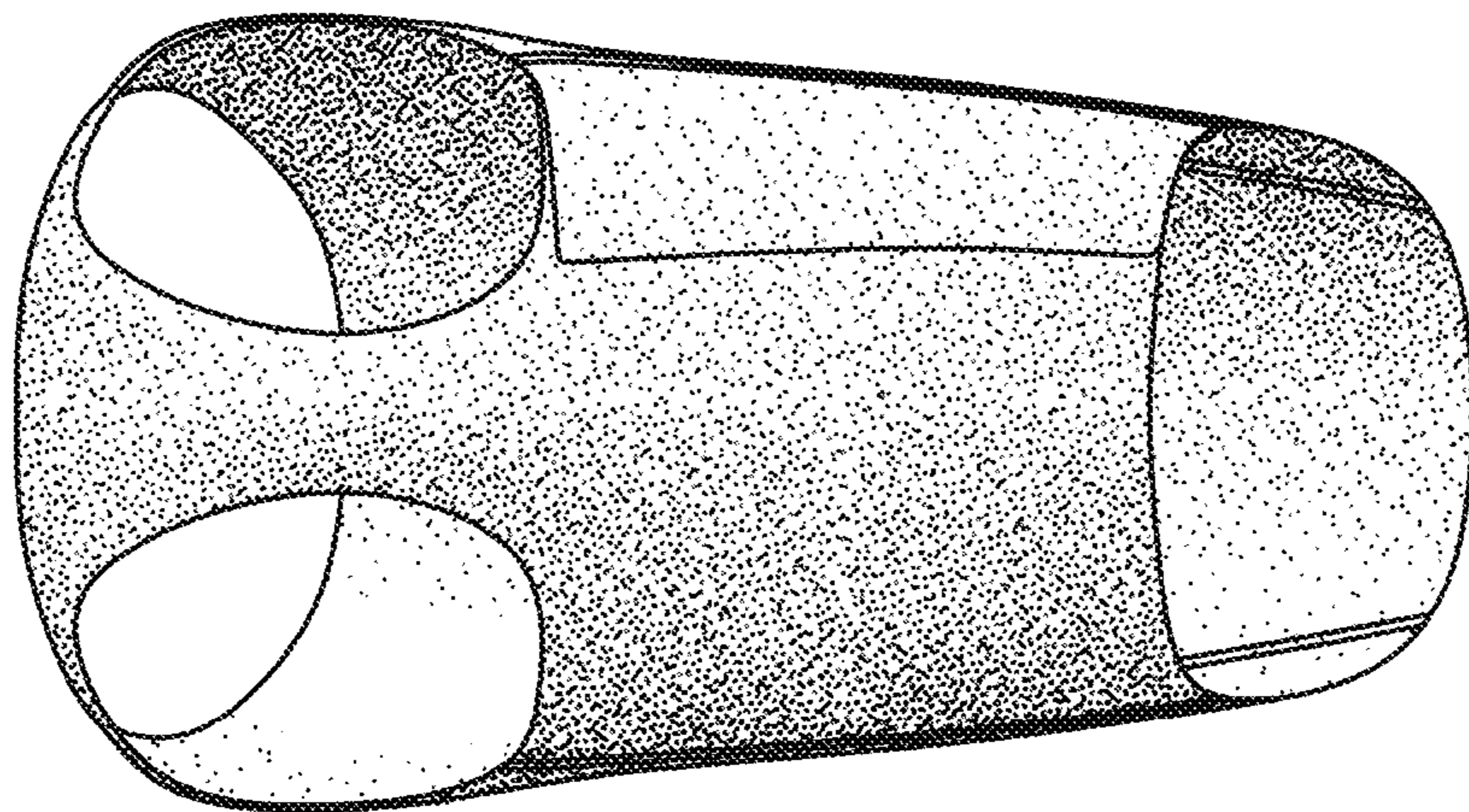

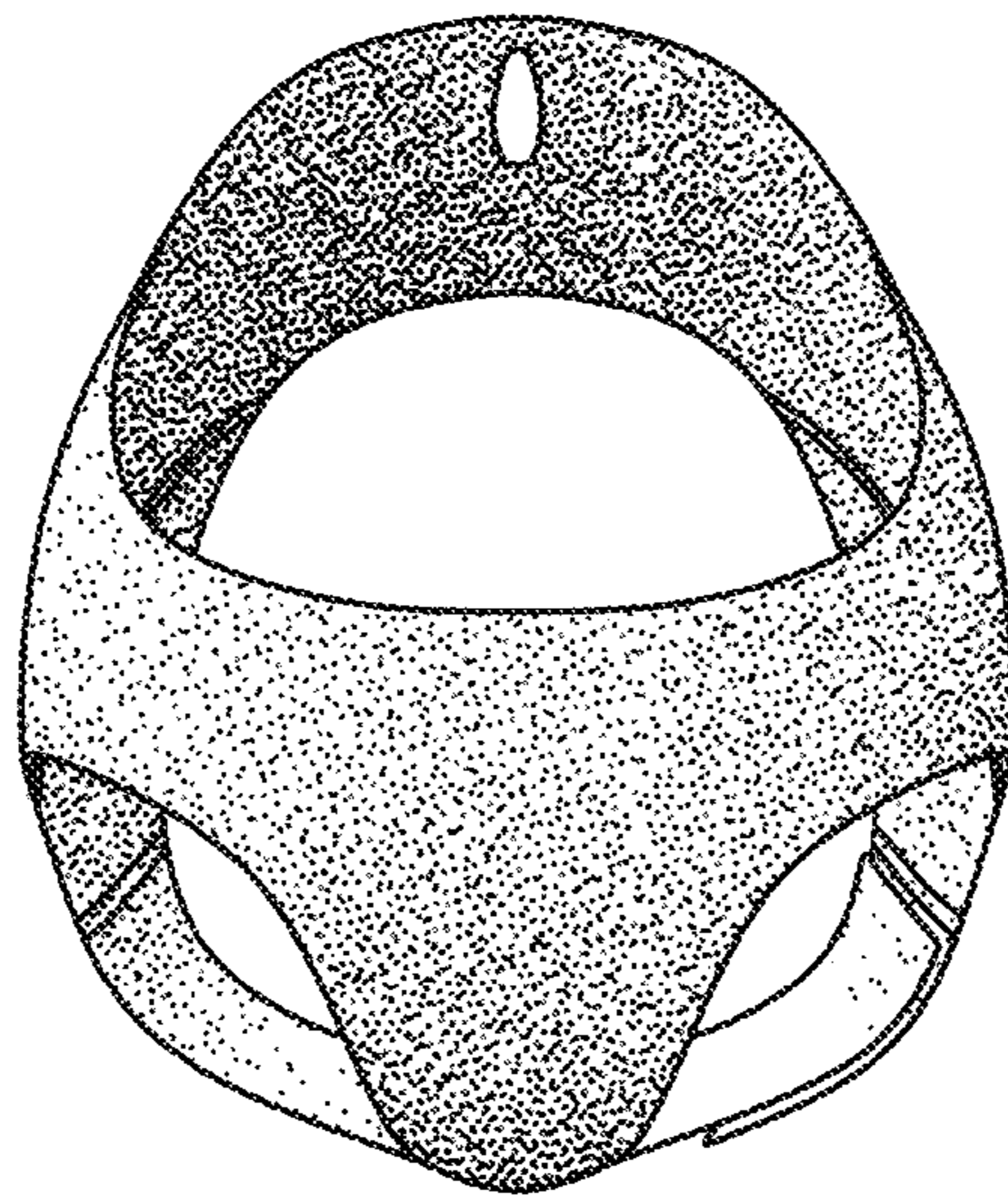

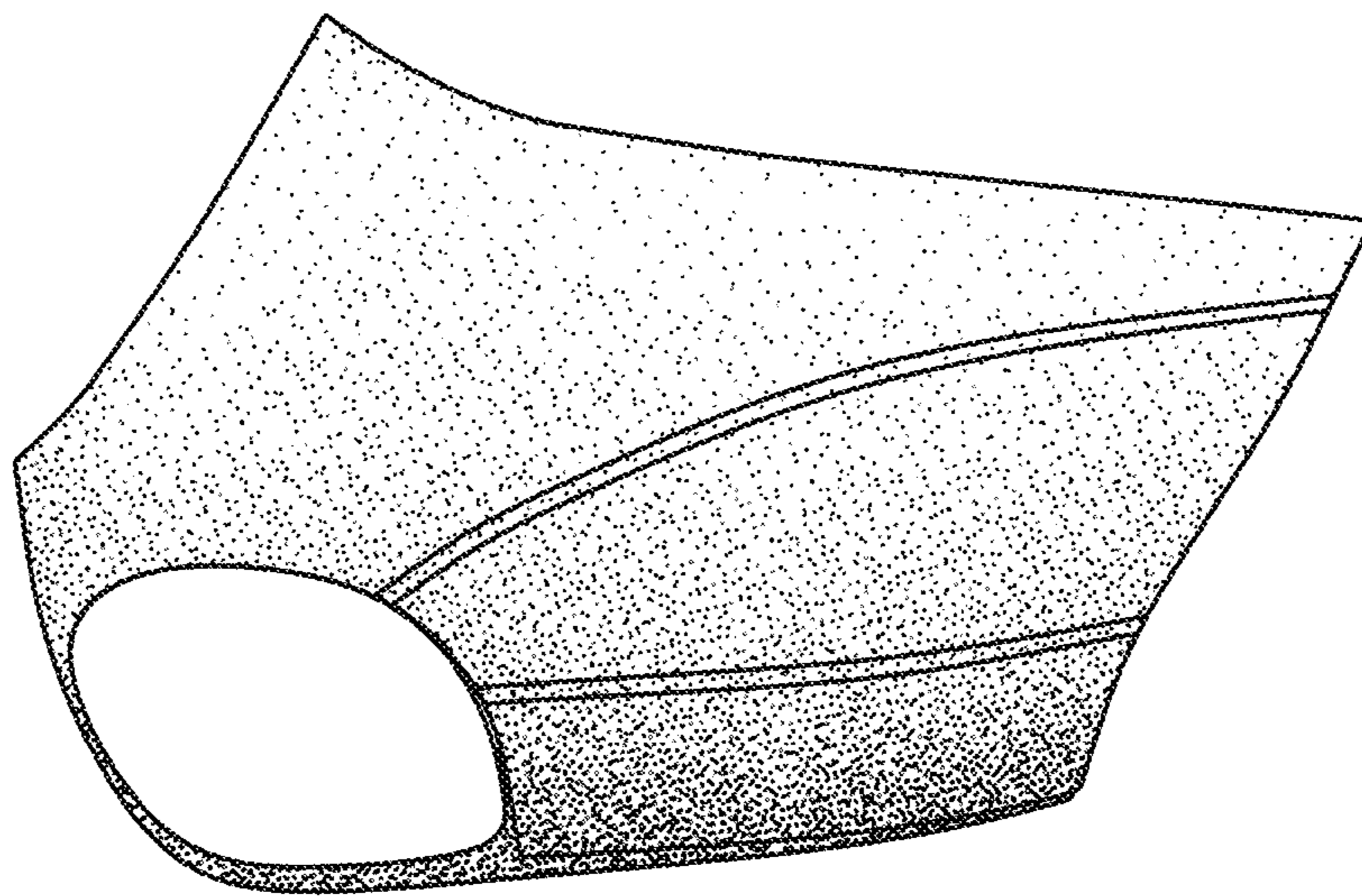

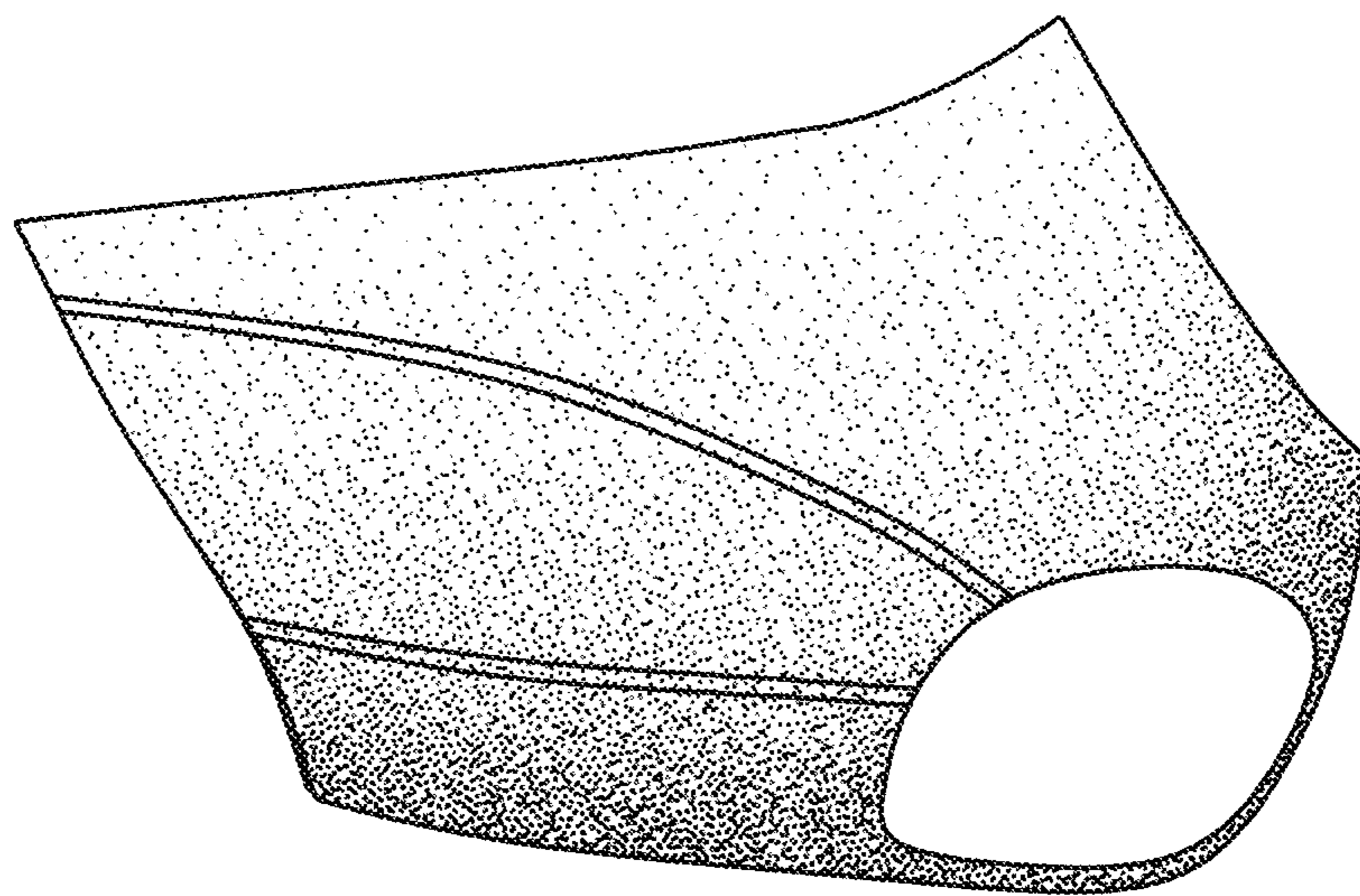

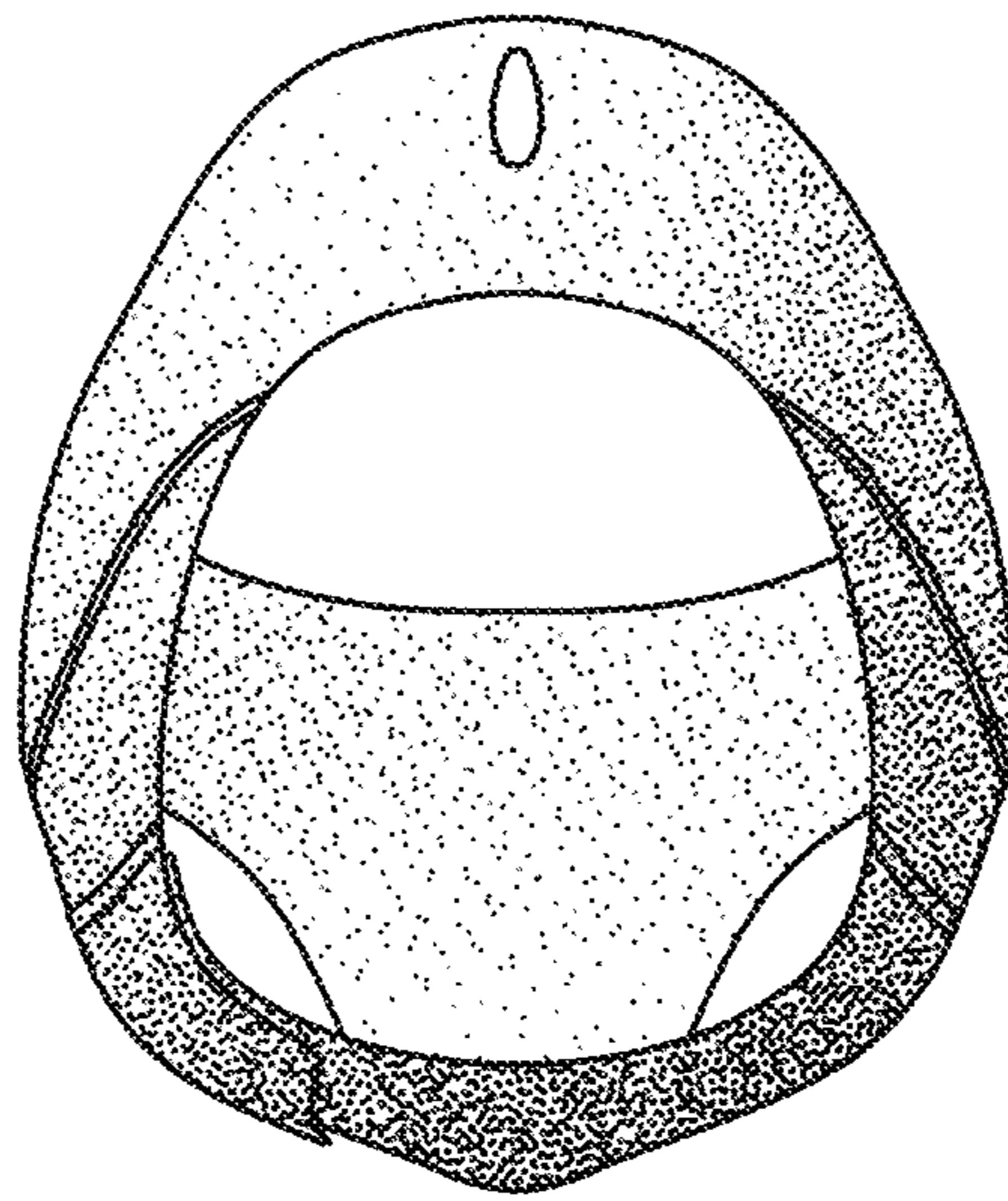

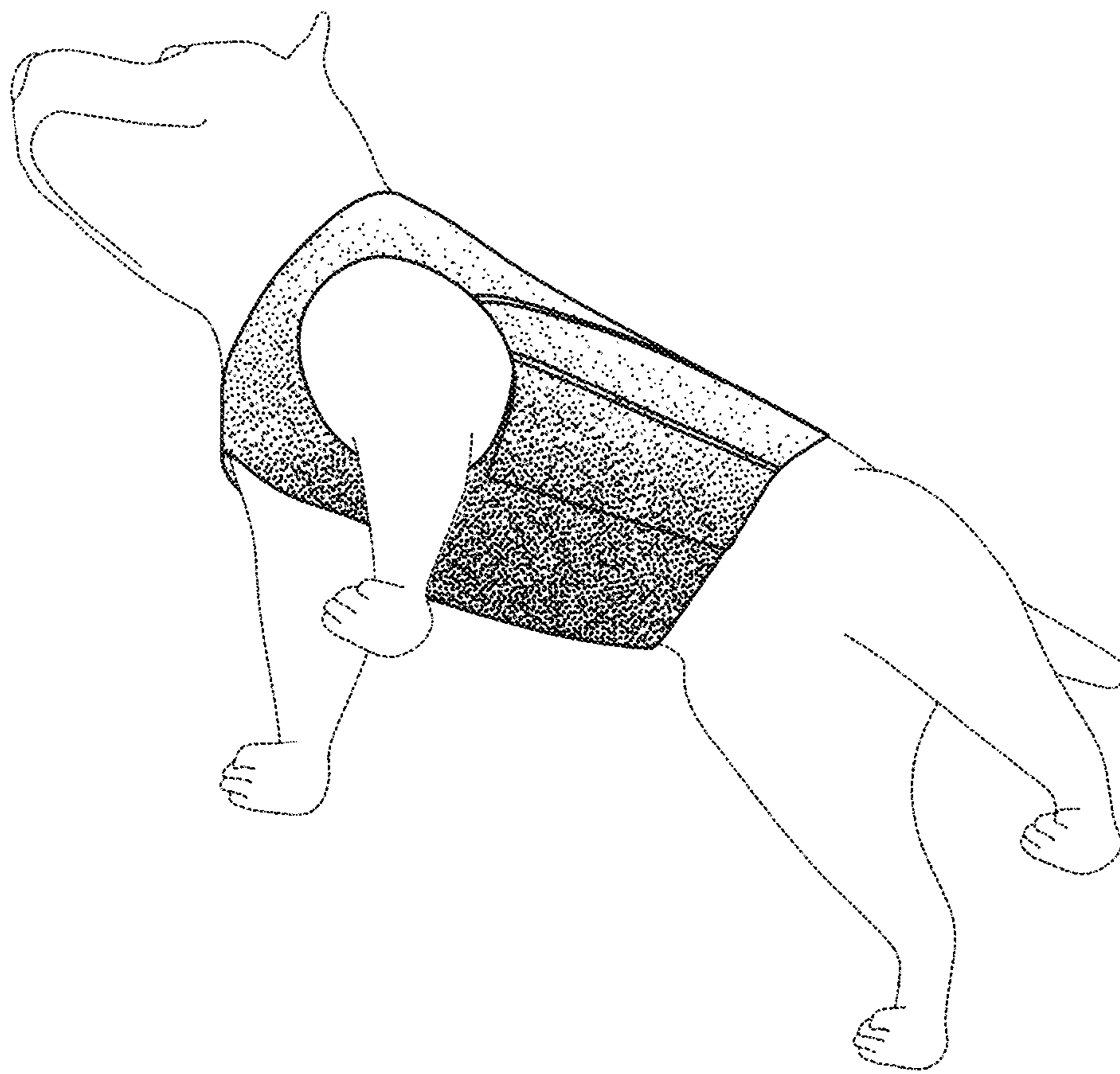

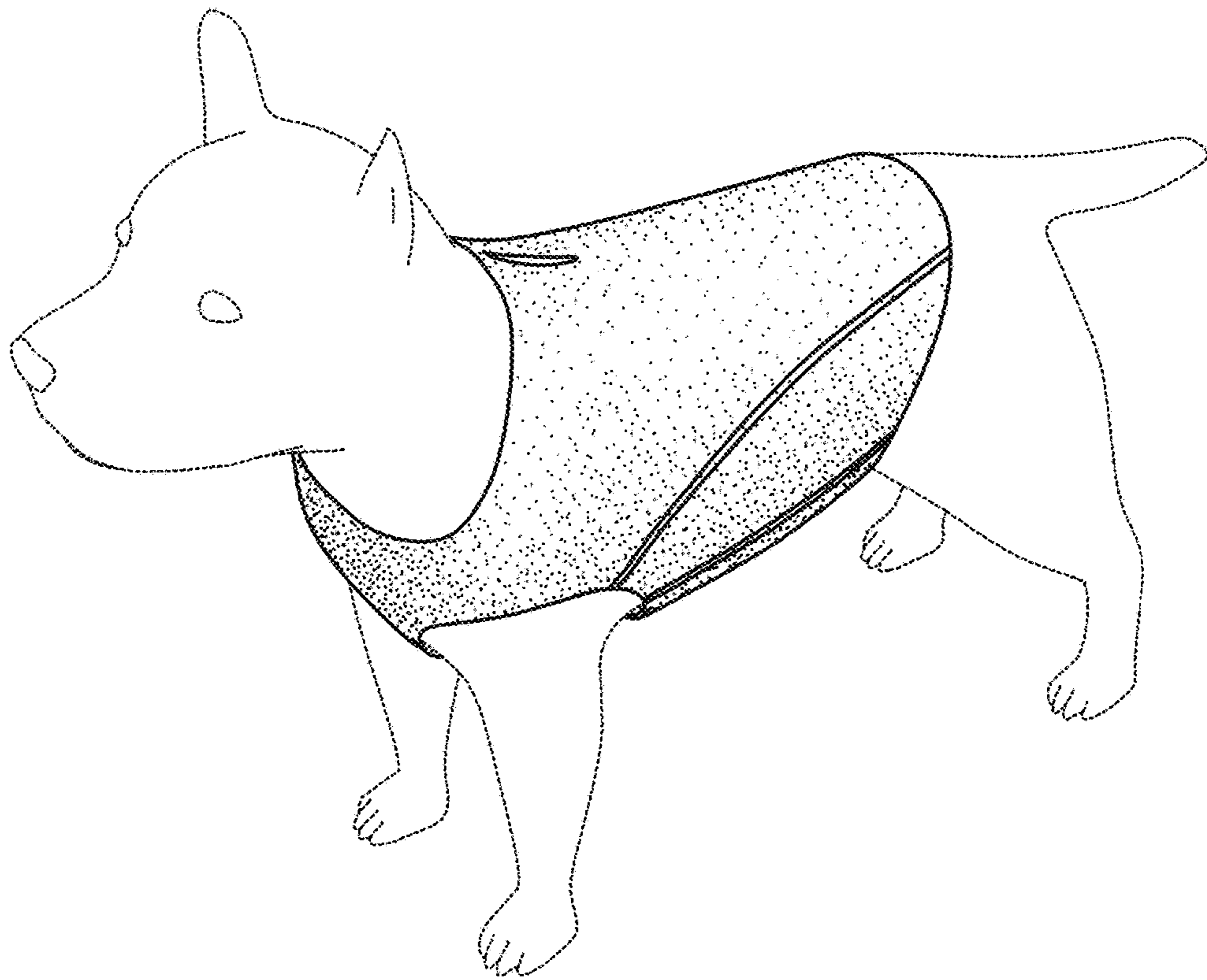
