DESCRIPTION

FIG. 1 is a perspective view of a pulsator for washing machine showing our new design;

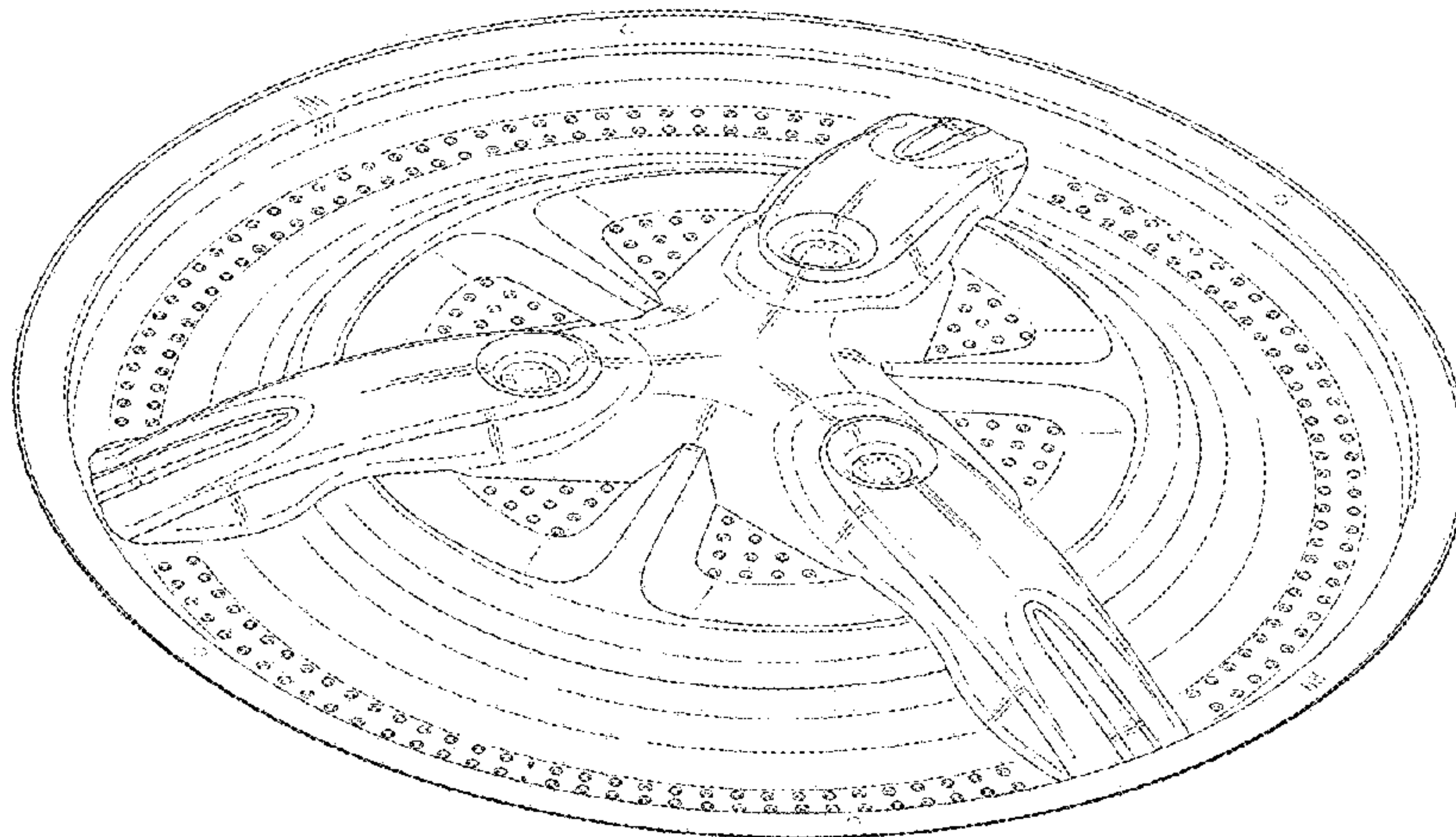

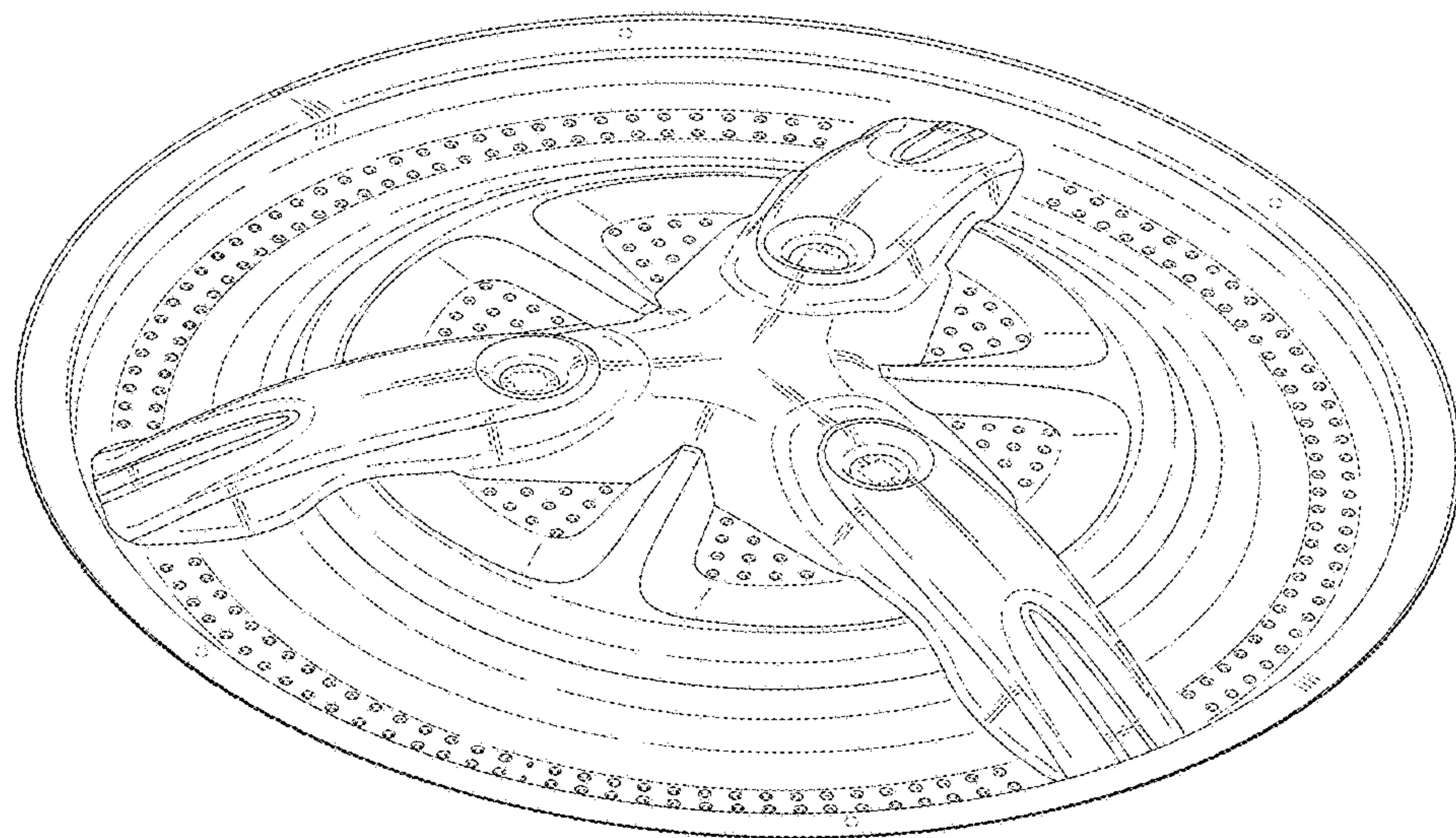

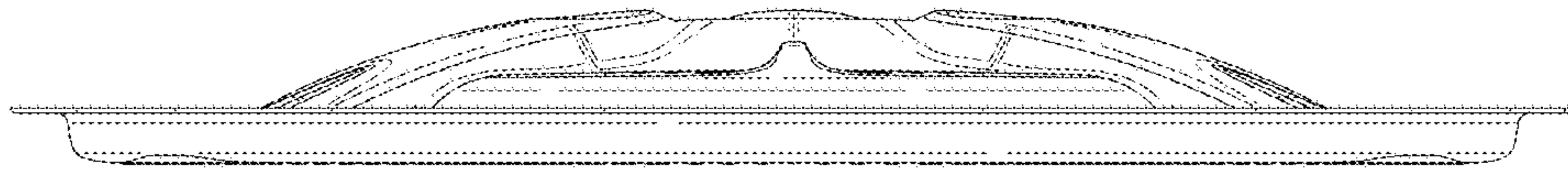

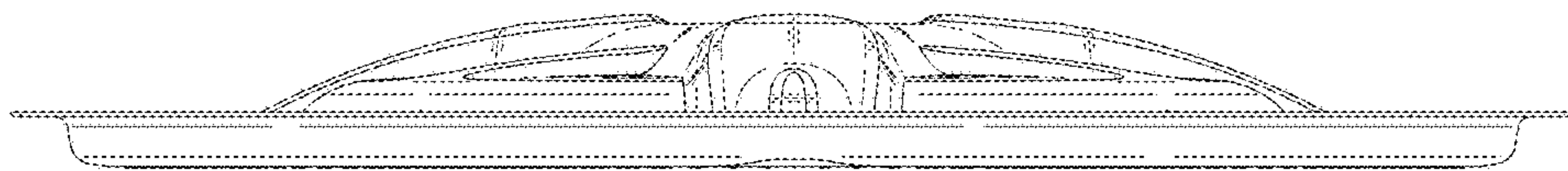

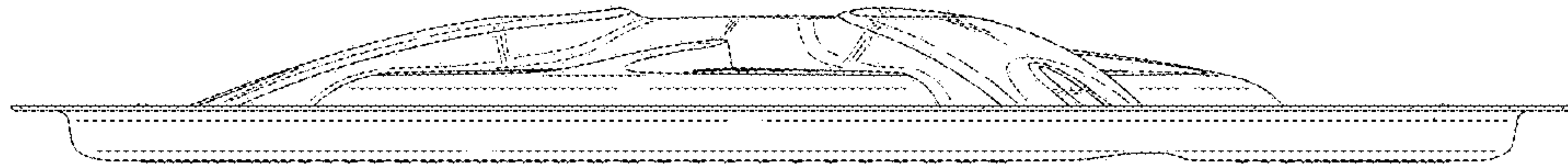

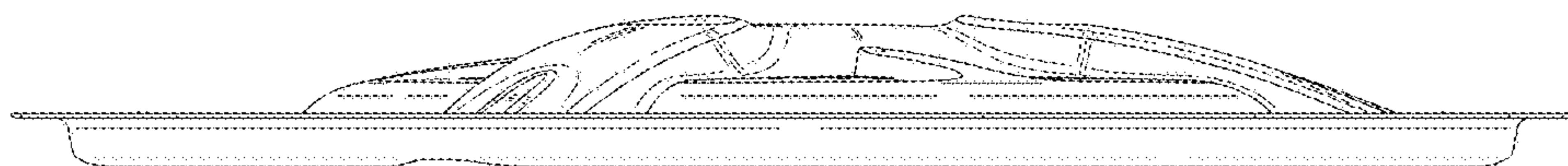

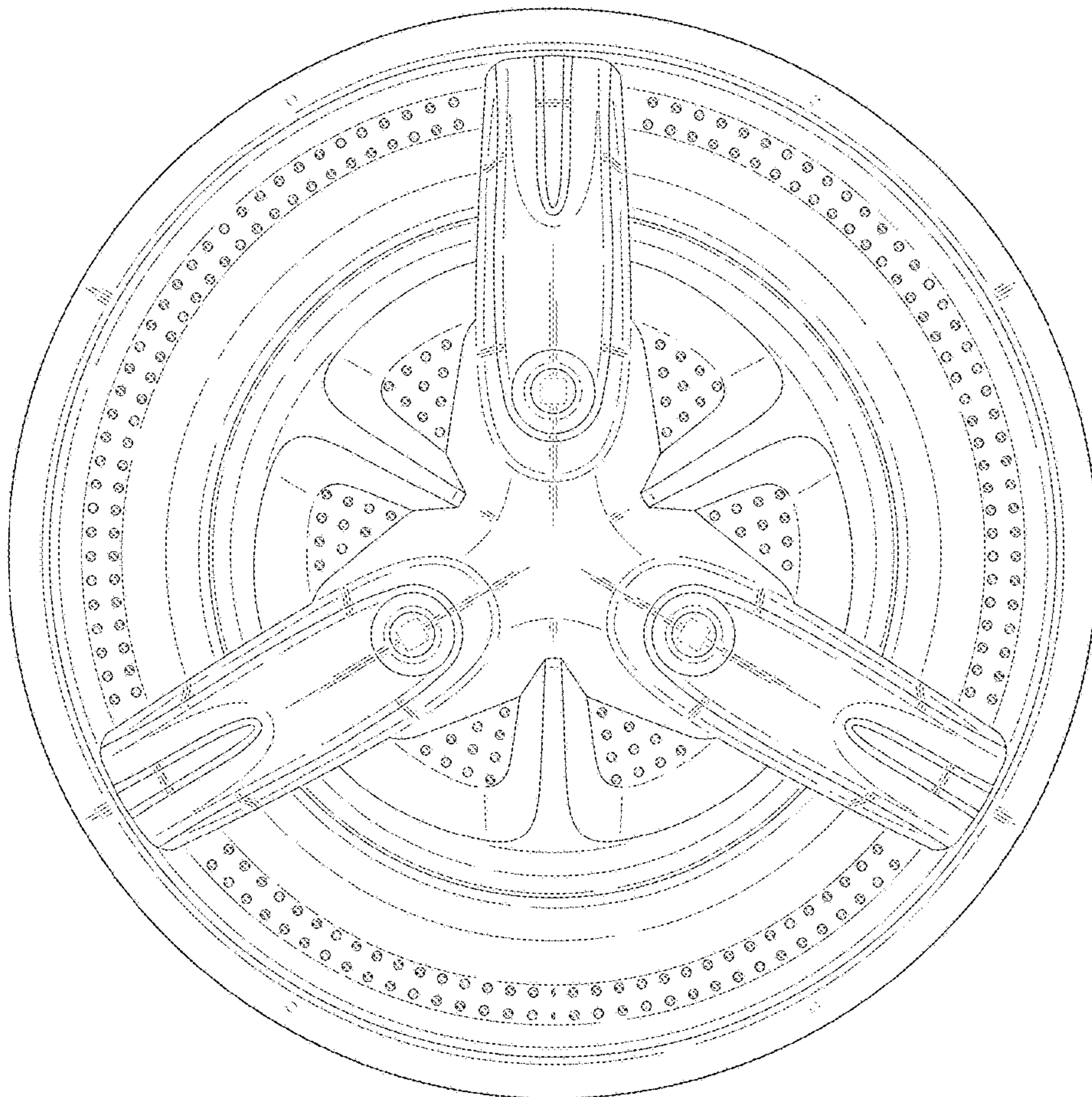
