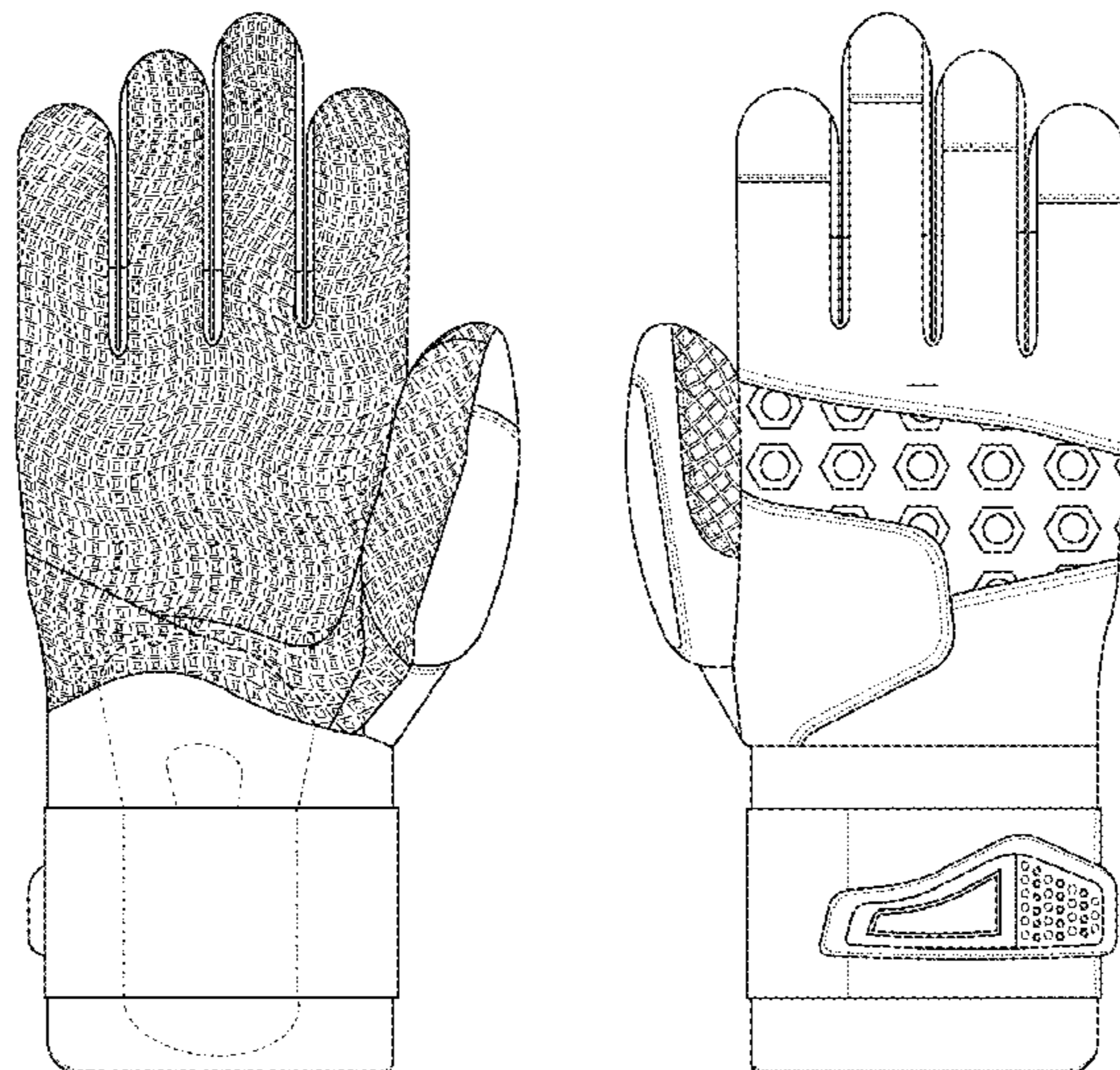
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front elevation view of a glove showing our new design;

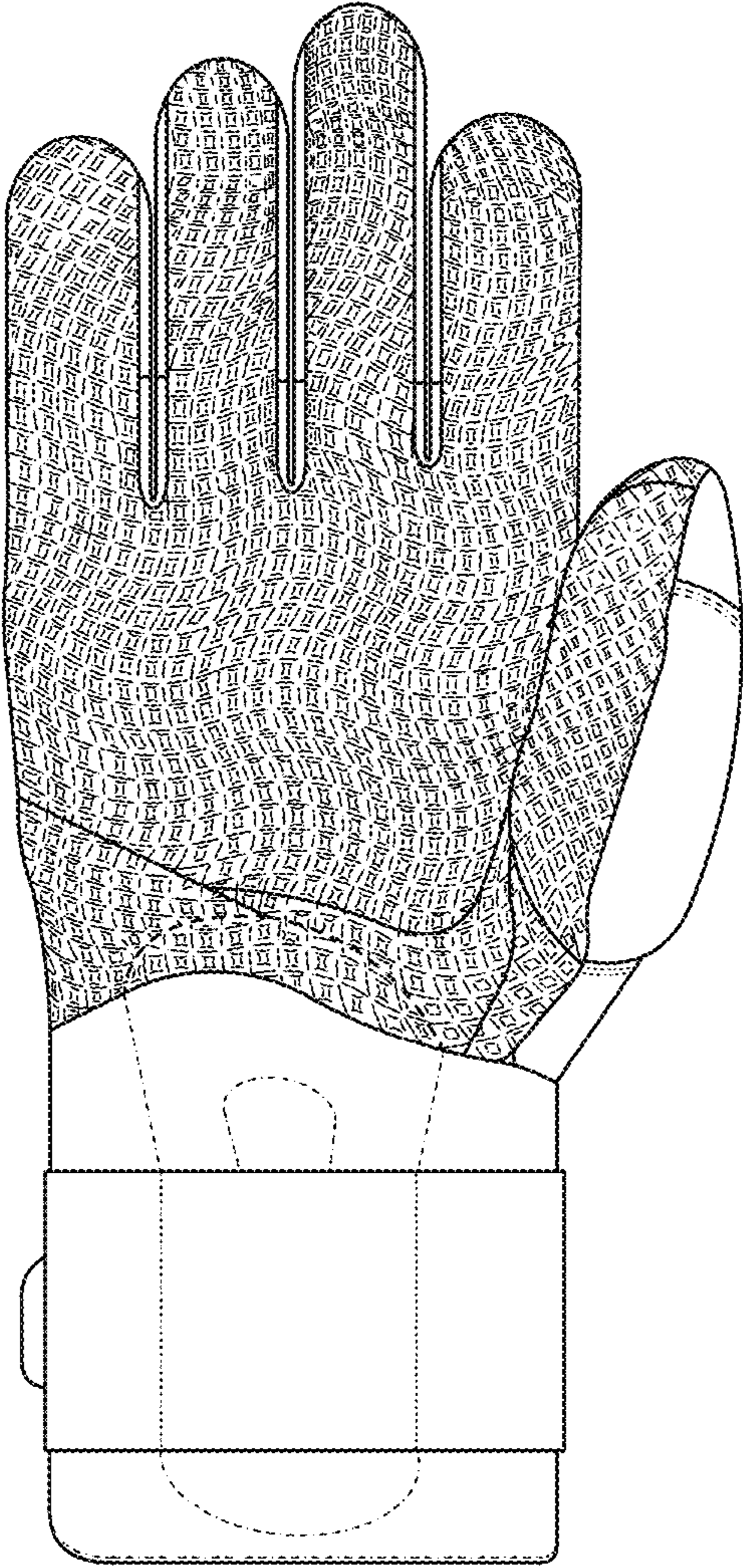

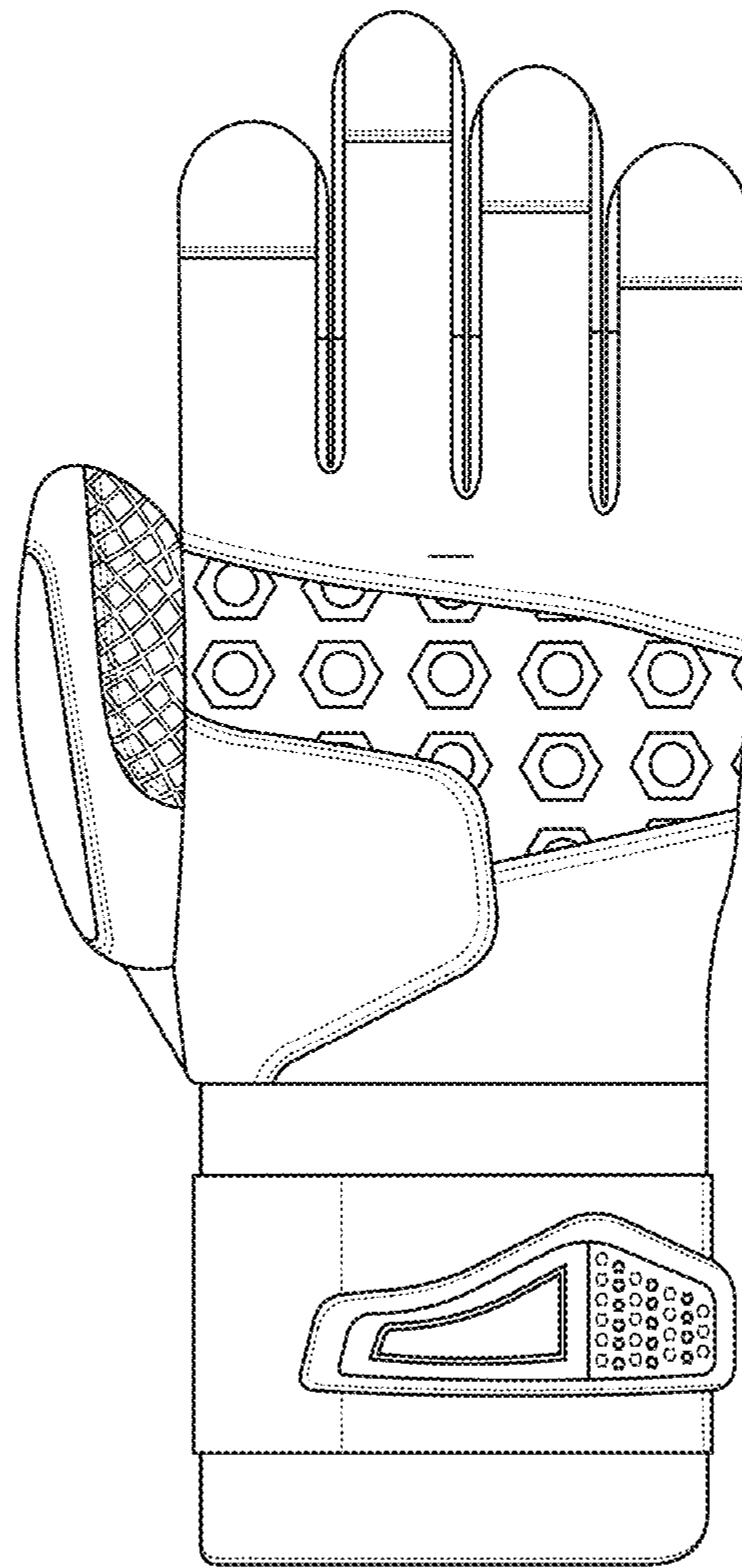

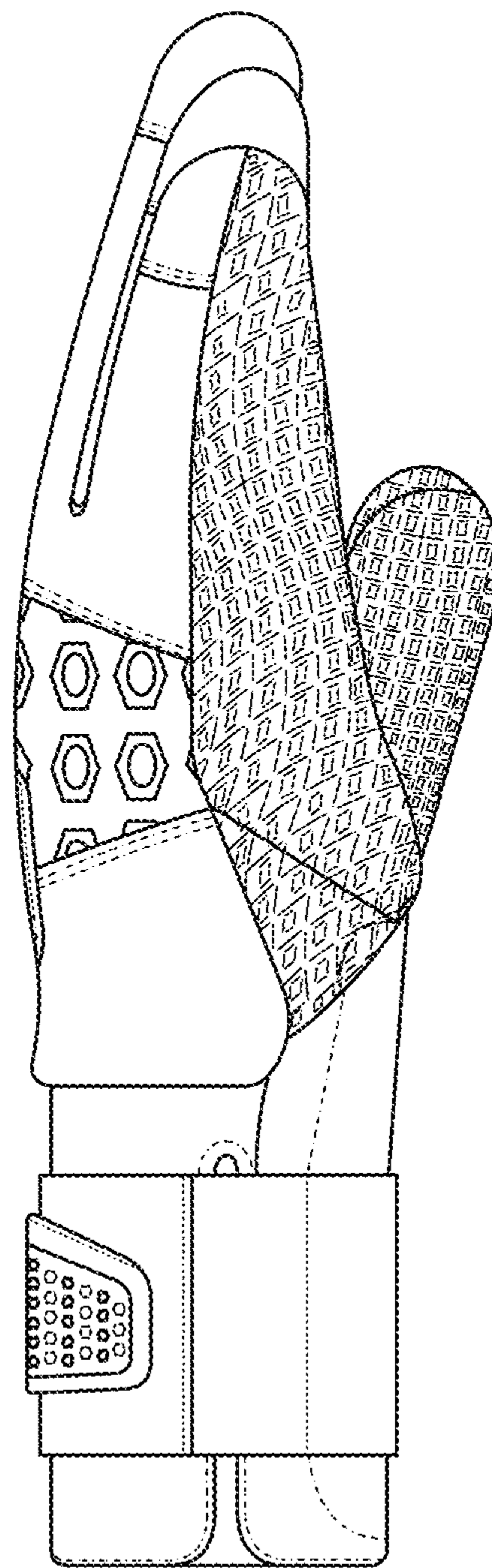

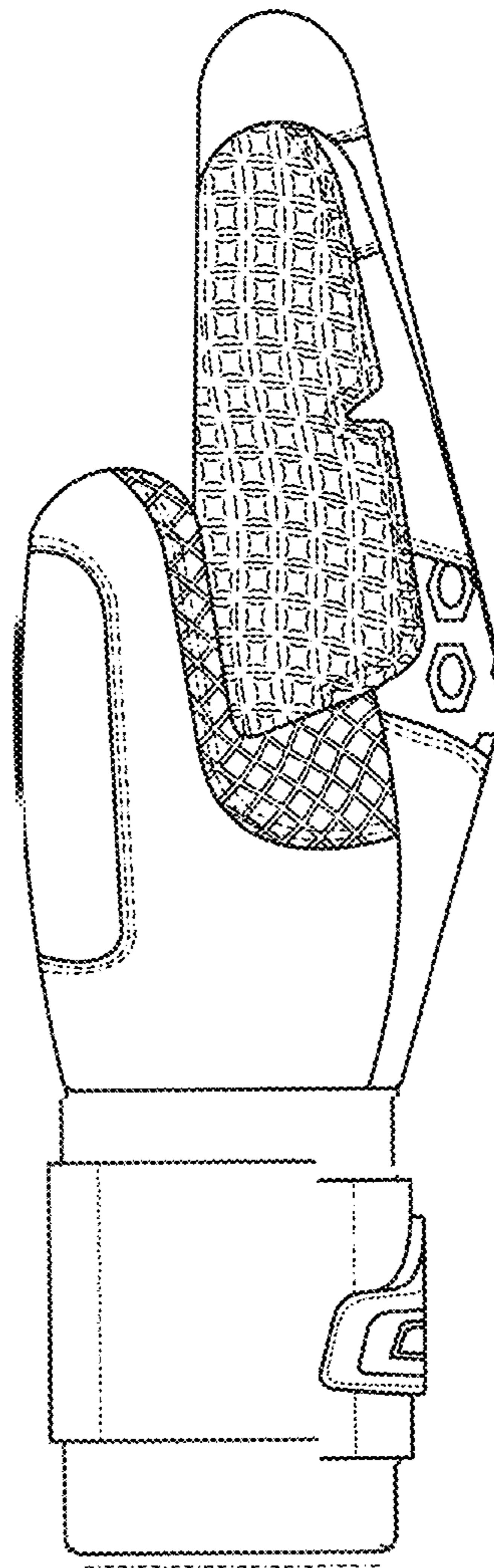

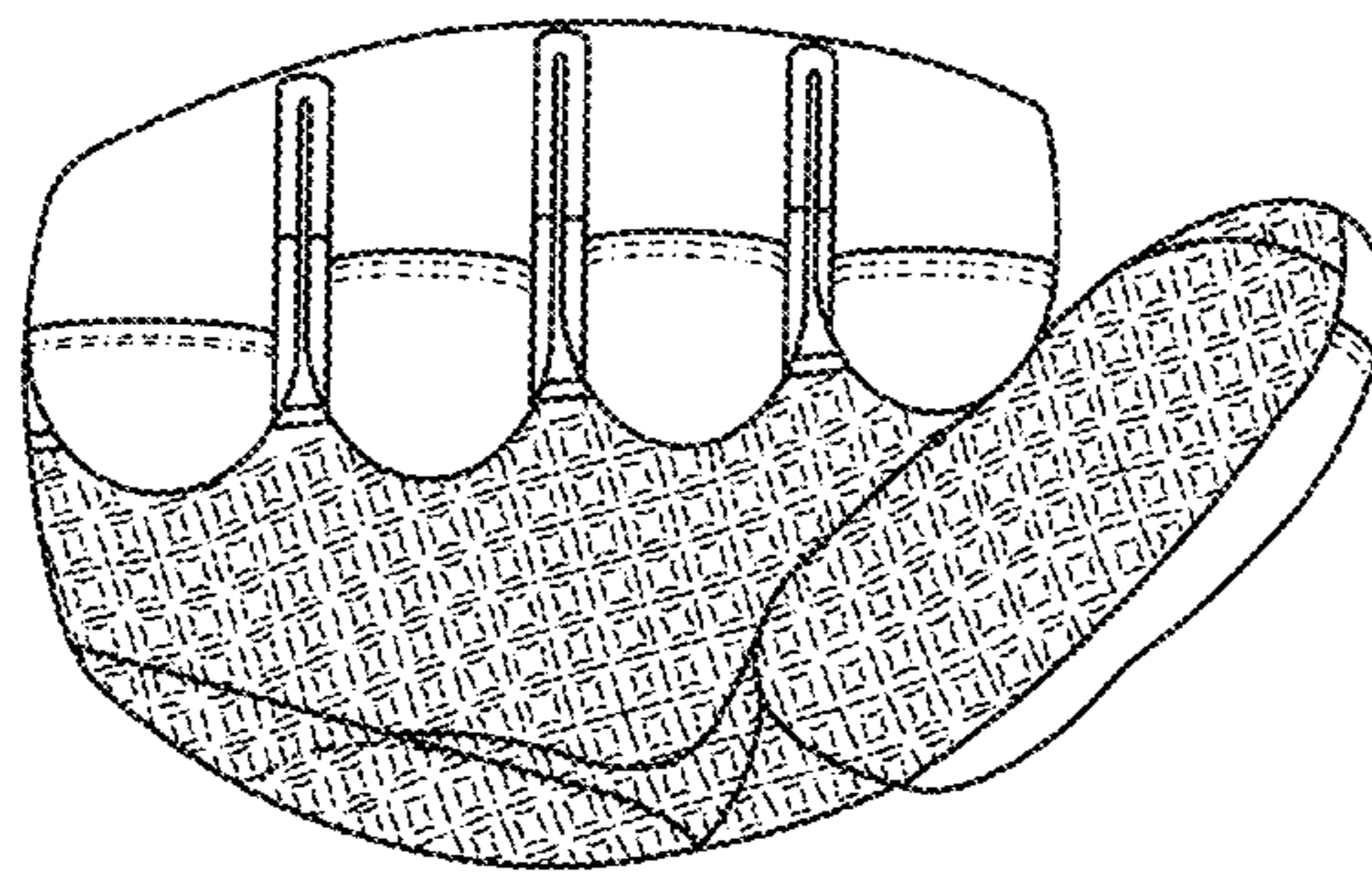
