(57) **CLAIM**

The ornamental design for a swimsuit, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a swimsuit according to the new design.

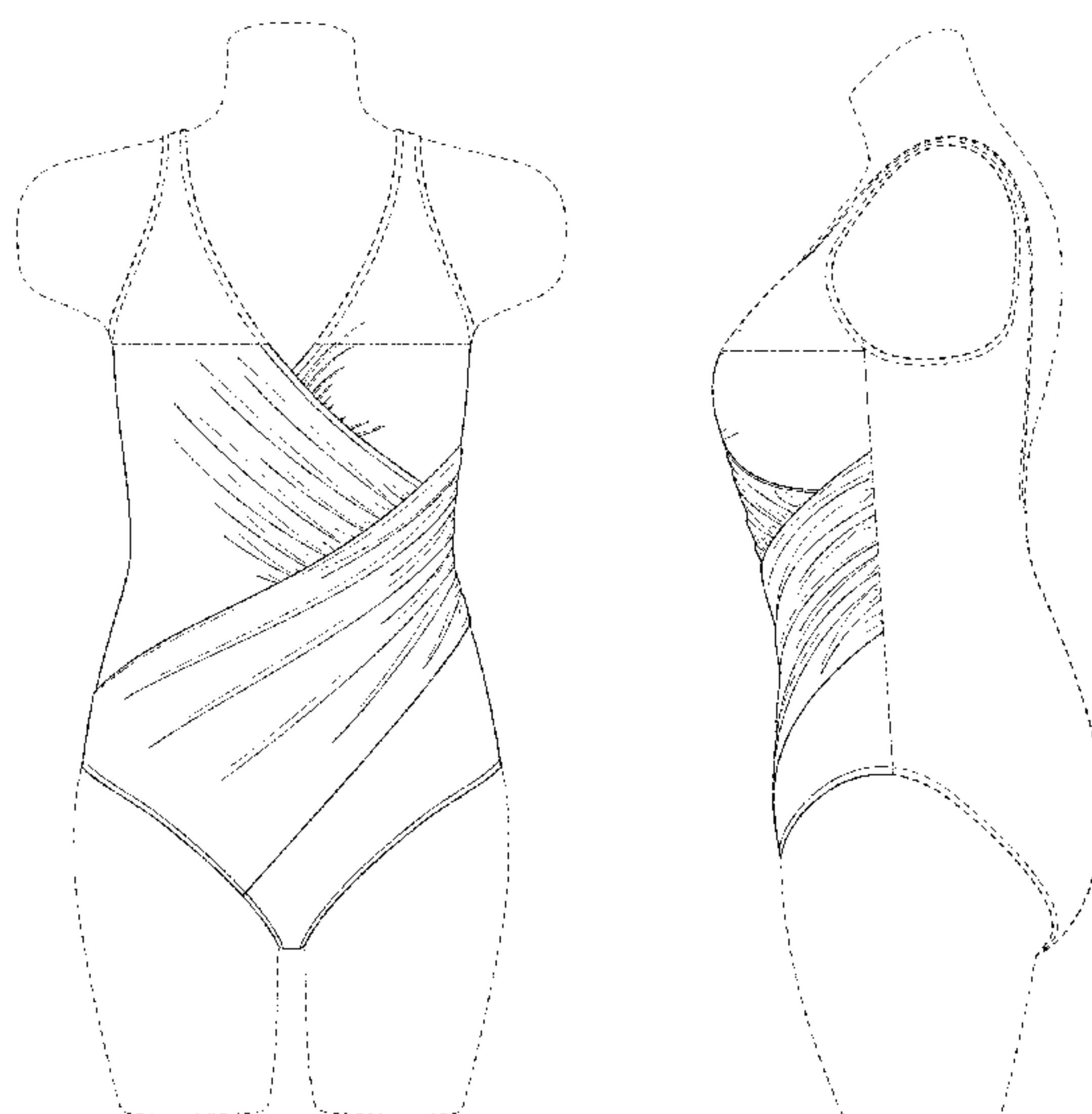
FIG. 2 is a rear view thereof.

FIG. 4 is a right-side view thereof.

The dash-dot-dash lines immediately adjacent to the solid lines illustrating portions of the swimsuit define the bounds of the claimed design and form no part thereof. The broken lines illustrating portions of the swimsuit form no part of the claimed design. All other broken lines illustrating a human body are for environmental purposes only and form no part of the claimed design.

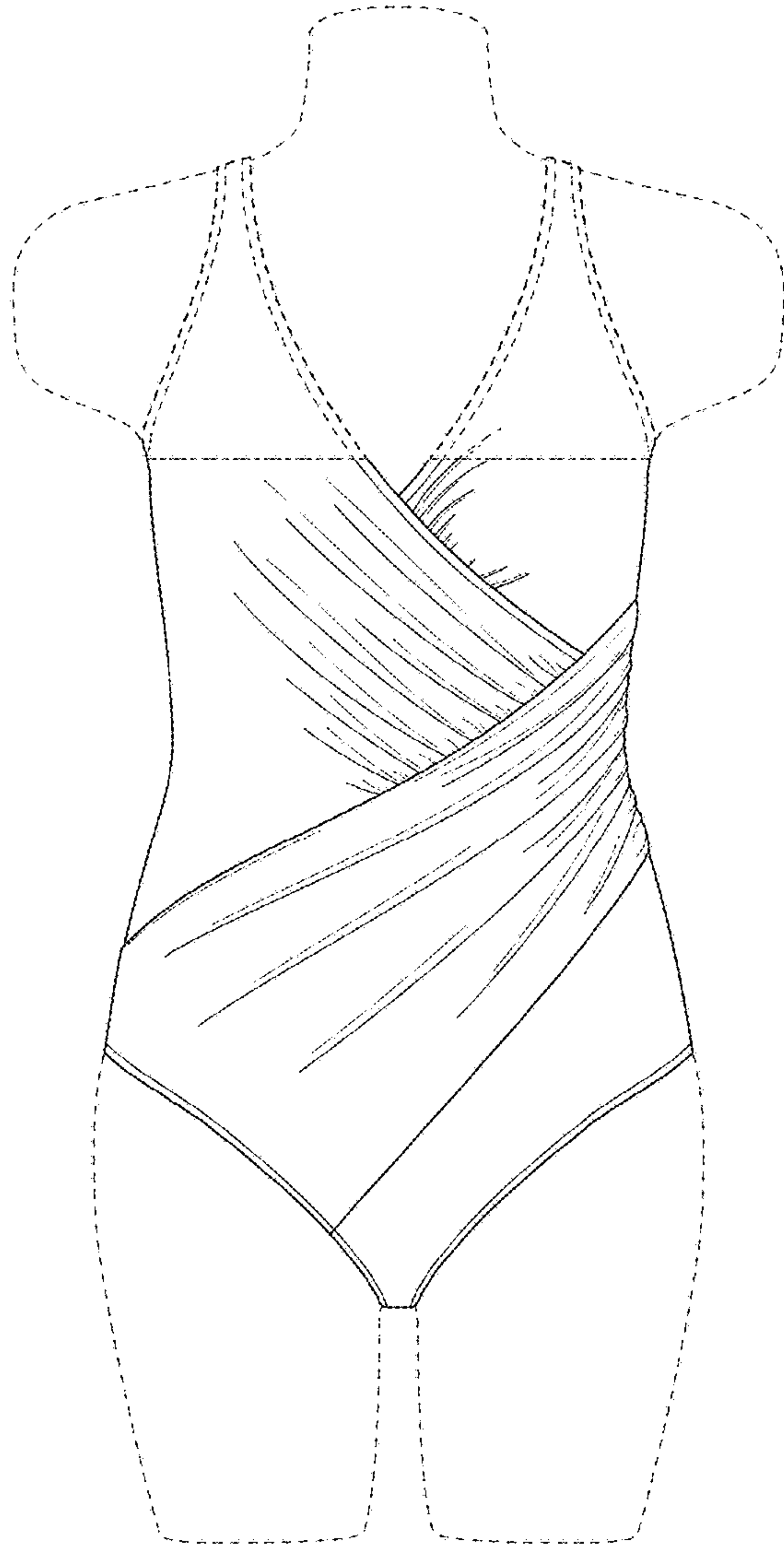

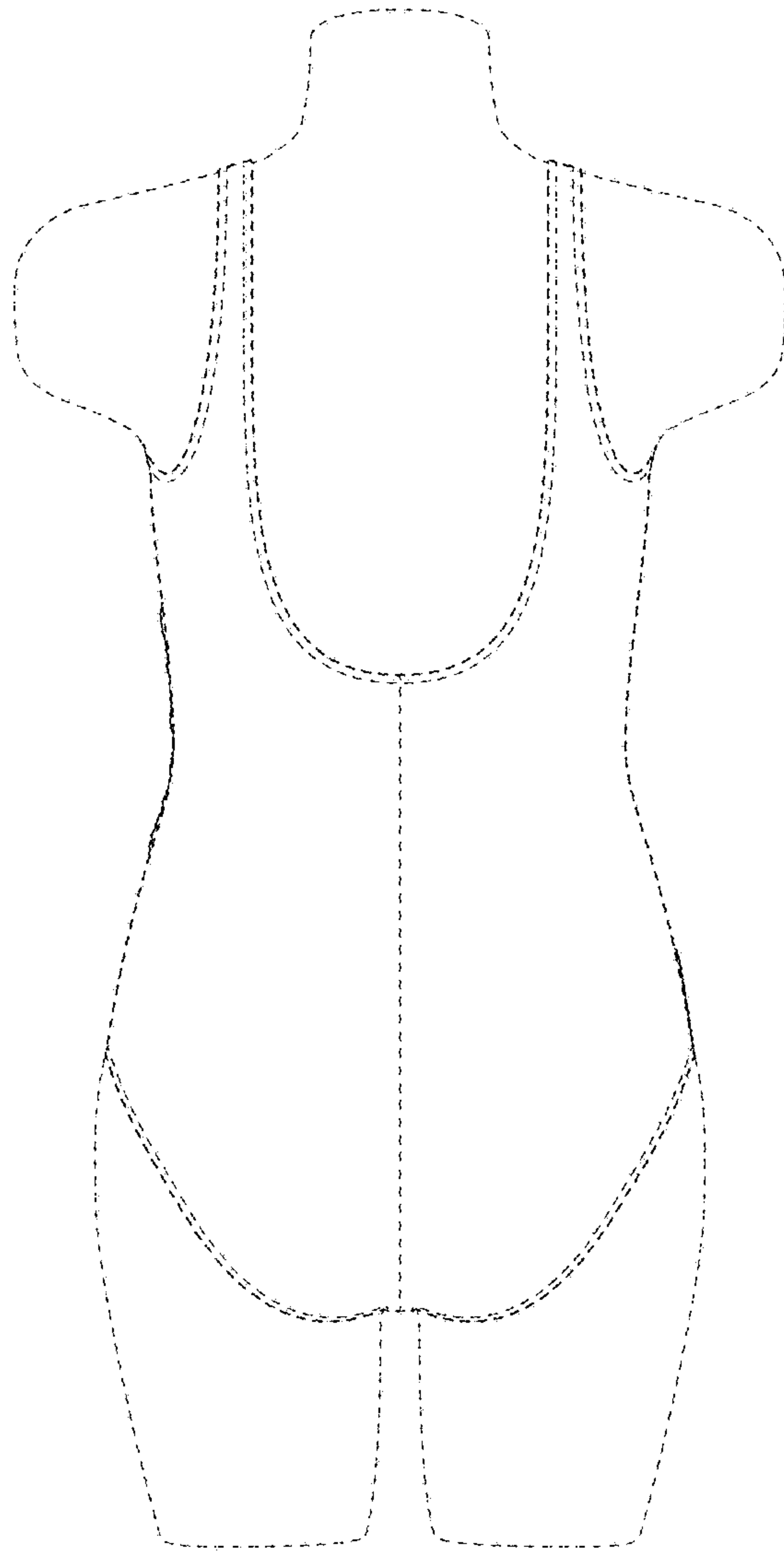

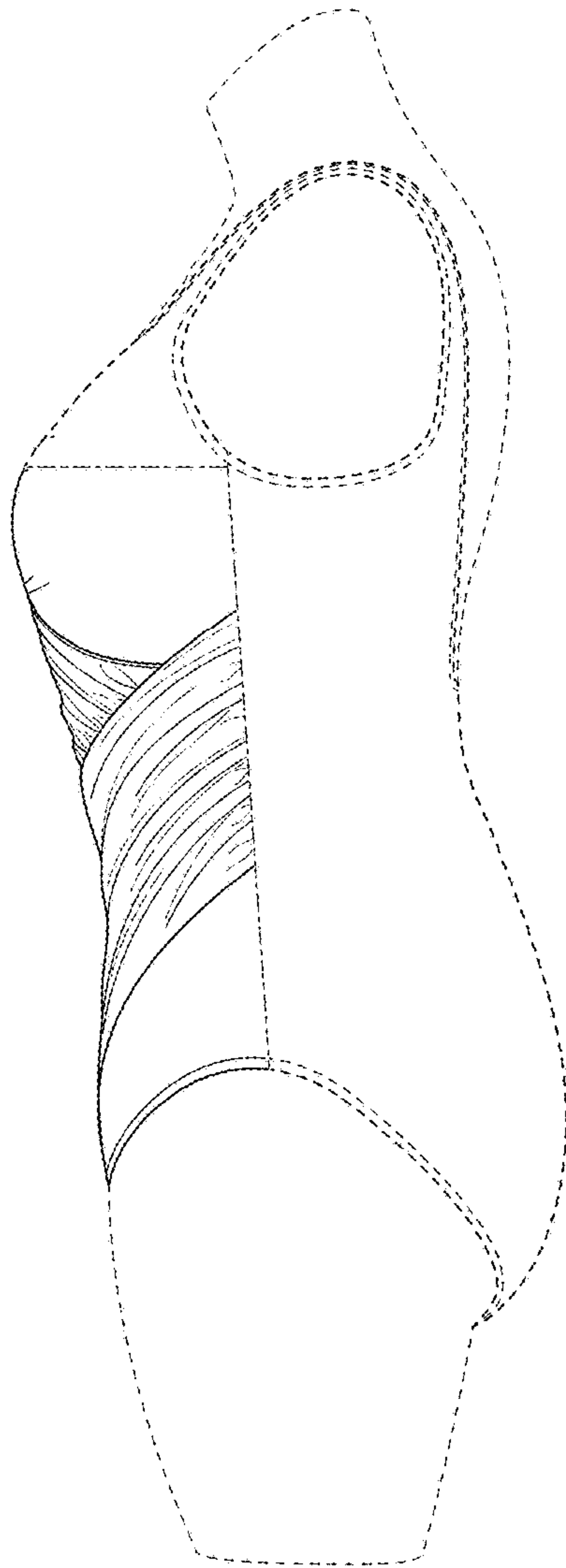

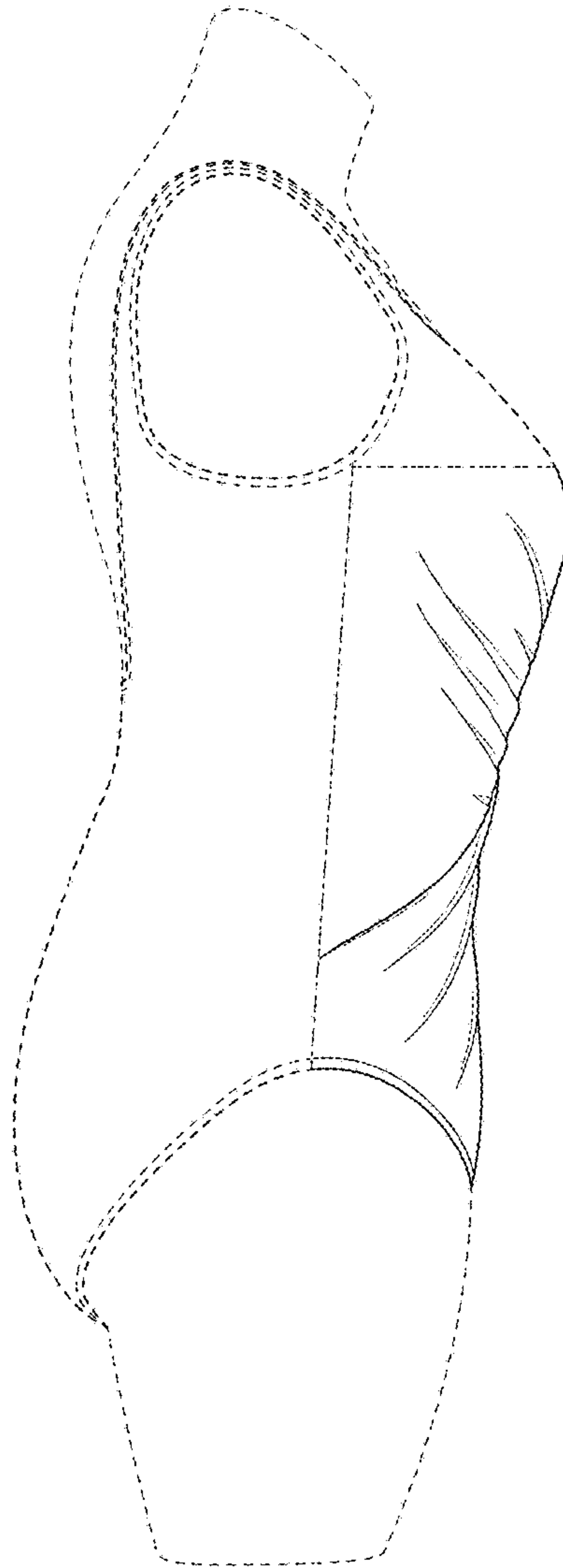
