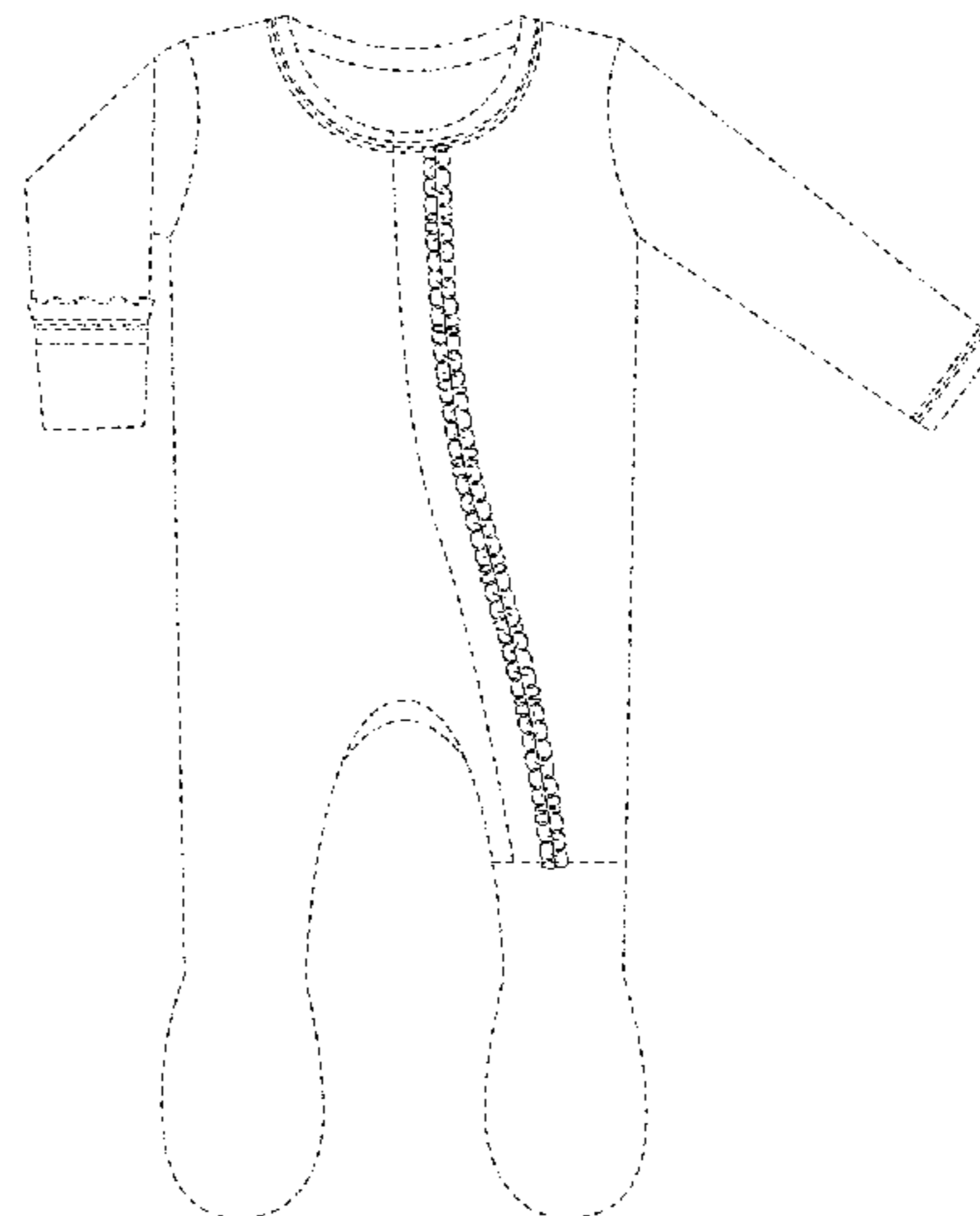
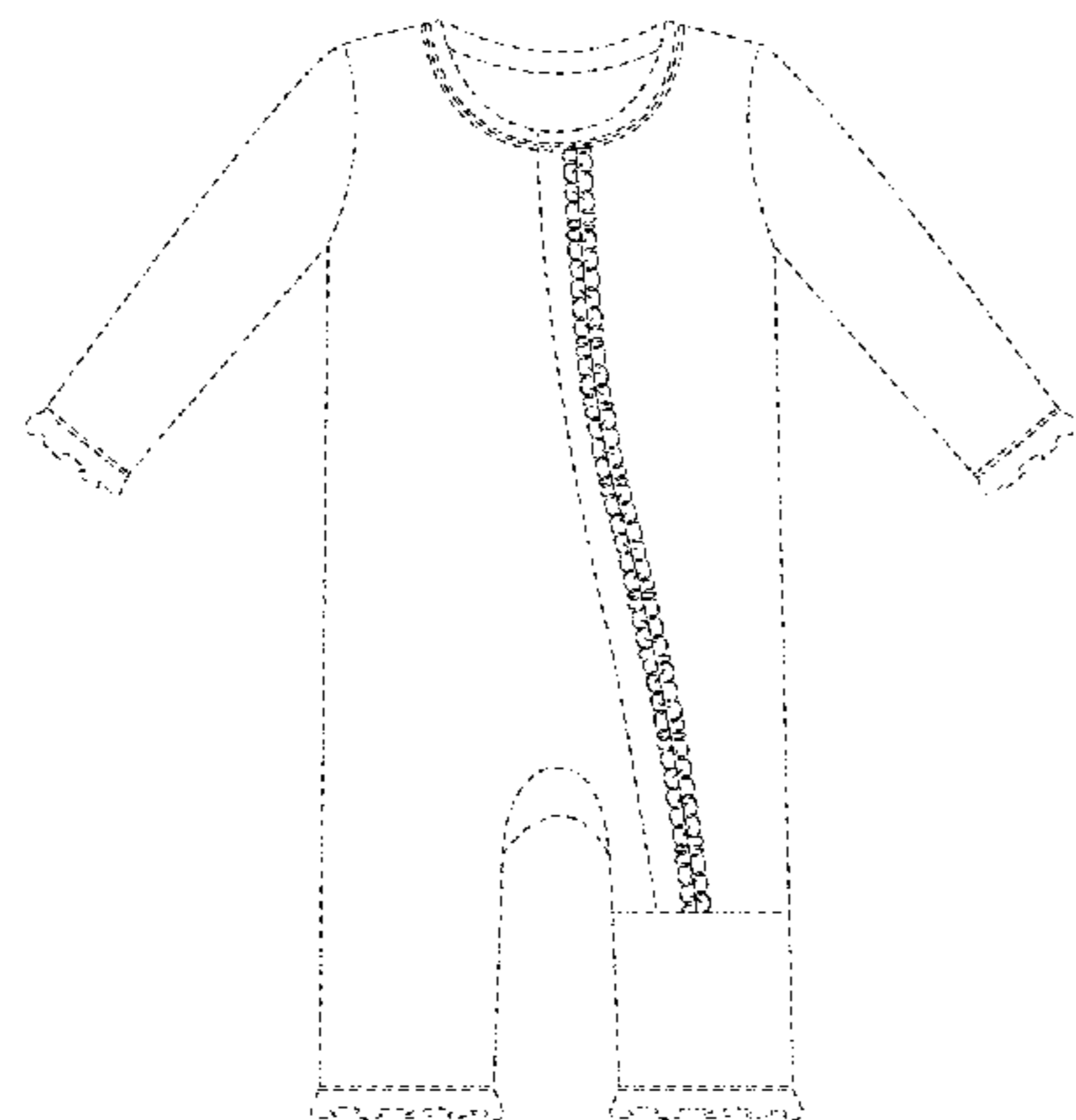

(57) **CLAIM**
The ornamental design for a clothes ruffle, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a clothes ruffle shown on a first article of clothing, such as a coverall; and, FIG. 2 is a front view of the clothes ruffle shown on a second article of clothing, such as a footie. The broken lines of FIG. 1 and FIG. 2 are for illustrative purposes only and form no part of the claimed design.

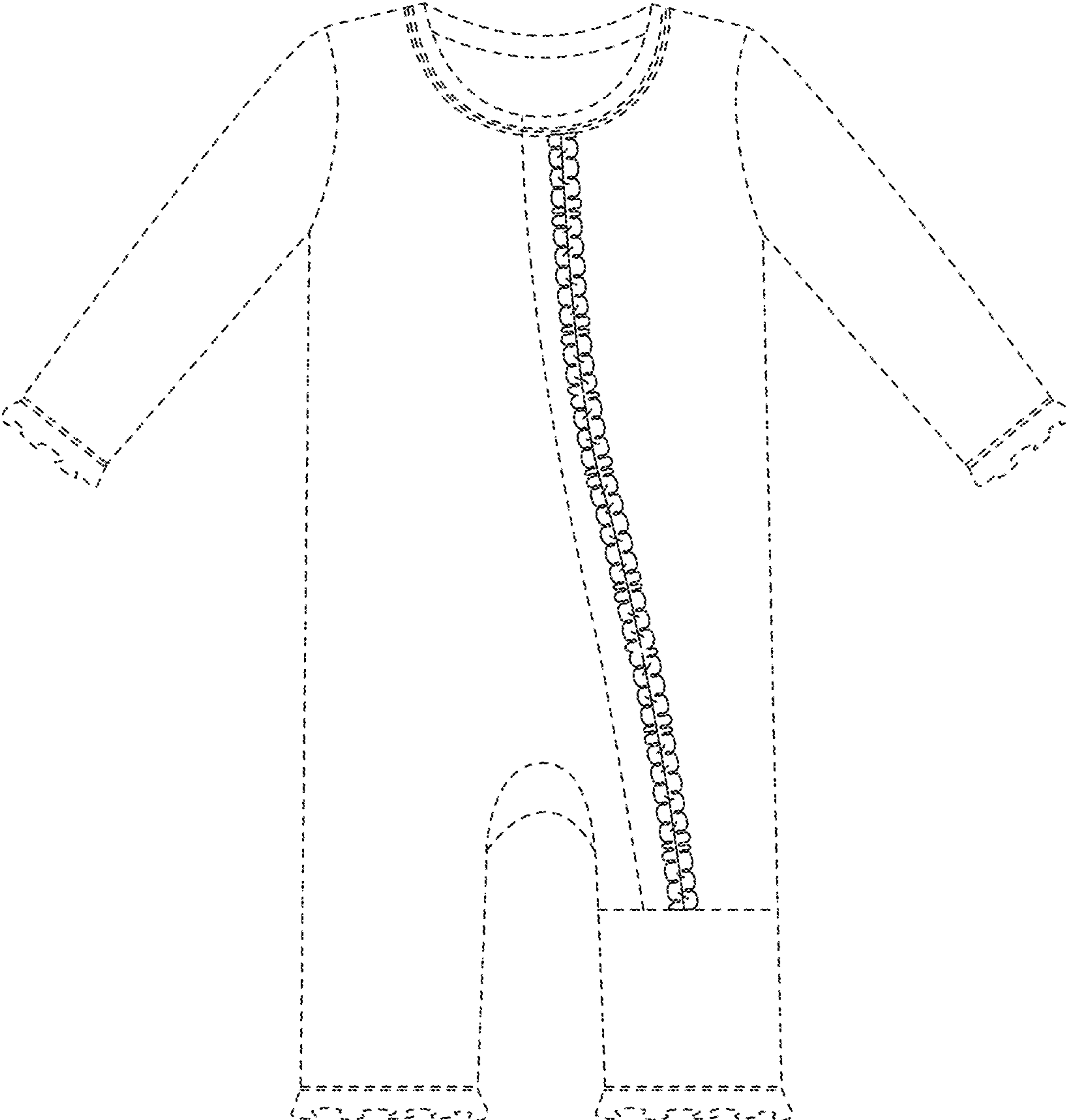

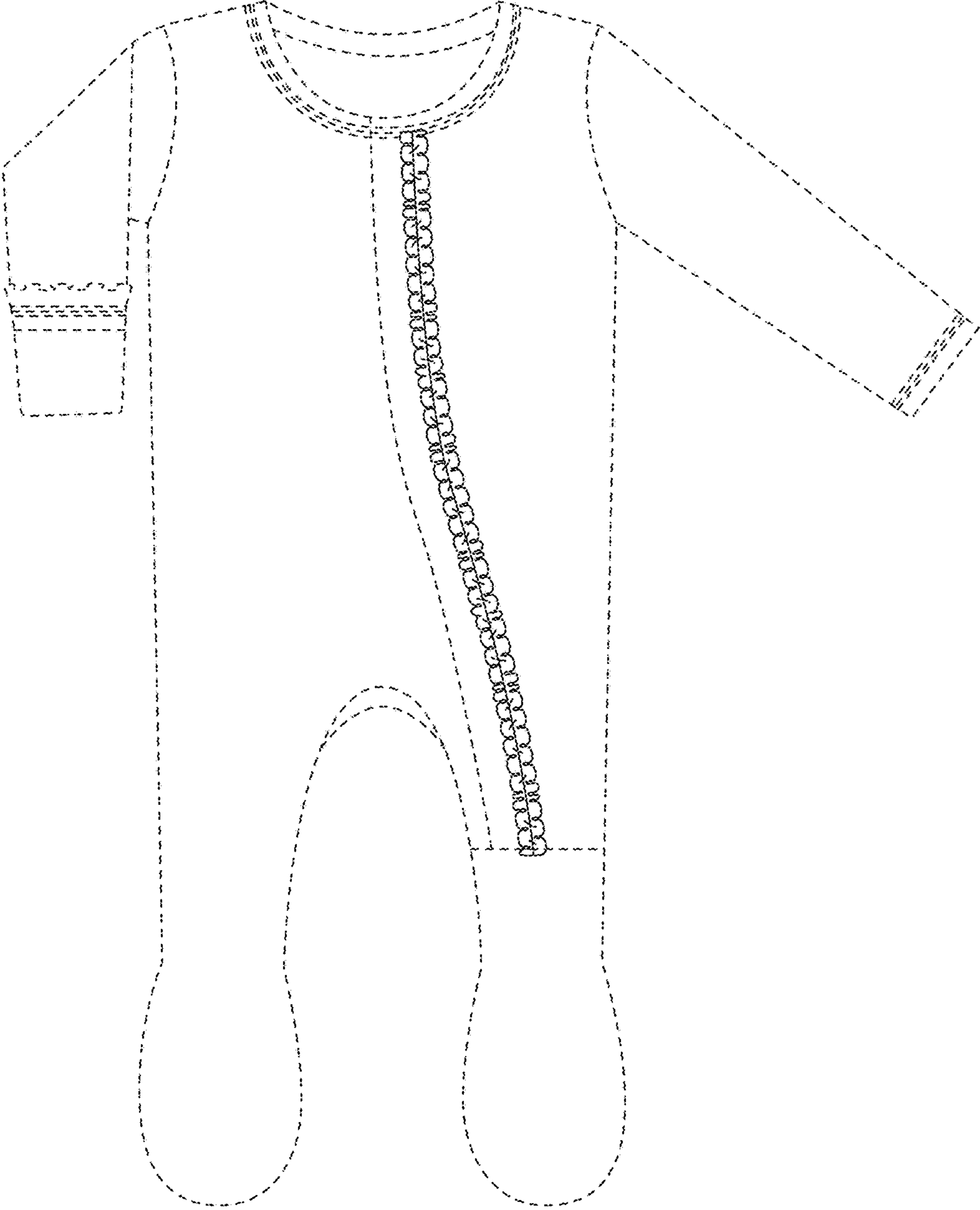
