The ornamental design for a shoe pair, as shown and described.

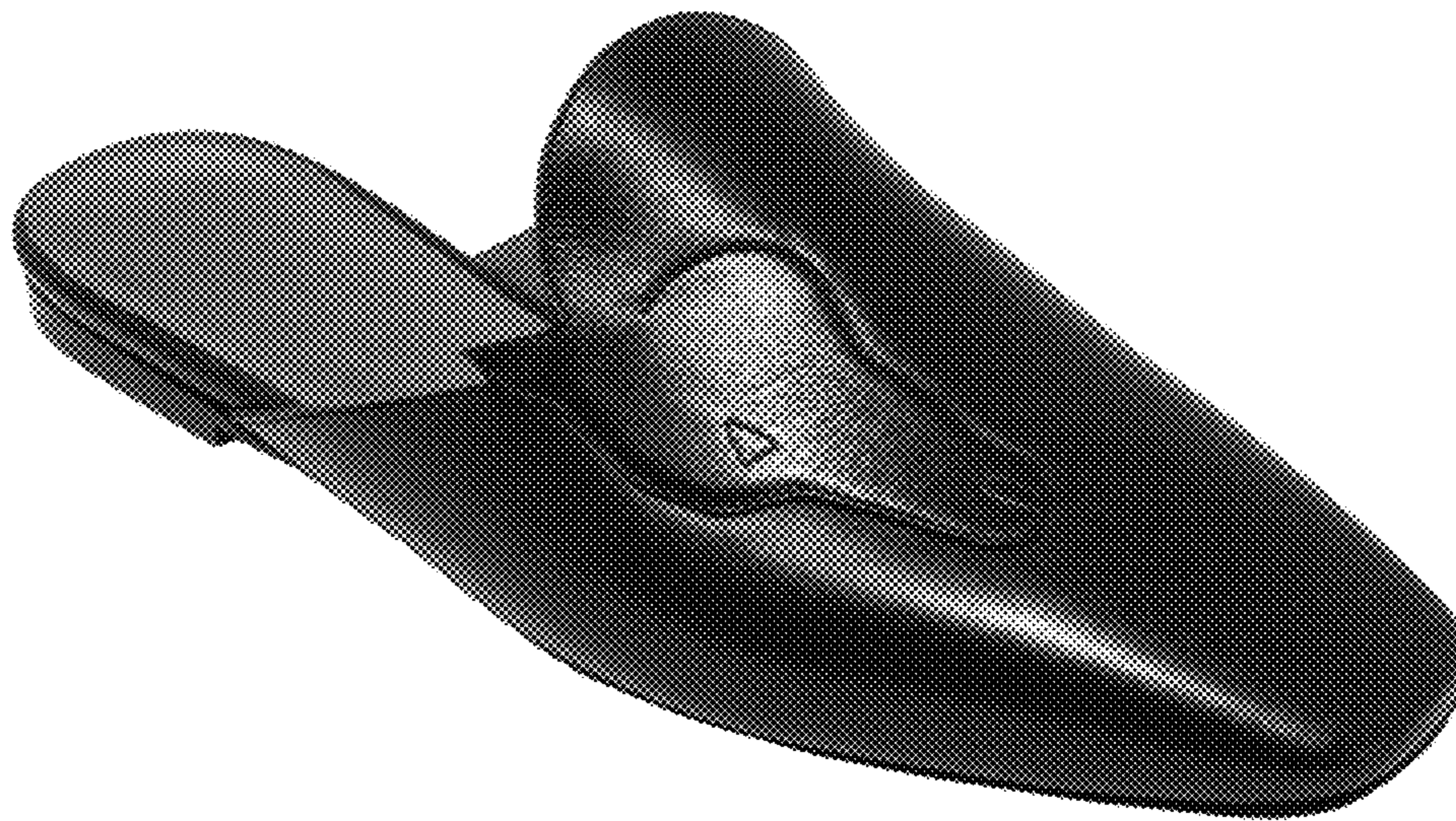
DESCRIPTION

 - 1.15 top view of a first and second shoe pair

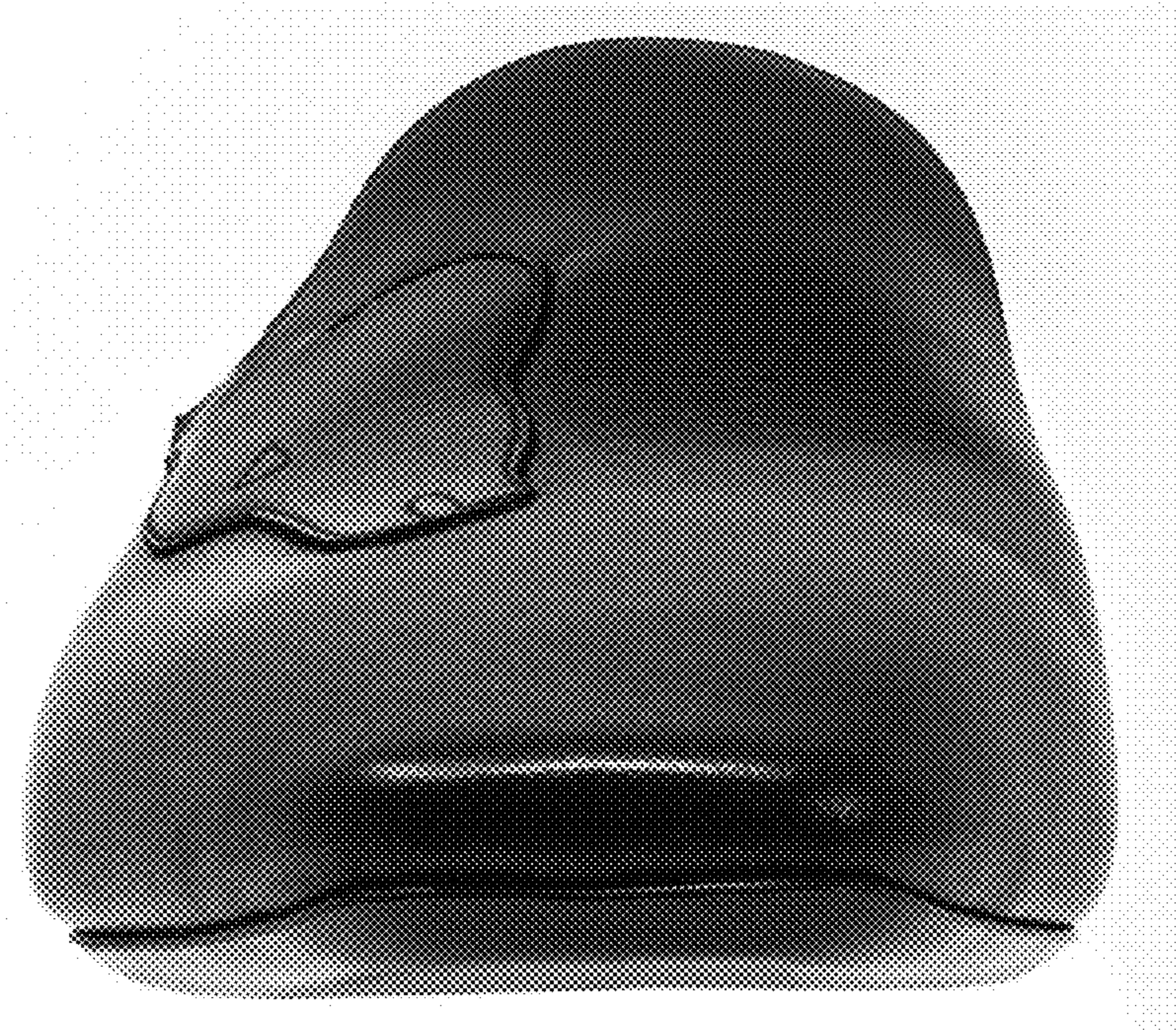

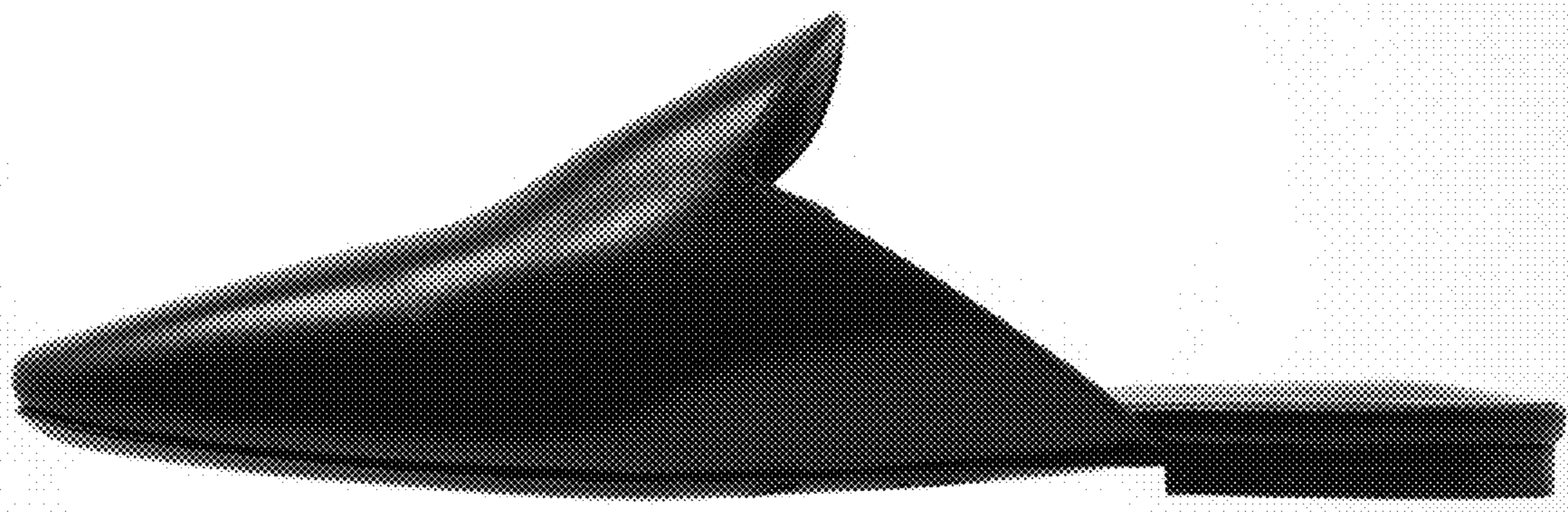

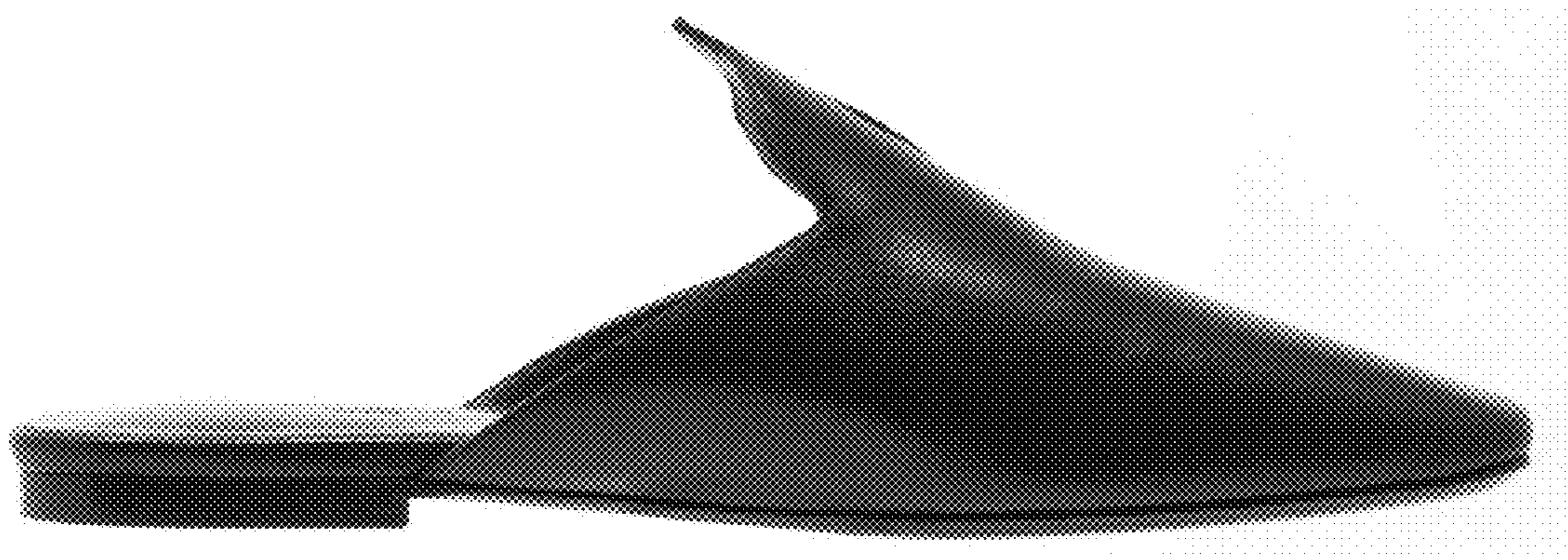

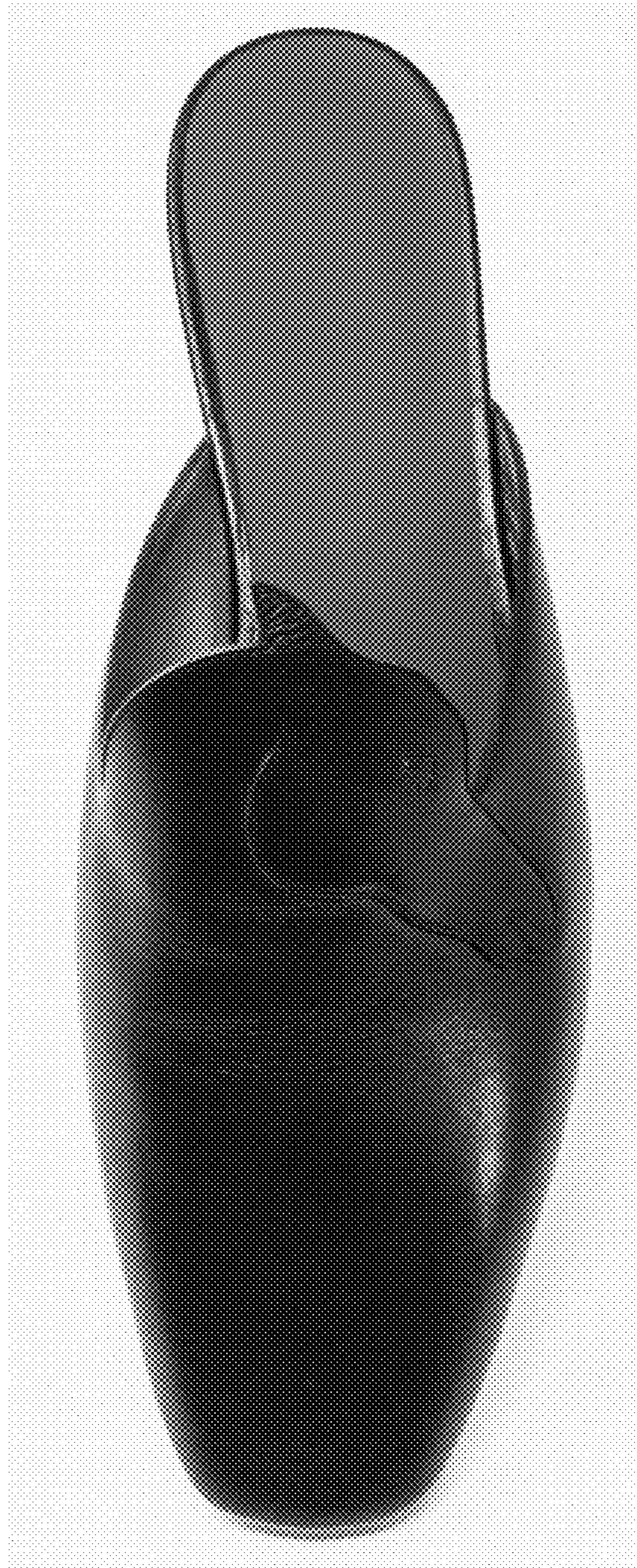
