(57) **CLAIM**

I claim the ornamental design for a backpack, as shown and
described.

DESCRIPTION

FIG. 1 is a front perspective view of a backpack according
to the present invention from the right side thereof. The left
side of the backpack is a mirror image of the right side; and,

The bottom of the backpack is unornamented and forms no
part of the claimed design. The grayed out portions of the
backpack form no part of the claimed design. The dash dot
dash line depicts the claim boundary and forms no part
thereof.

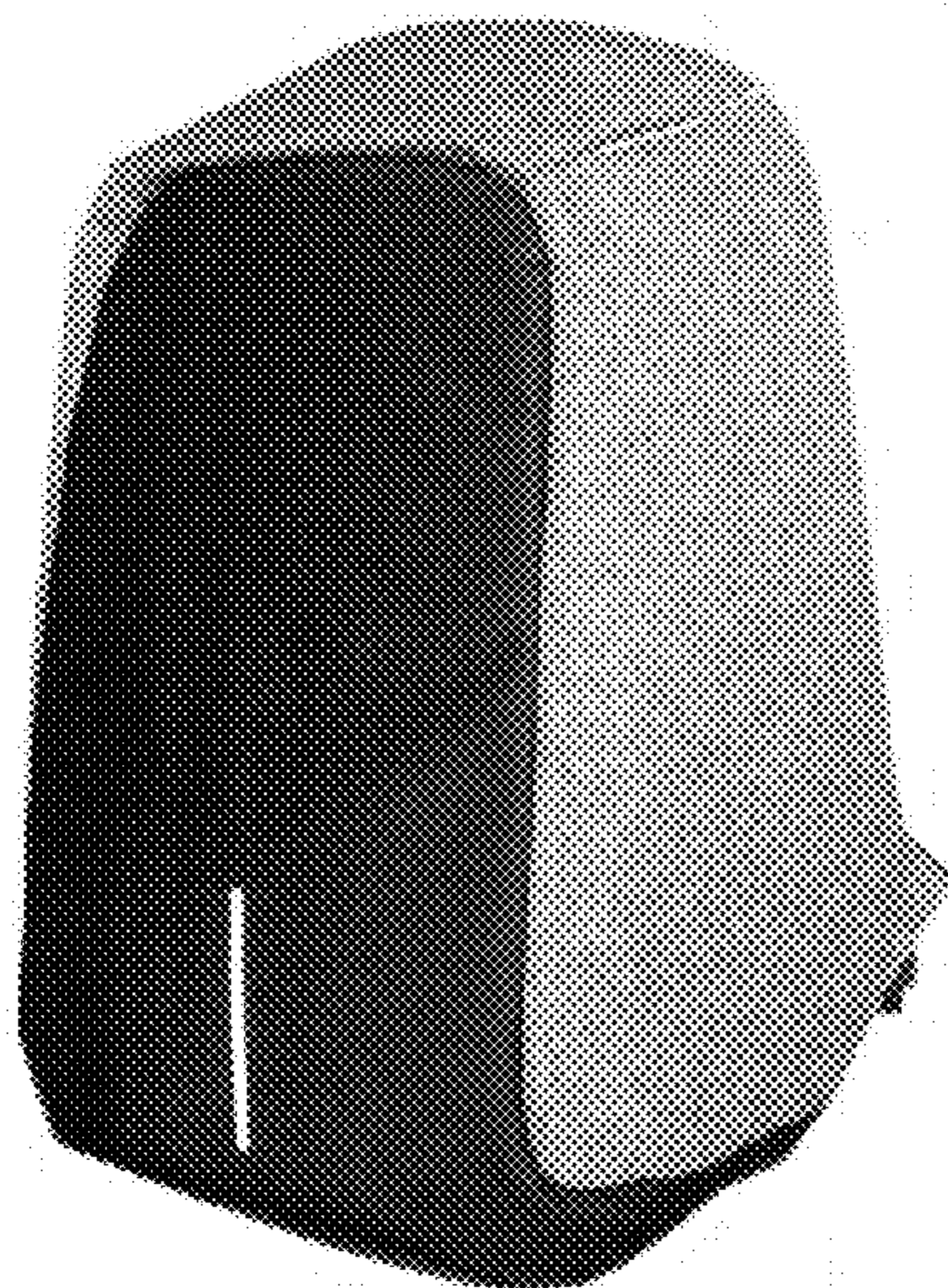
