1.5 : Right

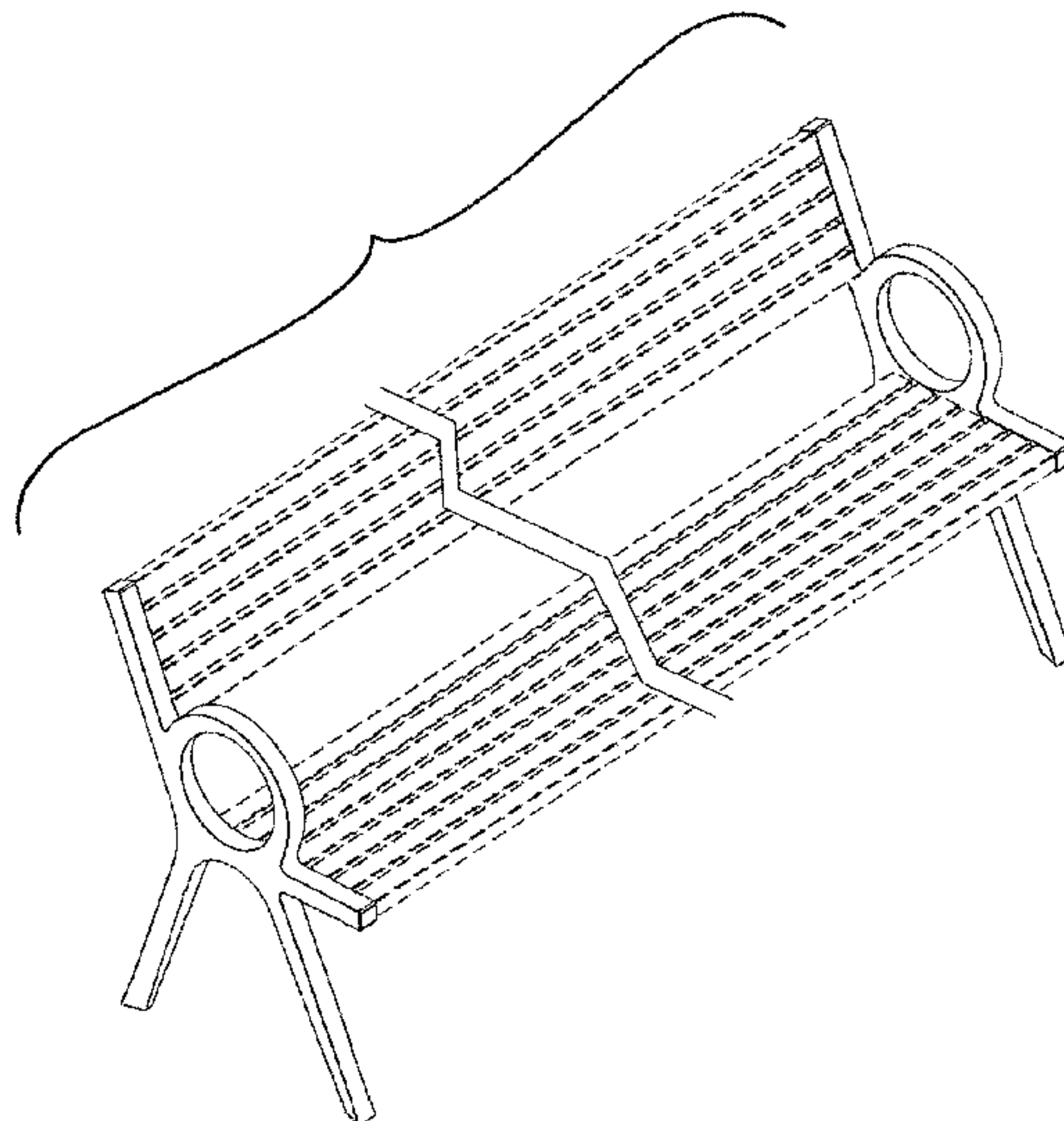
1.6 : Bottom

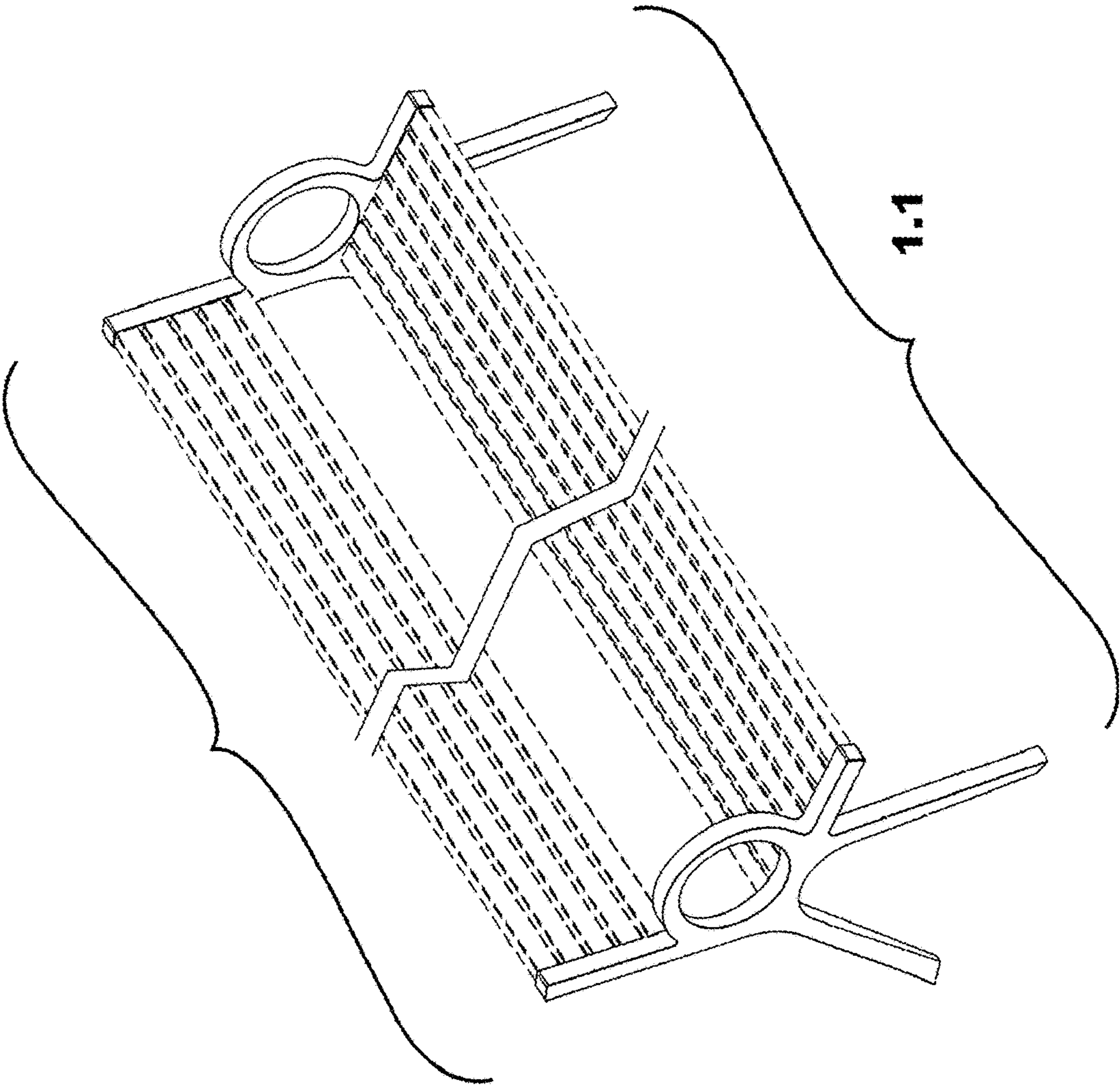

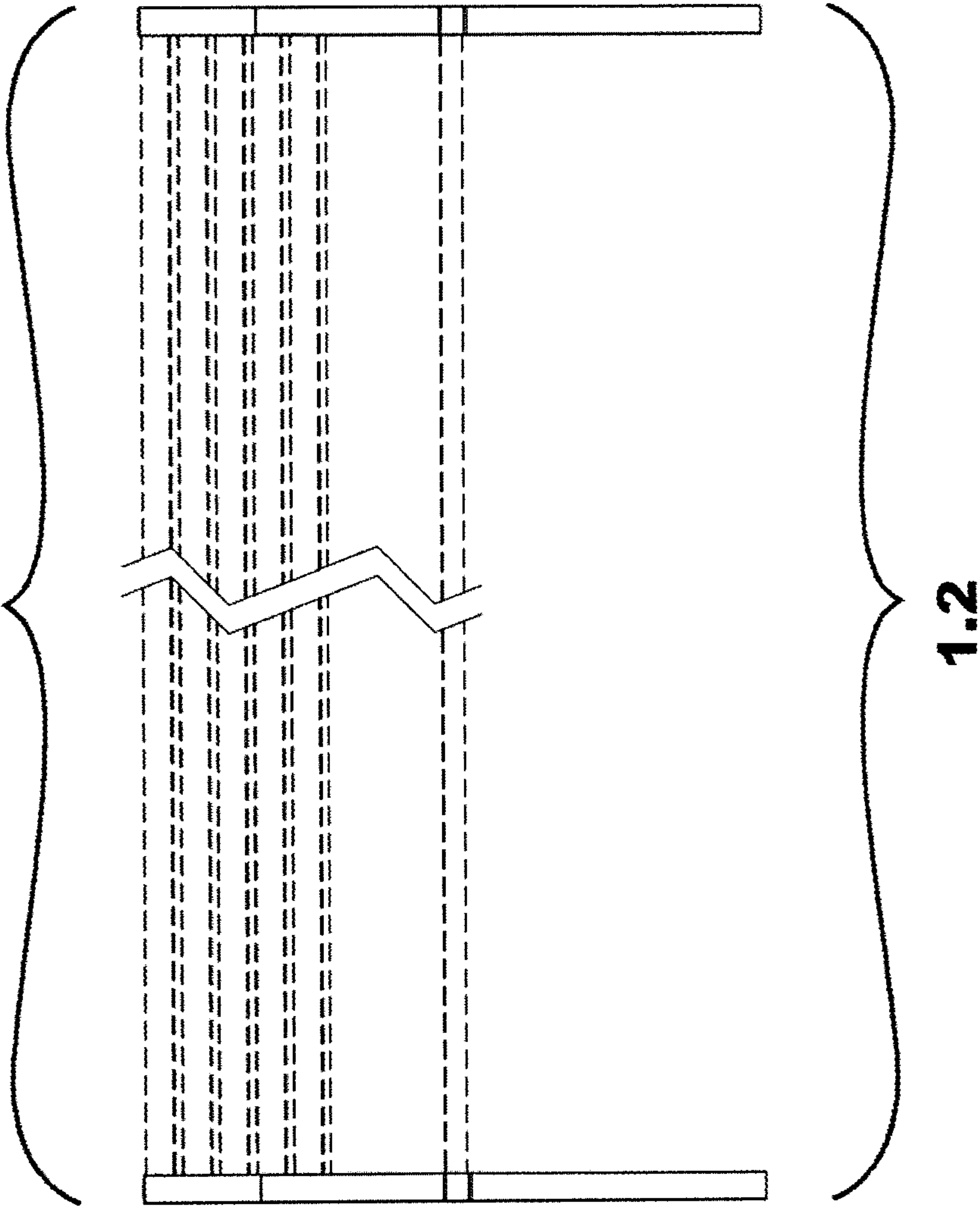
The parts shown by means of broken ones in the reproductions are not part of the claimed design.

The bench is shown with a symbolic break in its width. The appearance of any portion of the article between the break lines forms no part of the design.

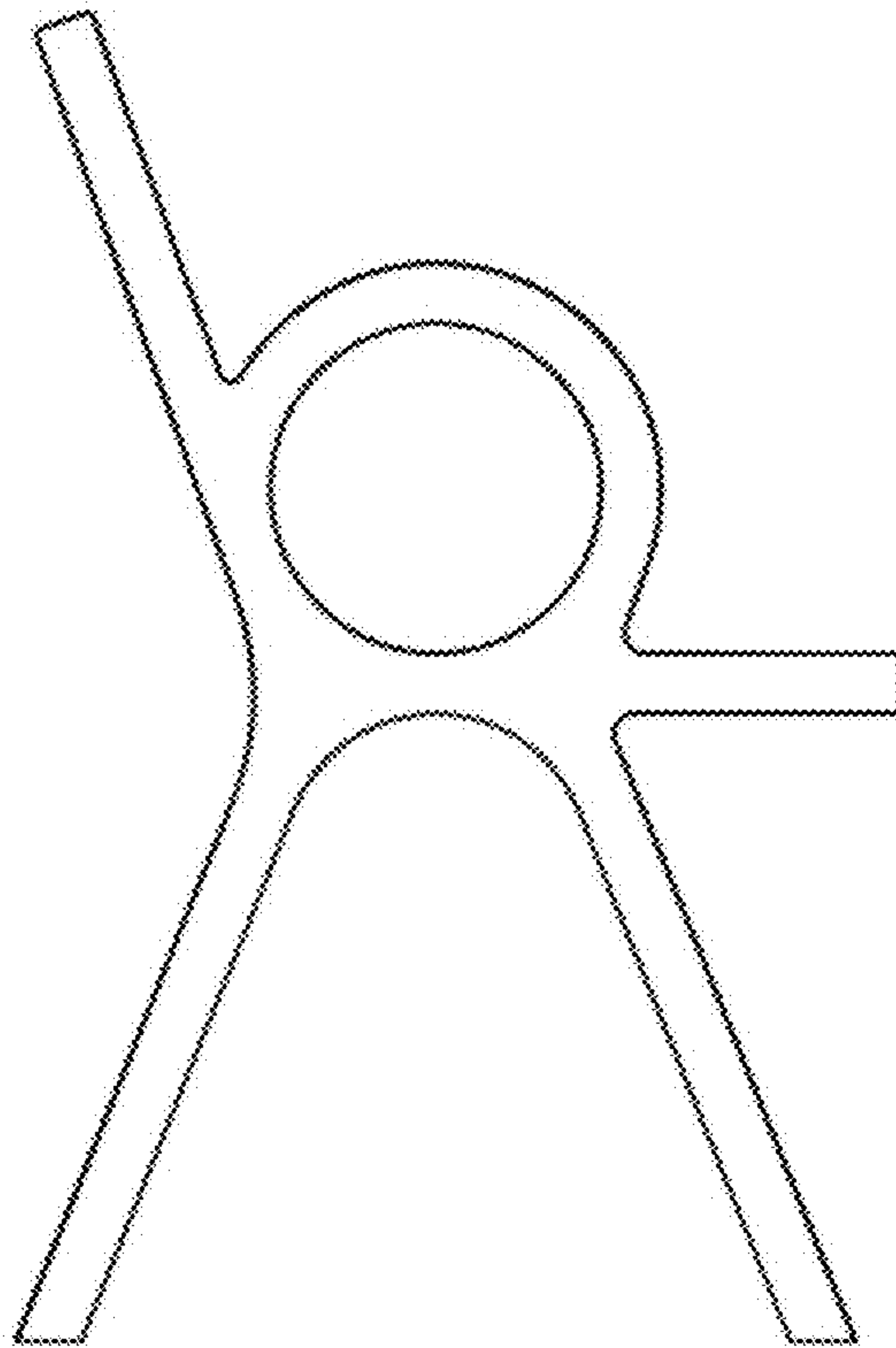

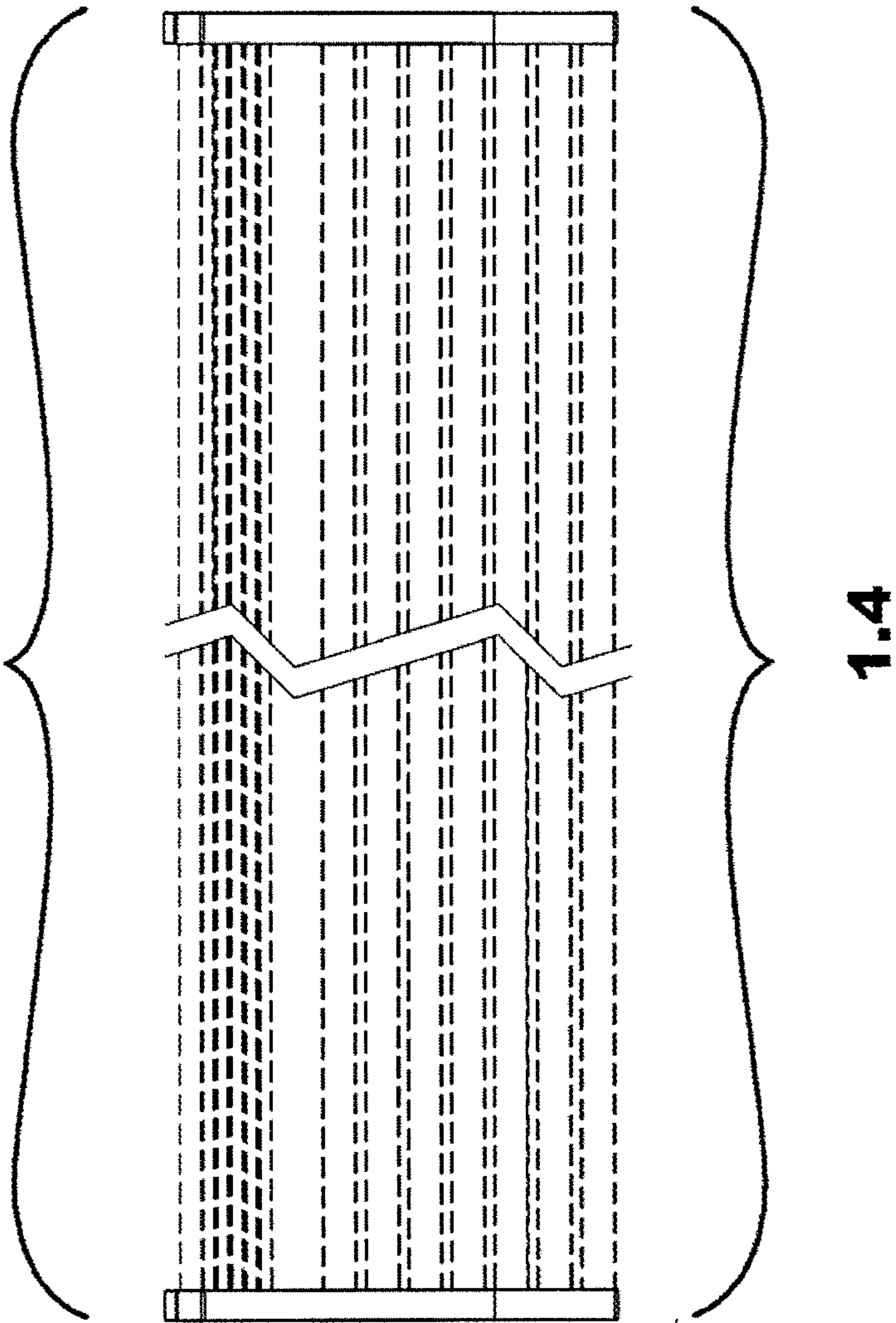
