**DESCRIPTION**

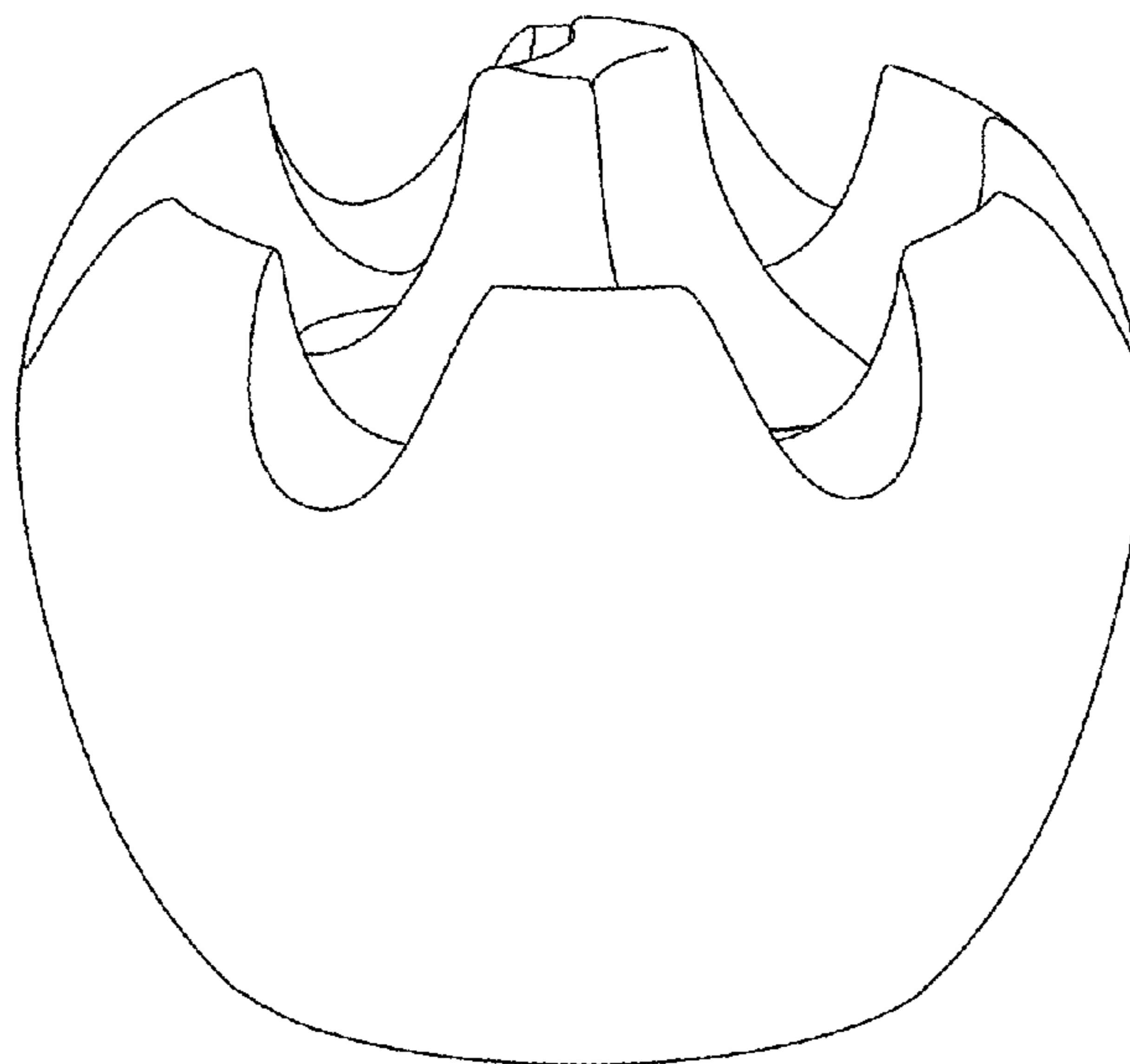
FIG. 1 is a perspective view from the top of a toothed ball

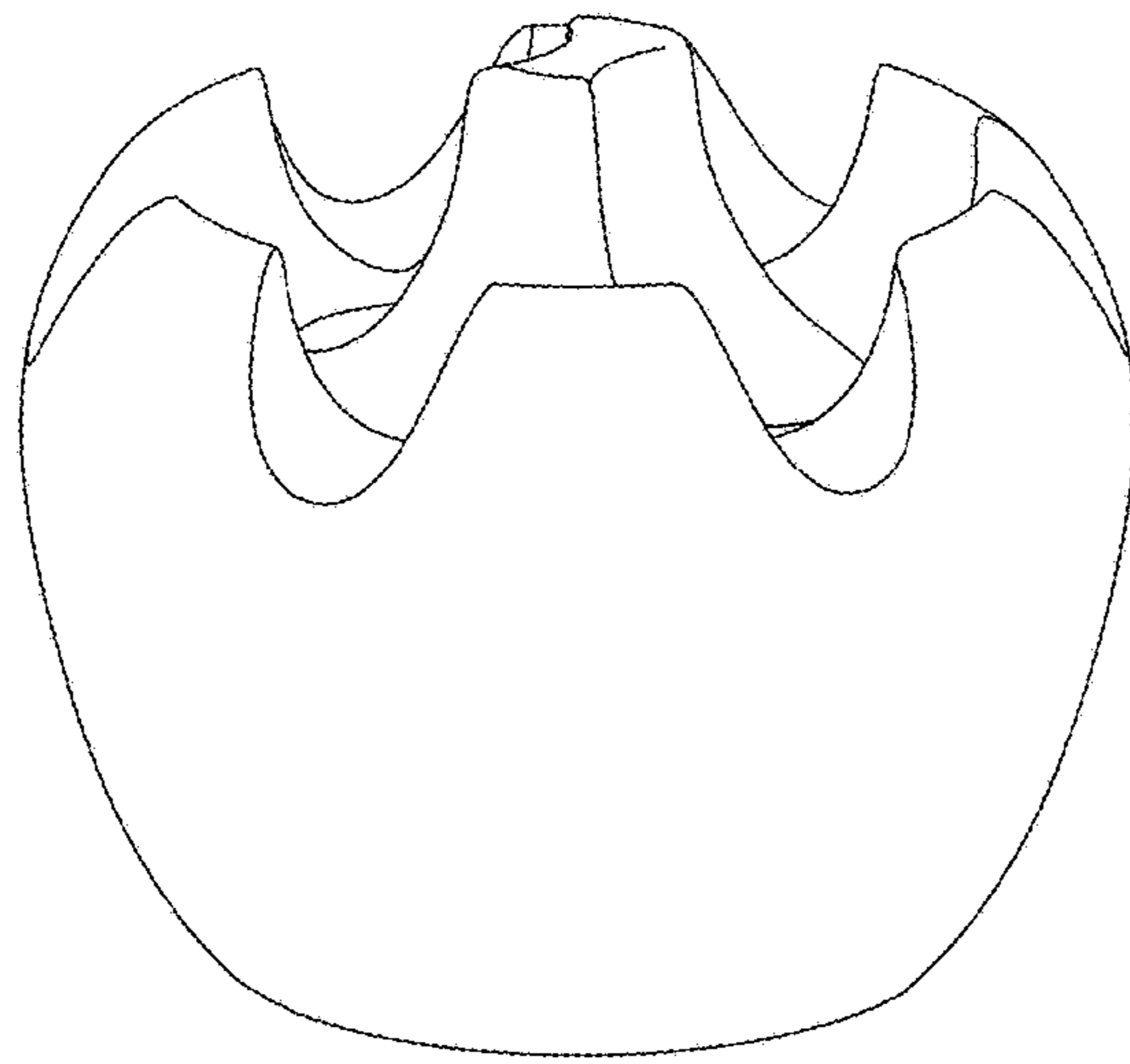

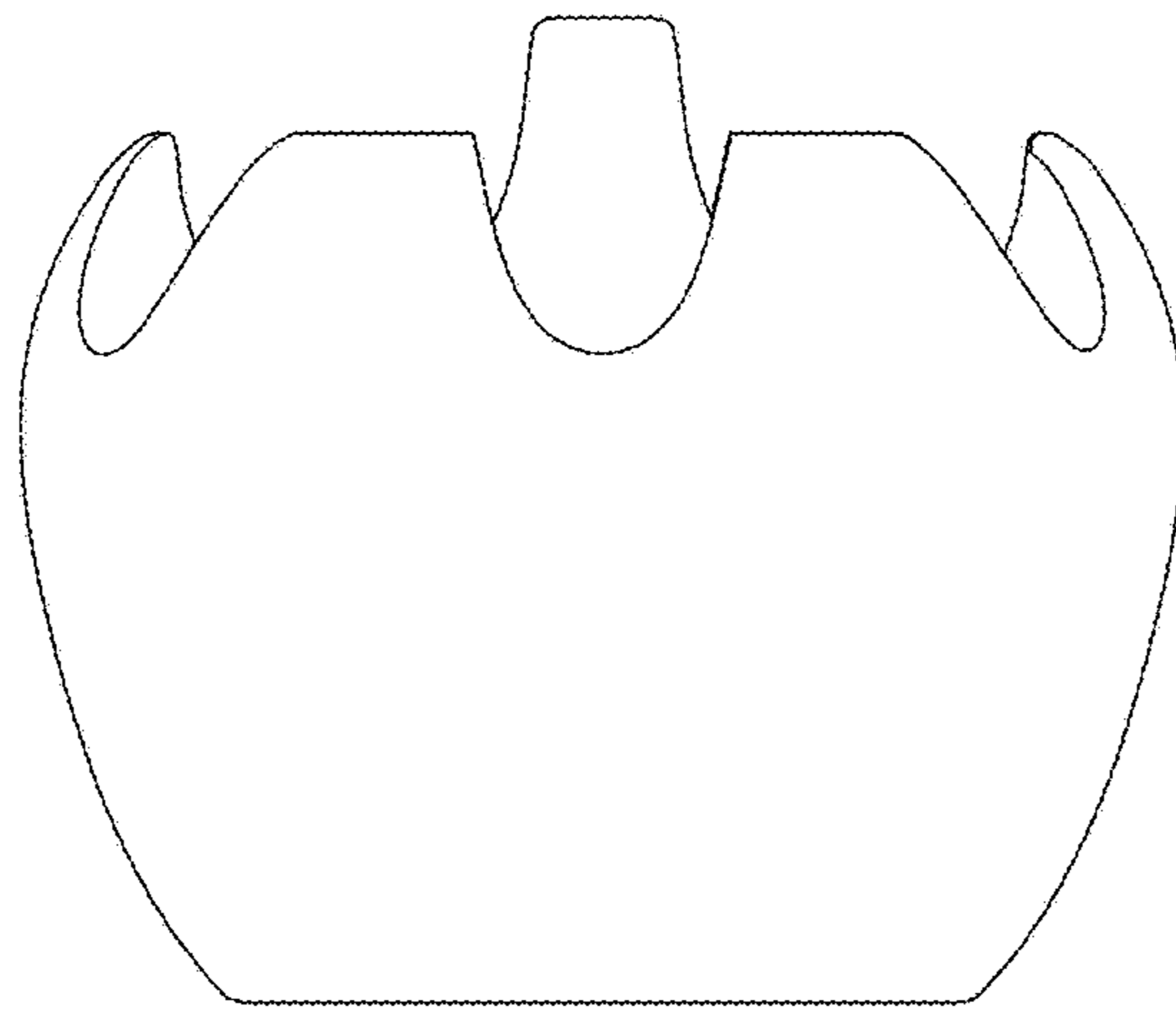

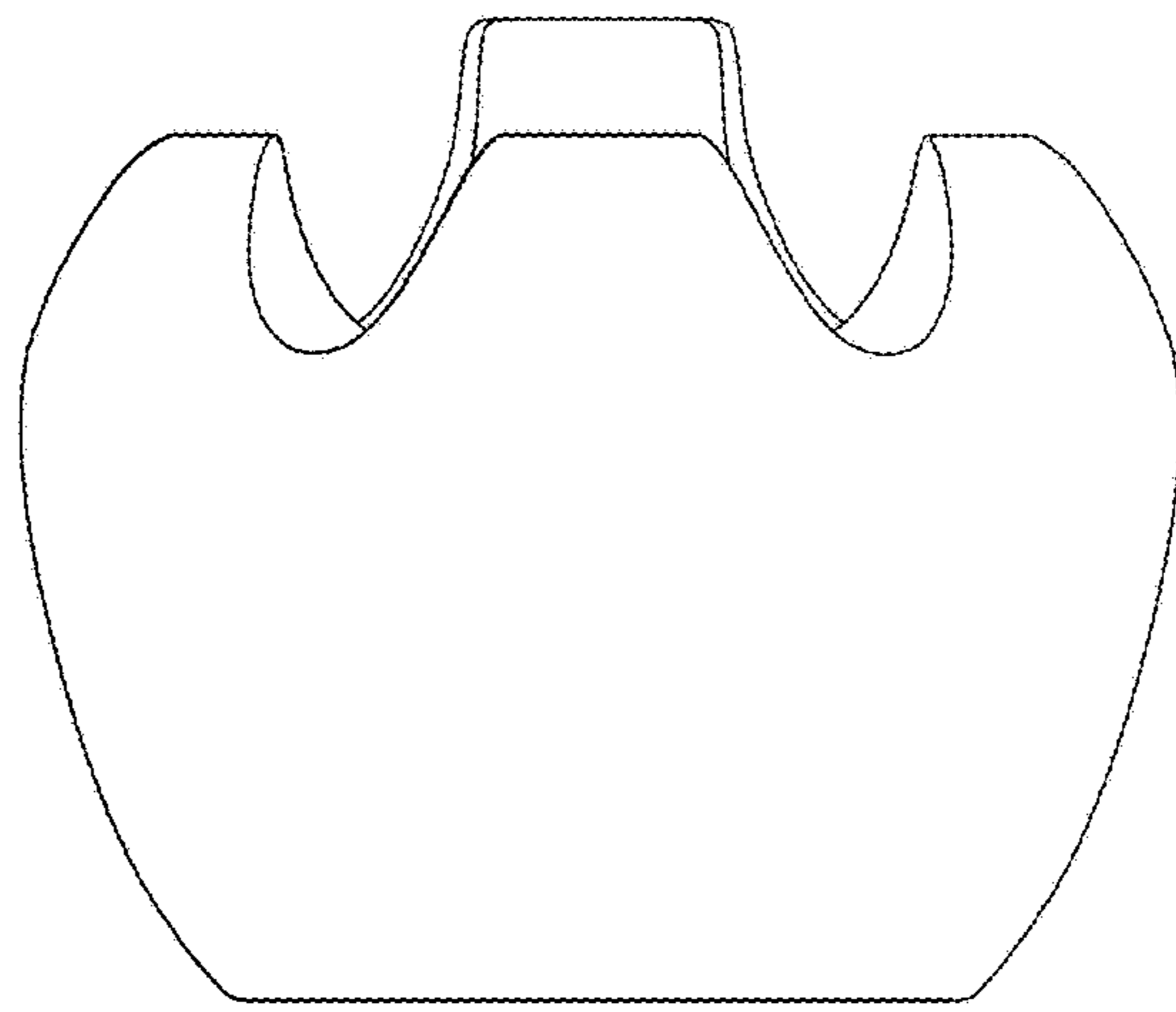

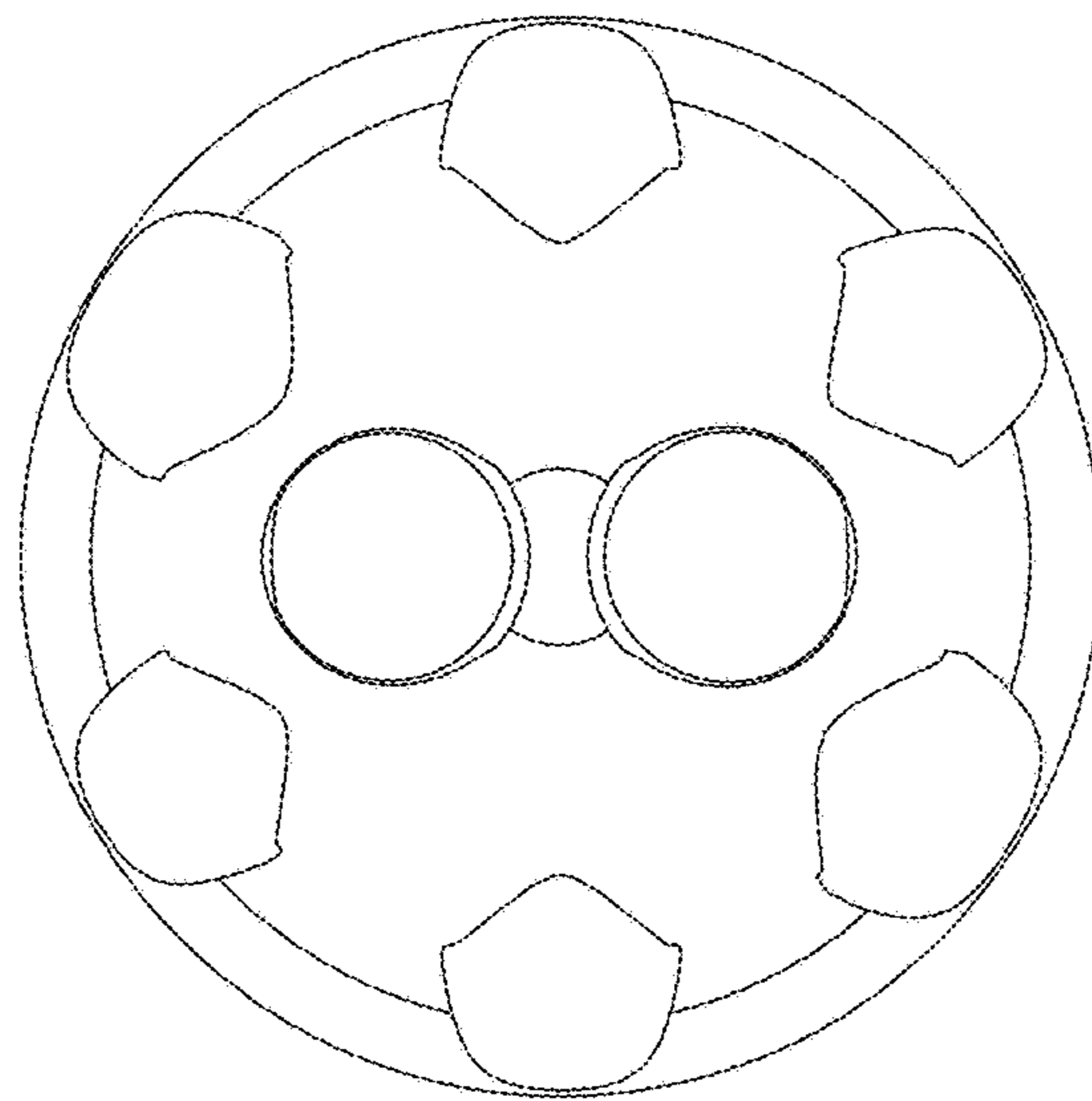

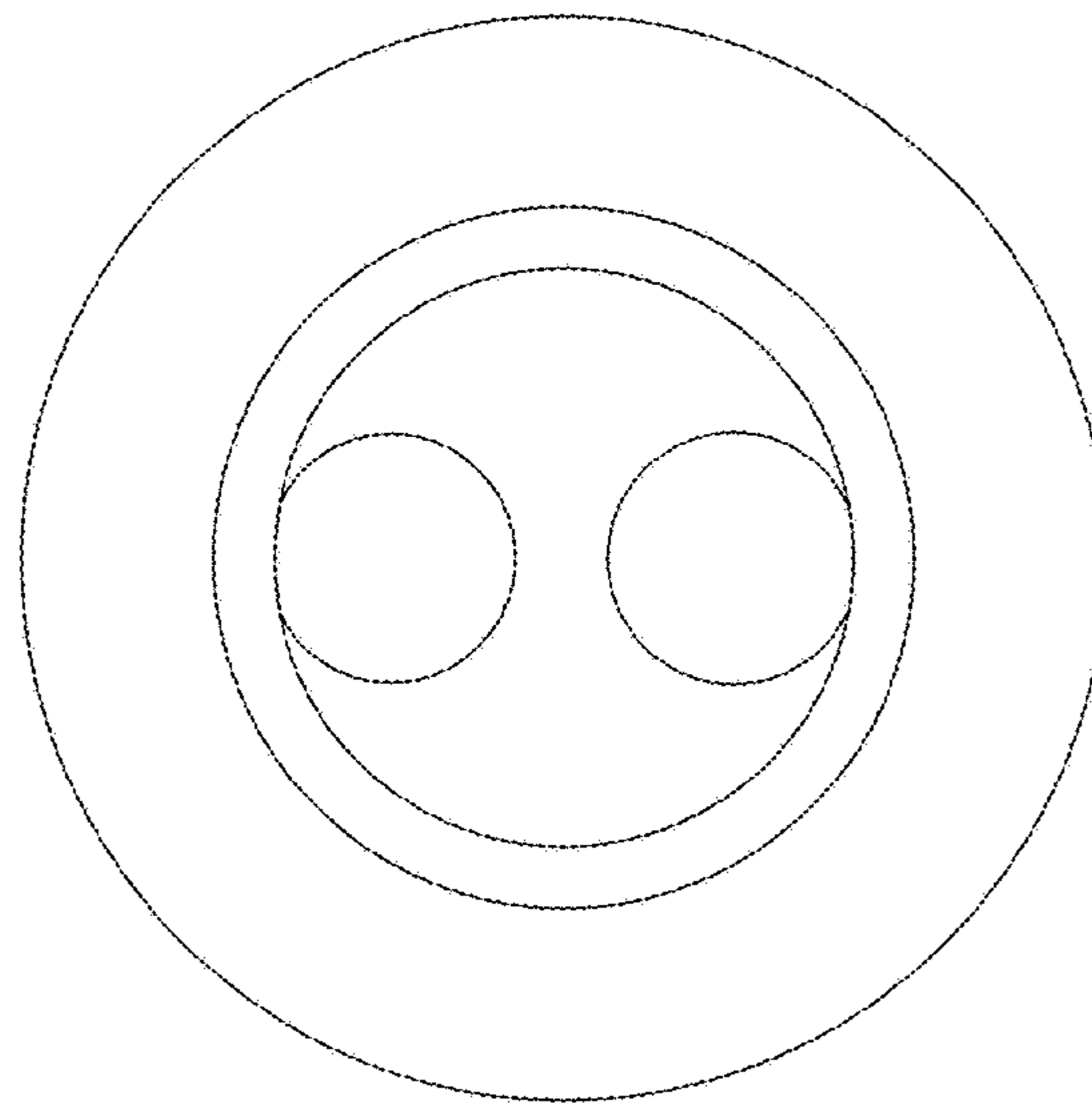

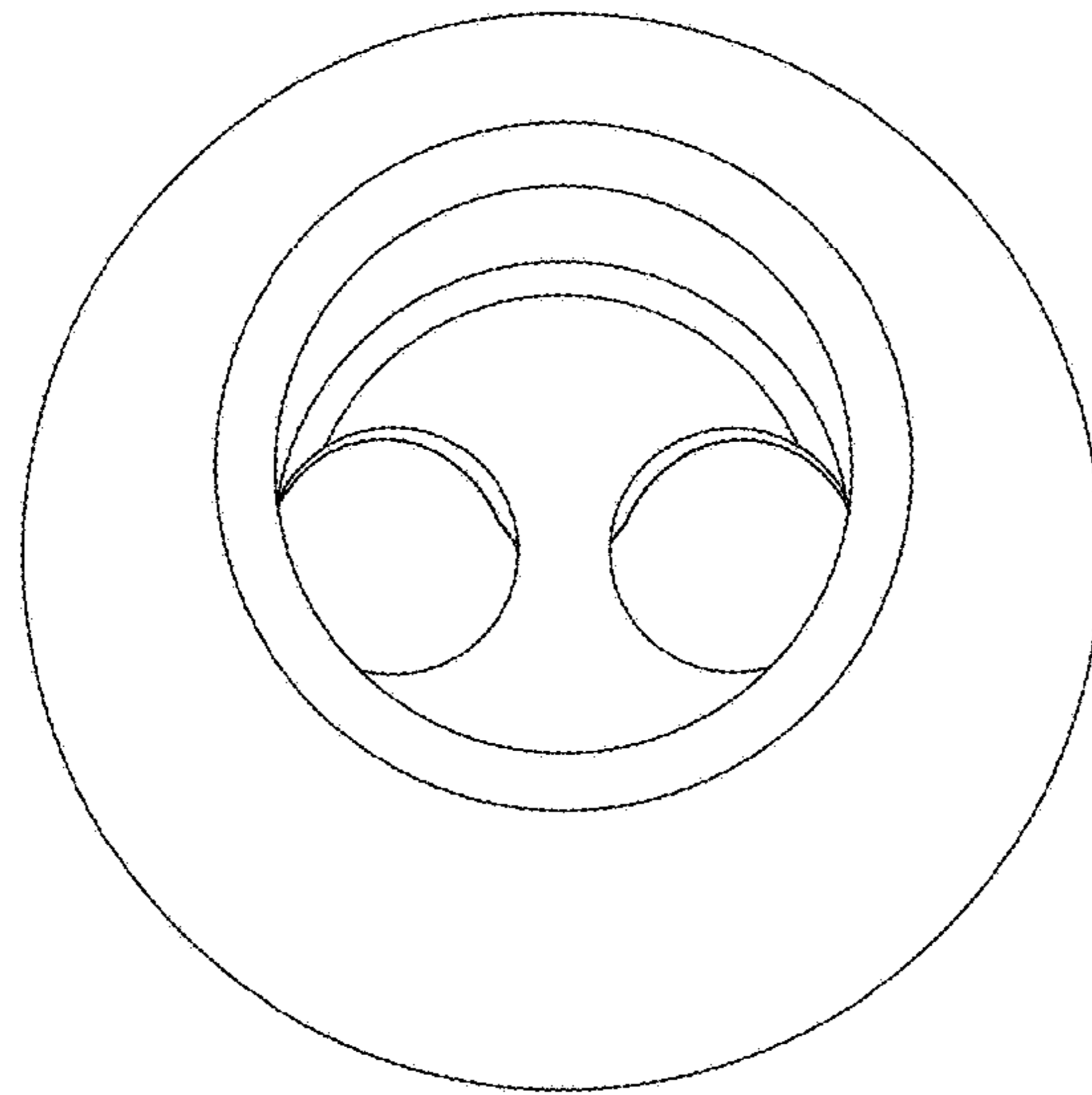
