1;

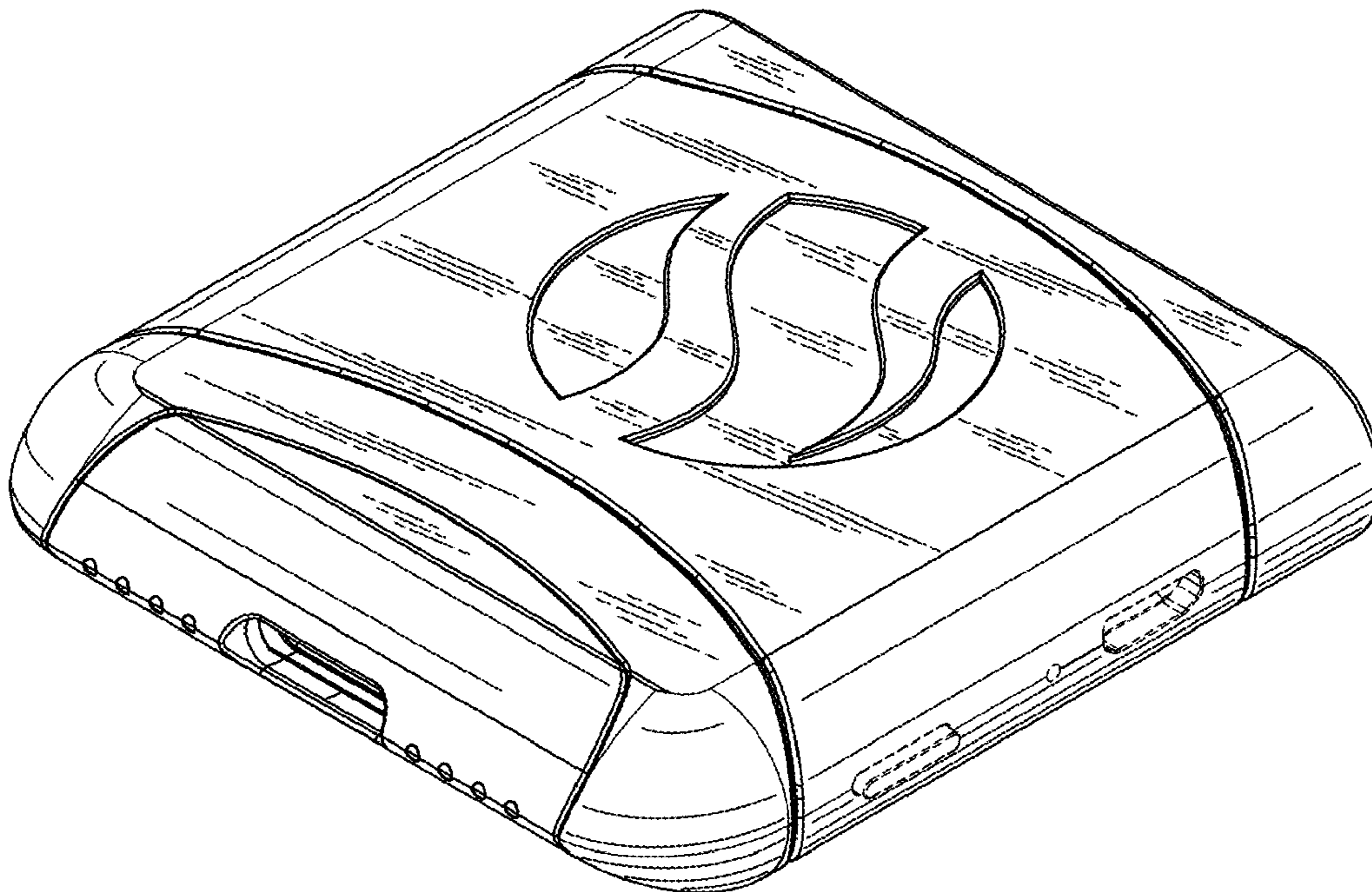
FIG. 6 is a left side elevational view of breath analyzer of

FIG. 1; and,

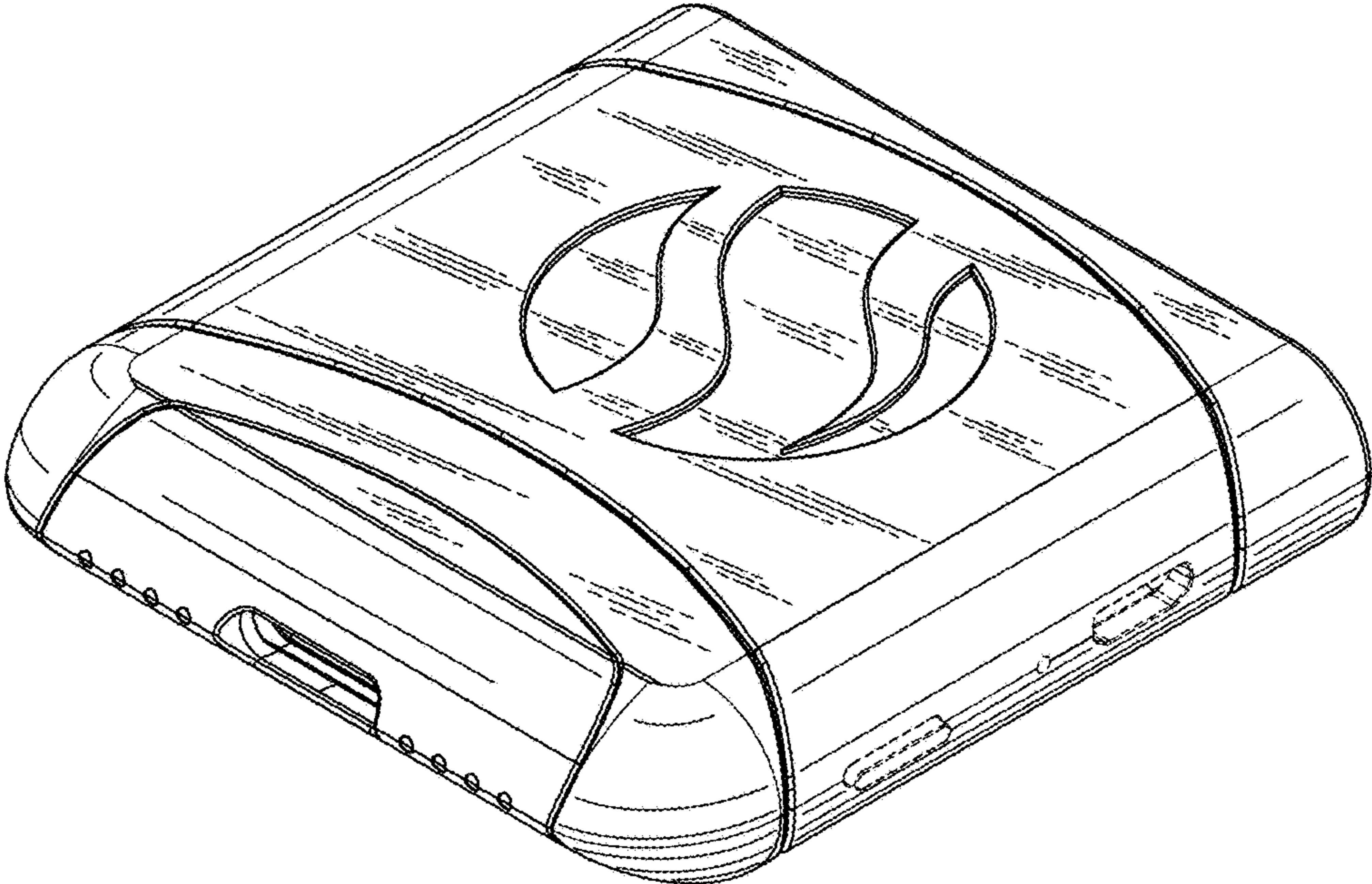
FIG. 8 is a front perspective view of breath analyzer of FIG.

form no part of the claimed design.

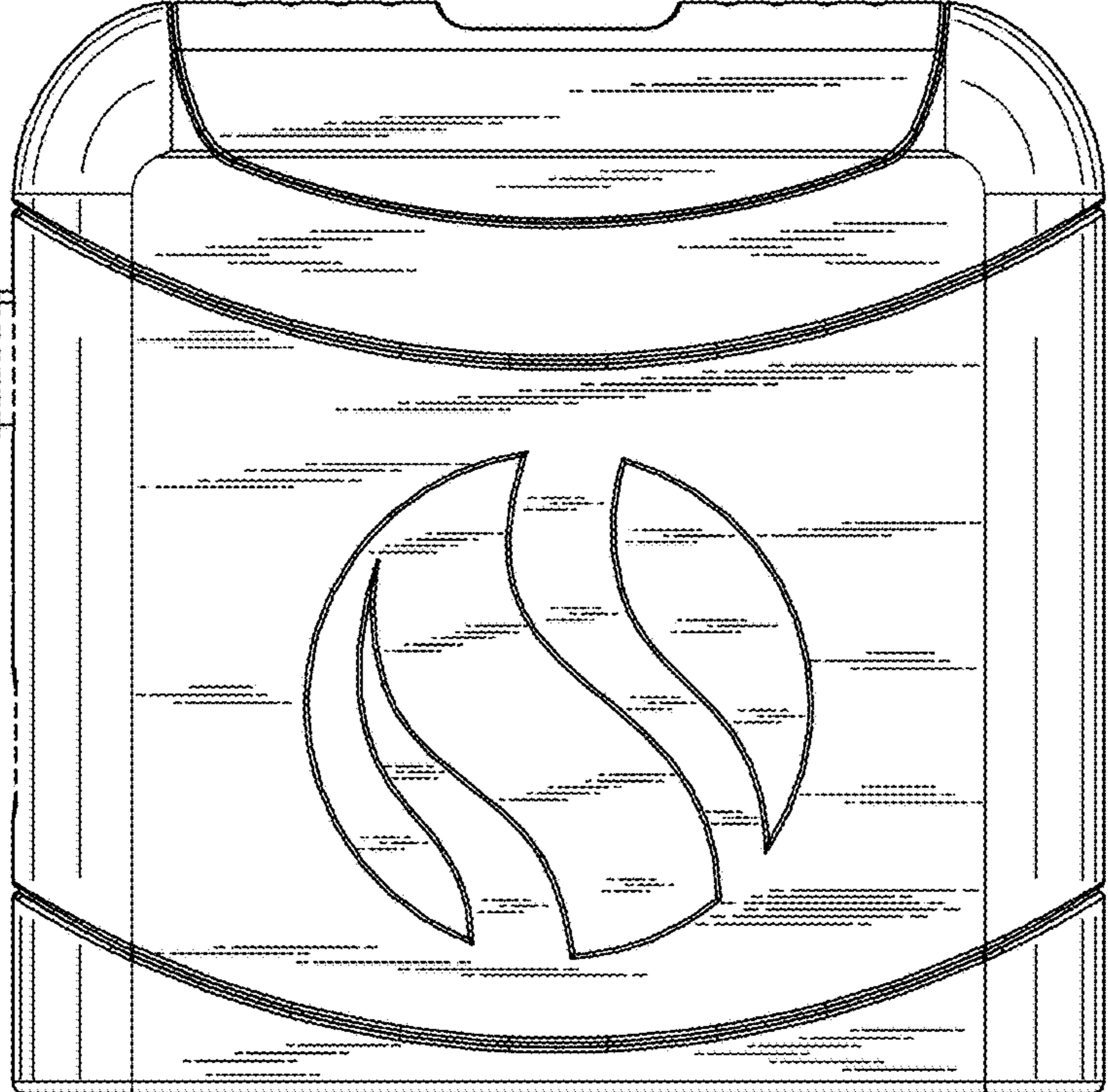

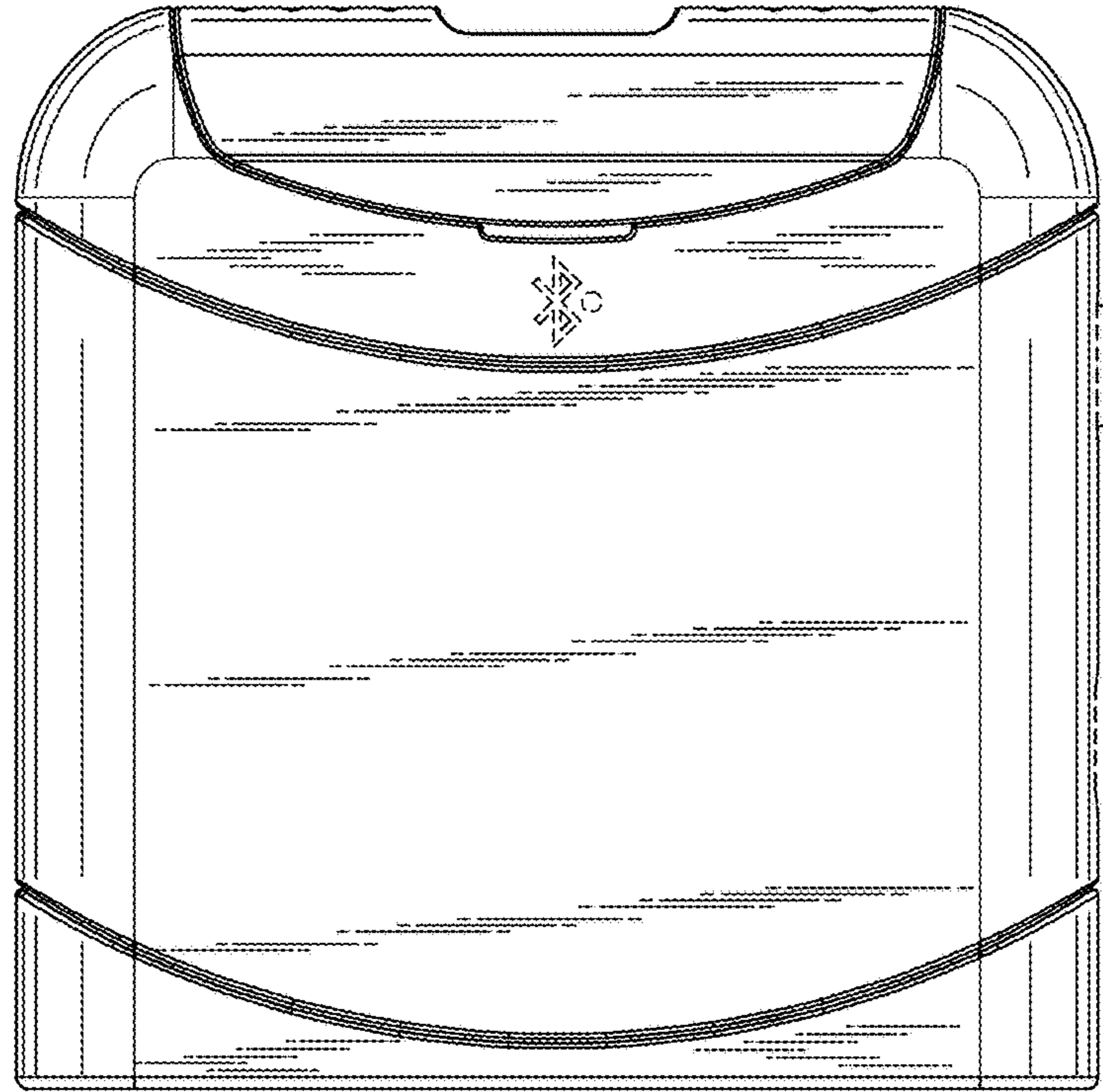

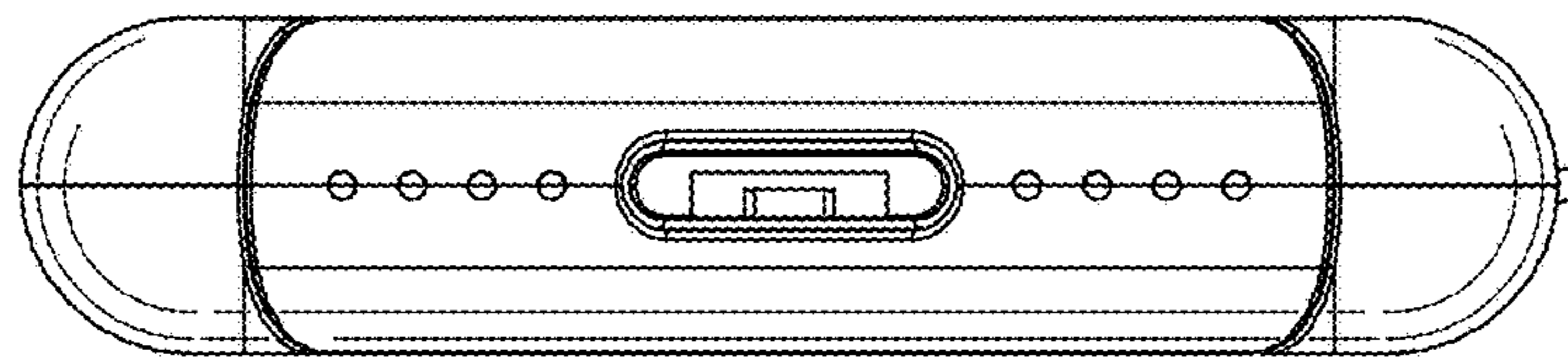

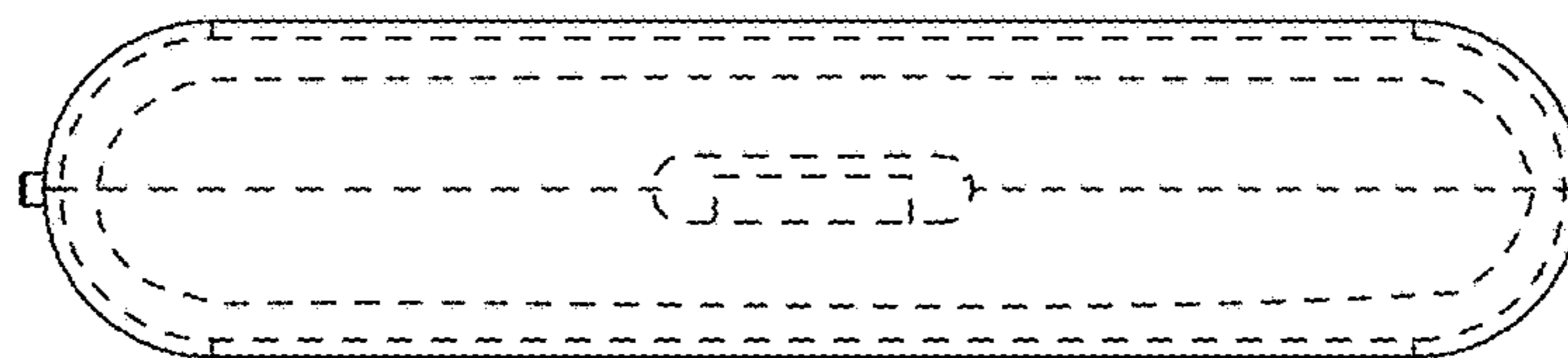

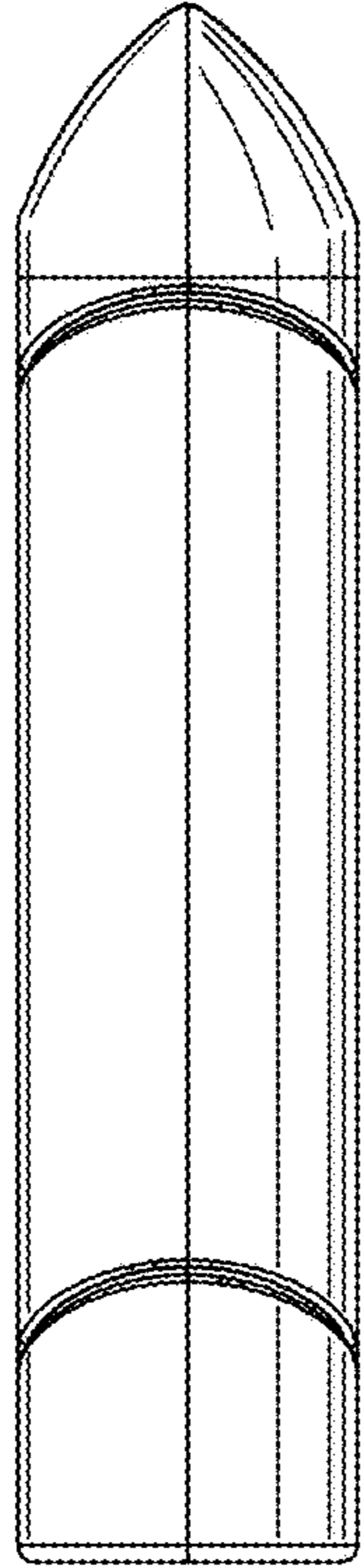

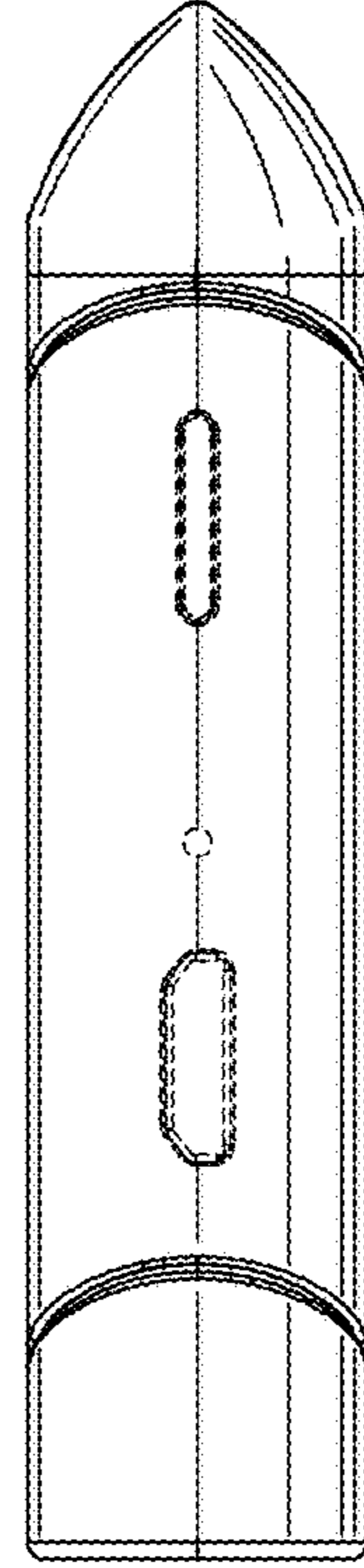
