(57) **CLAIM**

The ornamental design for a leather watch band, as shown and described.

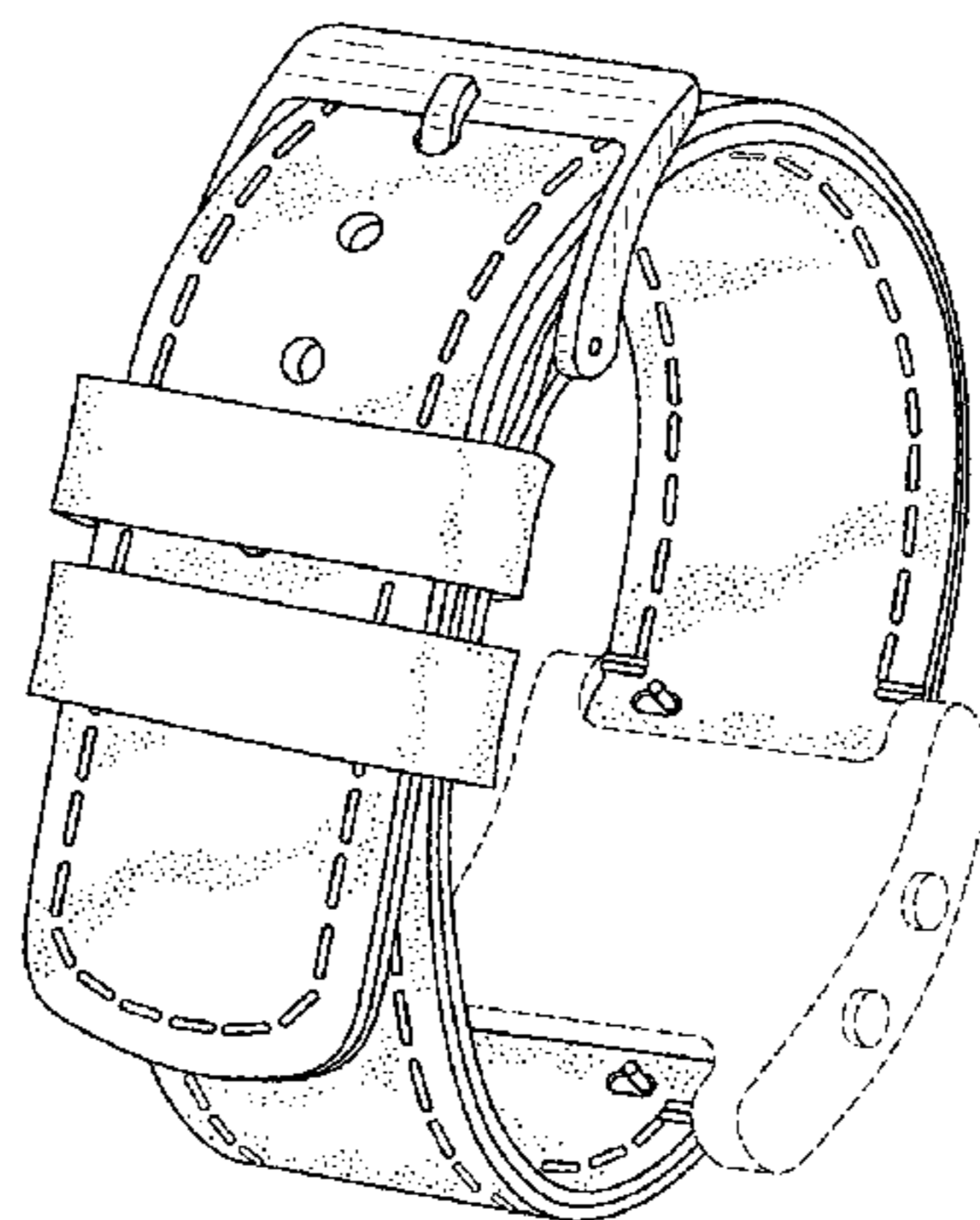
**DESCRIPTION**

FIG. 1 is an isometric view of the leather watch band; FIG. 2 is a top plan view of the leather watch band; FIG. 3 is a left side elevation view of the leather watch band, with the right side elevation view being the same; FIG. 4 is a bottom plan view of the leather watch band; FIG. 5 is a front elevation view of the leather watch band; and,

FIG. 6 is a back elevation view of the leather watch band. The stipple shading in the figures is fragmentarily shown for convenience of illustration, it being understood that the stipple shading is uniformly continued over the surface on which it appears.

The broken lines in the drawing illustrate environmental structure that forms no part of the claimed design. The illustrated stitching pattern forms part of the claimed design. 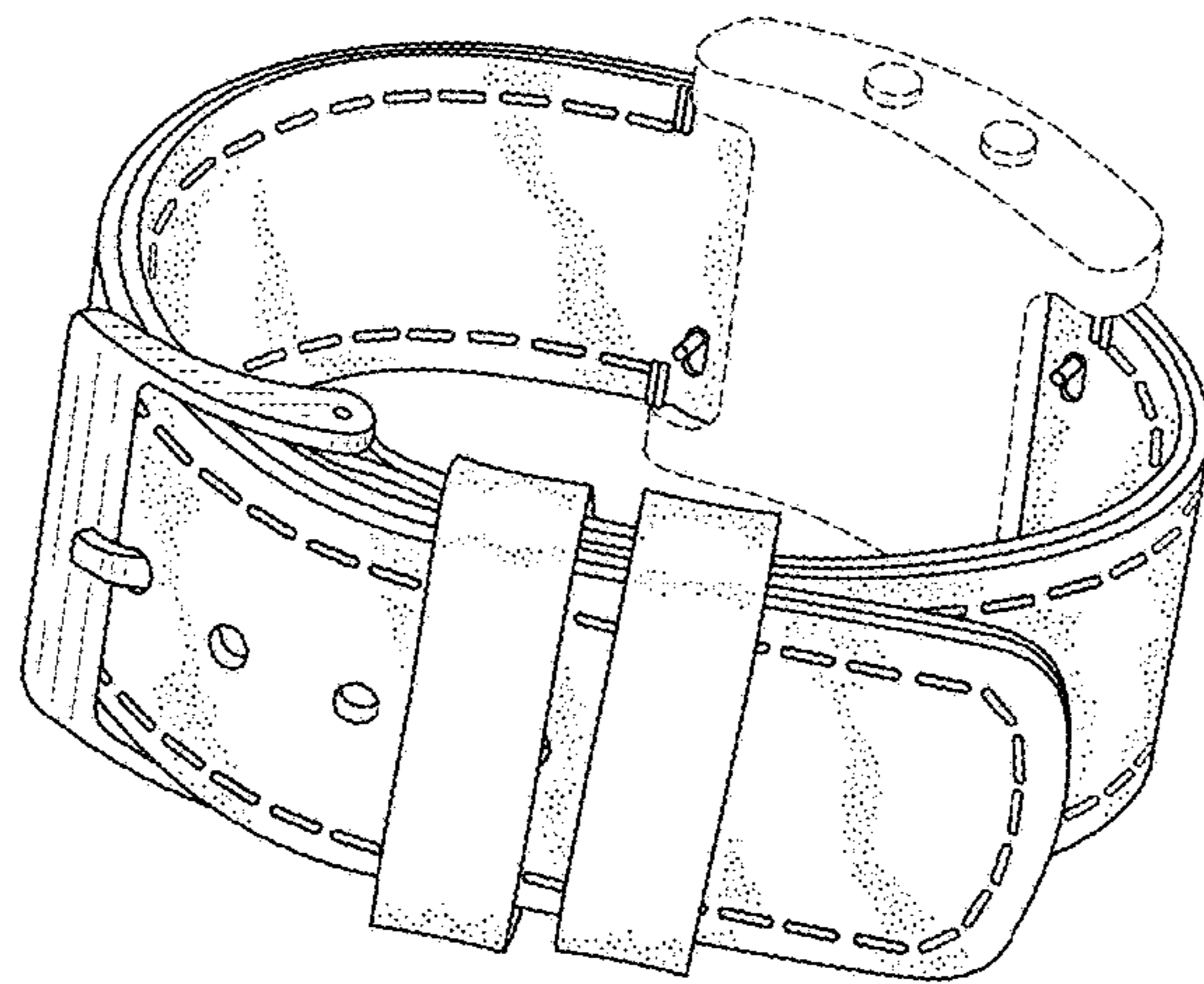

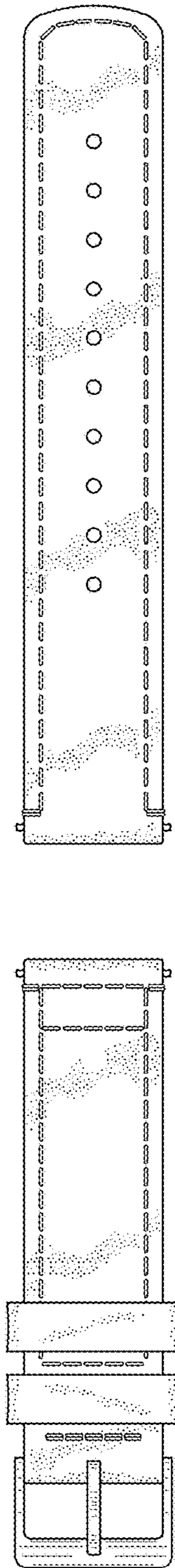

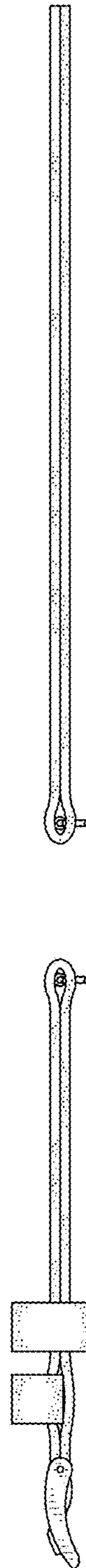

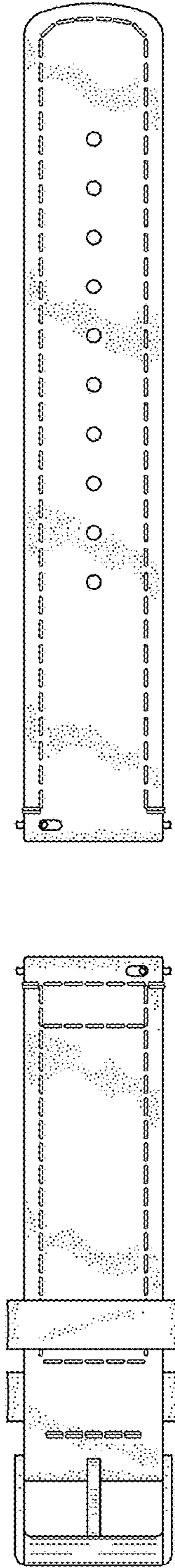

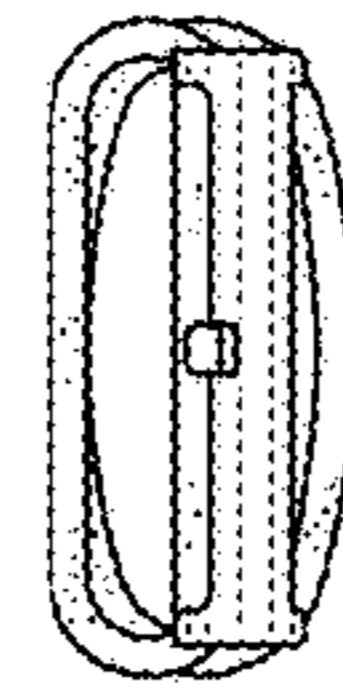
