DESCRIPTION

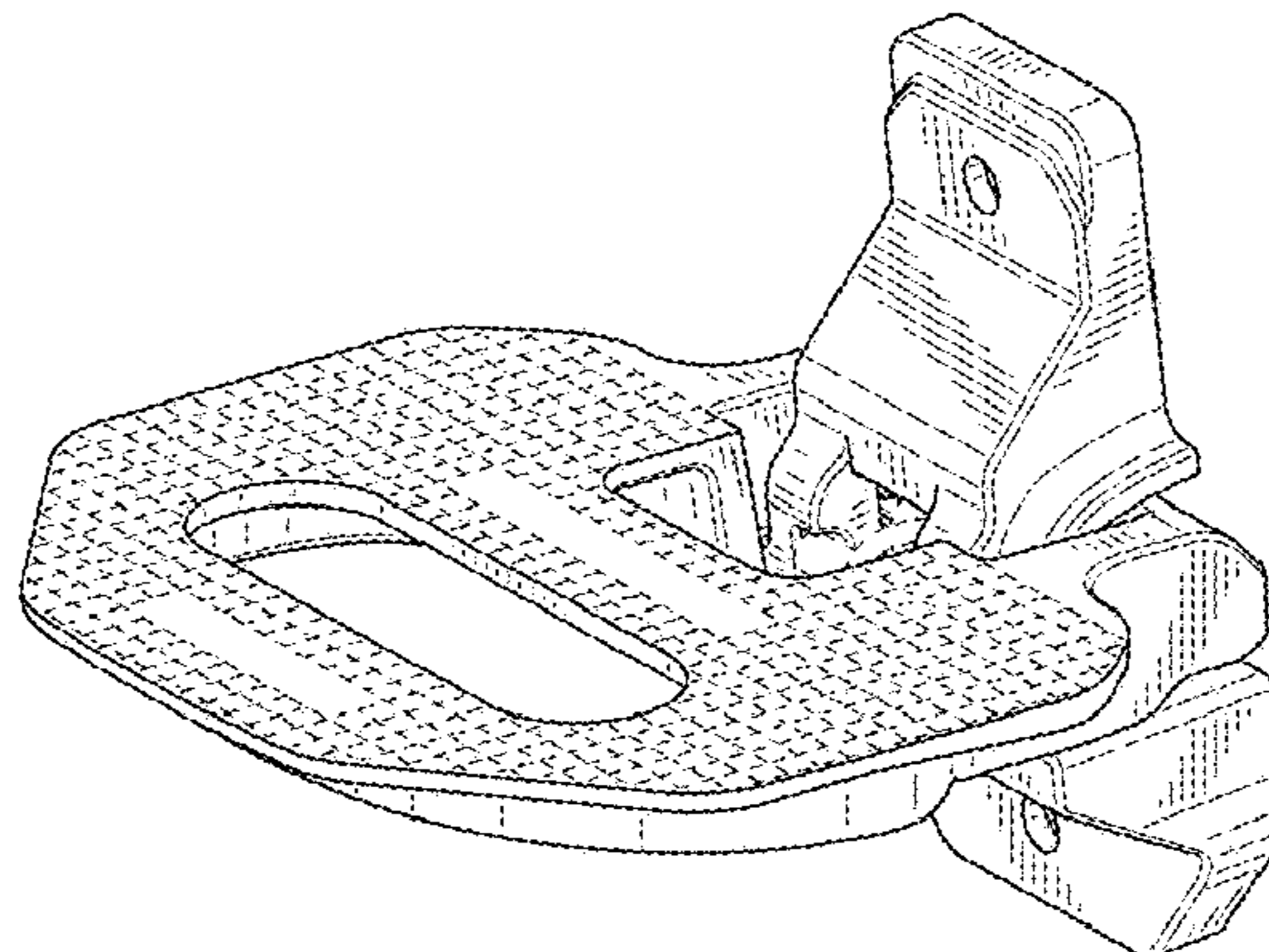
FIG. 1 is top right perspective view of the folding step of my new design with a step portion folded down.
FIG. 2 is a back right perspective view of the folding step of FIG. 1.
FIG. 3 is right side view of the folding step of FIG. 1, with the left side view being a mirror image of FIG. 3.
FIG. 4 is front view of the folding step of FIG. 1.
FIG. 5 is a rear view of the folding step of FIG. 1.
FIG. 6 is a top view of the folding step of FIG. 1.
FIG. 7 is a bottom view of the folding step of FIG. 1.
FIG. 8 is top right perspective view of the folding step of my new design of FIG. 1, but with the step portion folded.
FIG. 9 is a right side view of the folding step of FIG. 5, with the left side view being a mirror image of FIG. 3.
FIG. 10 is front side view of the folding step of FIG. 5
FIG. 11 is rear view of the folding step of FIG. 5.
FIG. 12 is a top view of the folding step of FIG. 5; and,
FIG. 13 is a bottom view of the folding step of FIG. 5.

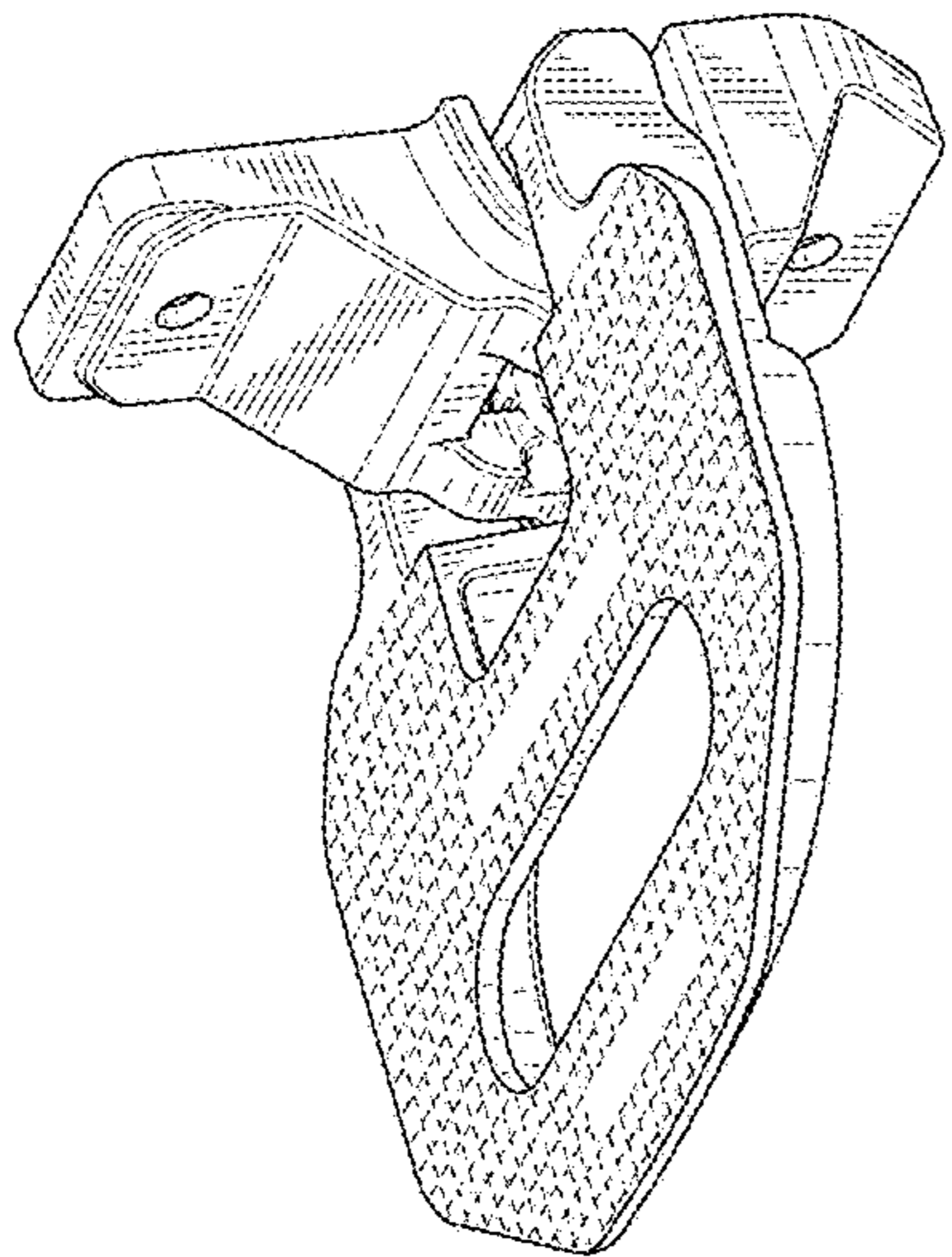

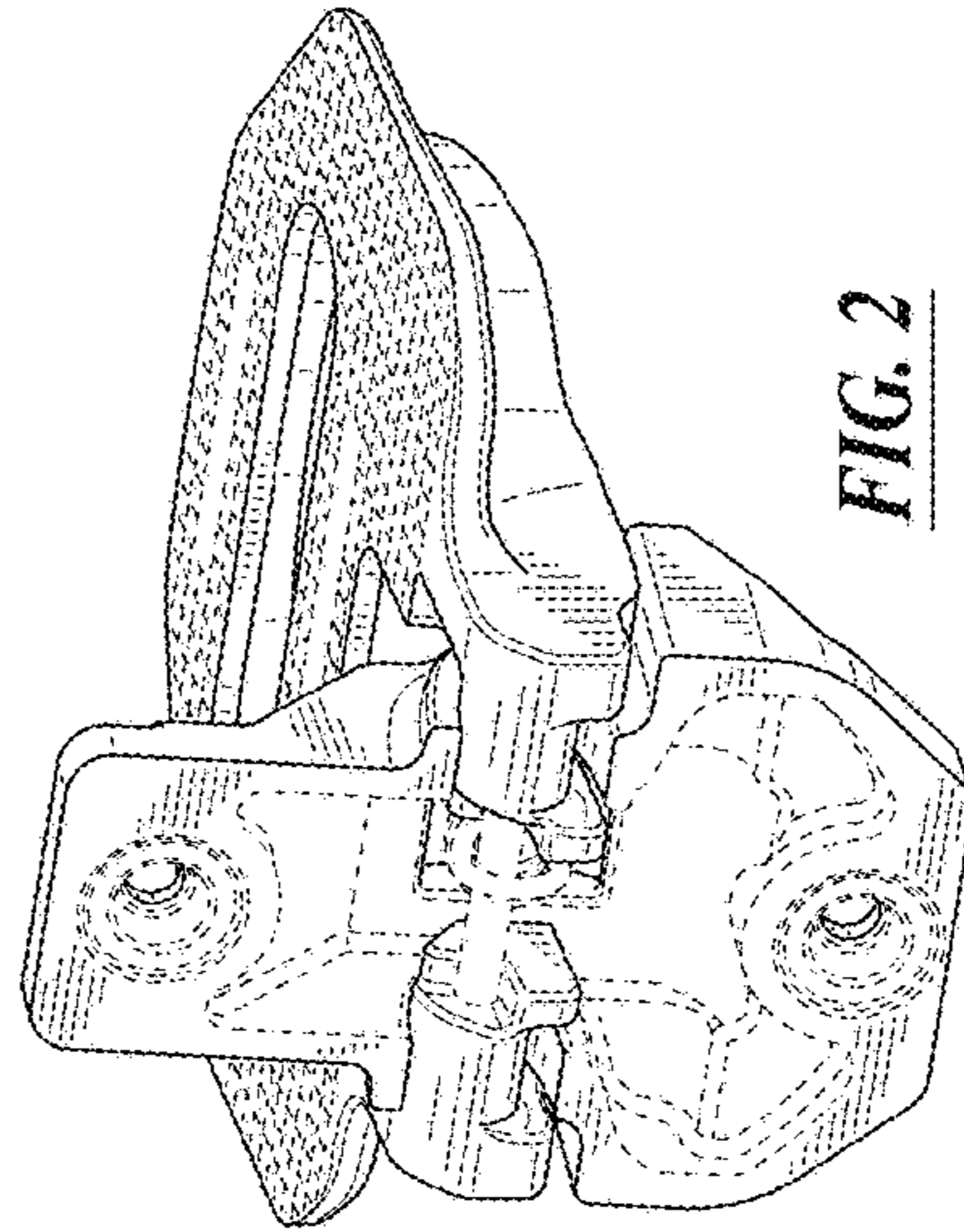

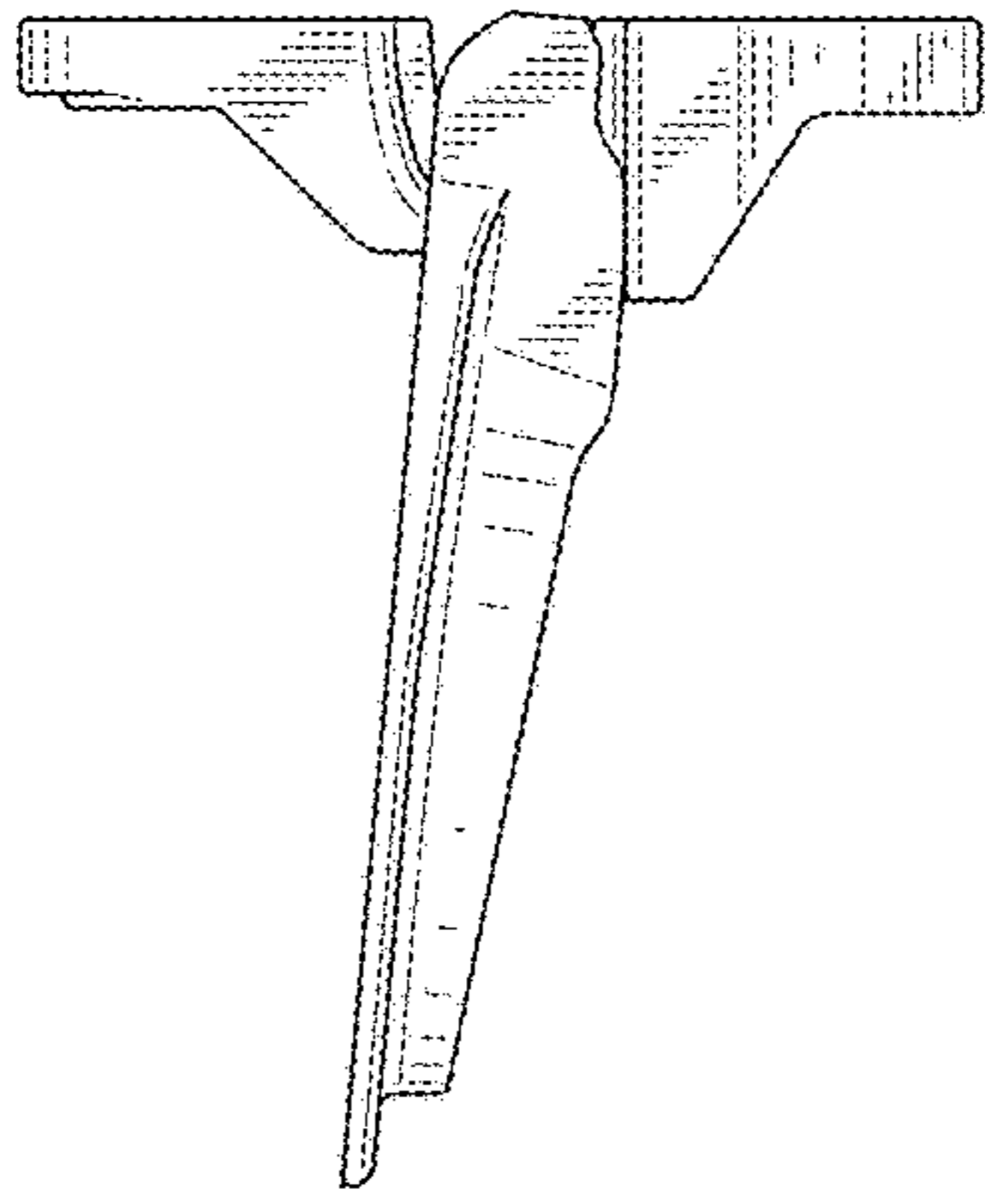

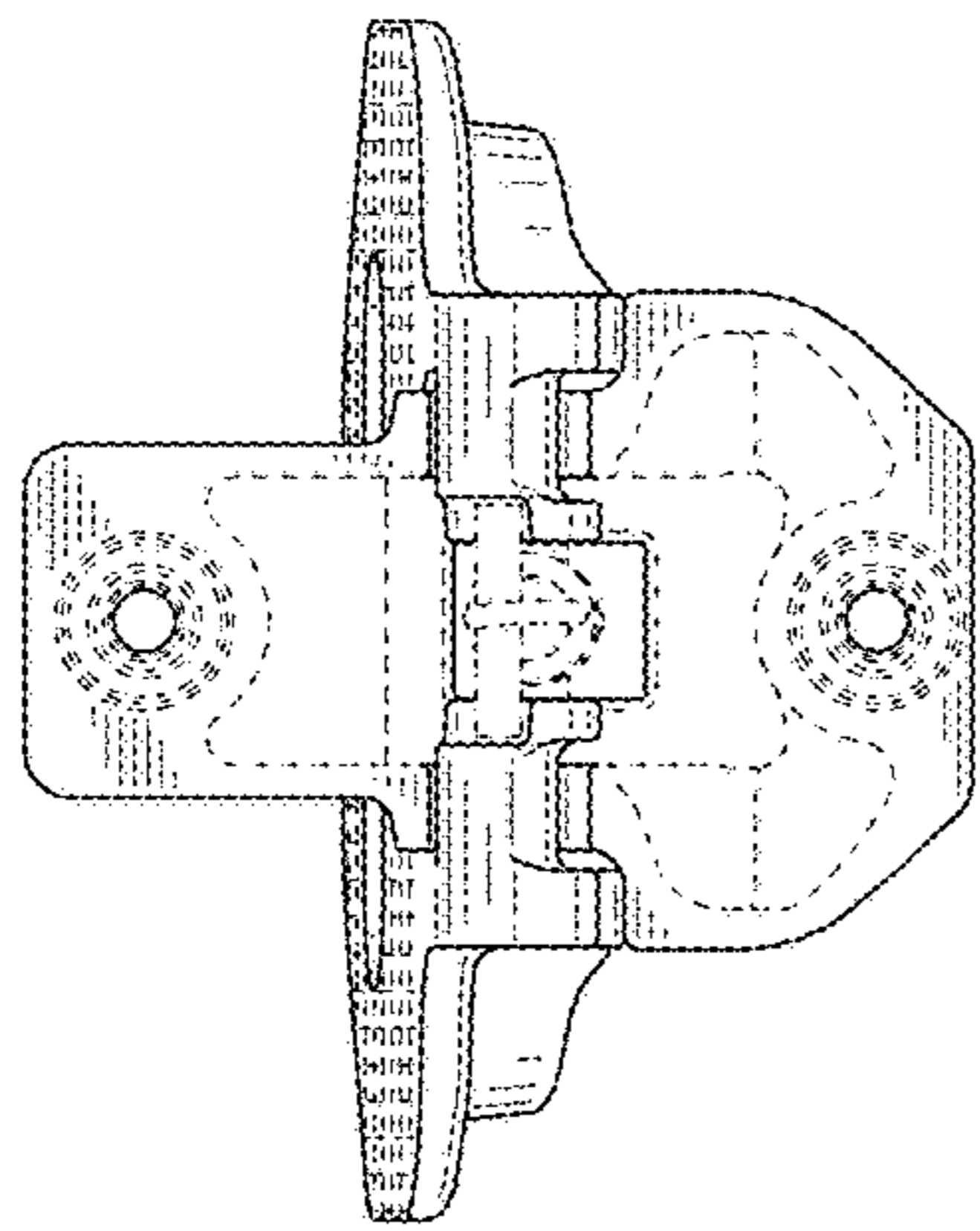

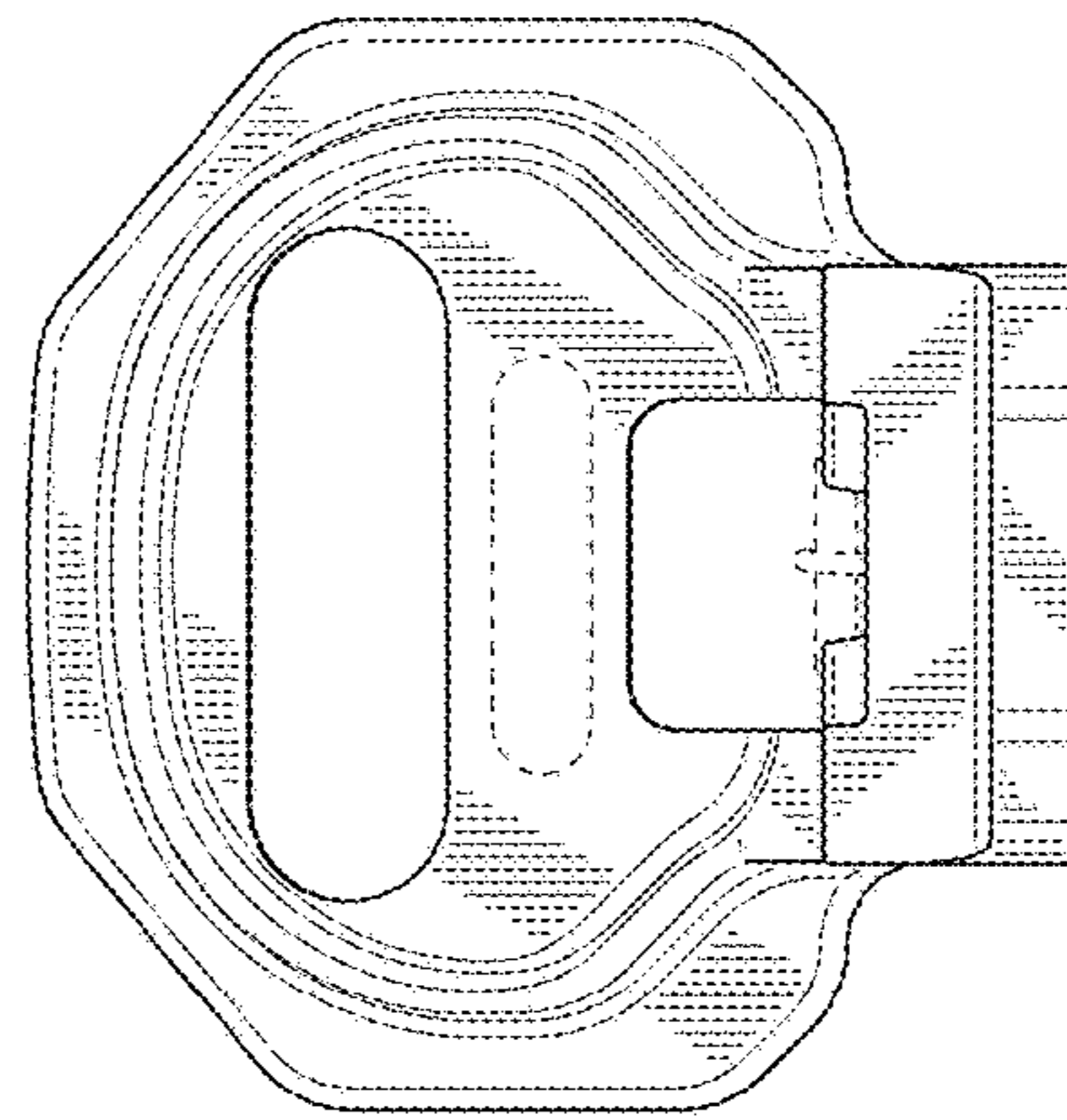

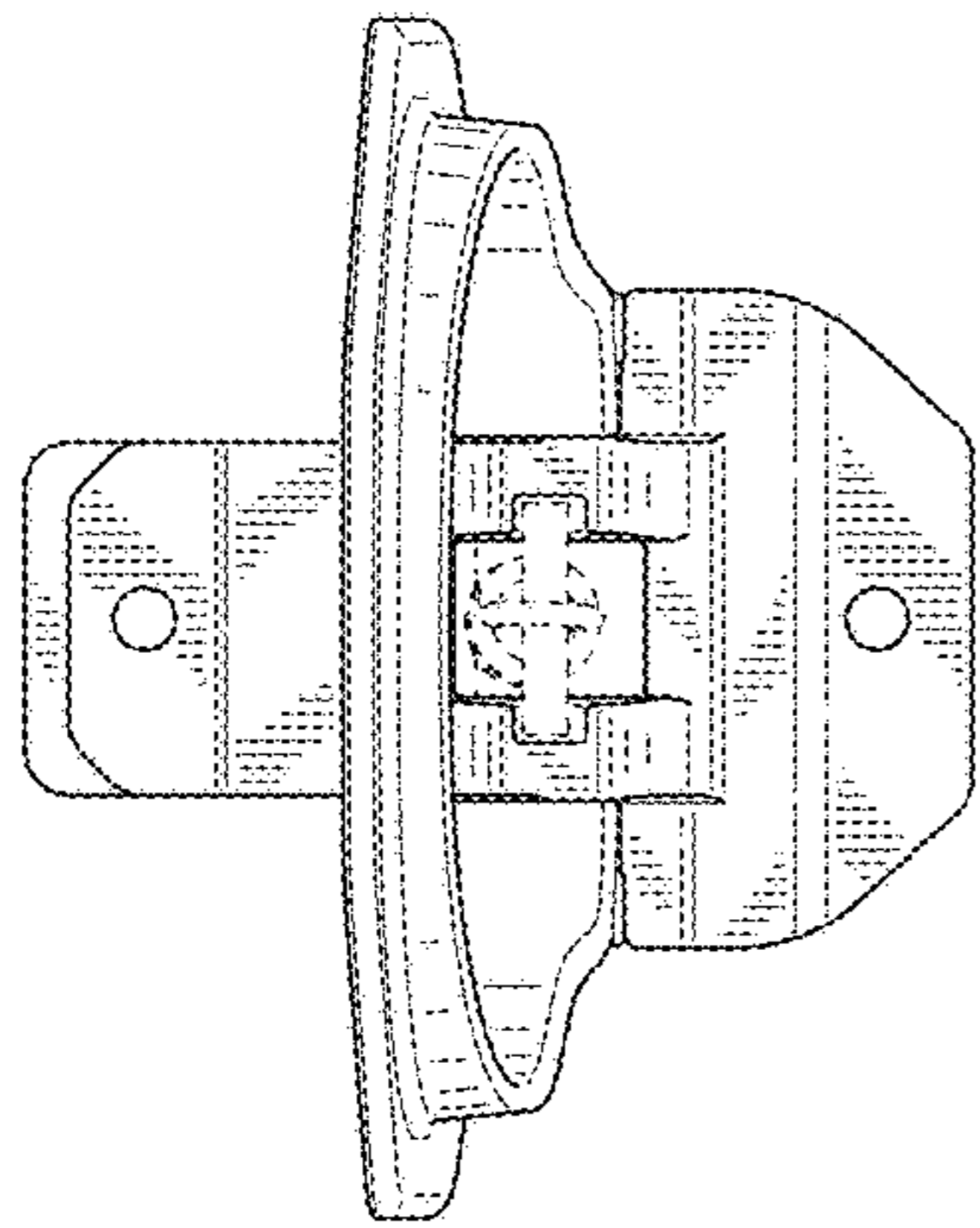

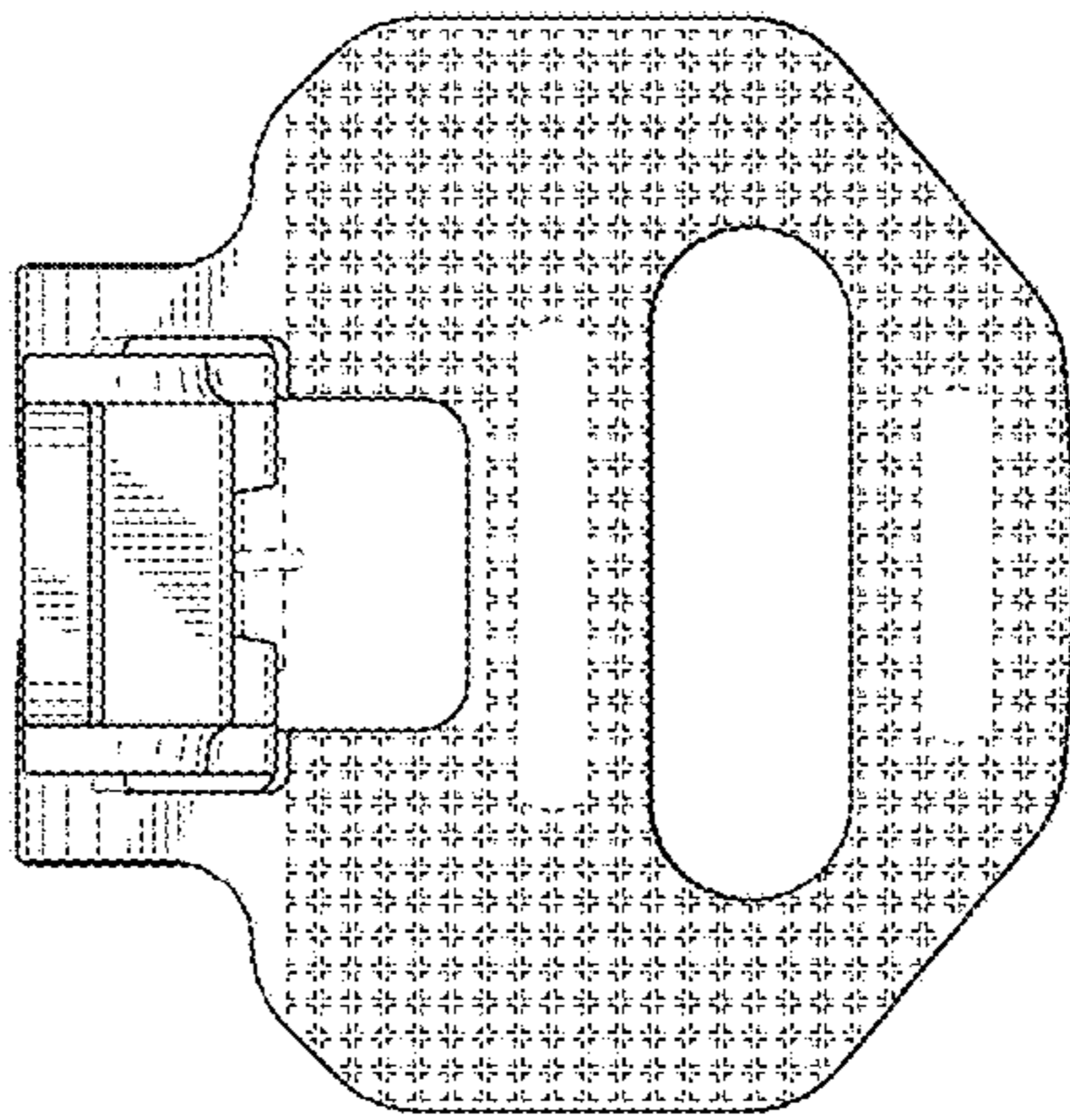

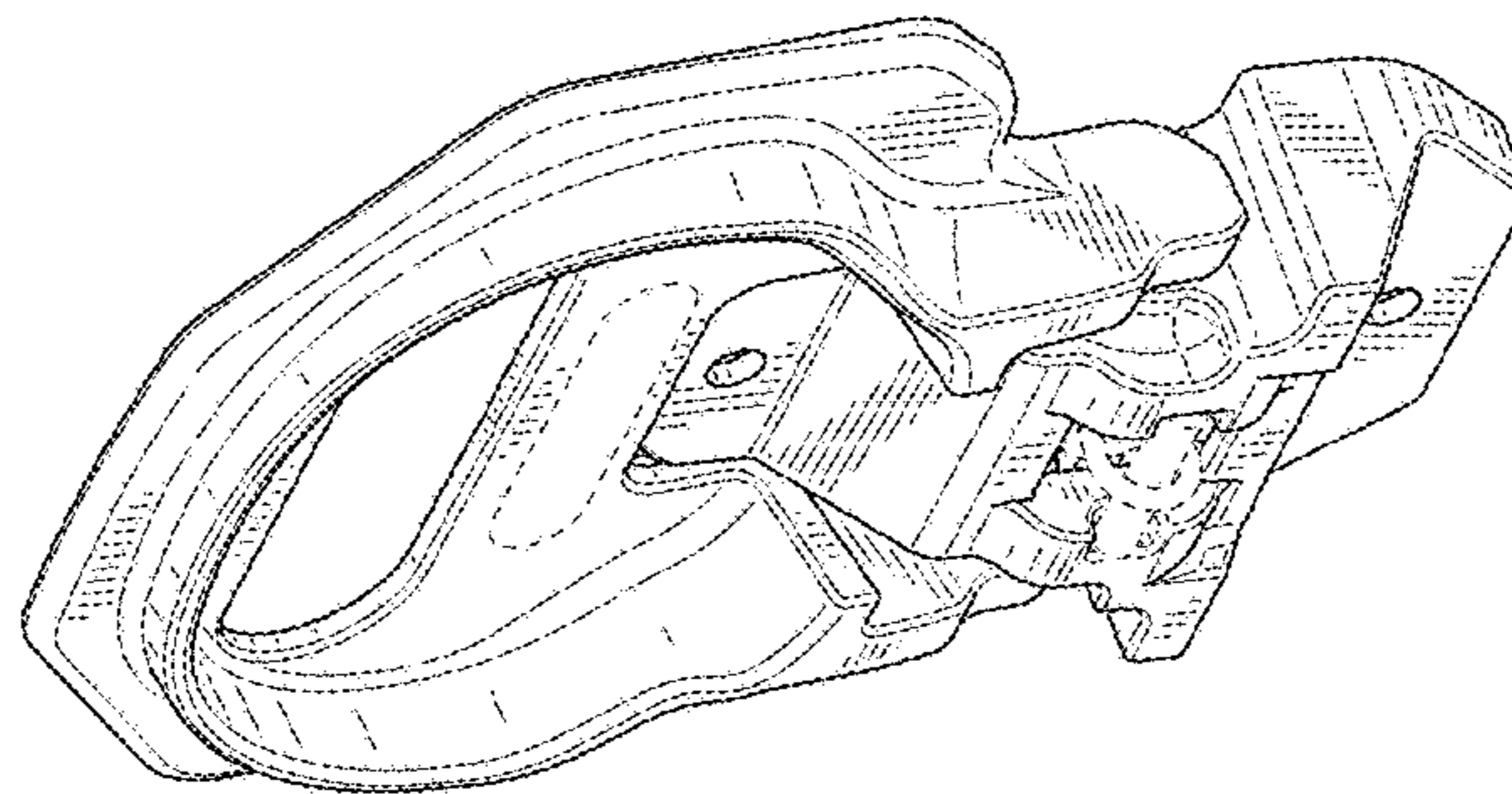

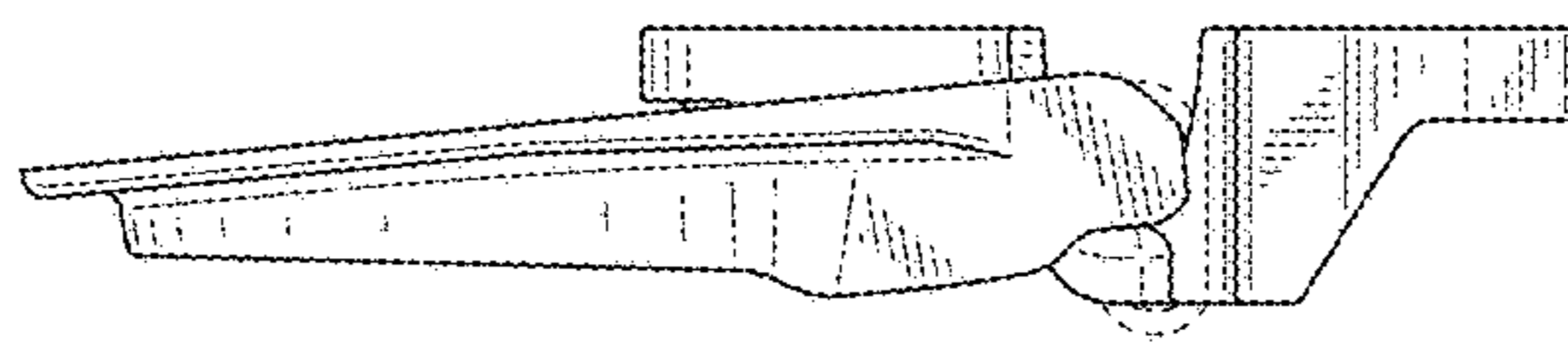

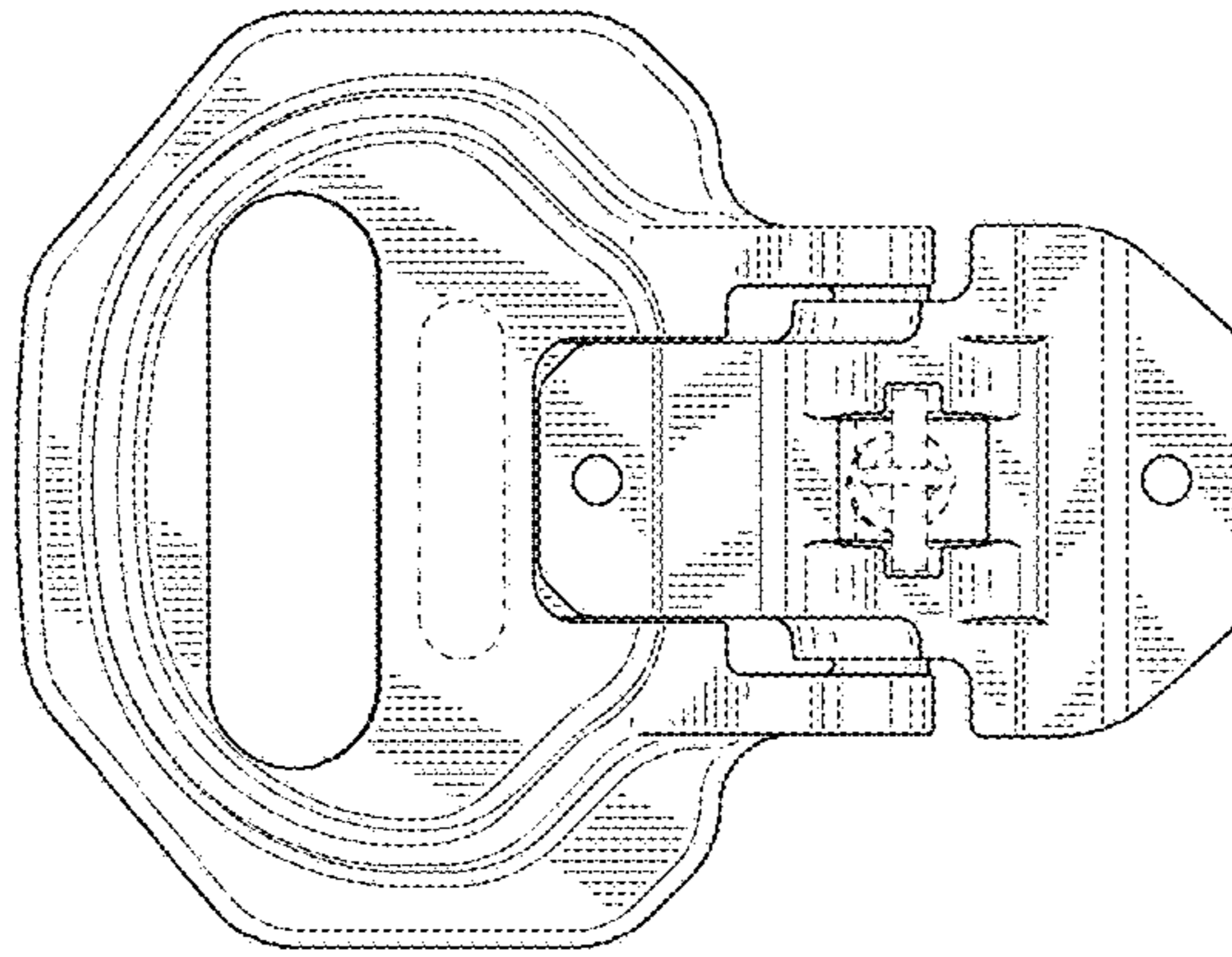

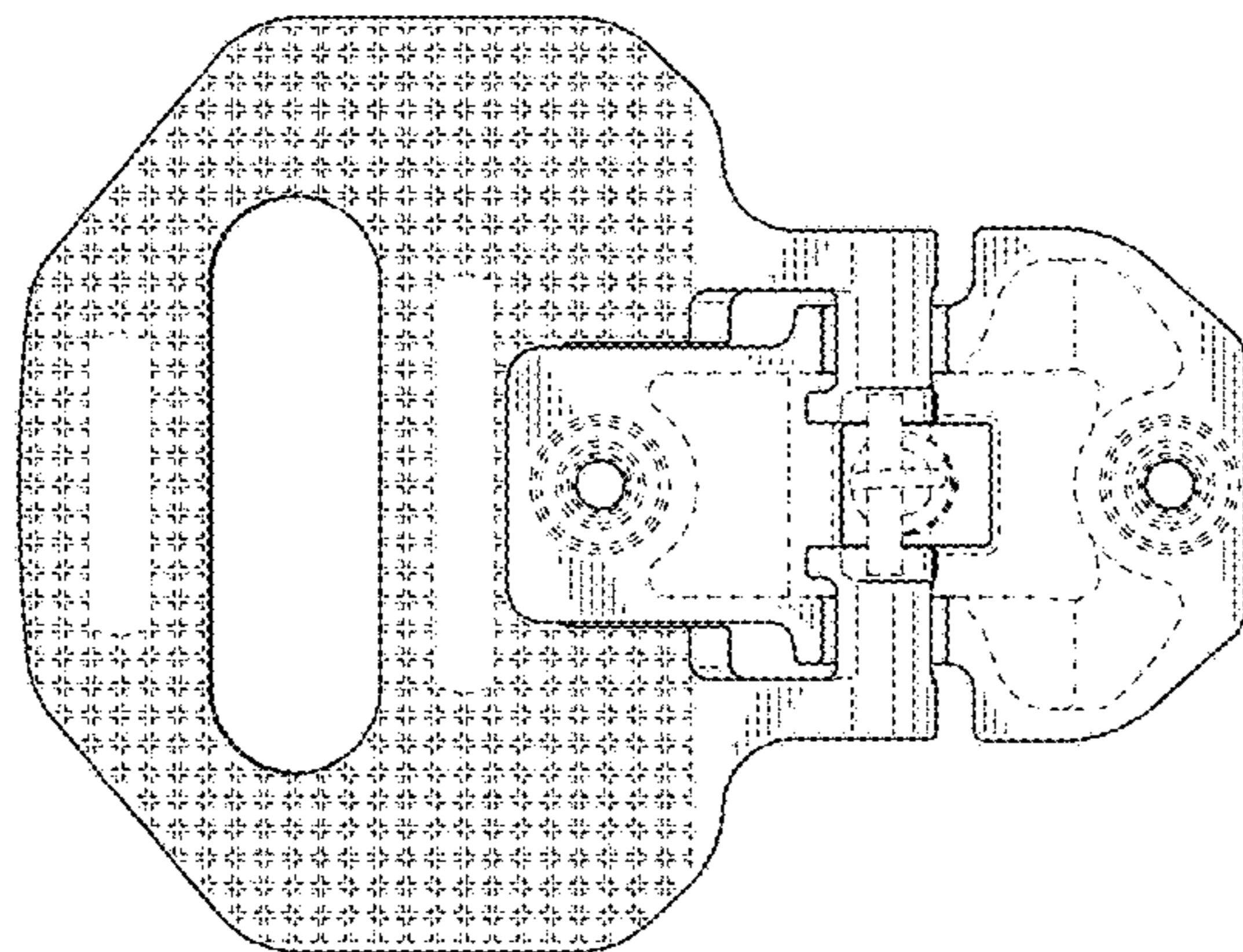

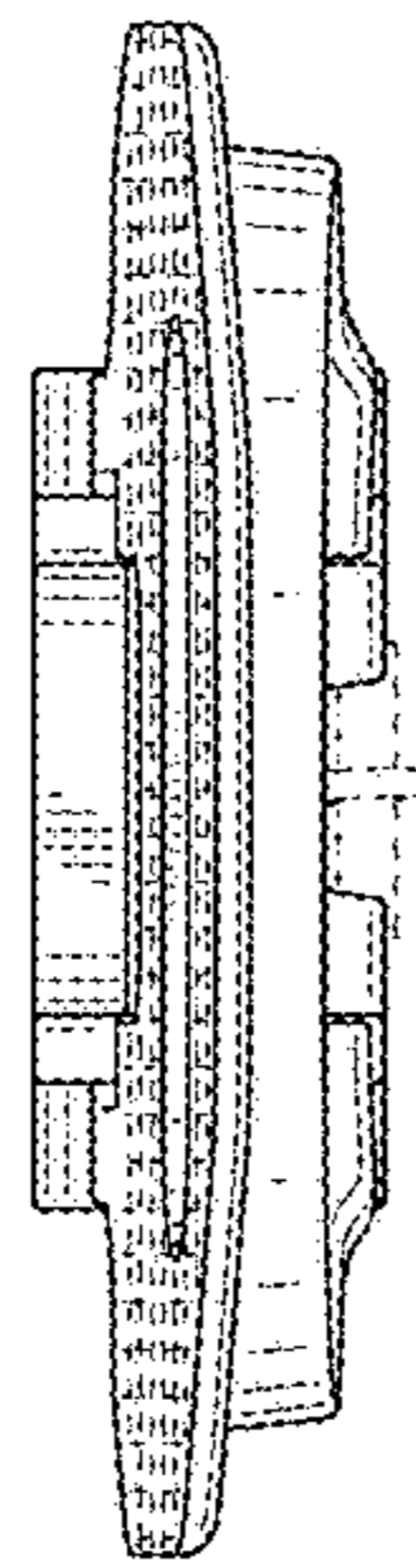

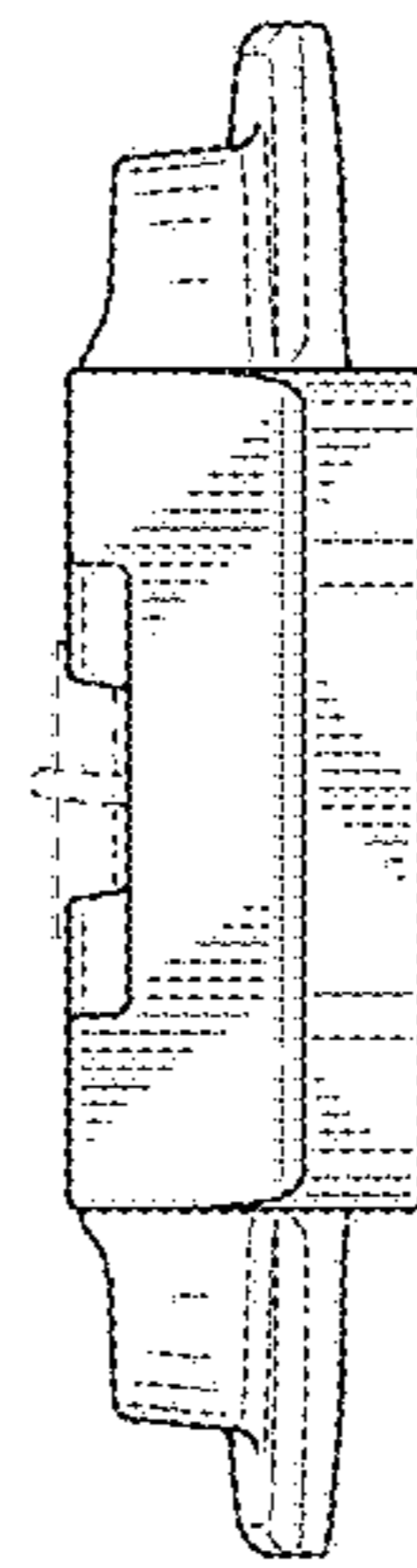
