FIG. 2 is a front elevation view thereof;

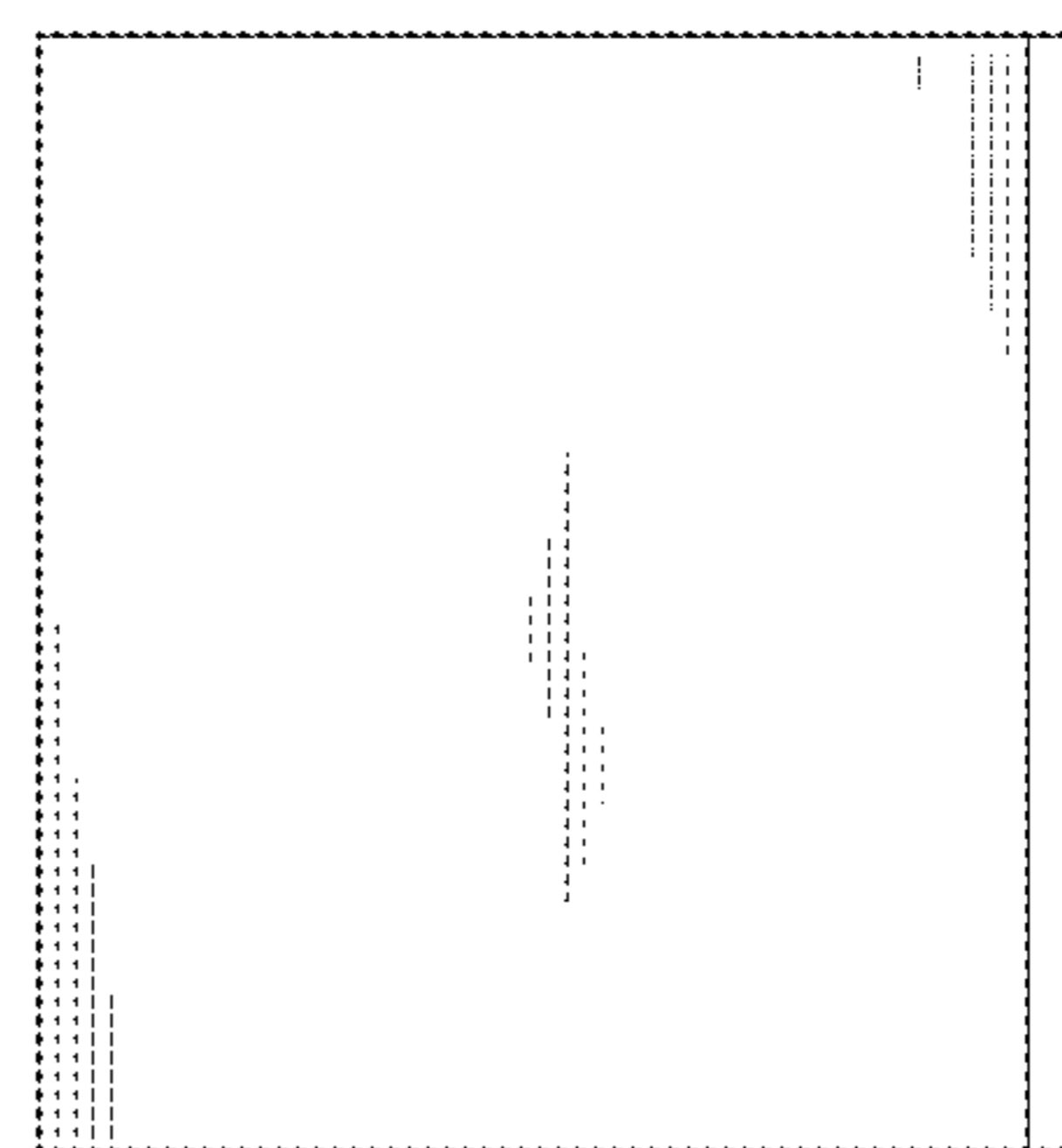
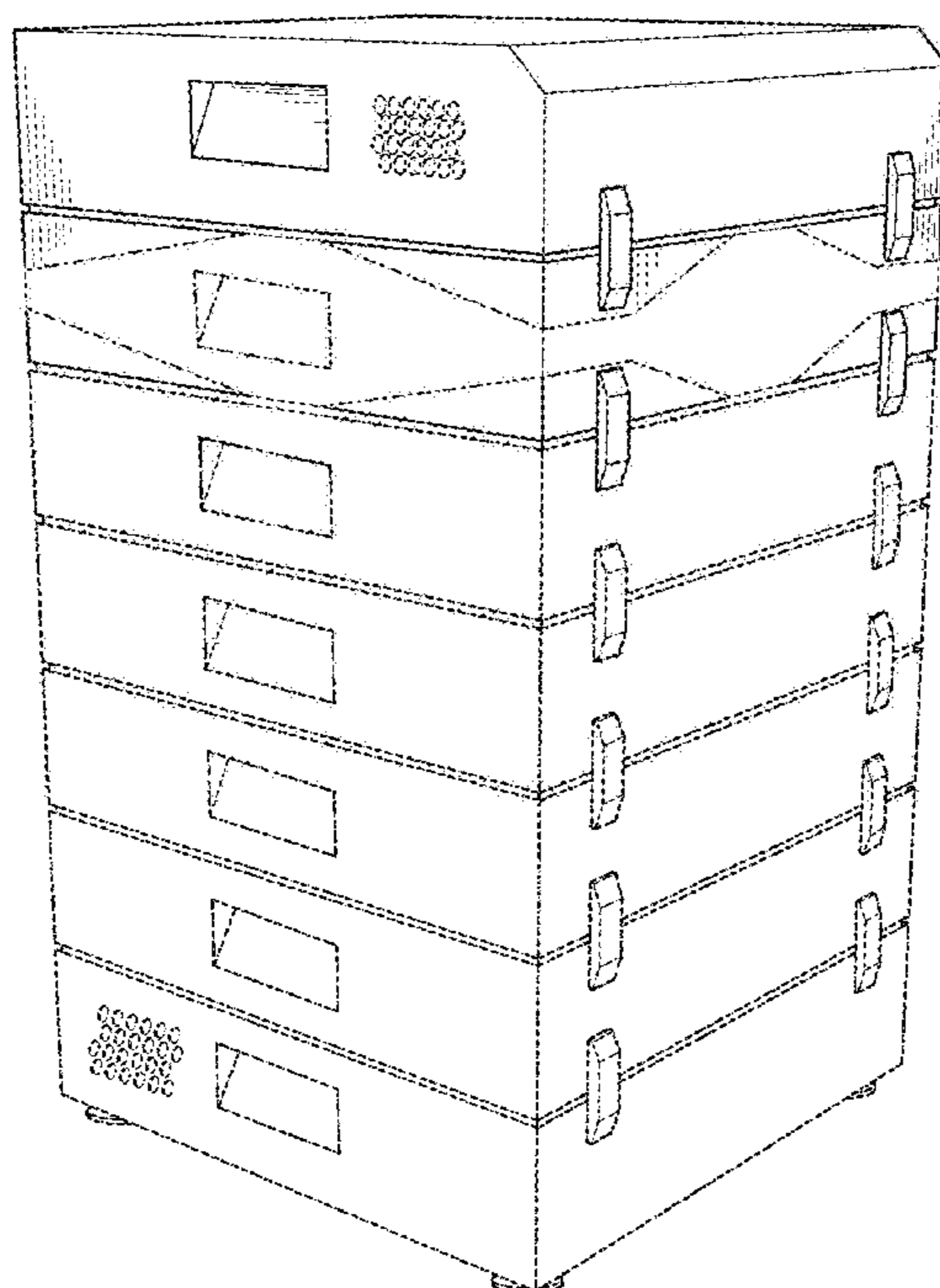
FIG. 3 is a back elevation view thereof;

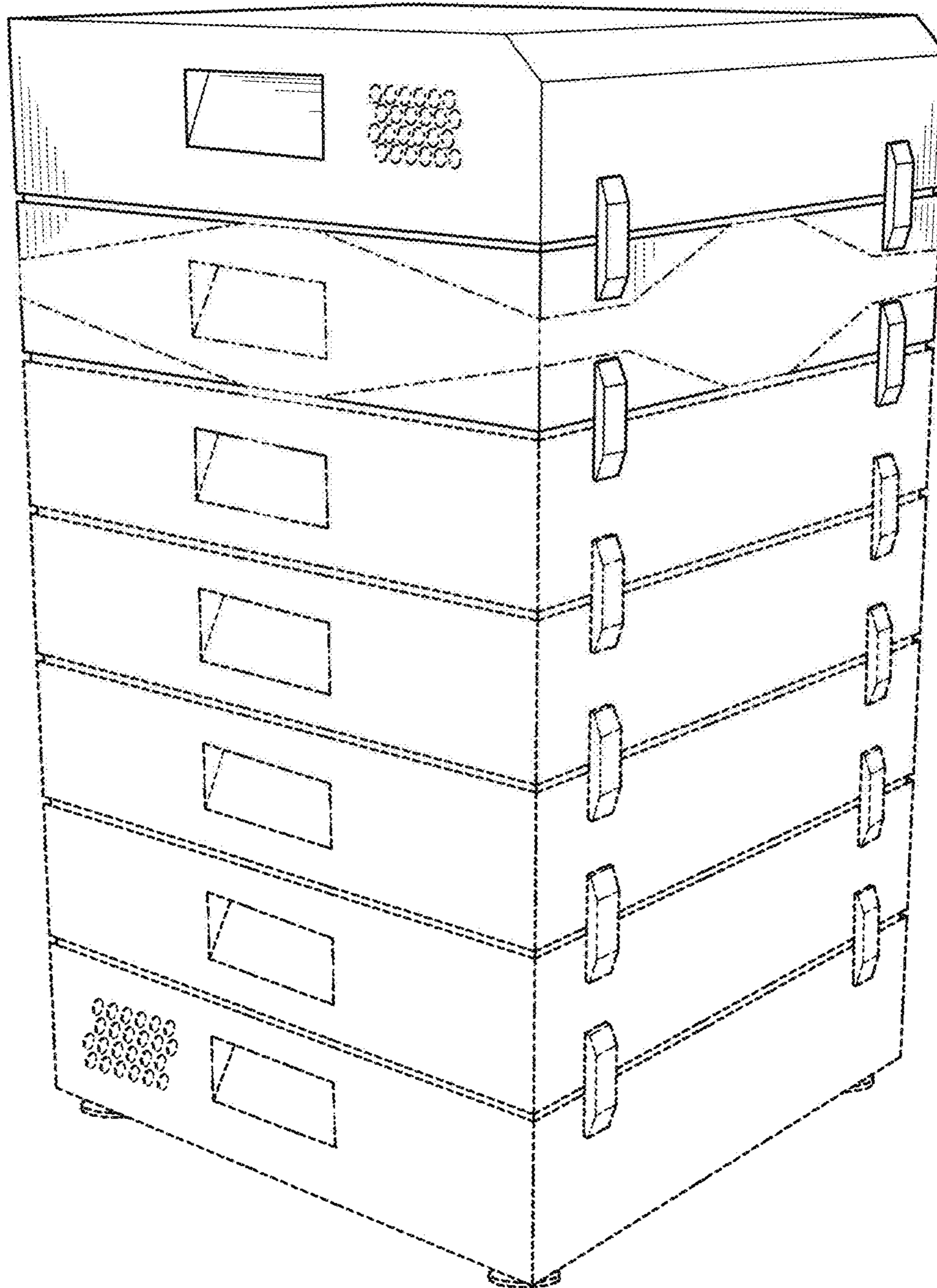
FIG. 4 is a top view thereof; and,

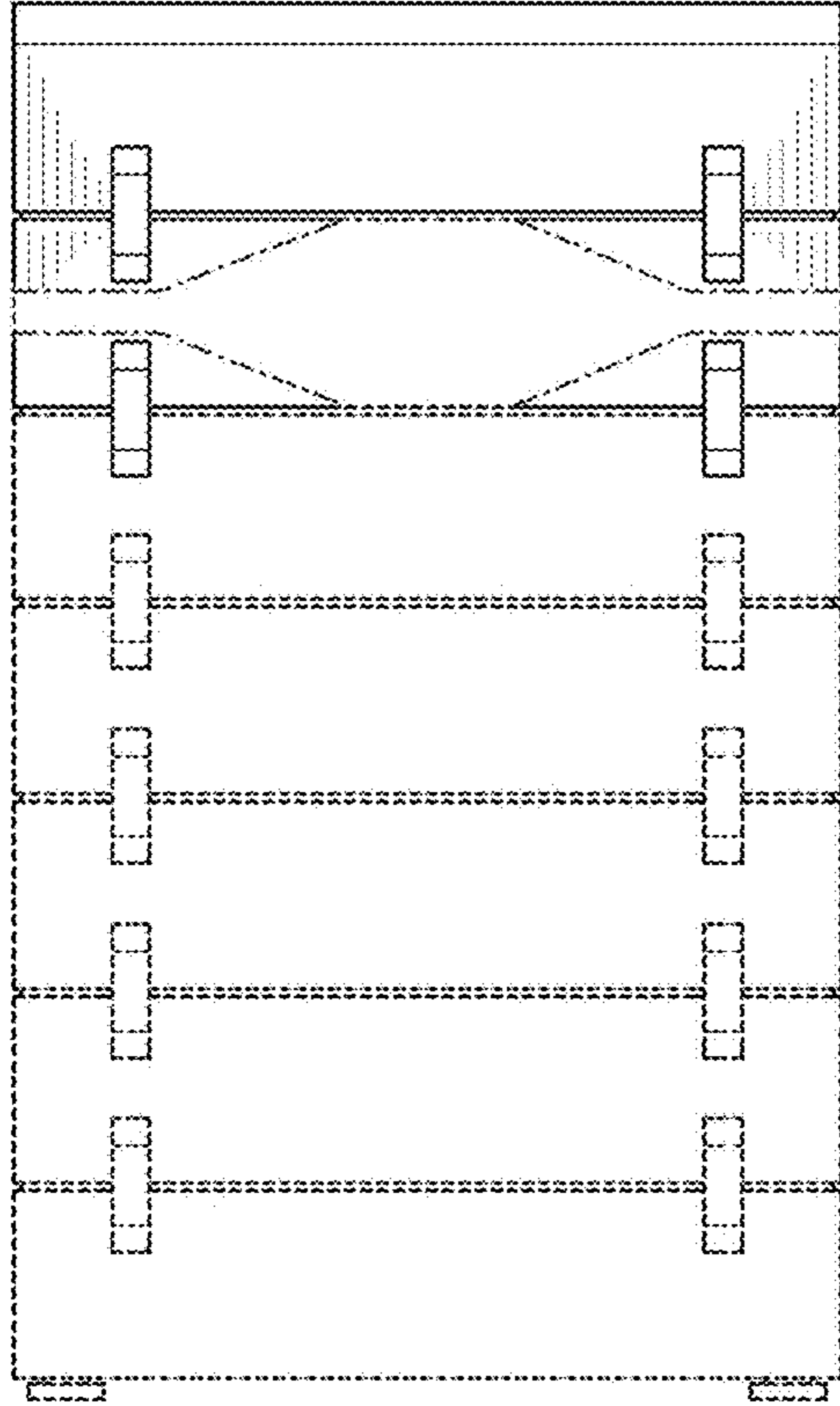

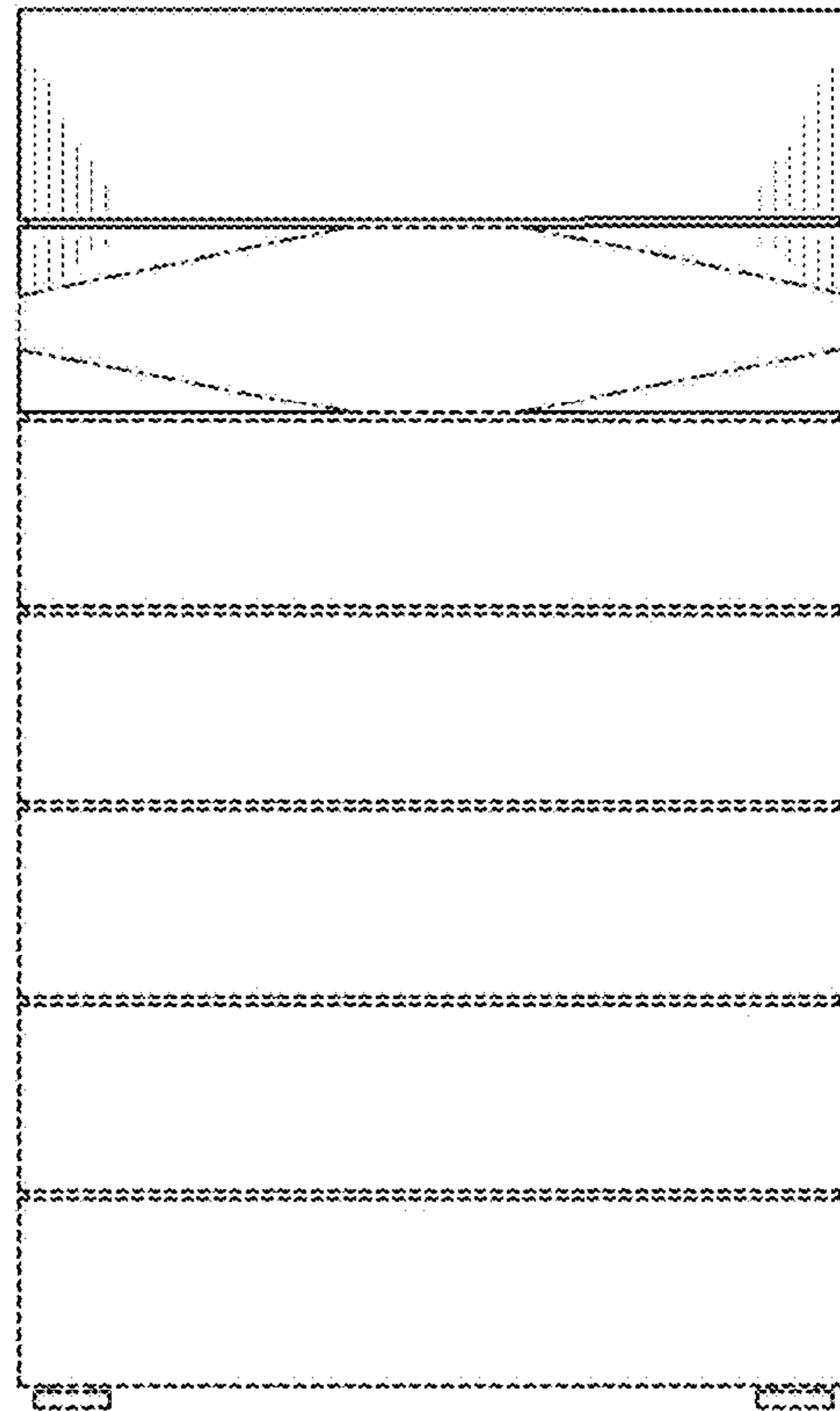

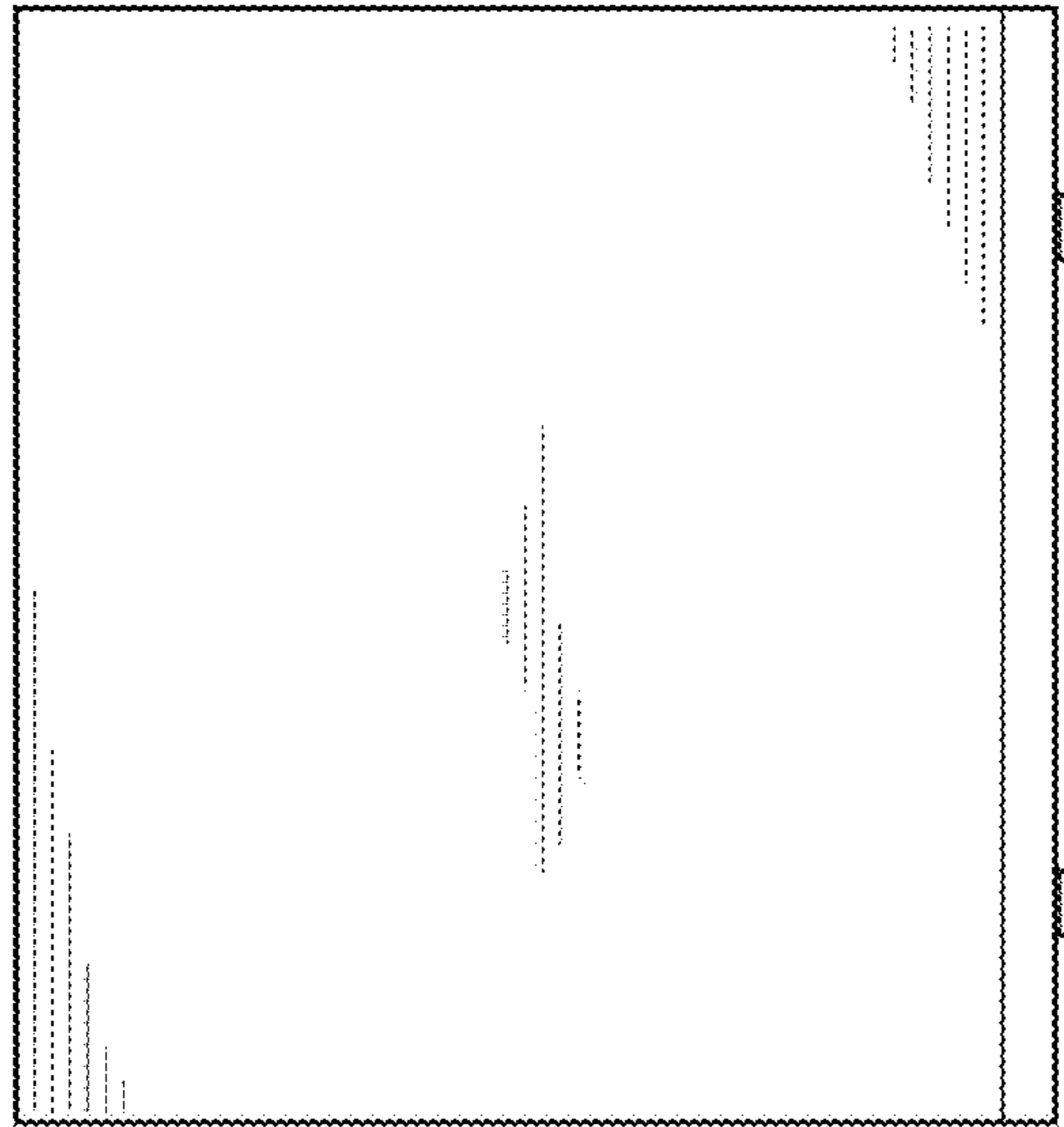

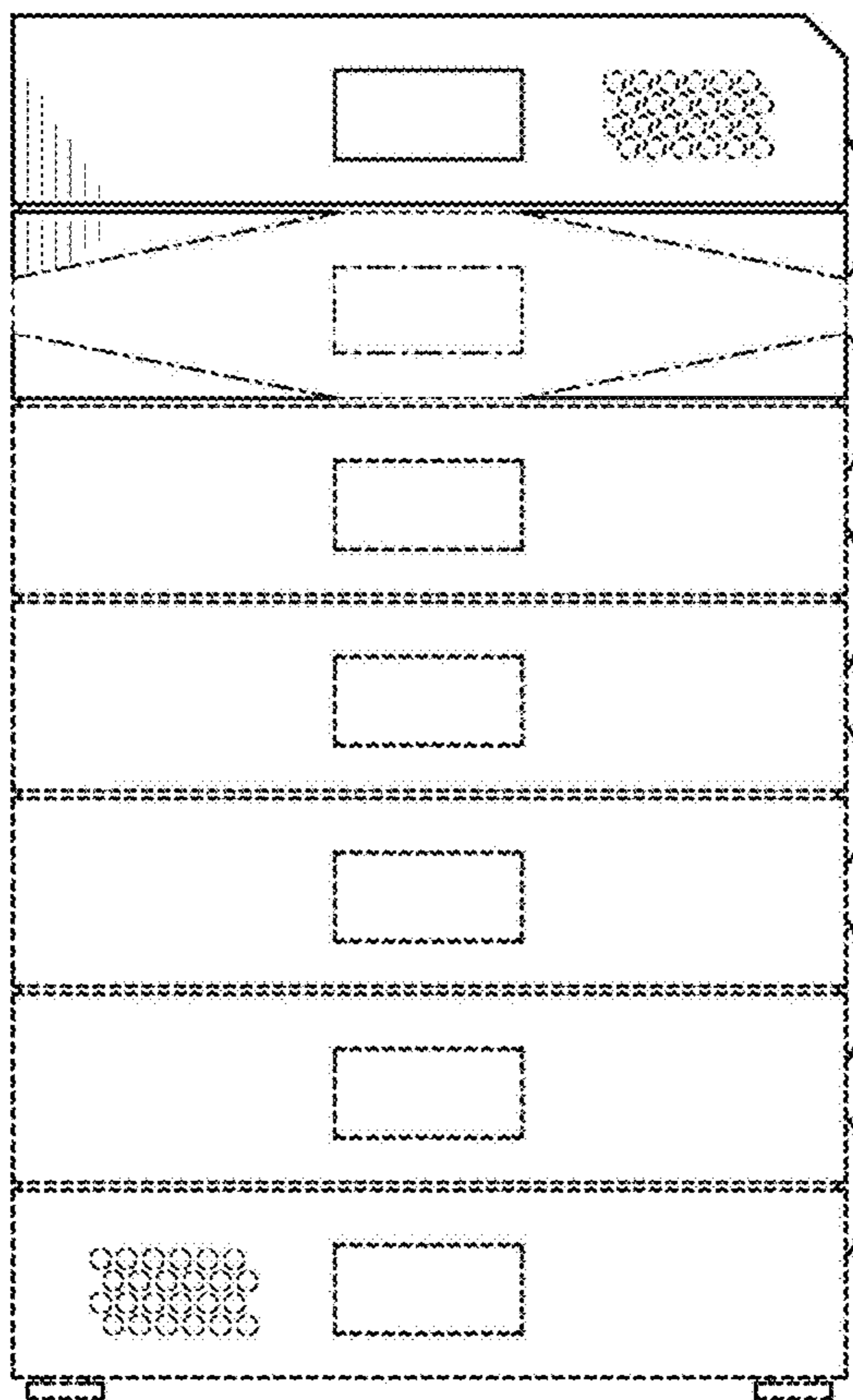
