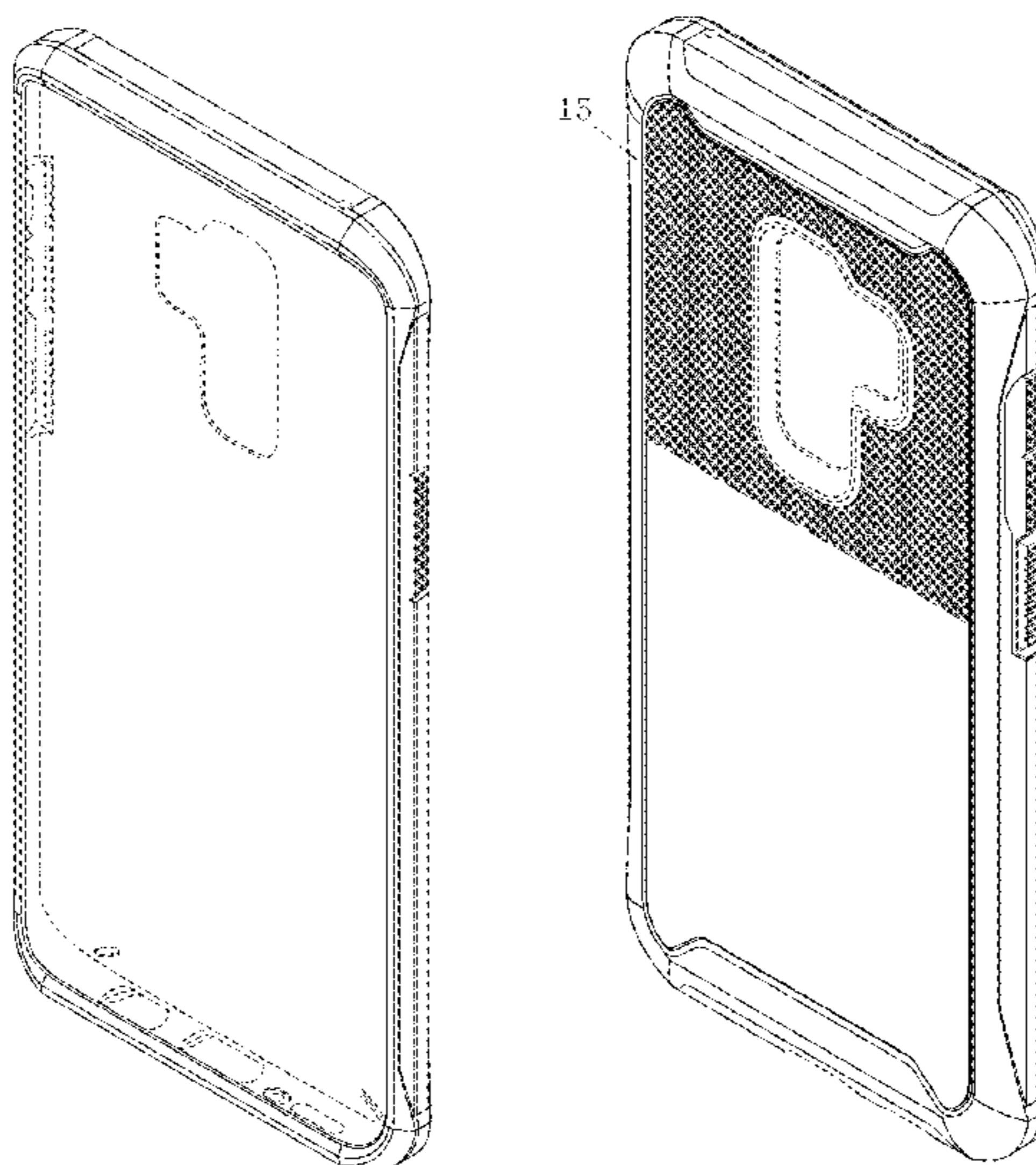
(57) **CLAIM**

The ornamental design for a case for electronic devices, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a case for electronic devices showing my new design;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is an enlarged top plan view thereof;
FIG. 8 is an enlarged bottom plan view thereof;
FIG. 9 is a front perspective view of the inner shell of the case, shown isolated from the case for clarity of illustration;
FIG. 10 is a rear perspective view of the inner shell of the case, shown isolated from the case for clarity of illustration;
FIG. 11 is a front perspective view of the outer frame of the case, shown isolated from the case for clarity of illustration;
FIG. 12 is a rear perspective view of the outer frame of the case, shown isolated from the case for clarity of illustration;
FIG. 13 is a front exploded perspective view of the case for electronic devices;
FIG. 14 is a rear exploded perspective view of the case for electronic devices; and,
FIG. 15 is a partial enlarged view, taken from FIG. 2.
Although the case for electronic devices in which the claimed design is embodied, consists of an inner shell and an outer frame, the claim is directed to the ornamental appearance of the case for electronic devices in its entirety and does not extend to each of the individual components in isolation. The dot-dash broken line circle in FIGS. 2 and 15 delineates a portion of the case that is part of the claimed design and that is shown on an enlarged scale in FIG. 15. The dashed broken lines, and unshaded regions bounded by broken lines, depict portions of the case for electronic devices that form no part of the claimed design.

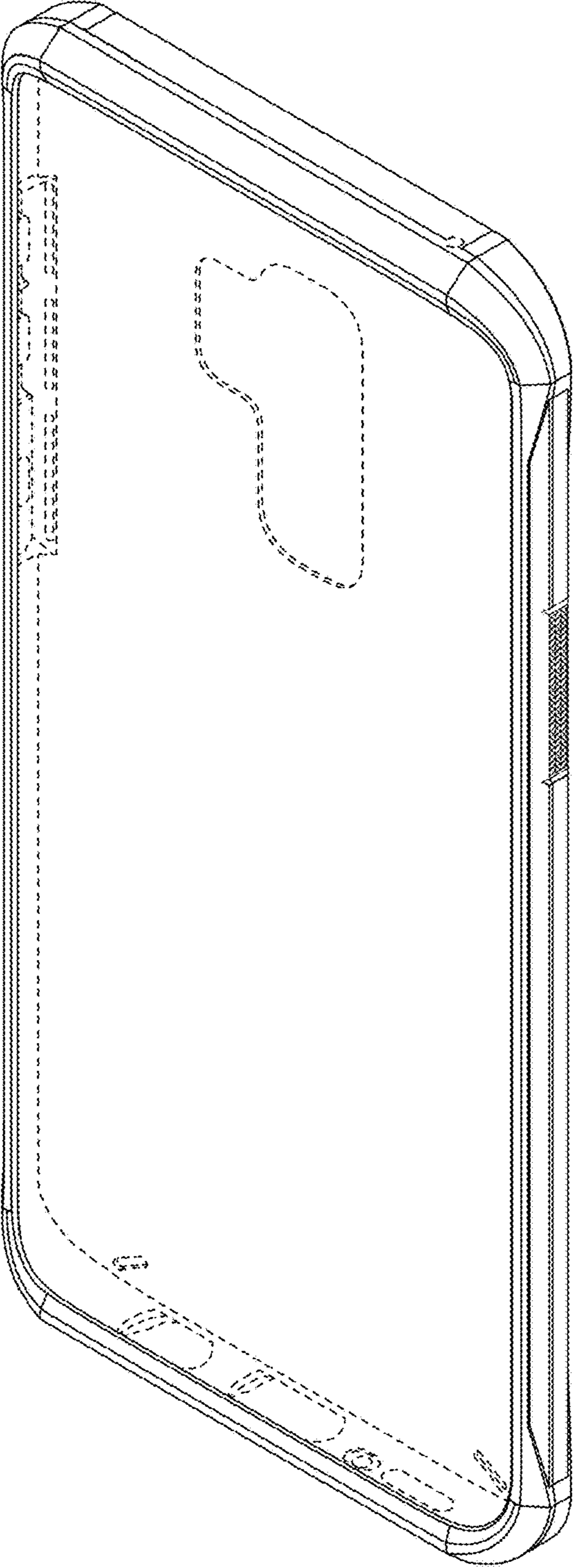

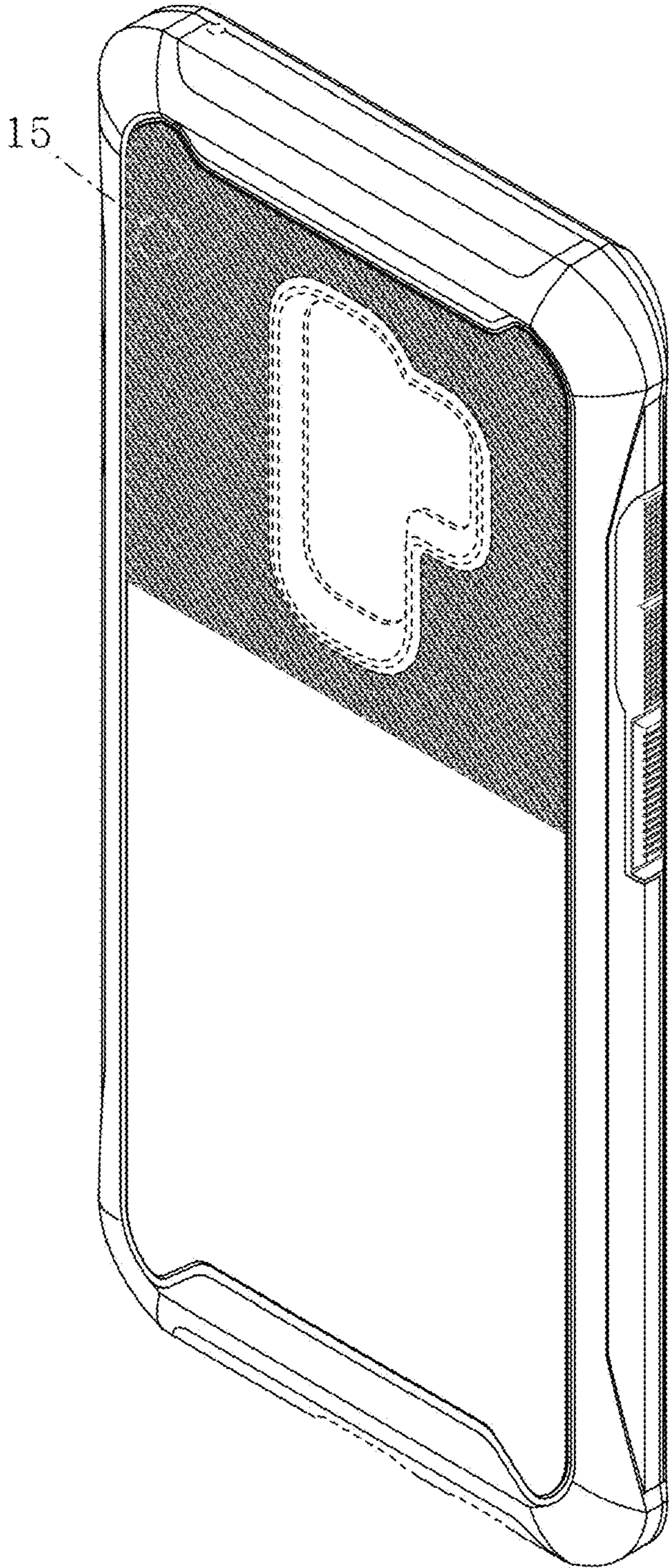

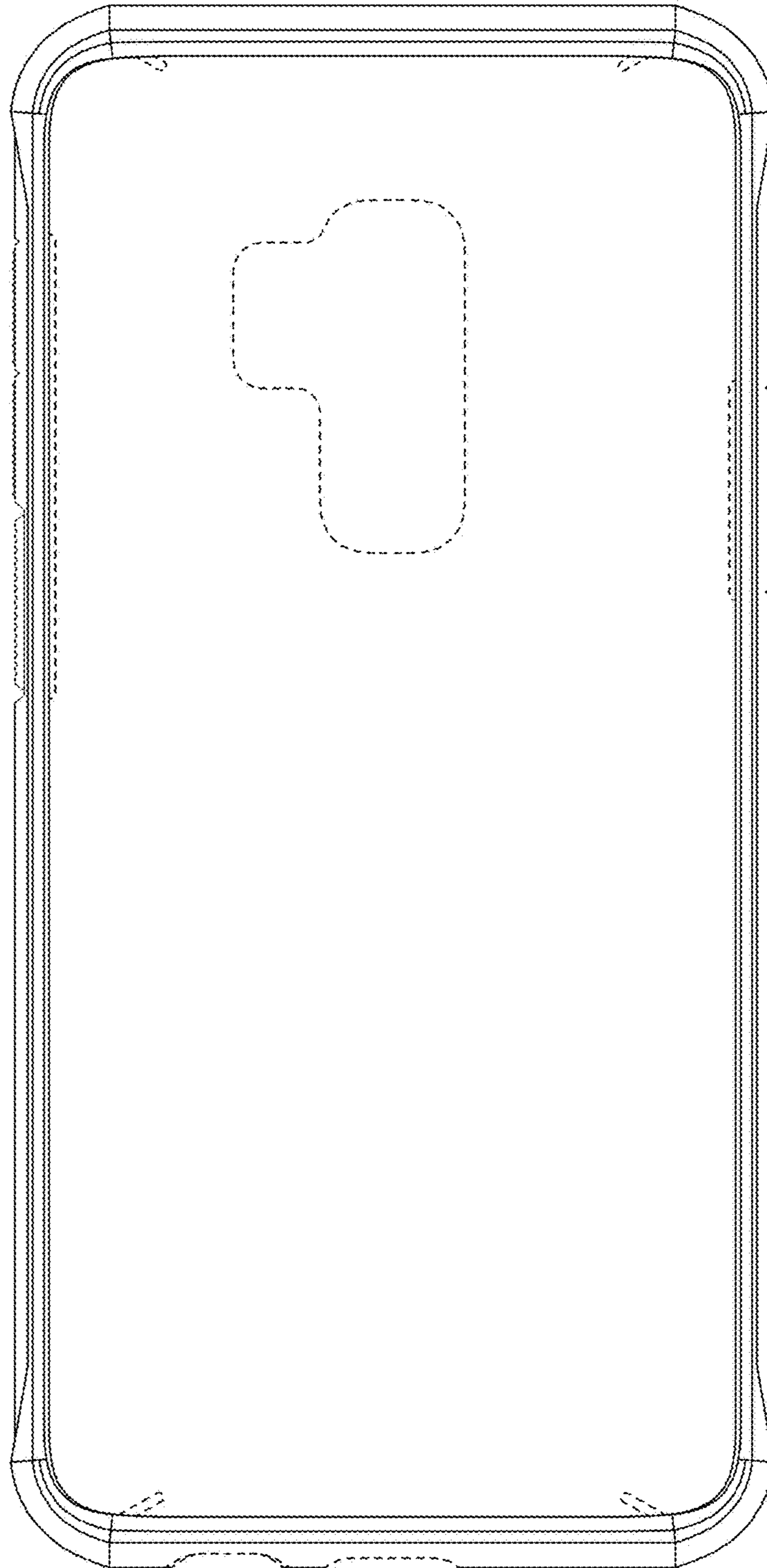

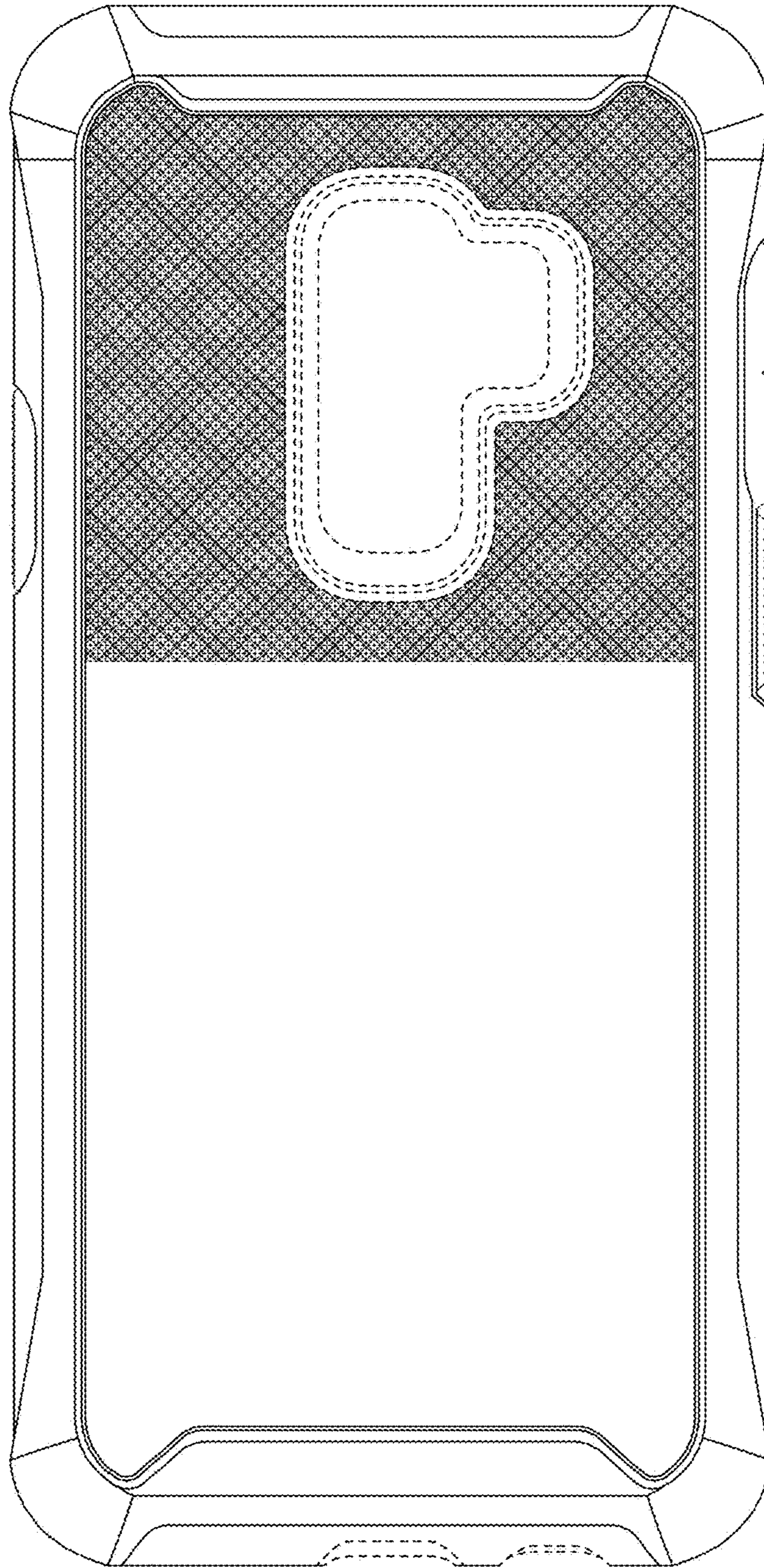

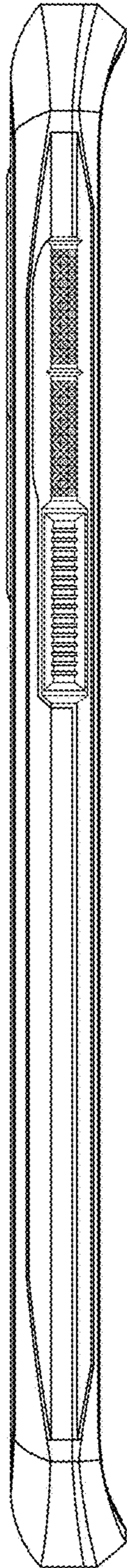

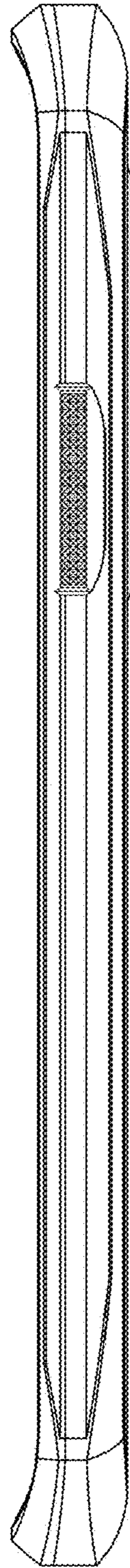

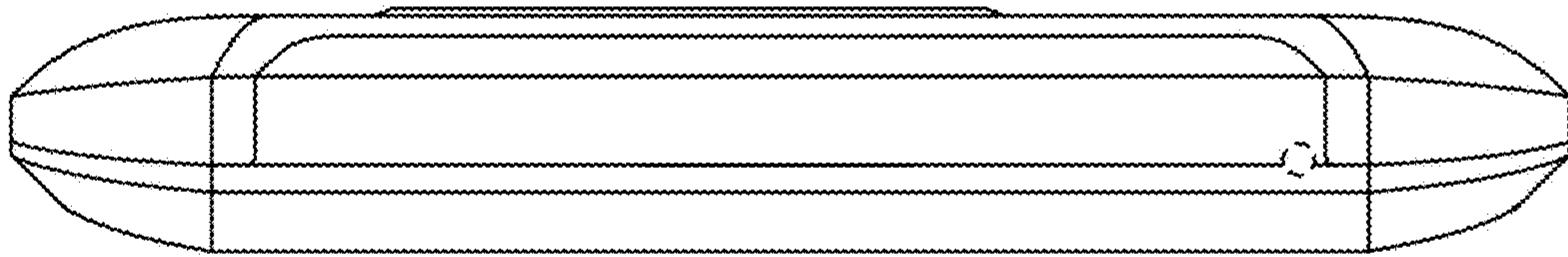

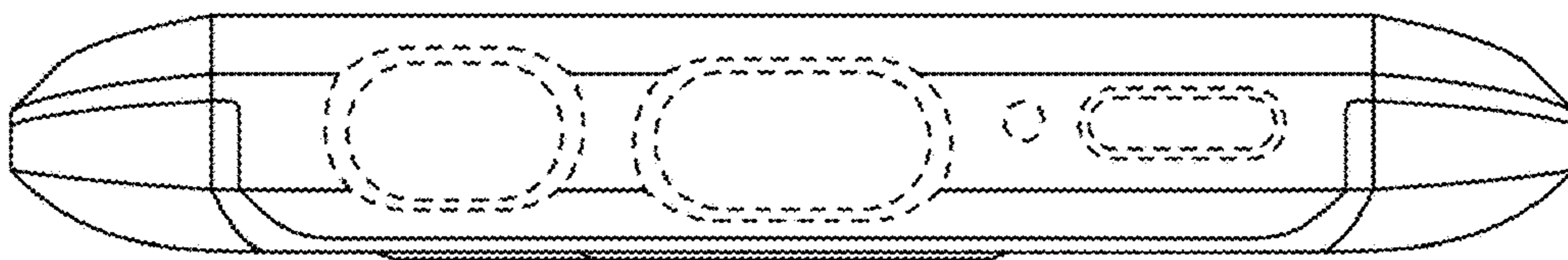

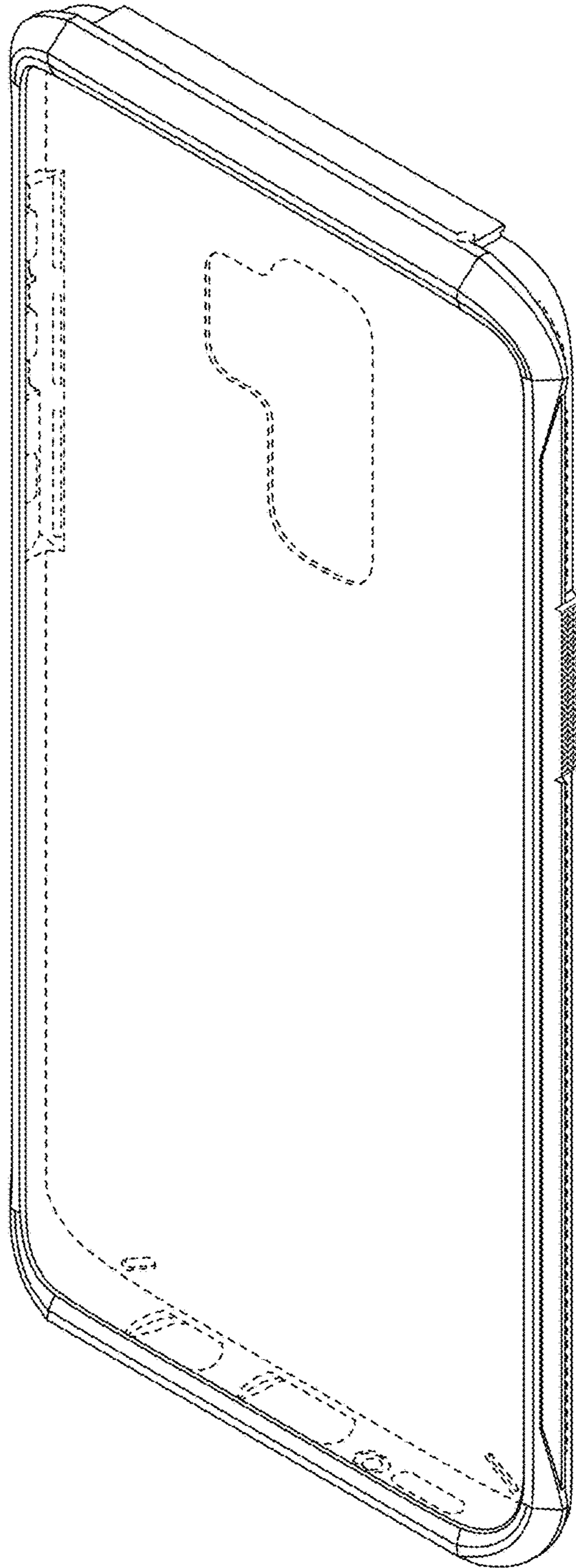

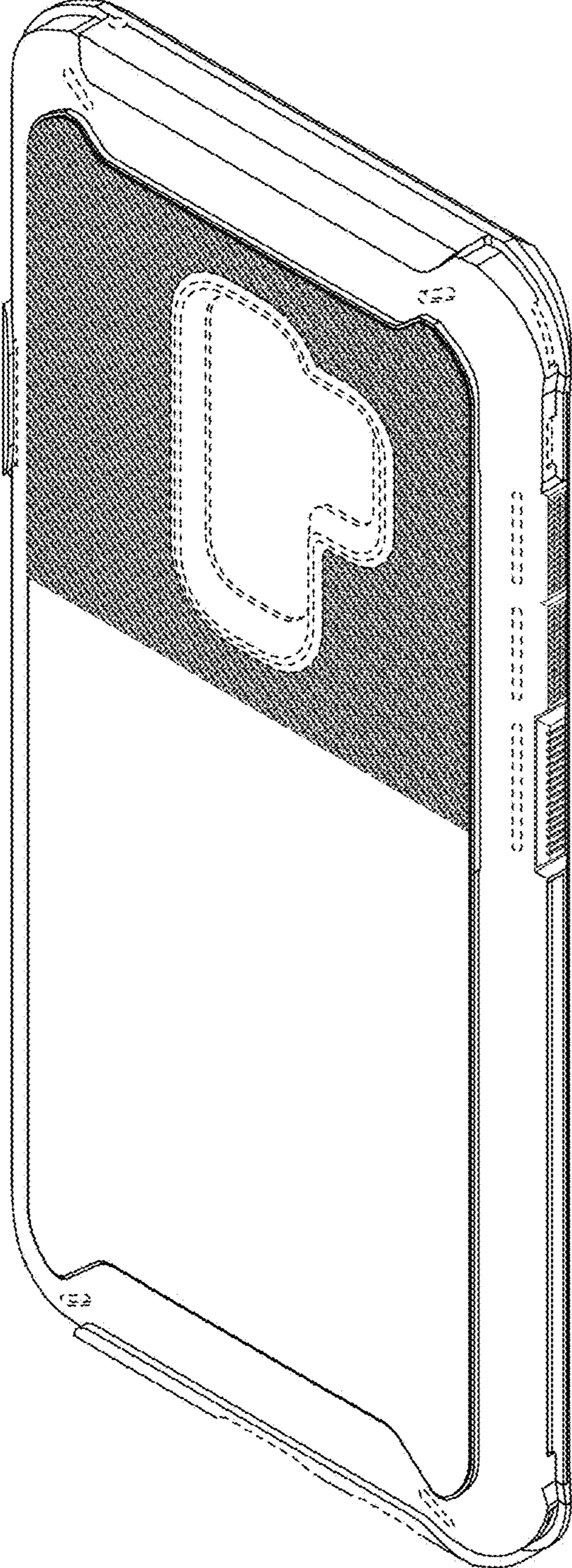

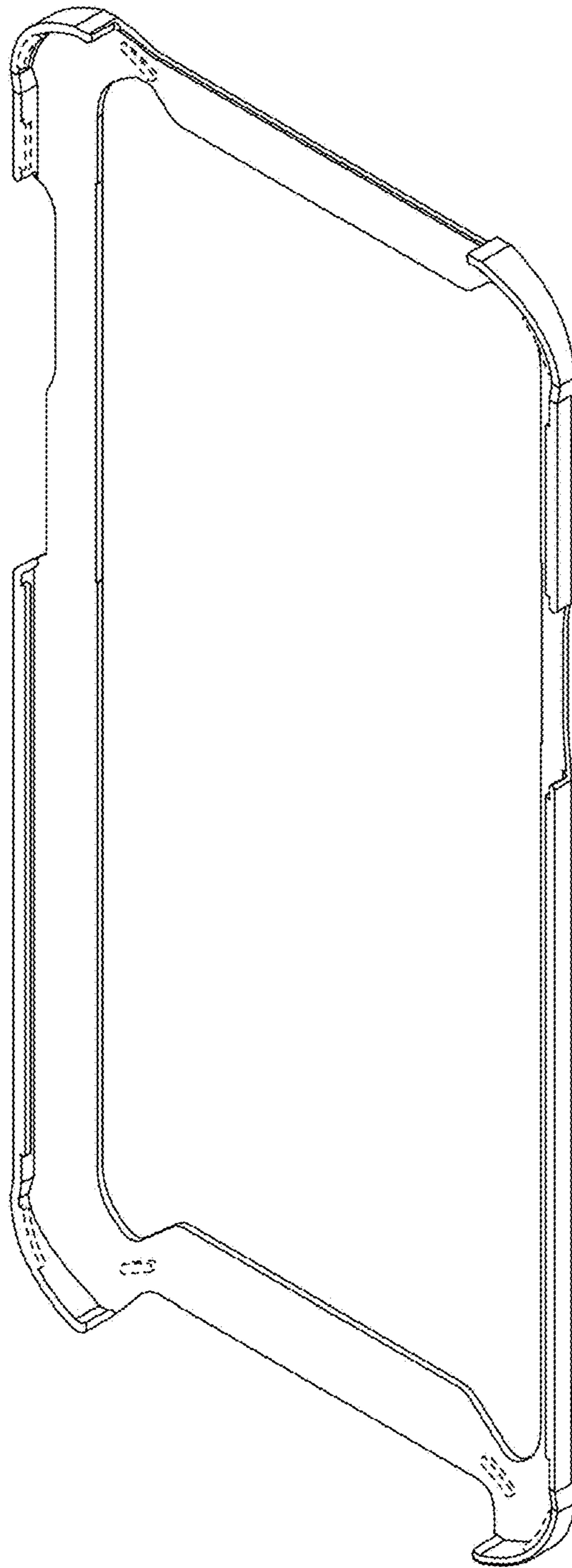

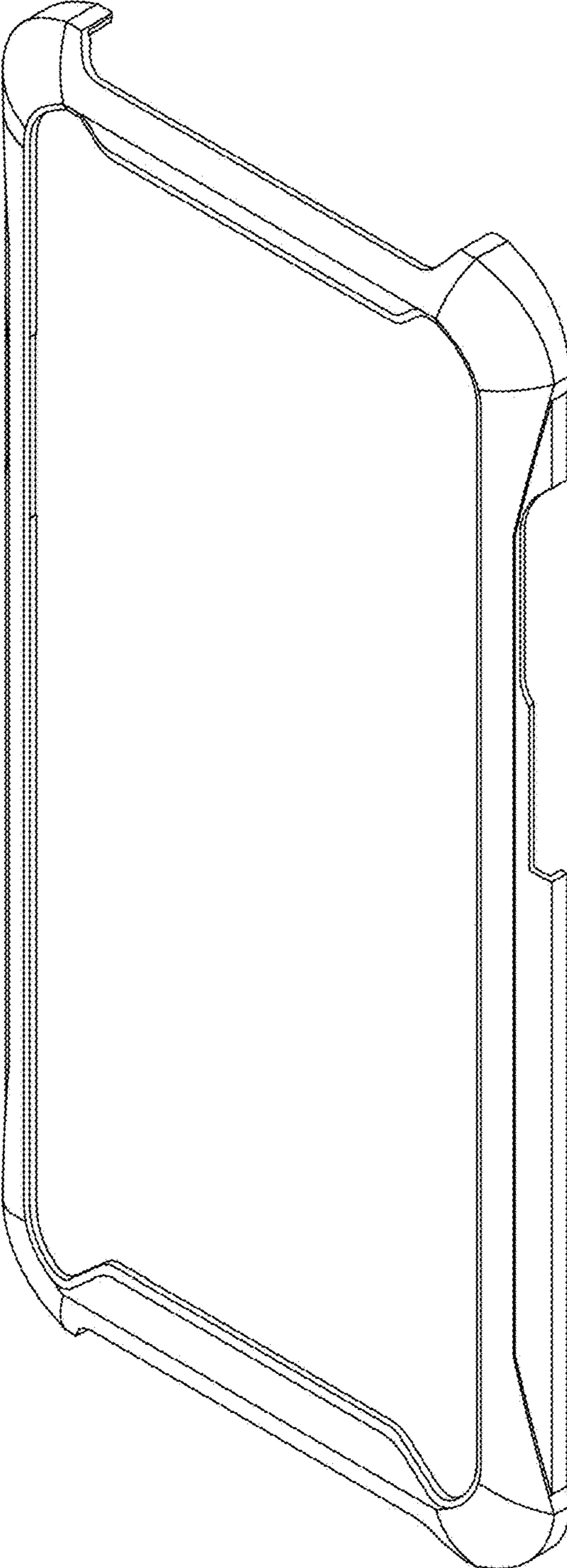

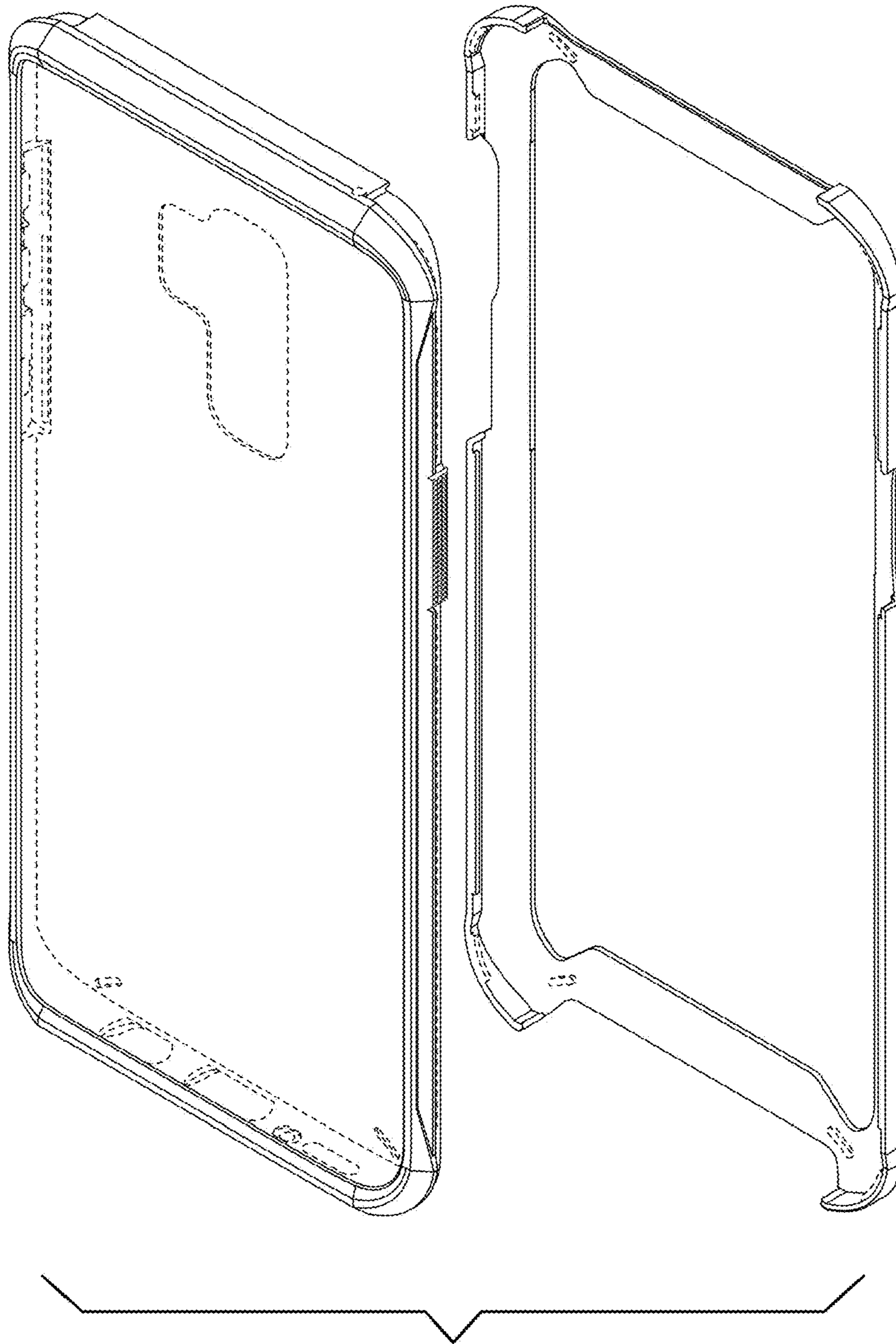

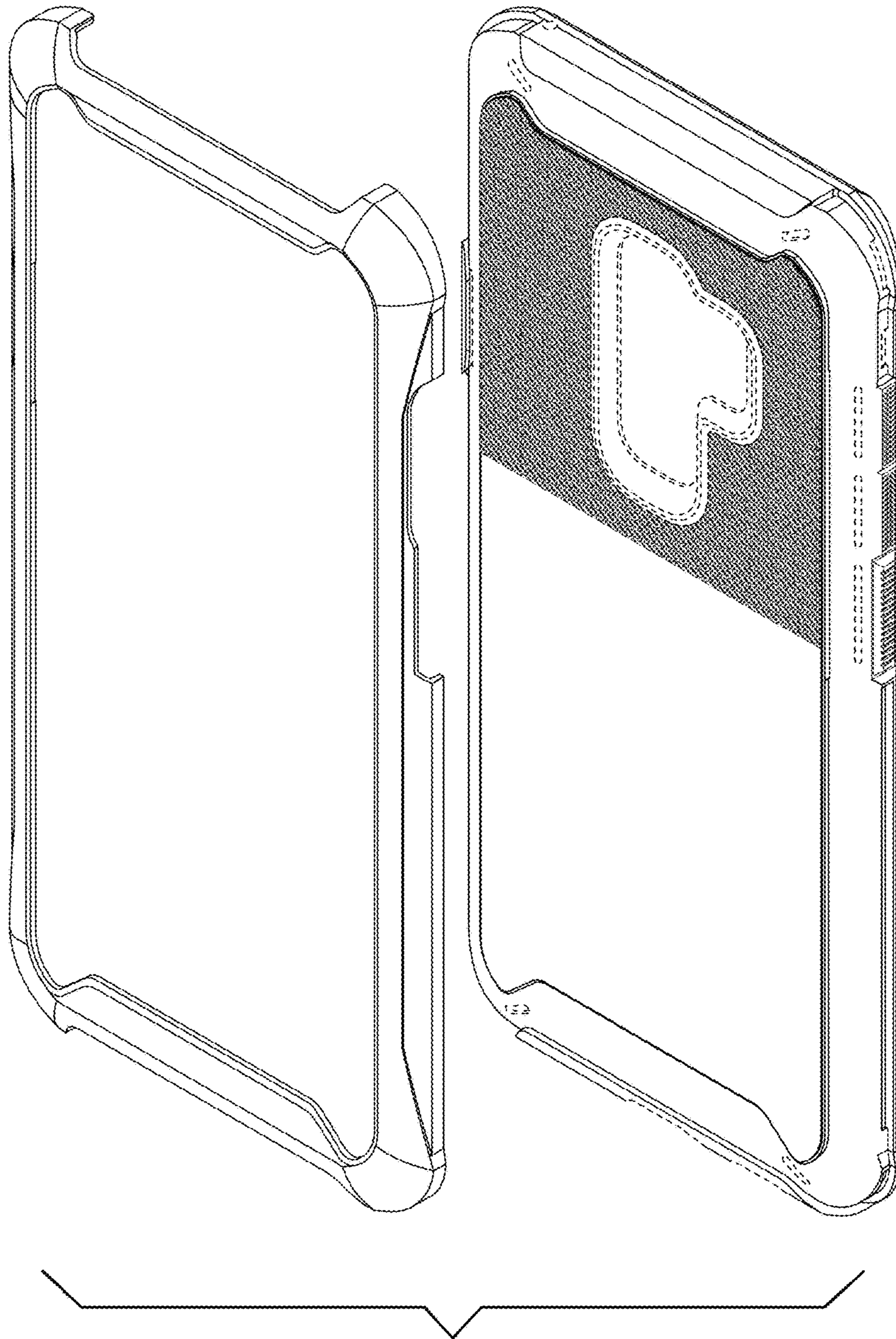
