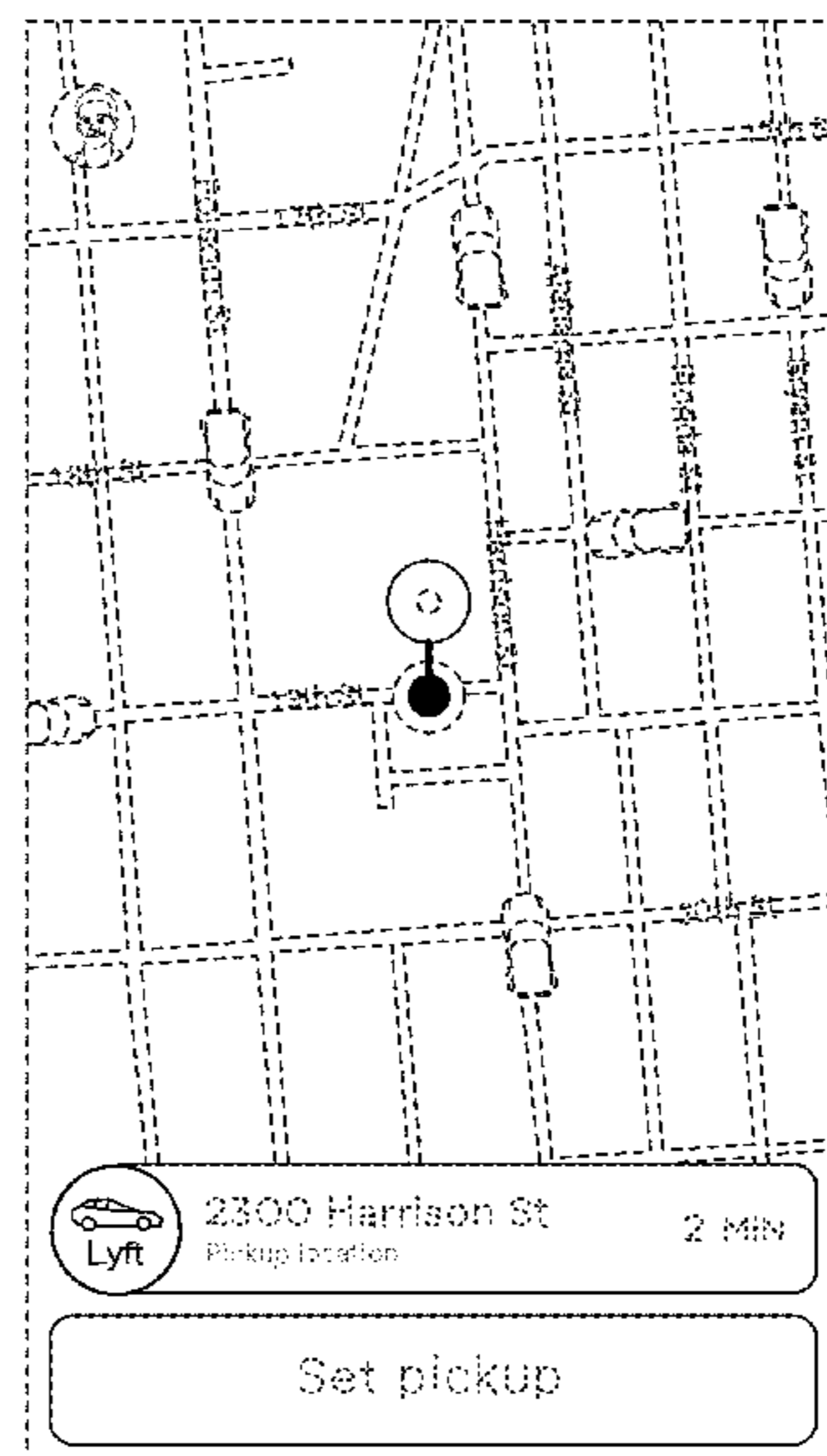
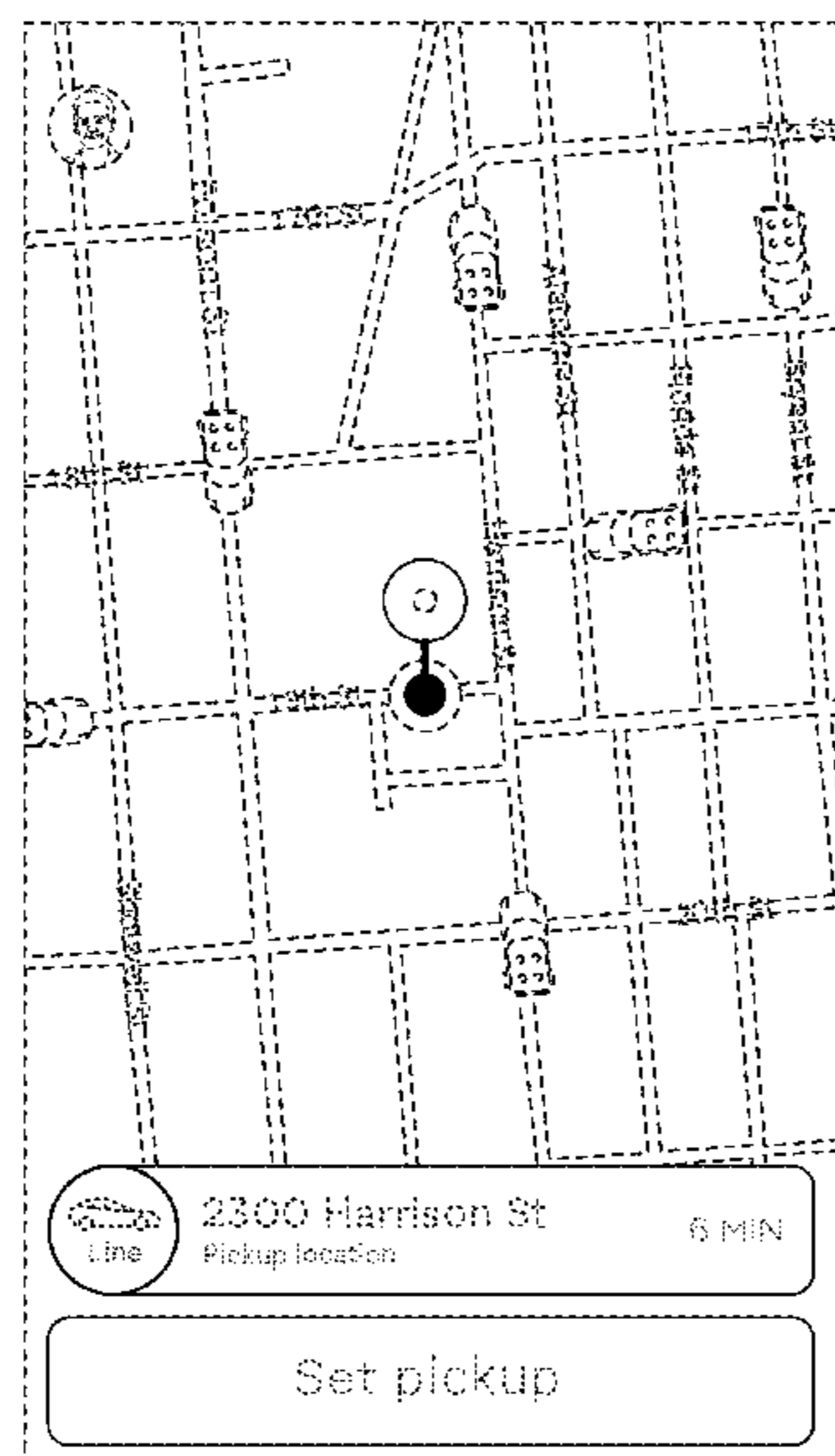
(57) **CLAIM**

The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface showing our new design; and, FIG. 2 is a front view of a display screen or portion thereof with graphical user interface showing our new design. The outermost broken line rectangle in the Figures shows a display screen or portion thereof and forms no part of the claimed design. 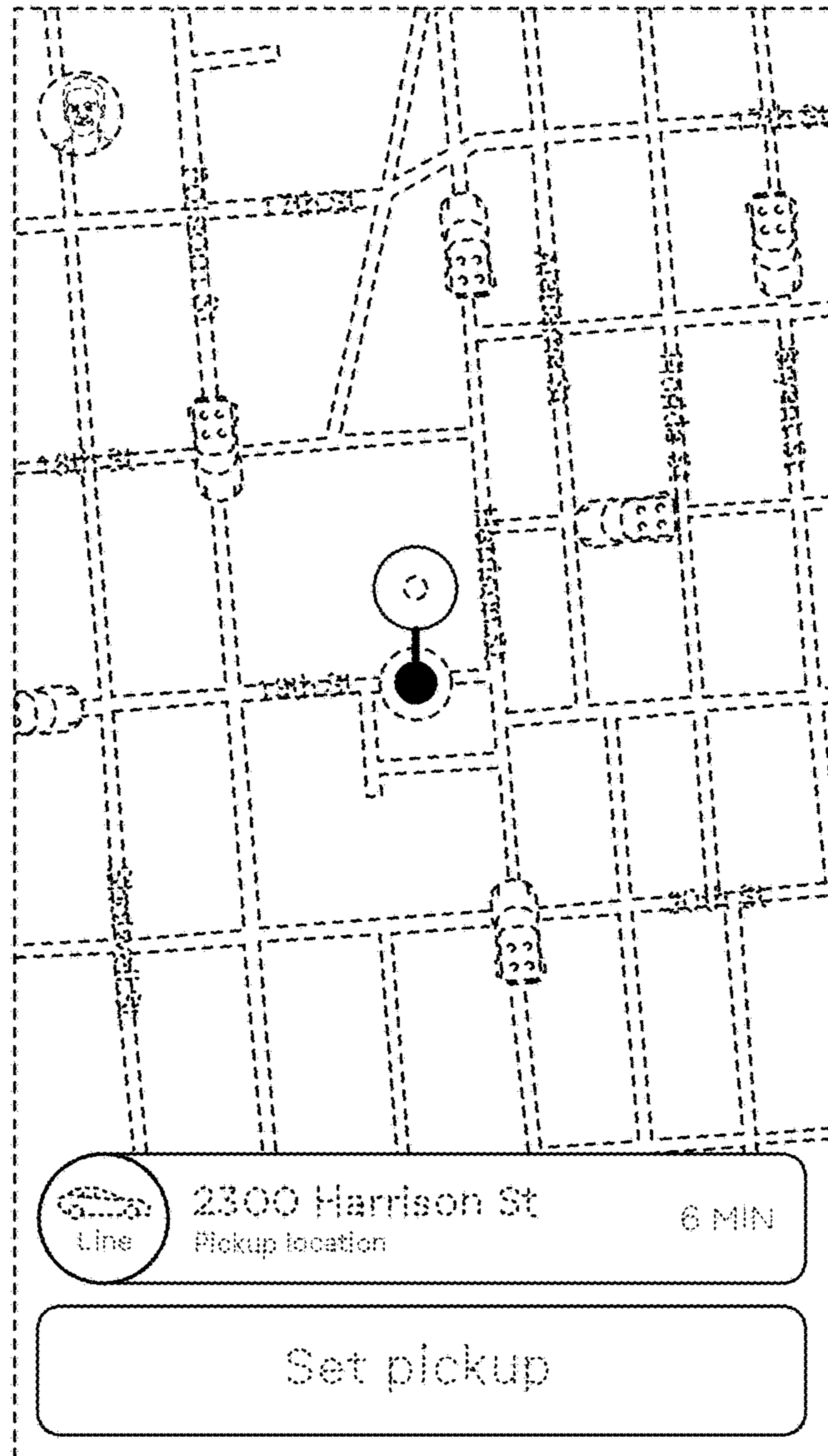

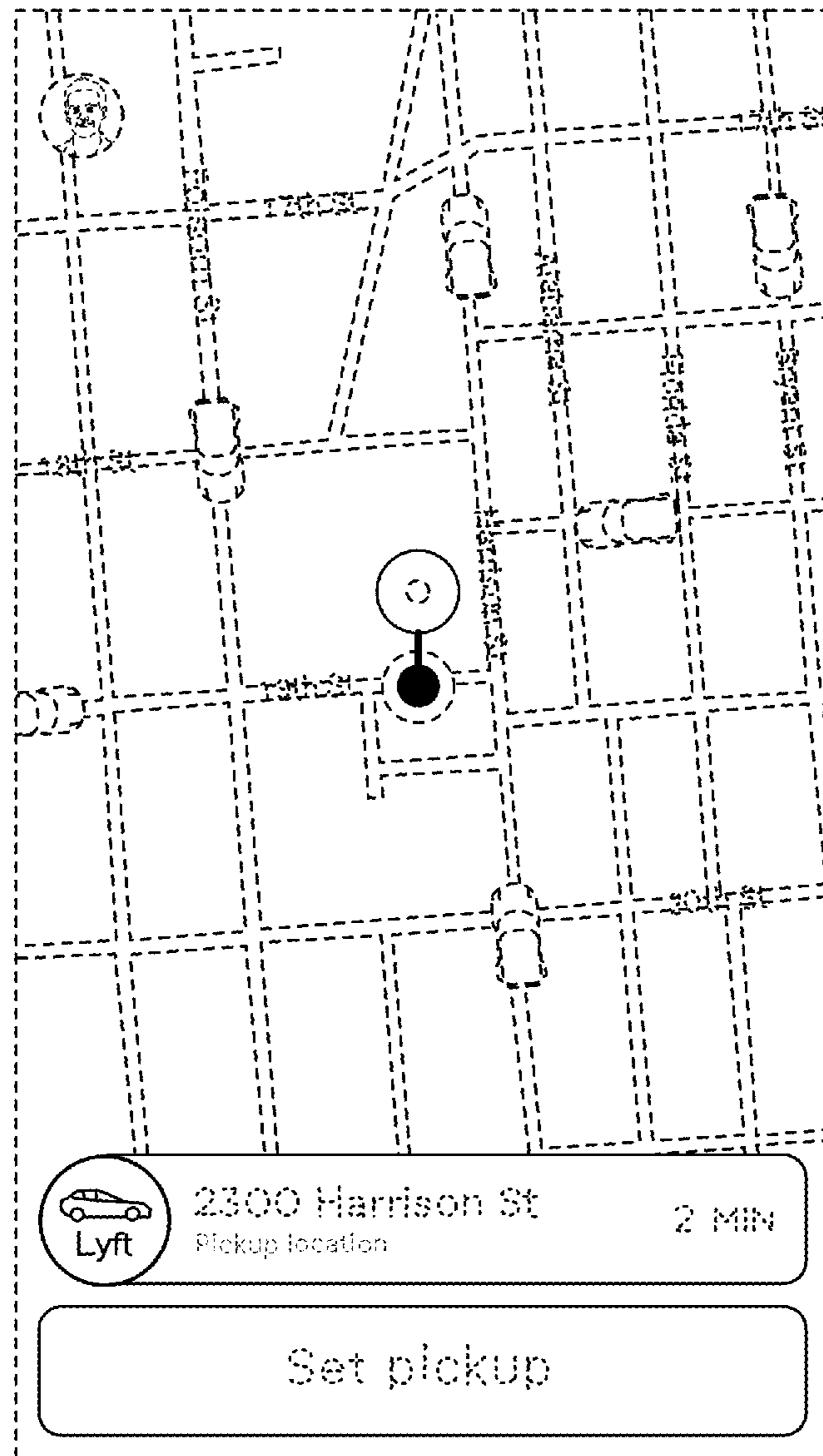
